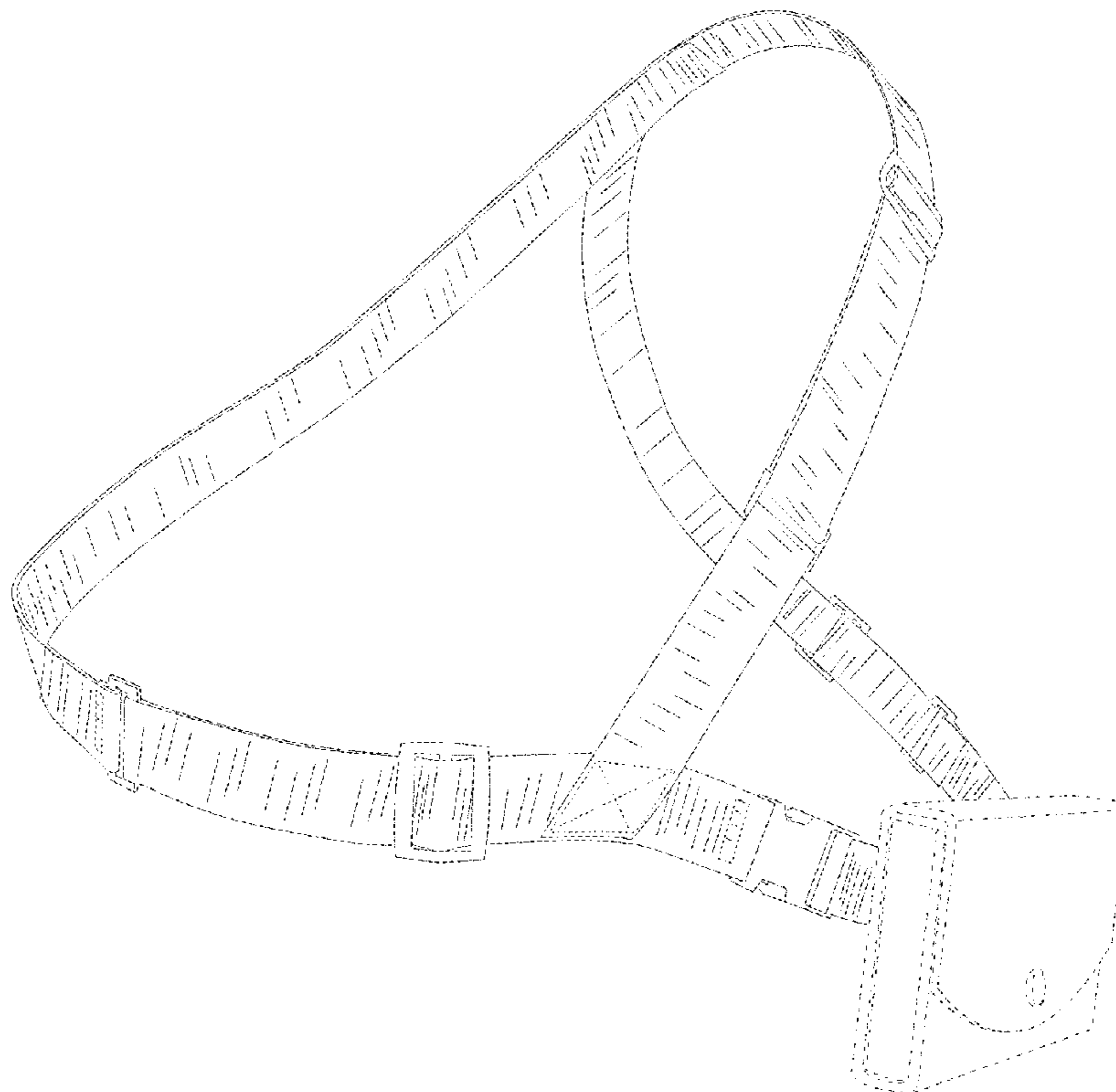
(57) **CLAIM**

The ornamental design for a carrying strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the carrying strap;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a right-side elevational view thereof;  
 FIG. 5 is a left-side elevational view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a front perspective view thereof with a user; and,  
 FIG. 9 is a rear perspective view thereof with the user.  
 The broken lines showing the bag in FIGS. 1-9 and the broken lines showing the user in FIGS. 8 and 9 are included for the purpose of showing environmental structure and form no part of the claimed design.

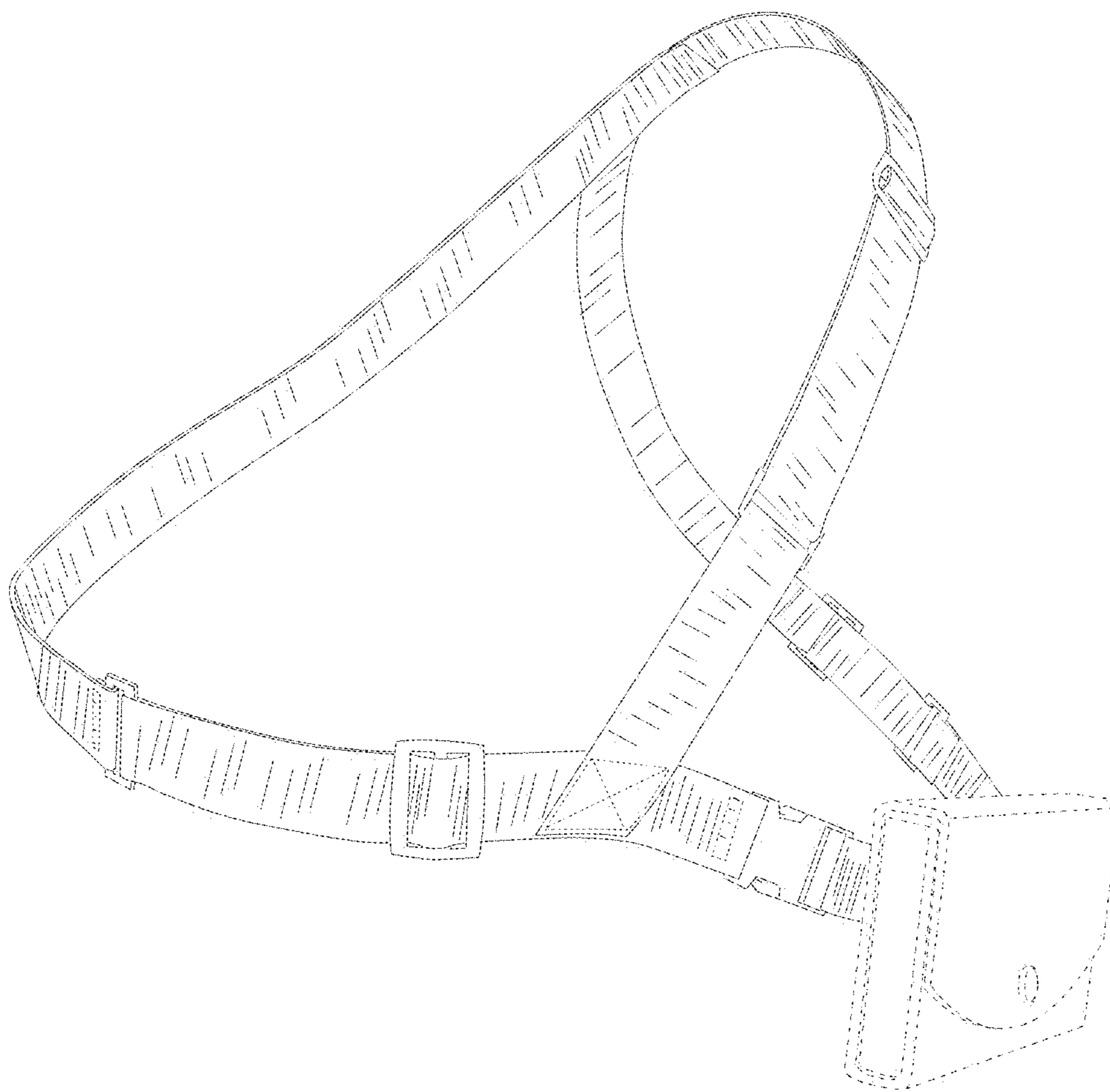

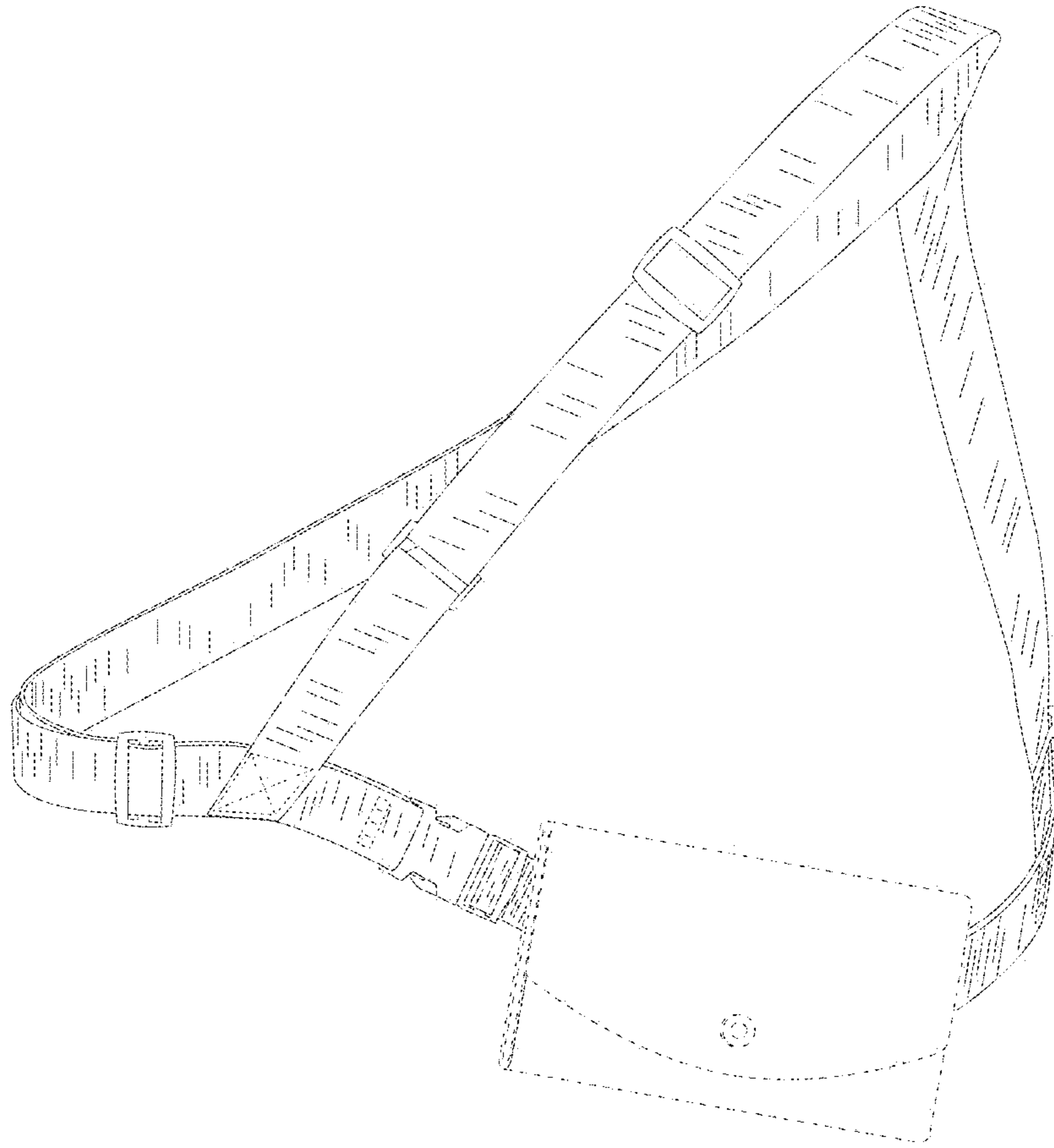

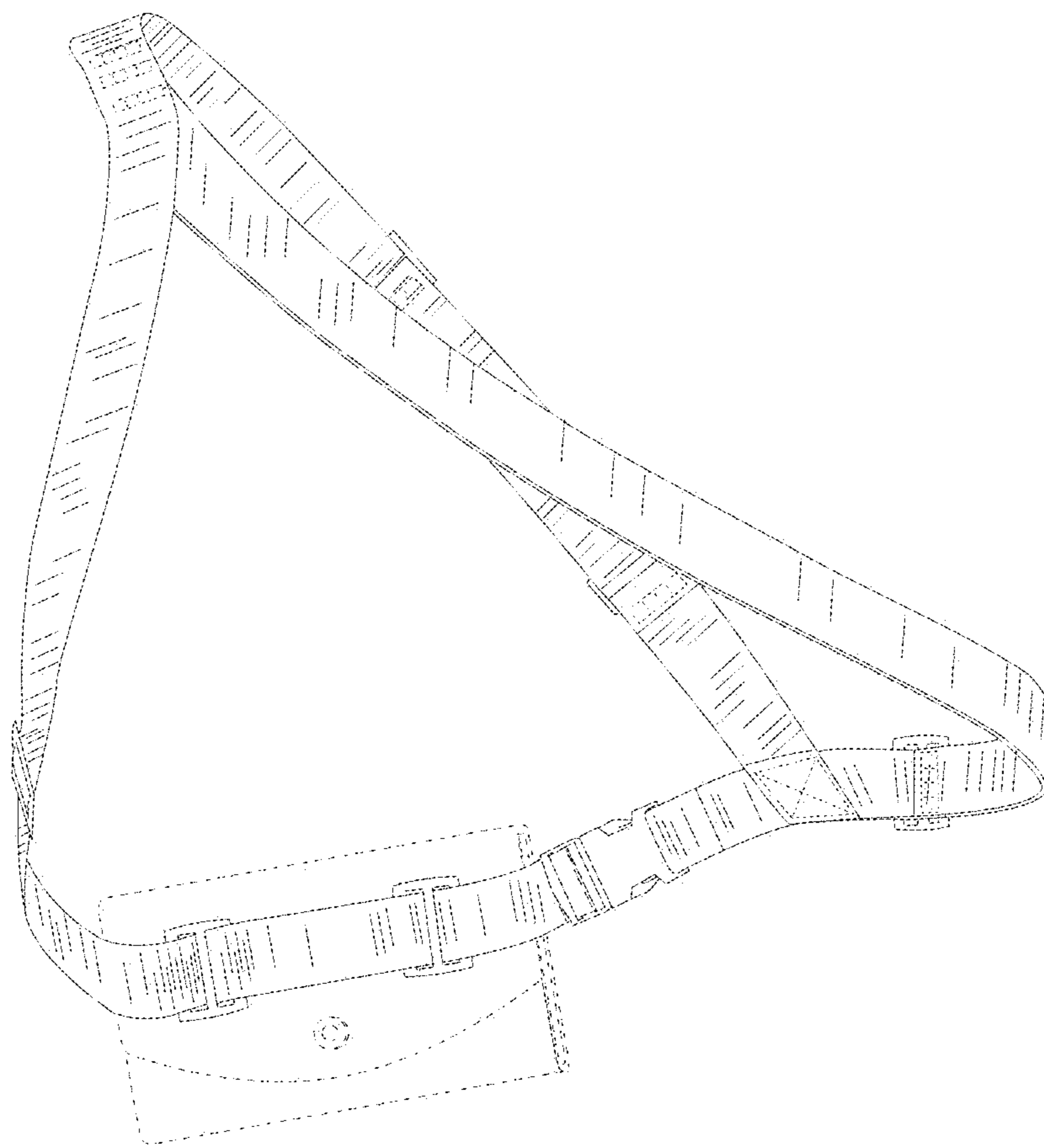

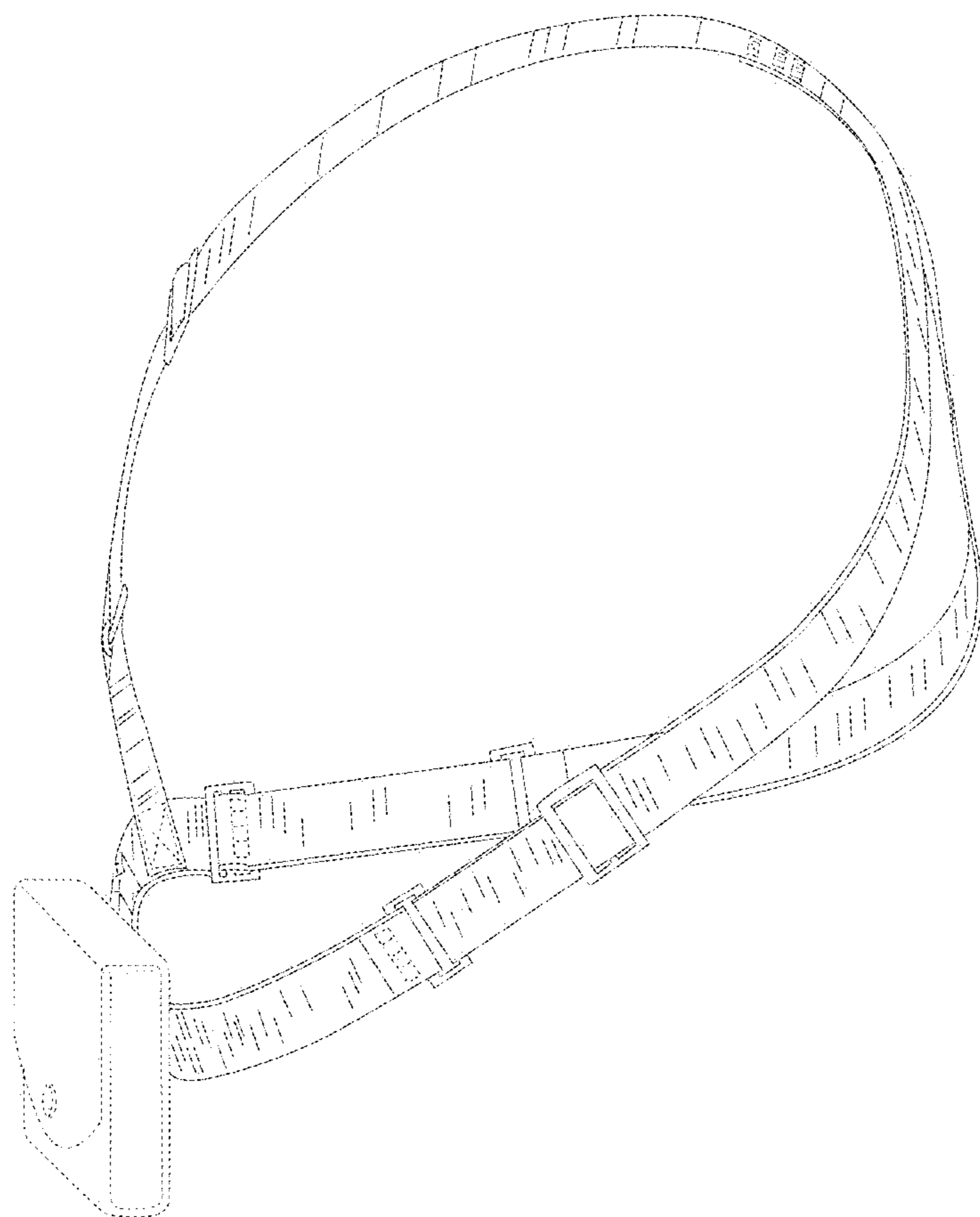

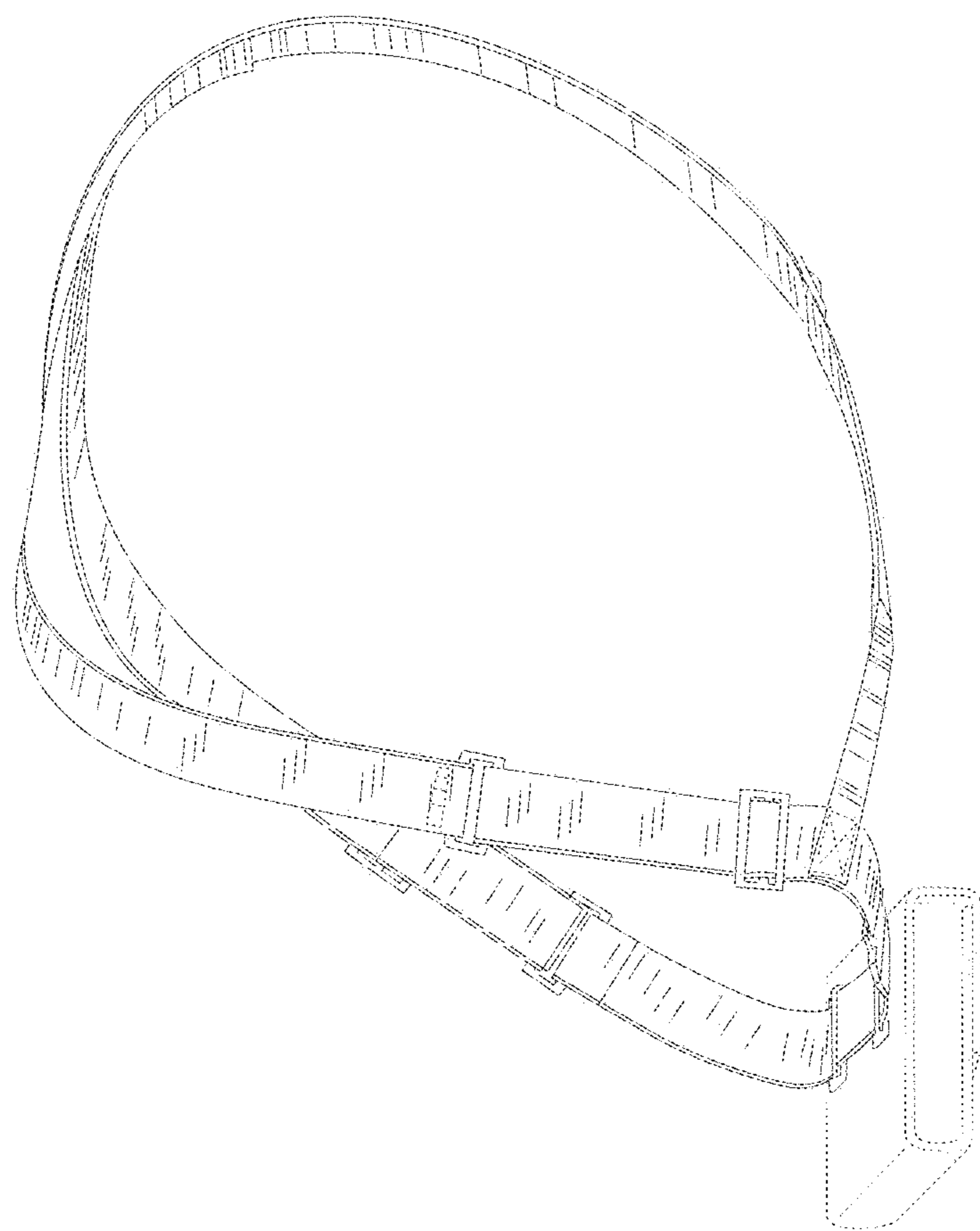

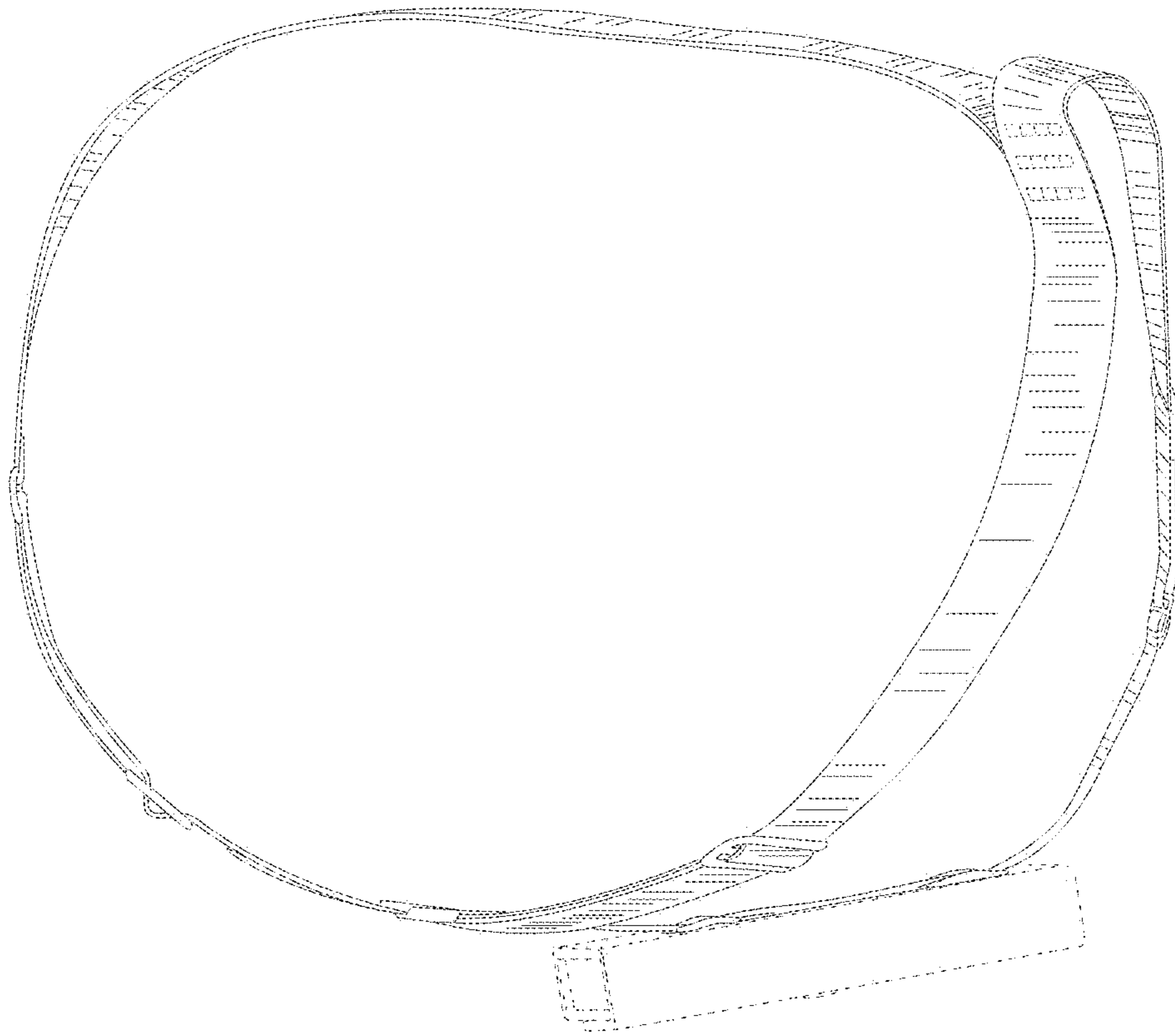

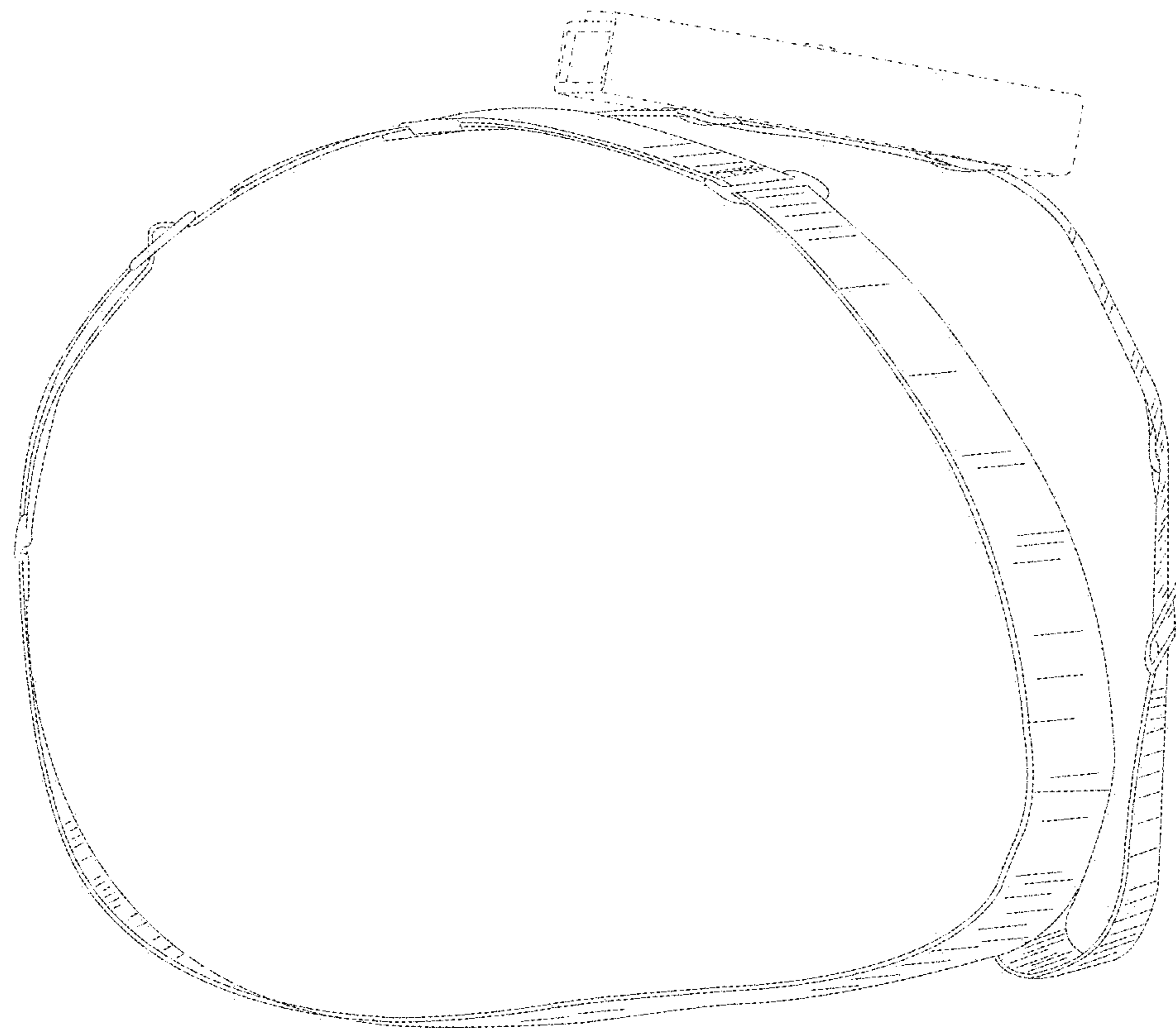

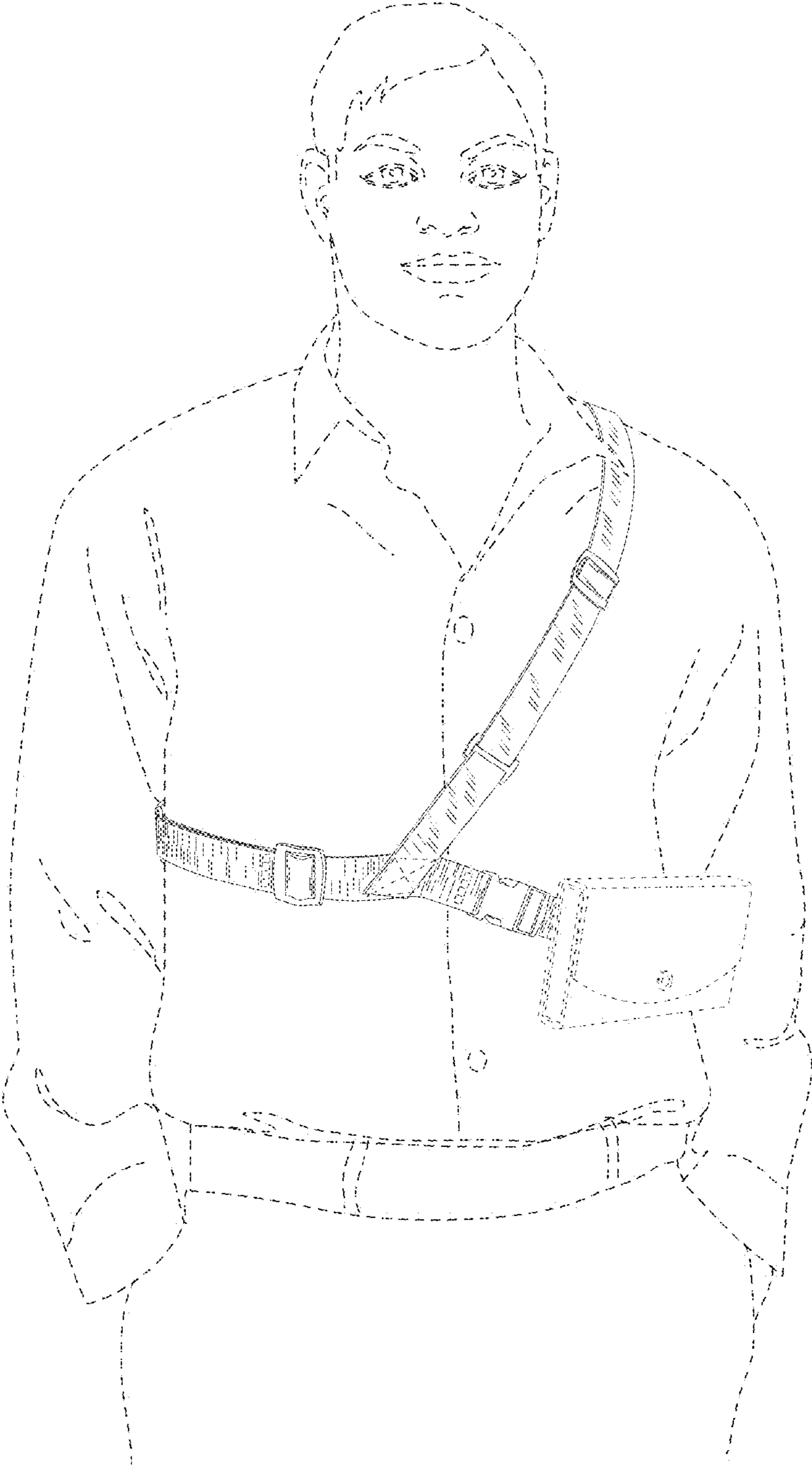

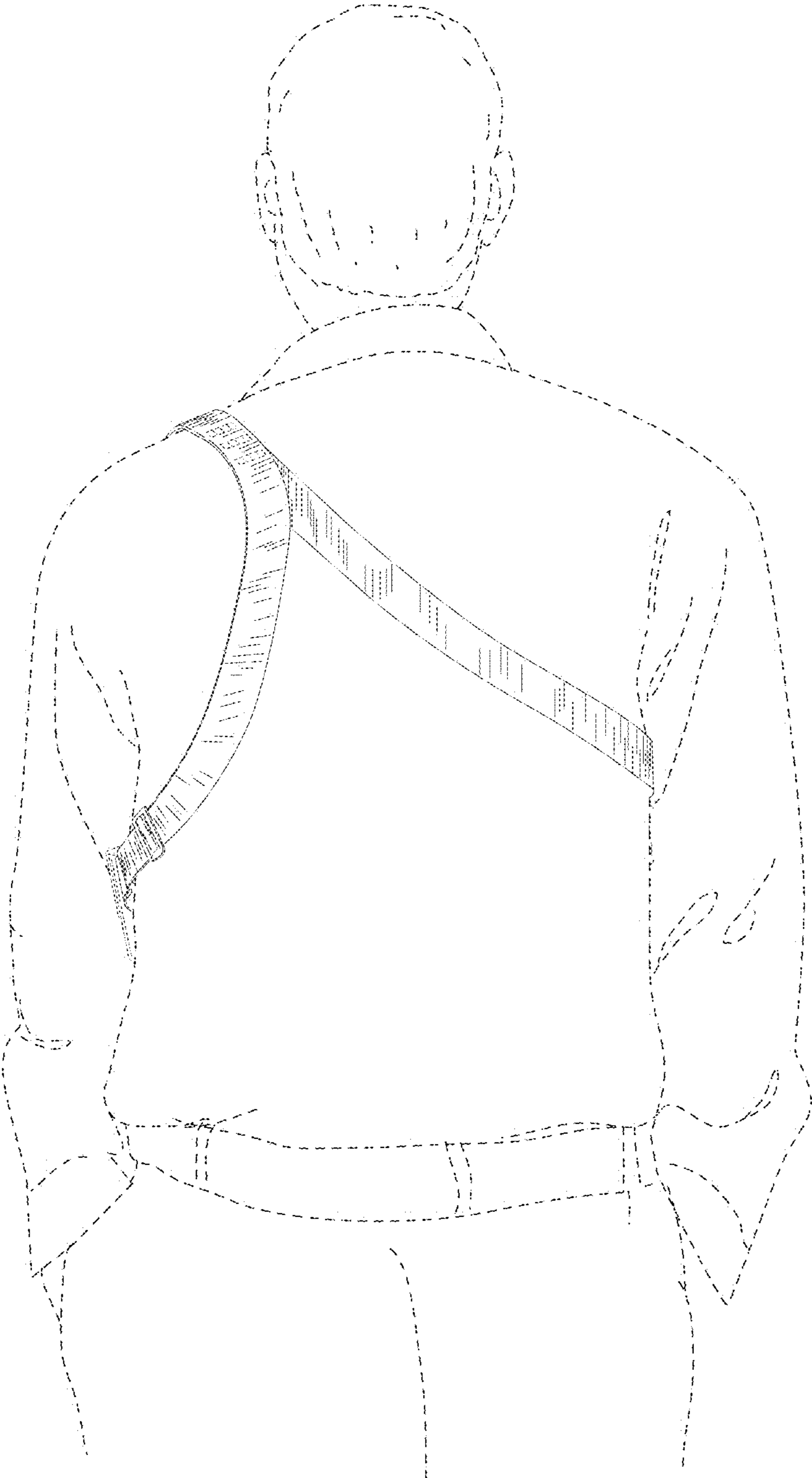
