


The ornamental design for an infant car seat cover, as shown.

**DESCRIPTION**

FIG. 1 is a left side view of the infant car seat cover, shown as installed on an infant car seat;  
FIG. 2 is a front view of the infant car seat cover;  
FIG. 3 is a rear view of the infant car seat cover;  
FIG. 4 is a left side view of the infant car seat cover;  
FIG. 5 is a right side view of the infant car seat cover;  
FIG. 6 is a top view of the infant car seat cover; and,














