DESCRIPTION

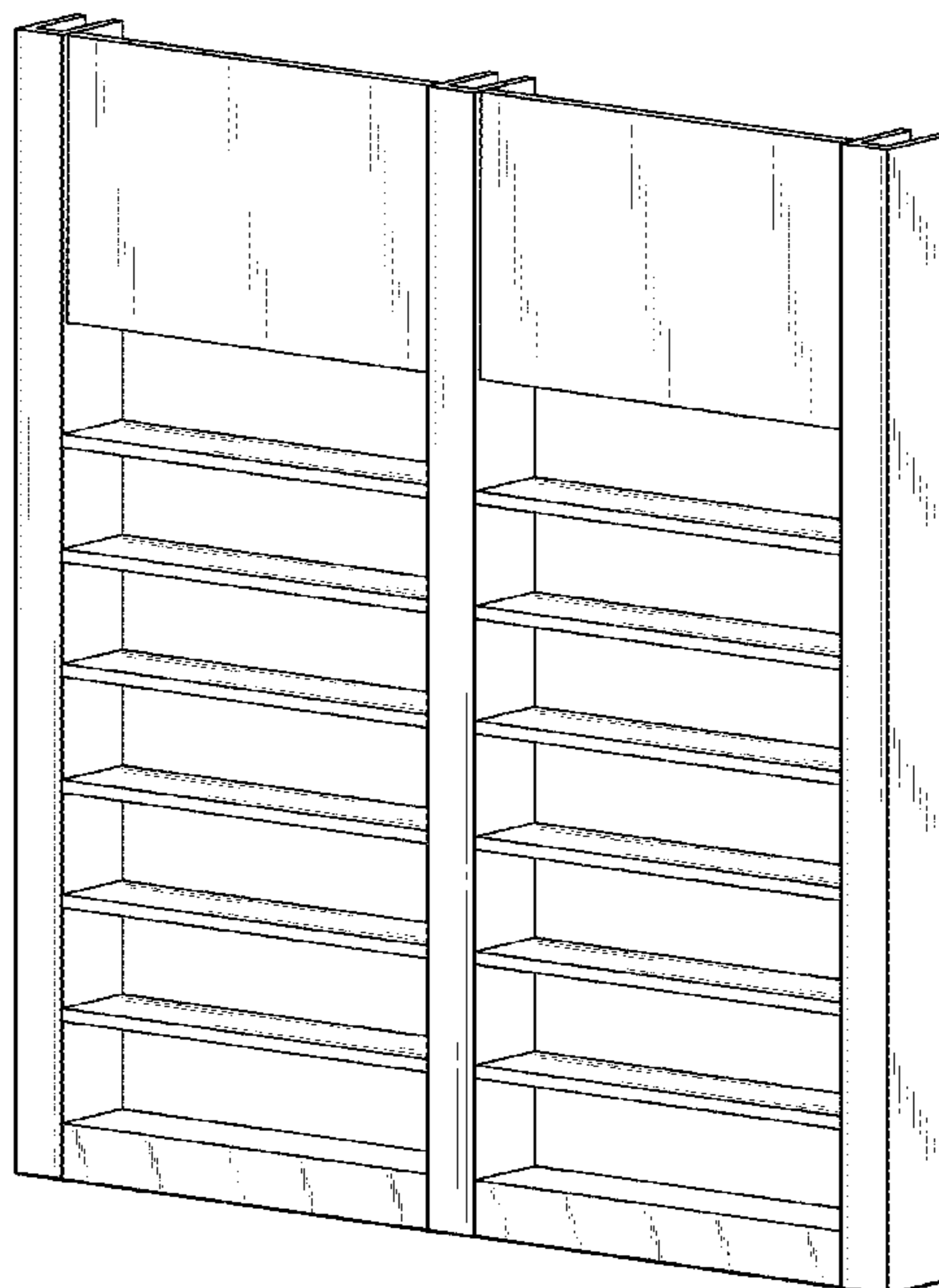
FIG. 1 is an isometric view showing the top, front, and side of the display shelving of my new design;

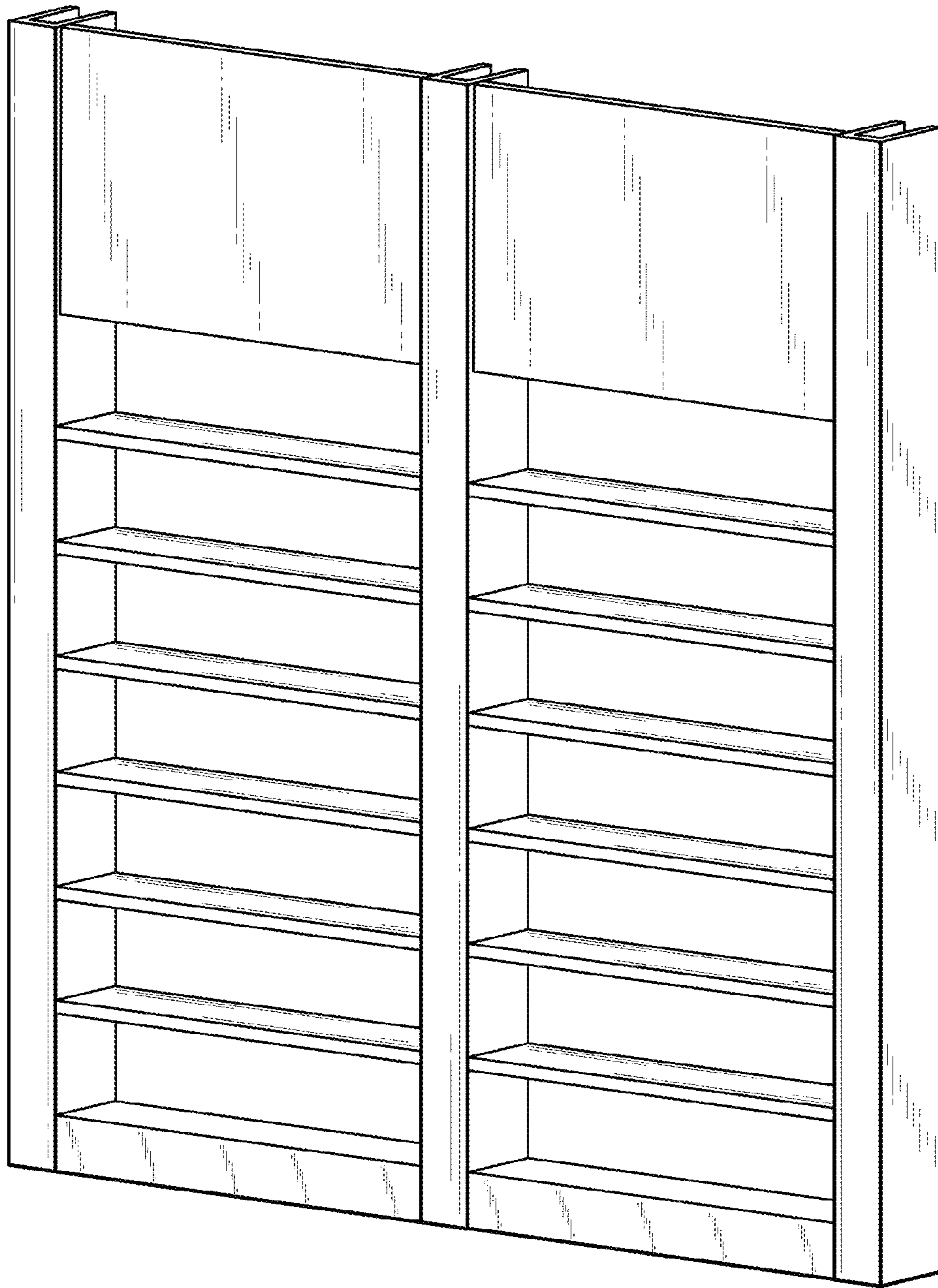

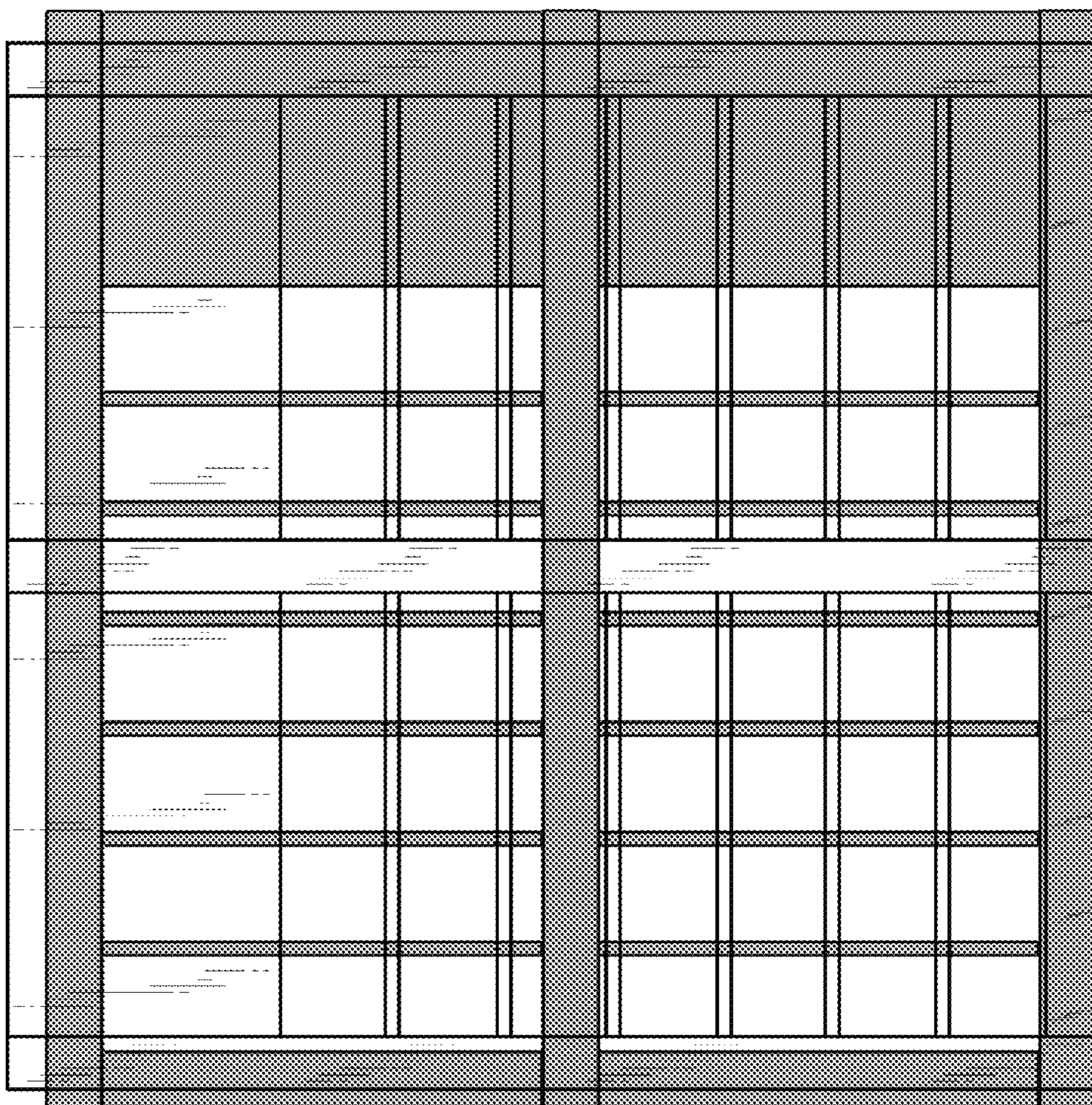

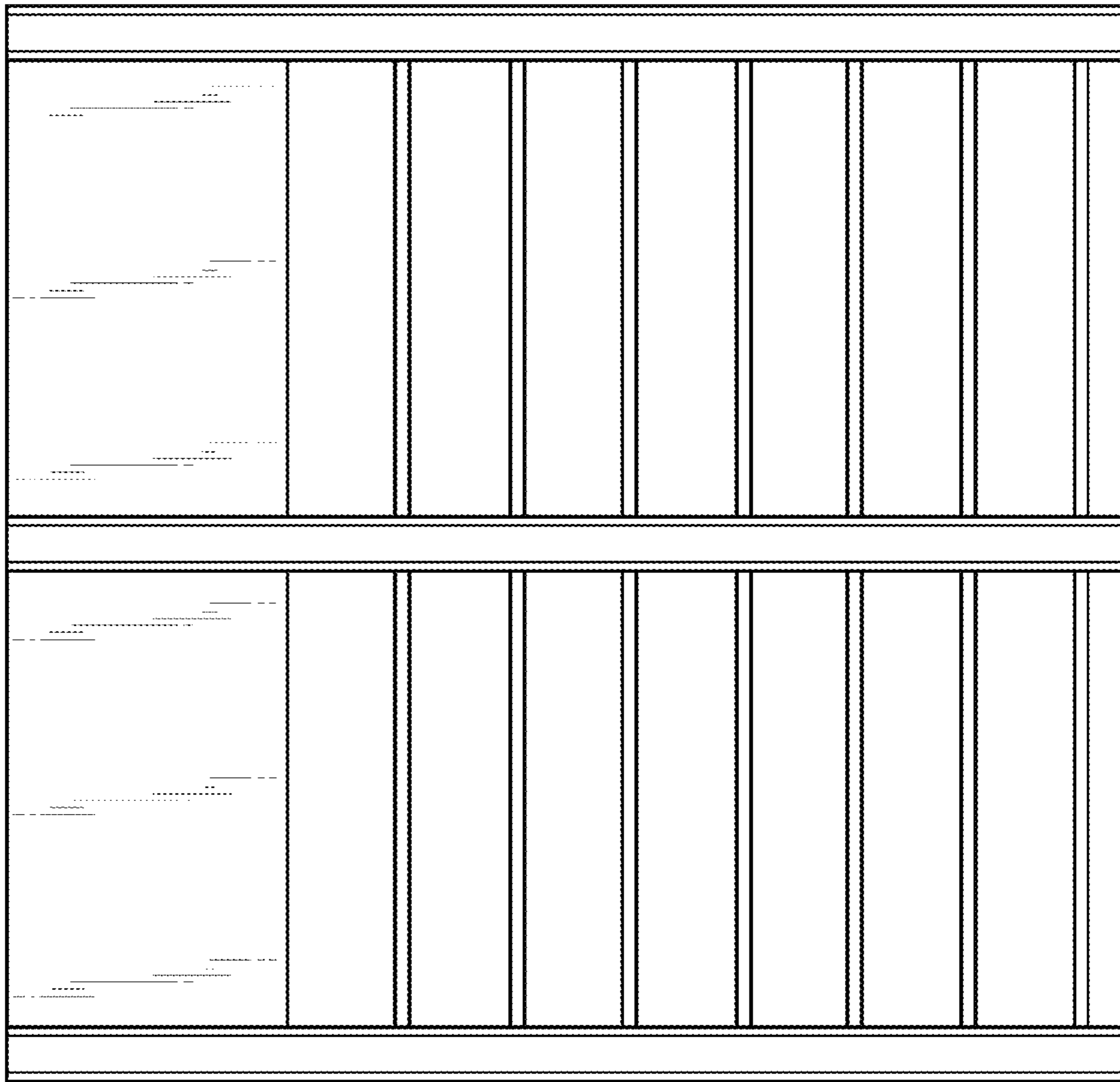

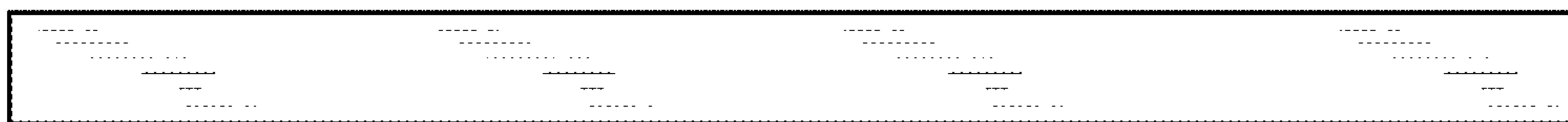

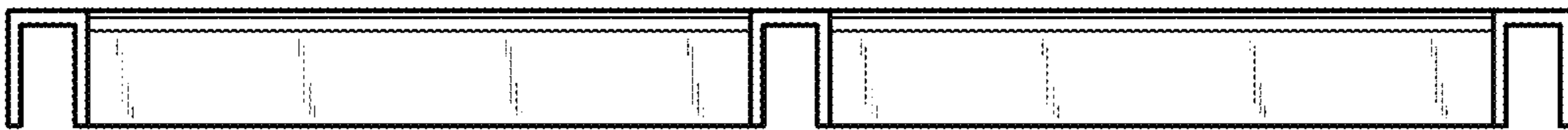

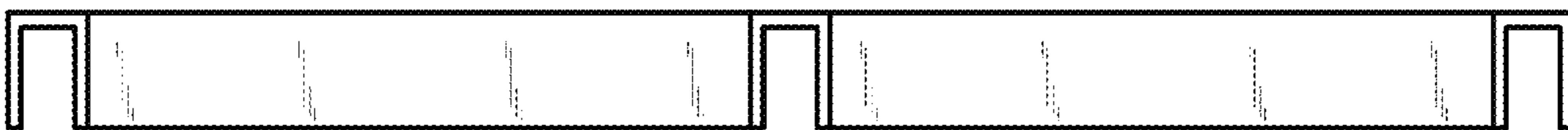
