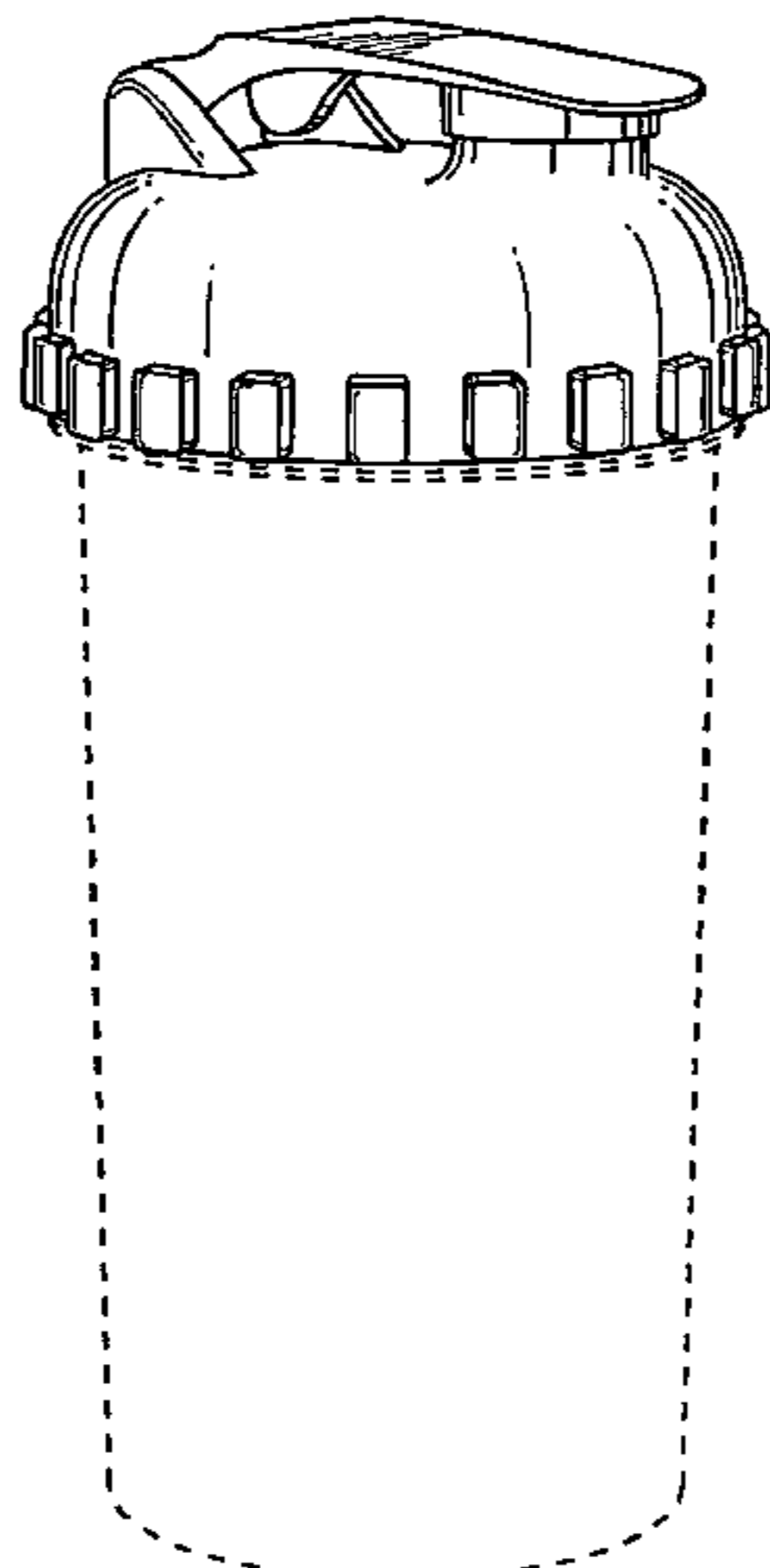
(57) **CLAIM**

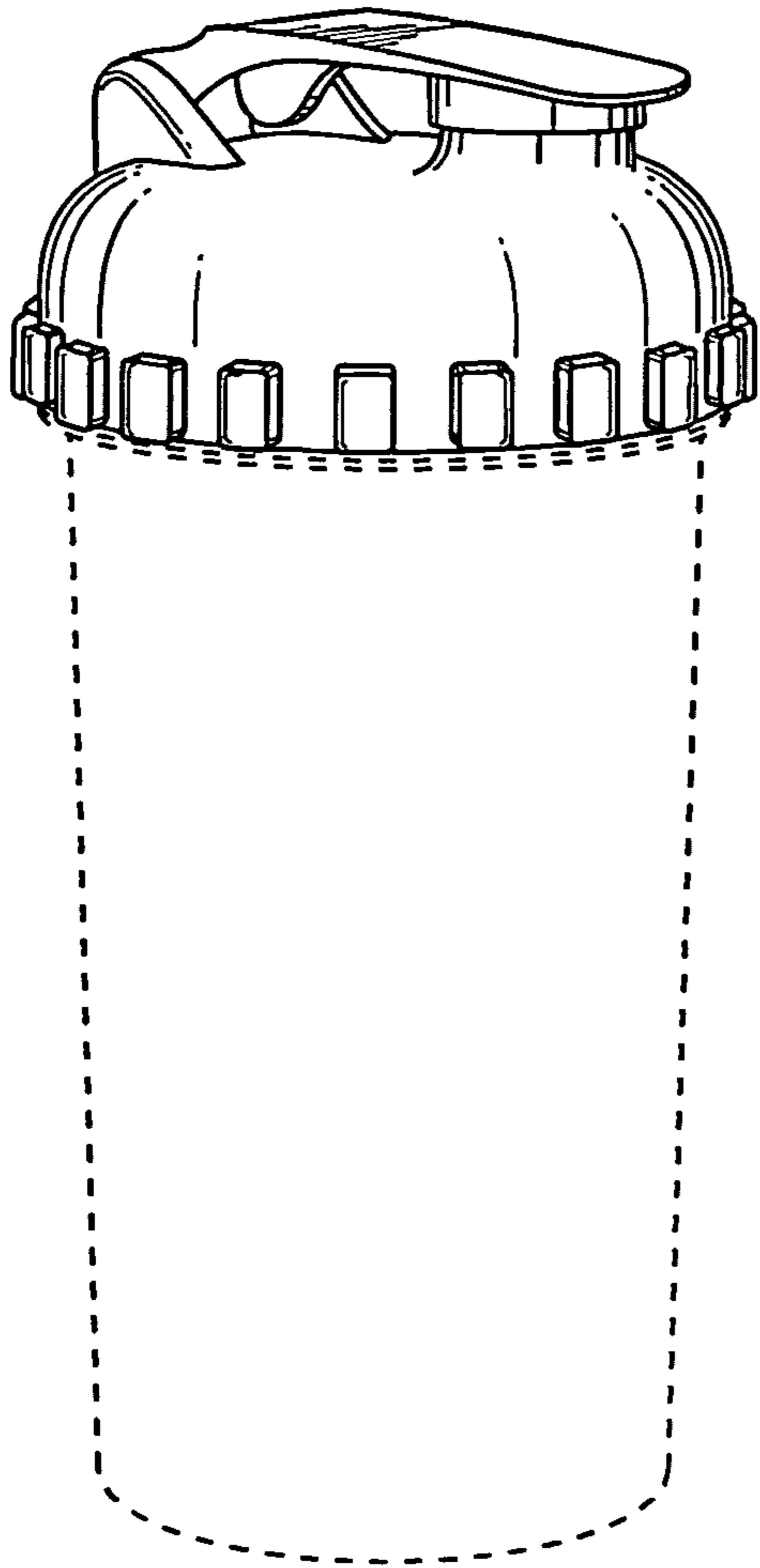
The ornamental design for a mug cap, as shown and described.

The structure depicted with dashed lines forms no part of the claimed design. Surfaces or parts of surfaces not shown form no part of the claimed design.

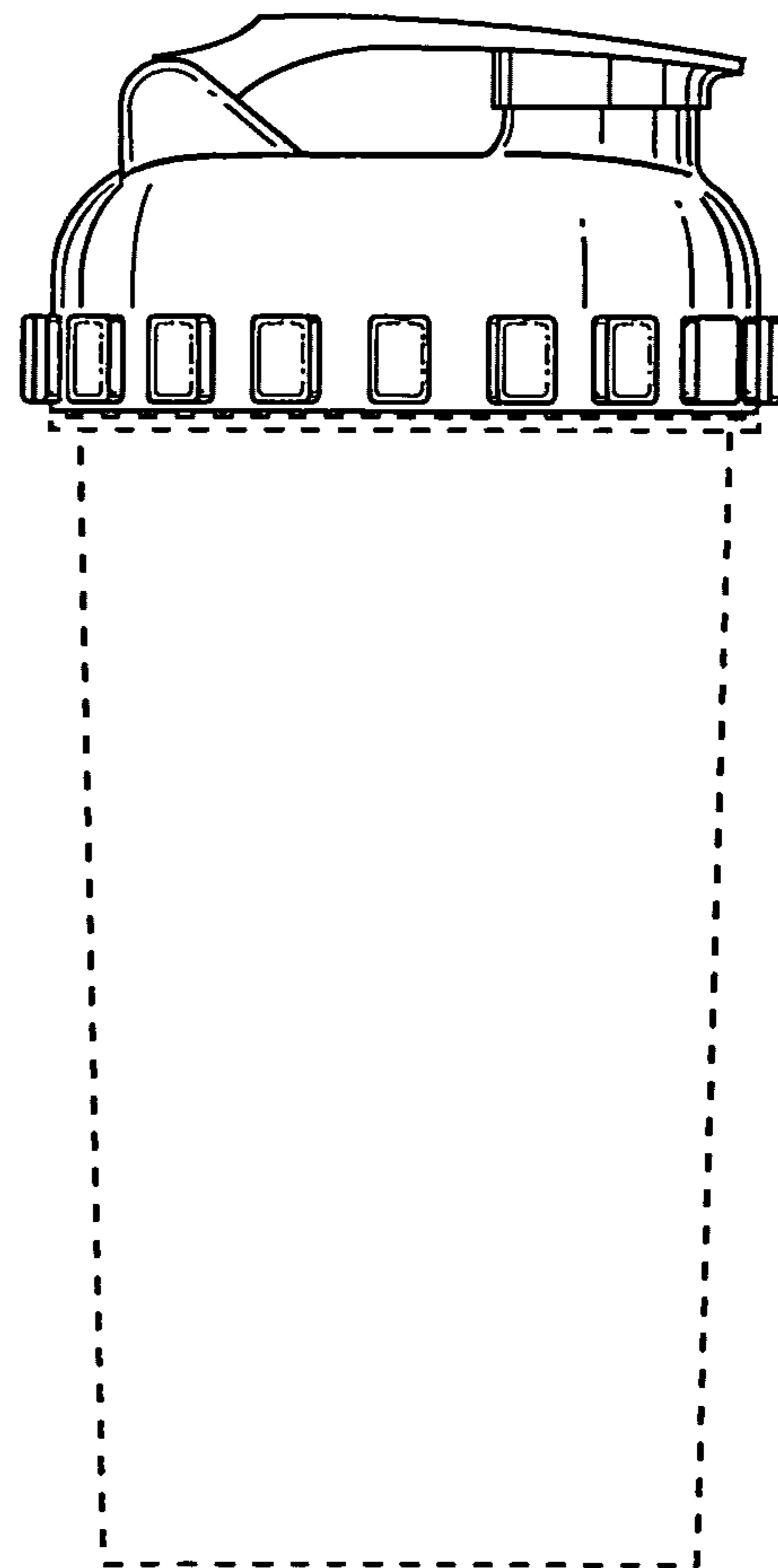

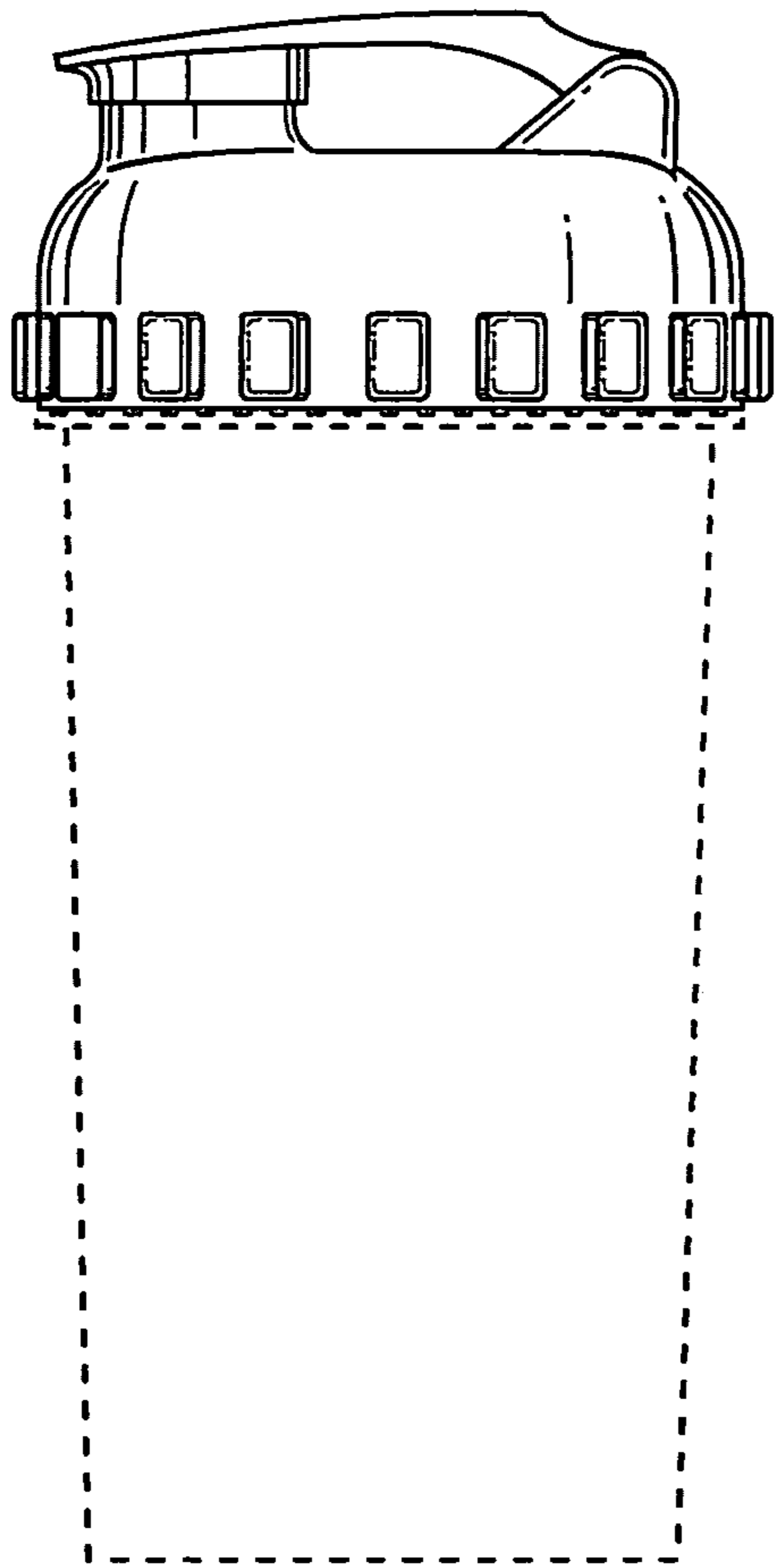




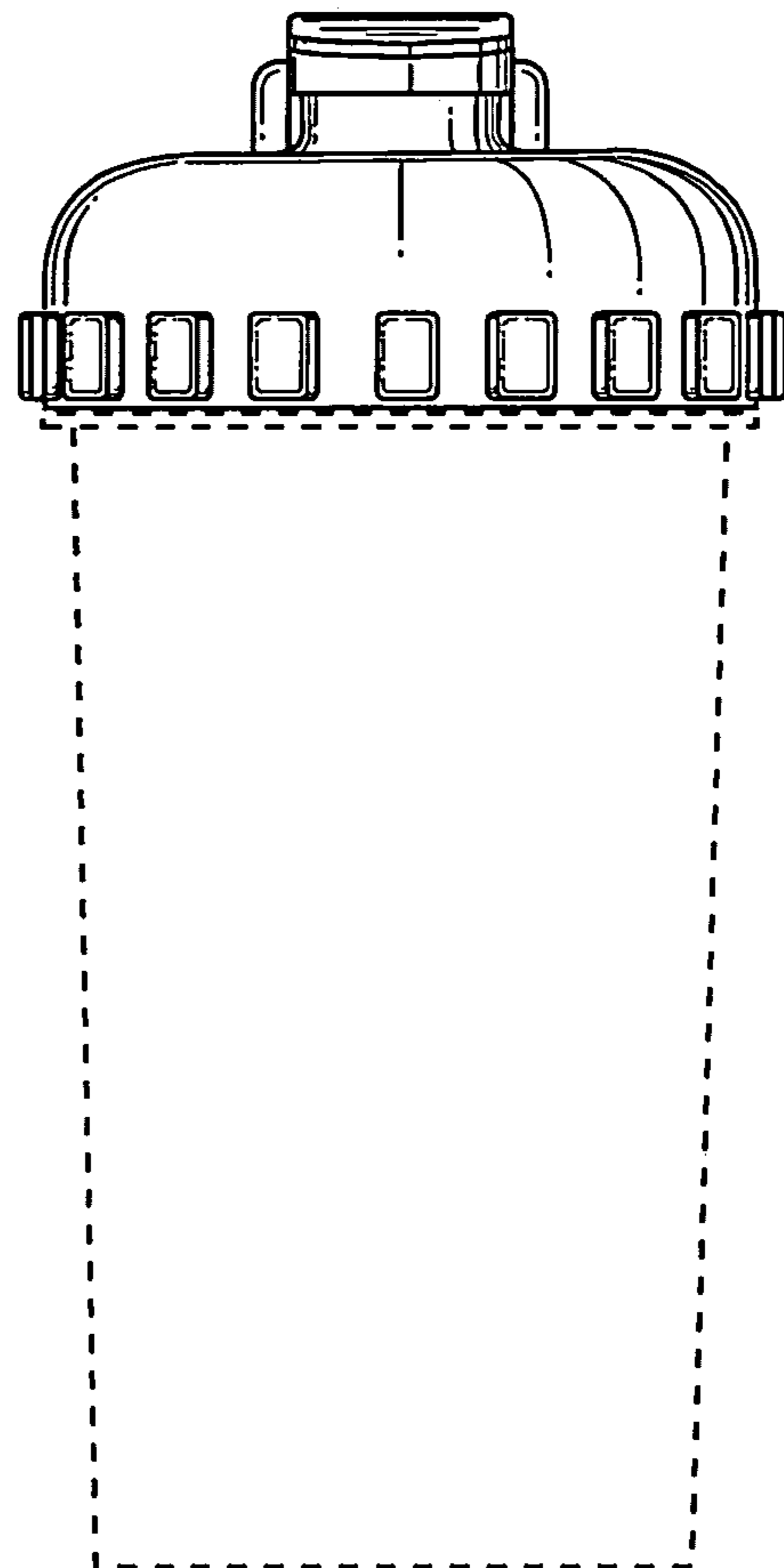

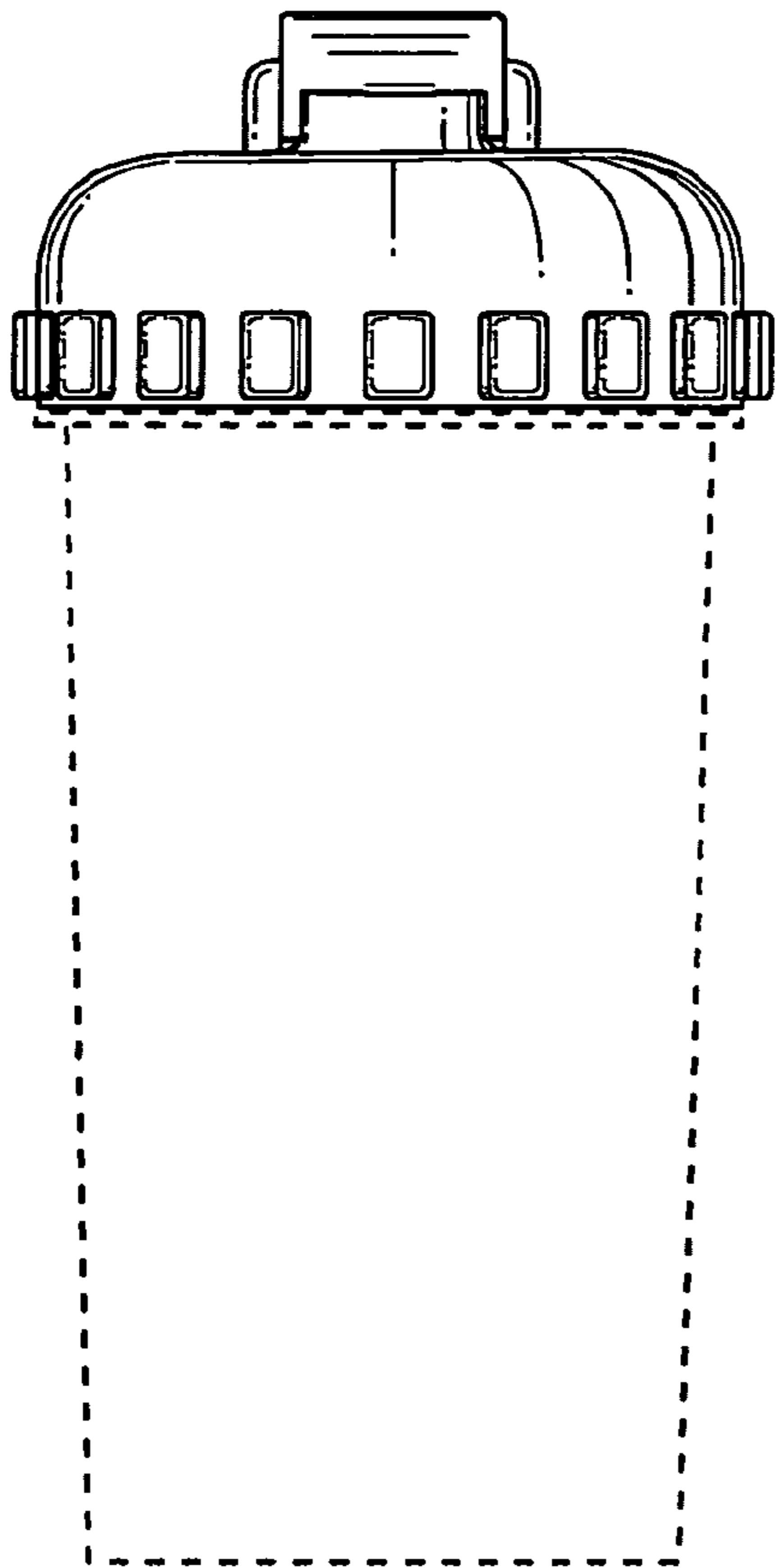




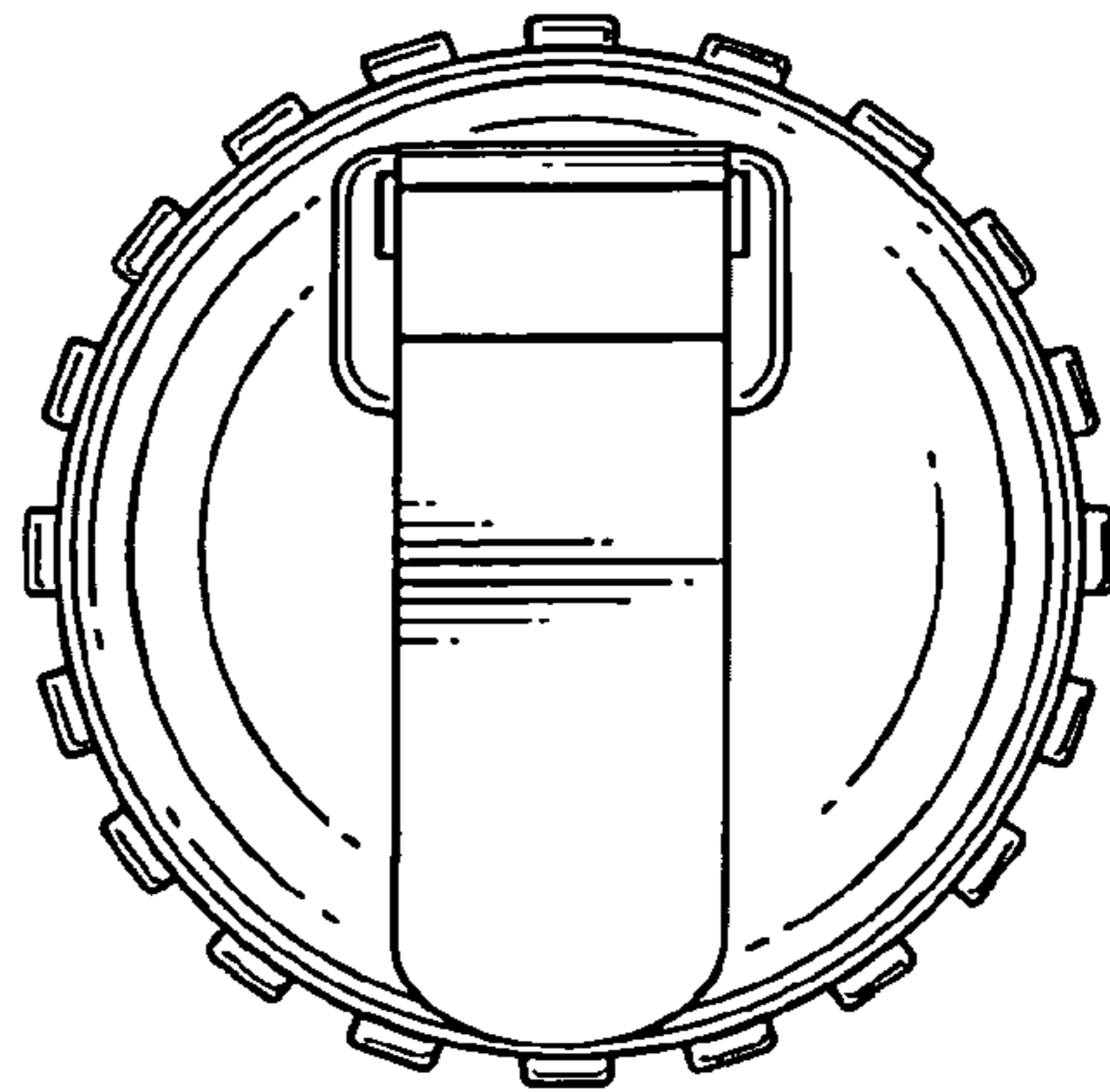

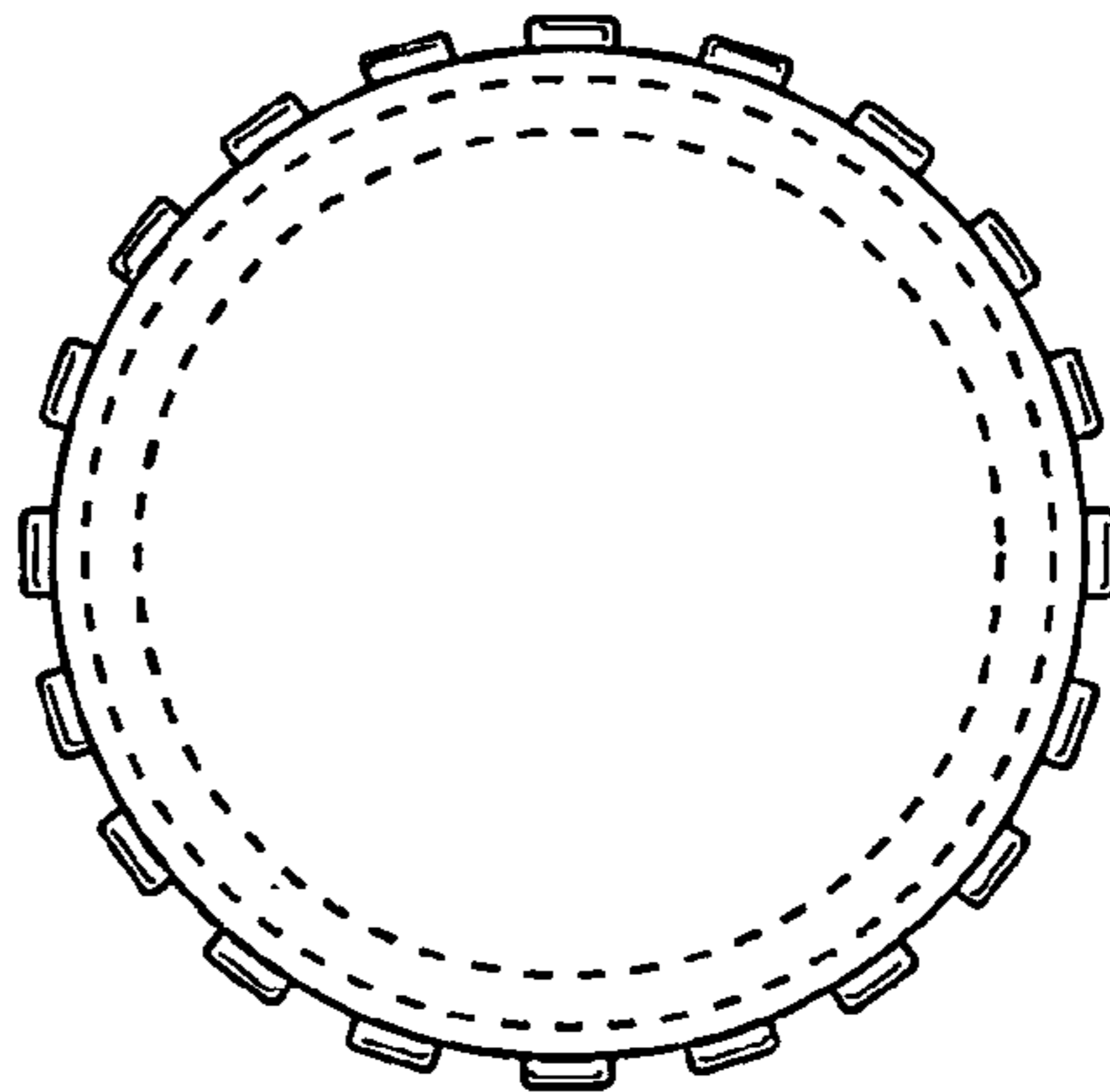
