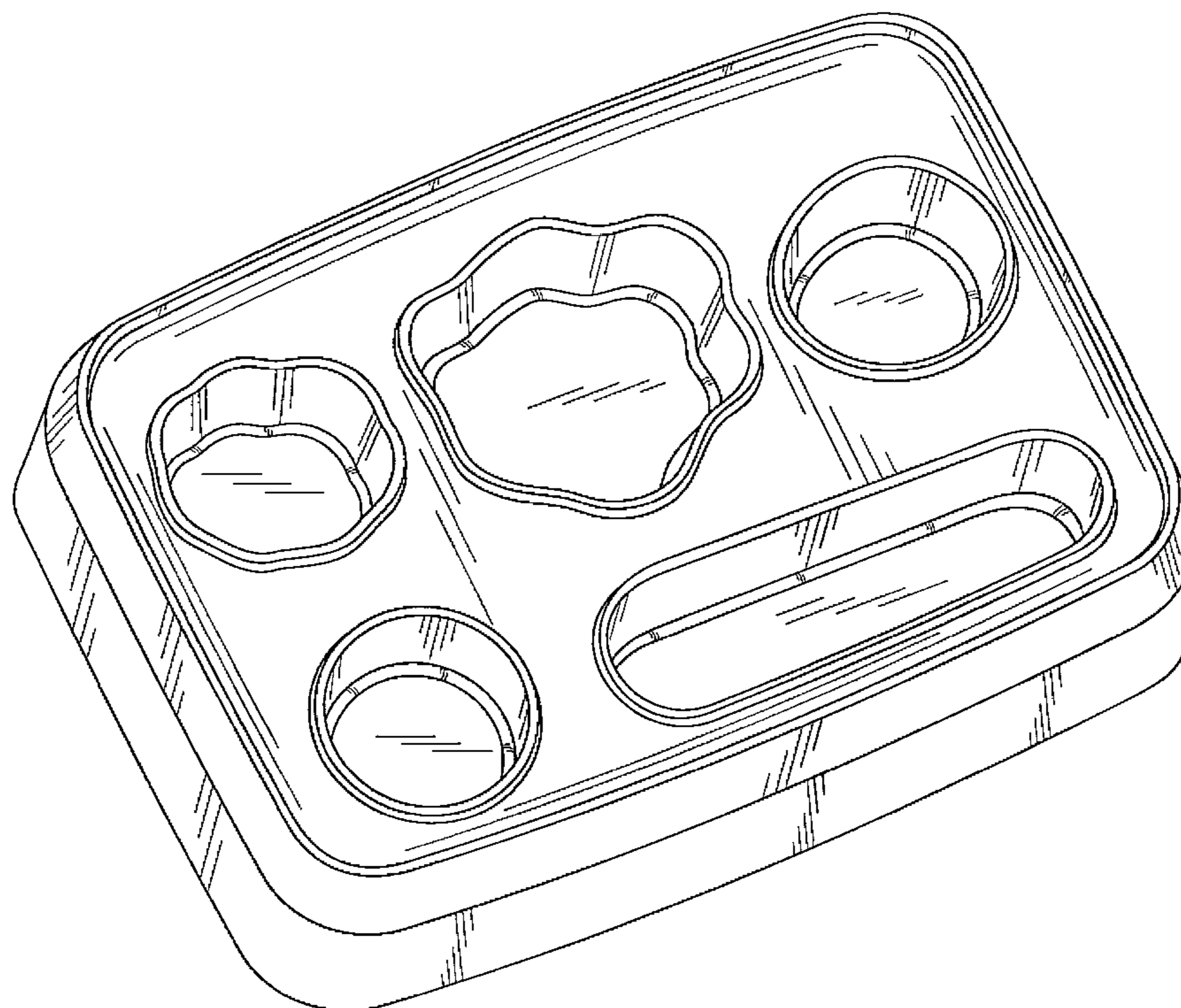
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a food tray showing the new design;
FIG. 2 is a top side elevational view thereof;

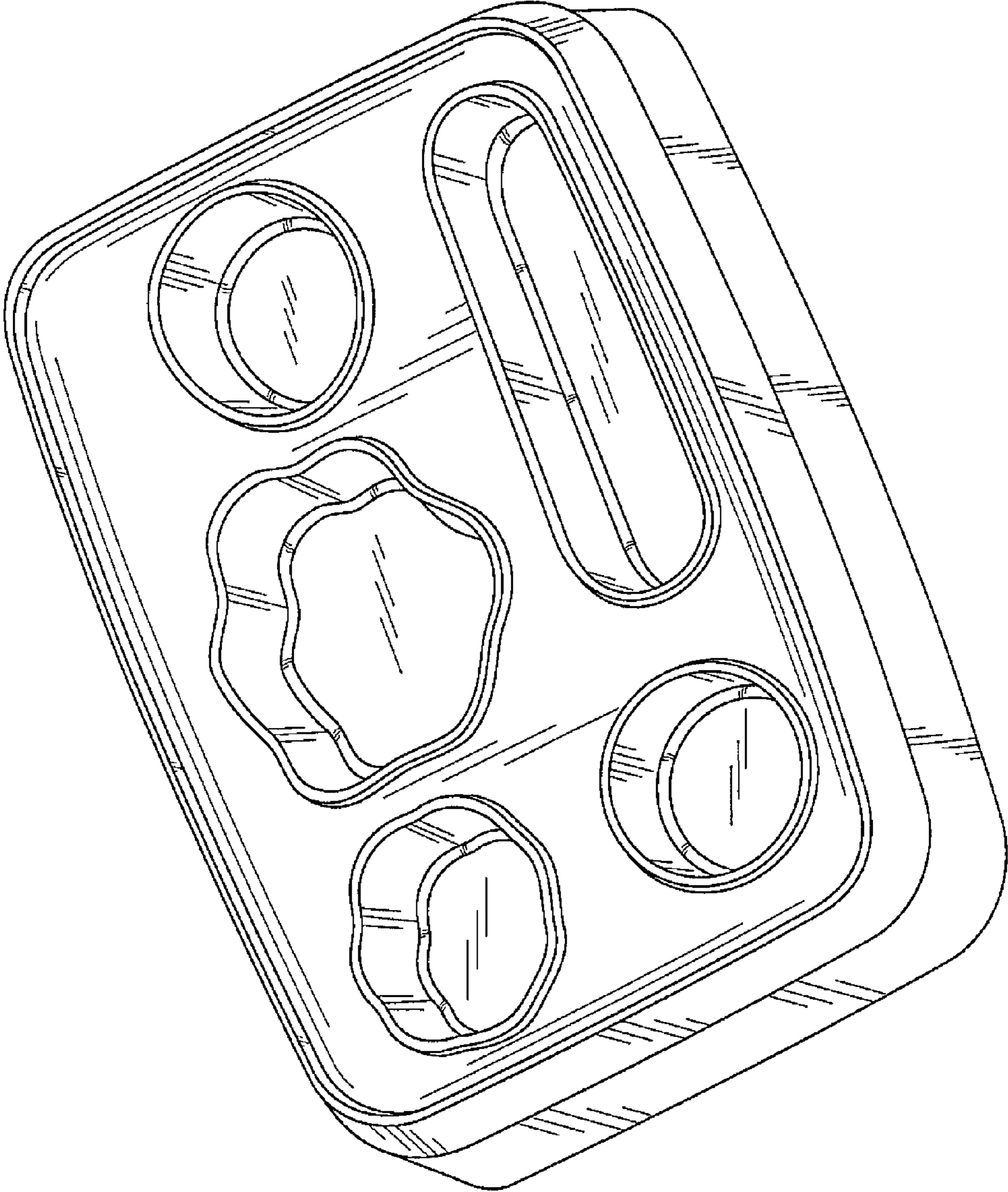

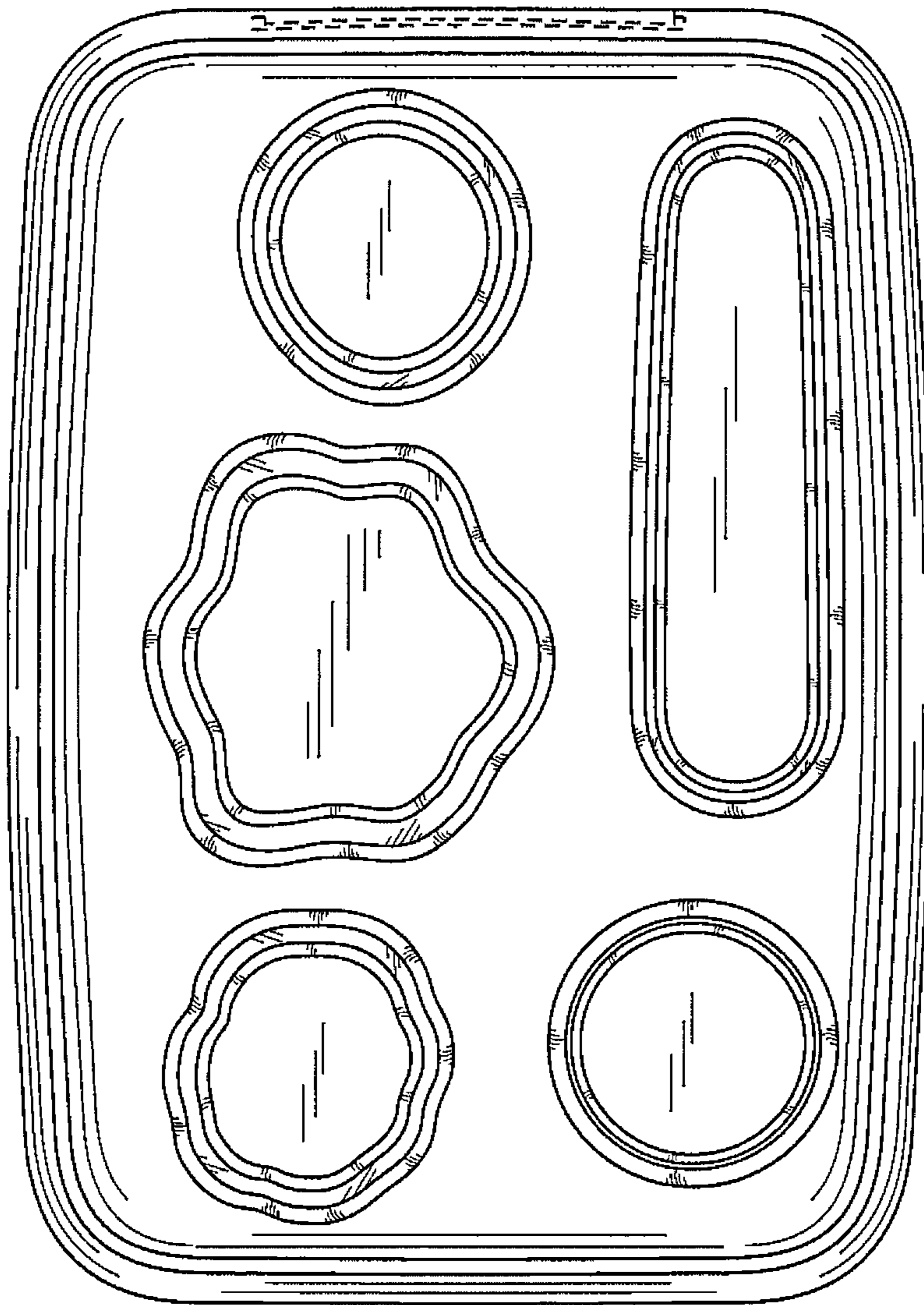

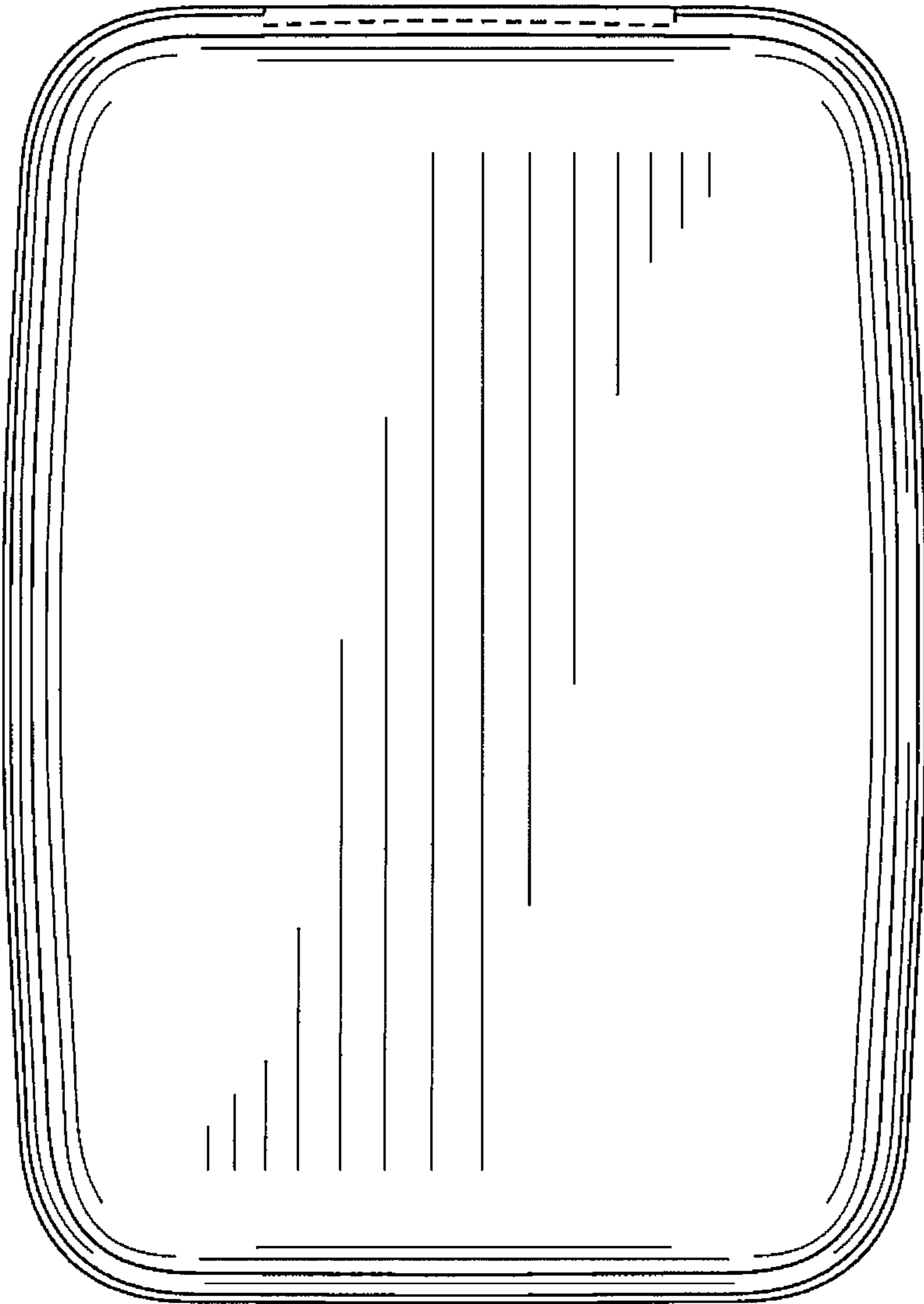

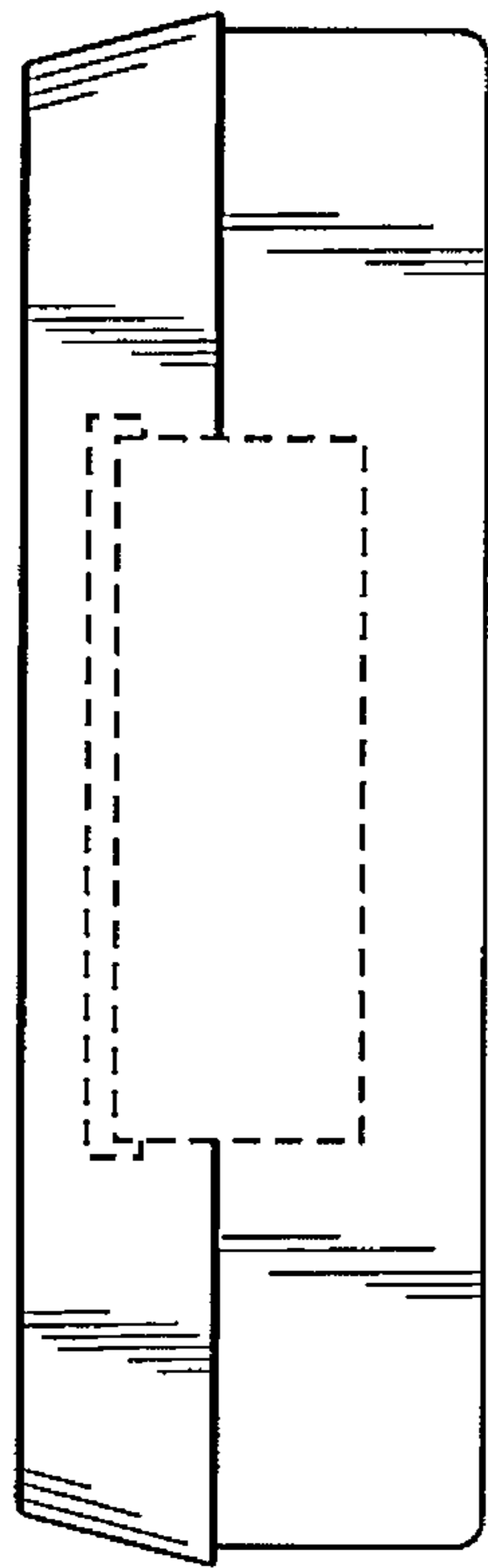

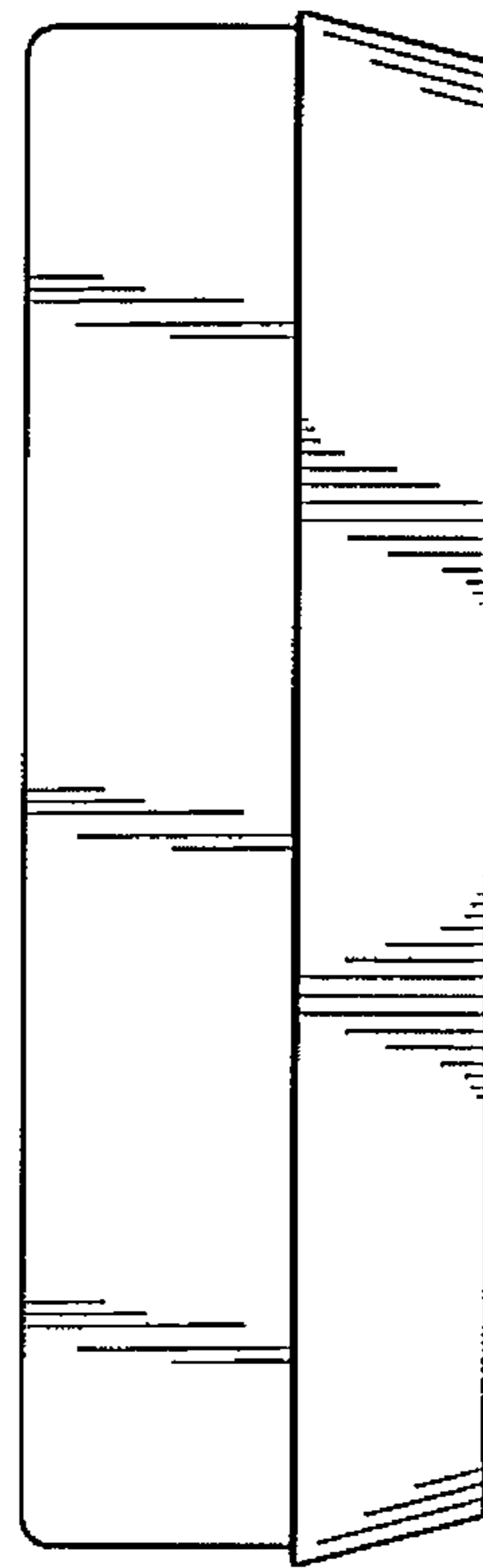

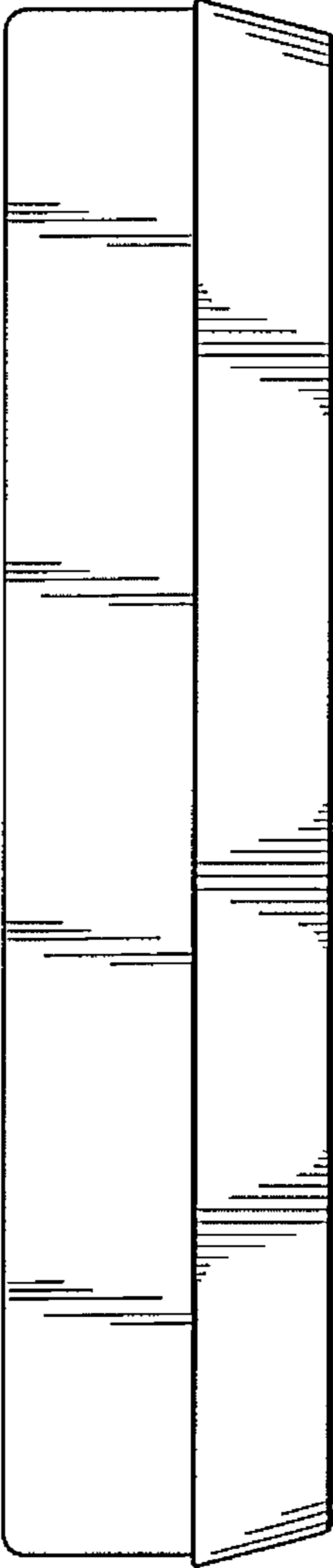
