(57) **CLAIM**

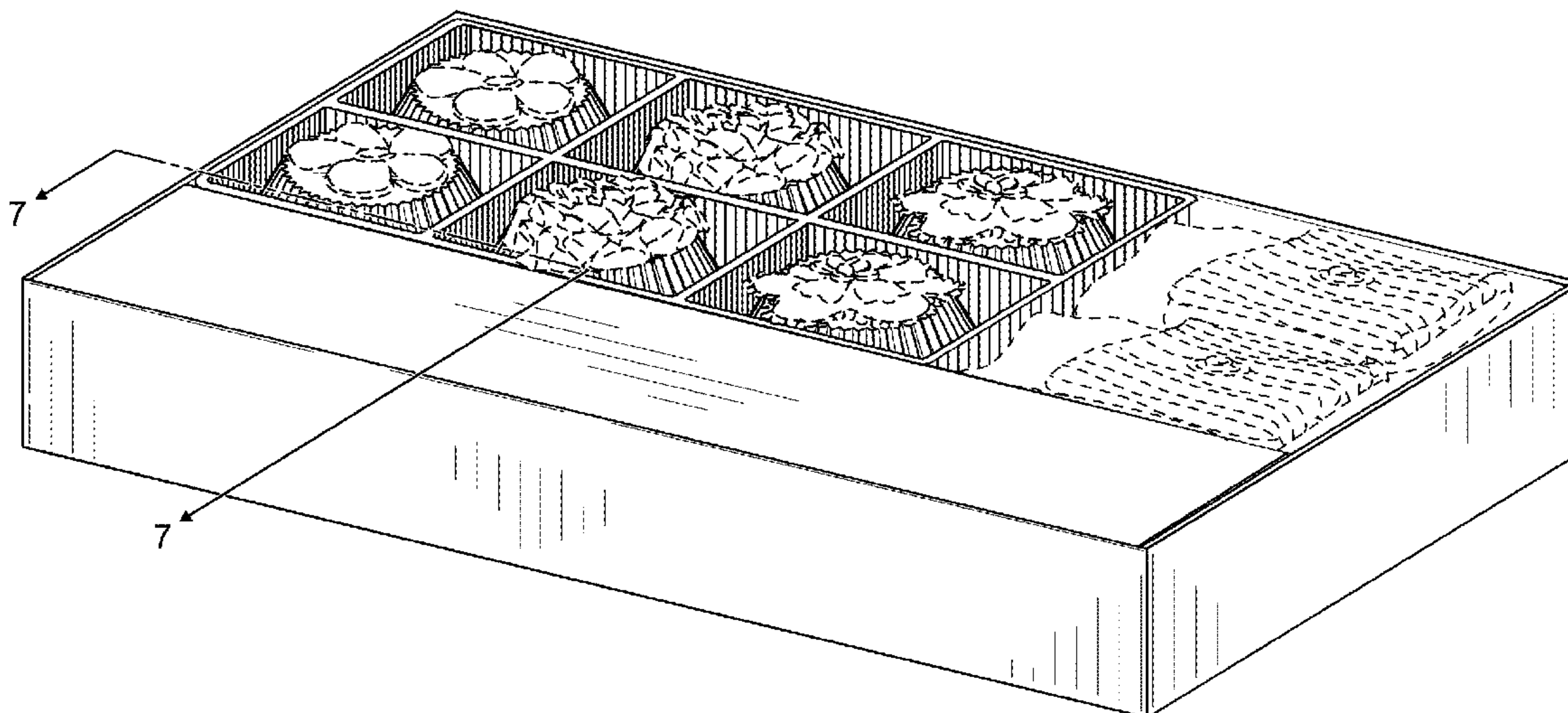
The ornamental design for a gift box arrangement for socks and accessories, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side perspective view of a gift box arrangement for socks and accessories showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a back elevational view thereof; and, FIG. 7 is a top, perspective section view taken along lines 7-7 of FIG. 1.

The broken line showing of the gift box arrangement represents unclaimed subject matter and forms no part of the claimed design.

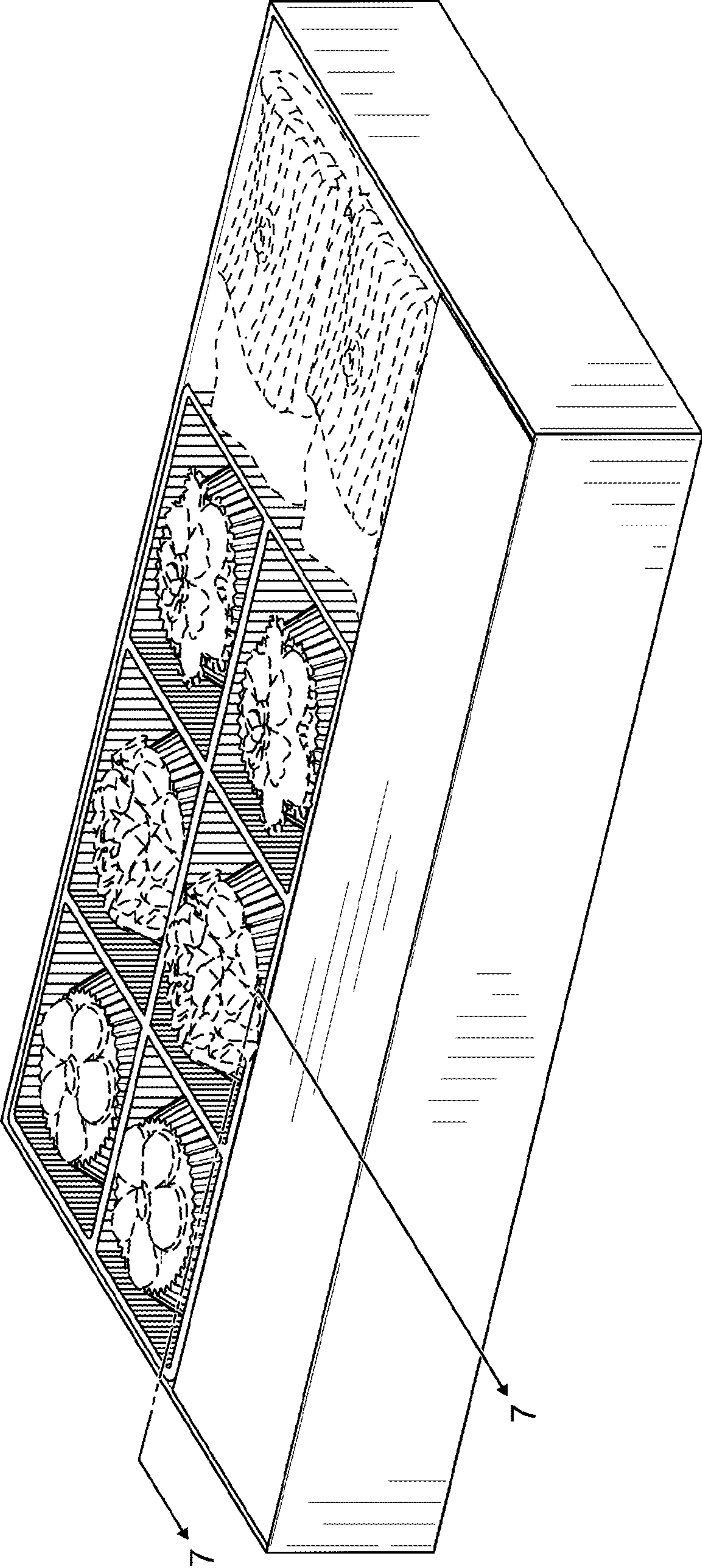

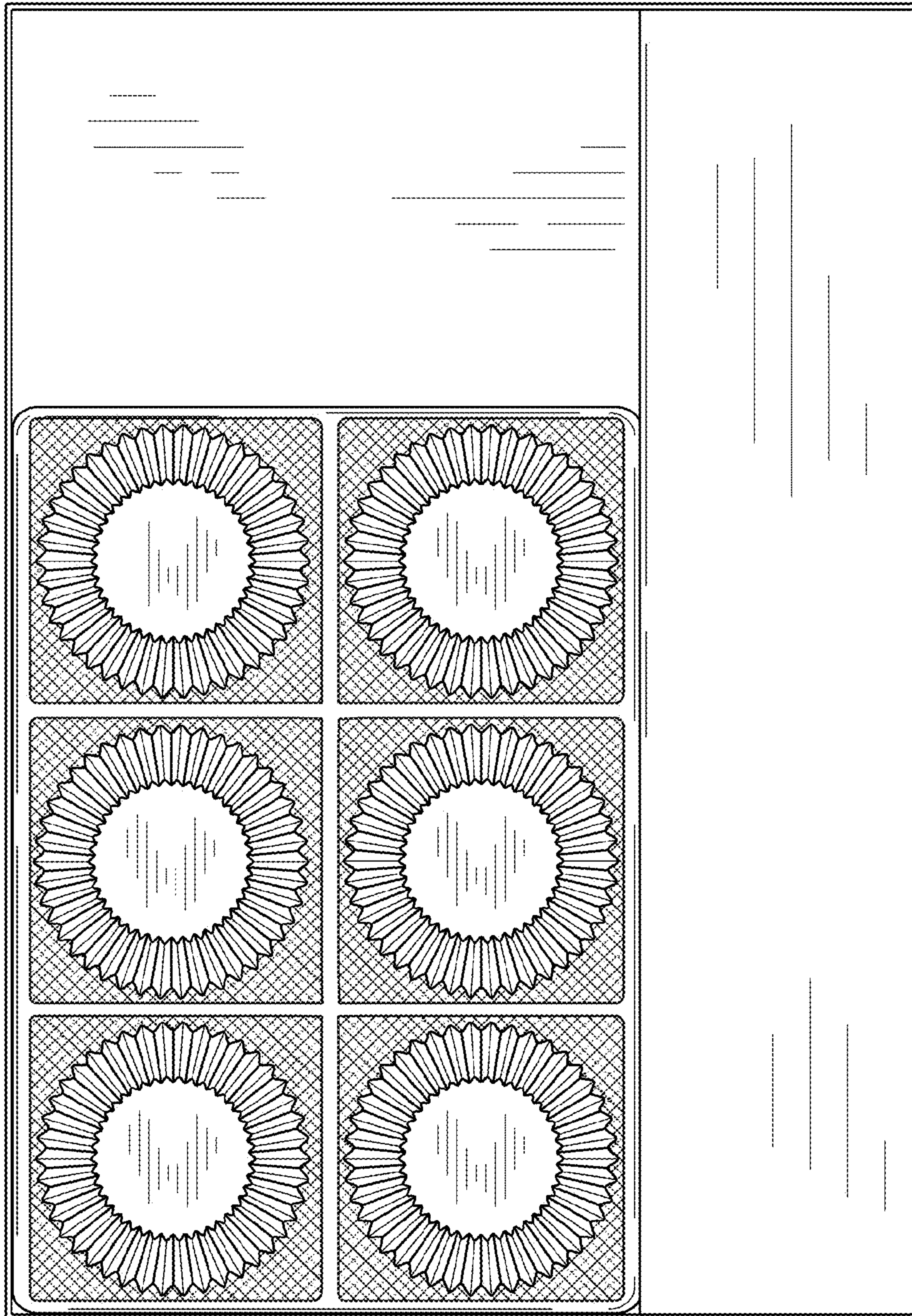

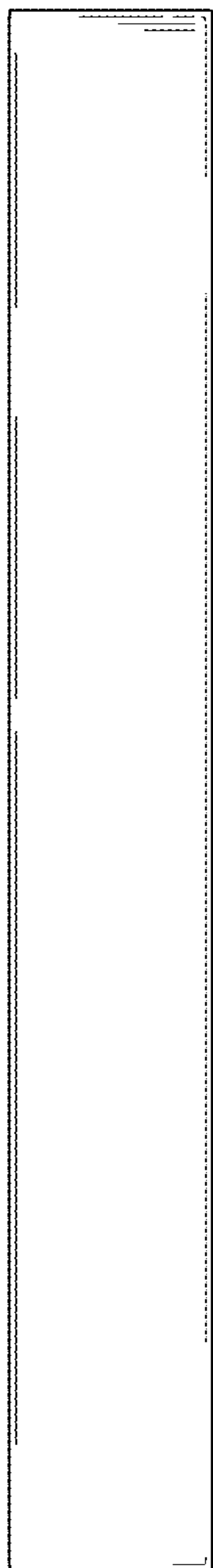

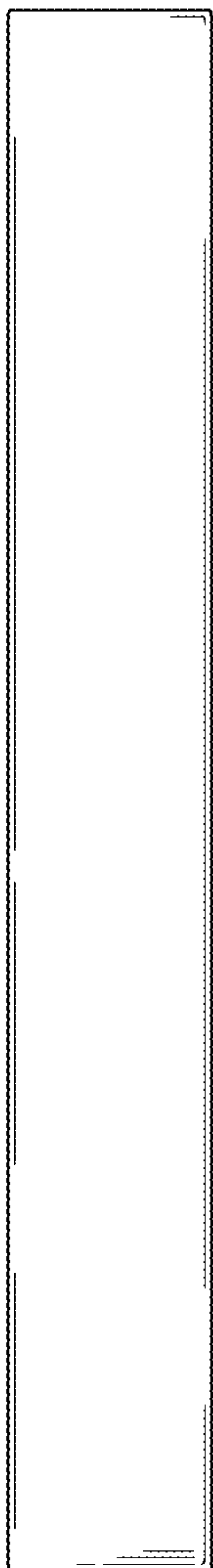

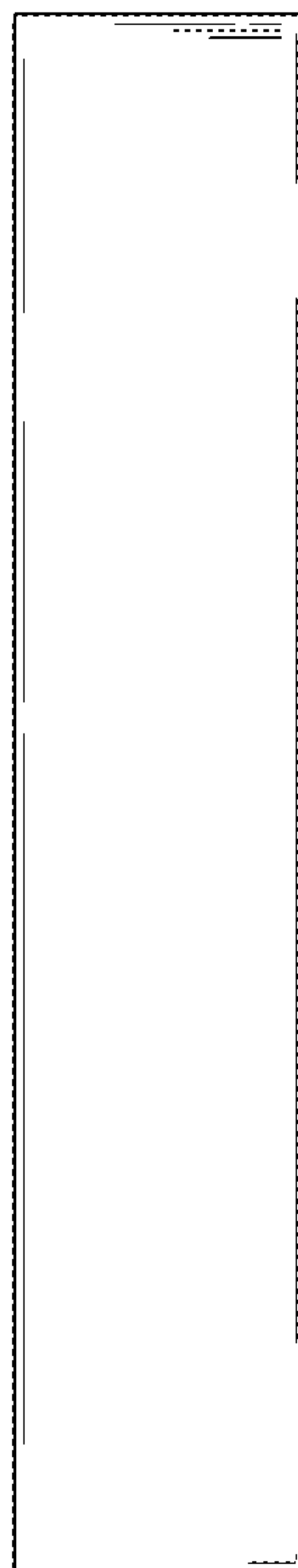

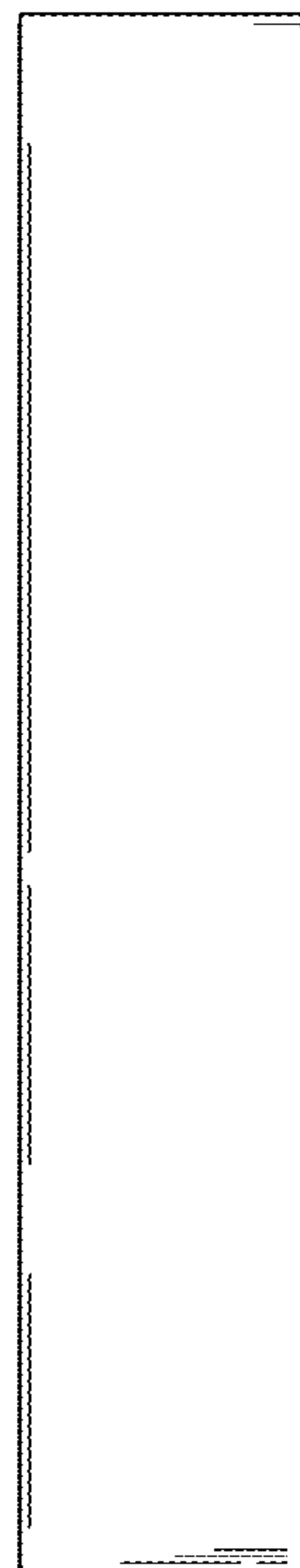

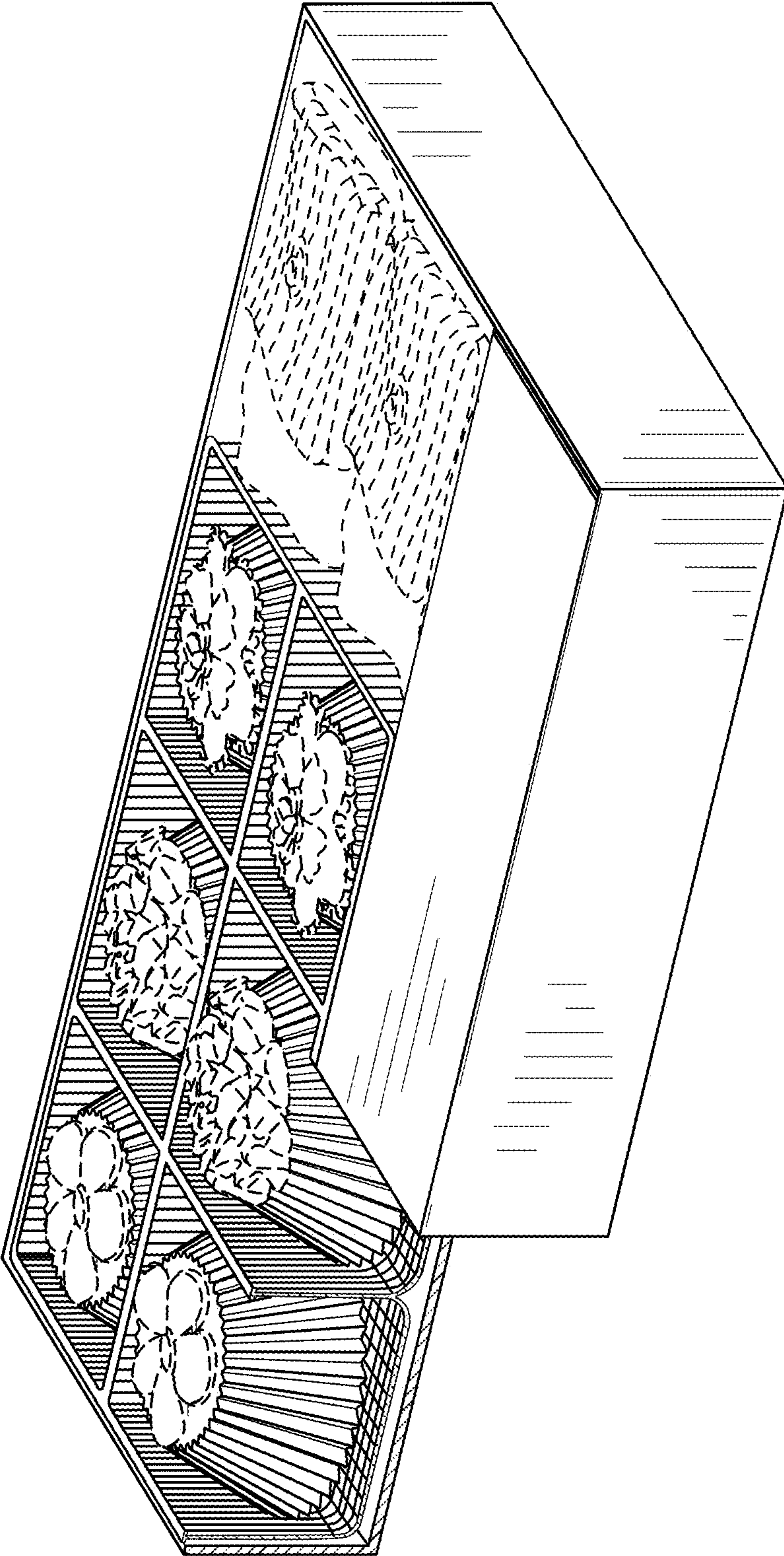
