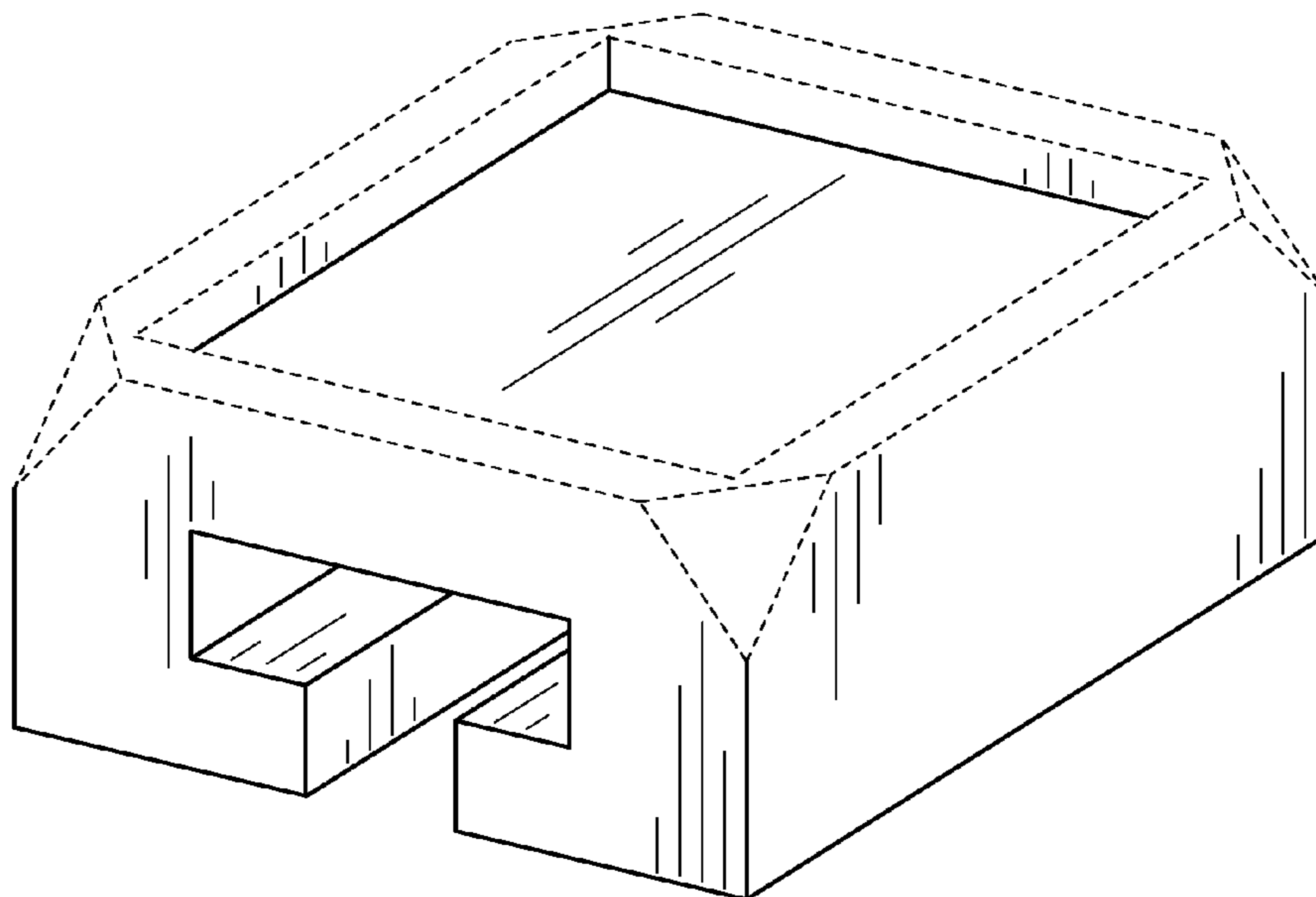
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right top perspective view of my new design for a wrist band charm;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a right-side elevation view thereof;
FIG. 7 is a left-side elevation view thereof; and,
FIG. 8 is a rear left bottom perspective view thereof.

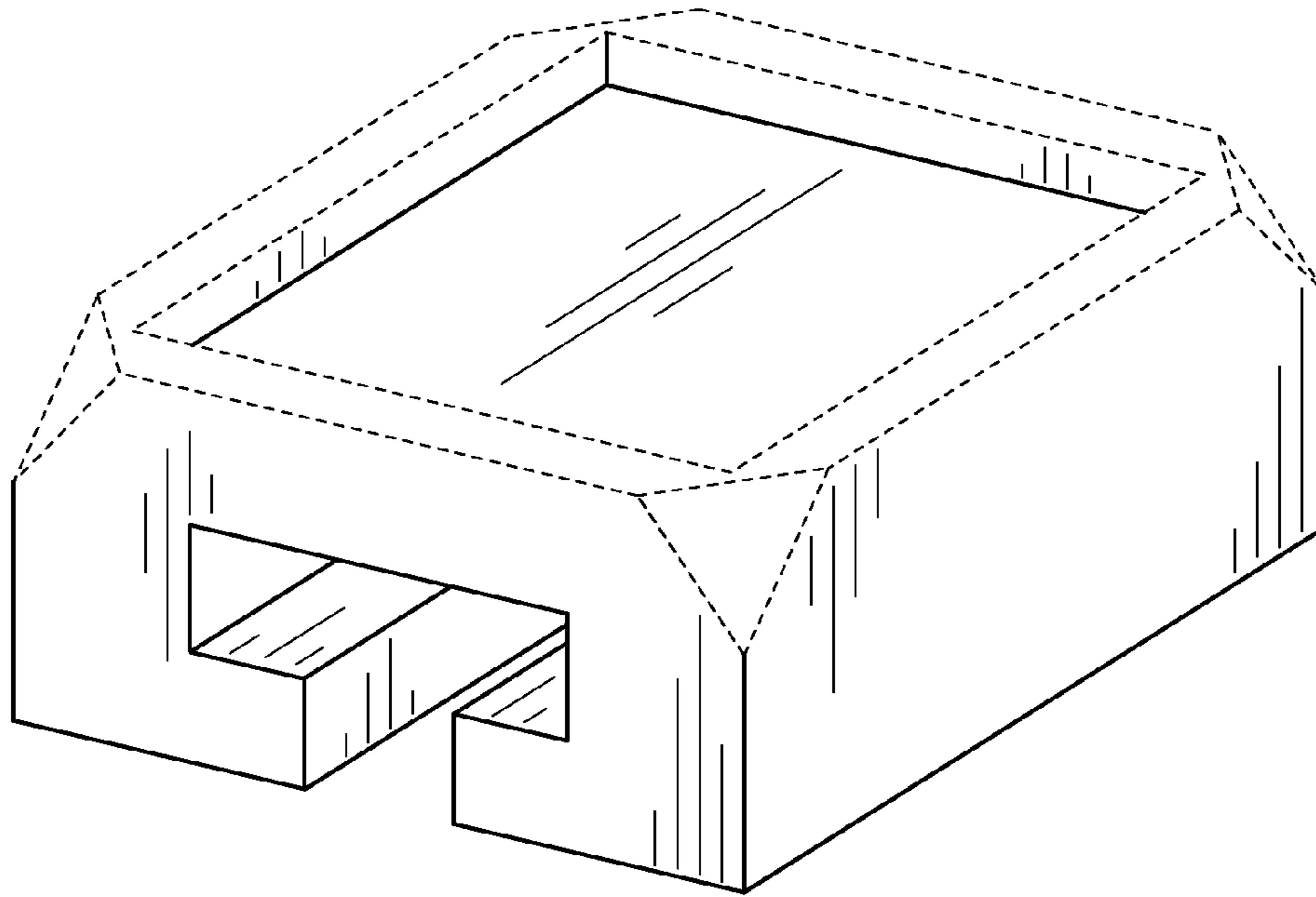

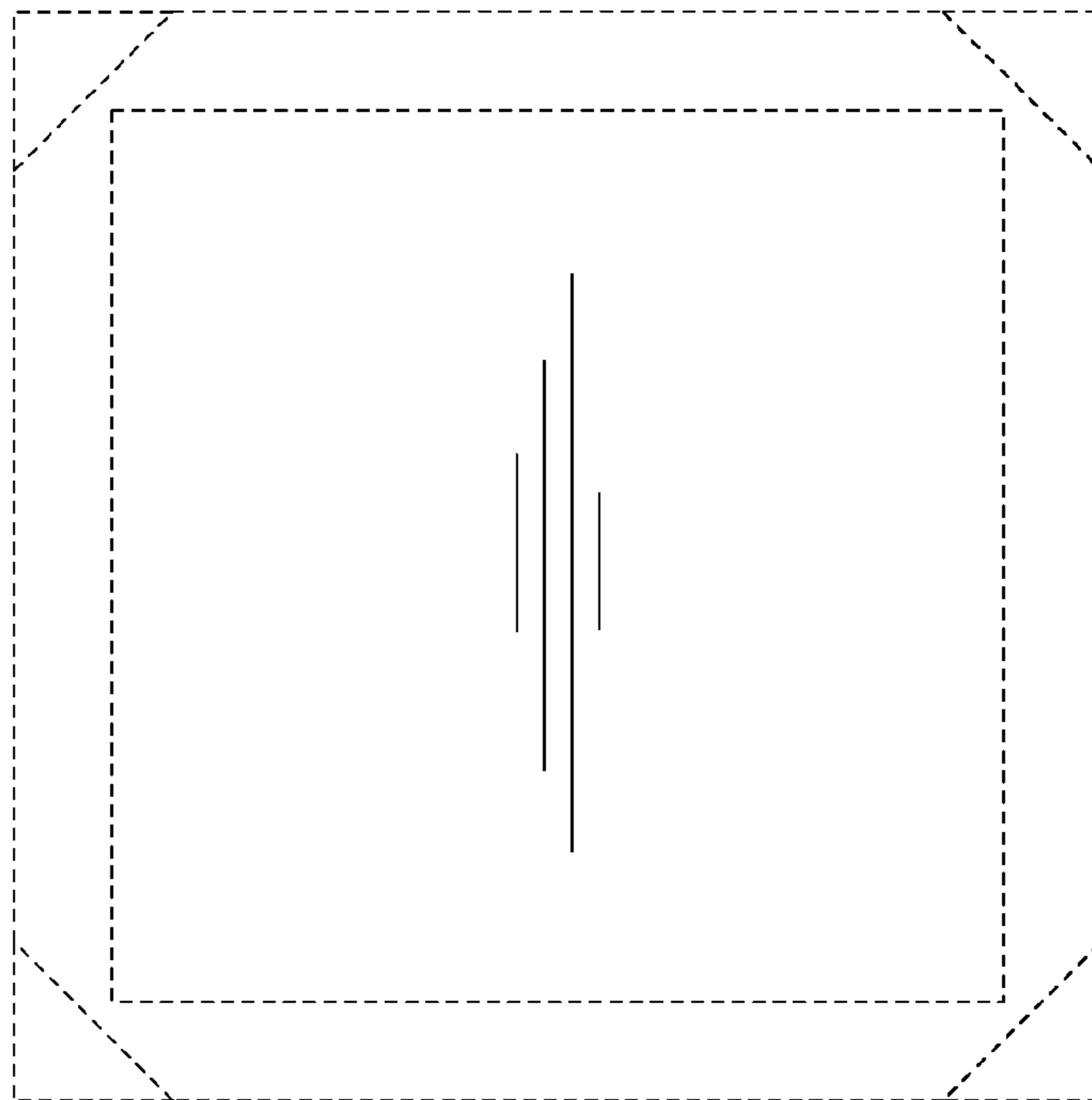

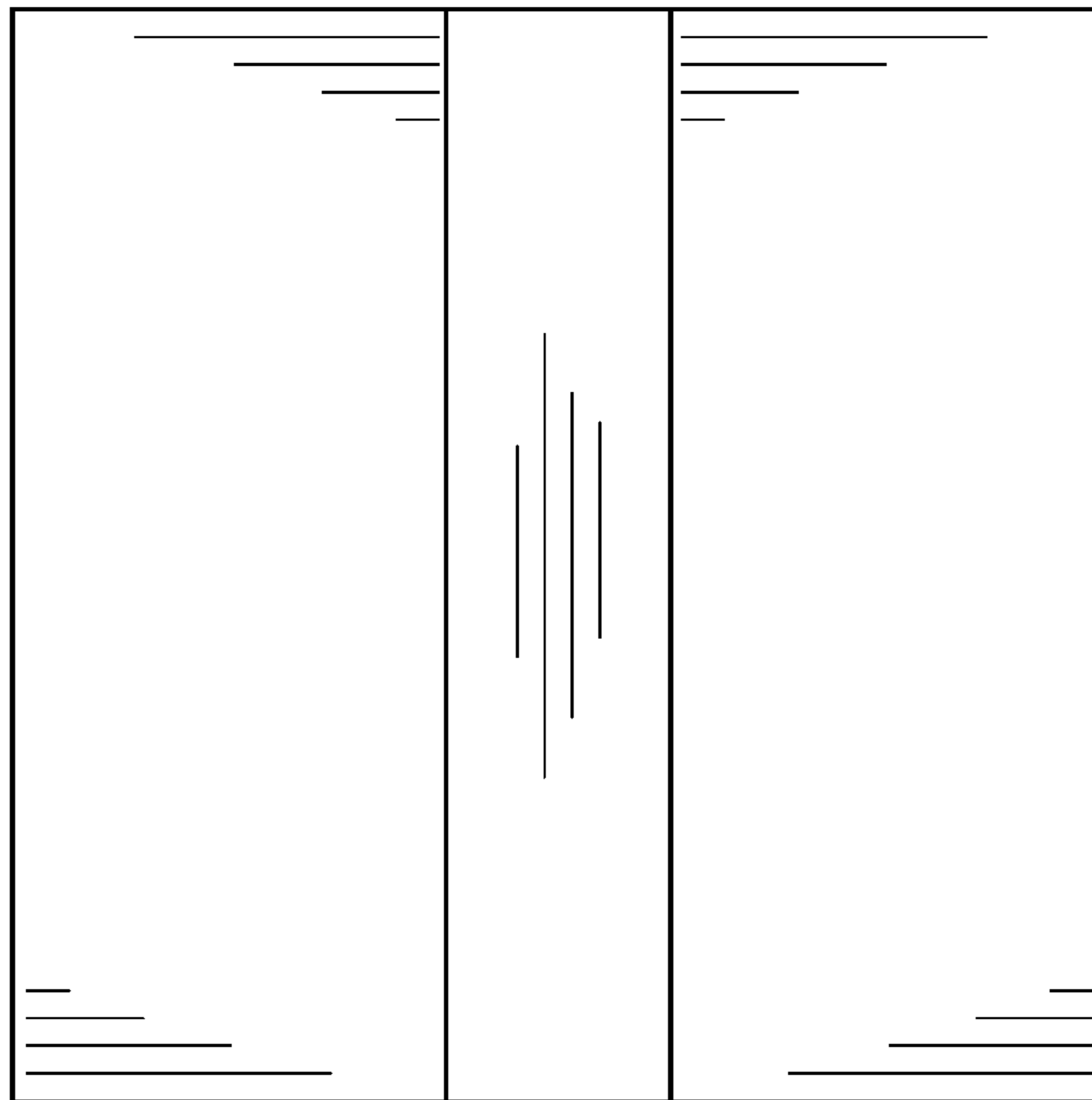

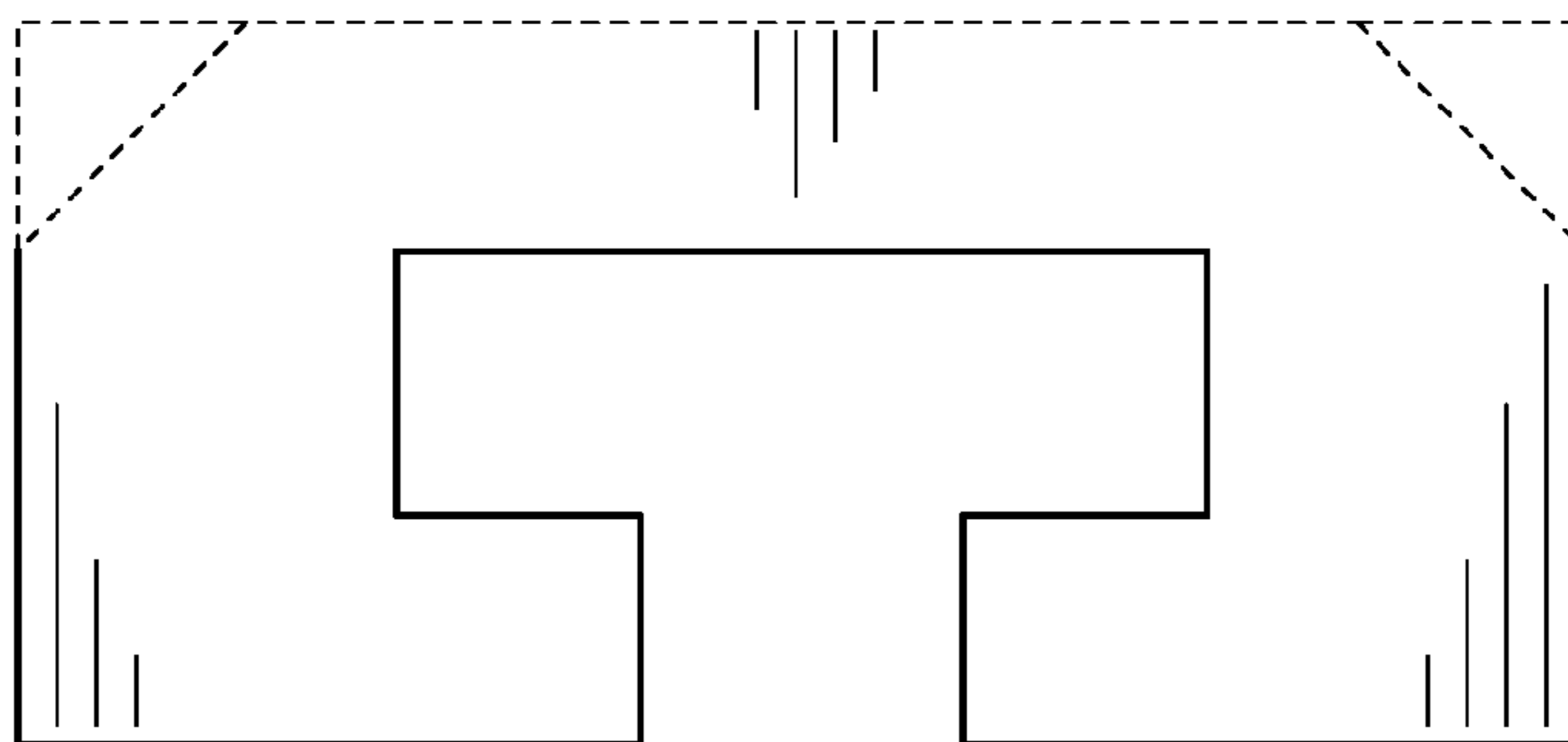

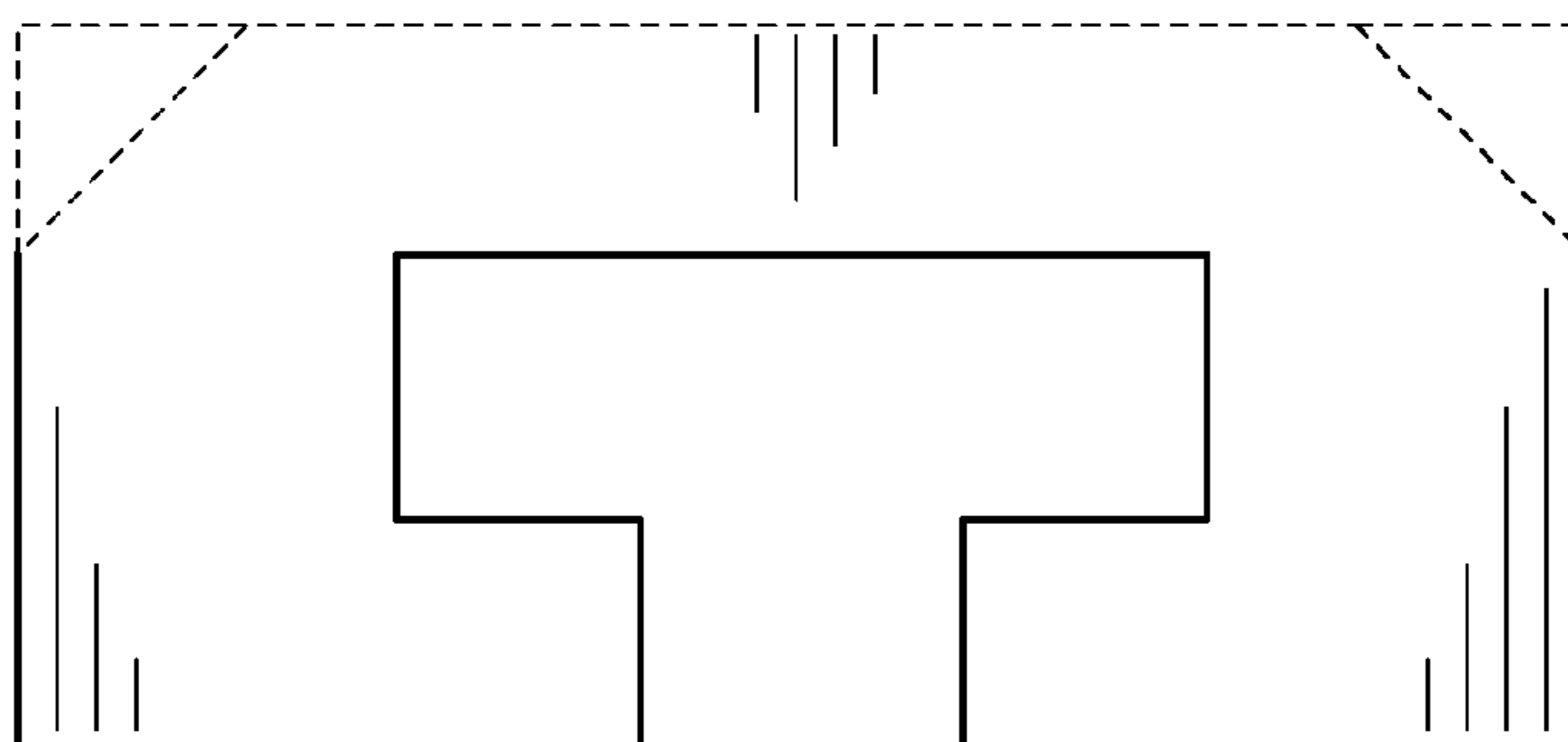

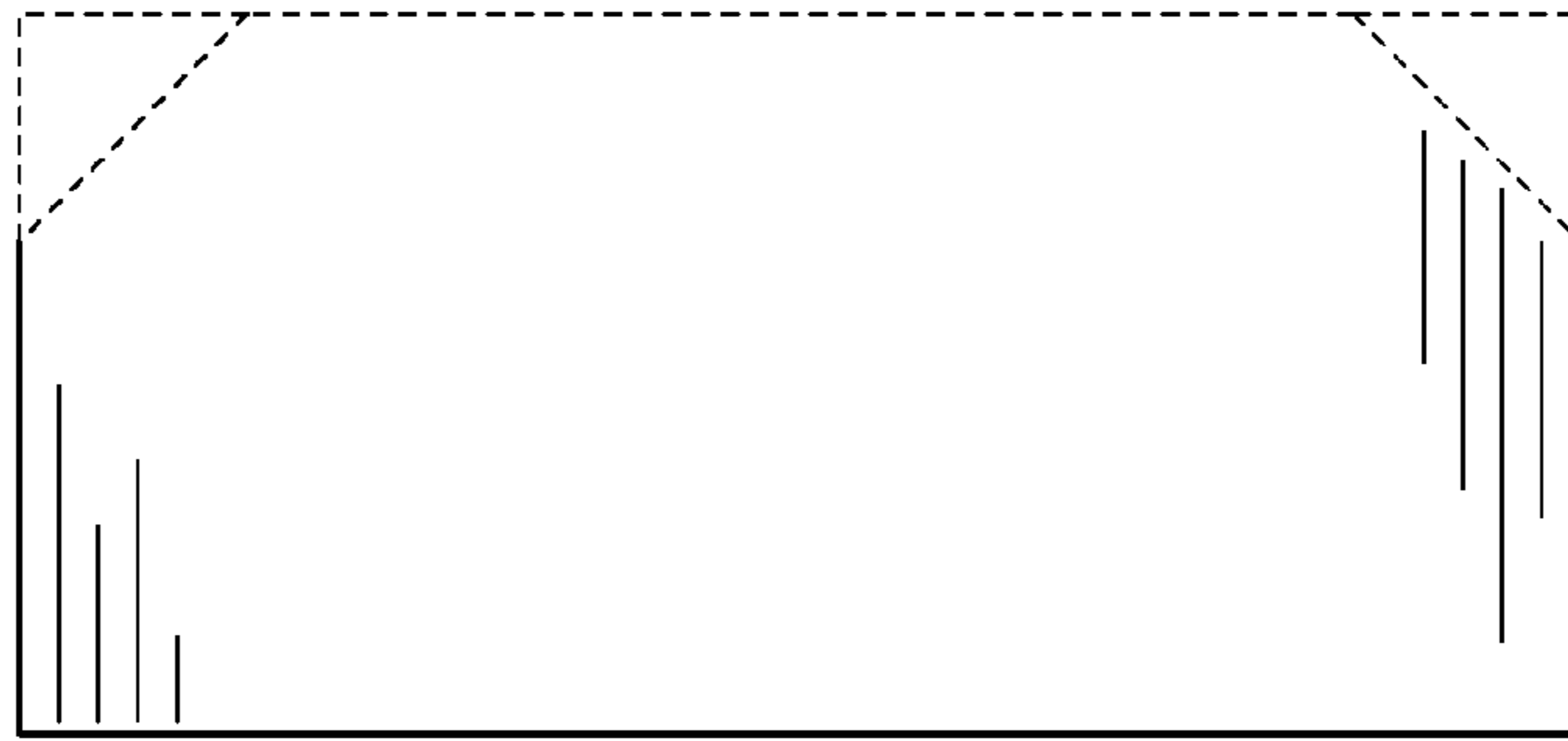

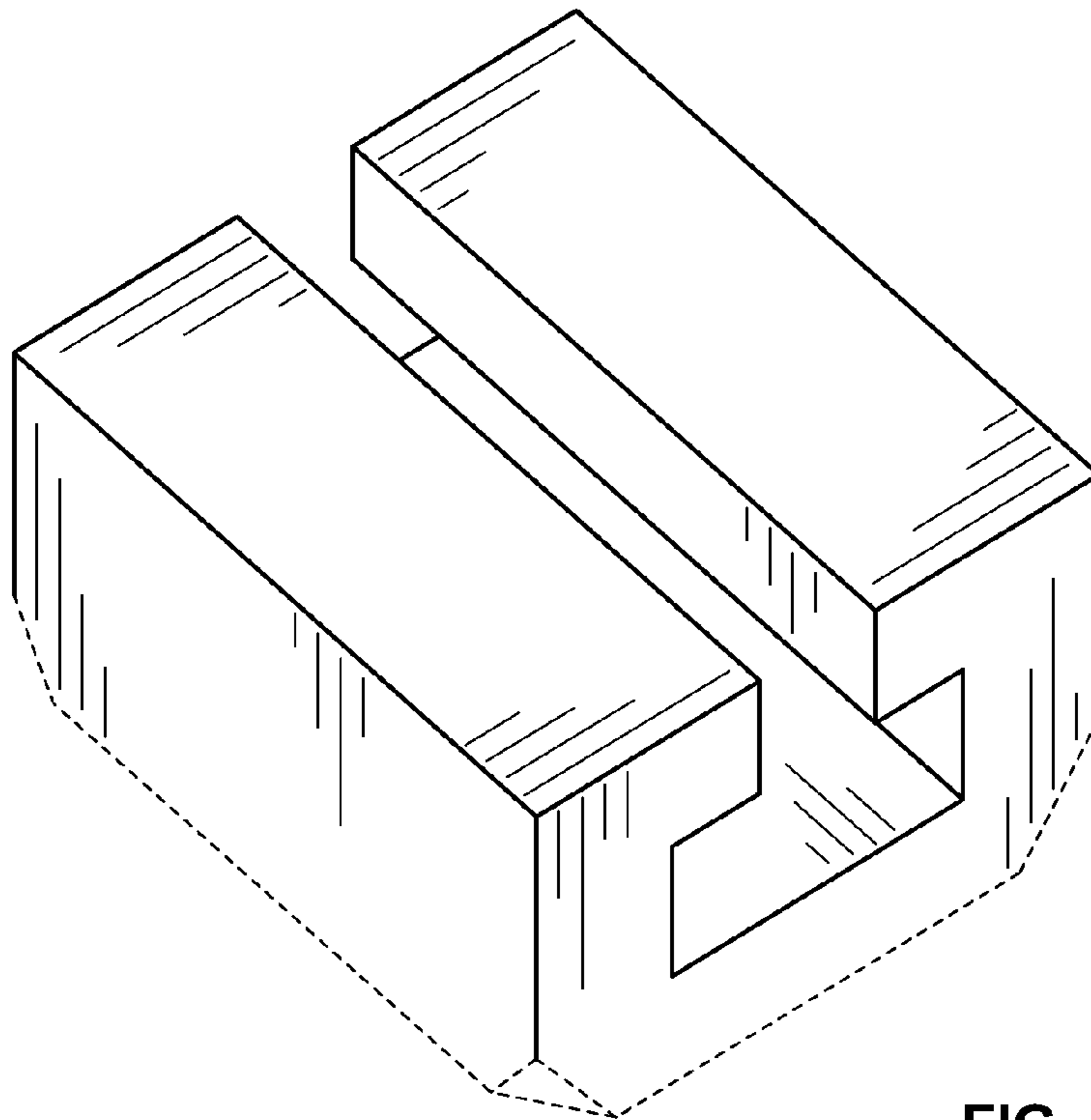
