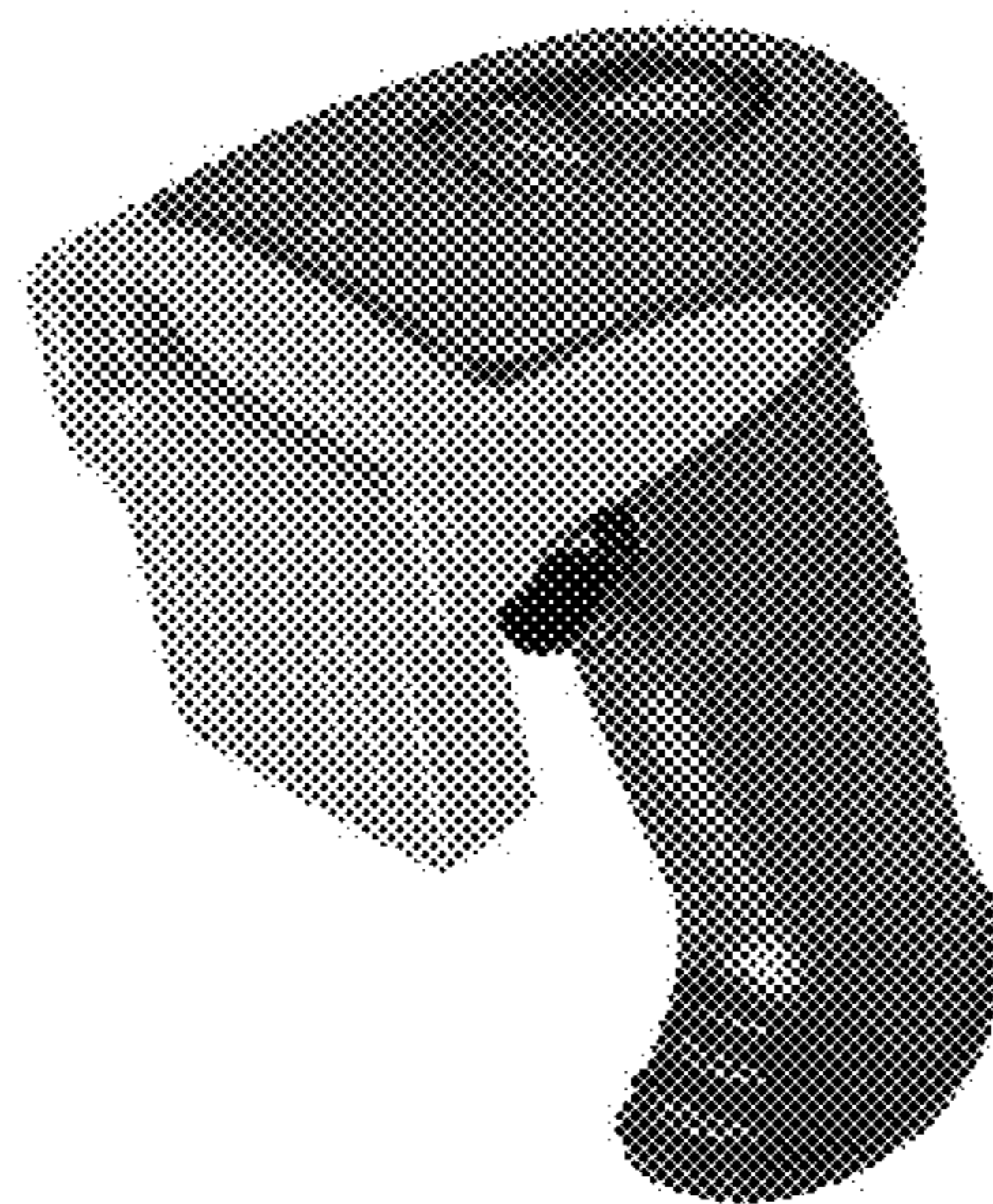

The ornamental design for a barcode scanner and radio frequency identification reader combo, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a barcode scanner and radio frequency identification reader combo of my new design; FIG. 2 is a front view of the barcode scanner and radio frequency identification reader combo thereof; FIG. 3 is a rear view of the barcode scanner and radio frequency identification reader combo thereof; FIG. 4 is a top view of the barcode scanner and radio frequency identification reader combo thereof; and, FIG. 5 is a left view of the barcode scanner and radio frequency identification reader combo thereof.

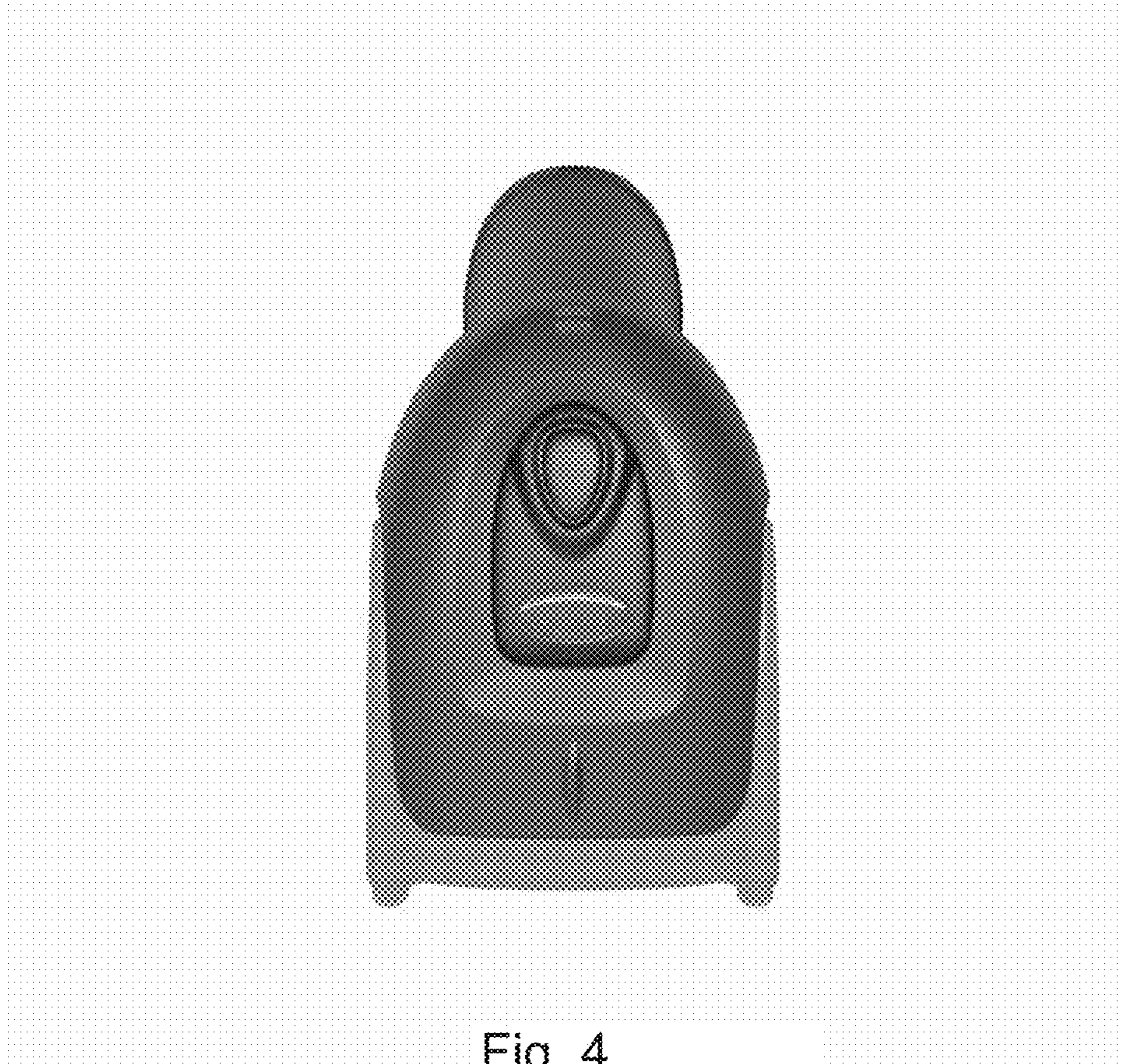
