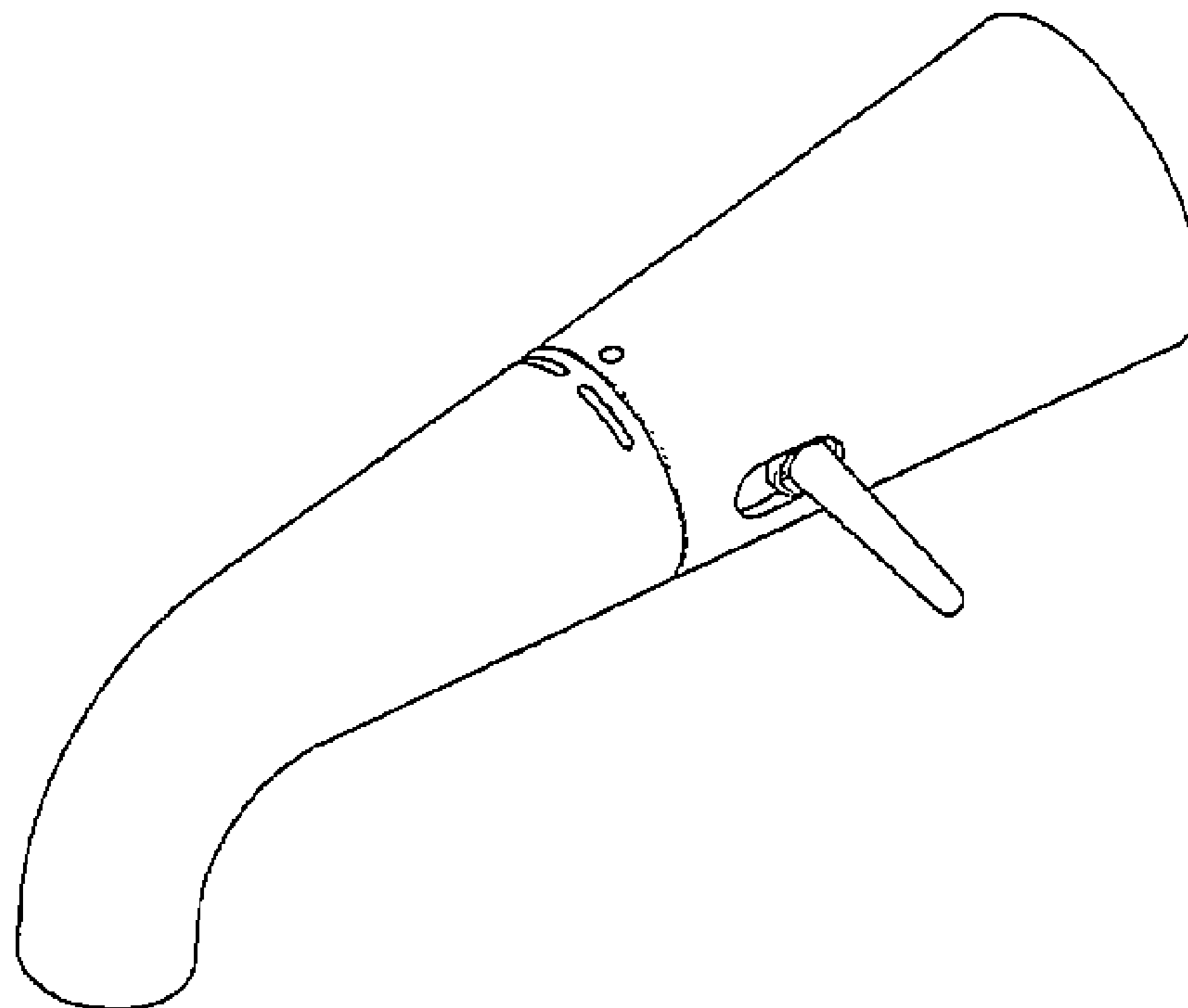
(57) **CLAIM**

I claim the ornamental design for a mixer tap, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a mixer tap showing my new design;

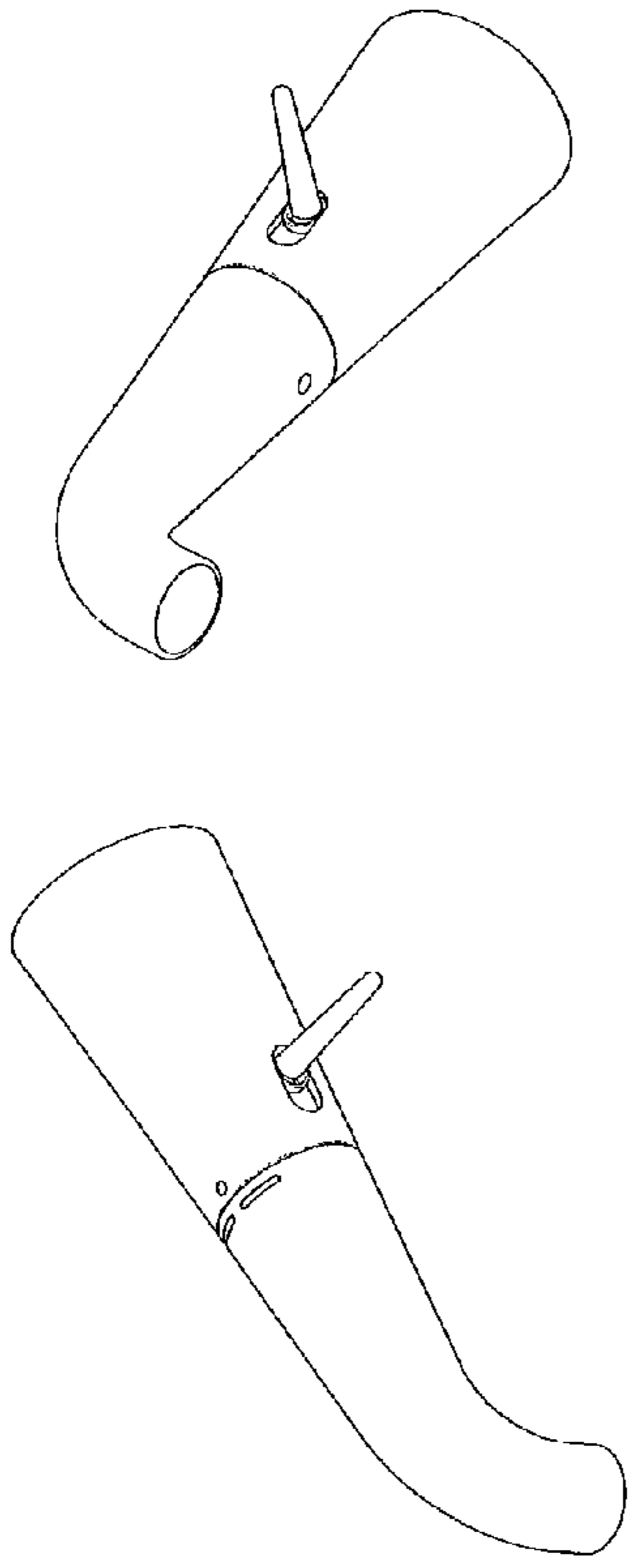

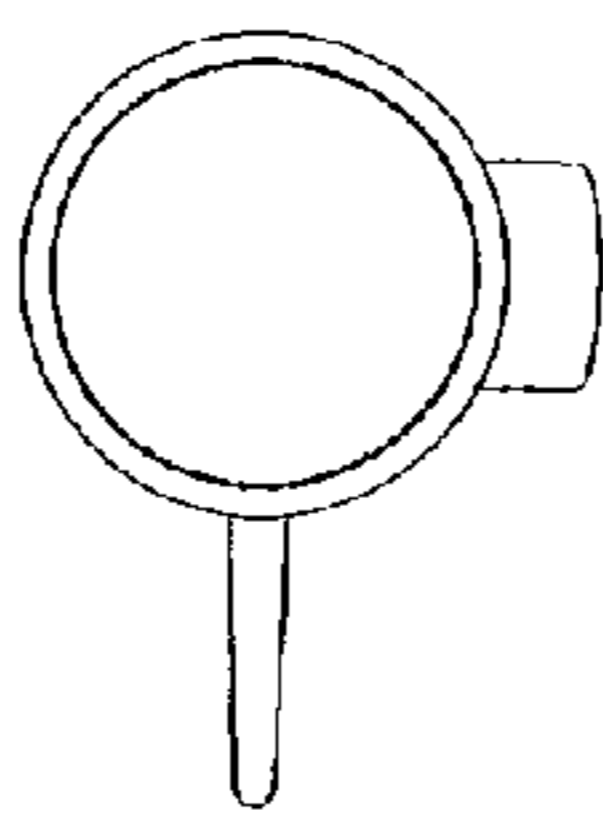

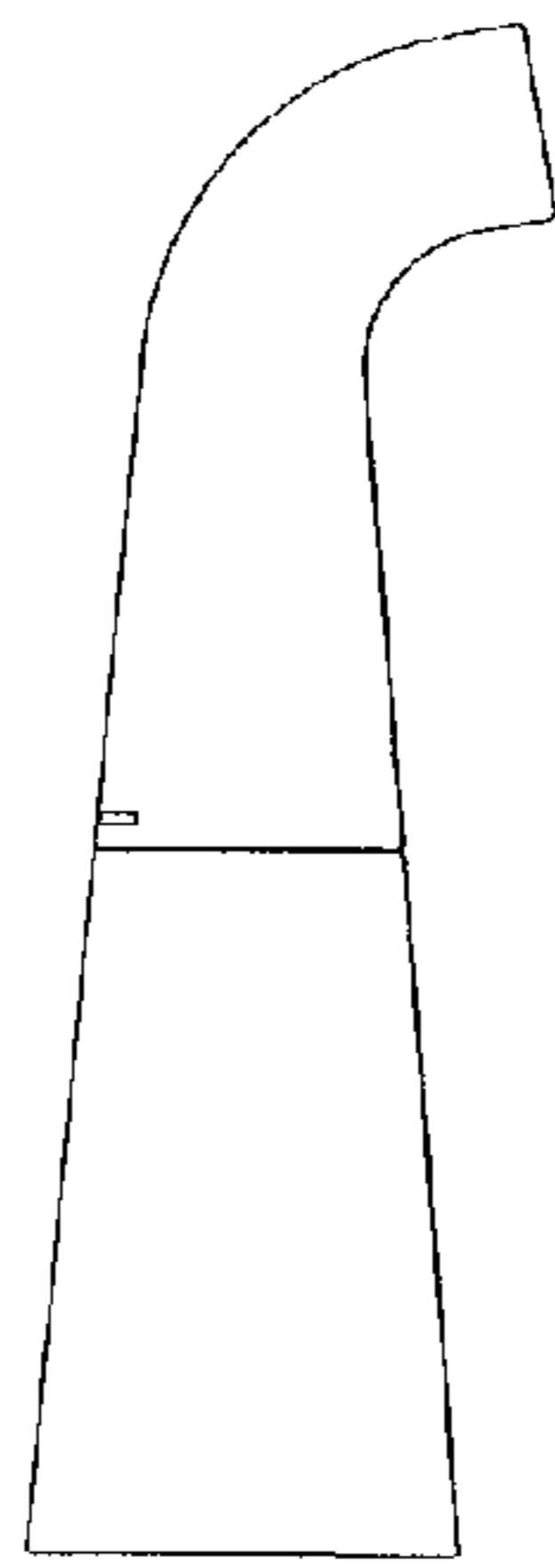

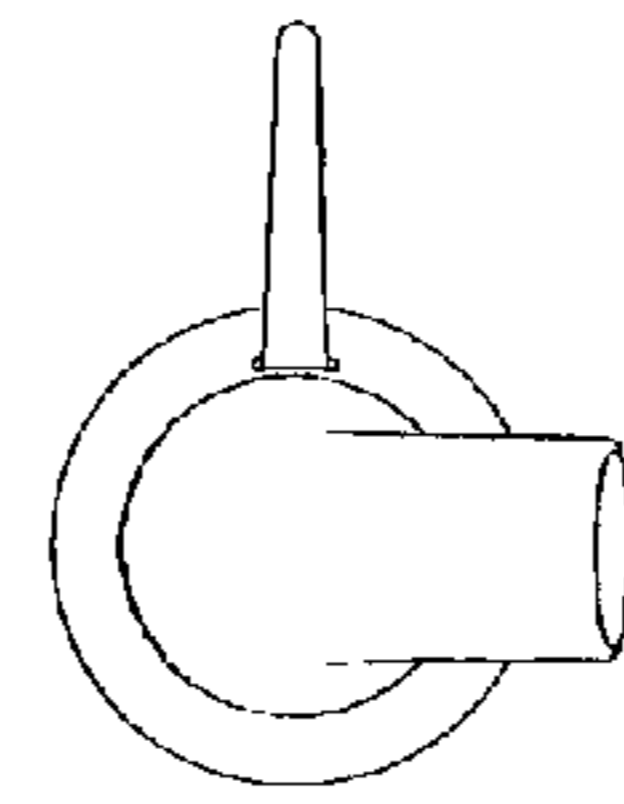

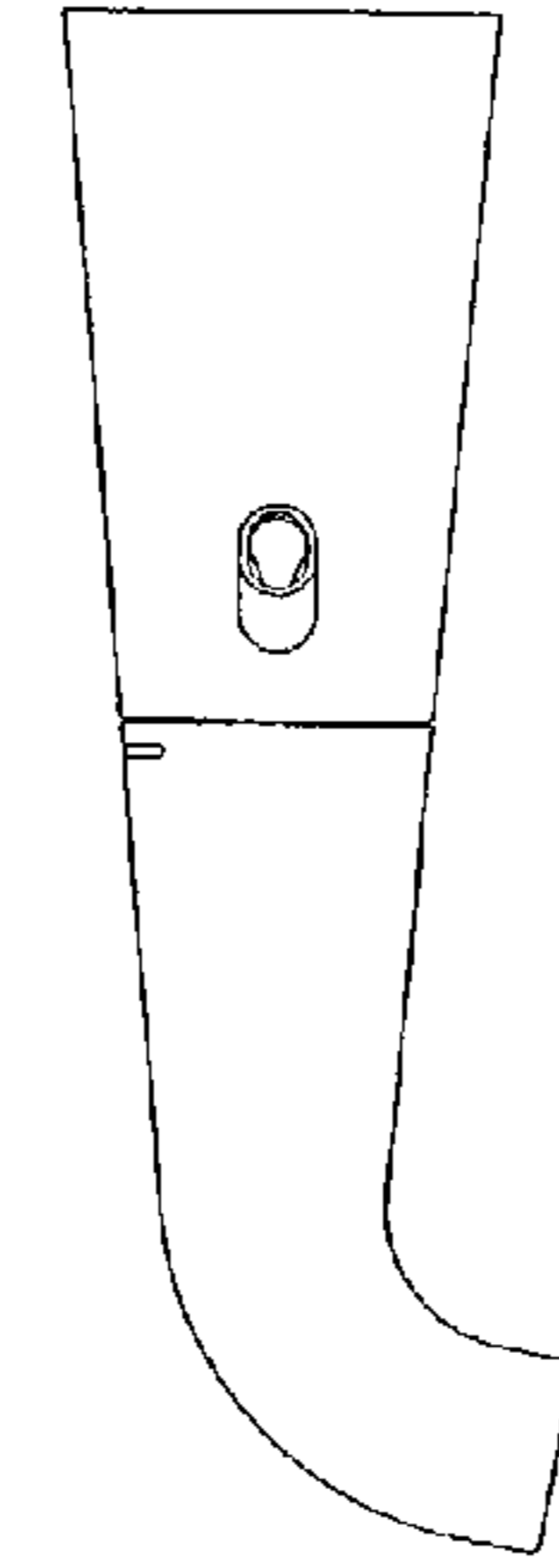

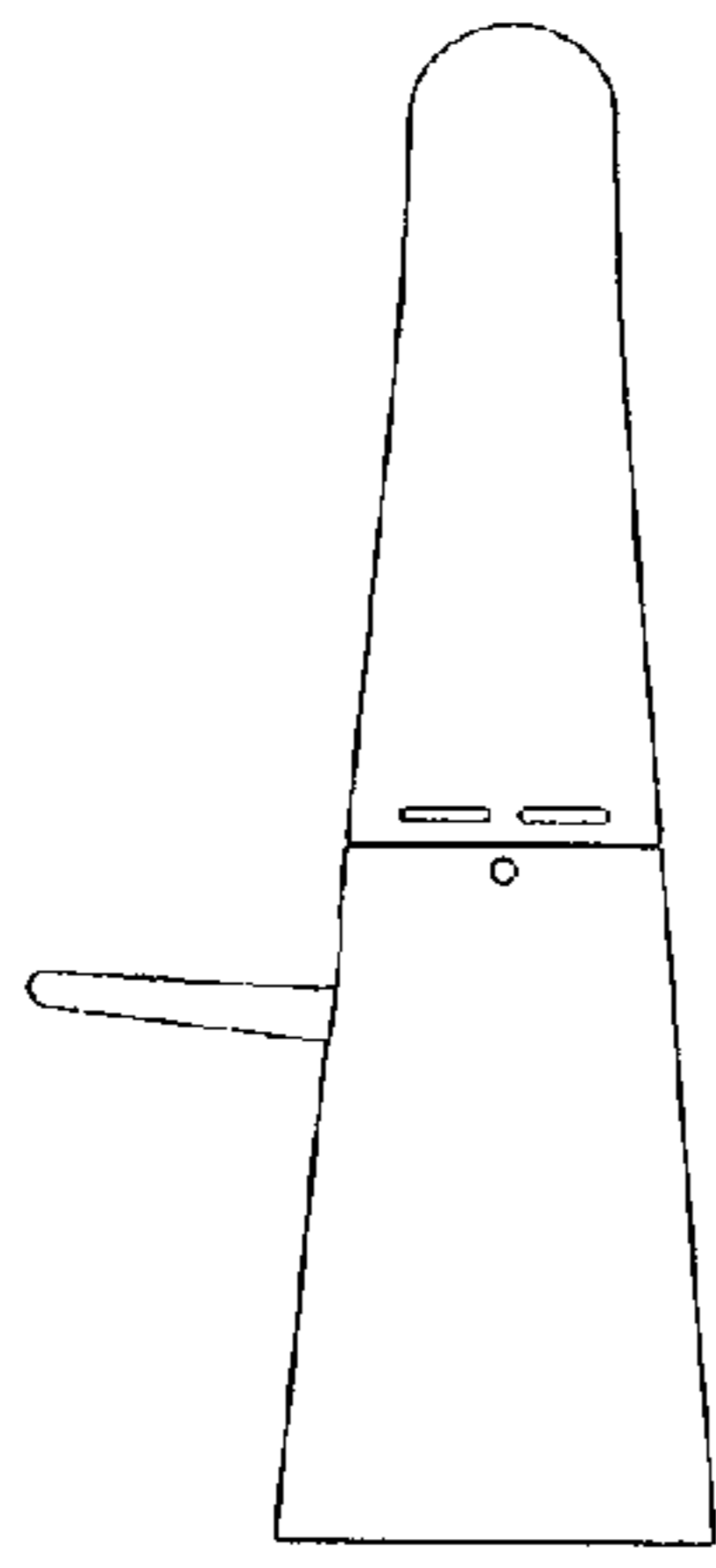

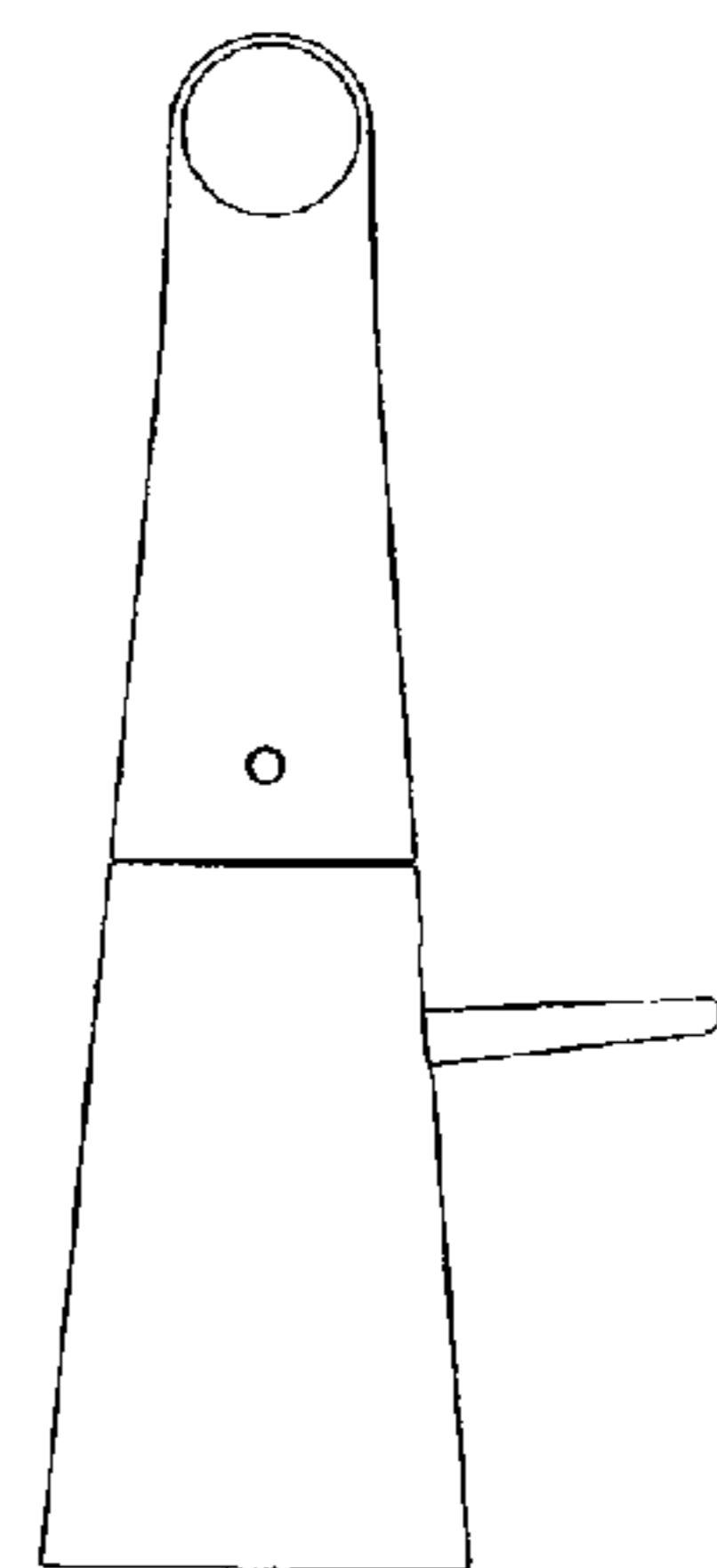
