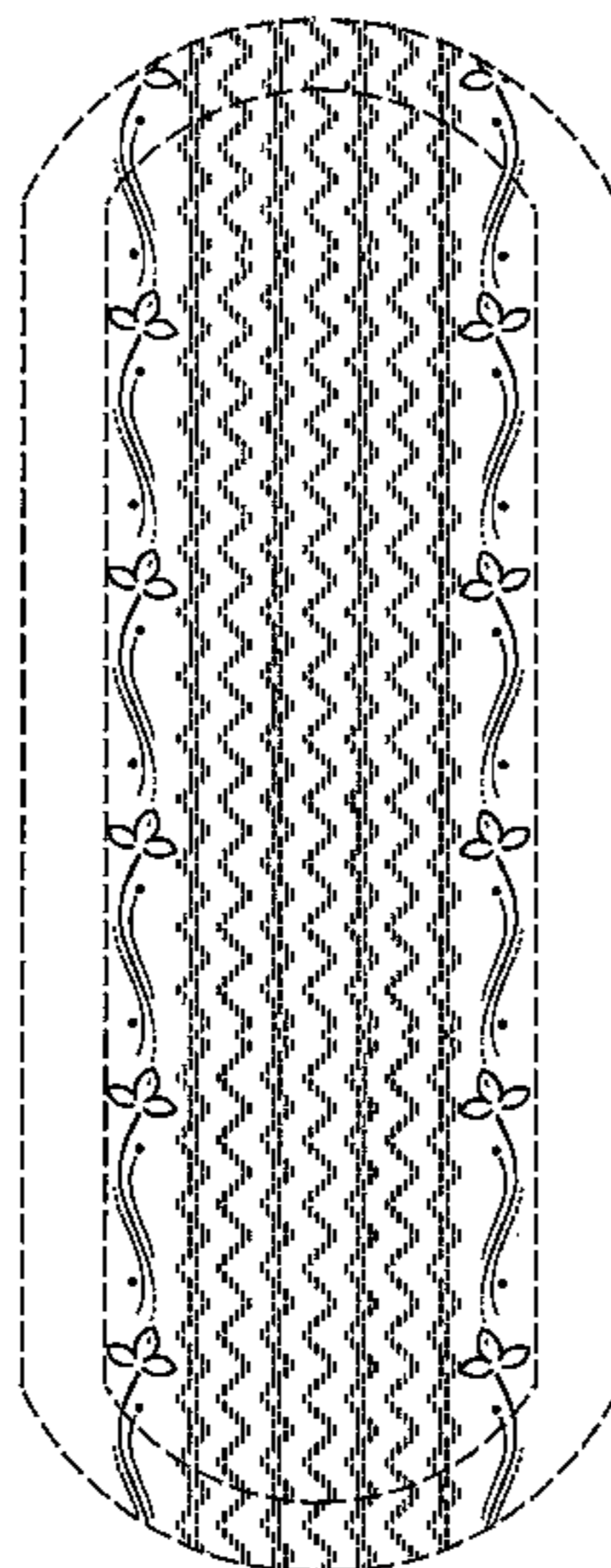

The embossing (the seven stripes in the center of the design)
is shown in FIG. 1 and FIG. 2 in hashed form to represent a
distinction between the printing and the embossing, and the
embossing forms part of the claimed design of FIG. 1 and
FIG. 2.

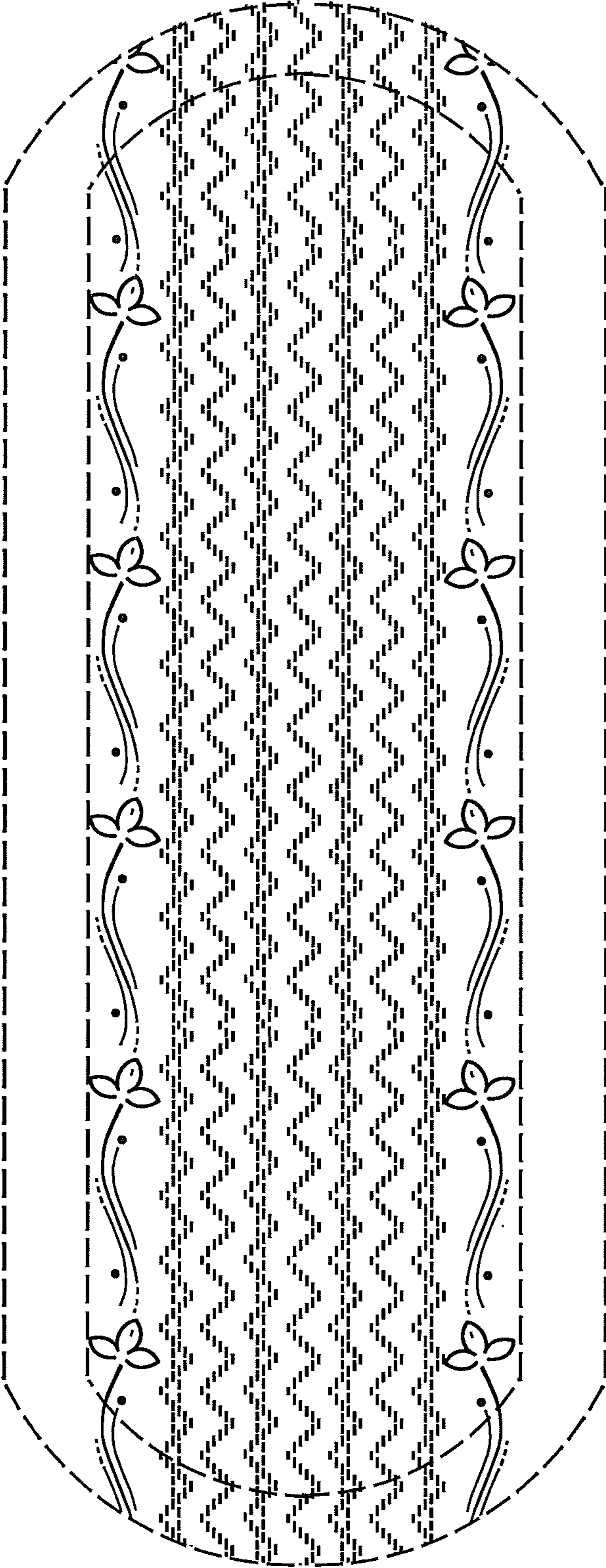

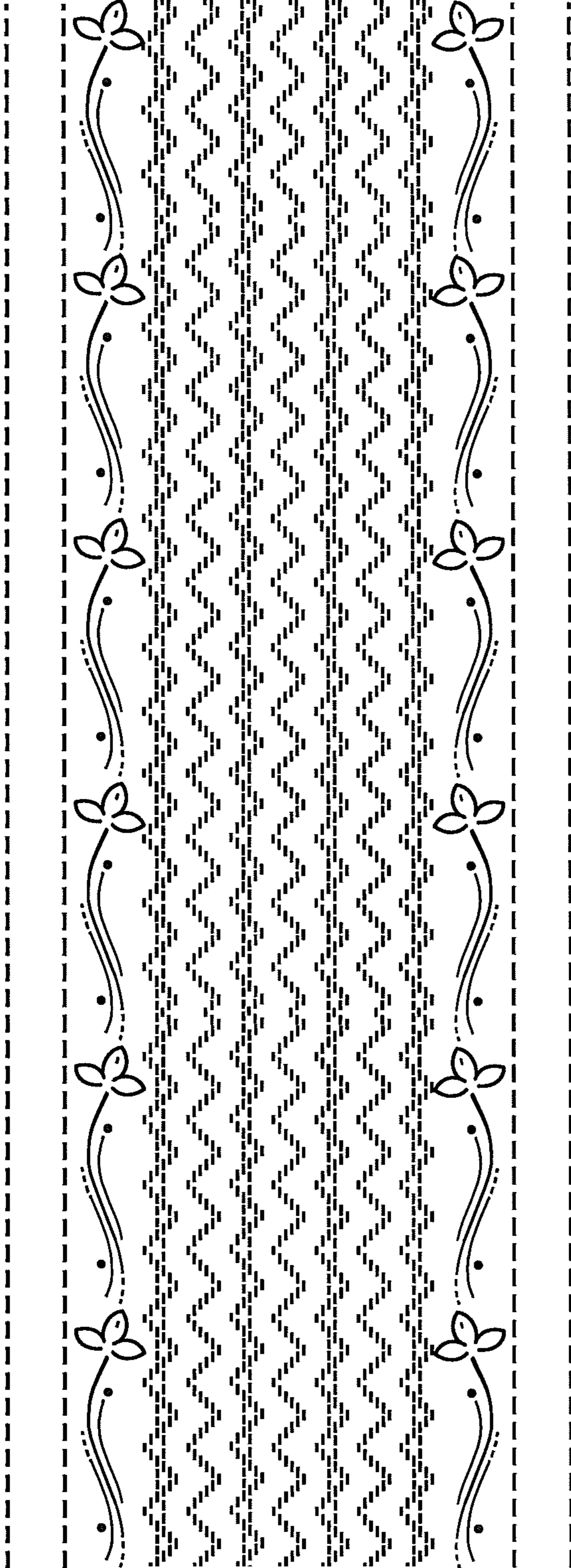
