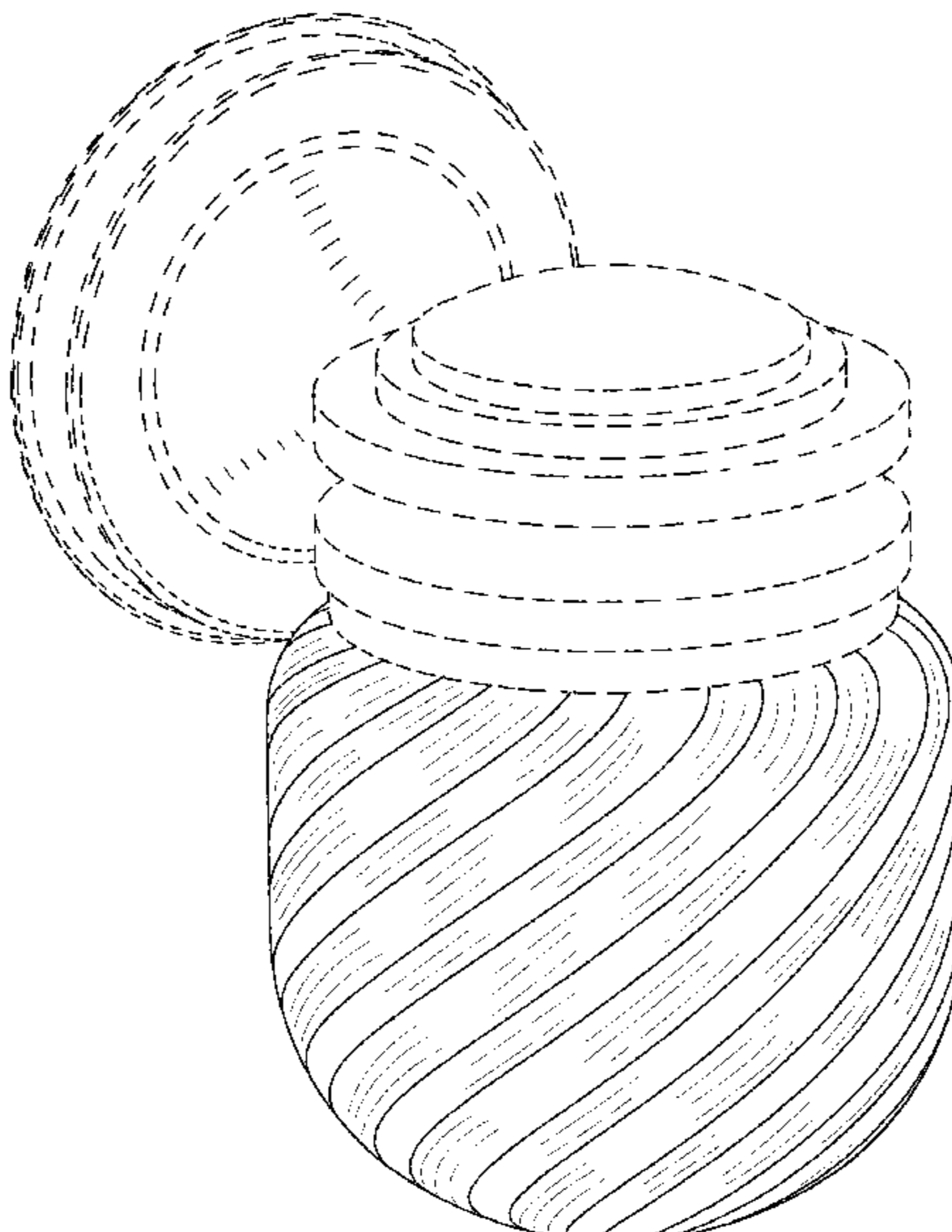
(57) **CLAIM**

The ornamental design for a swirled glass wall mount light  
fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top side of a swirled glass  
wall mount light fixture, showing the new design;  
FIG. 2 is a left side elevational view of the swirled glass wall  
mount light fixture from FIG. 1, where the right side eleva-  
tional view is identical to what is shown;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a back view thereof; and,  
FIG. 6 is a front elevational view thereof.  
The broken lines shown in the drawings illustrate portions of  
the light fixture that form no part of the claimed design.

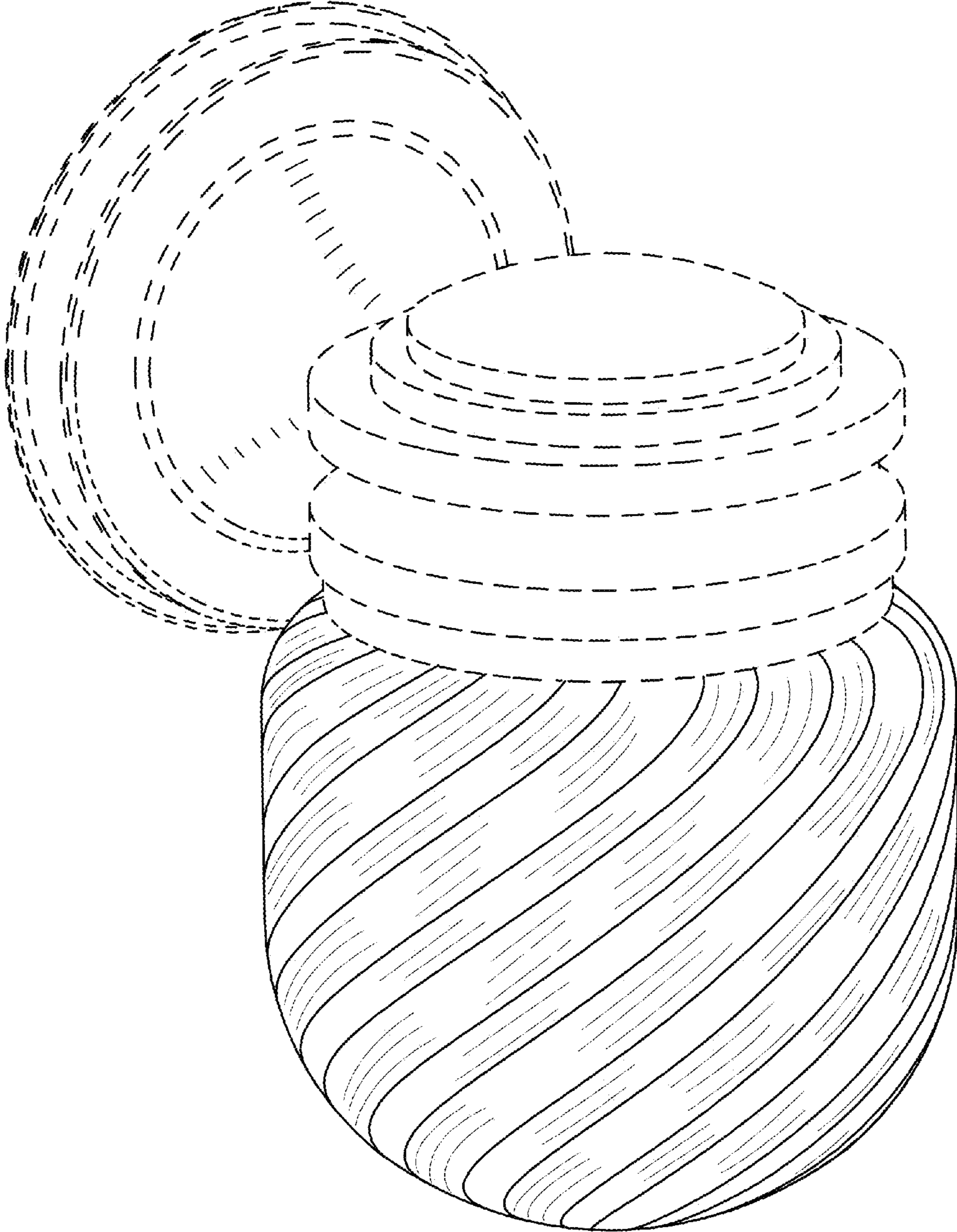

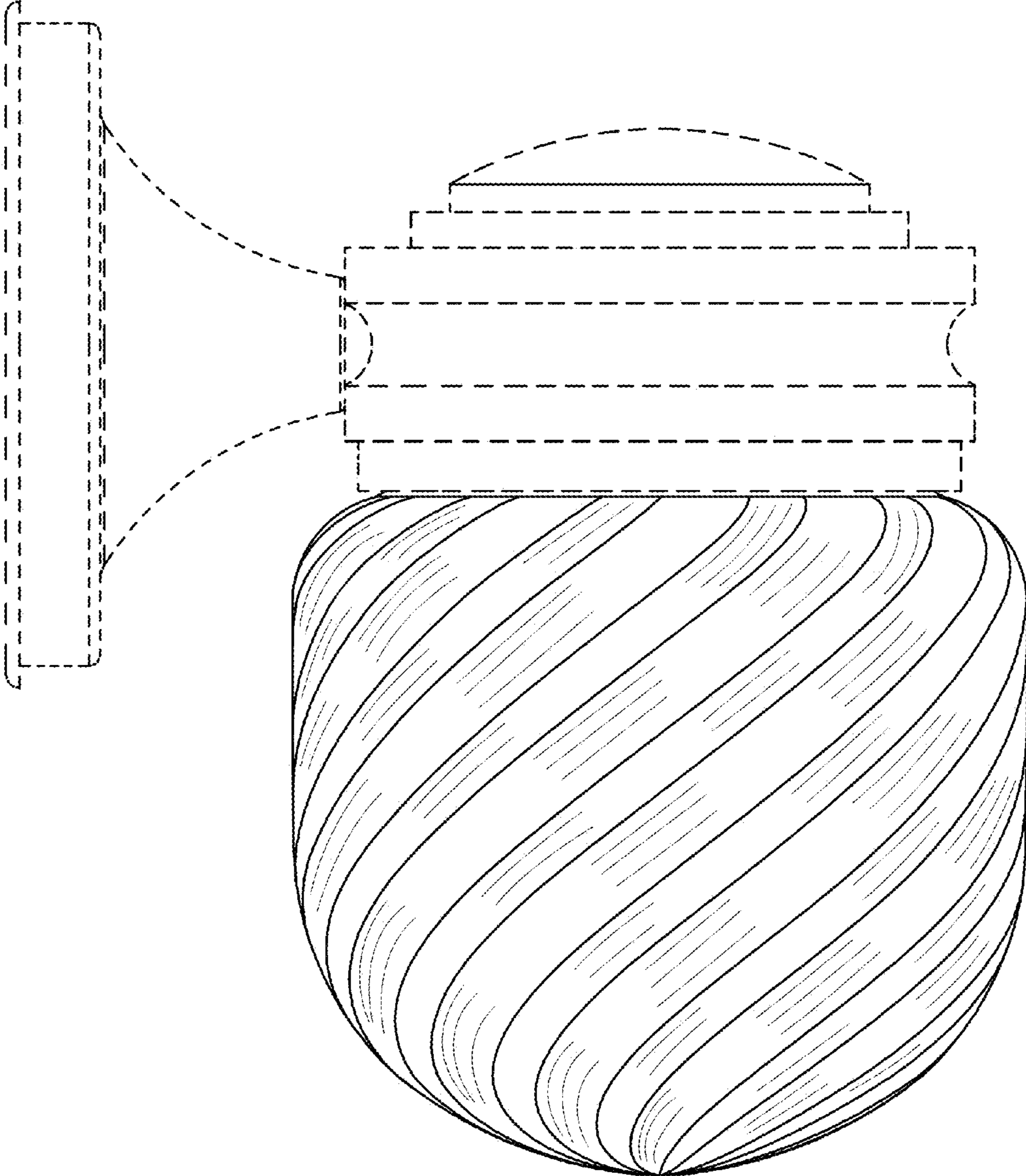

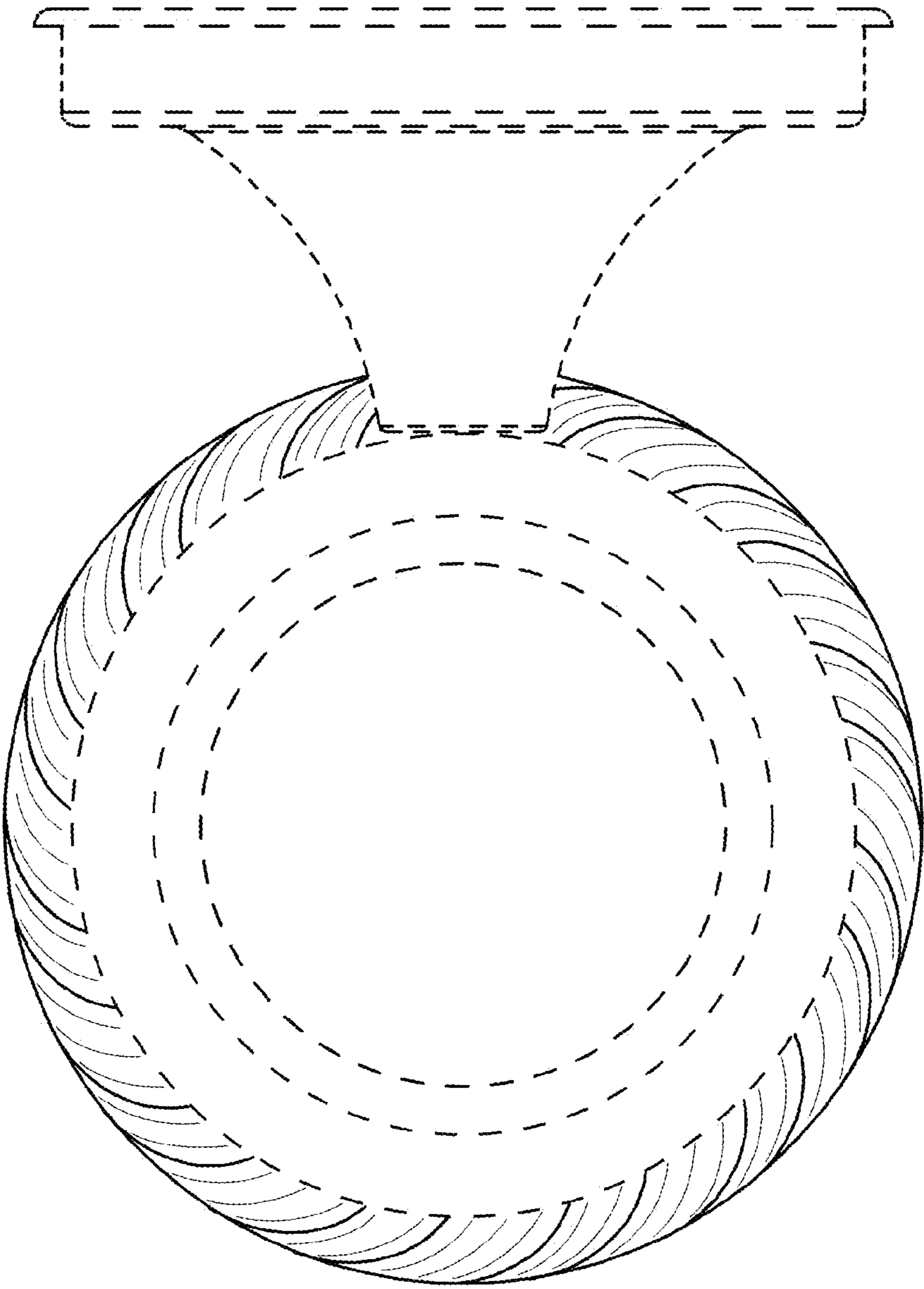

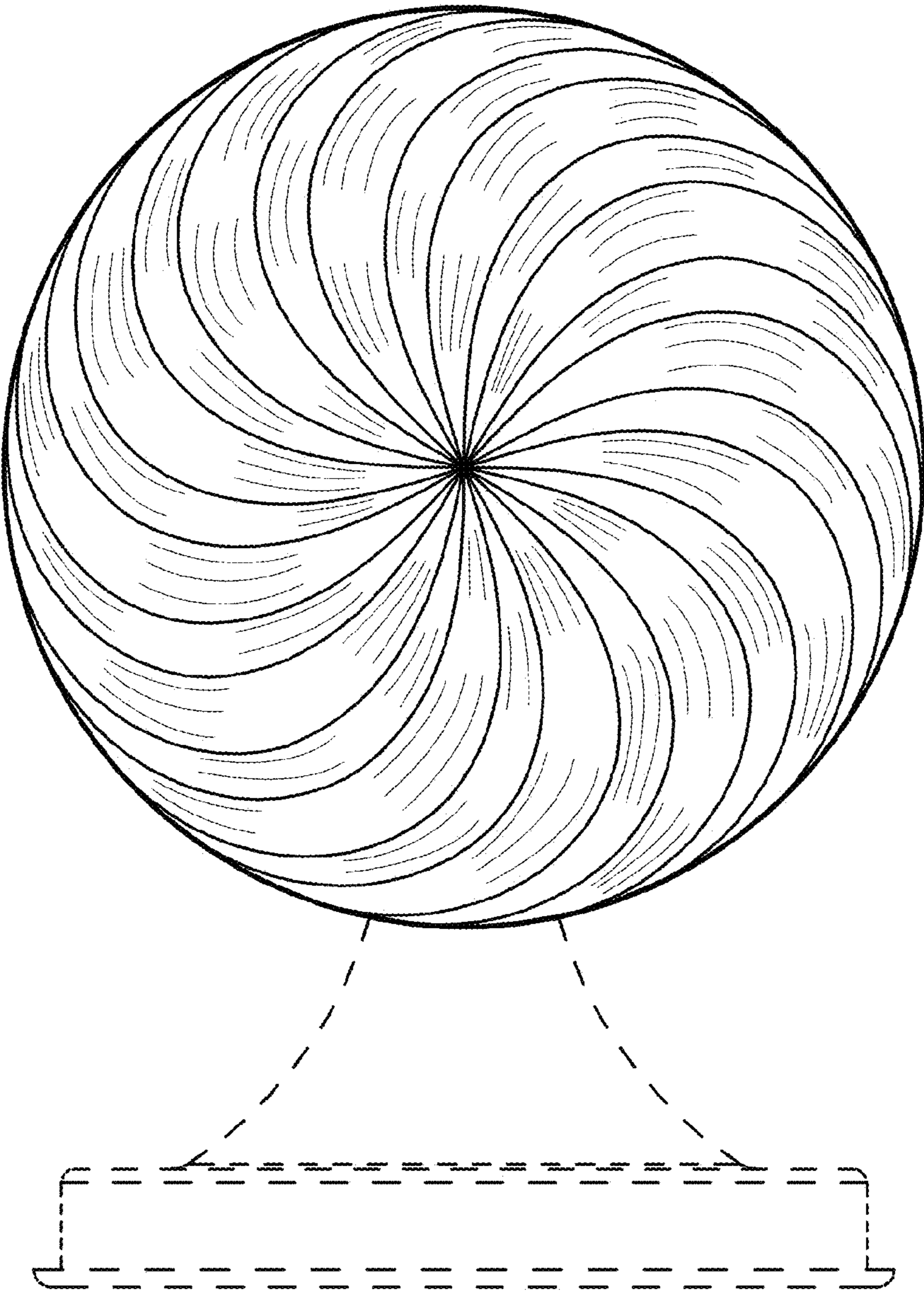

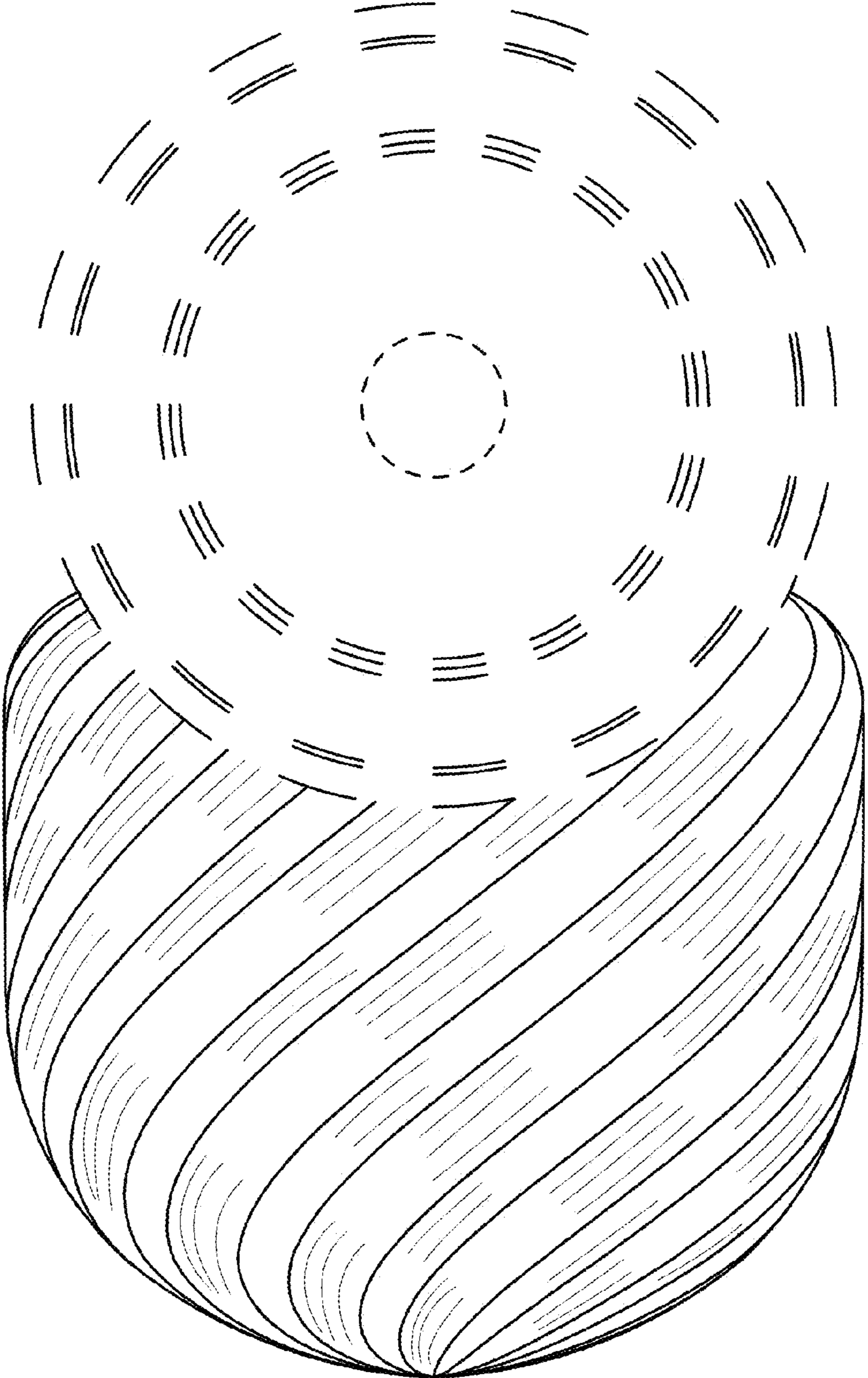

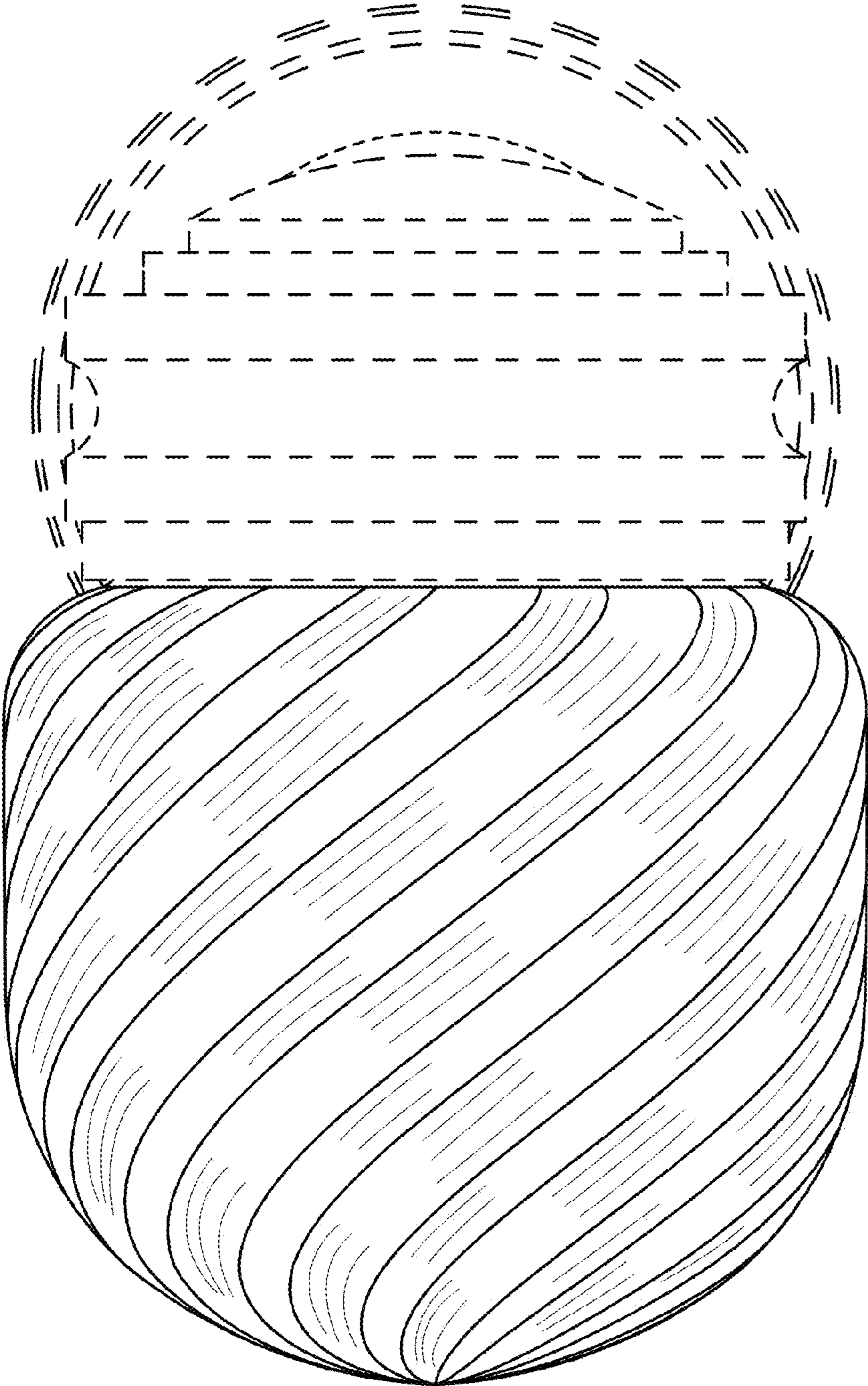
