The ornamental design for a combined ski face mask and hat, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, exploded perspective view of a combined ski face mask and hat in a detached position, showing my new design;

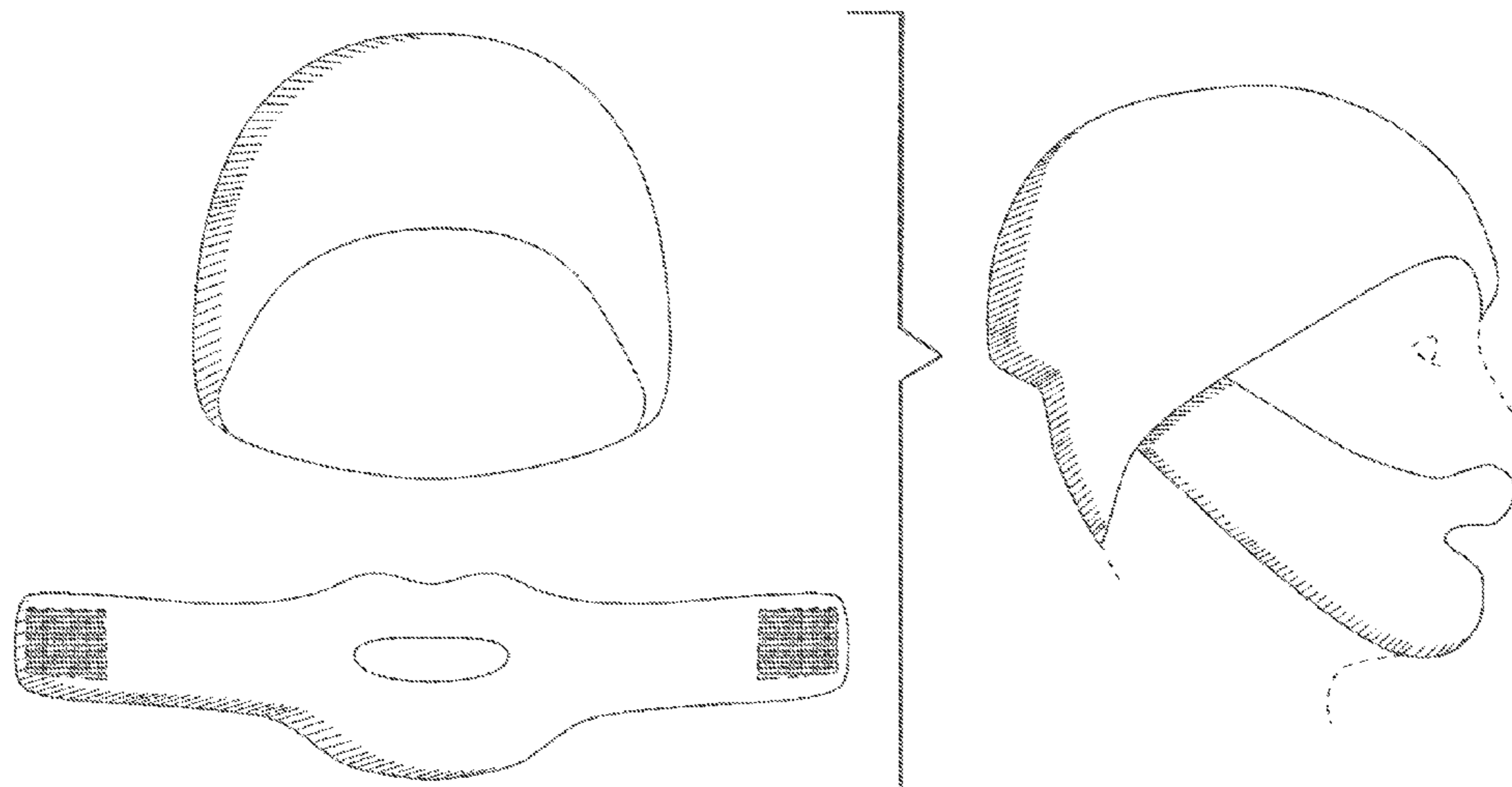
FIG. 2 is a left side perspective view of a combined ski face mask and hat in a used position; and,

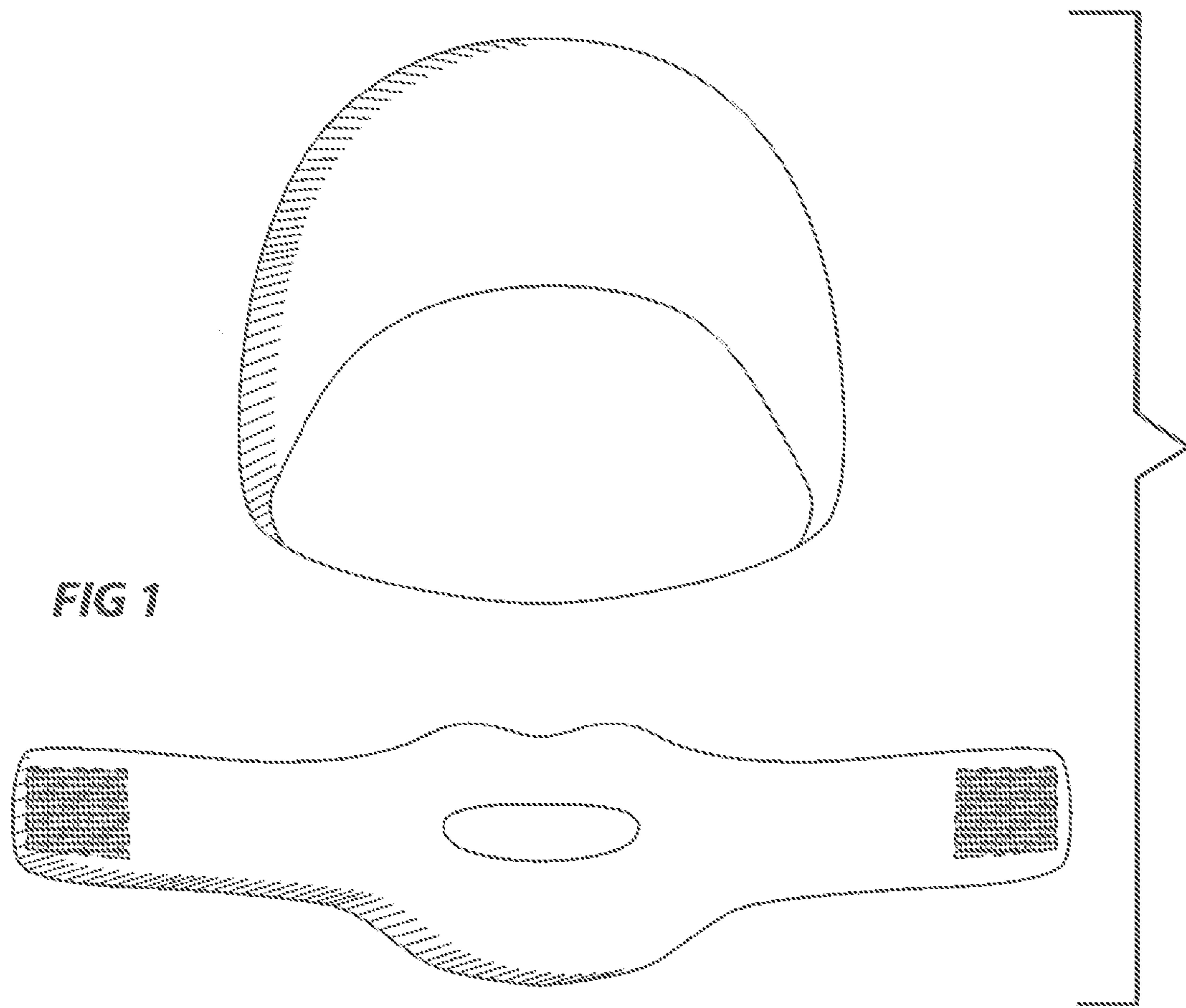
FIG. 3 is a front perspective view thereof.

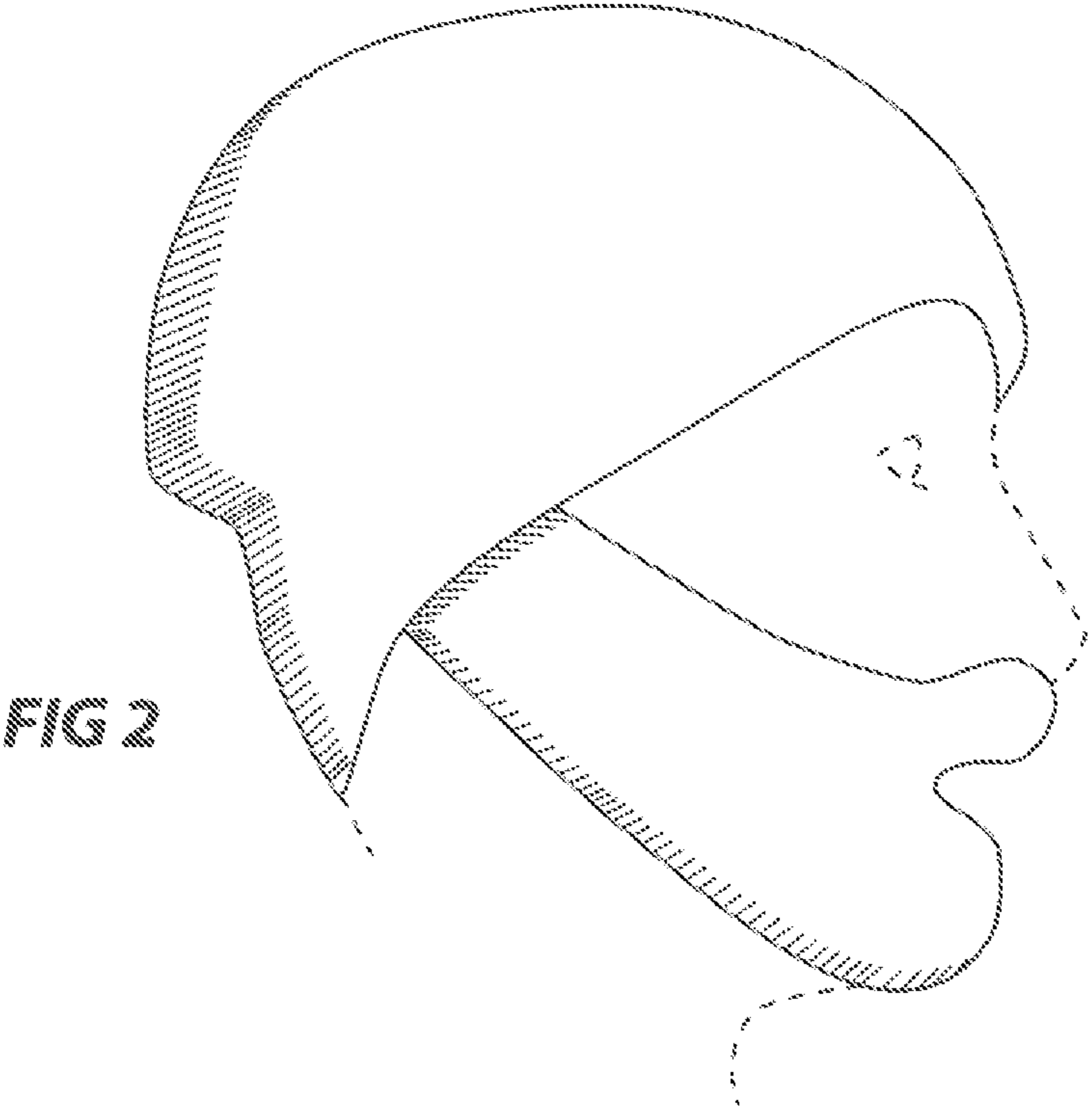

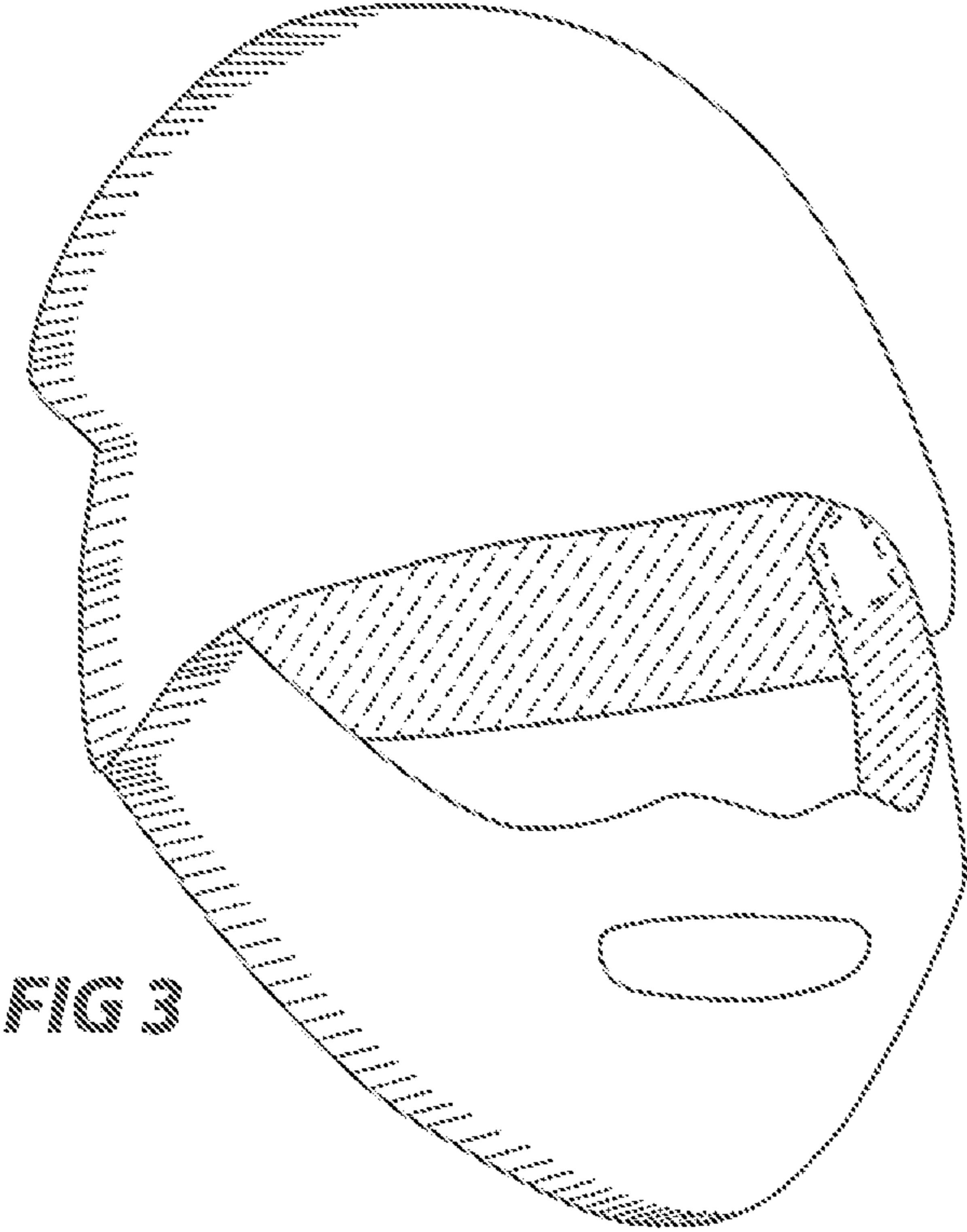


FIG 3
