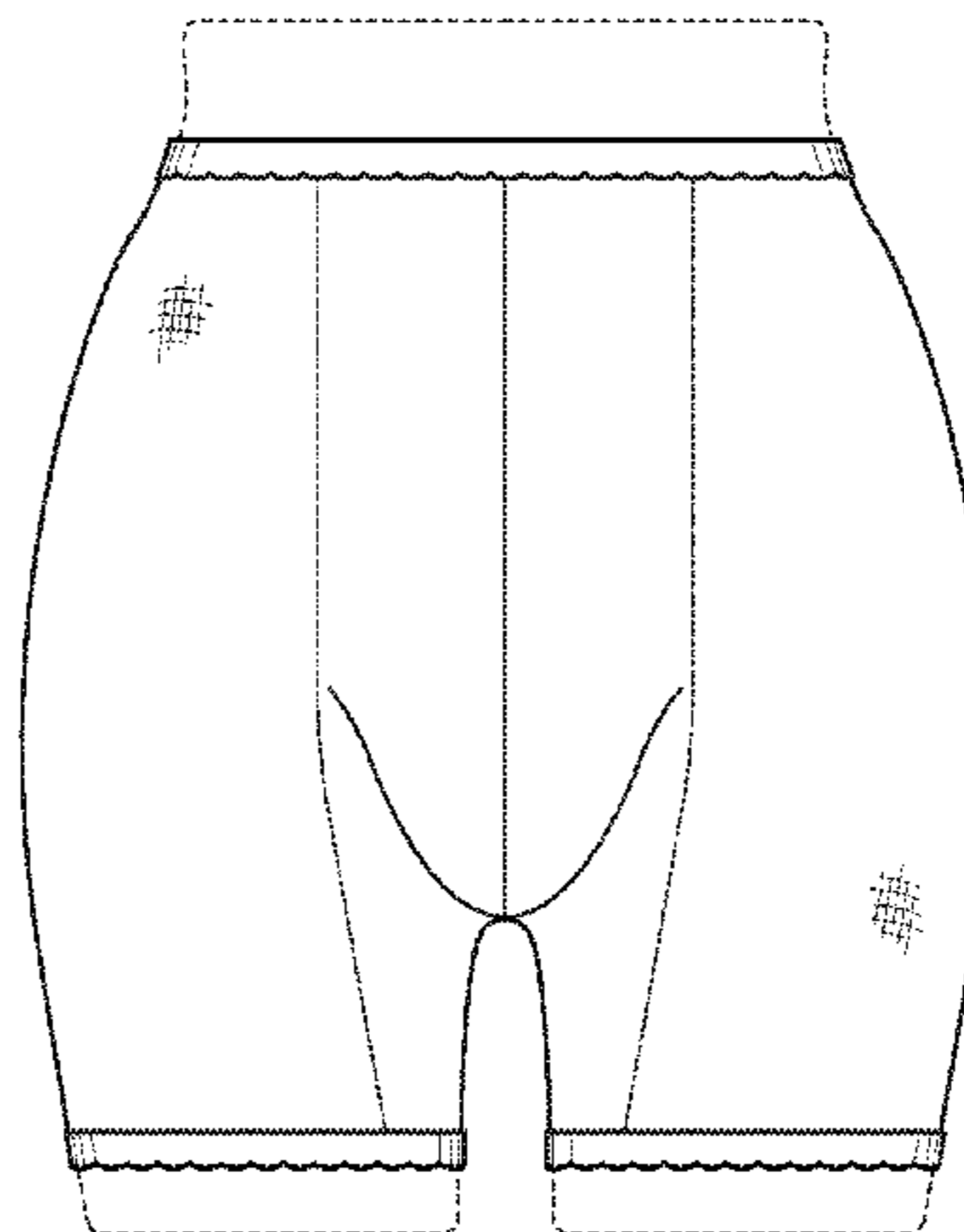
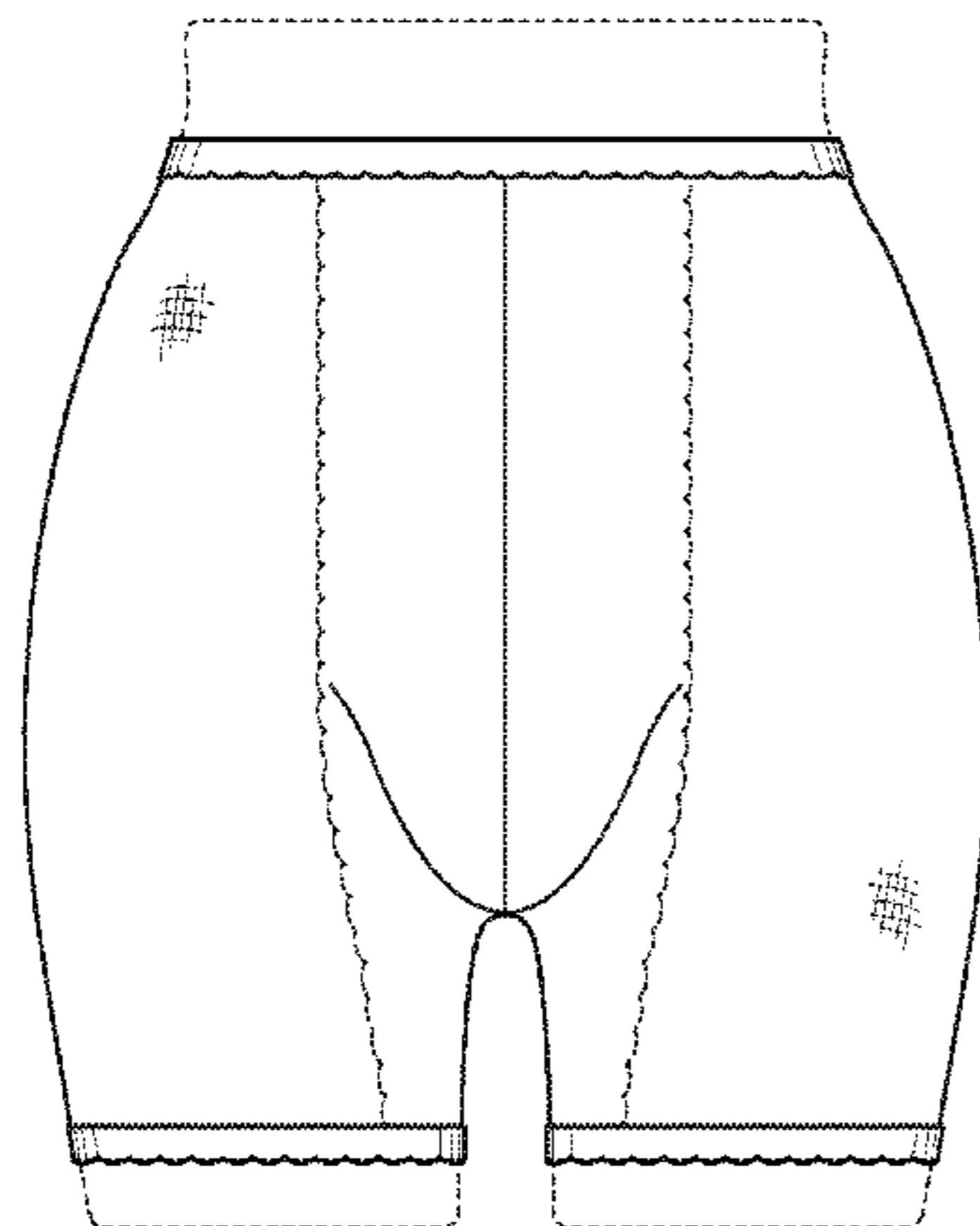

(57) **CLAIM**
The ornamental design for tight fitting sanitary absorbent under shorts, as shown and described.



DESCRIPTION

FIG. 1 is a perspective view of one side and the front of a first embodiment of the tight fitting sanitary absorbent under shorts with front and back scalloped stitching, clothing the female form, according to one embodiment of my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a back elevation view thereof;

FIG. 6 is a top plan view thereof; and

FIG. 7 is a bottom plan view thereof.

FIG. 8 is a perspective view of one side and the front of a second embodiment of the tight fitting sanitary absorbent under shorts with front and back scalloped stitching, clothing the female form, according to one embodiment of my new design;

FIG. 9 is a front elevation view thereof;

FIG. 10 is a right side elevation view thereof;

FIG. 11 is a left side elevation view thereof;

FIG. 12 is a back elevation view thereof;

FIG. 13 is a top plan view thereof; and

FIG. 14 is a bottom plan view thereof.

FIG. 15 is a perspective view of one side and the front of a third embodiment of the tight fitting sanitary absorbent under shorts with front and back straight stitching, clothing the female form, according to one embodiment of my new design;

FIG. 16 is a front elevation view thereof;

FIG. 17 is a right side elevation view thereof;

FIG. 18 is a left side elevation view thereof;

FIG. 19 is a back elevation view thereof;

FIG. 20 is a top plan view thereof; and,

FIG. 21 is a bottom plan view thereof.

FIG. 22 is a perspective view of one side and the front of a fourth embodiment of the tight fitting sanitary absorbent under shorts with front and back straight stitching, clothing the female form, according to one embodiment of my new design;

FIG. 23 is a front elevation view thereof;

FIG. 24 is a right side elevation view thereof;

FIG. 25 is a left side elevation view thereof;

FIG. 26 is a back elevation view thereof;

FIG. 27 is a top plan view thereof; and,

FIG. 28 is a bottom plan view thereof.

The dashed lines on the surface of the tight fitting sanitary absorbent under shorts represent stitching.

The scalloped and straight stitching shown in dashed lines are part of the claimed design.

The partial human figure shown in broken lines in the drawings illustrates the environment in which the claimed design is used and assists in showing how the design appears when worn. The partial human figure forms no part of the claim.

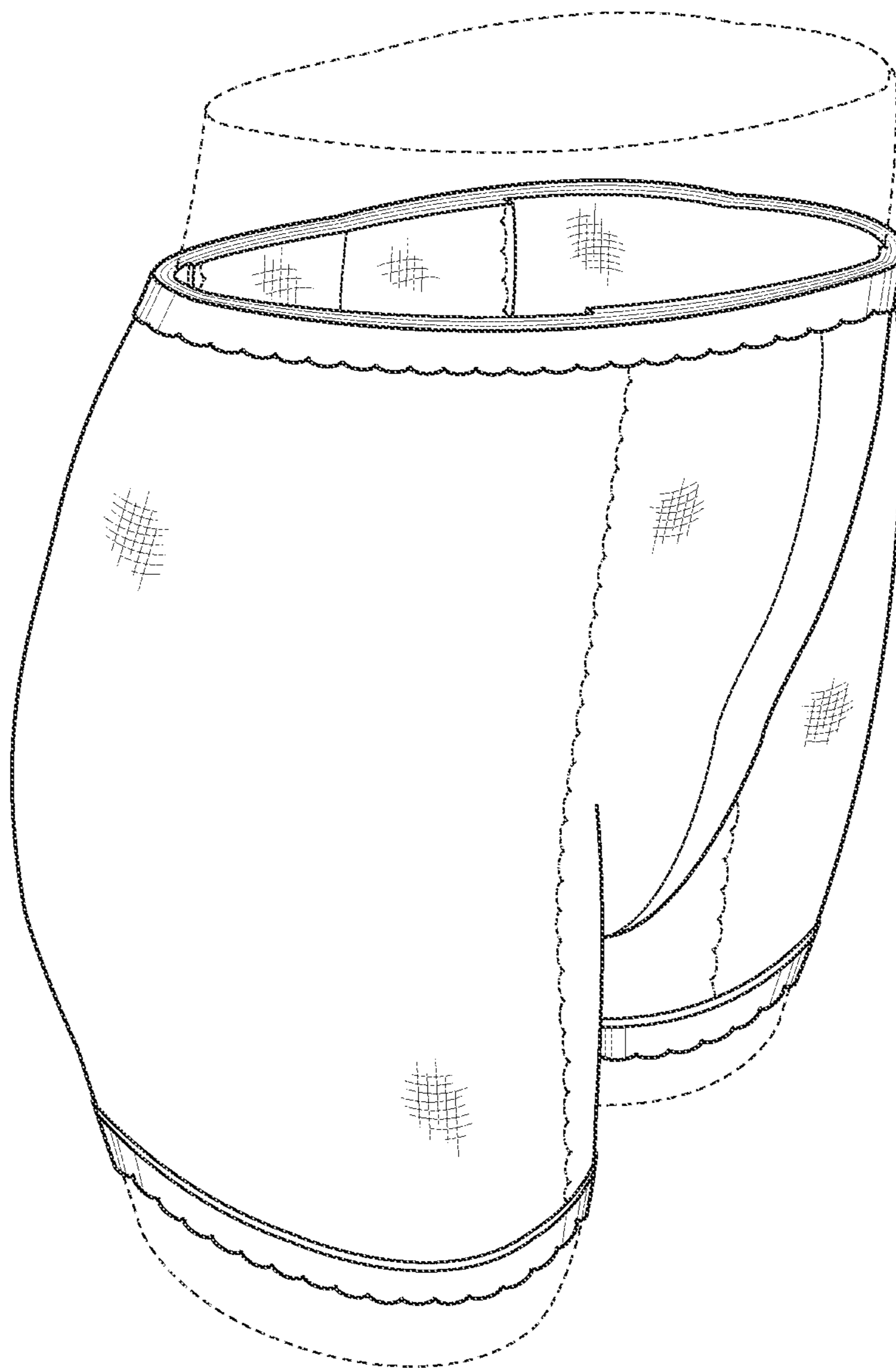

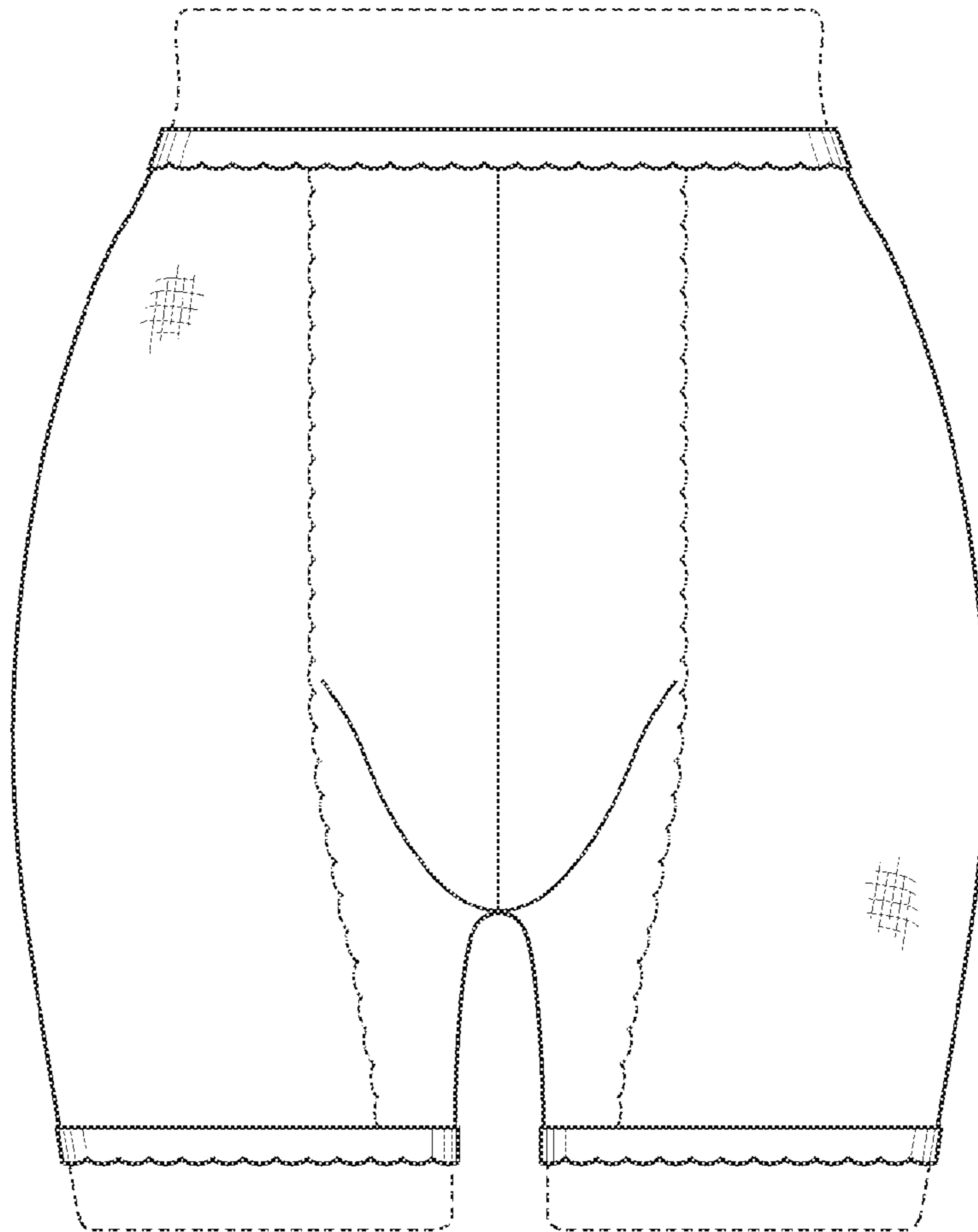

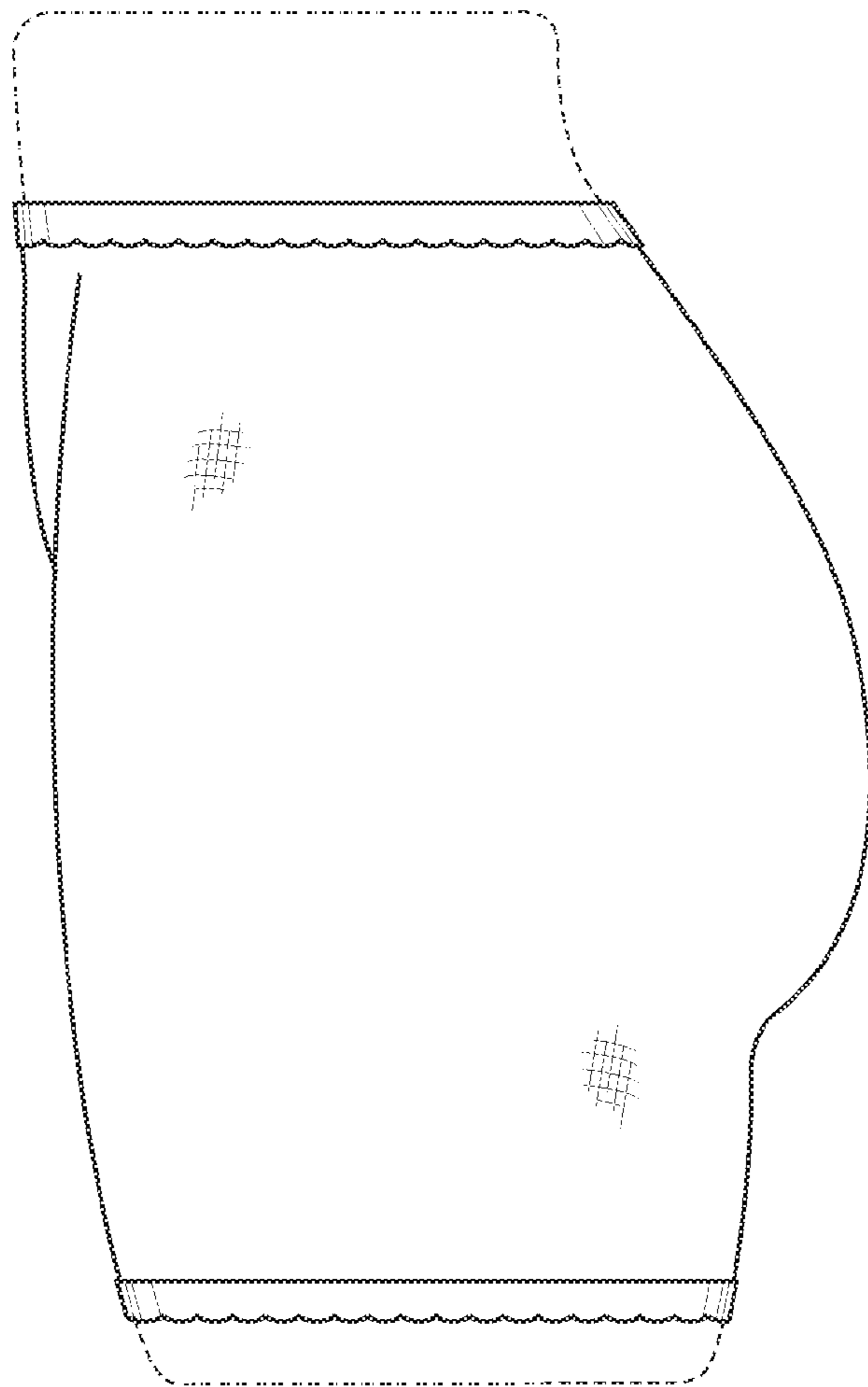

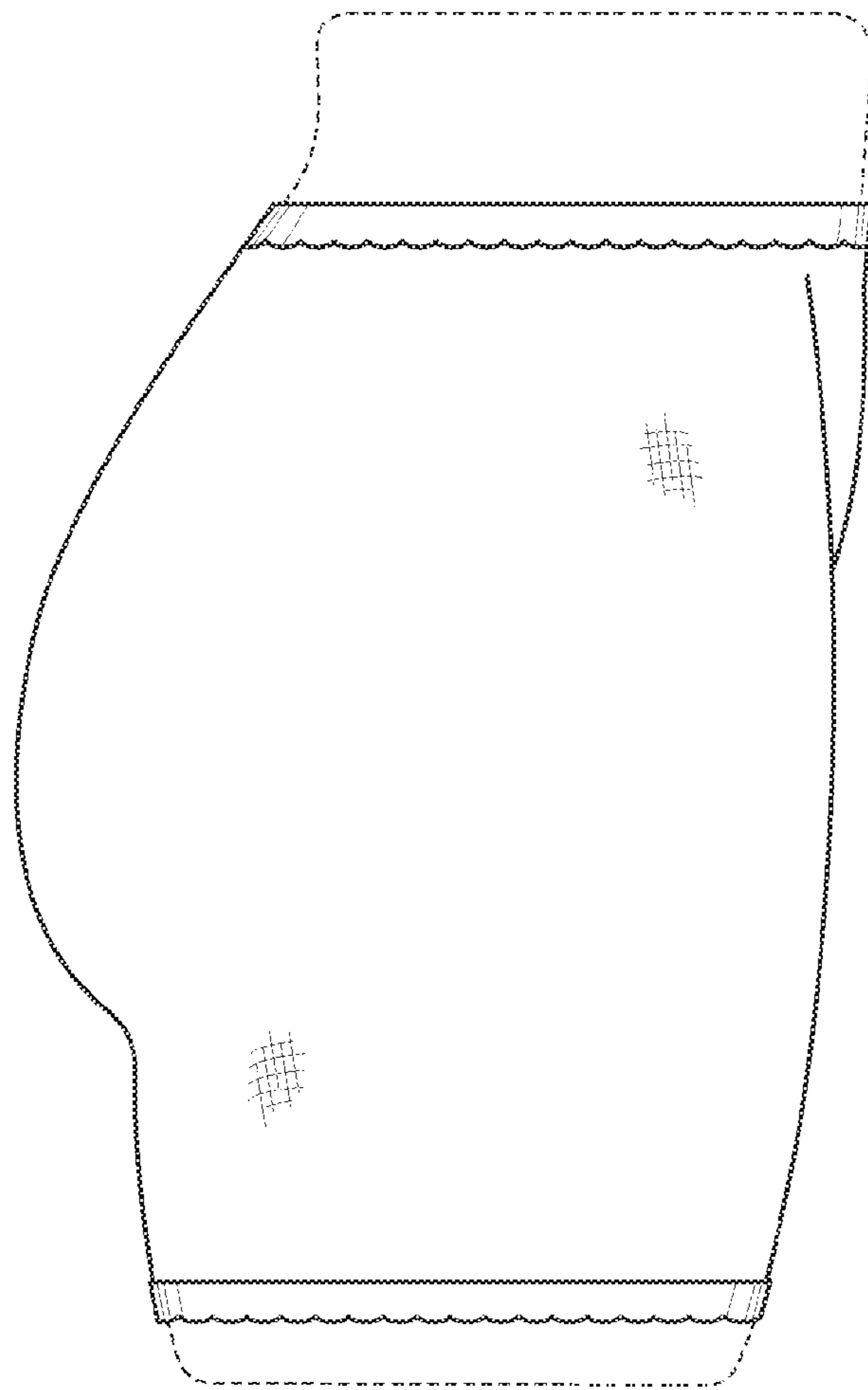

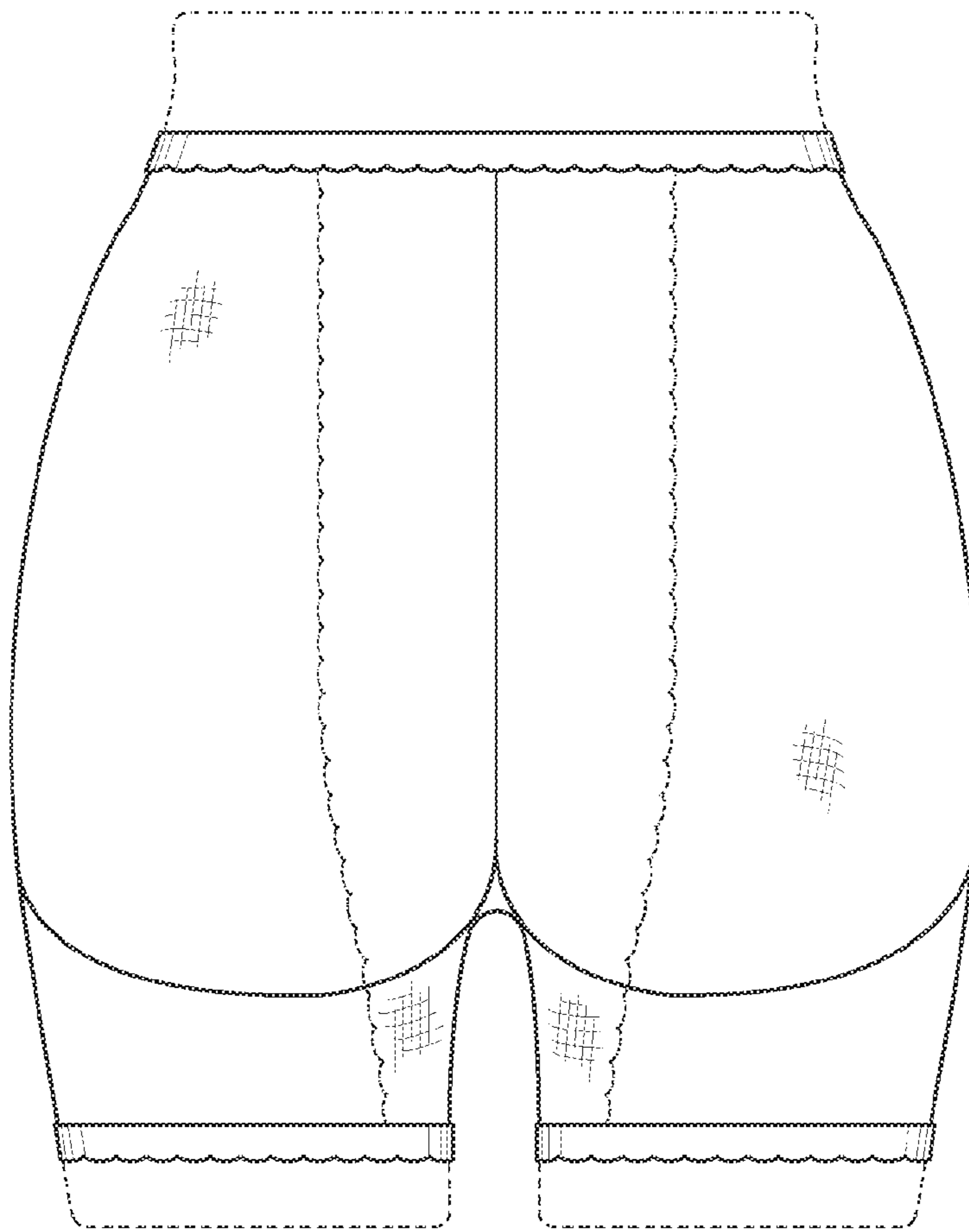

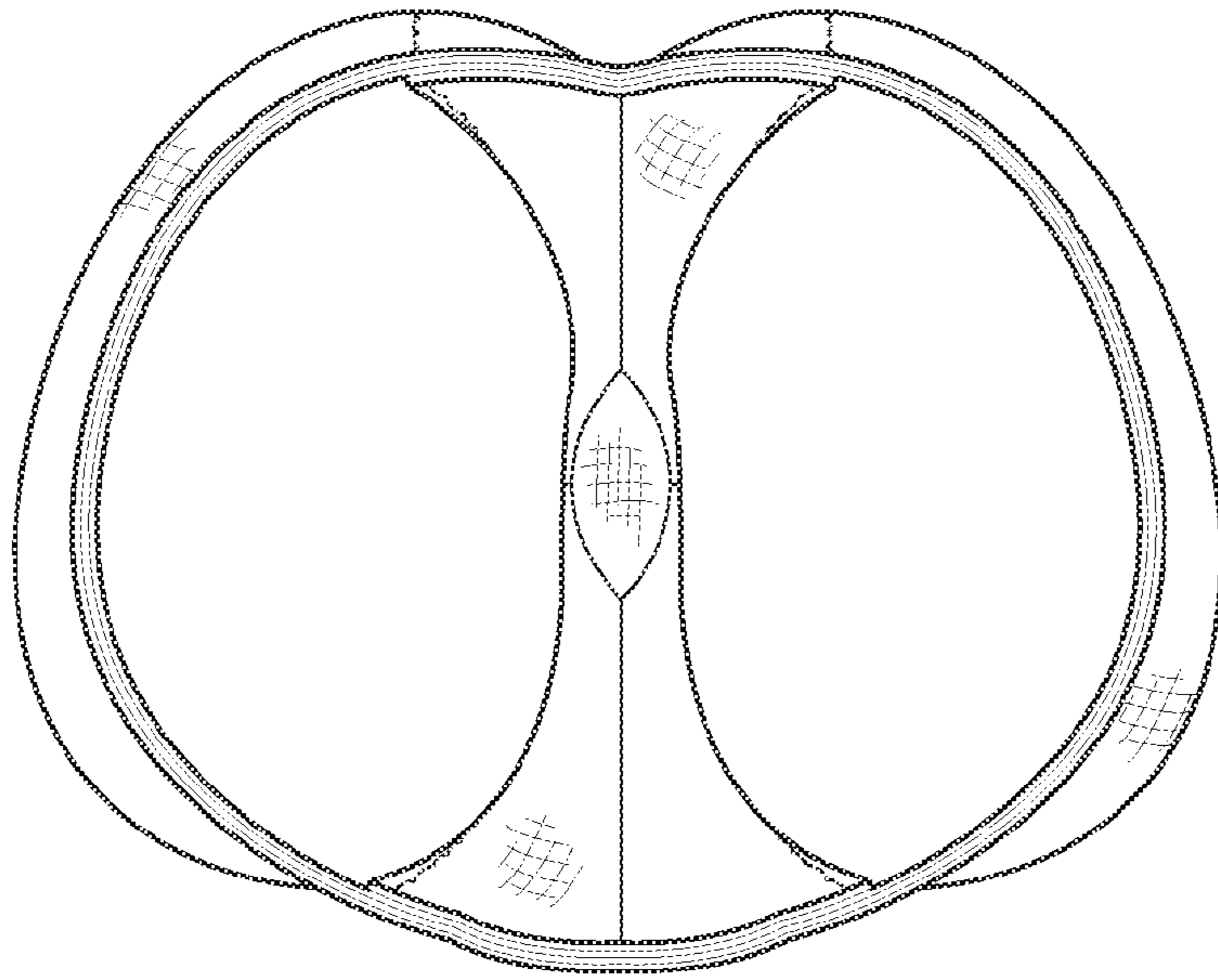

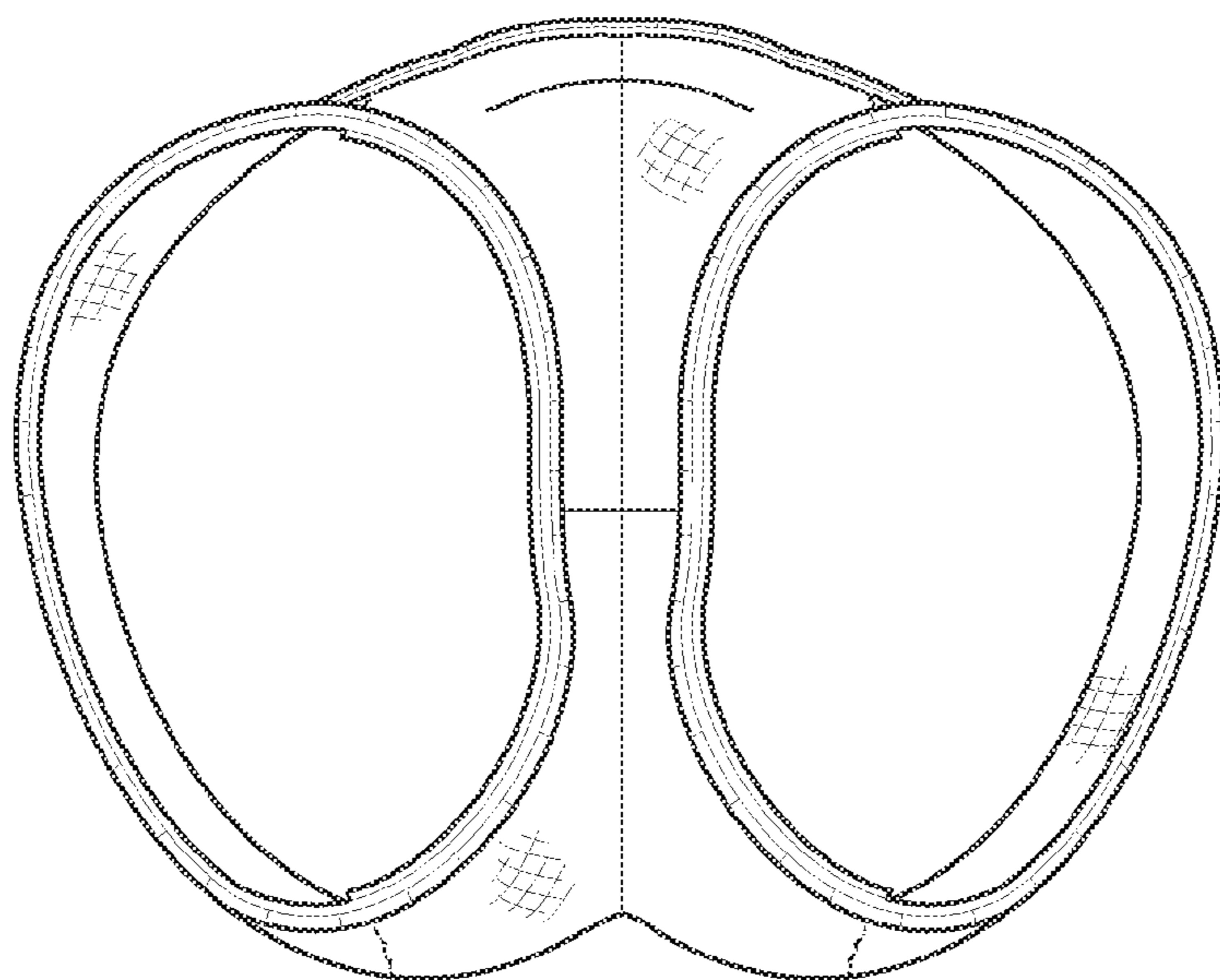

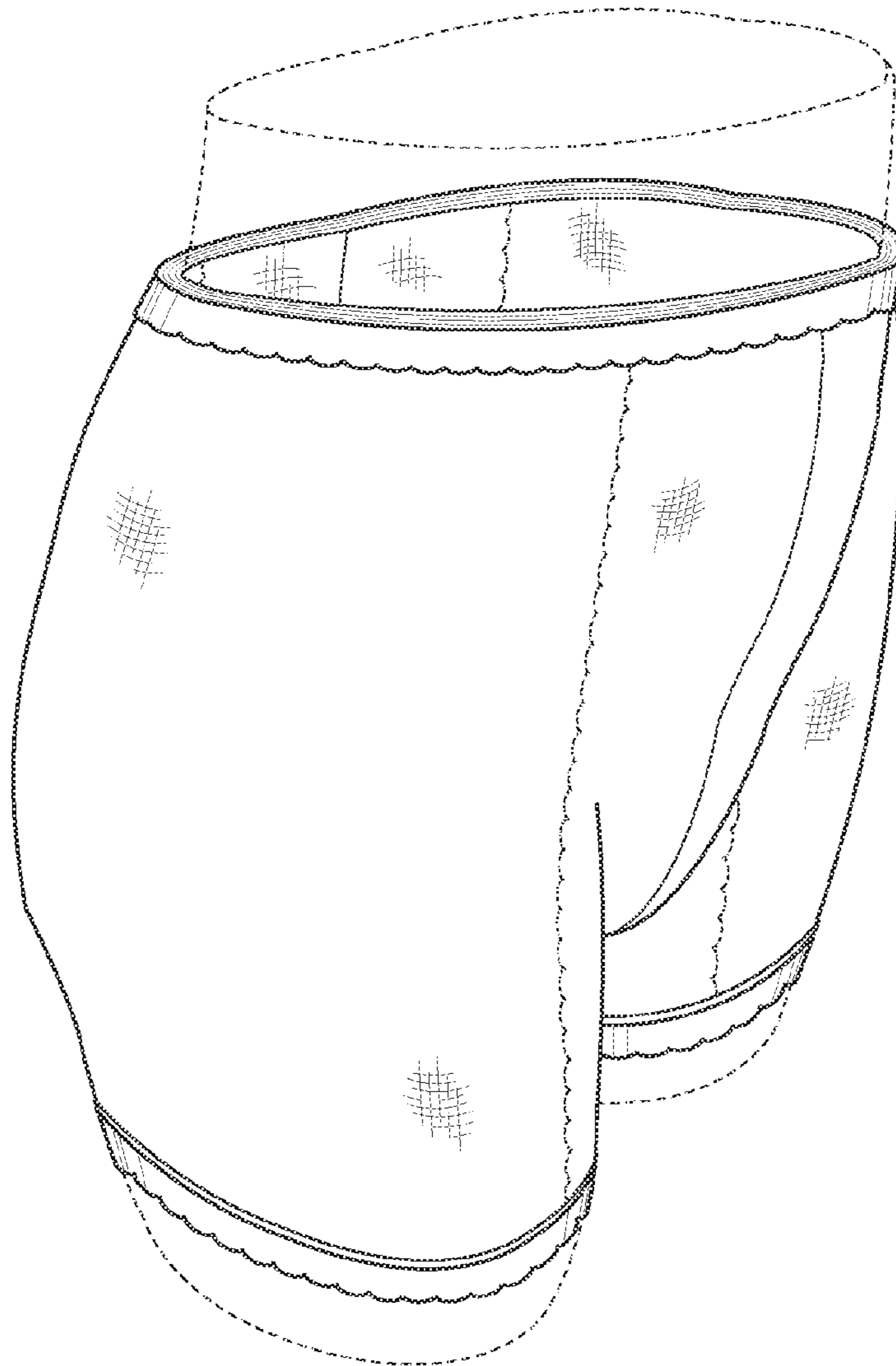

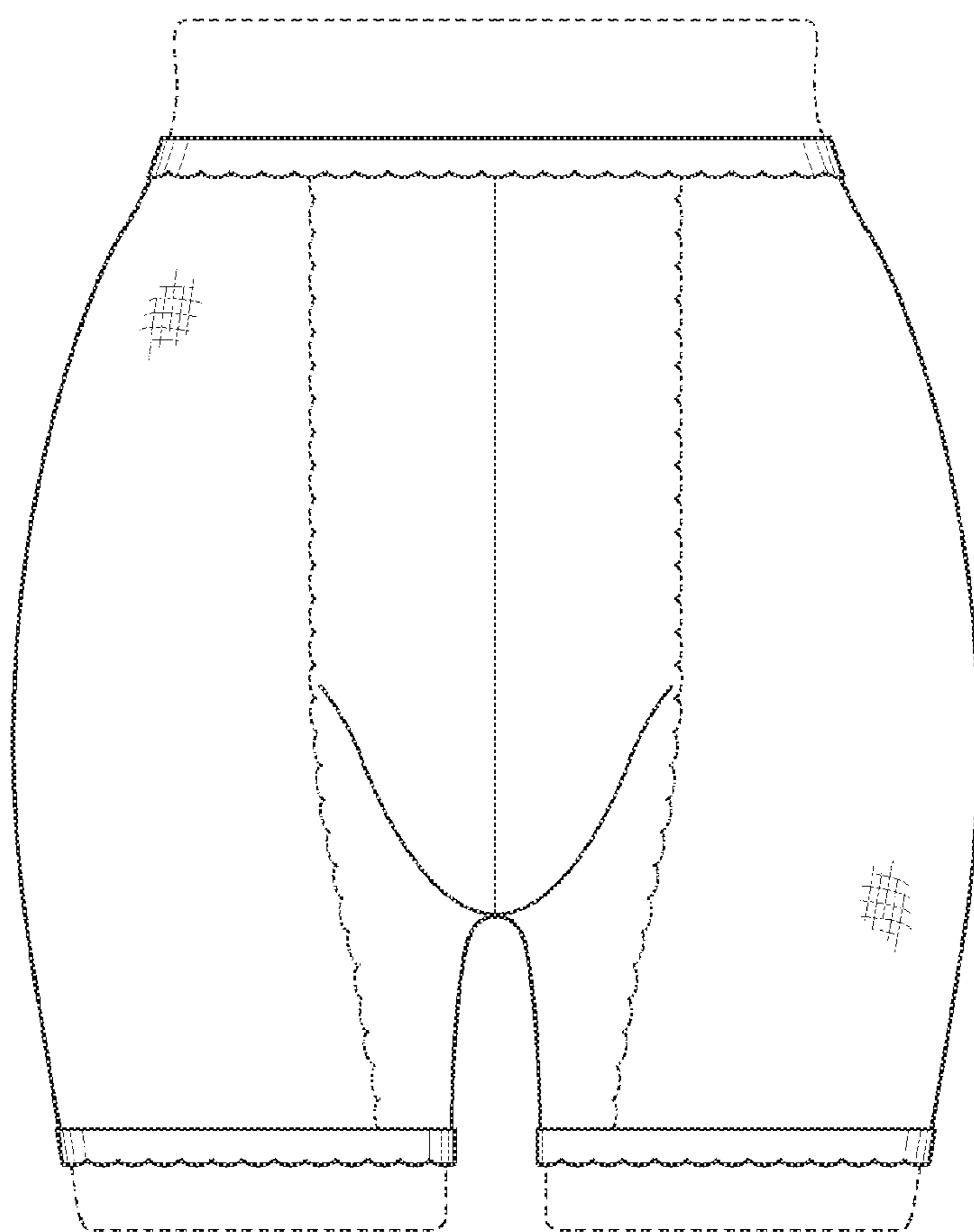

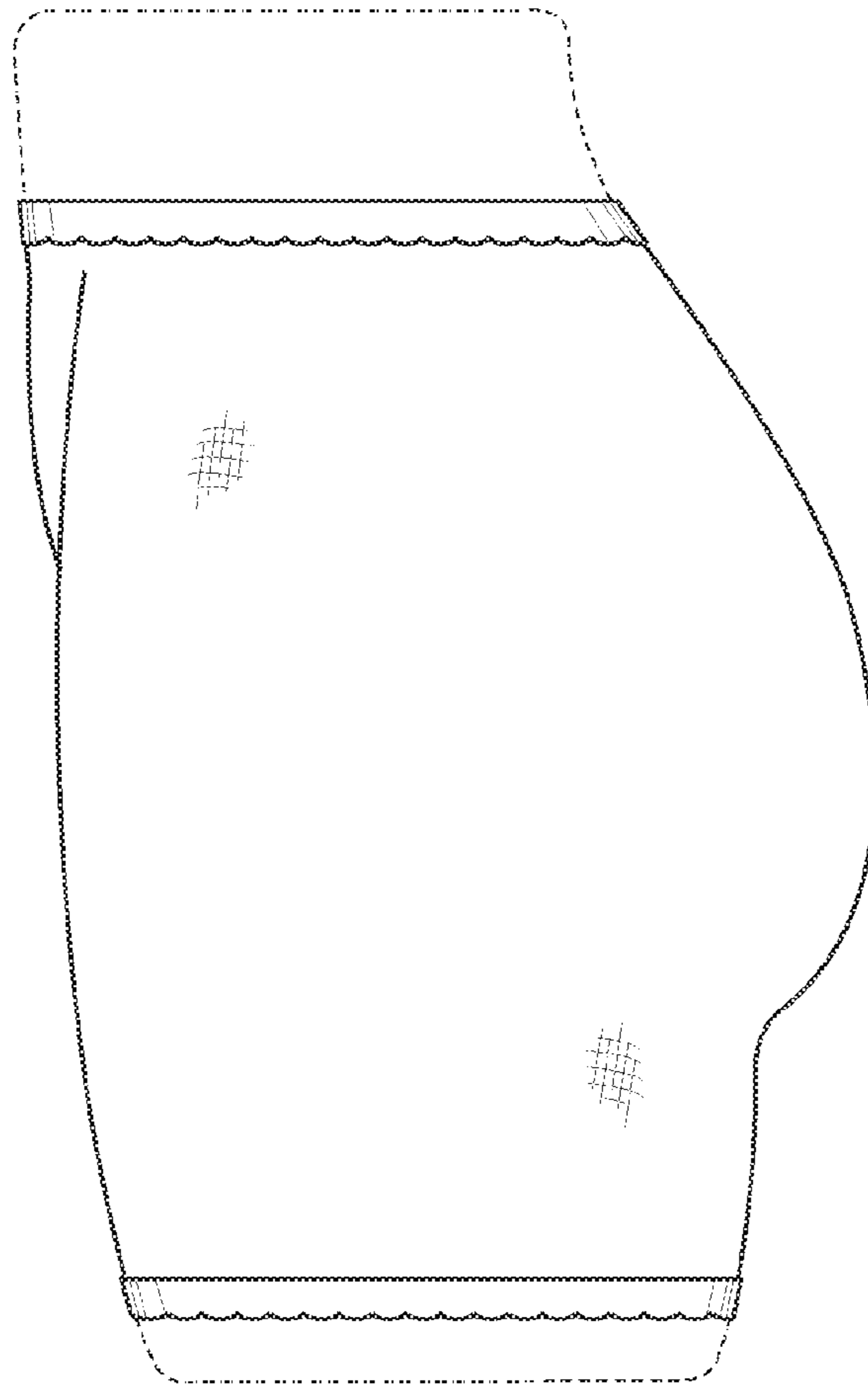

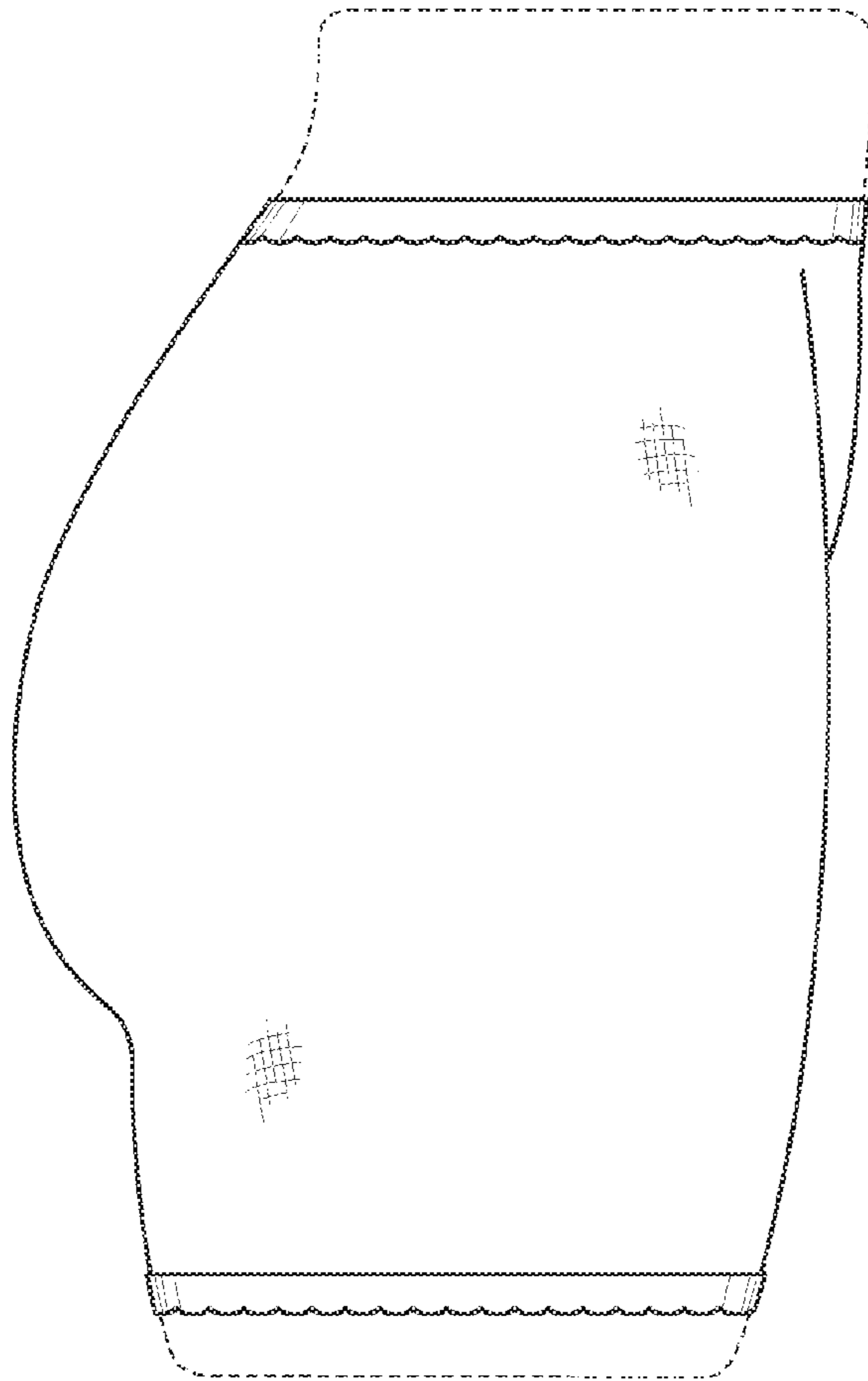

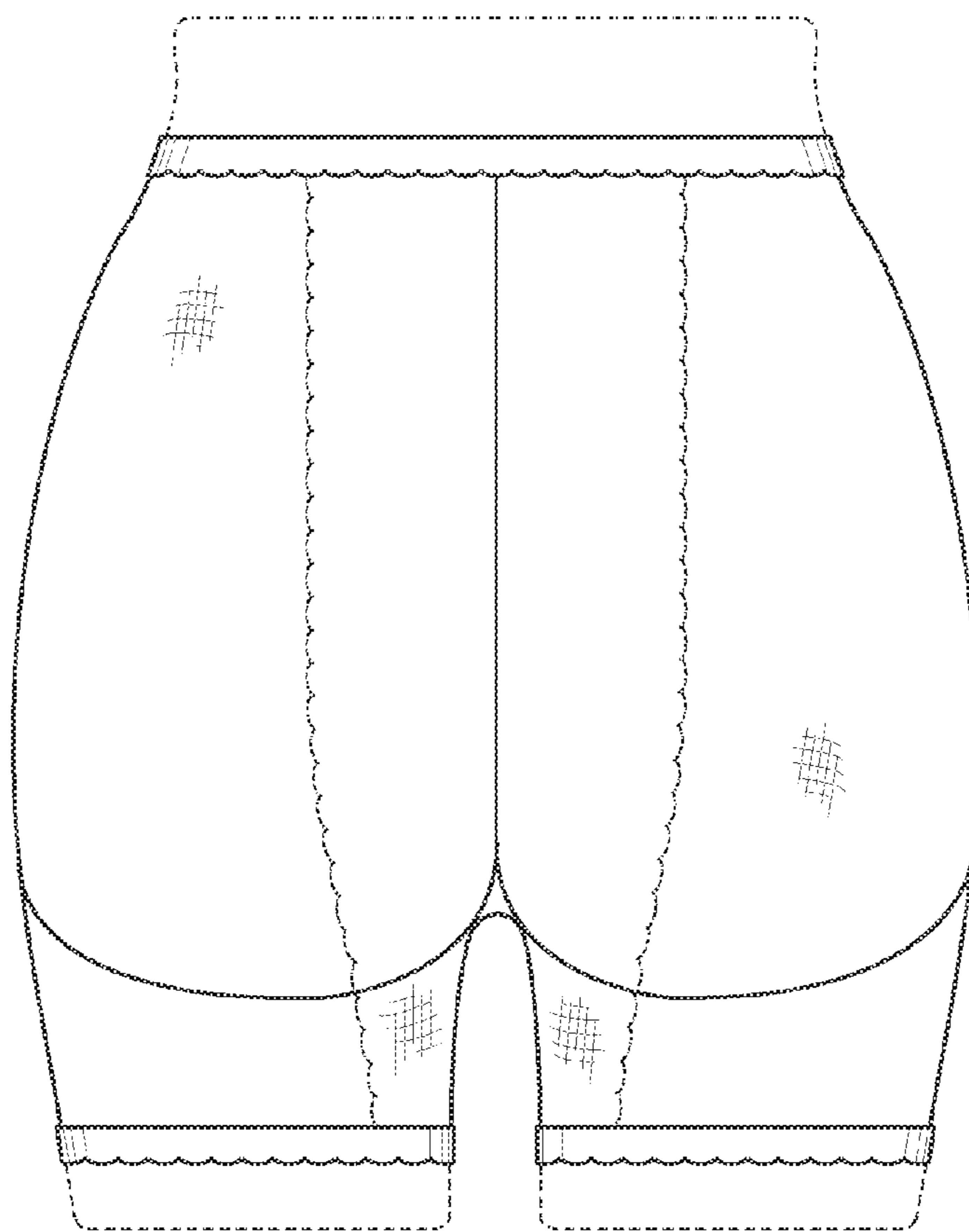

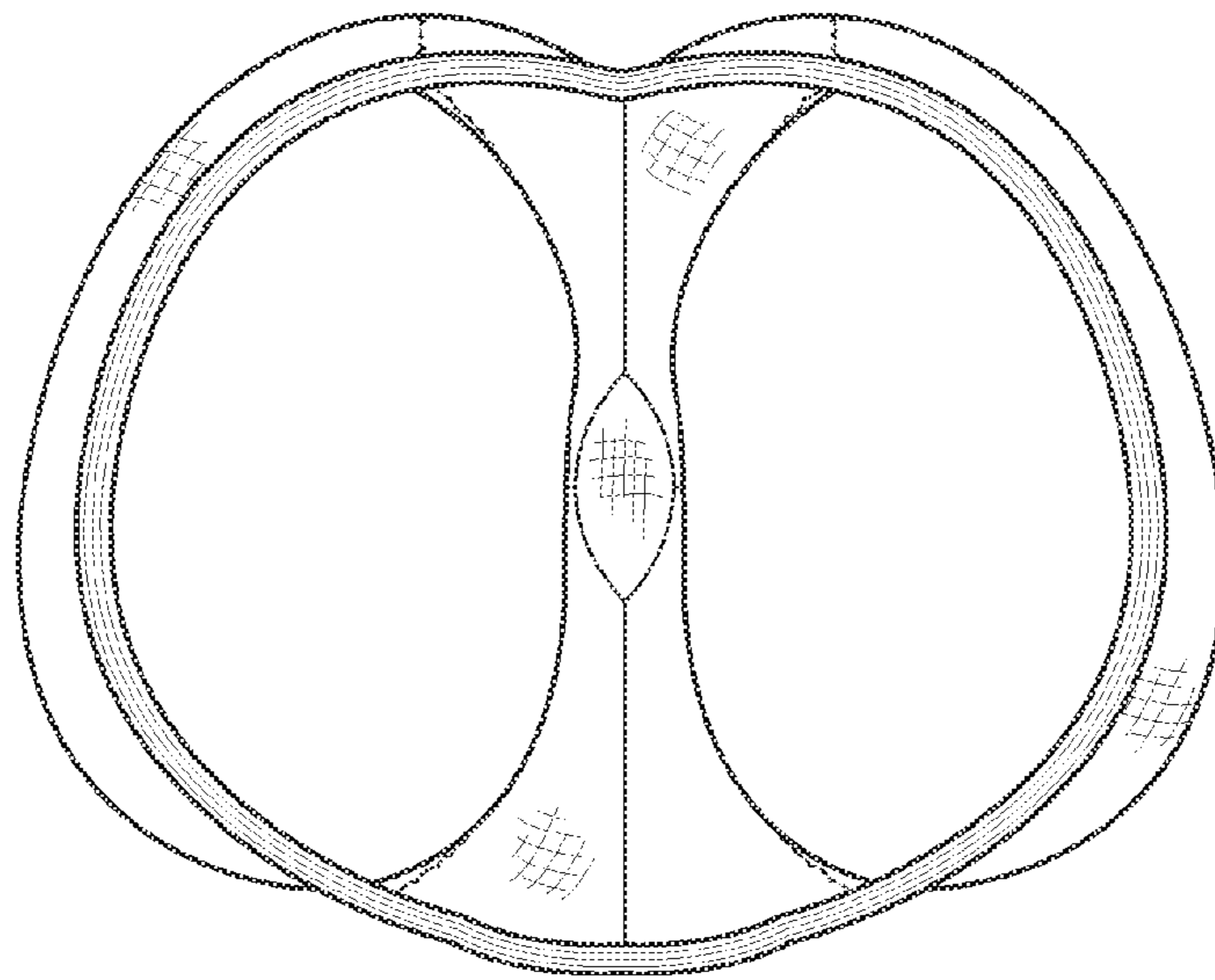

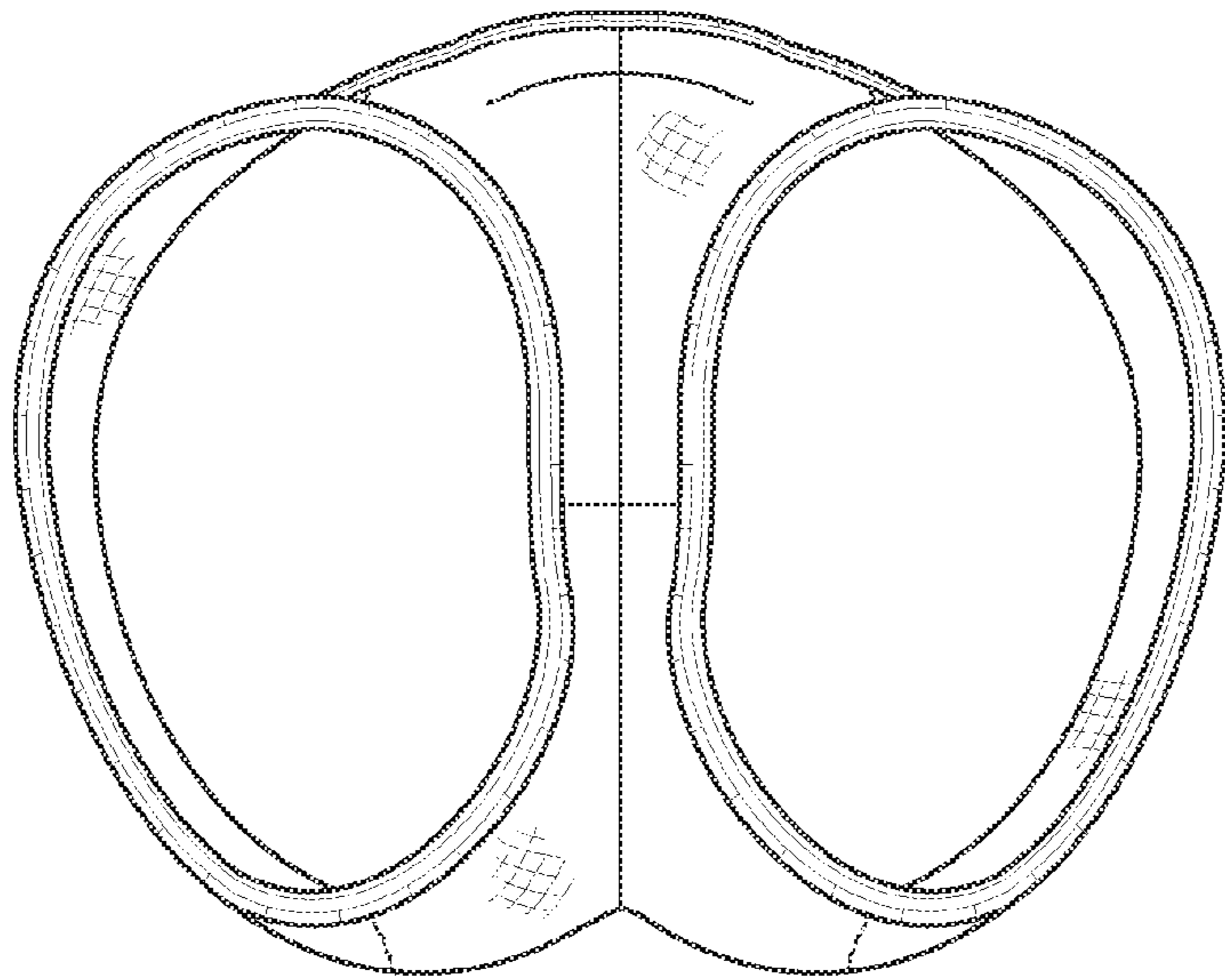

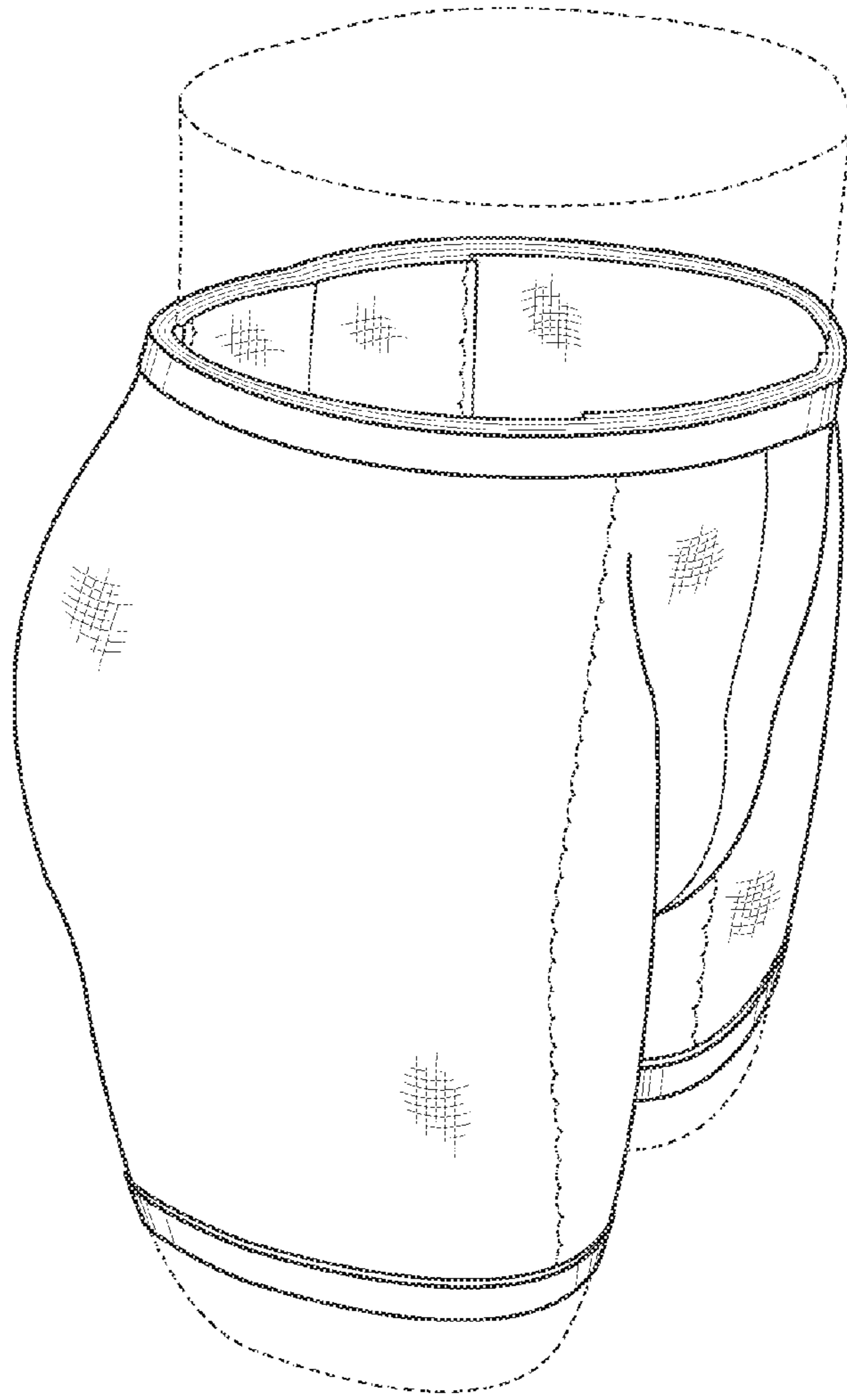

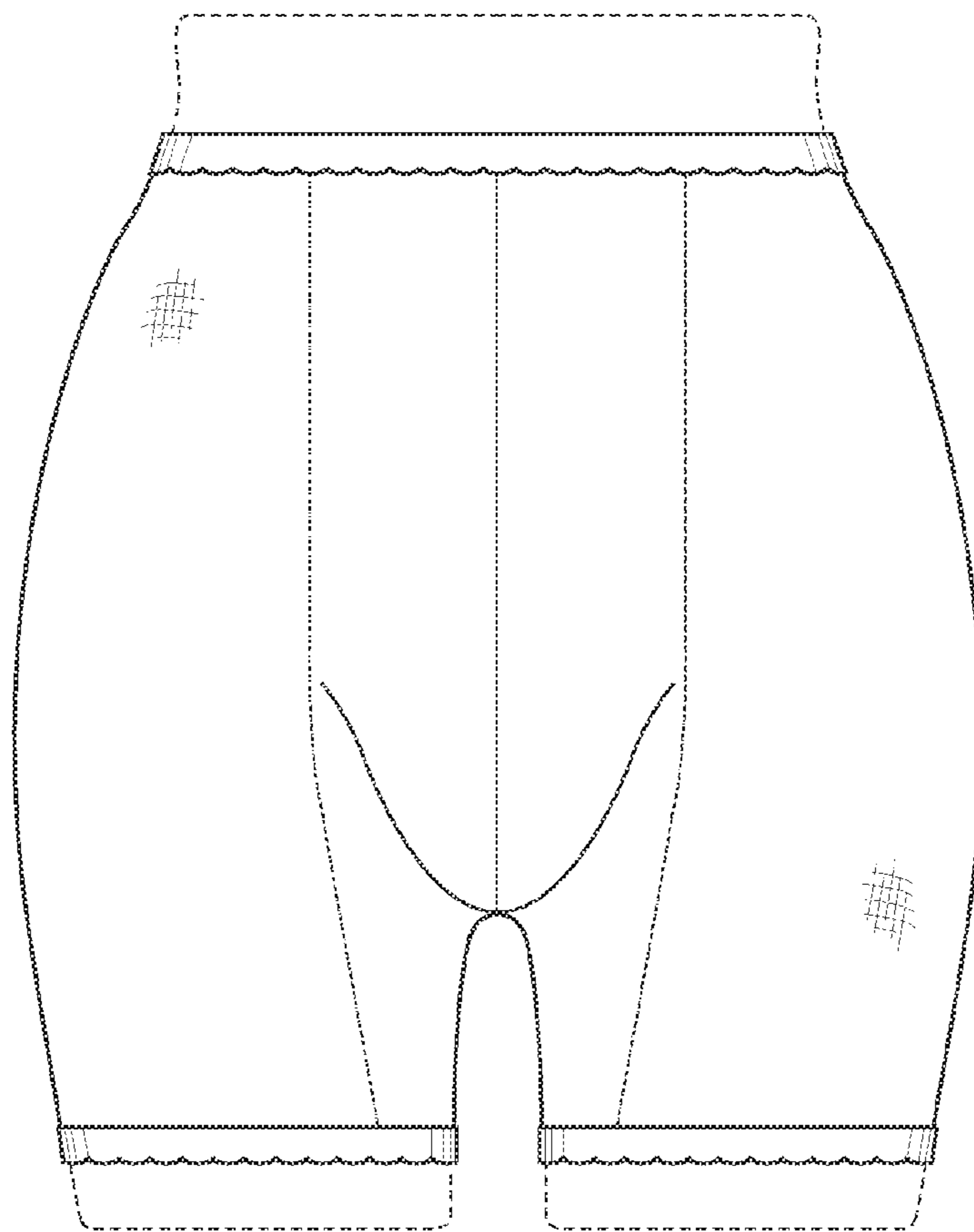

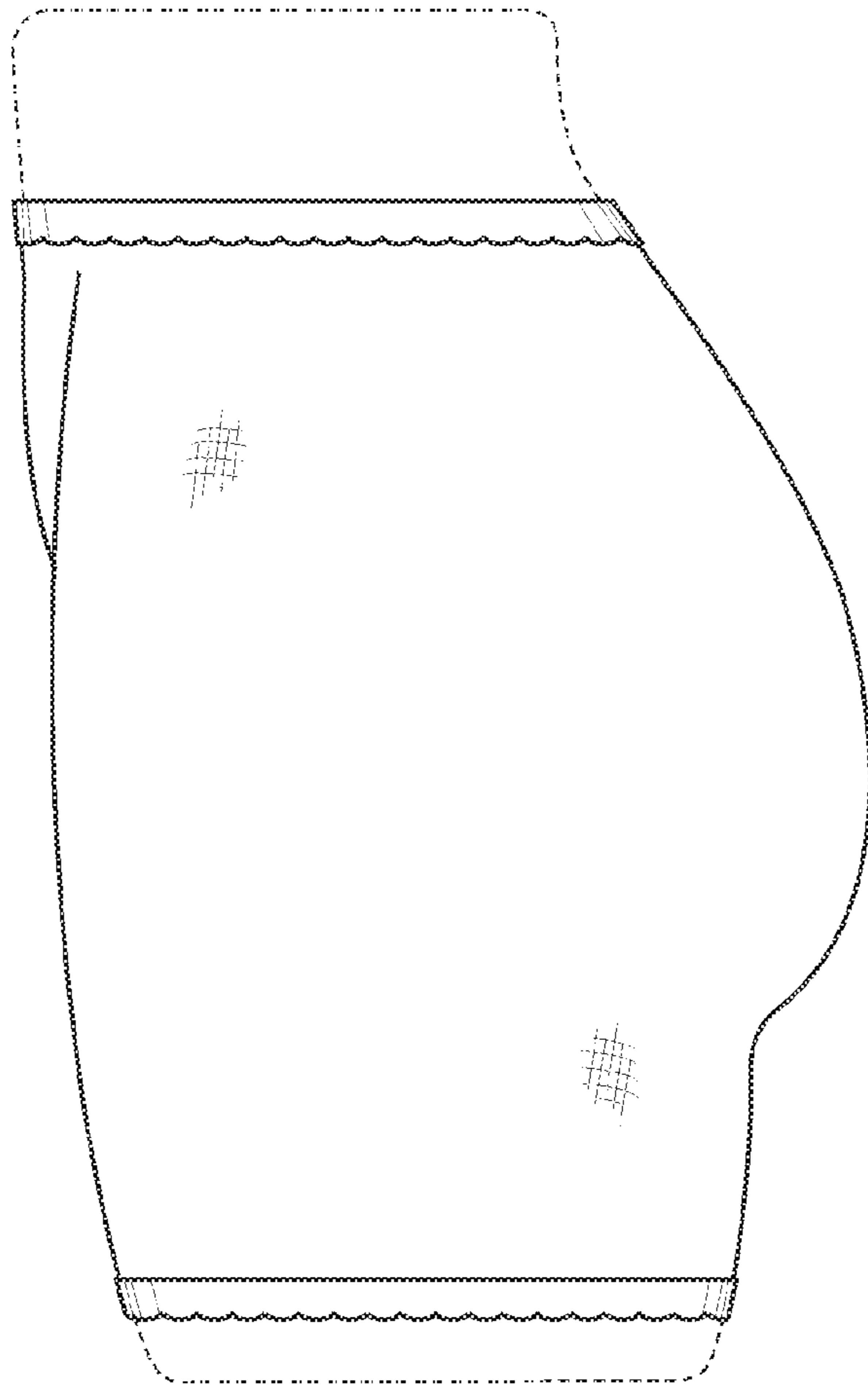

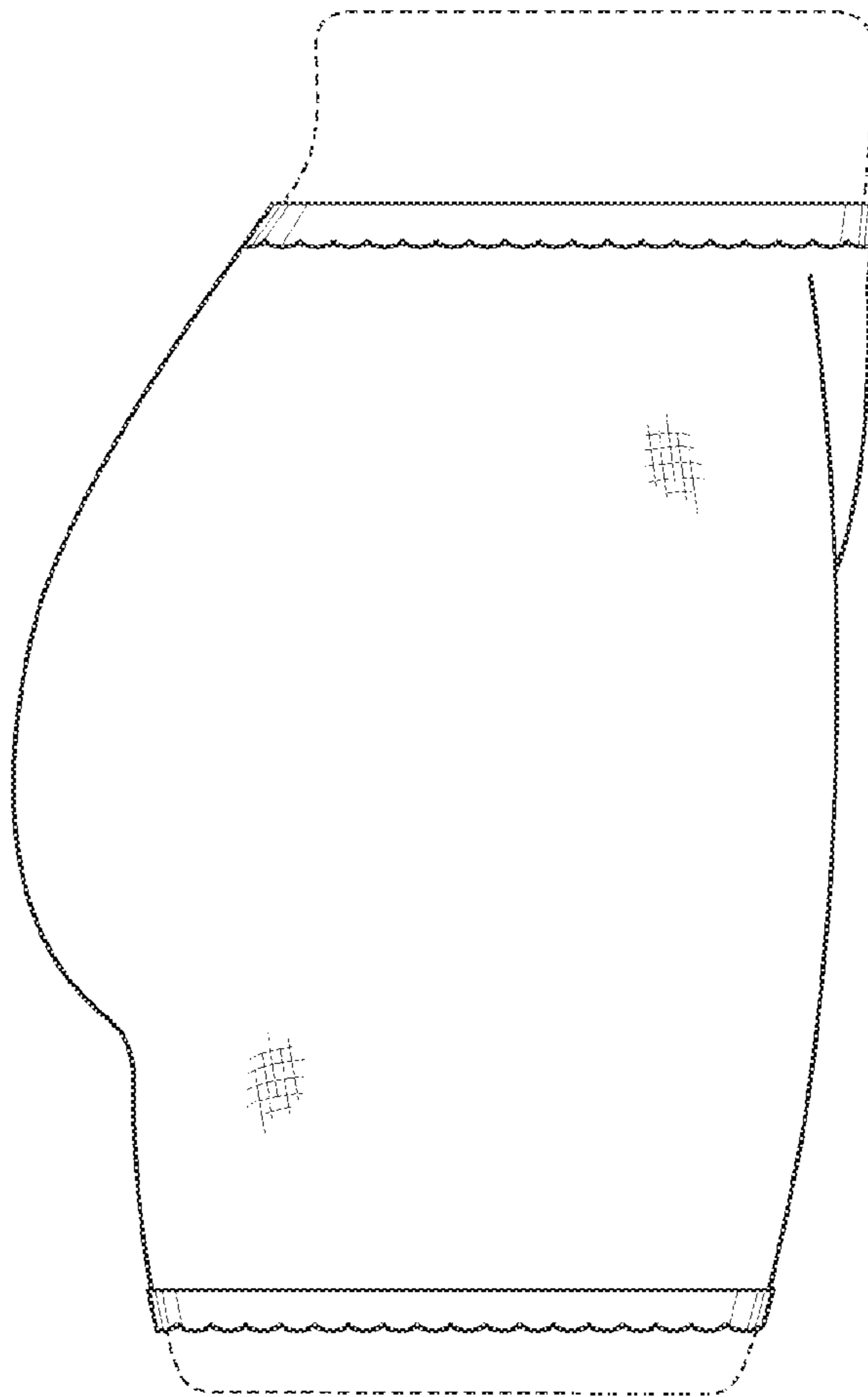

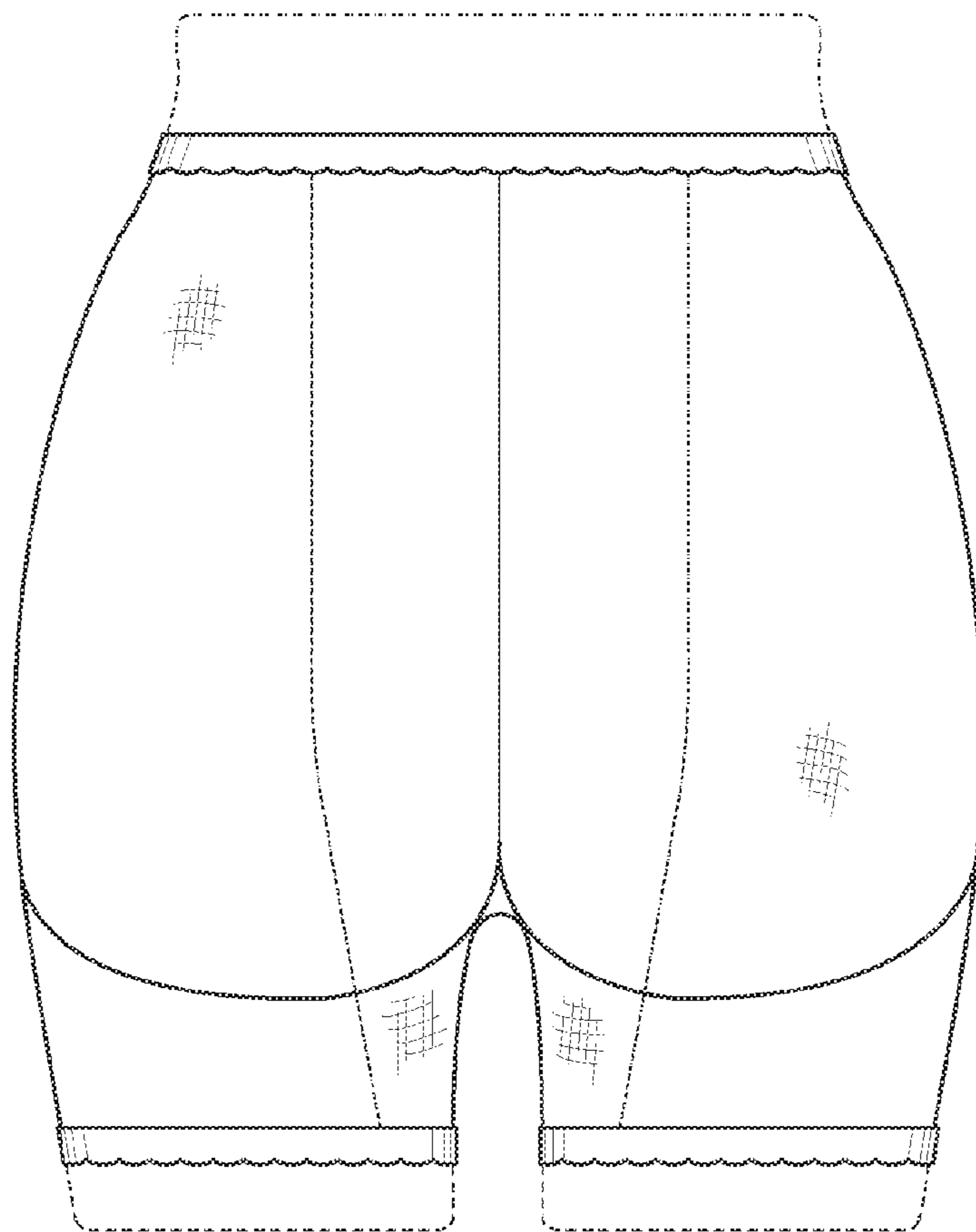

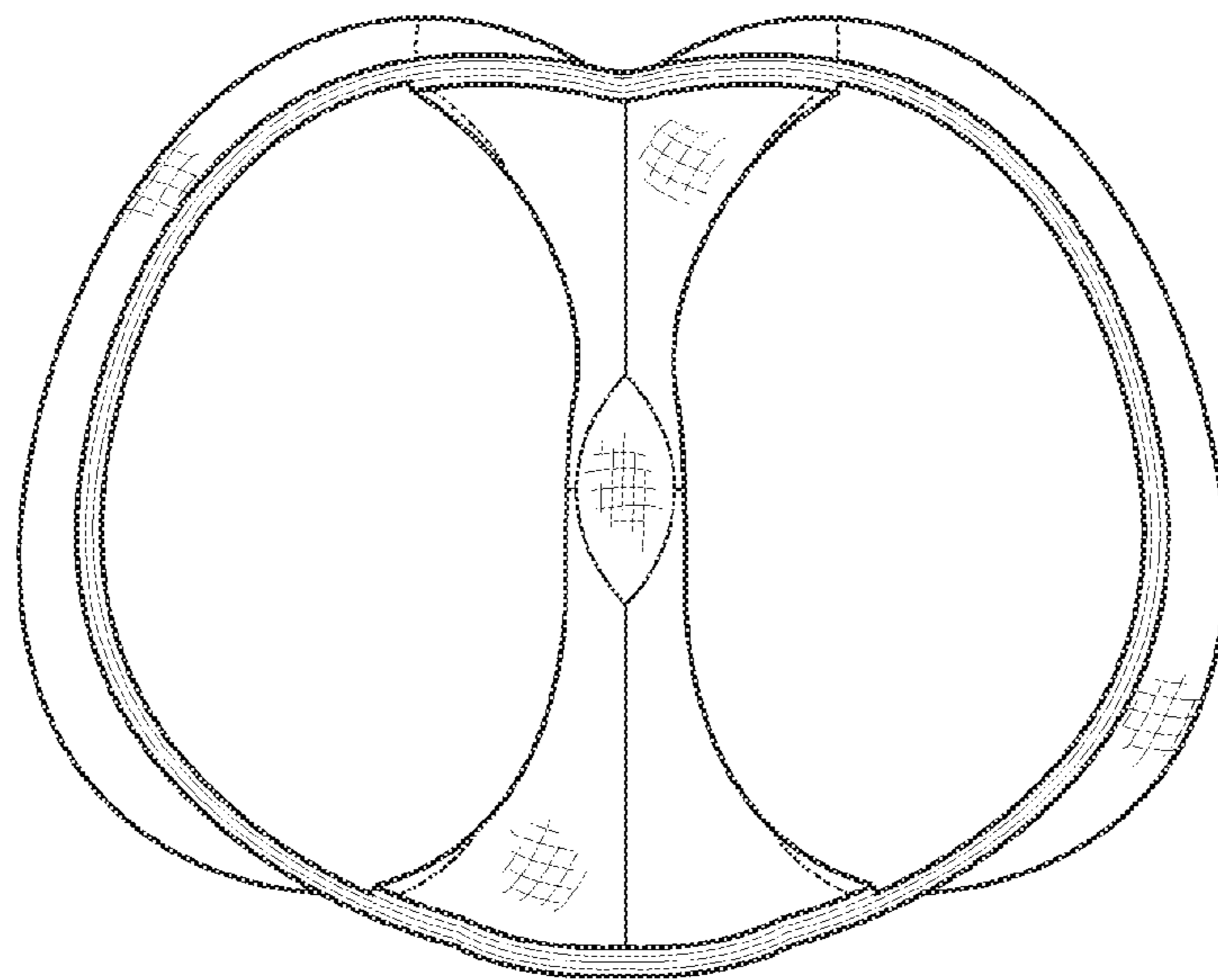

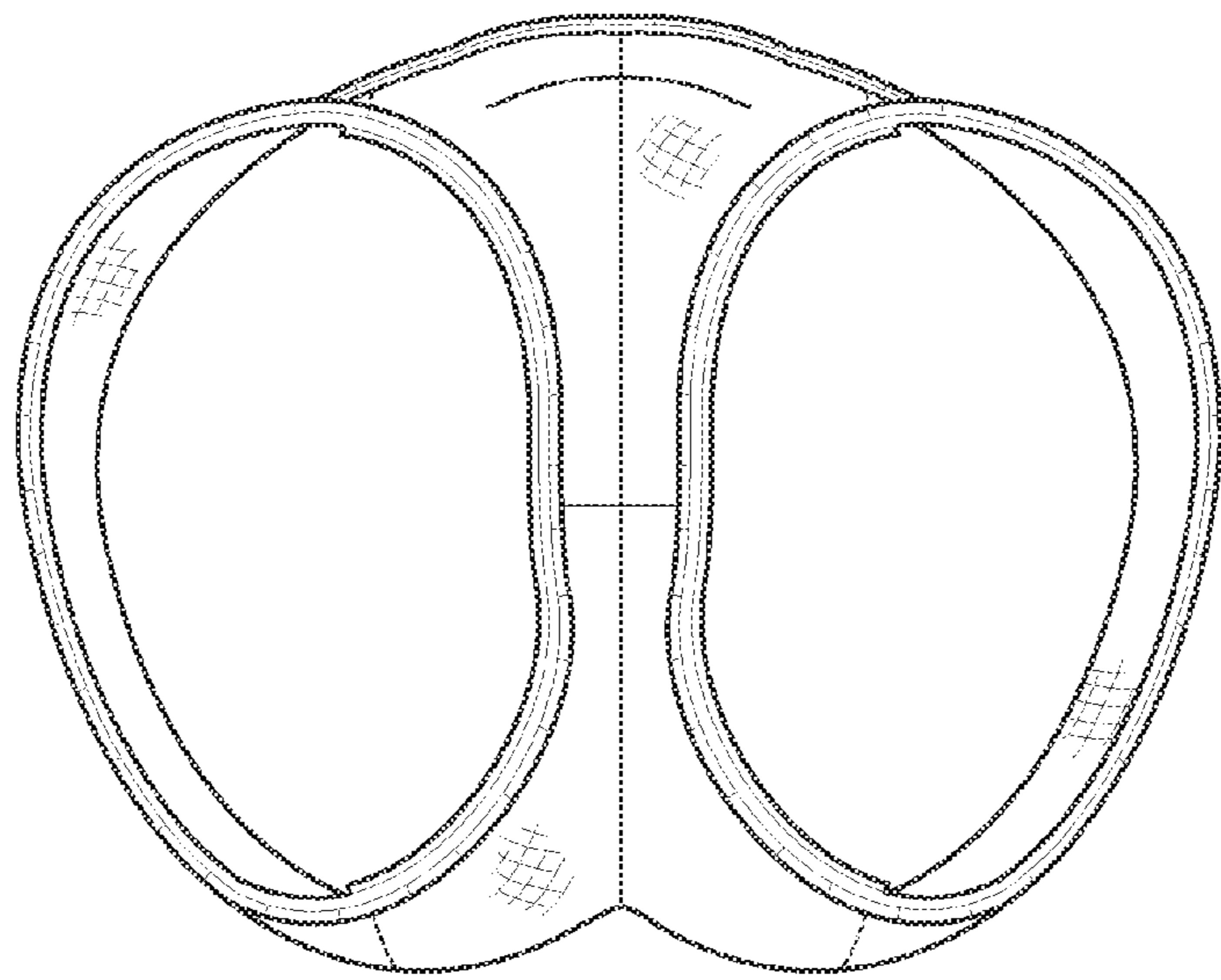

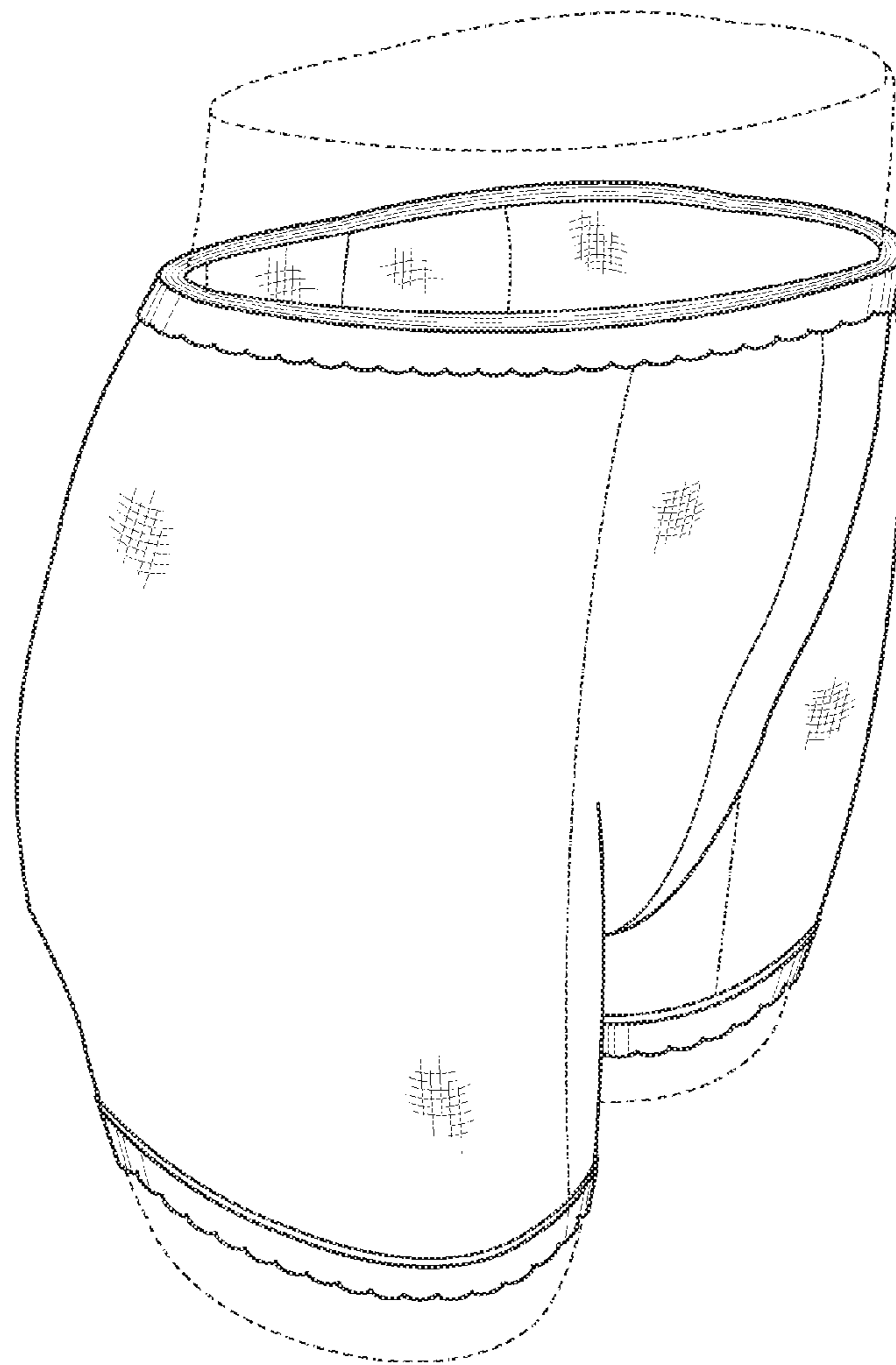

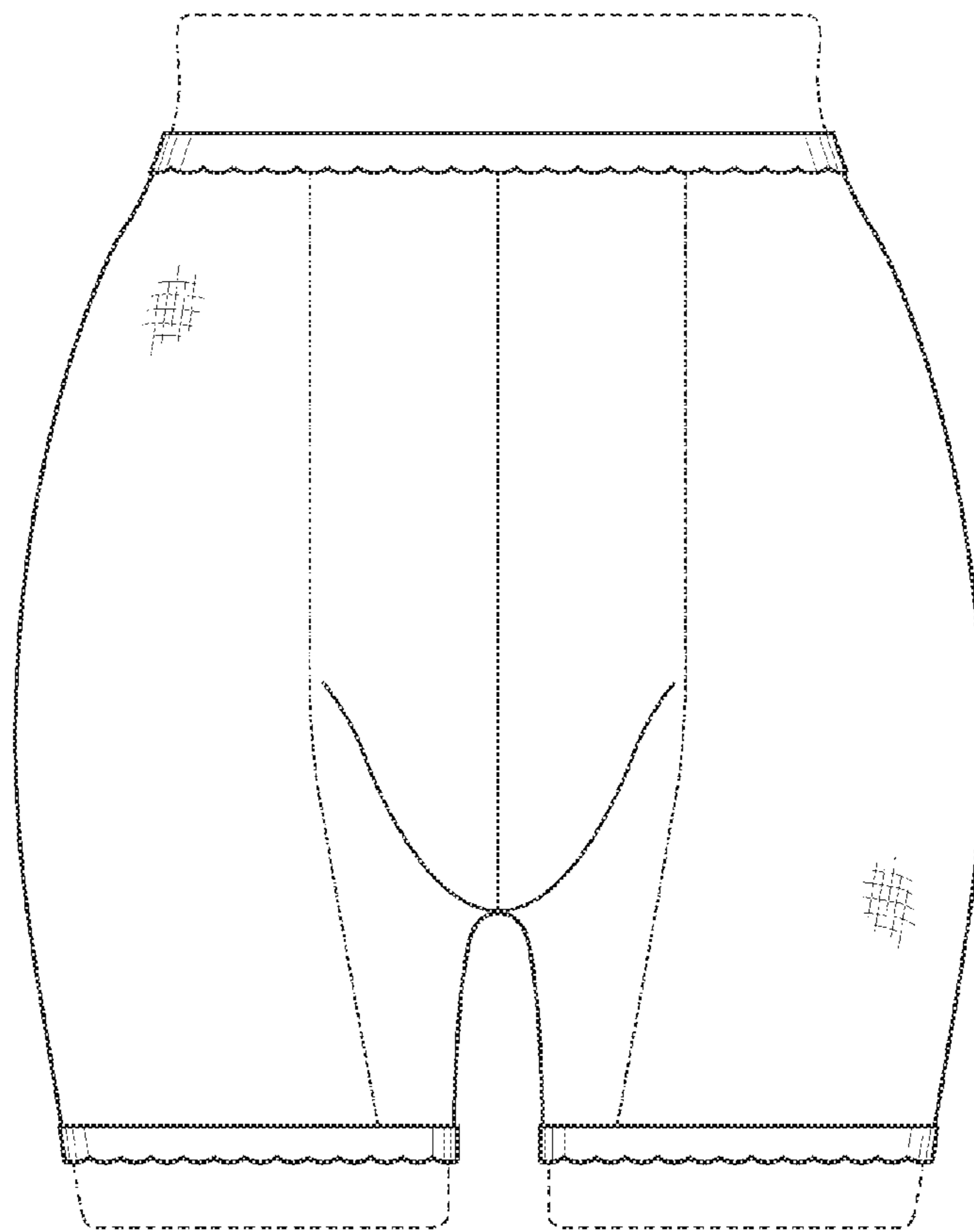

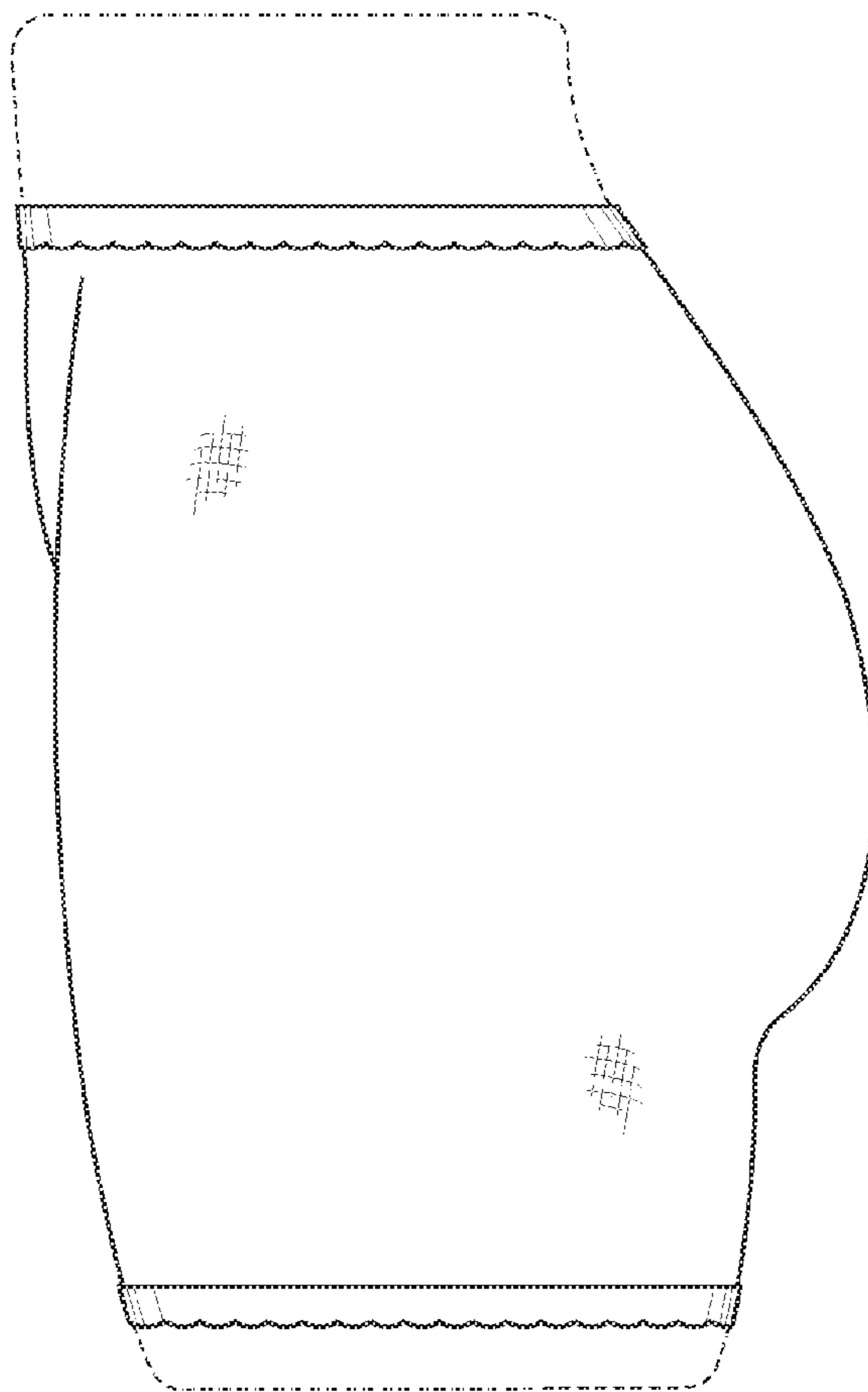

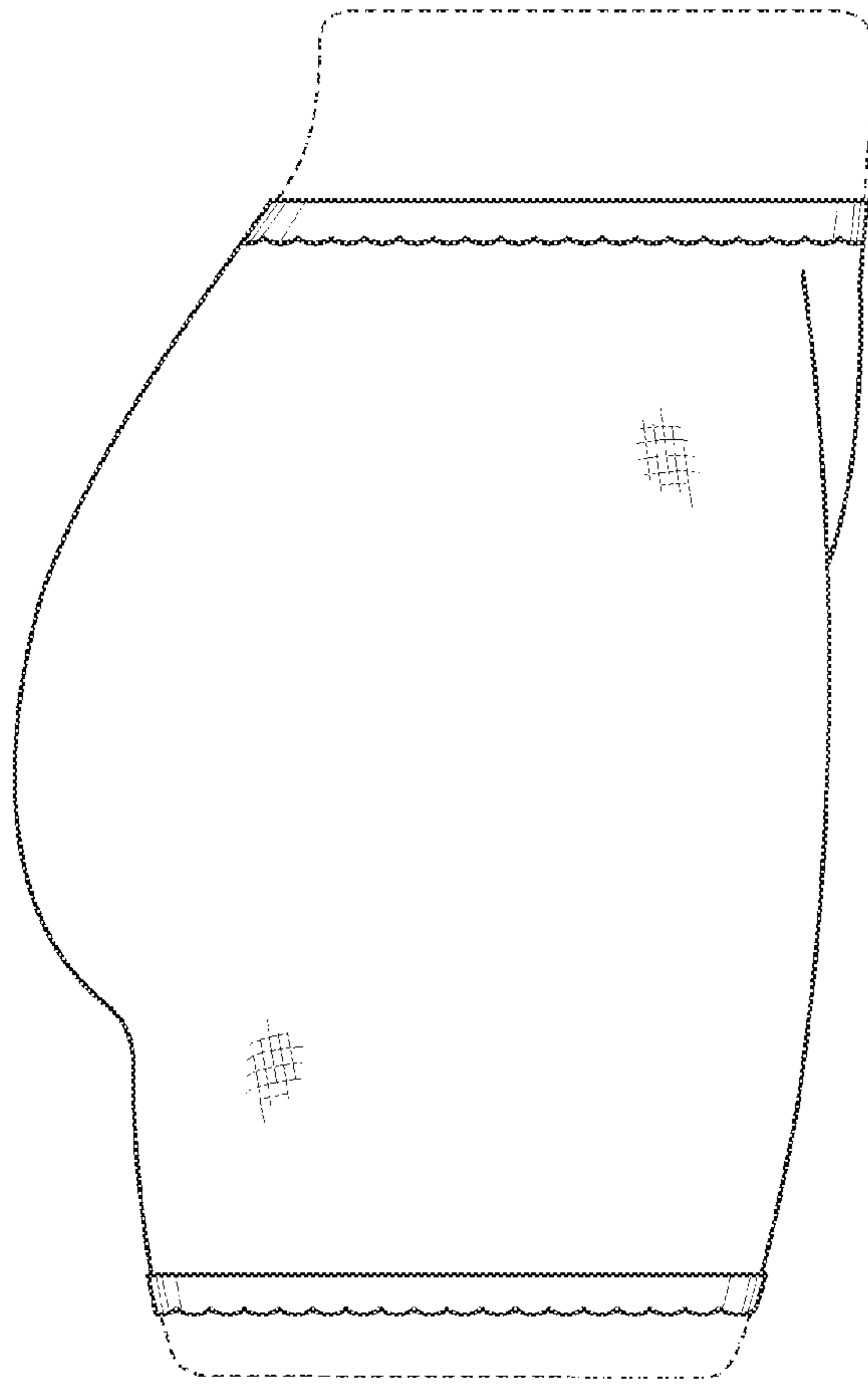

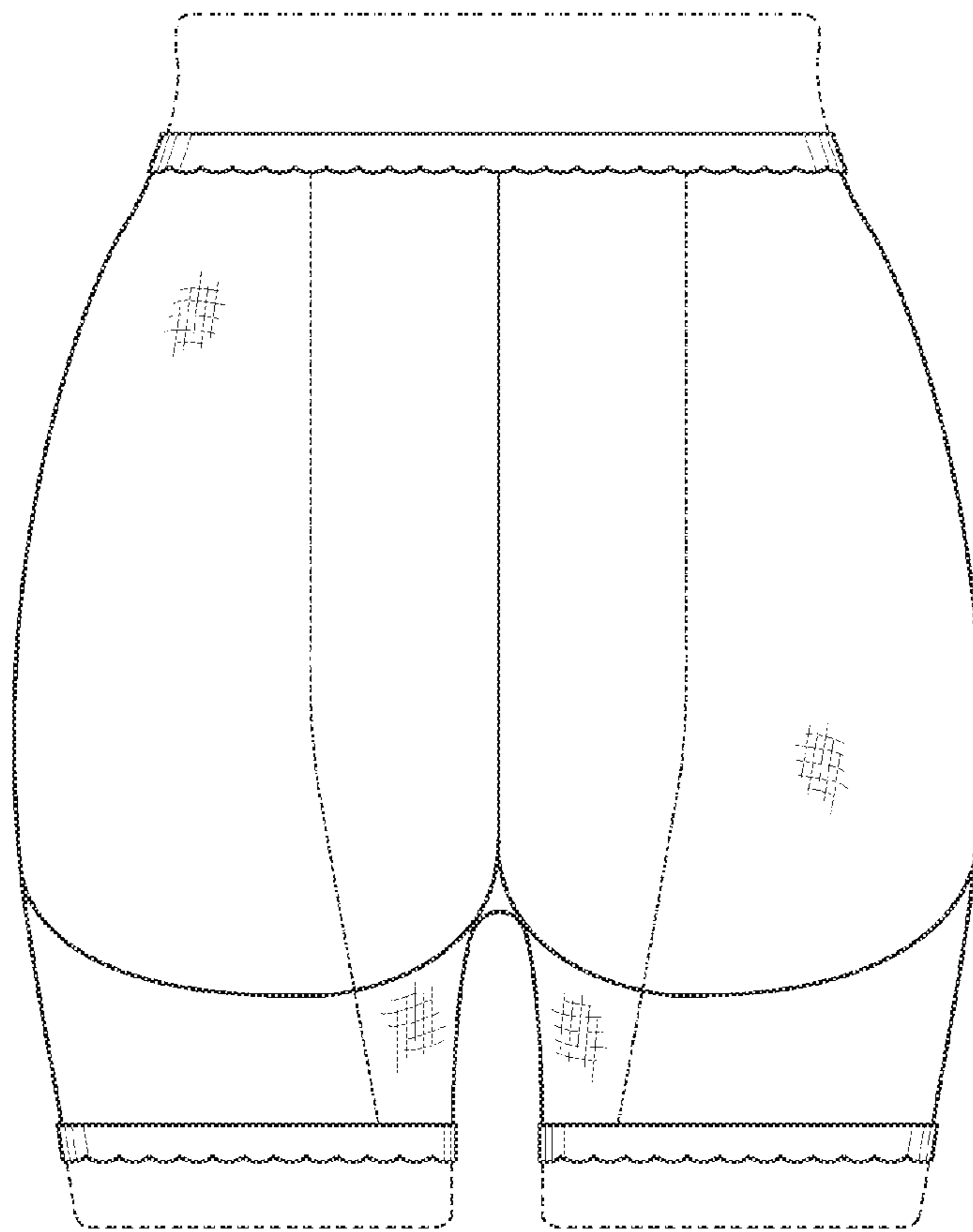

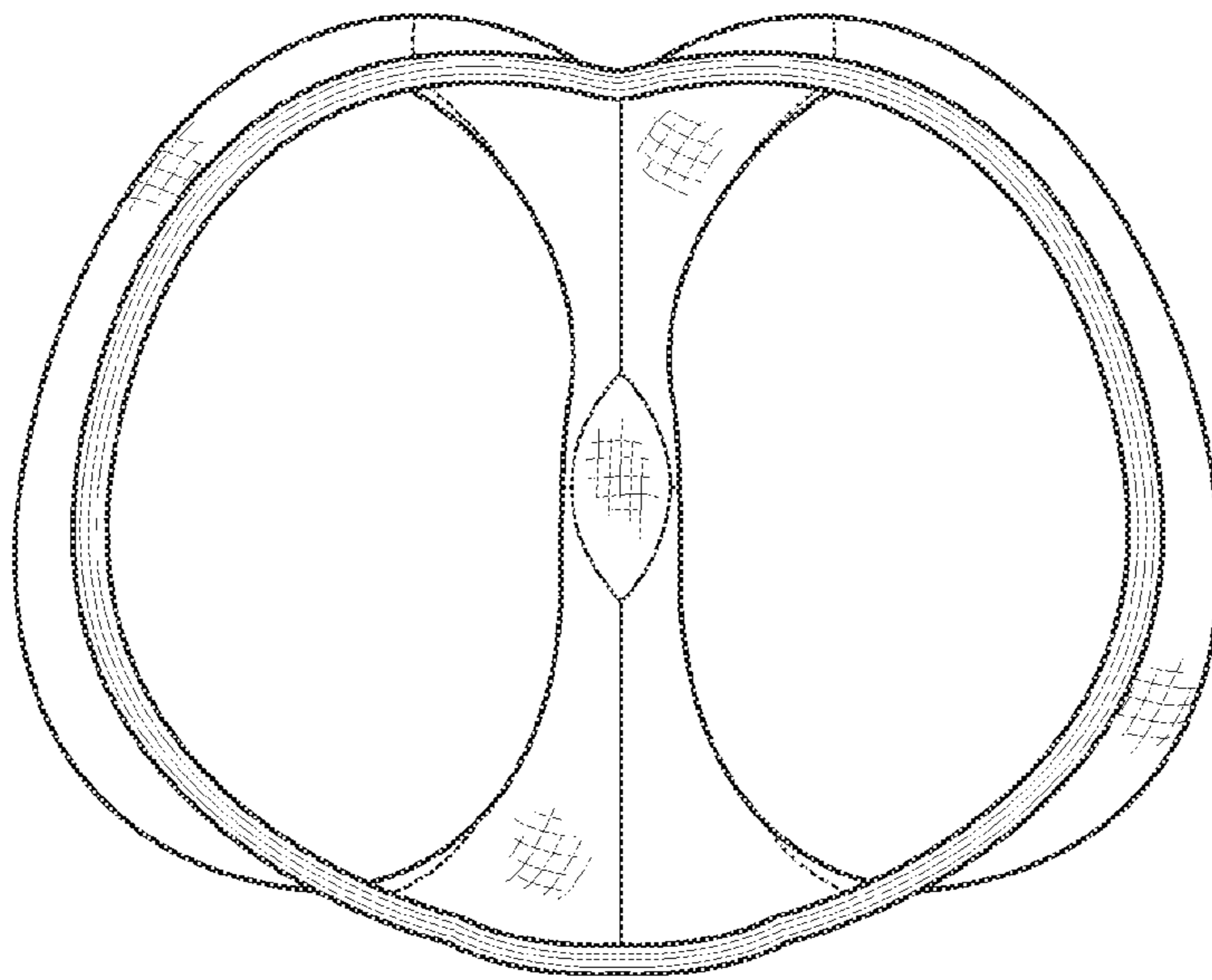

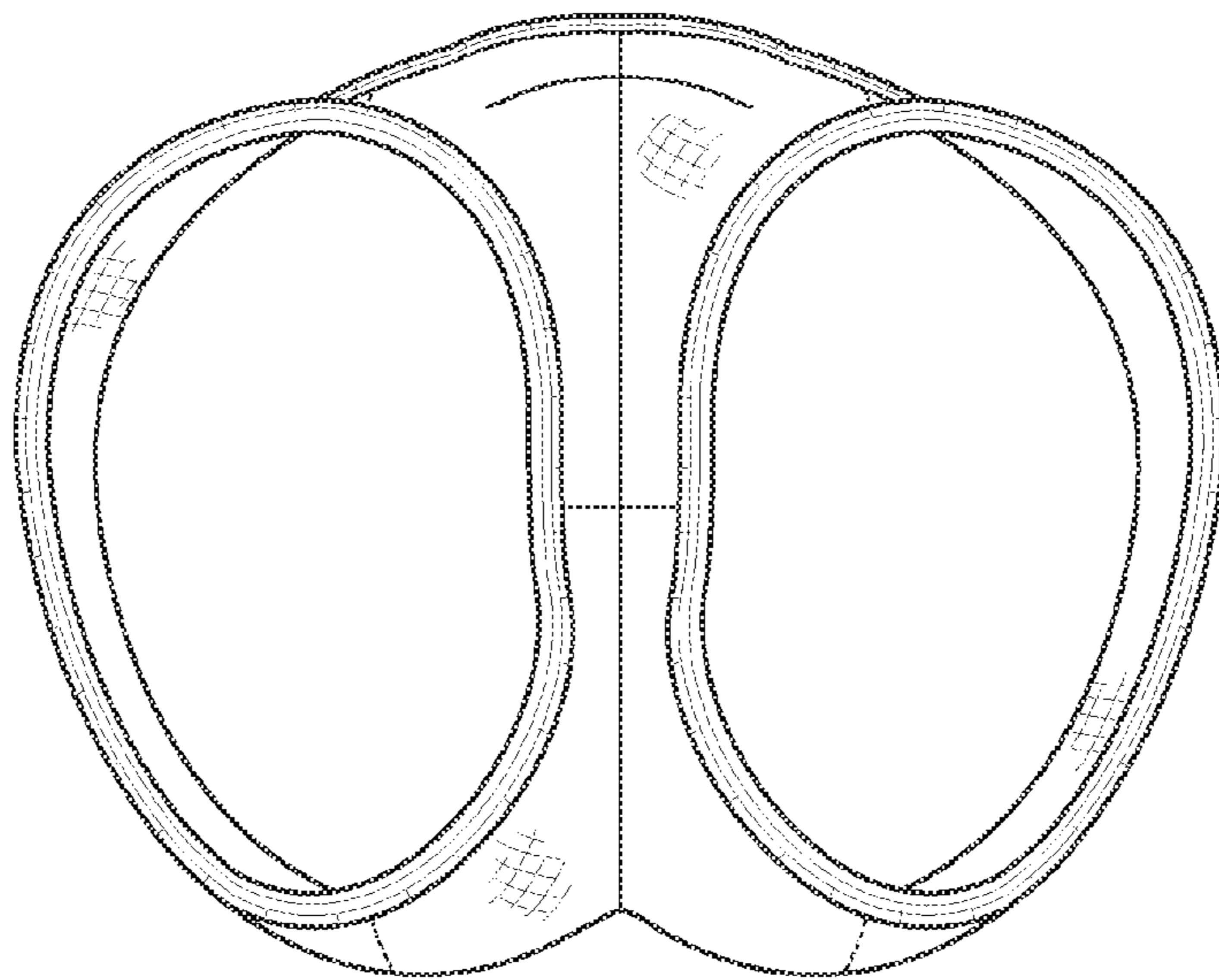
