DESCRIPTION

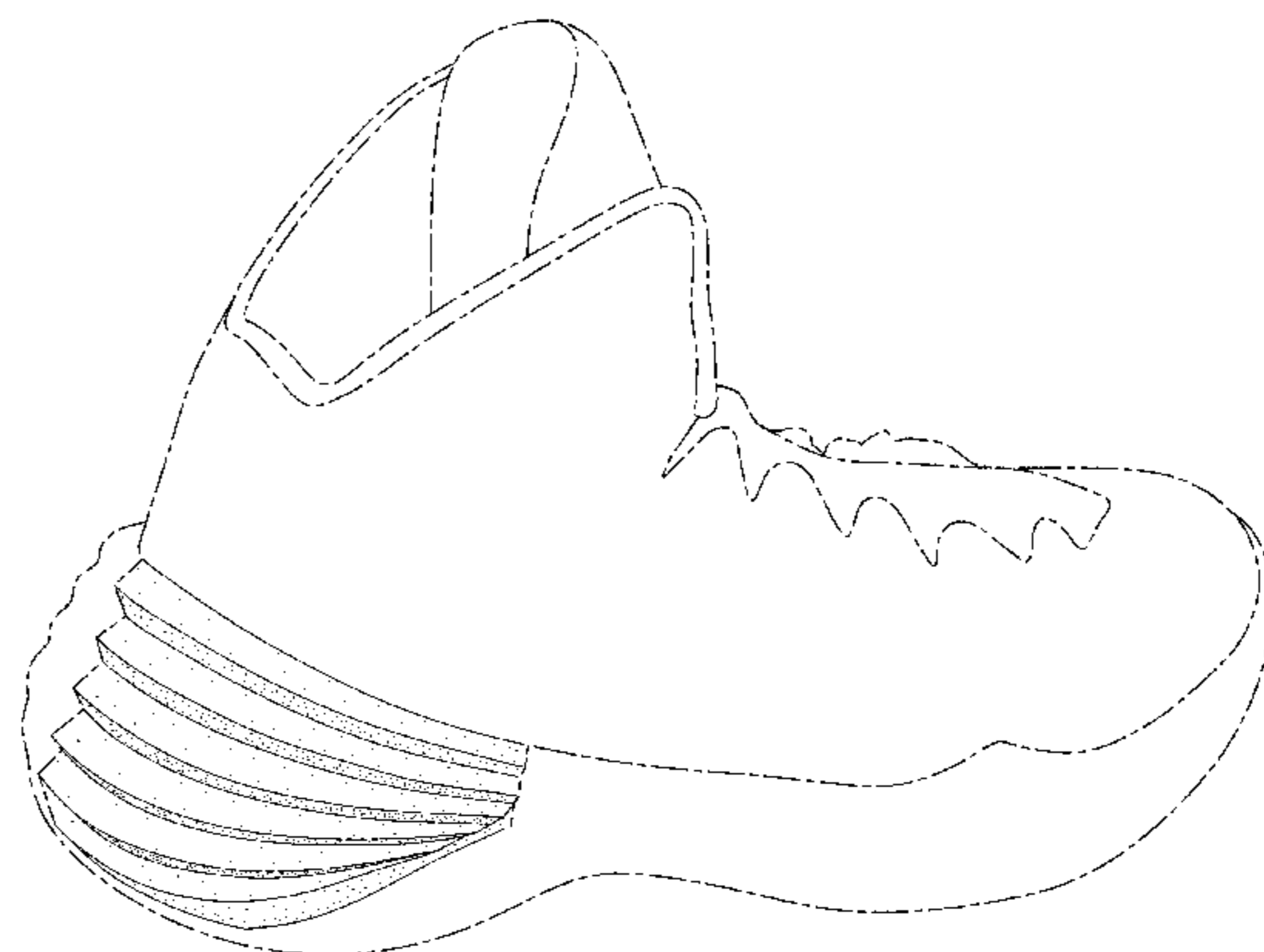
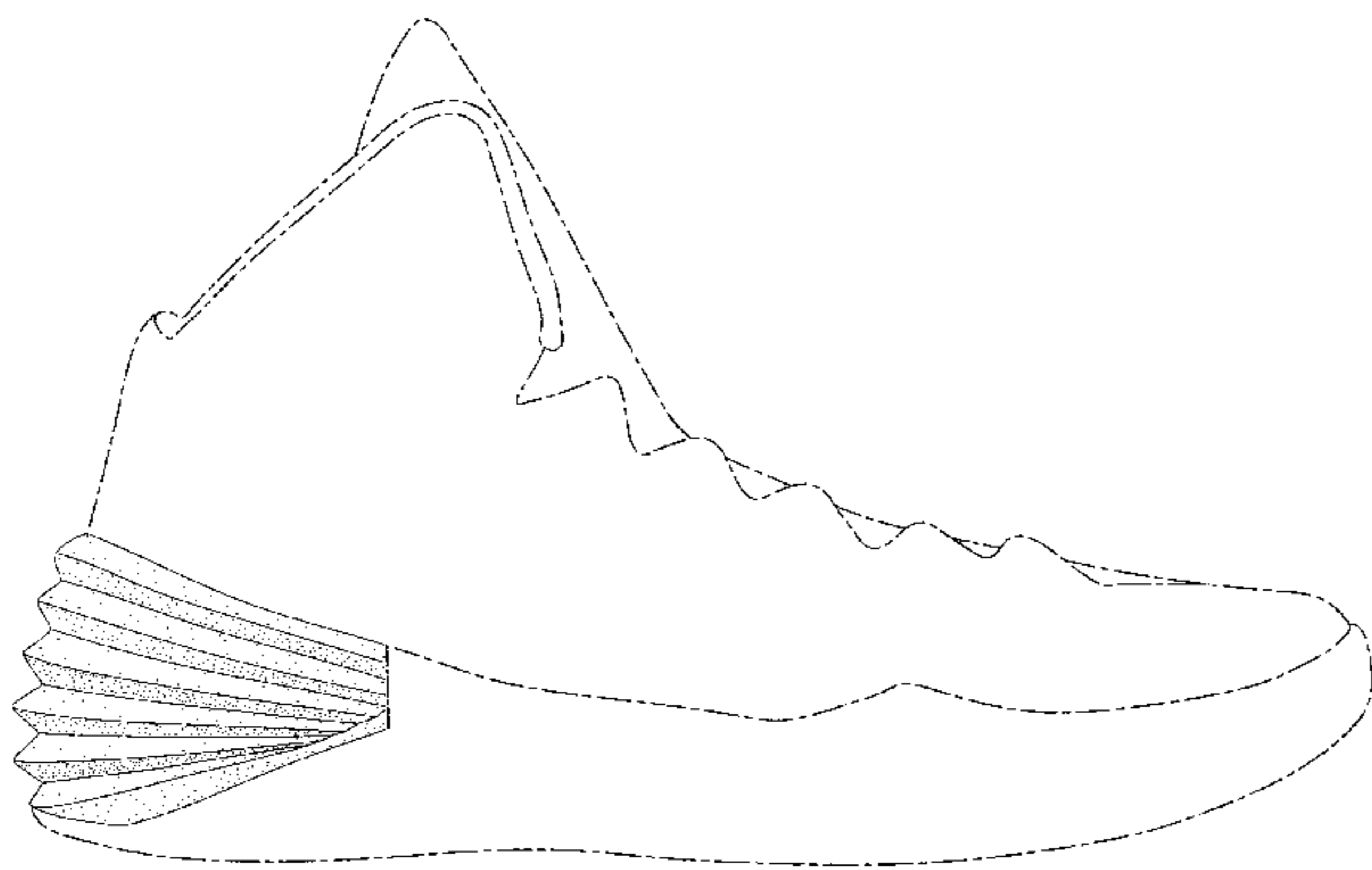
FIG. 1 is a side view of a shoe midsole showing my new design;

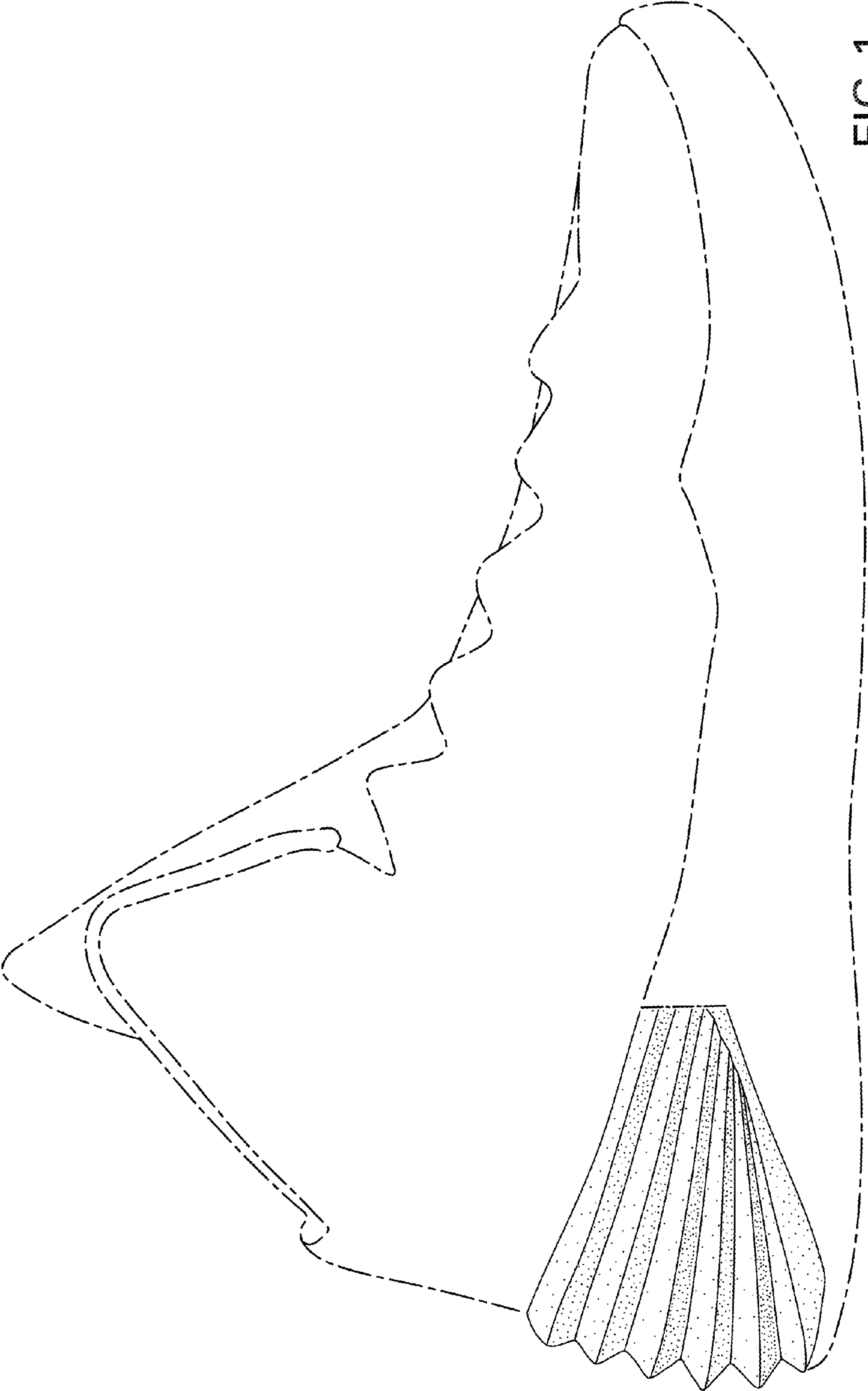

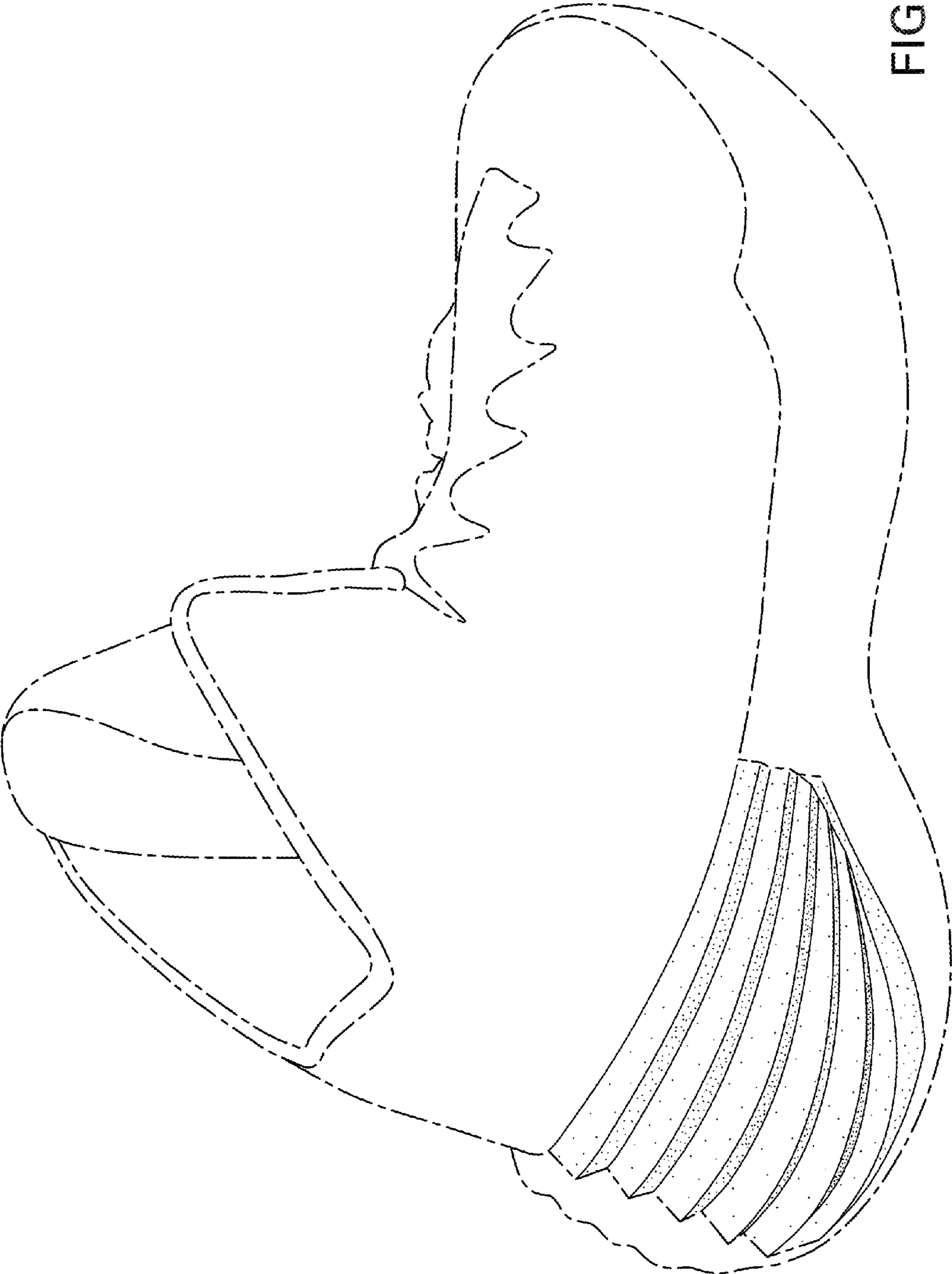

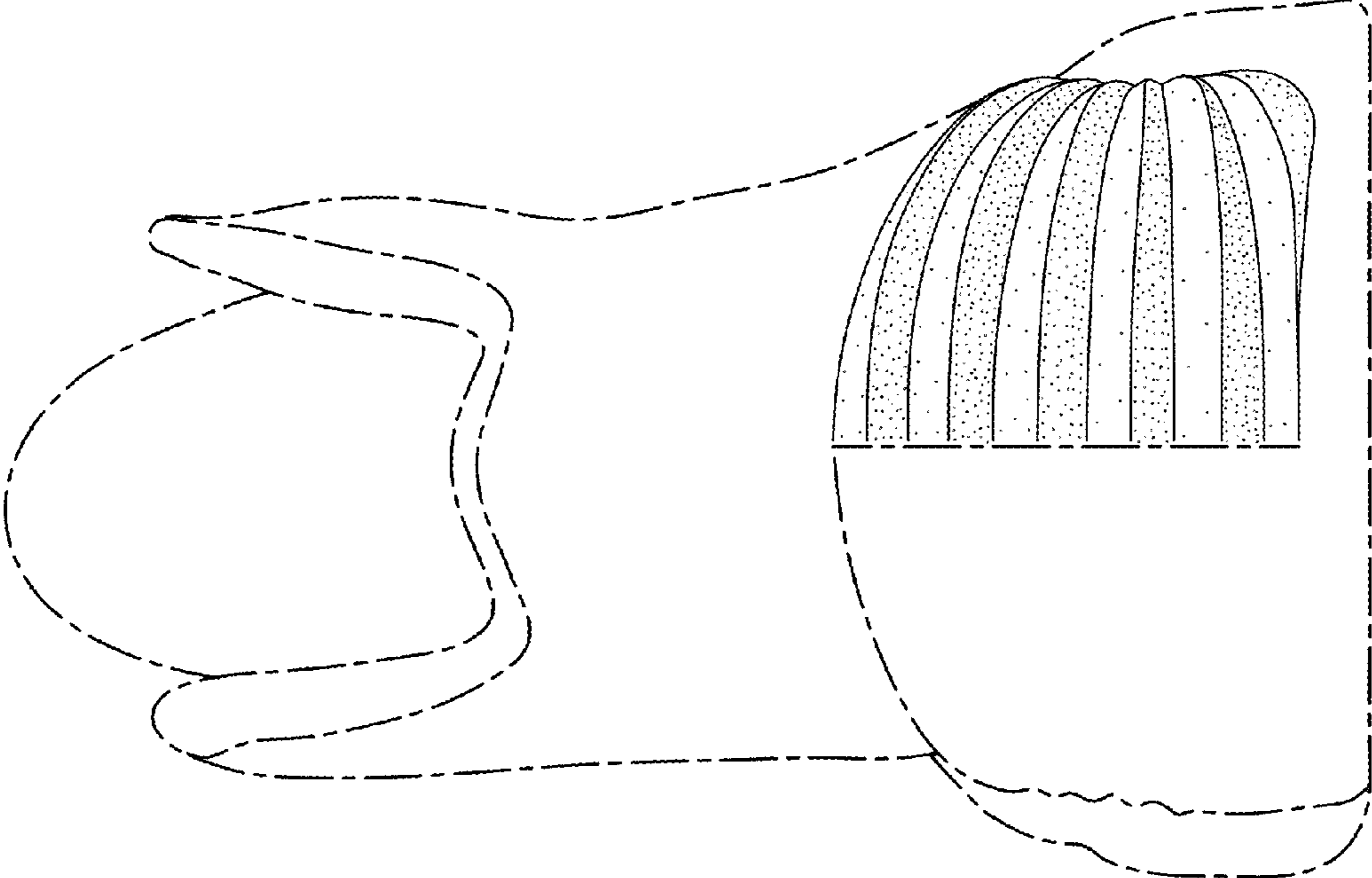
