FIG. 1 is a front perspective view of a shoe midsole showing our new design;

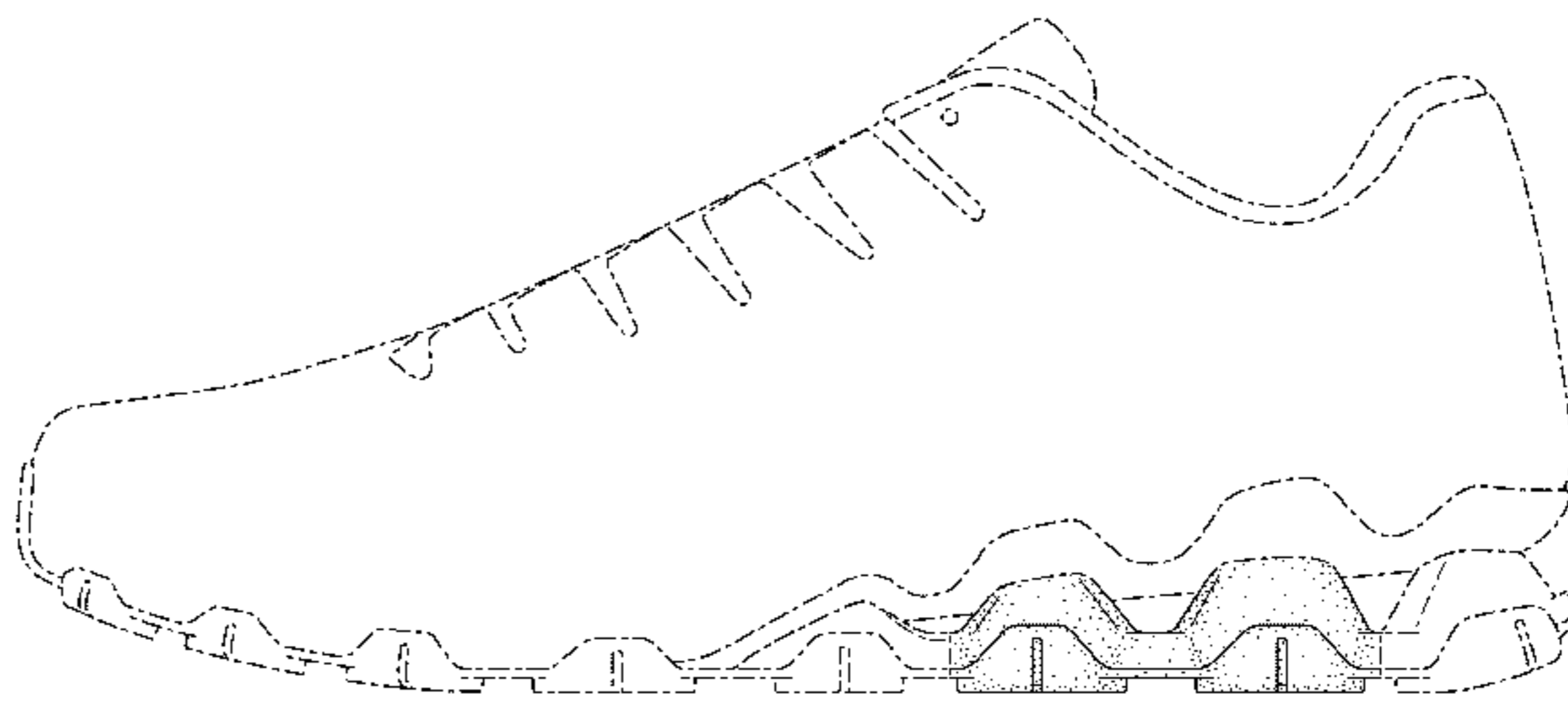
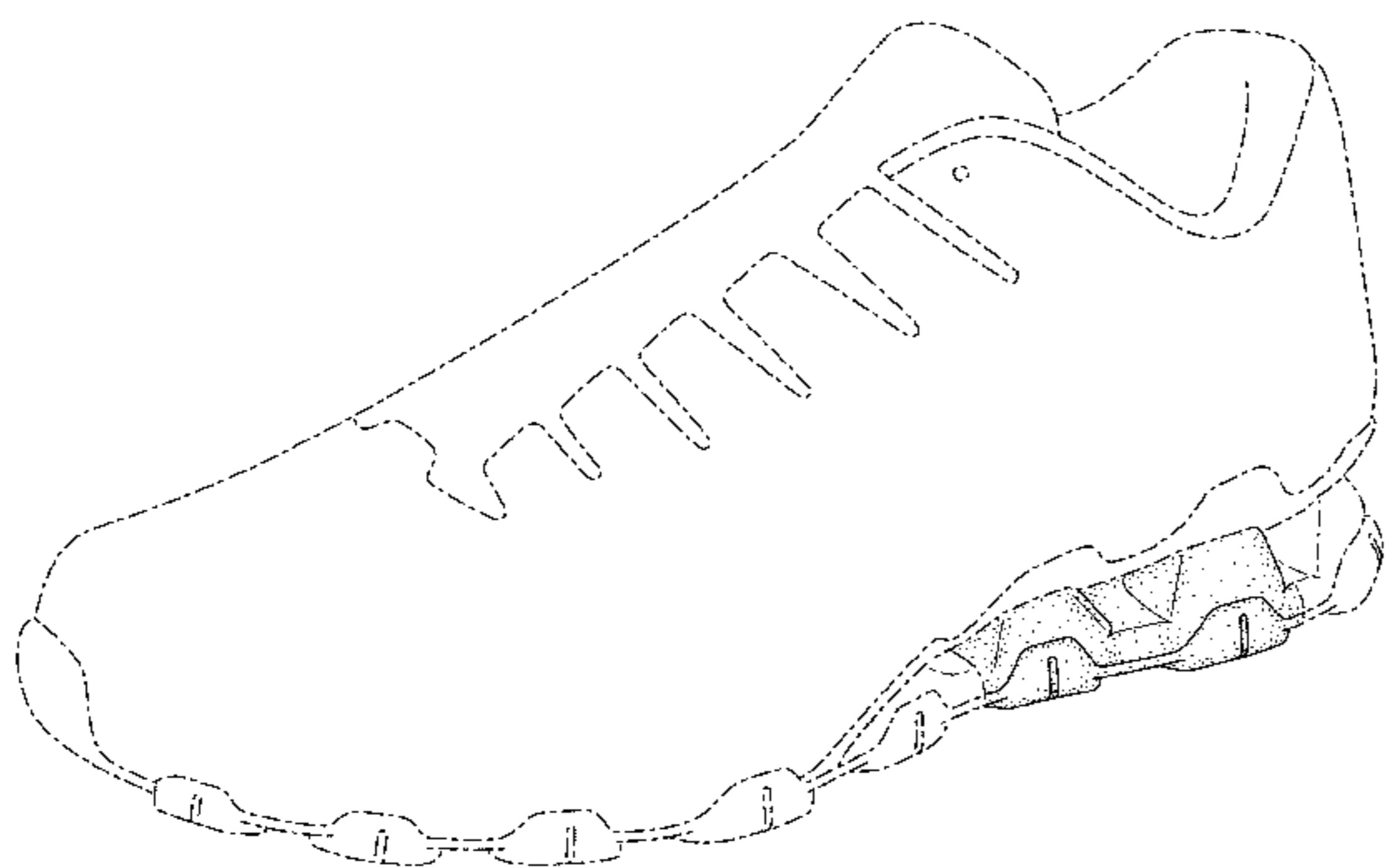
FIG. 2 is a rear perspective view thereof;

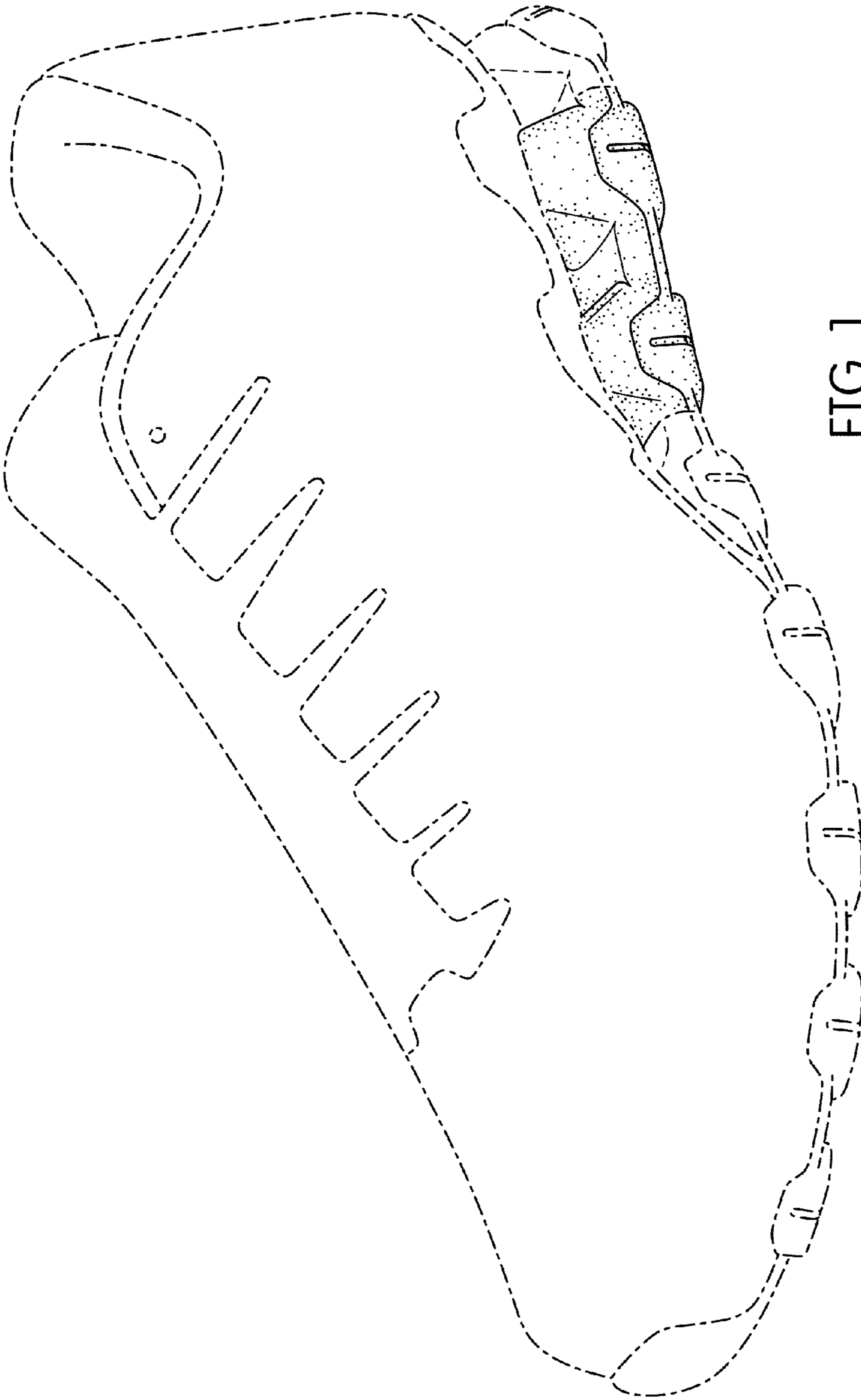

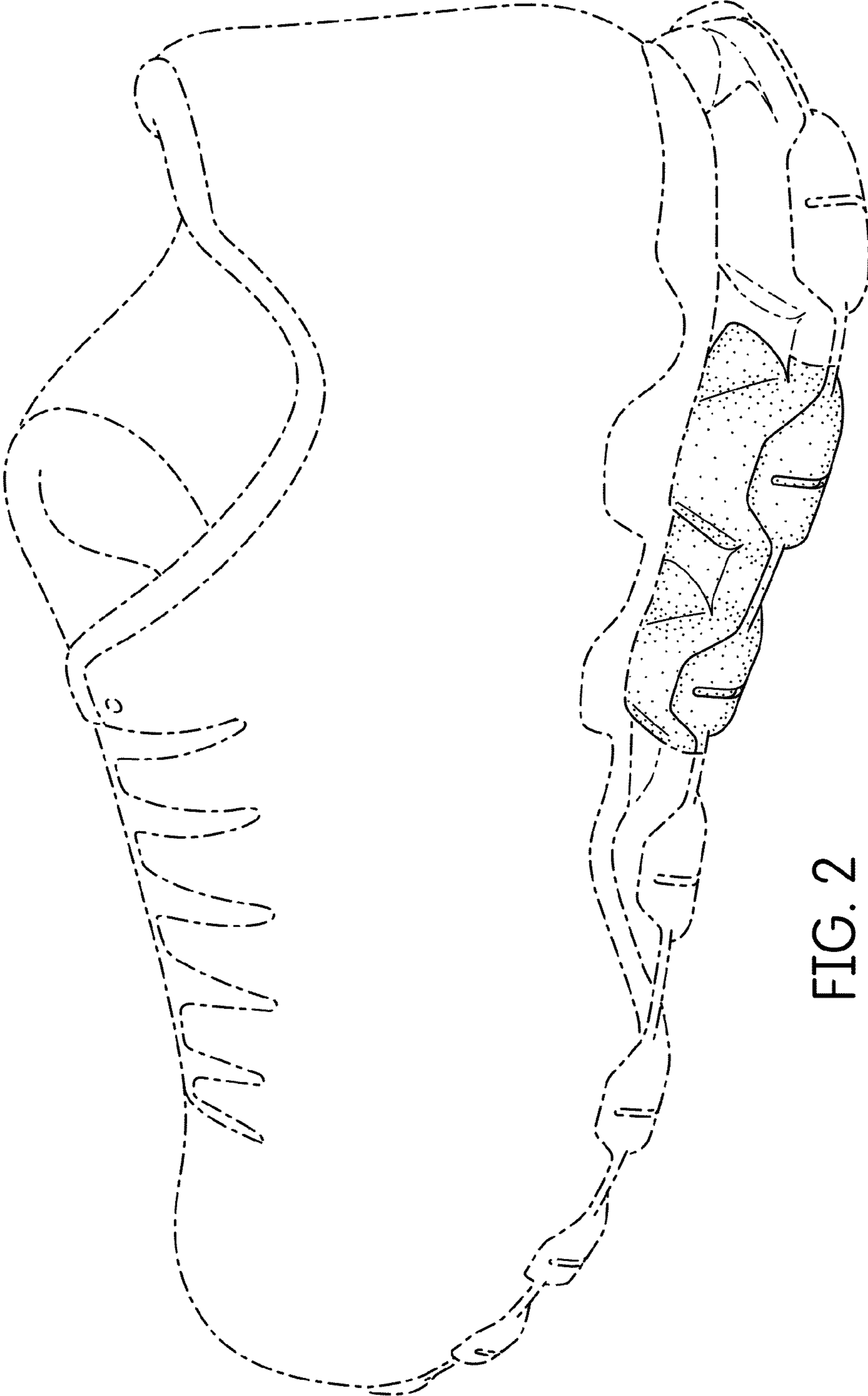

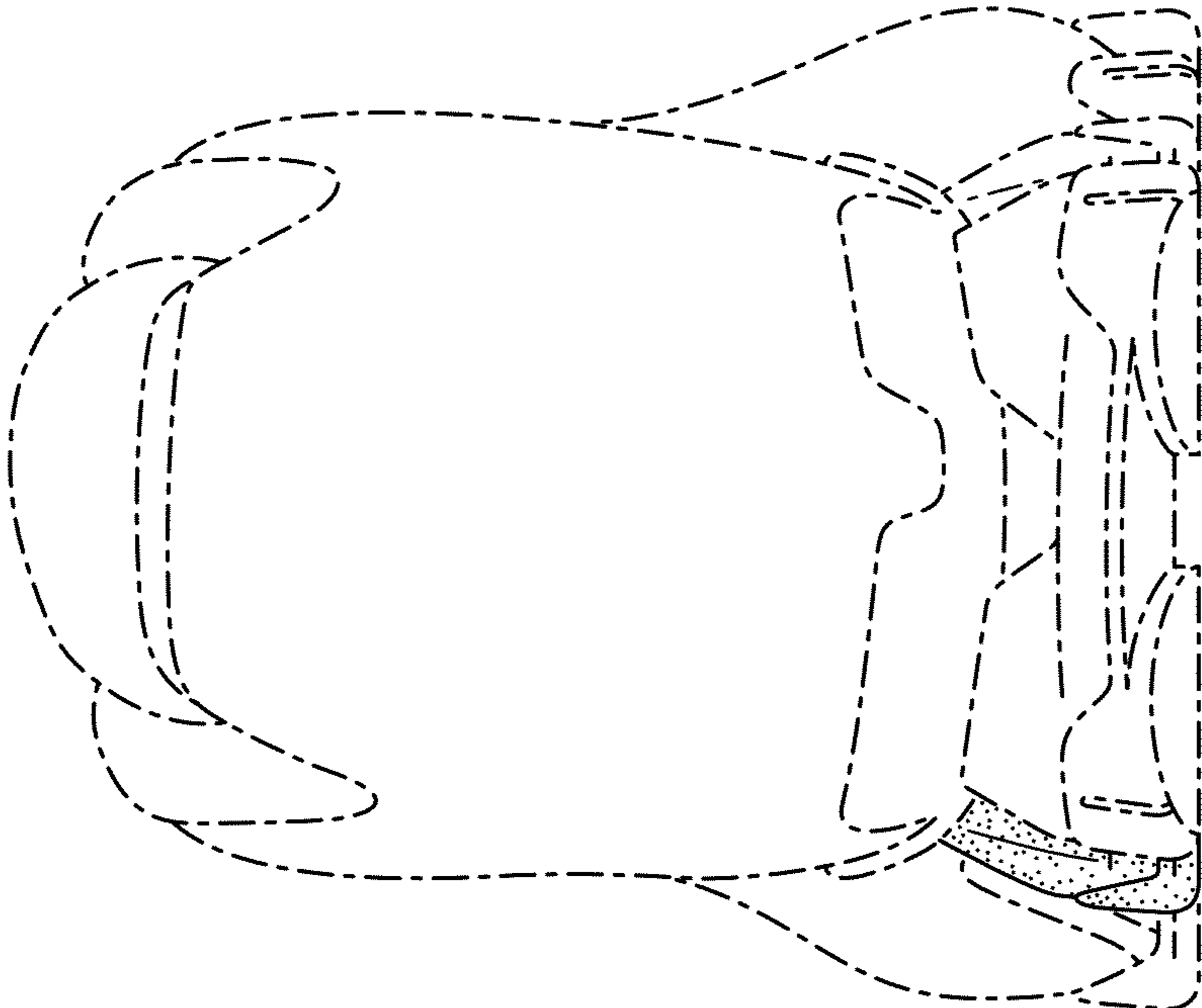
