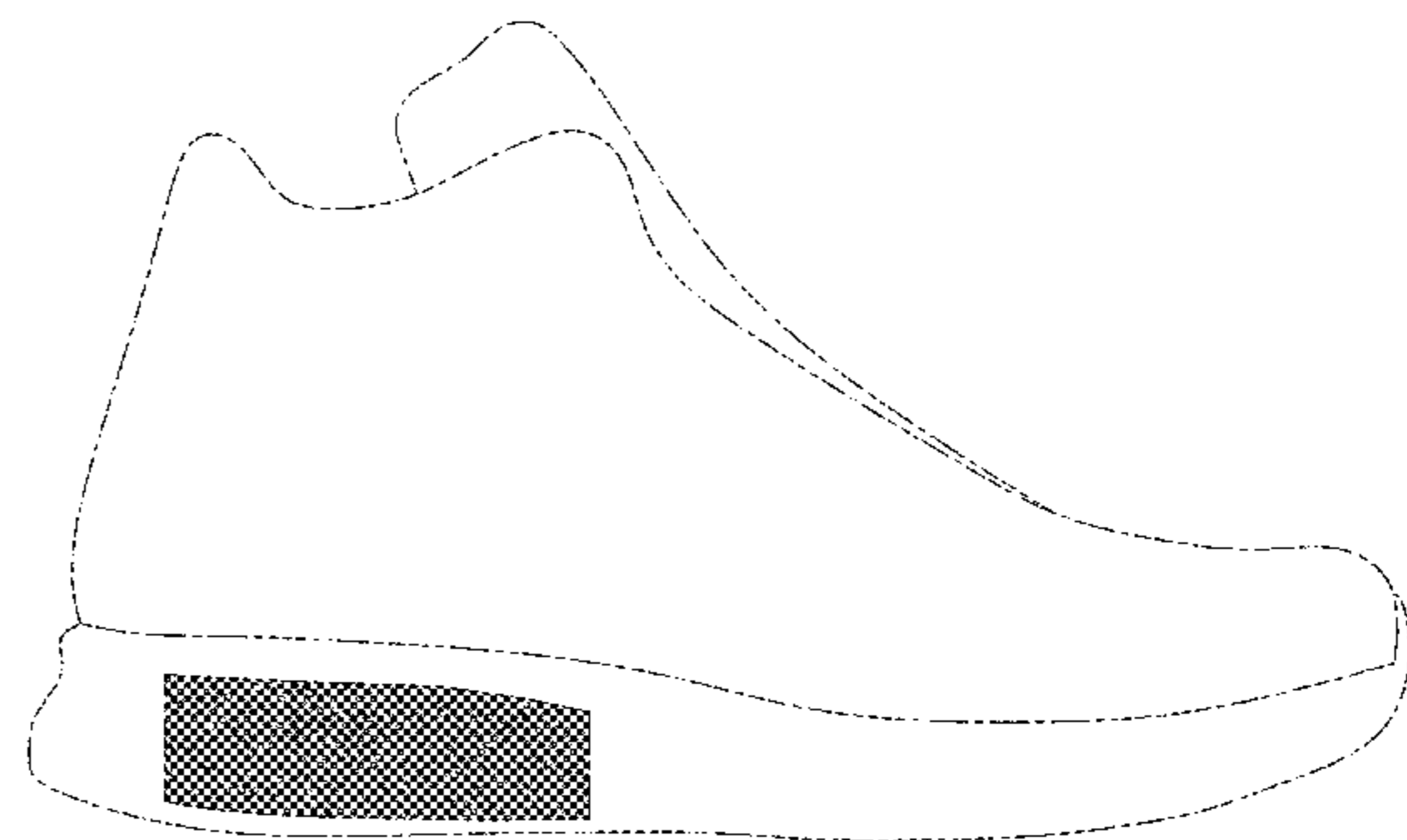
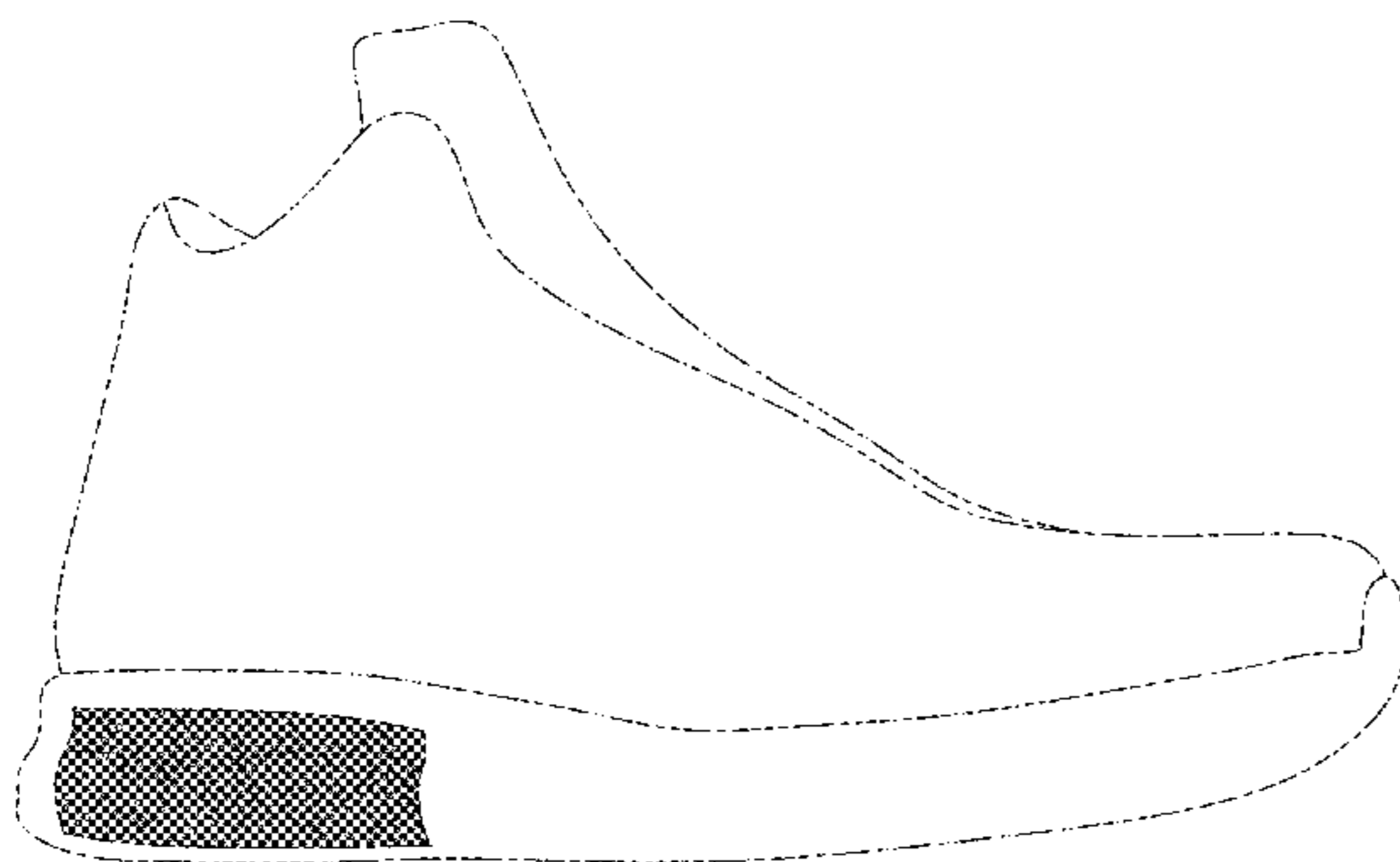
(57) **CLAIM**

The ornamental design for a shoe midsole with partially translucent region, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe midsole with partially translucent region showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a front perspective view of the shoe midsole with partially translucent region of FIGS. 1-3 shown without the disclaimed interior elements for clarity purposes;
FIG. 5 is a side view thereof; and,
FIG. 6 is a rear perspective view thereof.
The broken lines immediately adjacent to and fully surrounding the shaded area represent unclaimed boundaries of the design. The broken lines within the claimed region in FIGS. 1-3 represent disclaimed interior elements of the shoe midsole and form no part of the claimed design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

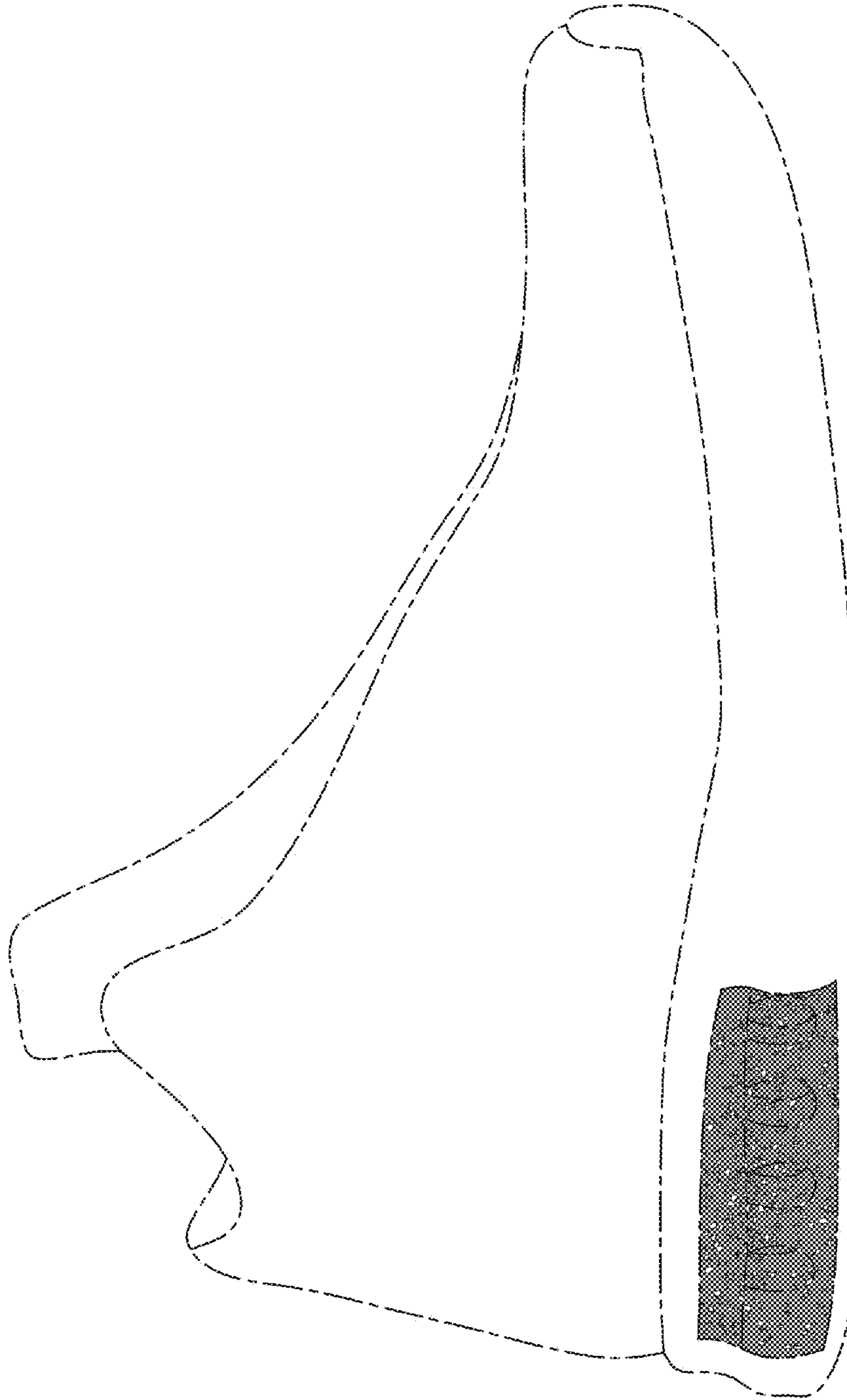

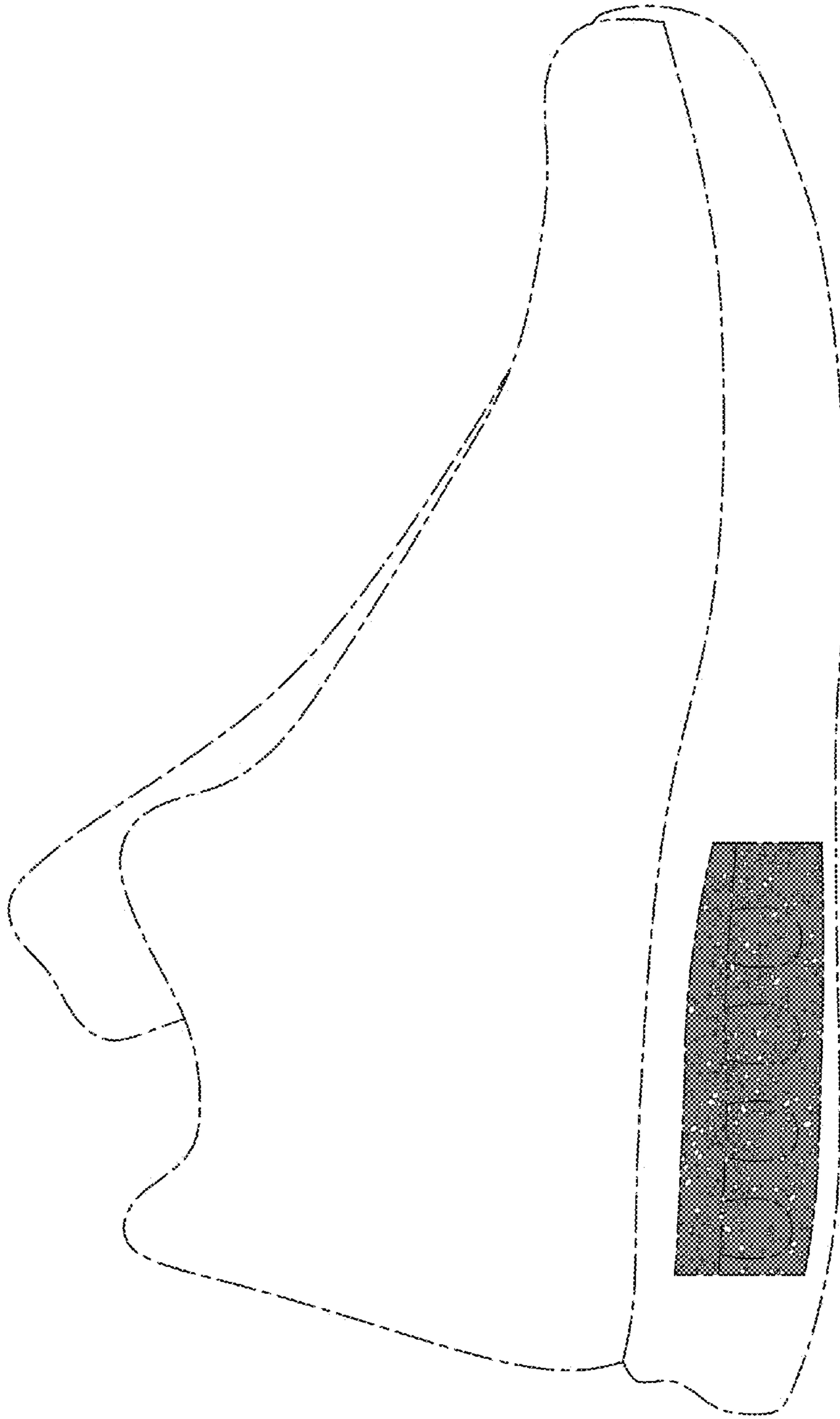

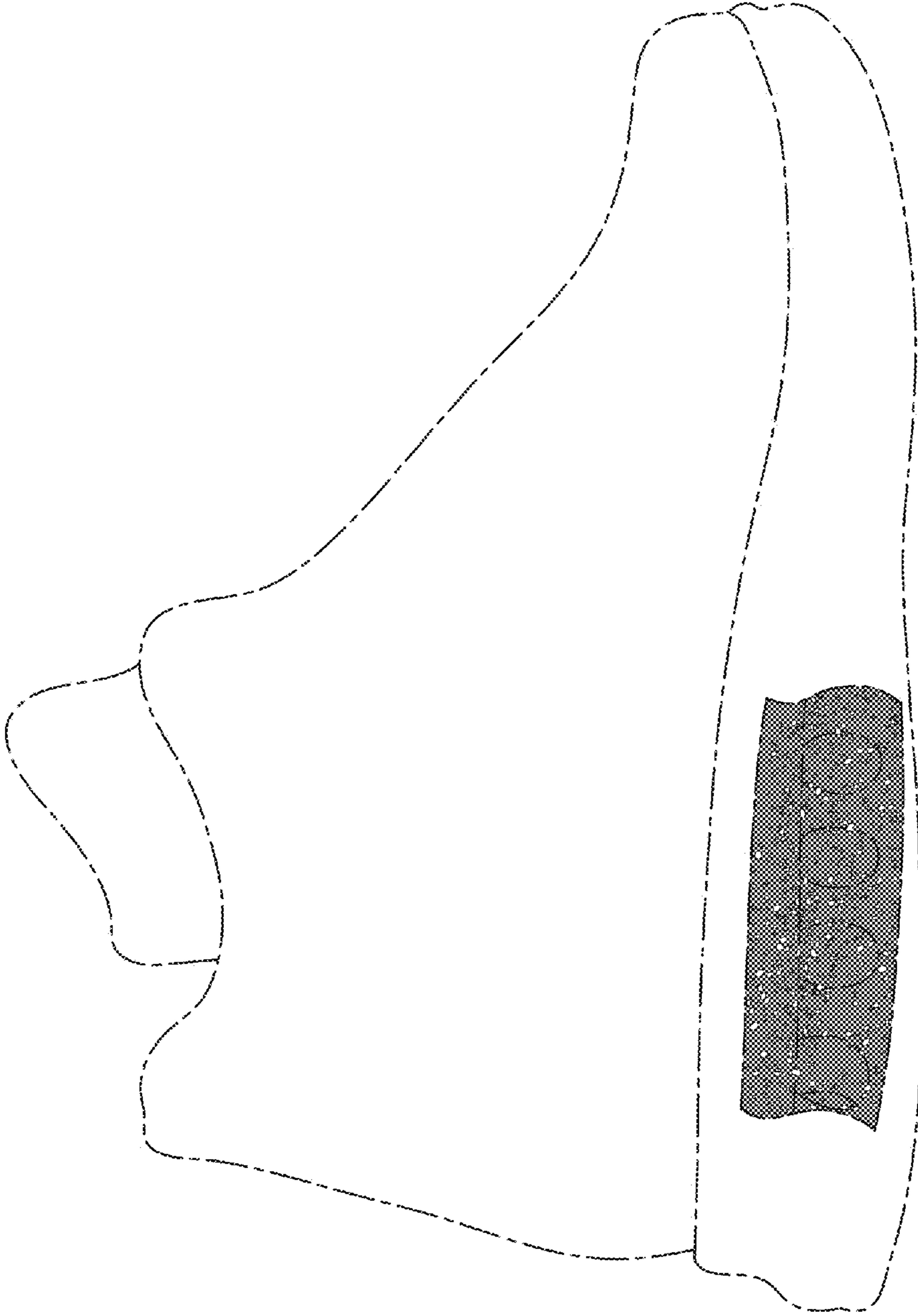

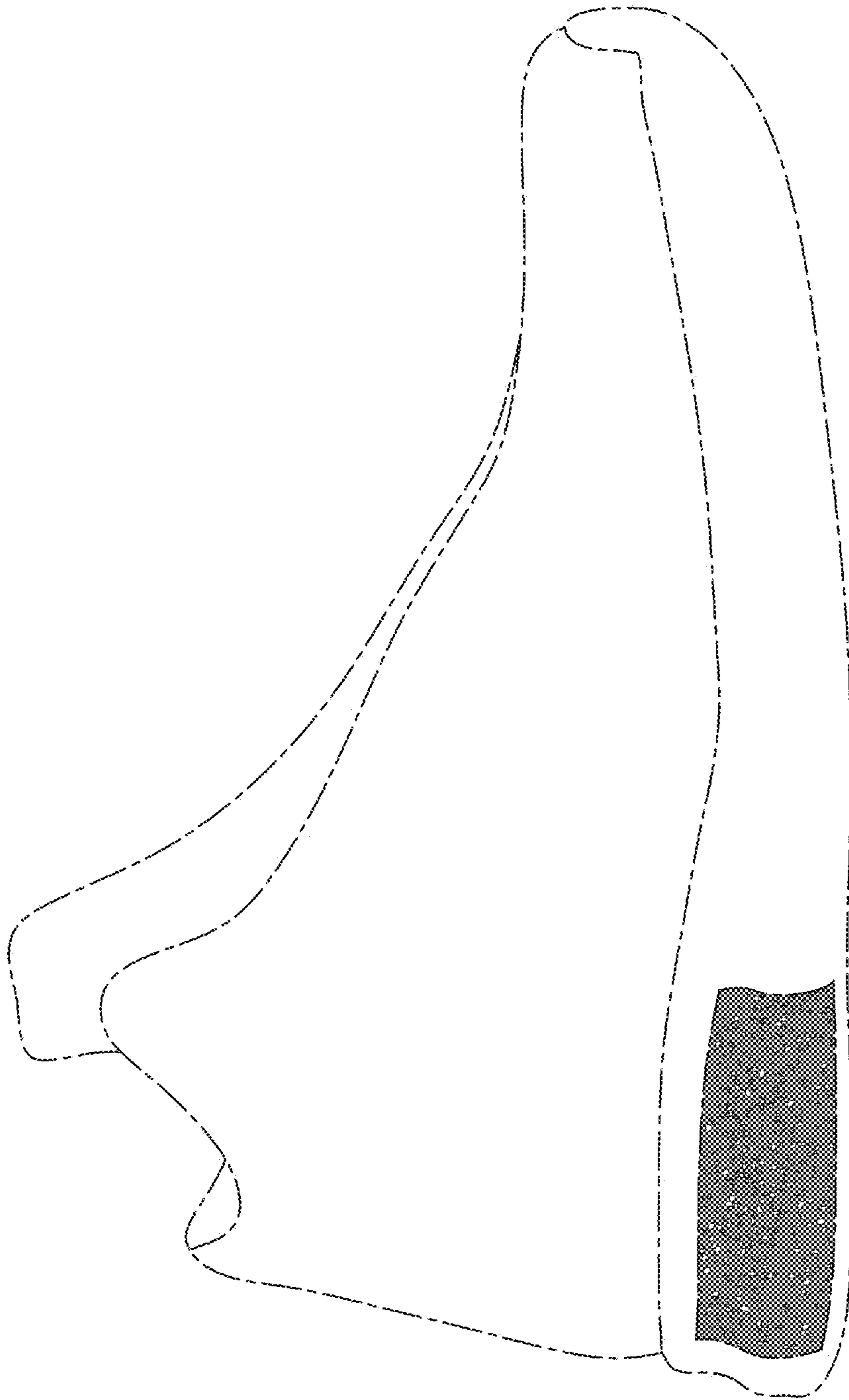

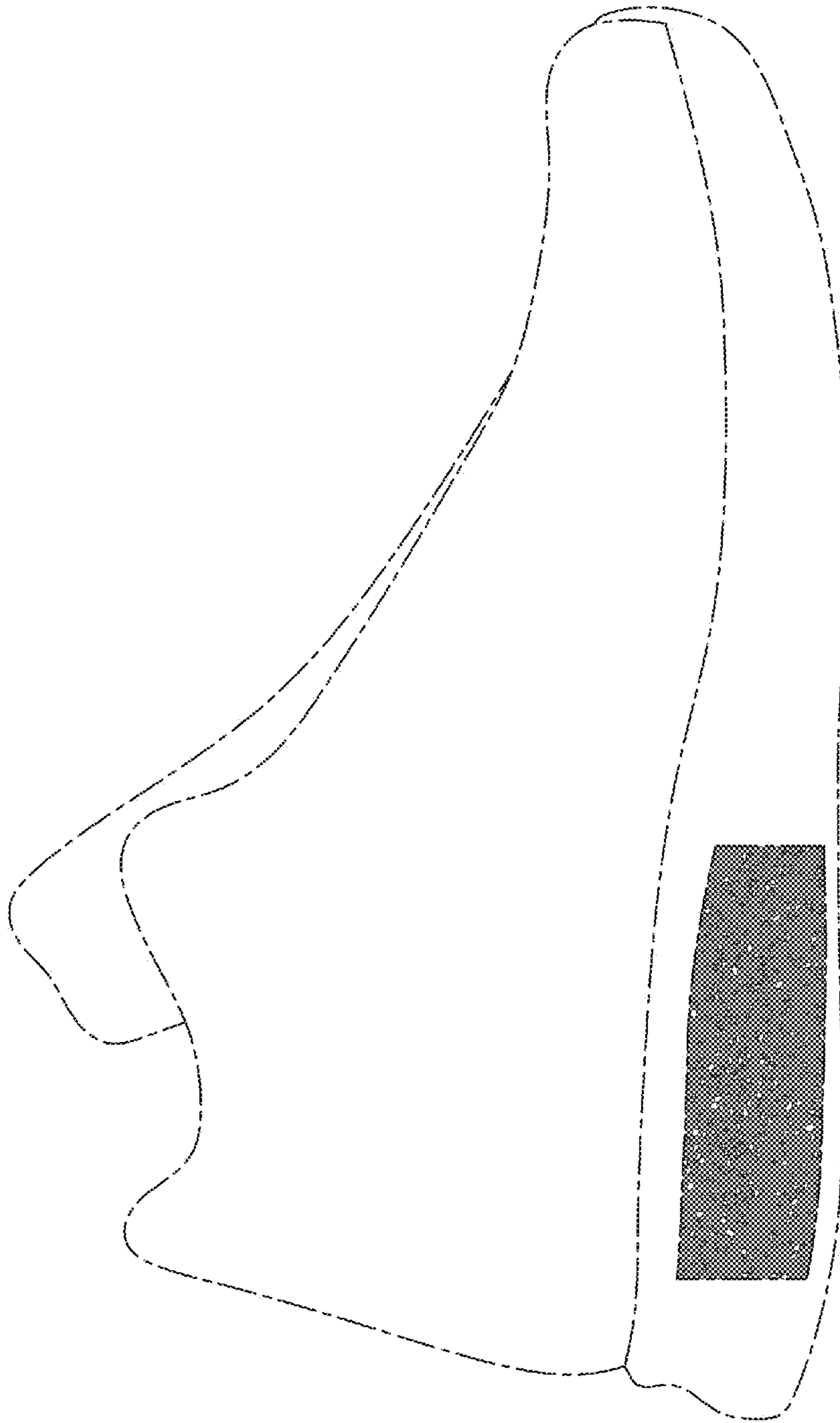

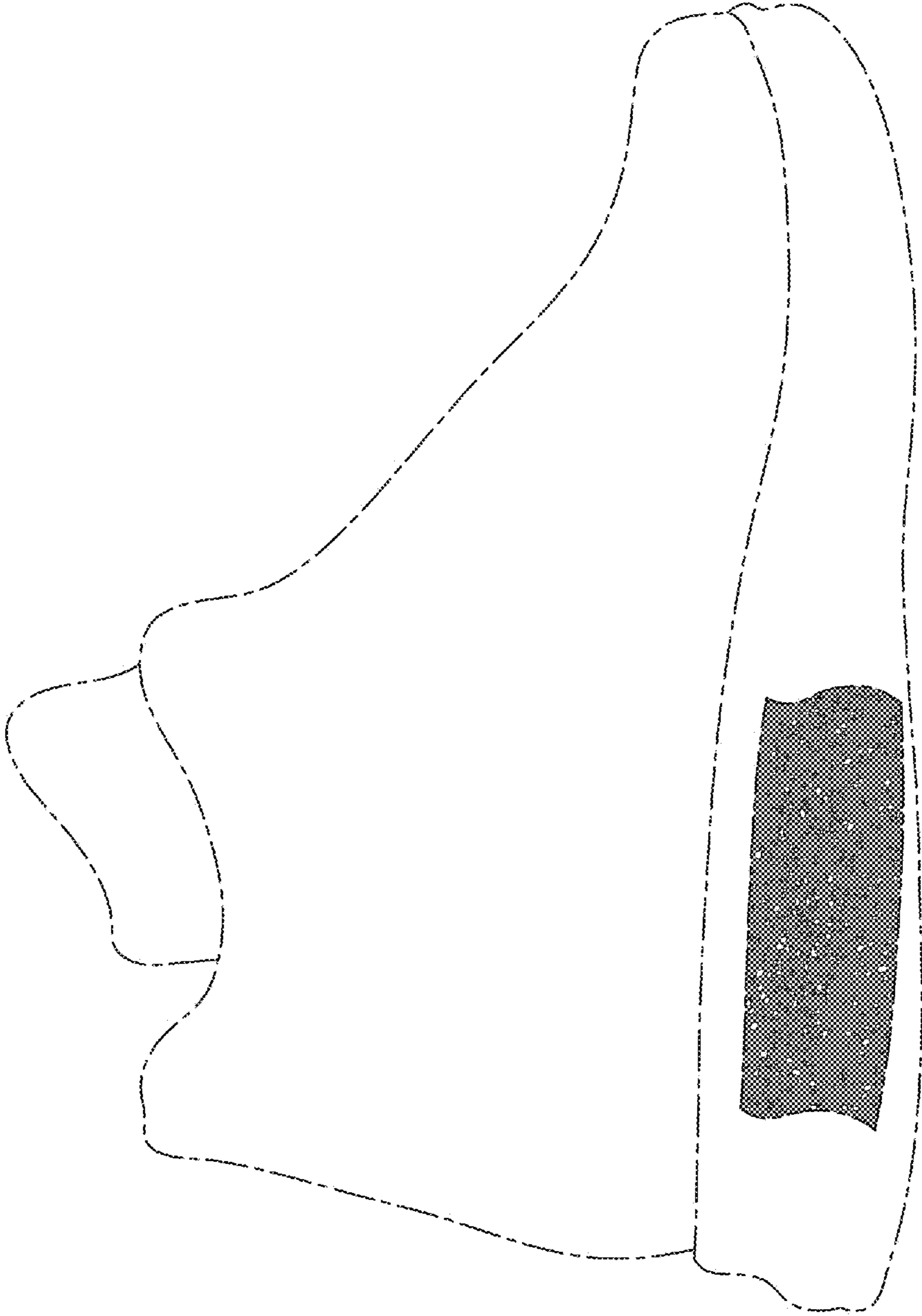
