FIG. 1 is a perspective view of an embodiment of a sofa showing my new design;

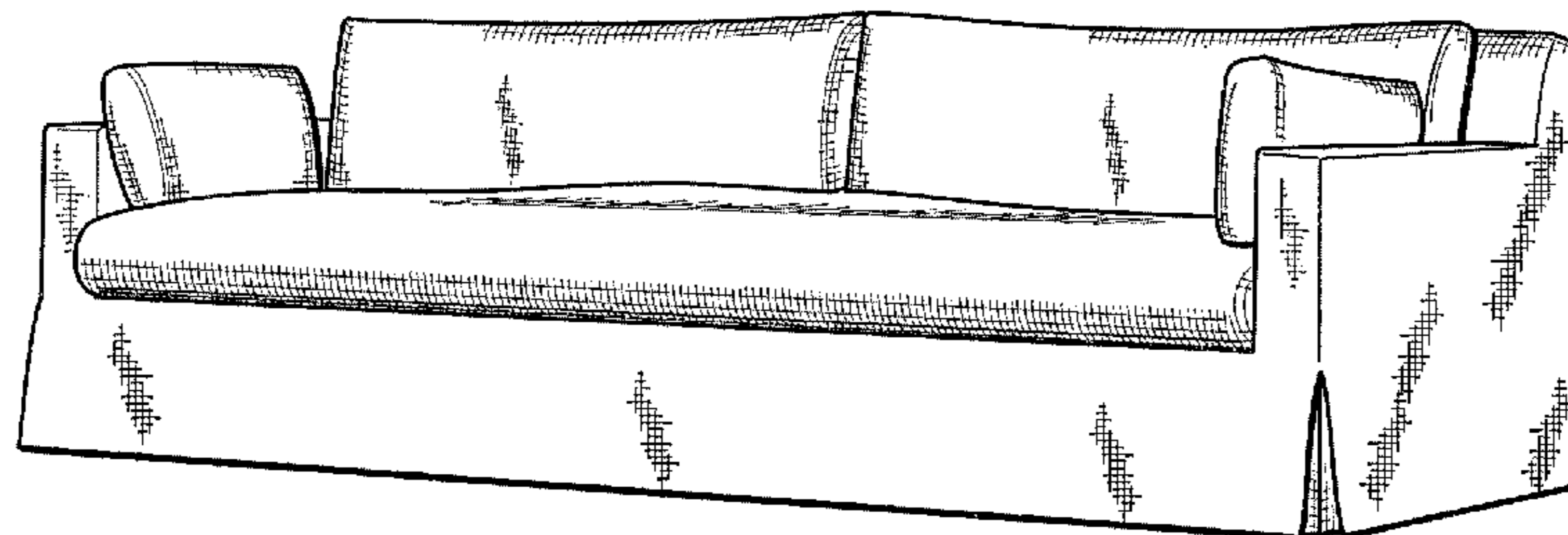
FIG. 2 is a top view thereof;

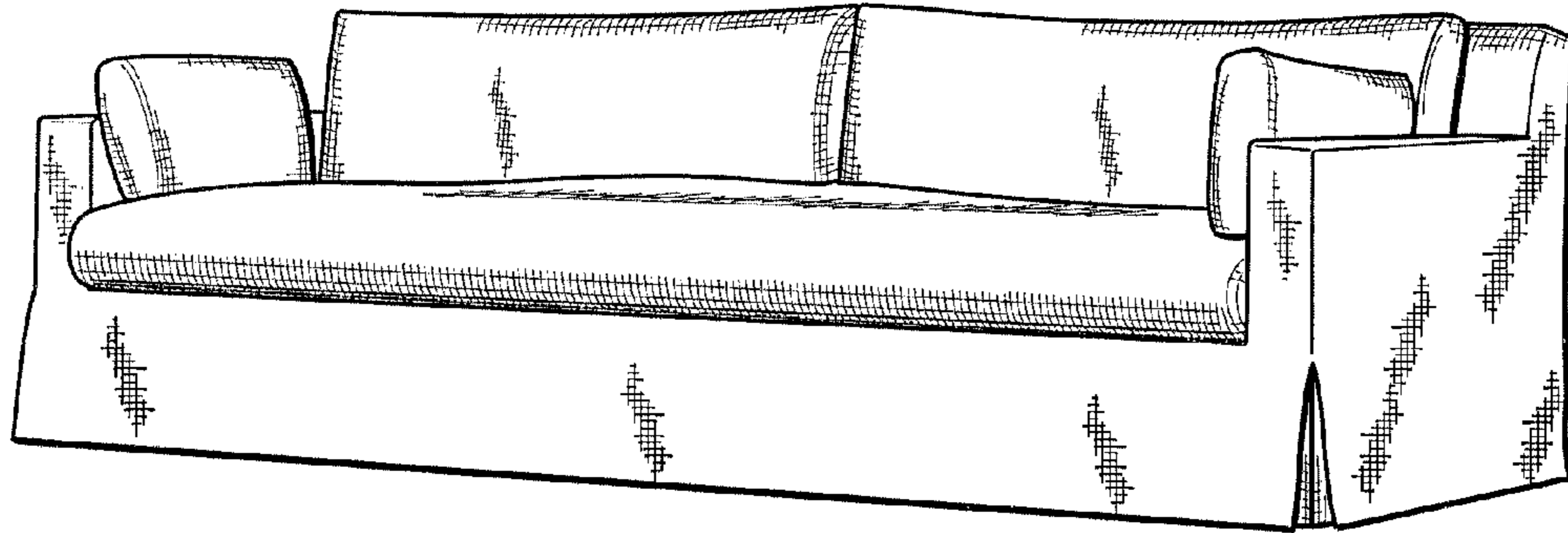

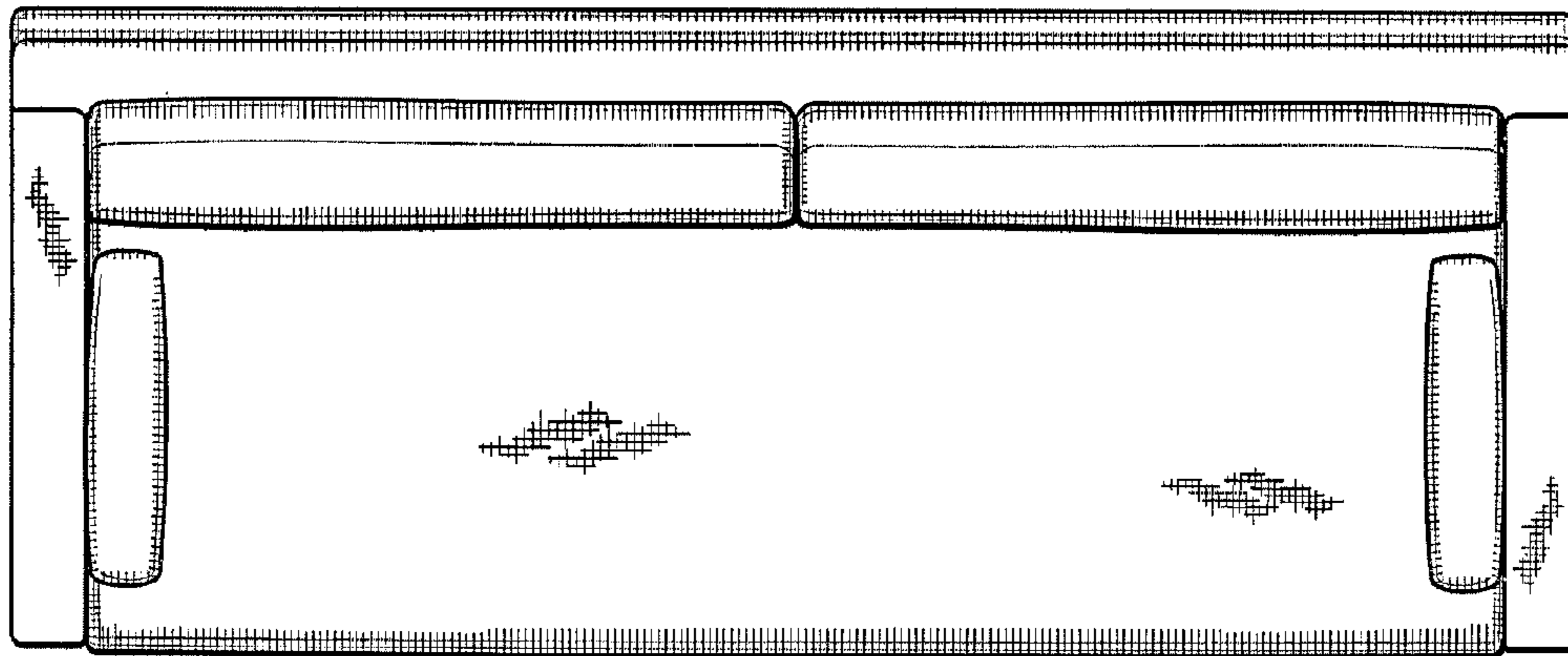

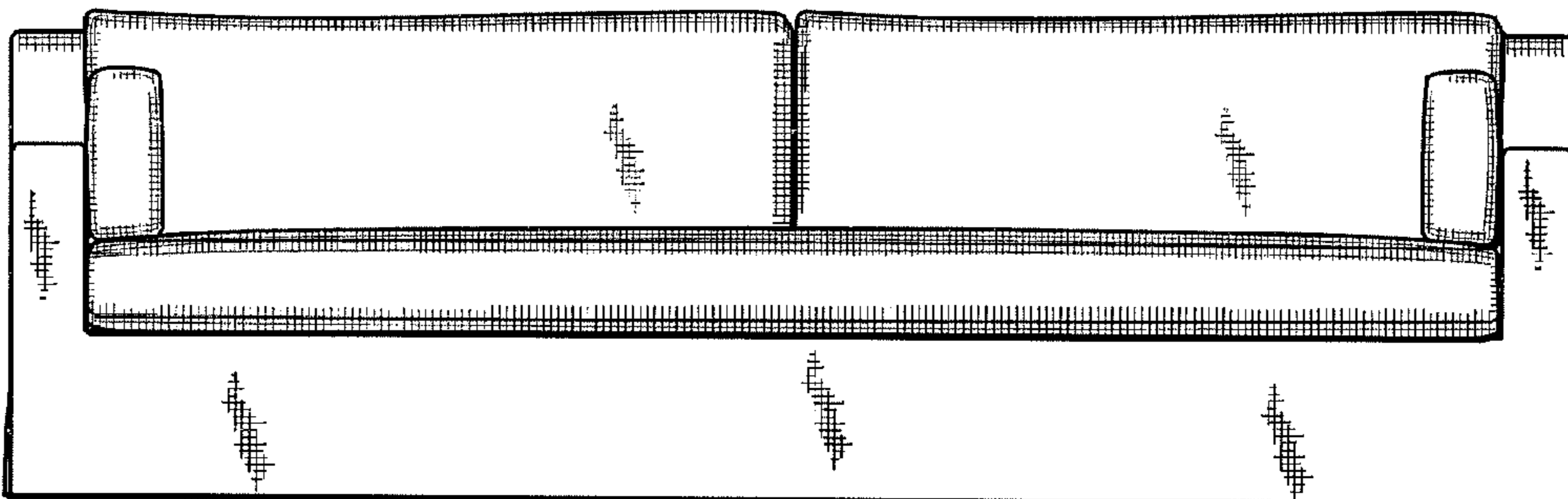
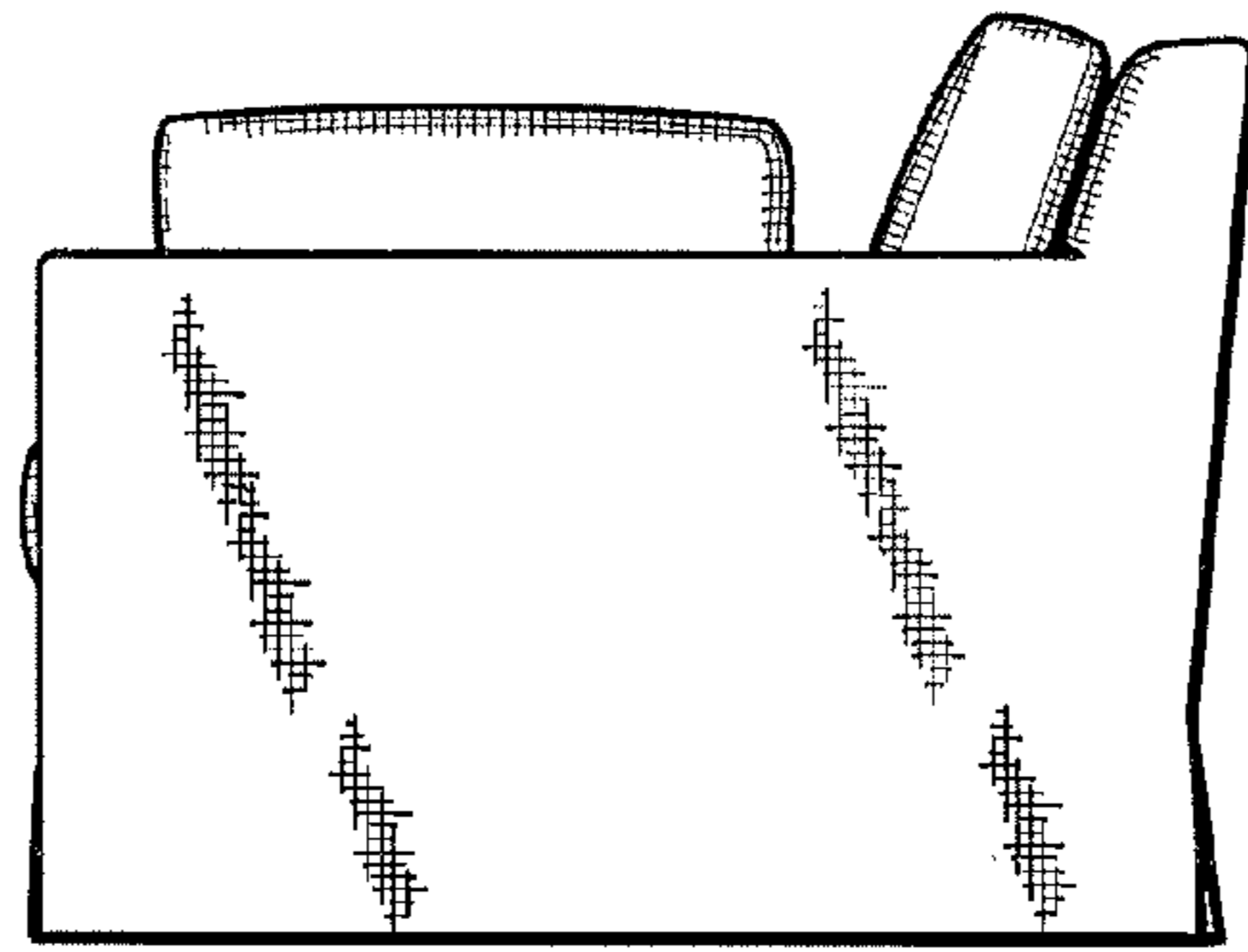
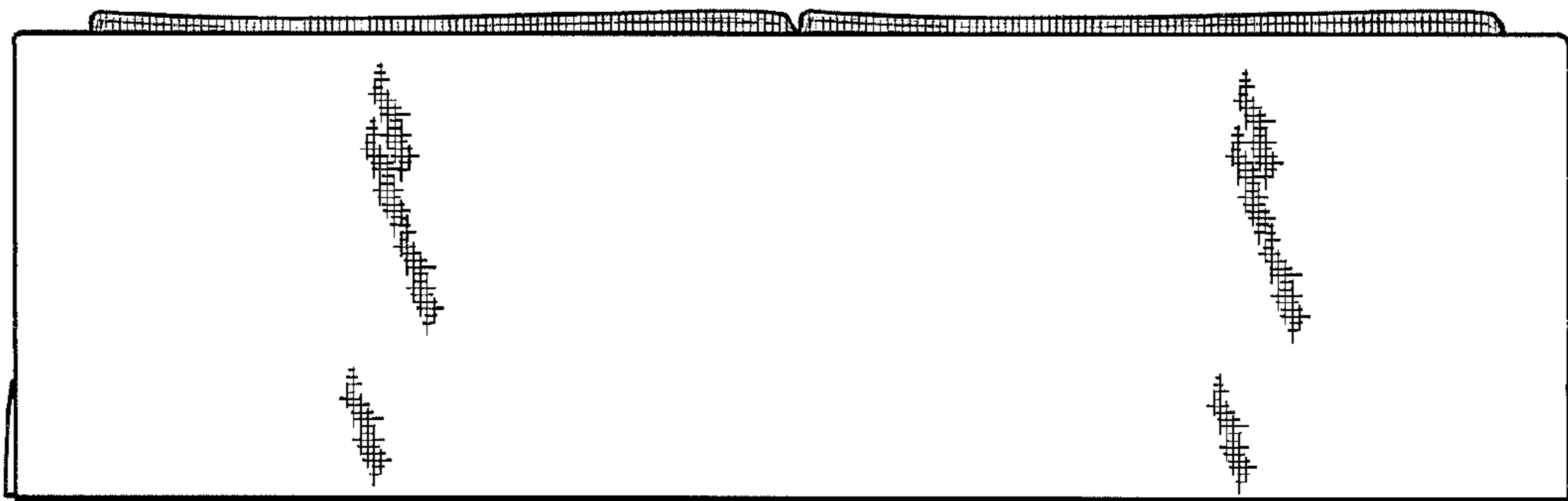
