(57) **CLAIM**

The ornamental design for a seat cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the seat cover showing the removable center panel attached to the seat cover. Stitching shown in dashed lines in FIG. 1 forms no part of the claimed design;

FIG. 2 is another perspective view of the seat cover of FIG. 1 showing the removable center panel partially removed from the seat cover. Stitching shown in dashed lines in FIG. 2 forms no part of the claimed design;

FIG. 3 is a right side view of the seat cover of FIG. 1. Stitching shown in dashed lines in FIG. 3 forms no part of the claimed design;

FIG. 4 is a left side view of the seat cover of FIG. 1. Stitching shown in dashed lines in FIG. 4 forms no part of the claimed design;

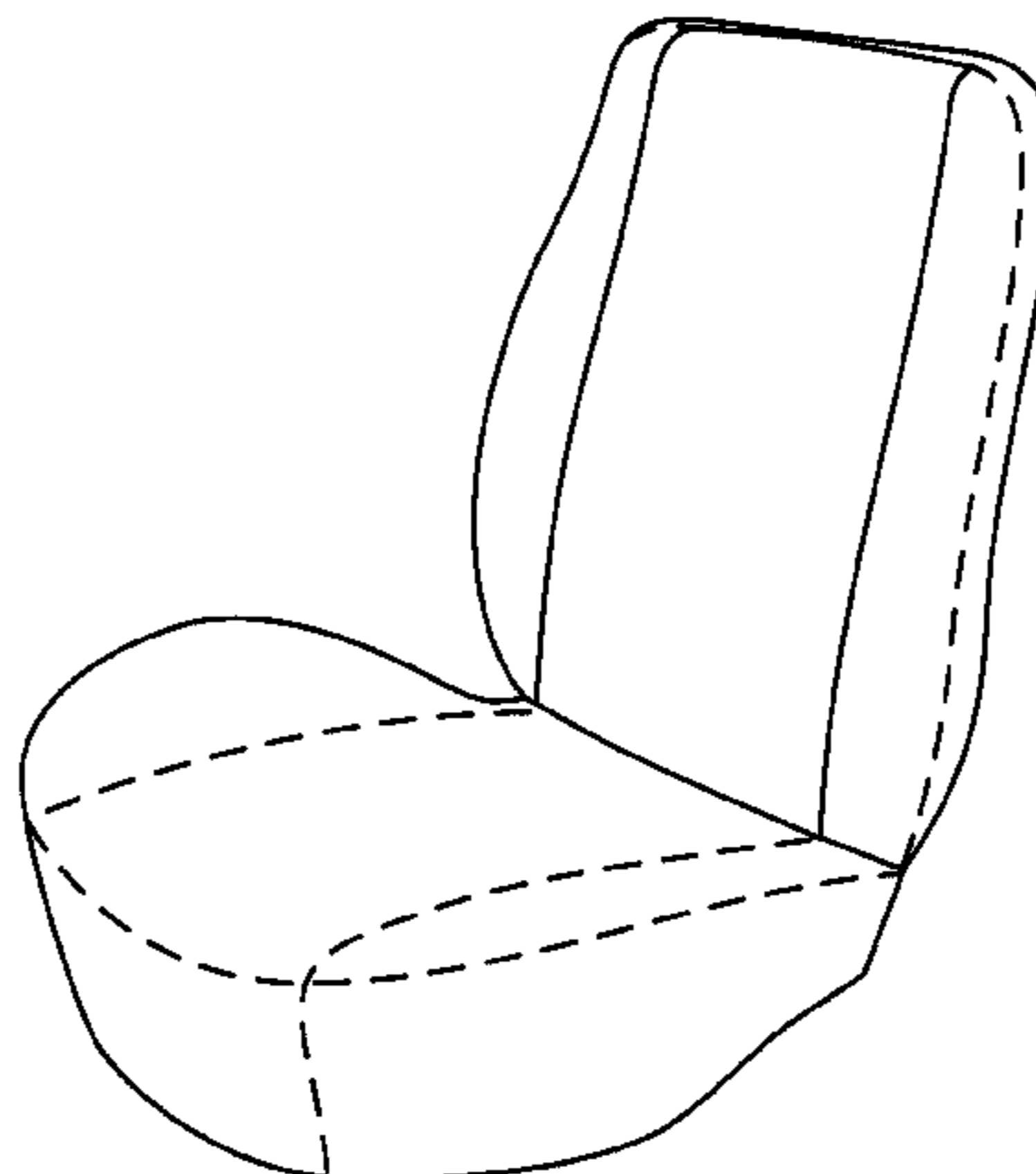
FIG. 5 is a top view of the seat cover of FIG. 1. Stitching shown in dashed lines in FIG. 5 forms no part of the claimed design;

FIG. 6 is a bottom view of the seat cover of FIG. 1. The perimeter of the underside of the seat cover shown in dashed lines in FIG. 6 forms no part of the claimed design;

FIG. 7 is a front view of the seat cover of FIG. 1. Stitching shown in dashed lines in FIG. 7 forms no part of the claimed design; and,

FIG. 8 is a back view of the seat cover of FIG. 1.

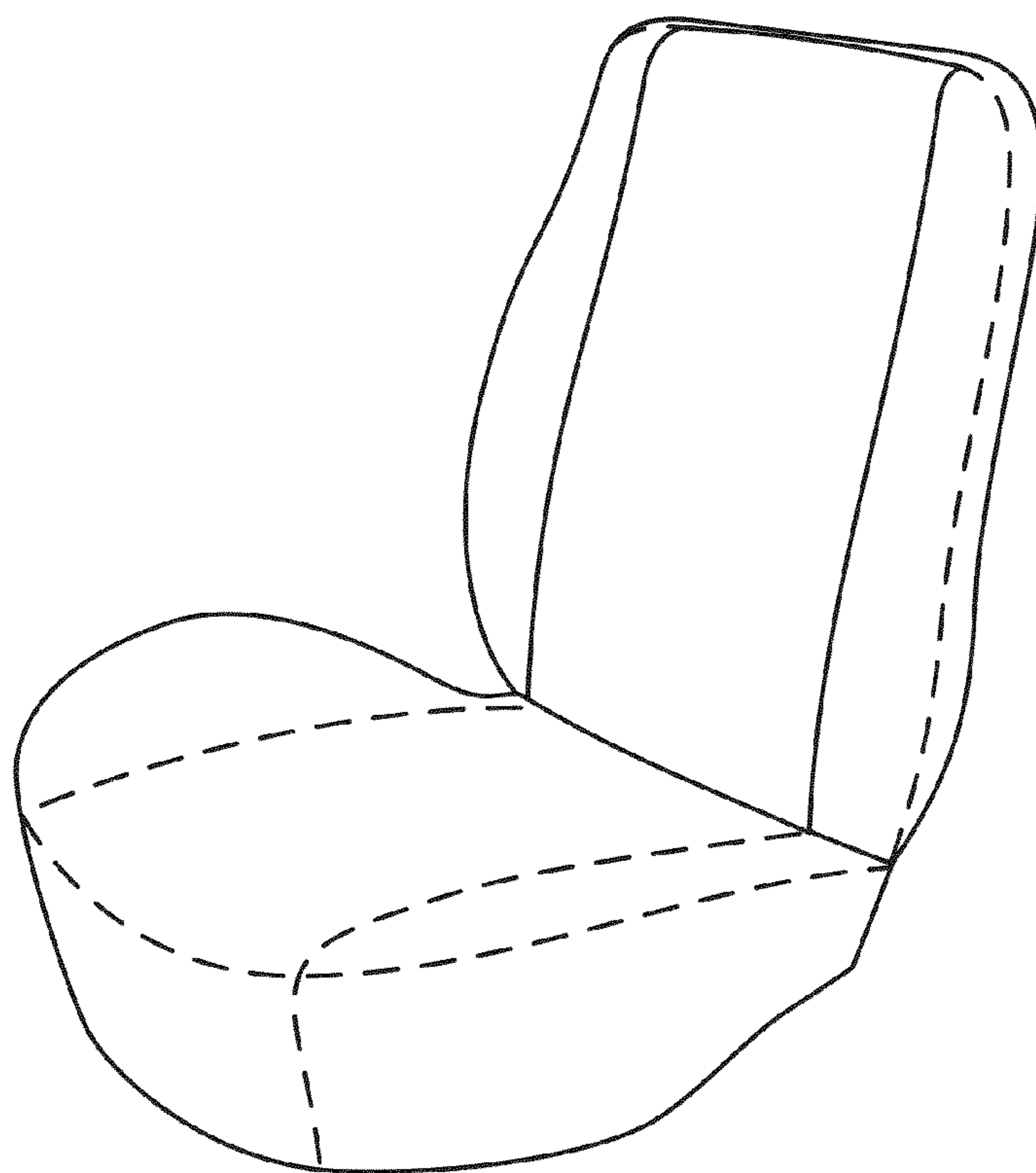

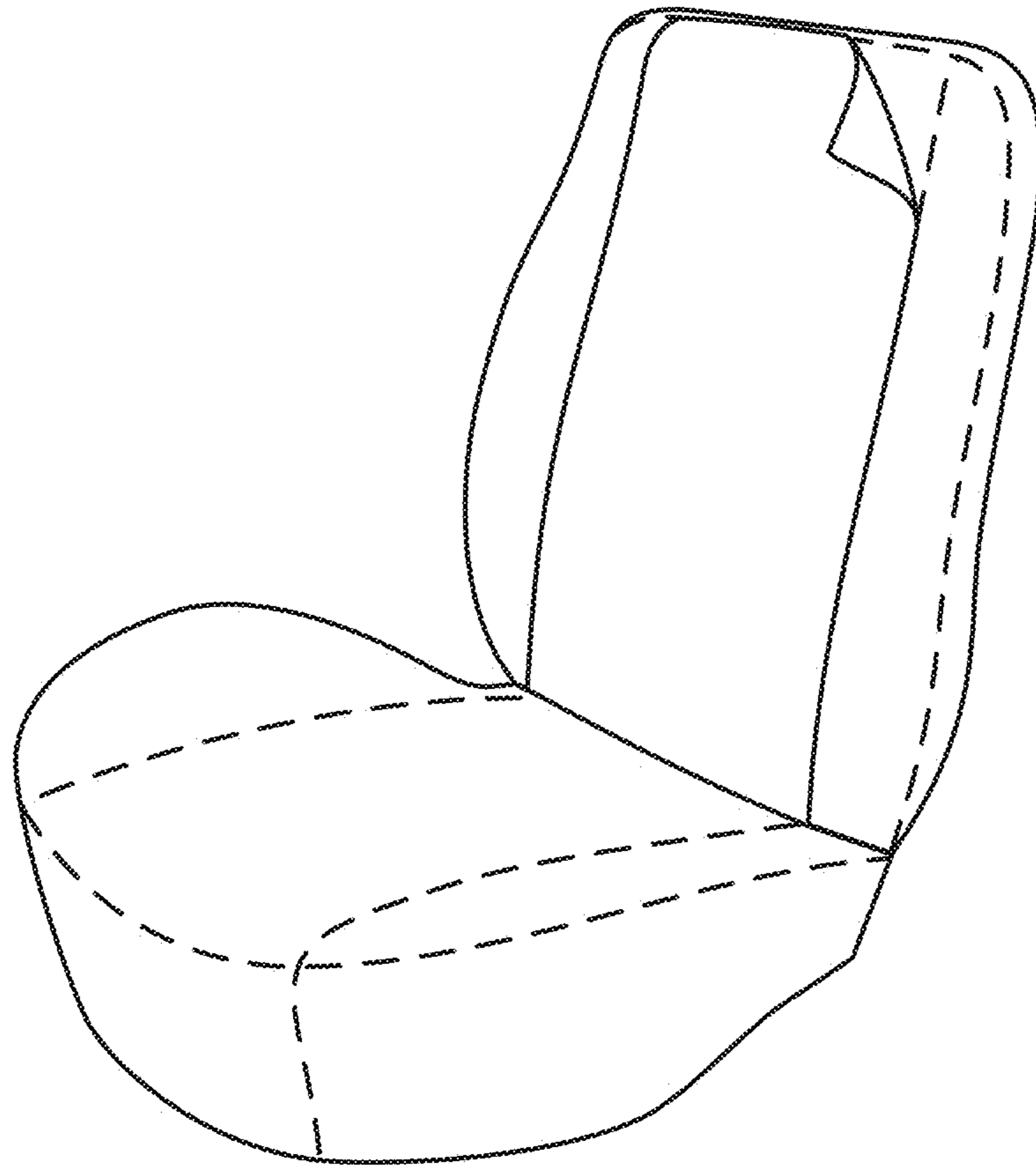

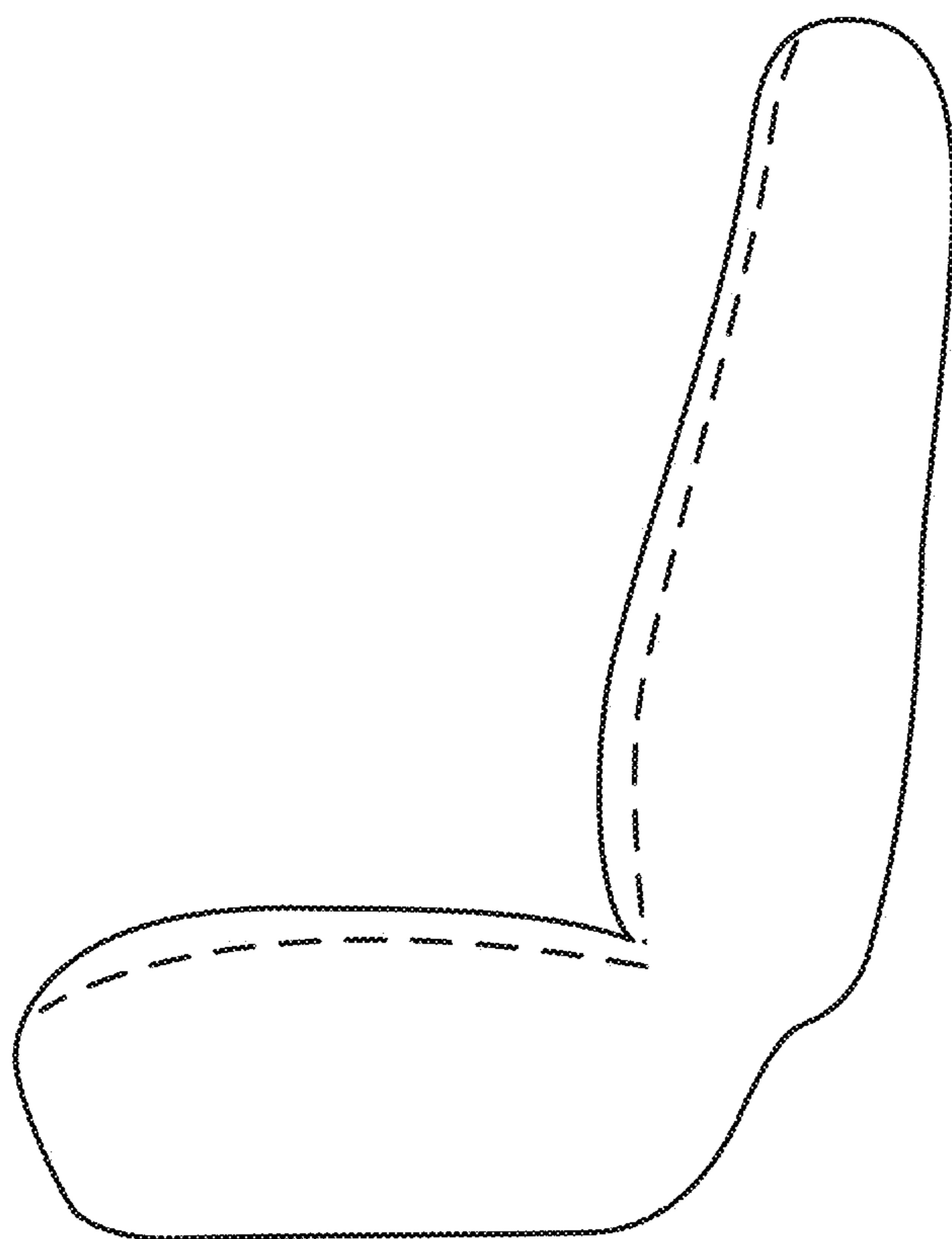

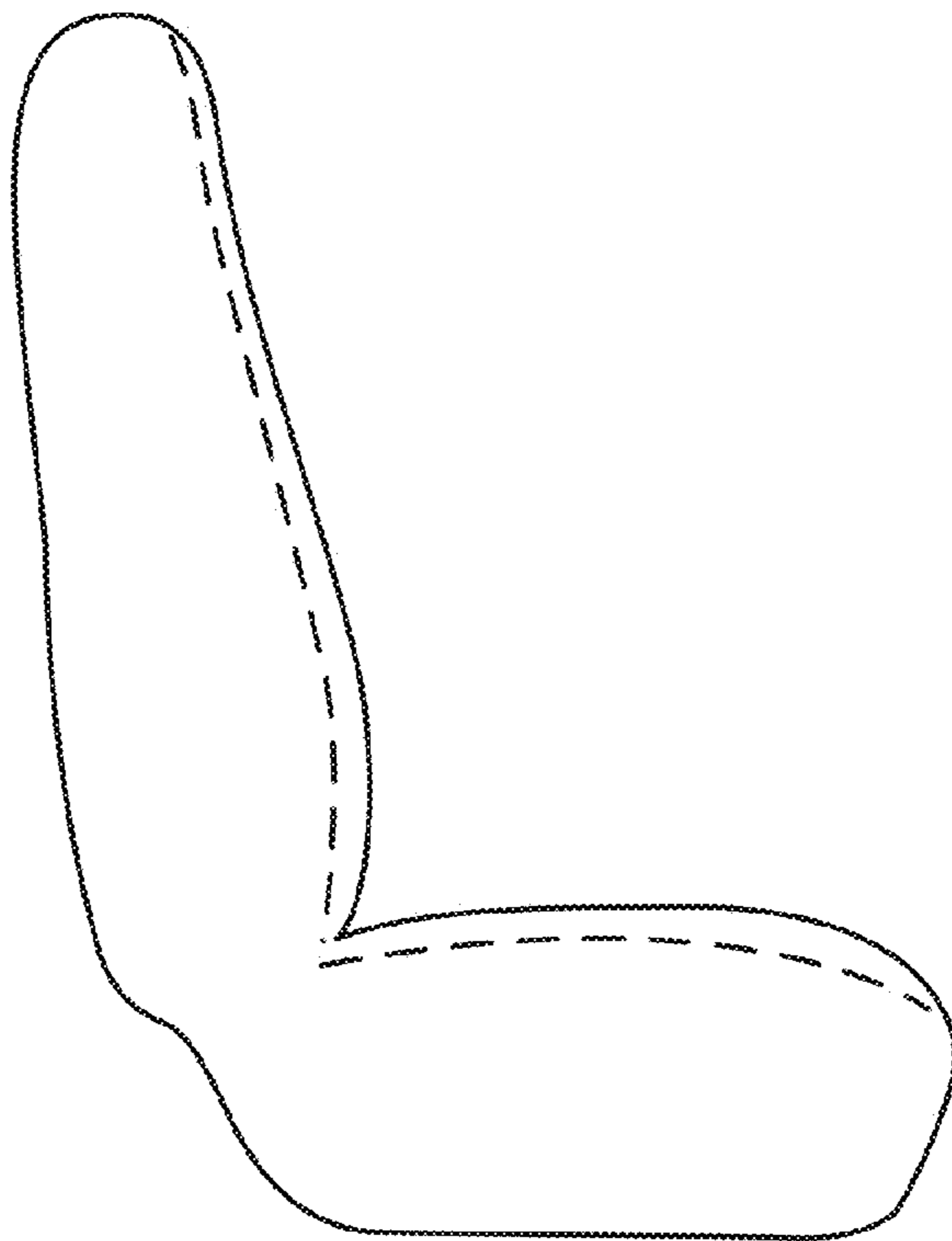

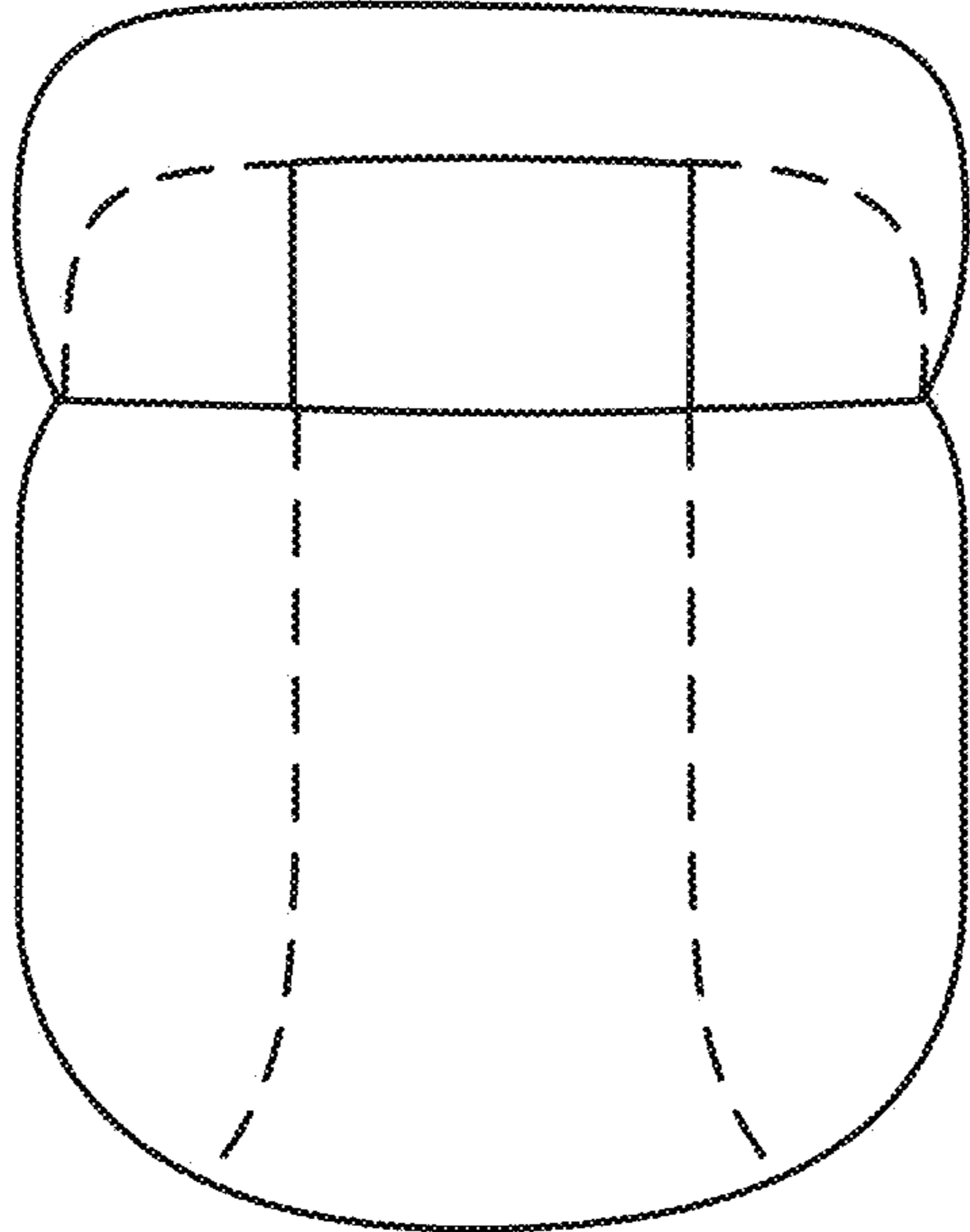

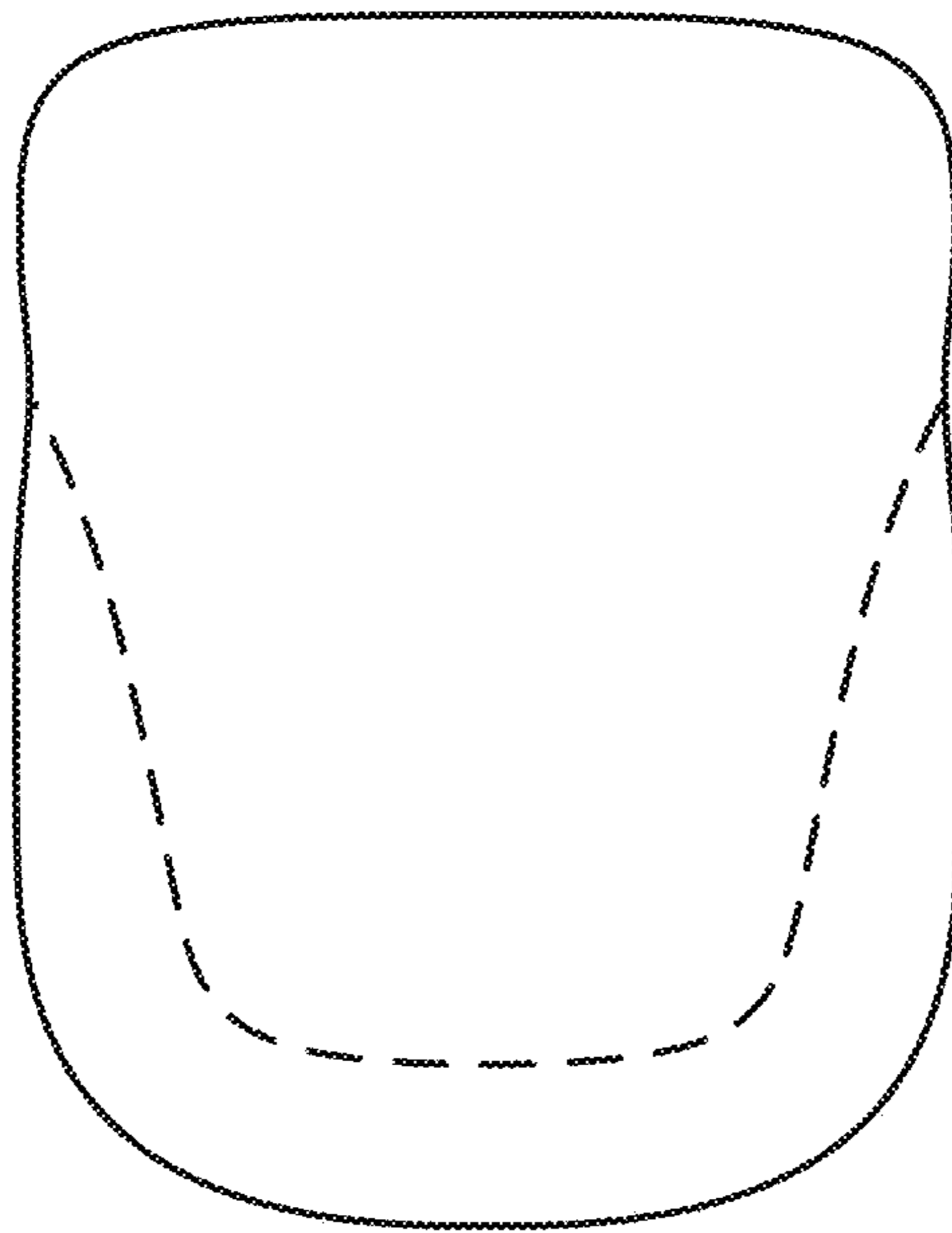

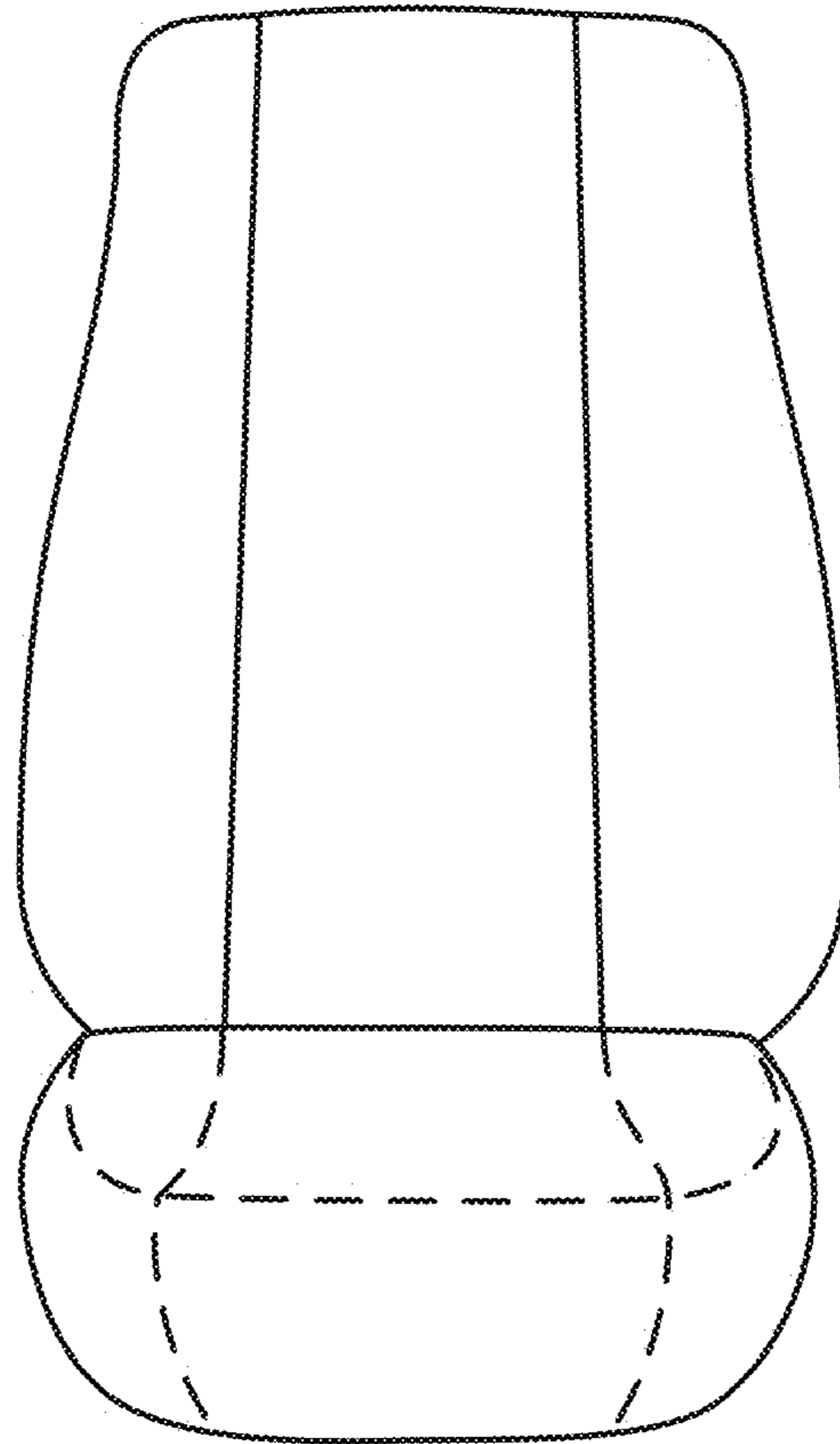

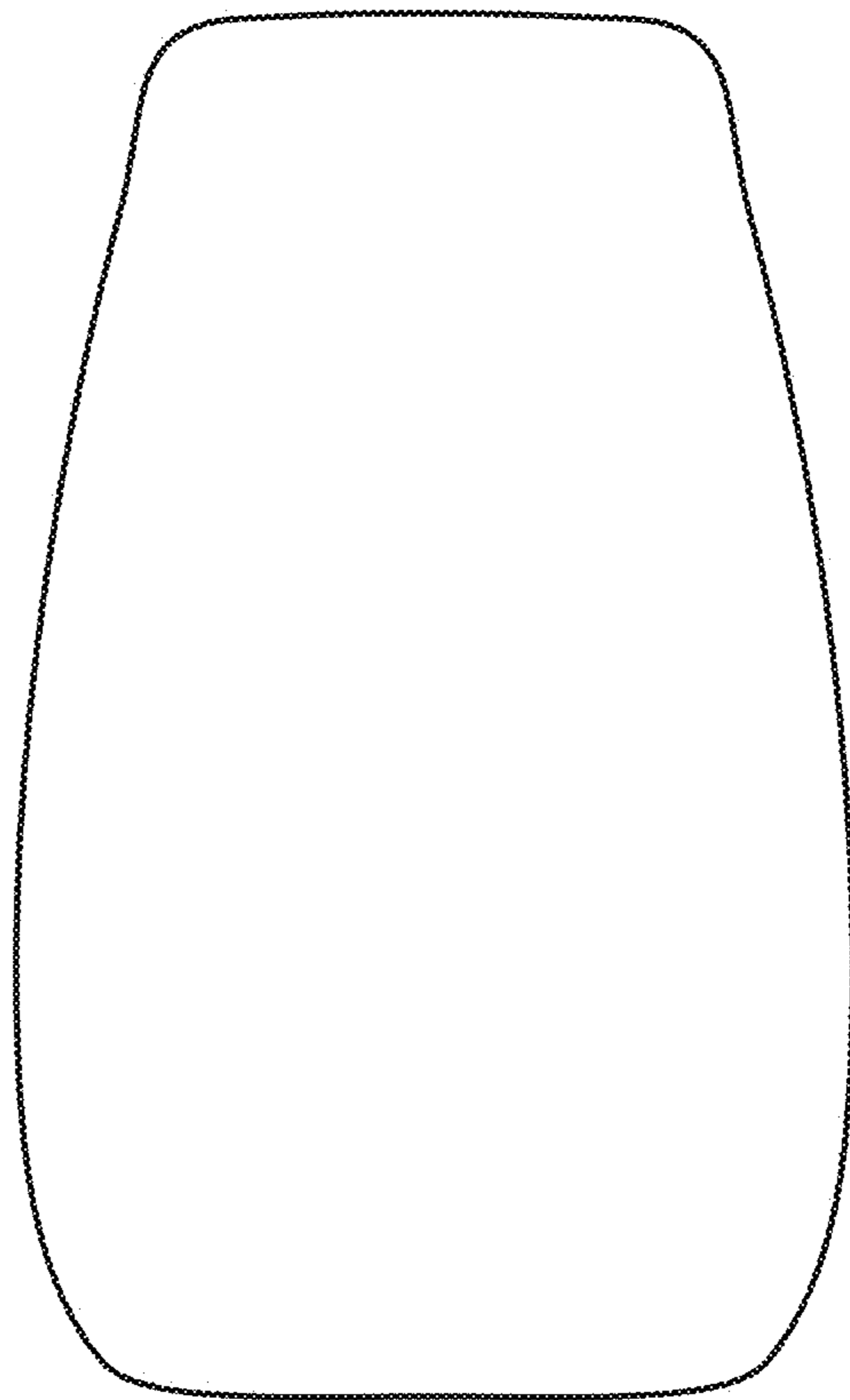
