design; and,

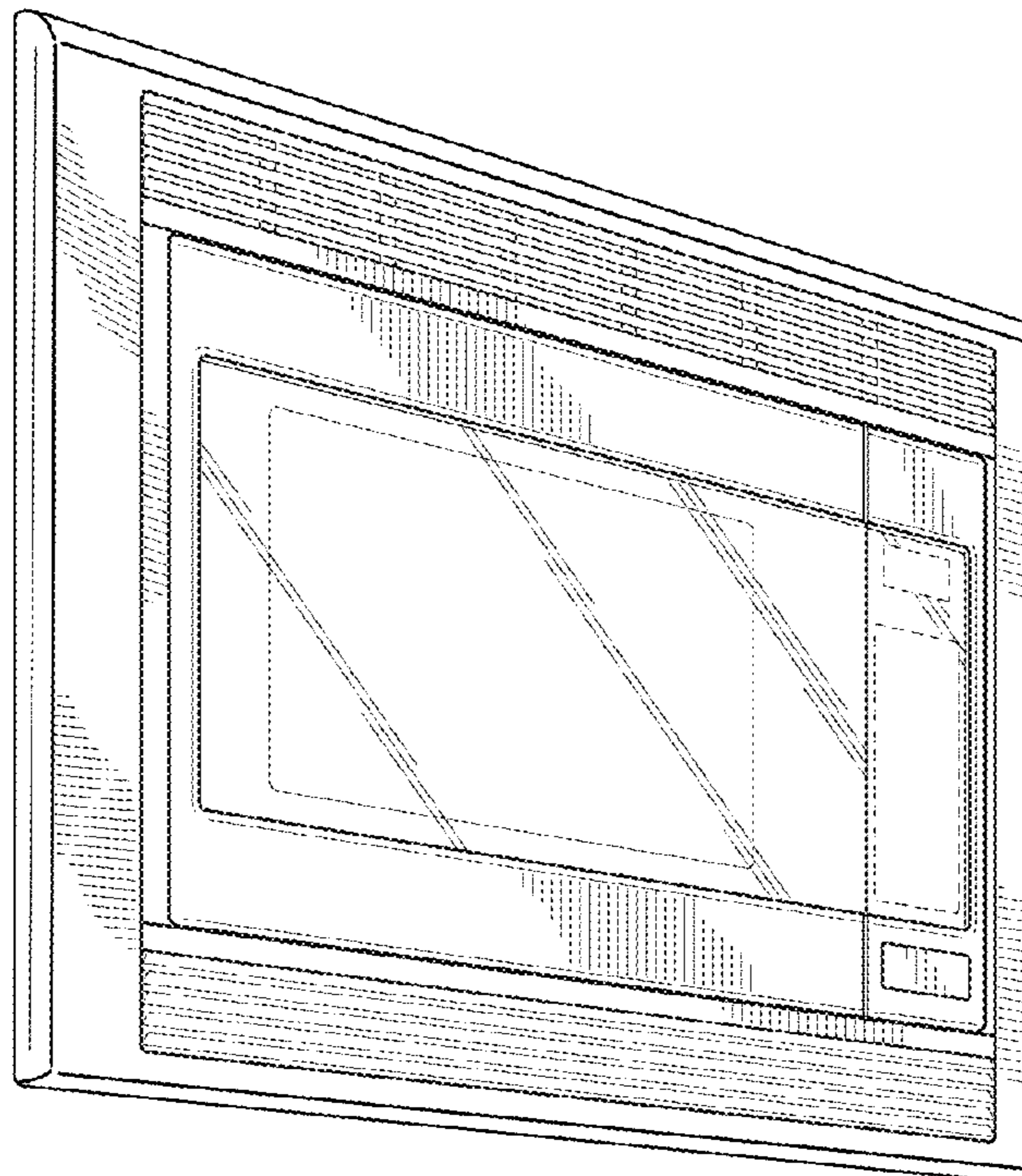
FIG. 2 is a perspective view thereof.

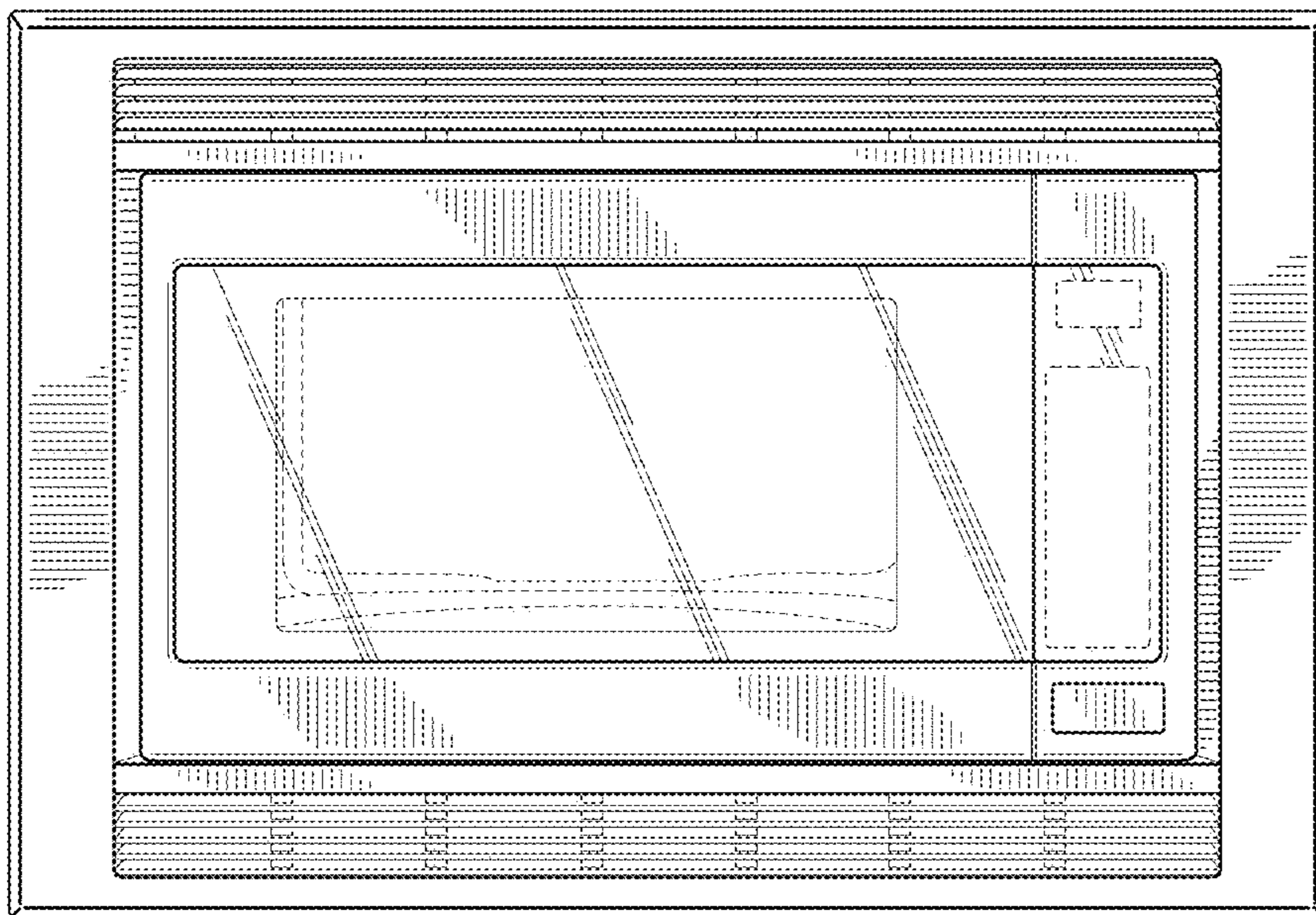

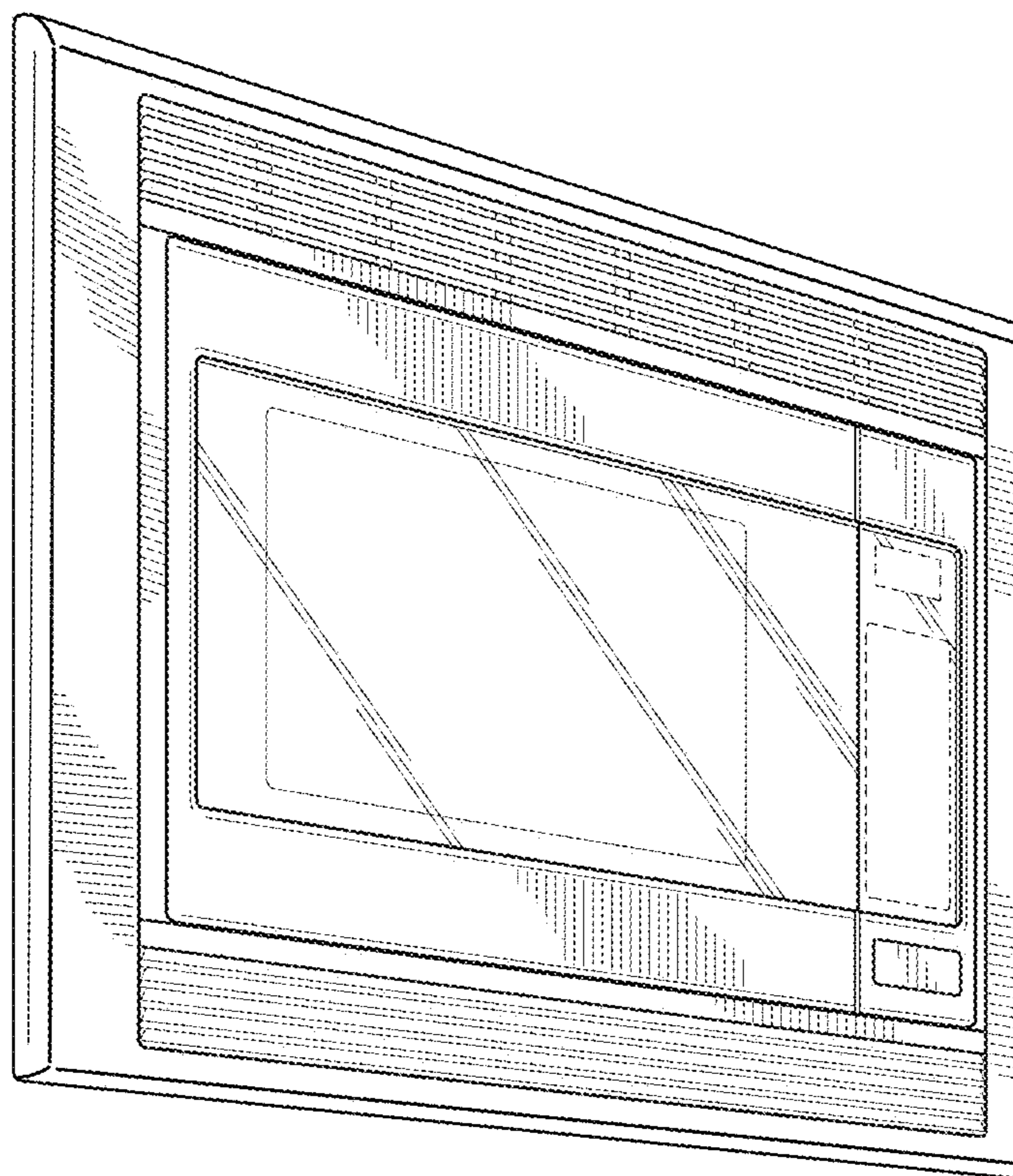
