DESCRIPTION

FIG. 1 is a front elevational view from front of the packaging with the opposite side being a mirror image thereof in accordance with our new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a perspective bottom view;

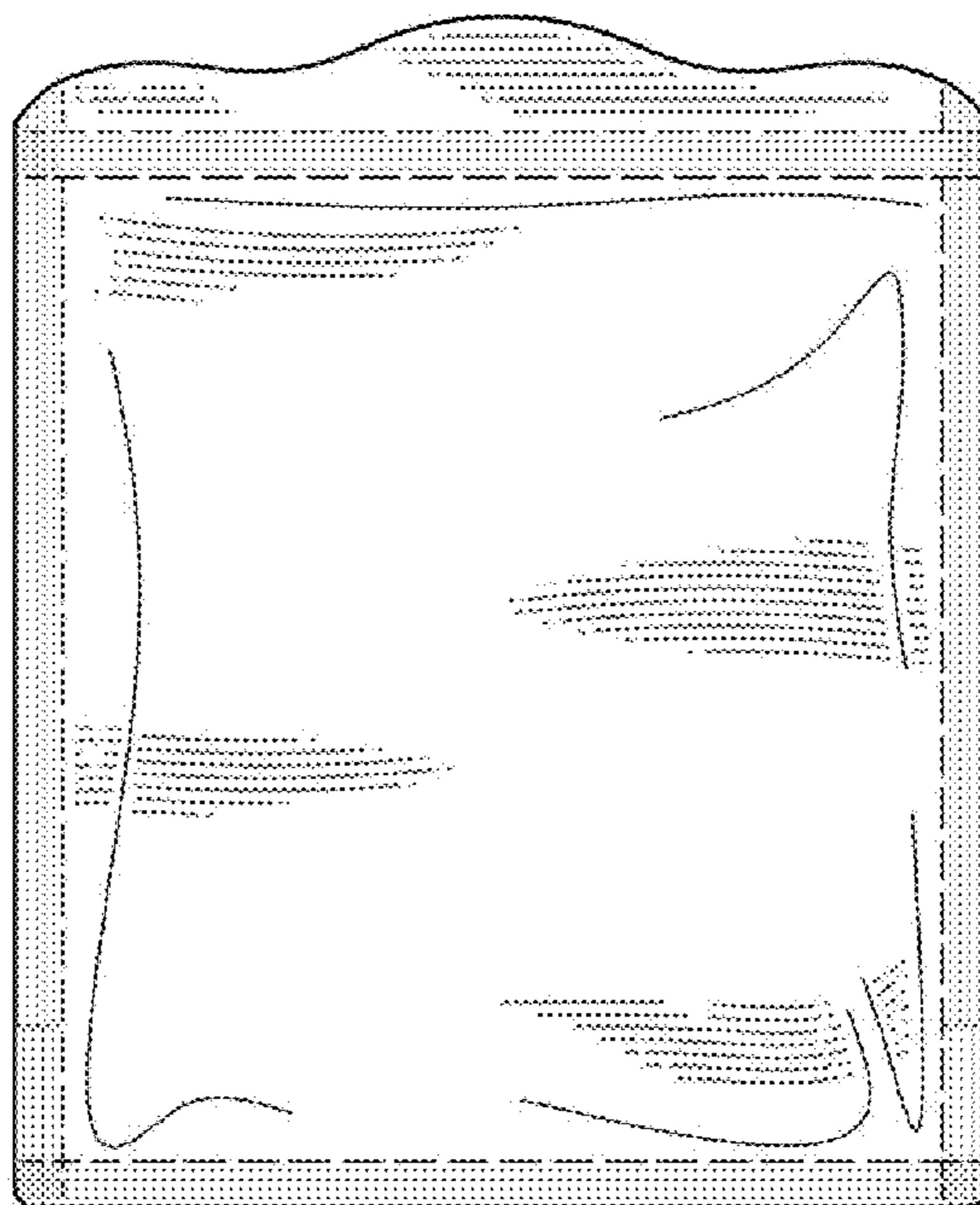
FIG. 4 is a perspective view from the top corner of one side thereof;

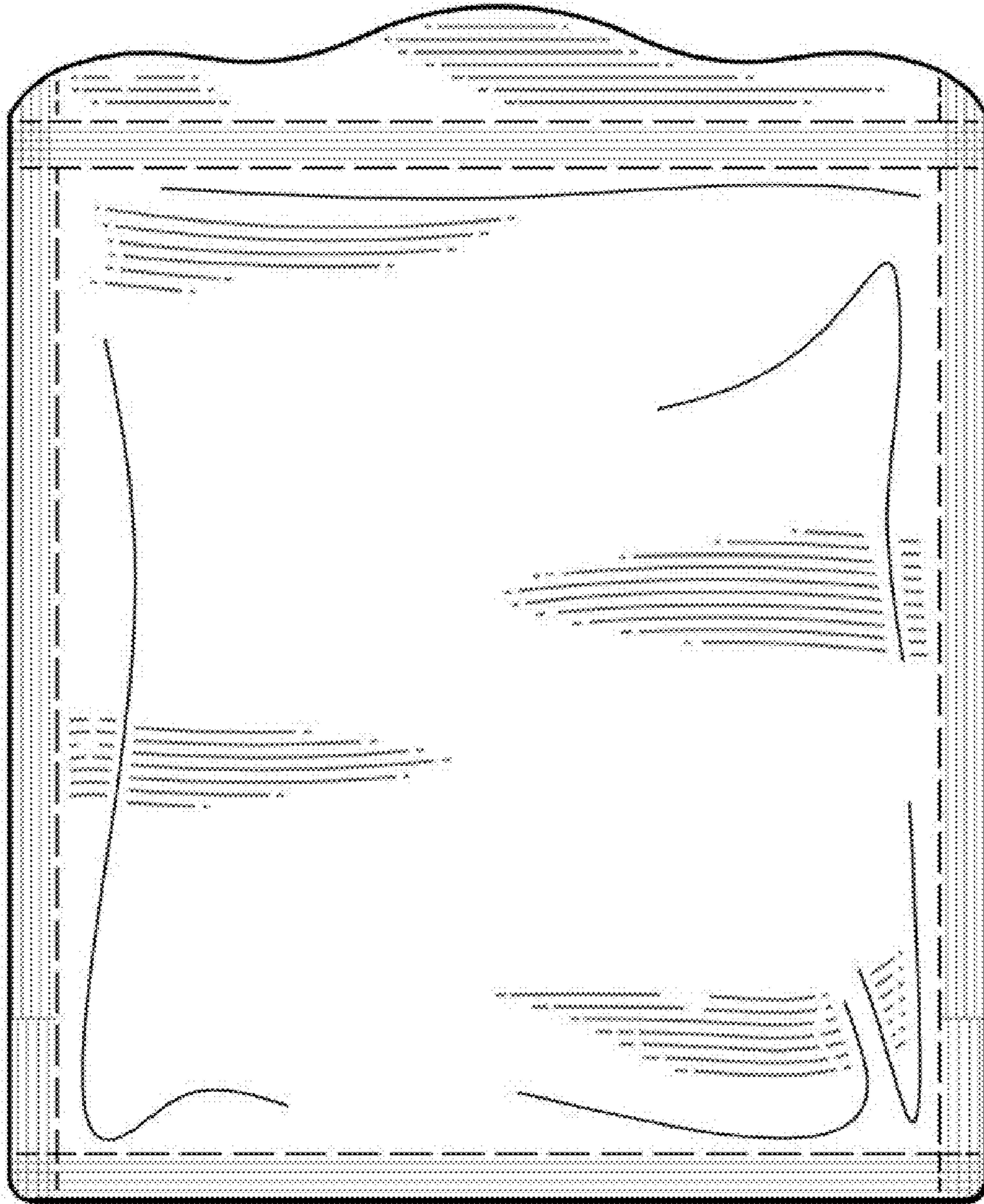

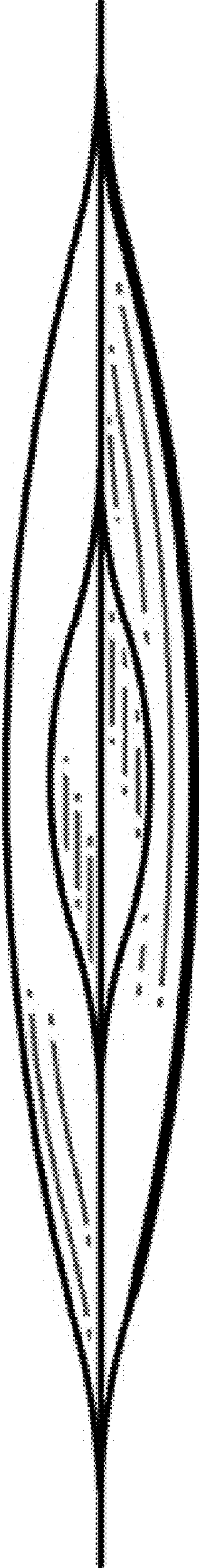

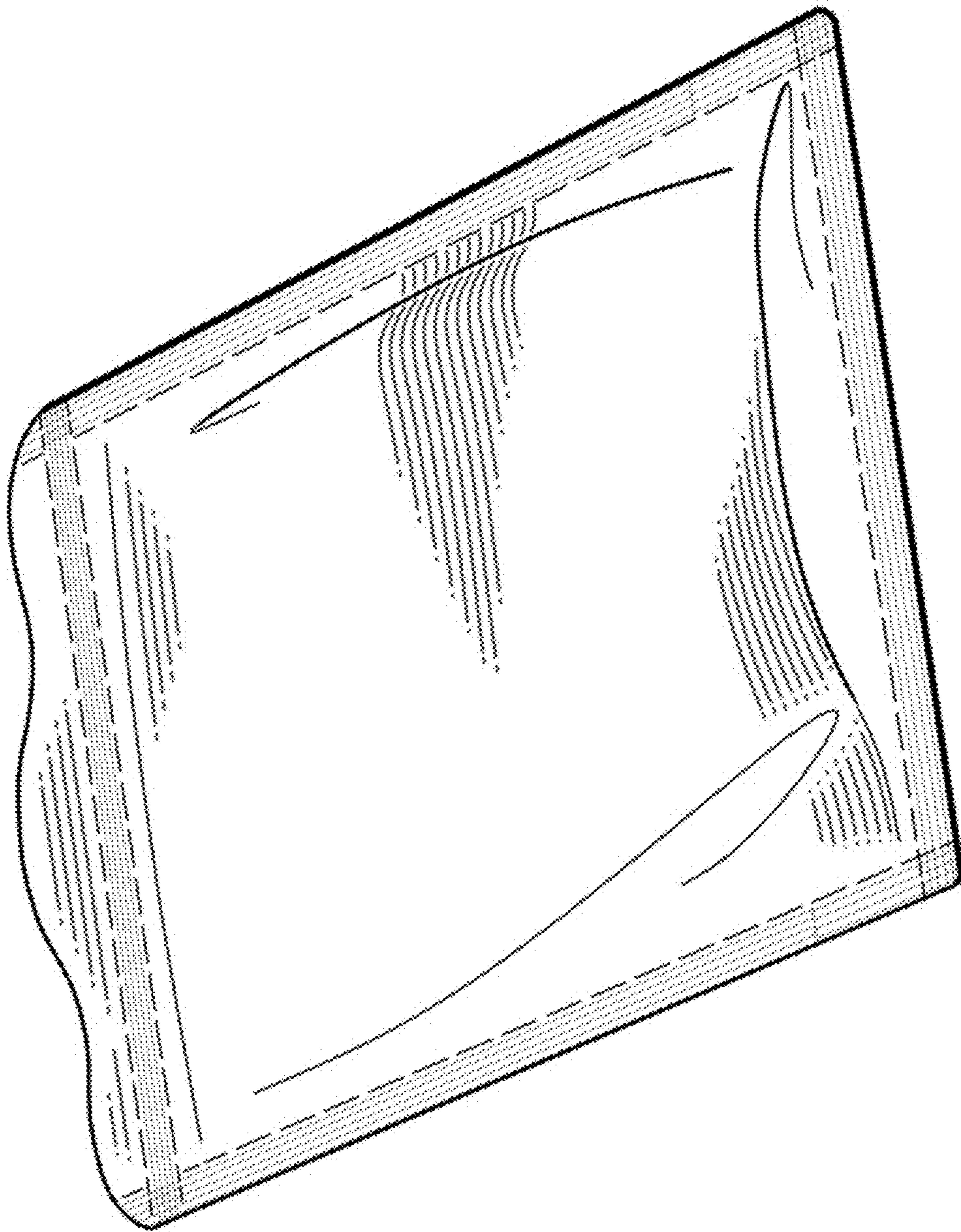

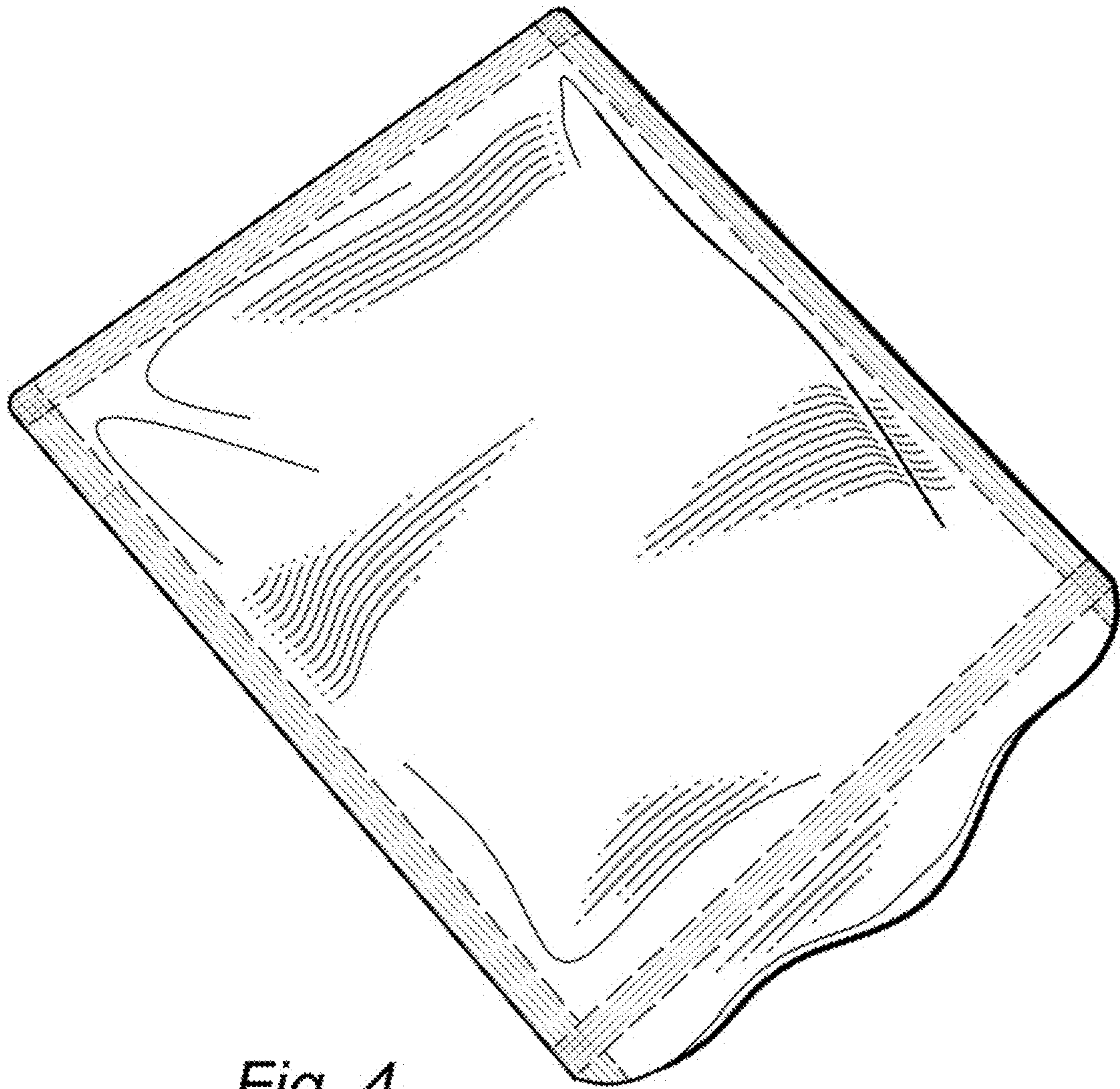

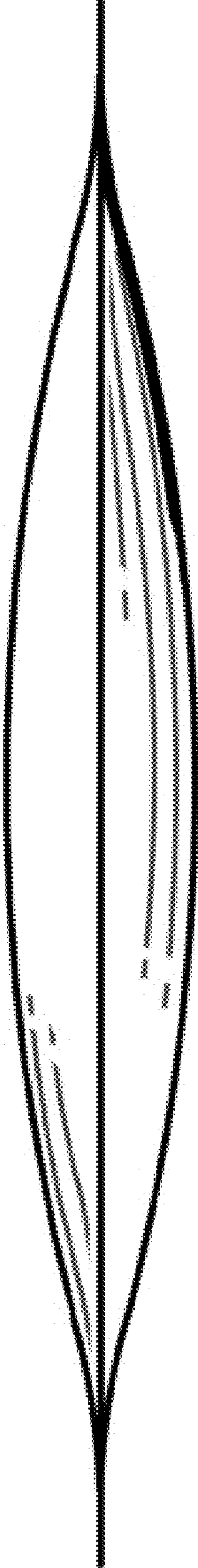

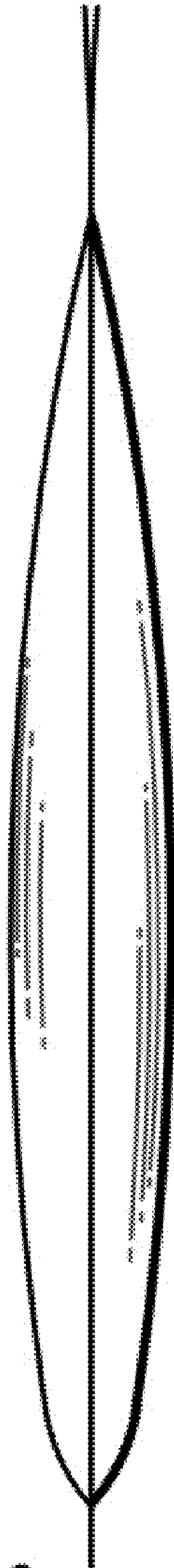
