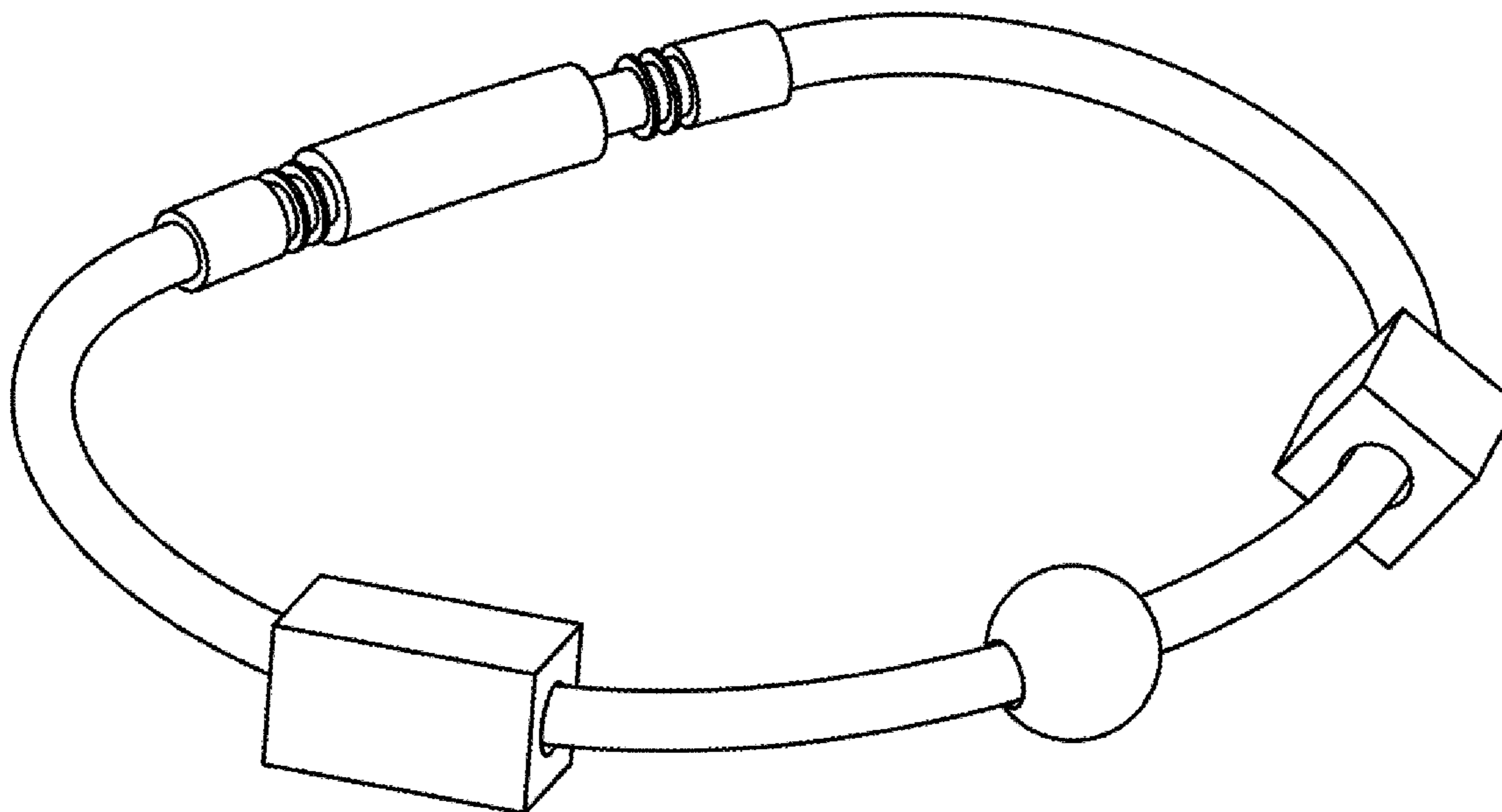
(57) **CLAIM**

The ornamental design for a bracelet with charms, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of the bracelet with charms in a closed position, showing the new design;
FIG. 2 is a frontal view of the bracelet with charms in an open position, showing the new design;
FIG. 3 is a perspective view of the bracelet of FIG. 2;
FIG. 4 is another perspective view of the bracelet of FIG. 2;
FIG. 5 is another side perspective view of the bracelet of FIG. 1;
FIG. 6 is a left side view of the bracelet of FIG. 2; and,
FIG. 7 is a right side view of the bracelet of FIG. 2.
The broken lines shown in FIGS. 3 and 6 illustrate portions of the bracelet with charms and form no part of the claimed design.

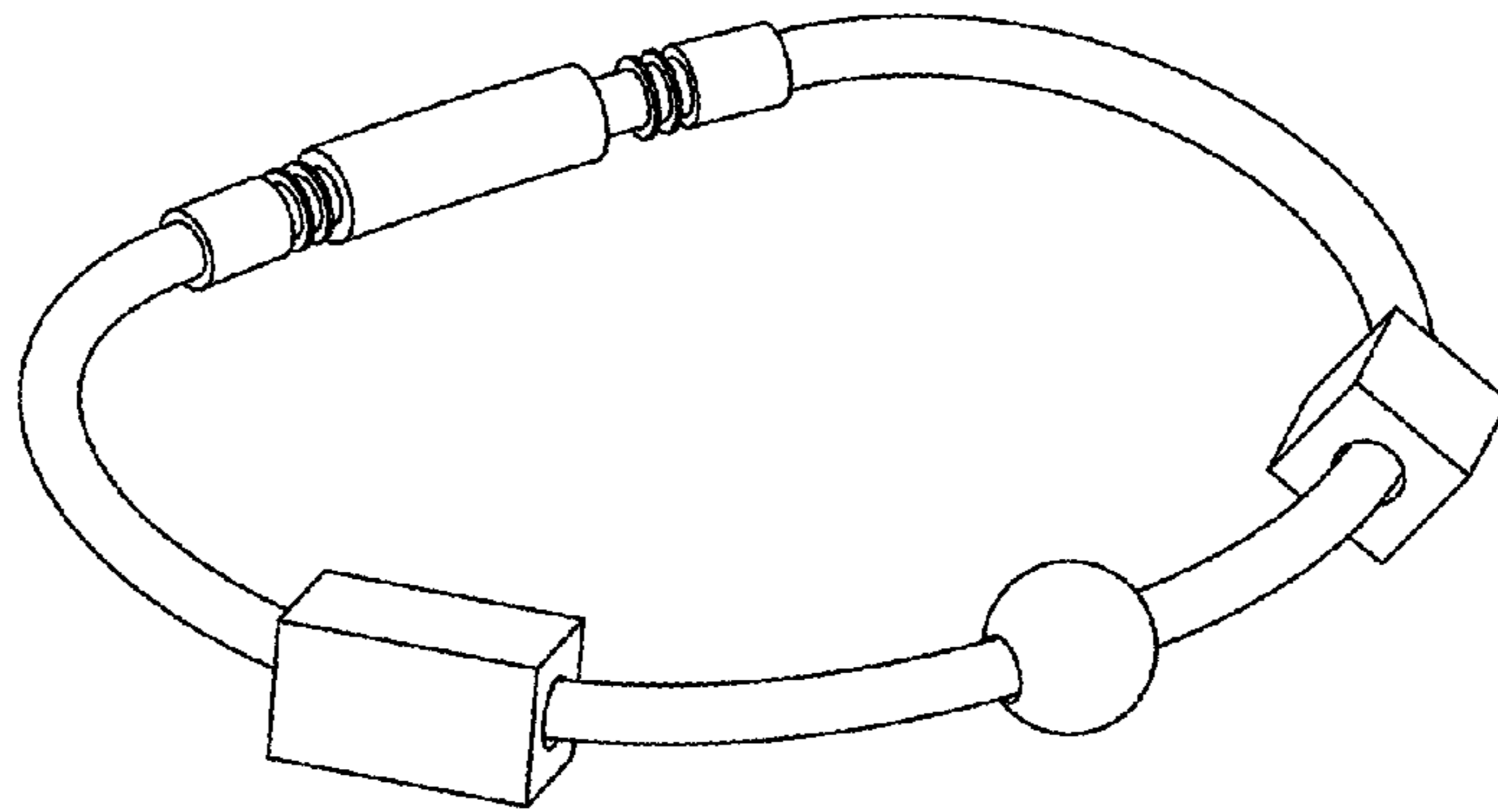

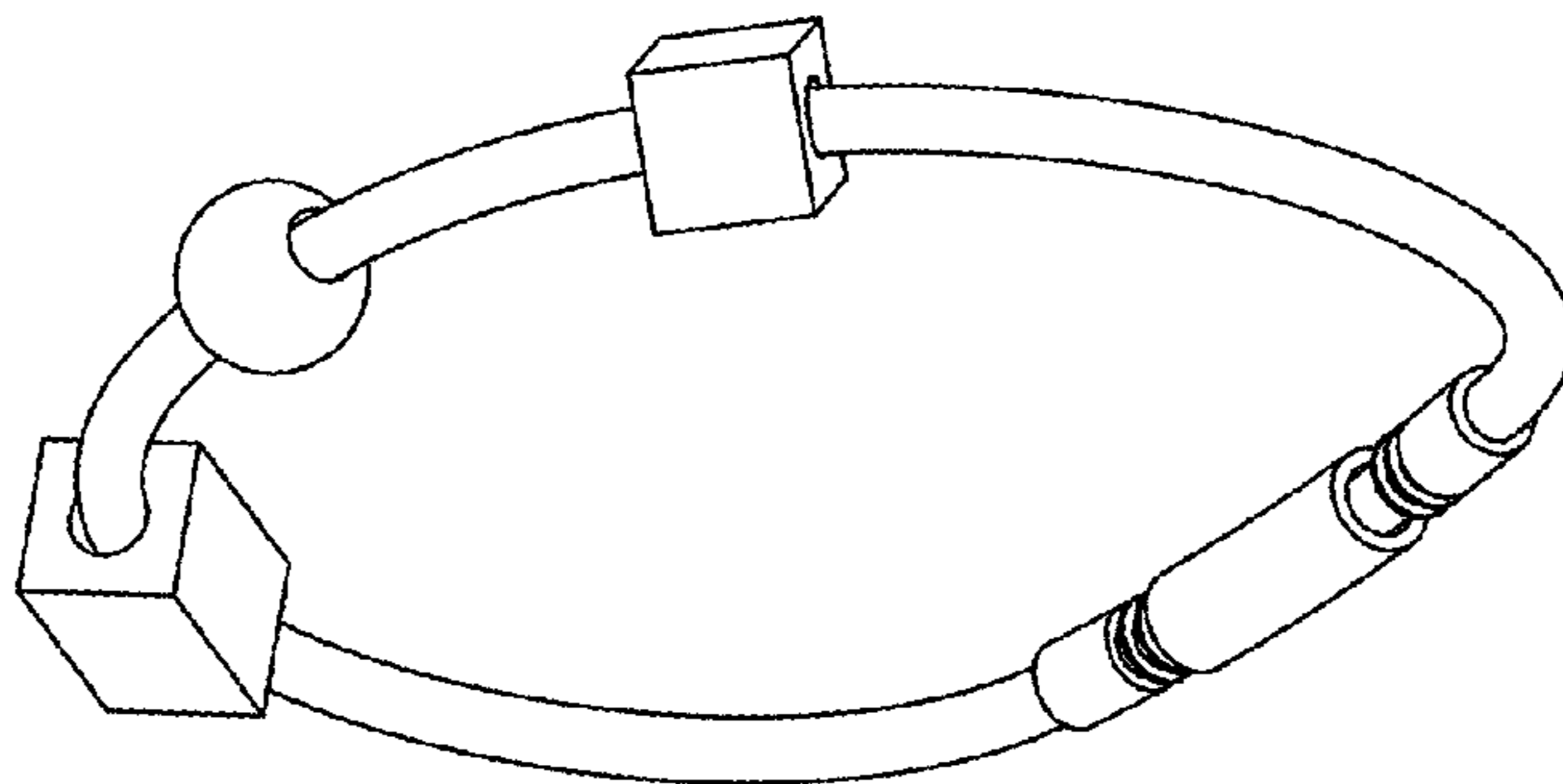

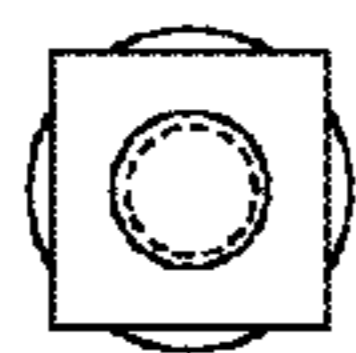

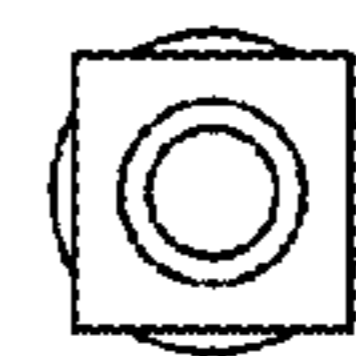

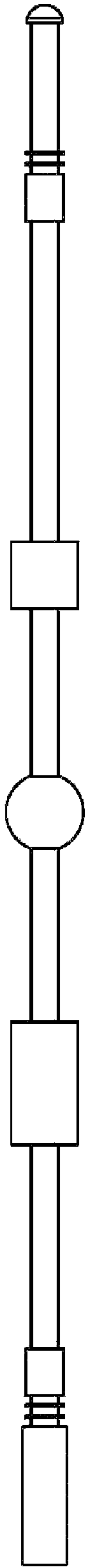

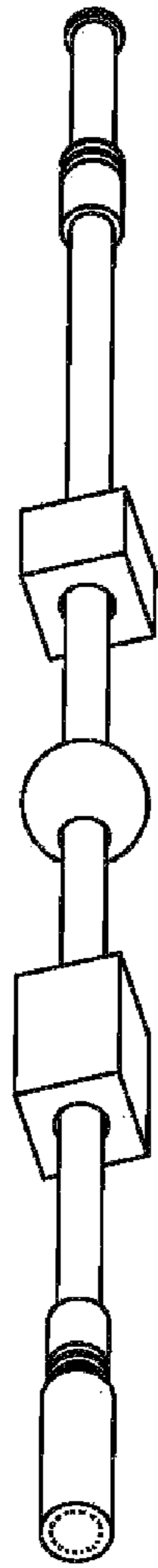

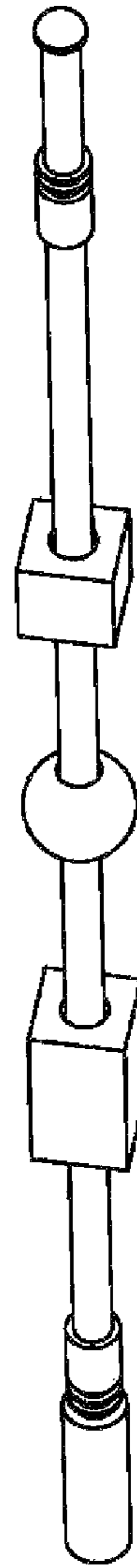
