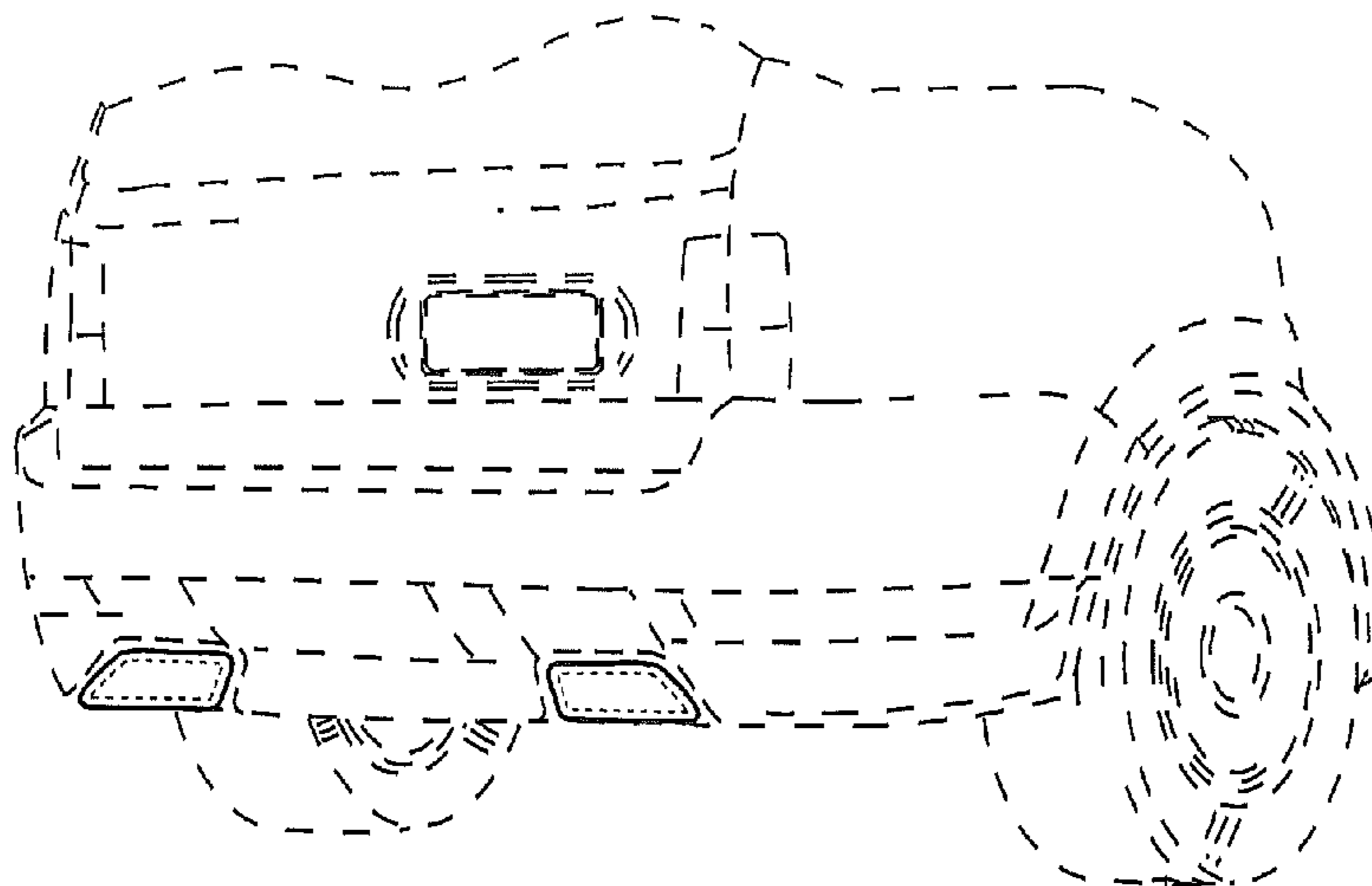

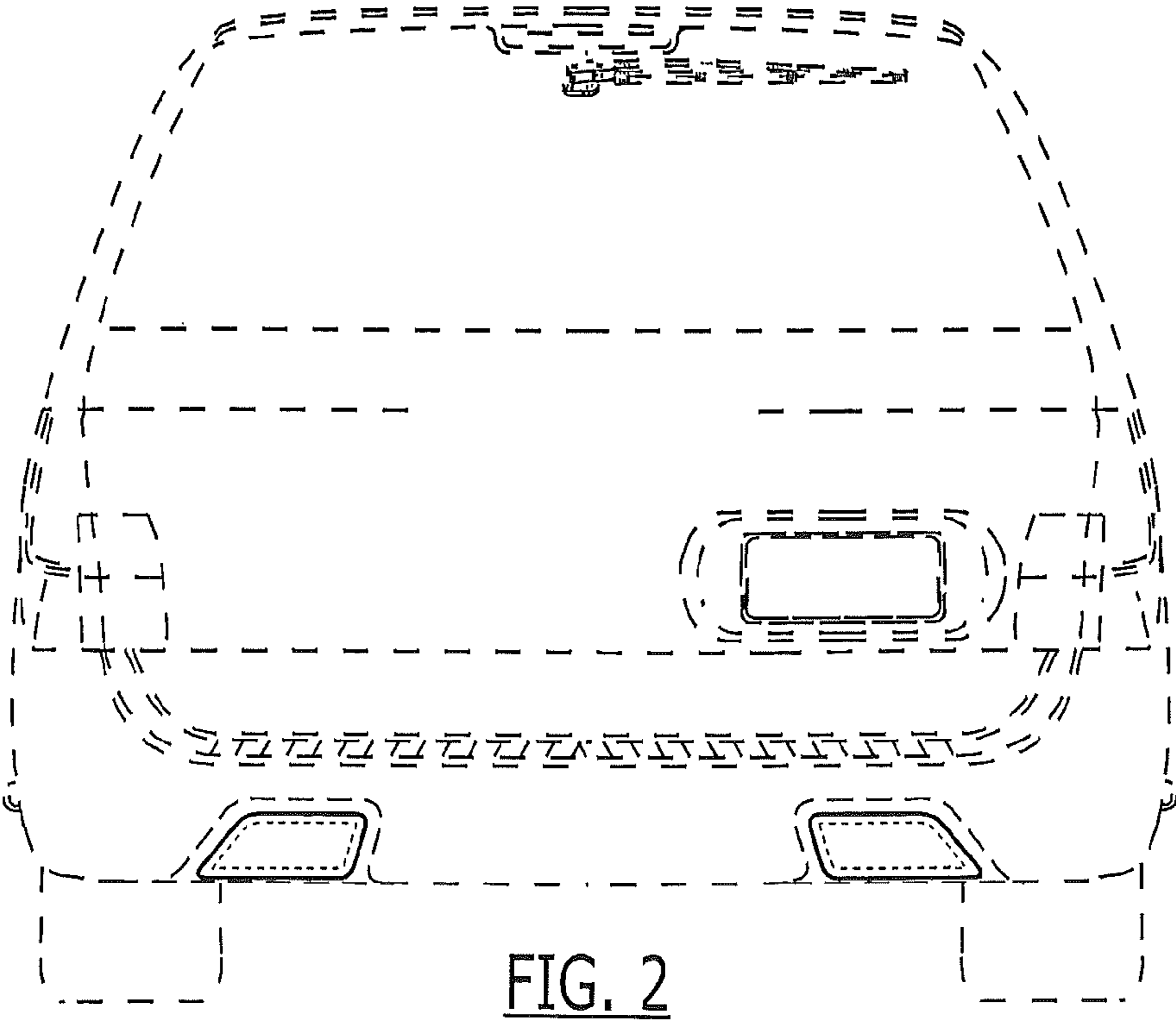
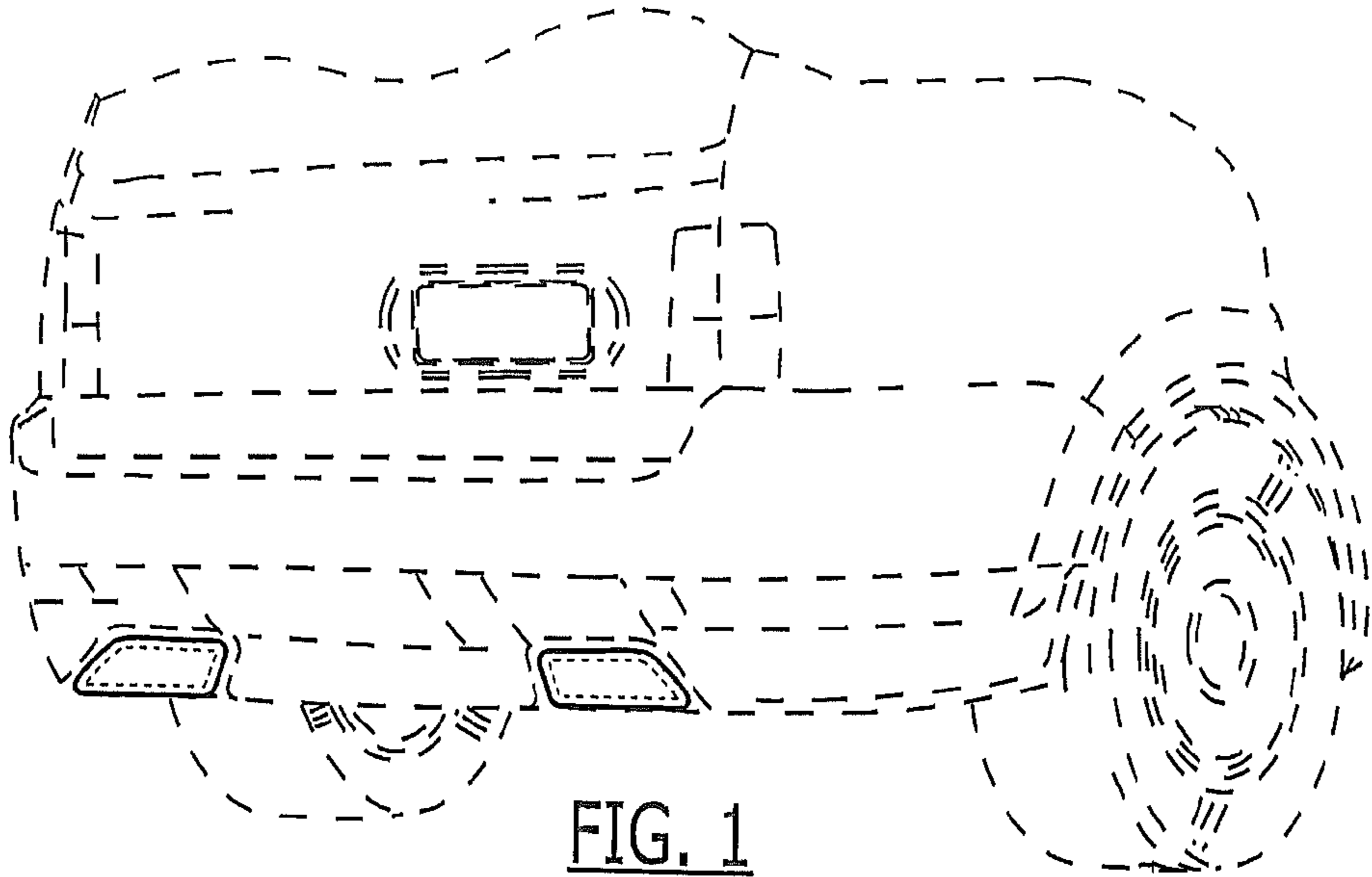
FIG. 1 is a partial perspective view of the present design showing an exhaust pipe set for a minivan;

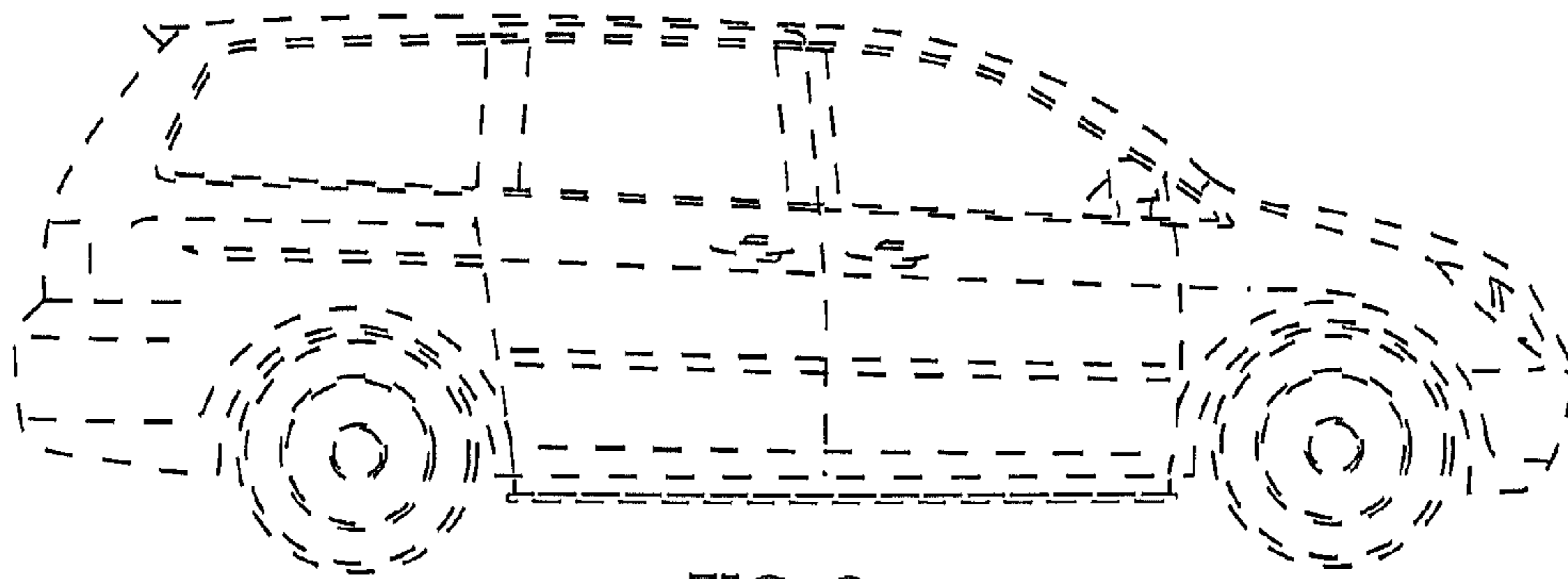

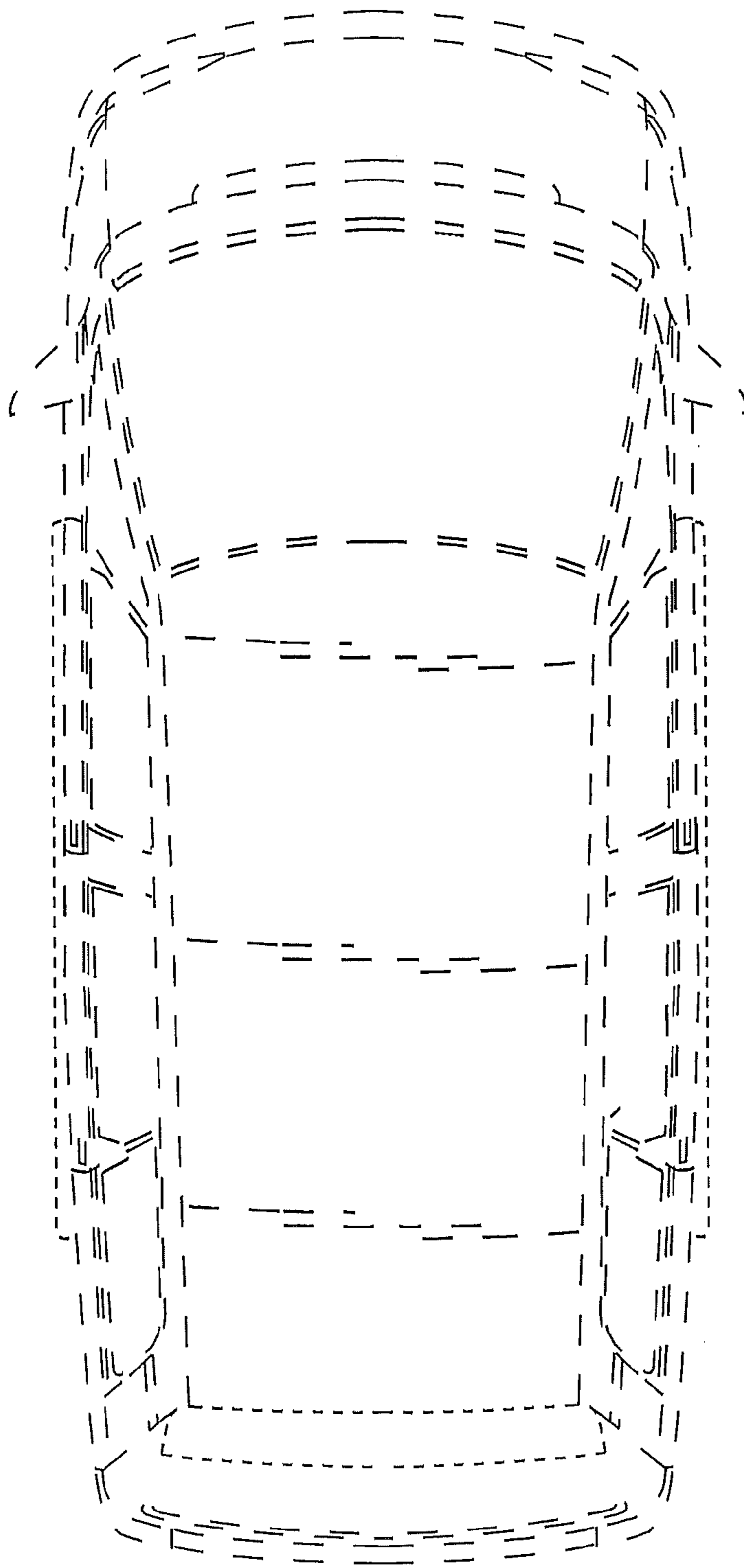
