The ornamental design for a front fairing, as shown and described.

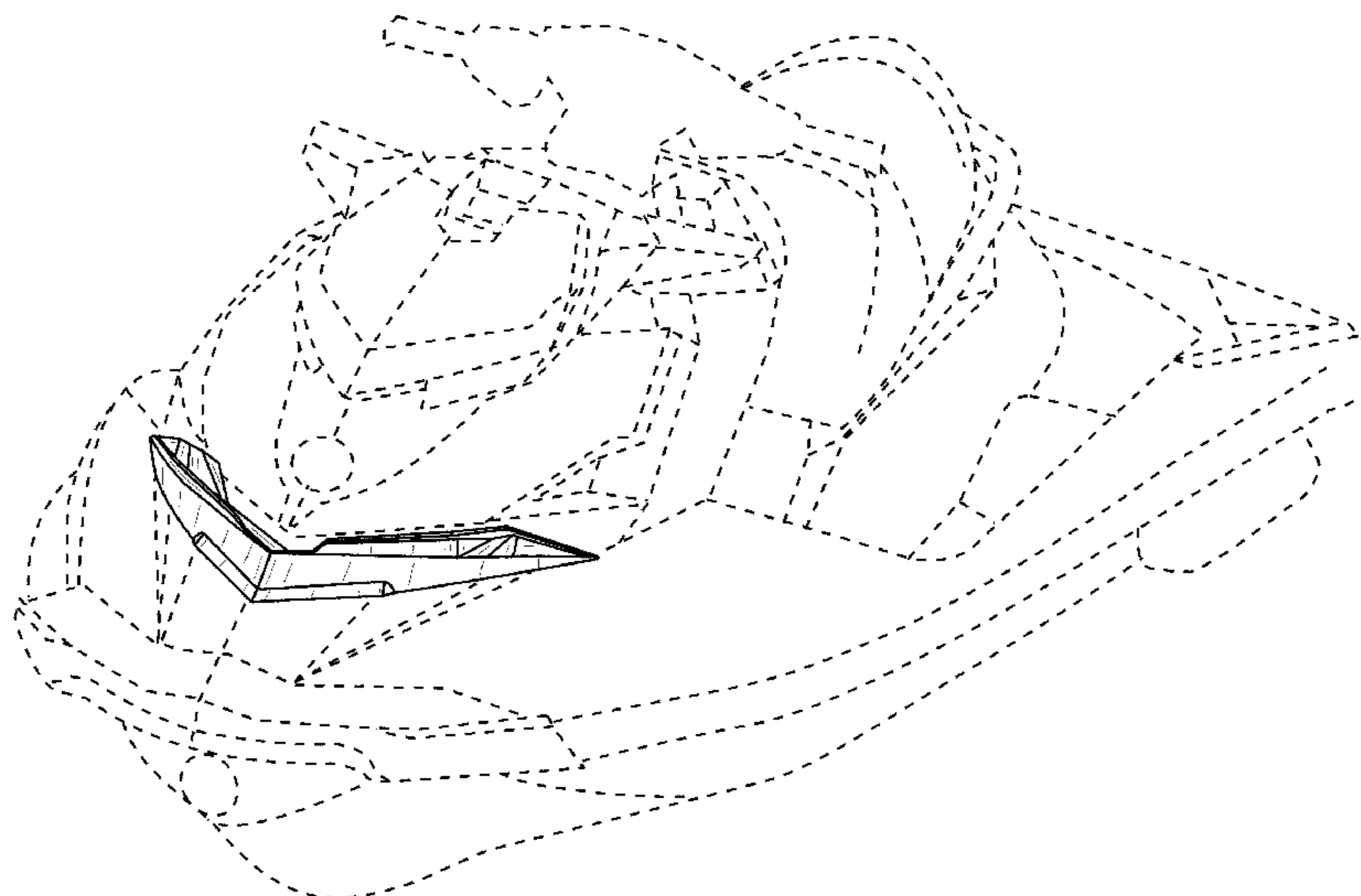
DESCRIPTION

FIG. 1 is a perspective view taken from a front, left side of a front fairing according our design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a right side elevation view thereof;
 FIG. 4 is a left side elevation view thereof;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a perspective view taken from a front, left side of a front fairing of FIG. 1 shown on a personal watercraft shown in dotted lines.

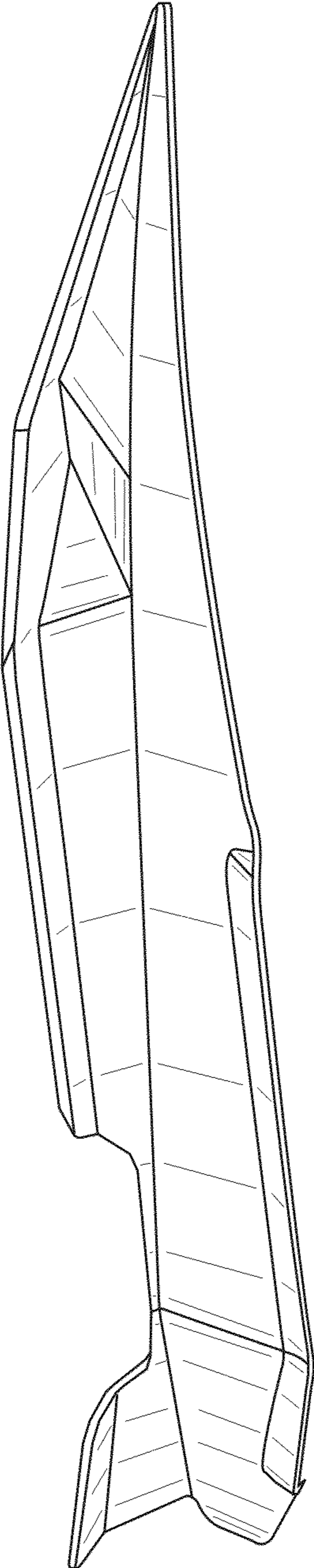

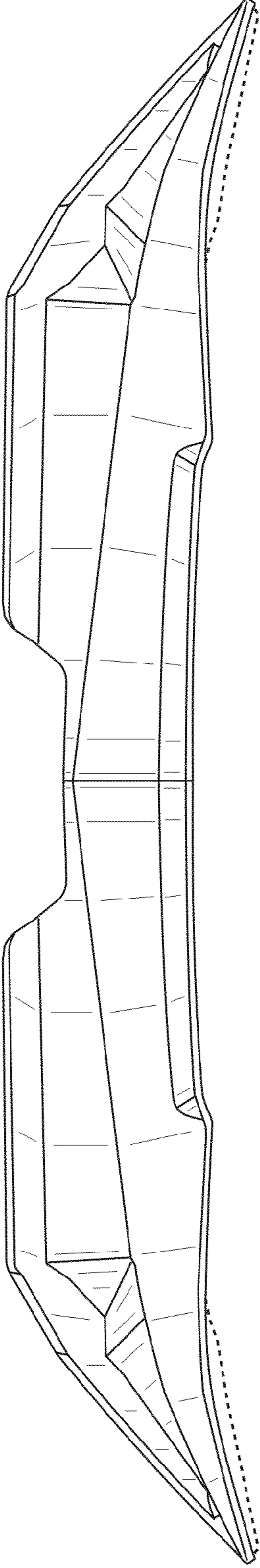

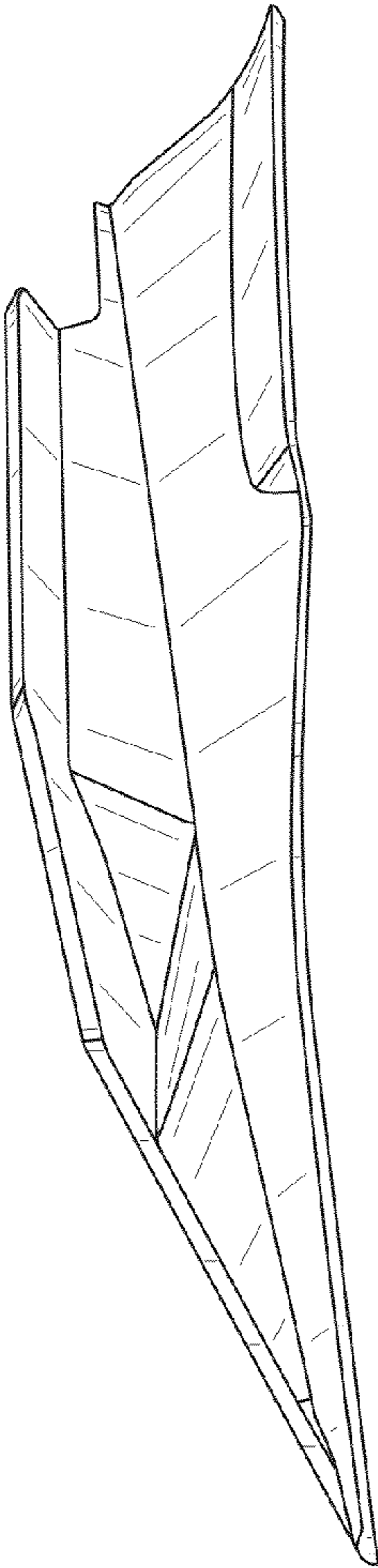

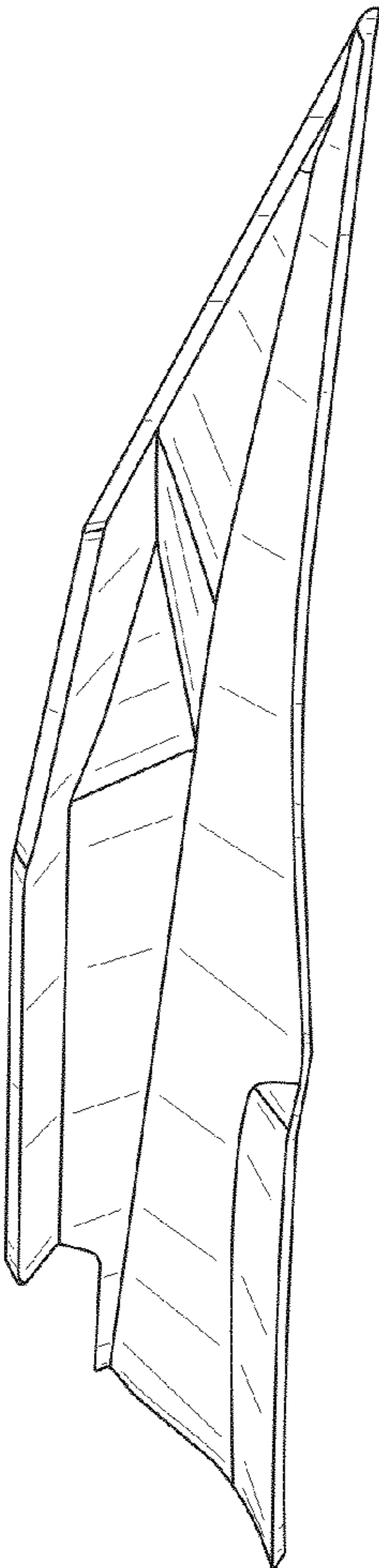

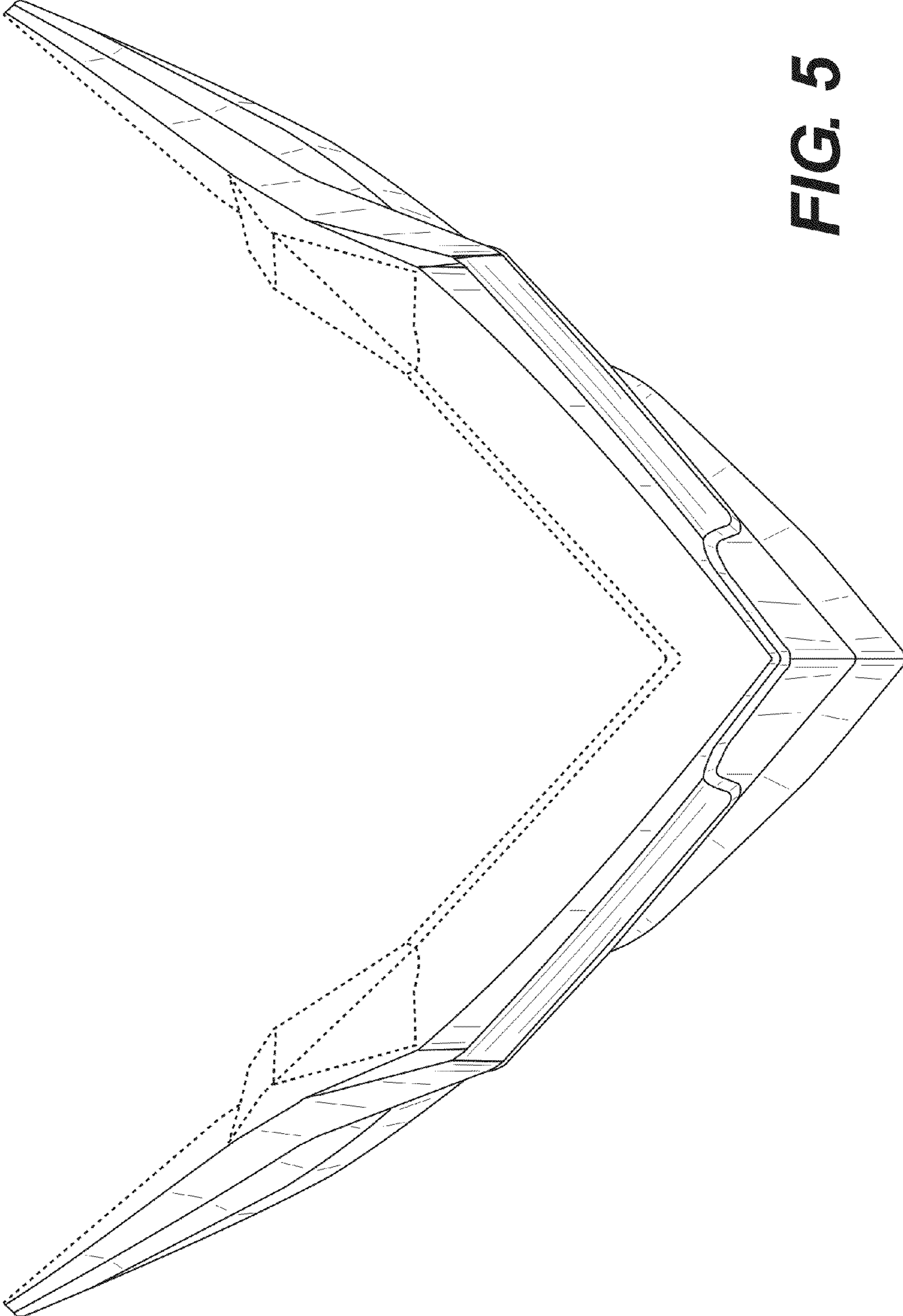

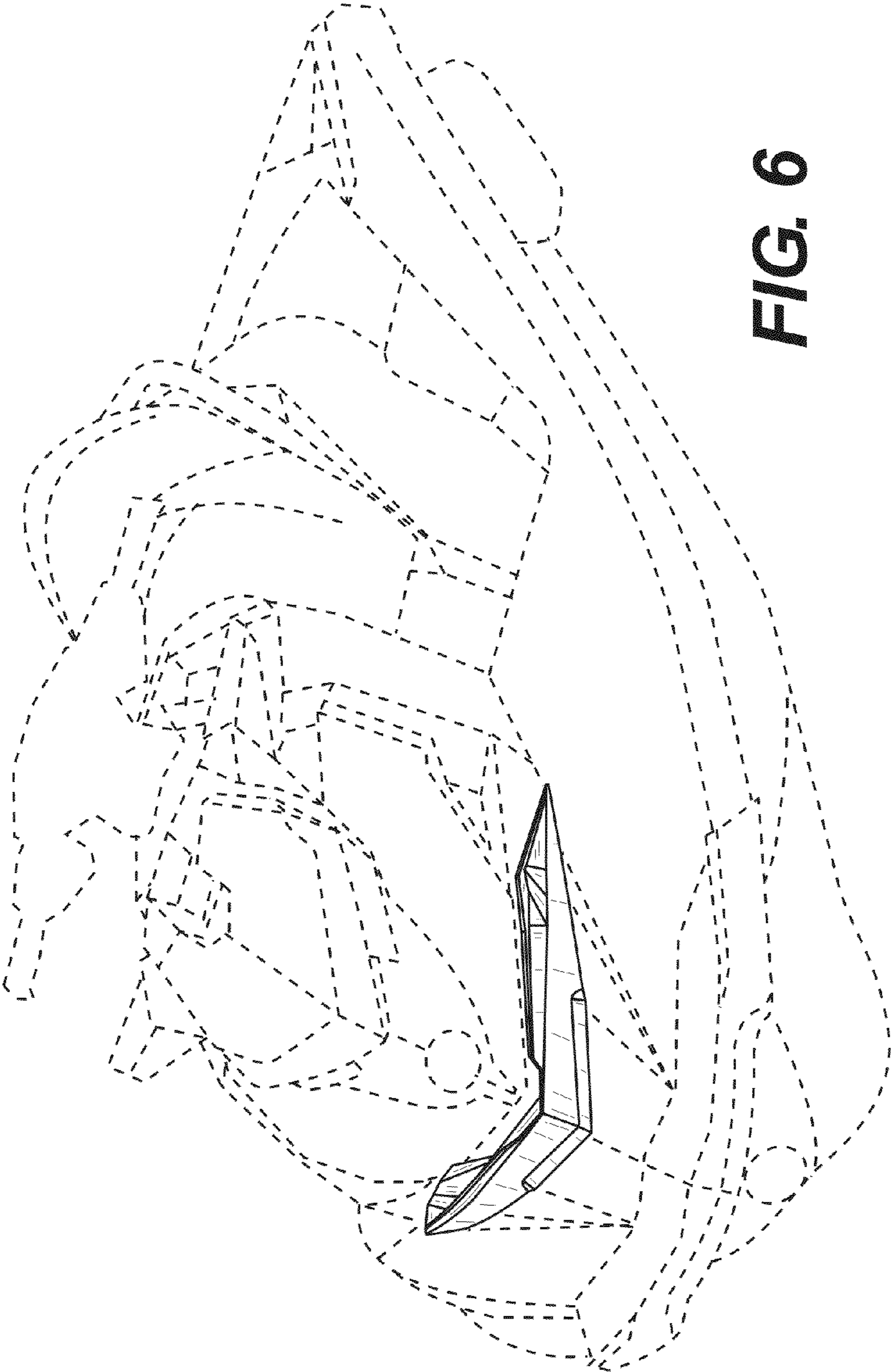
