DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a charging system having the design of my invention;

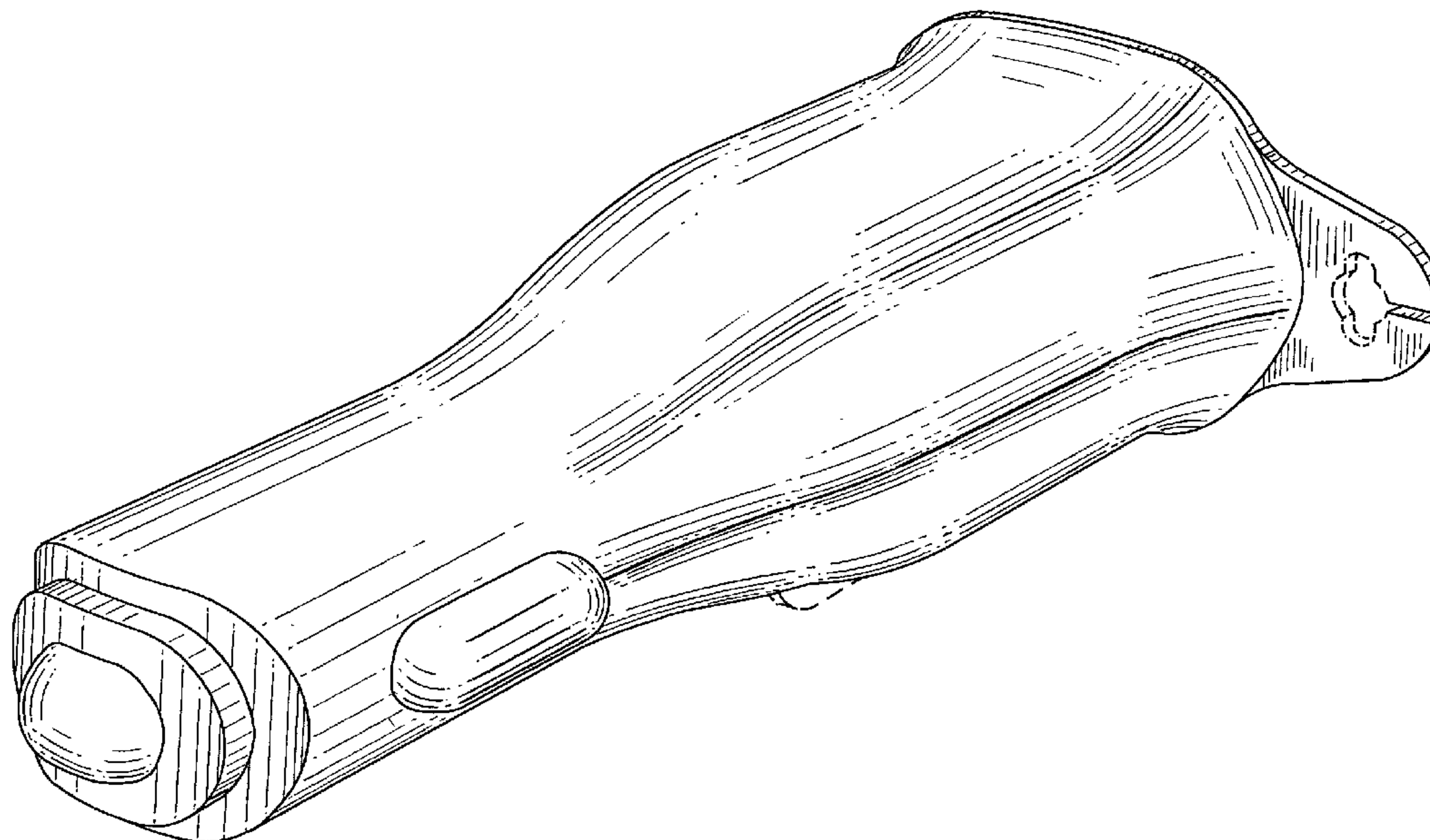
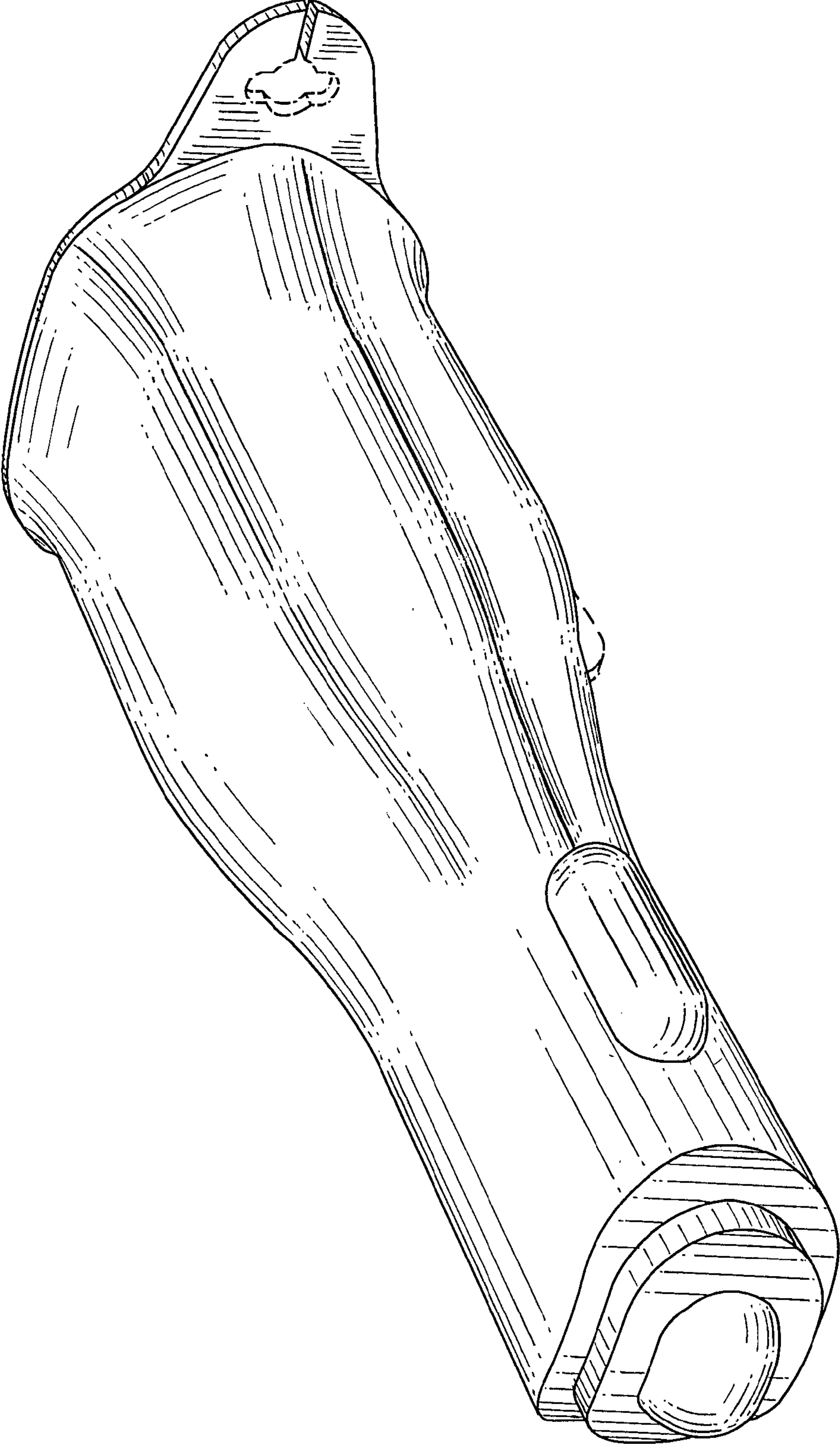

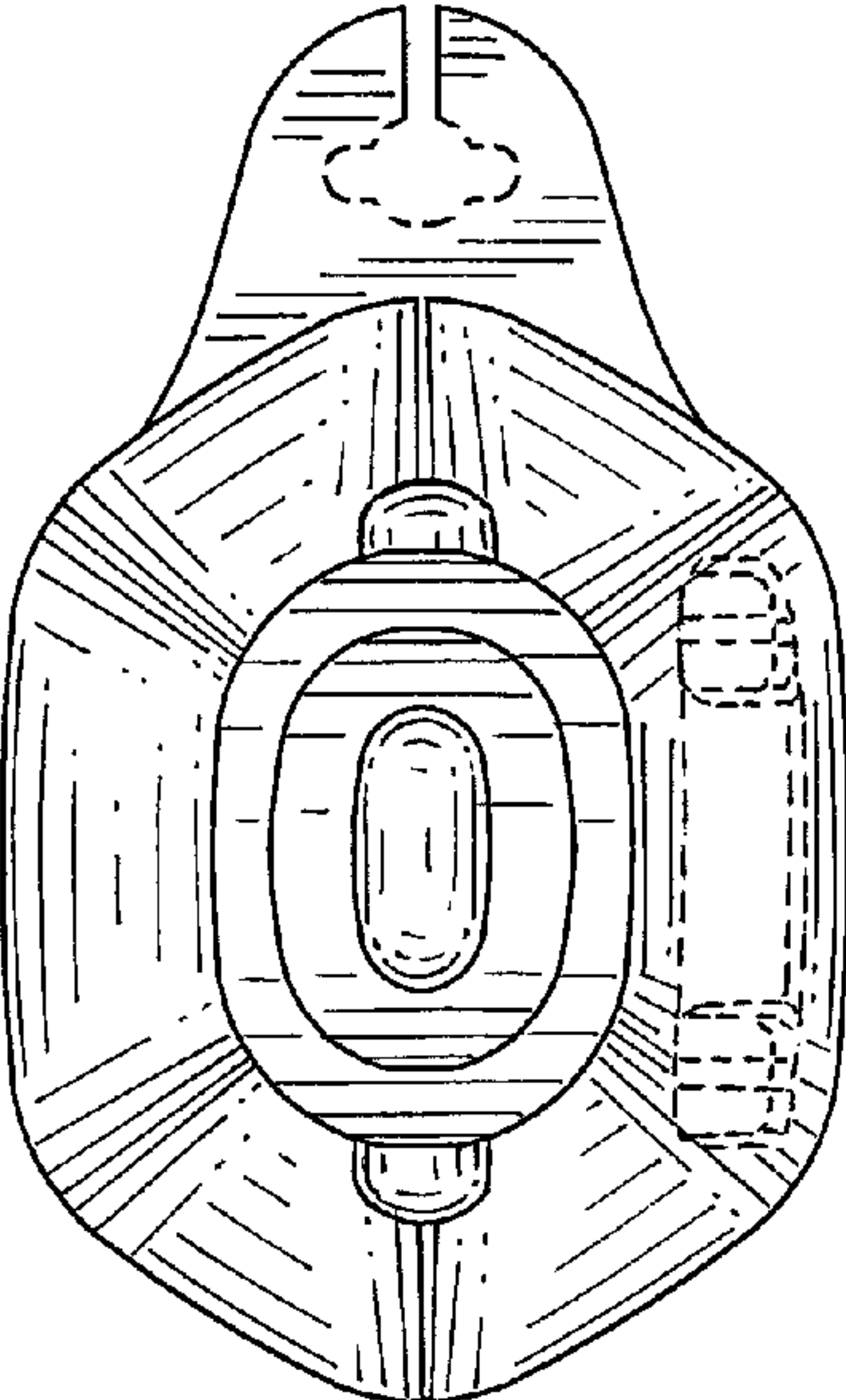

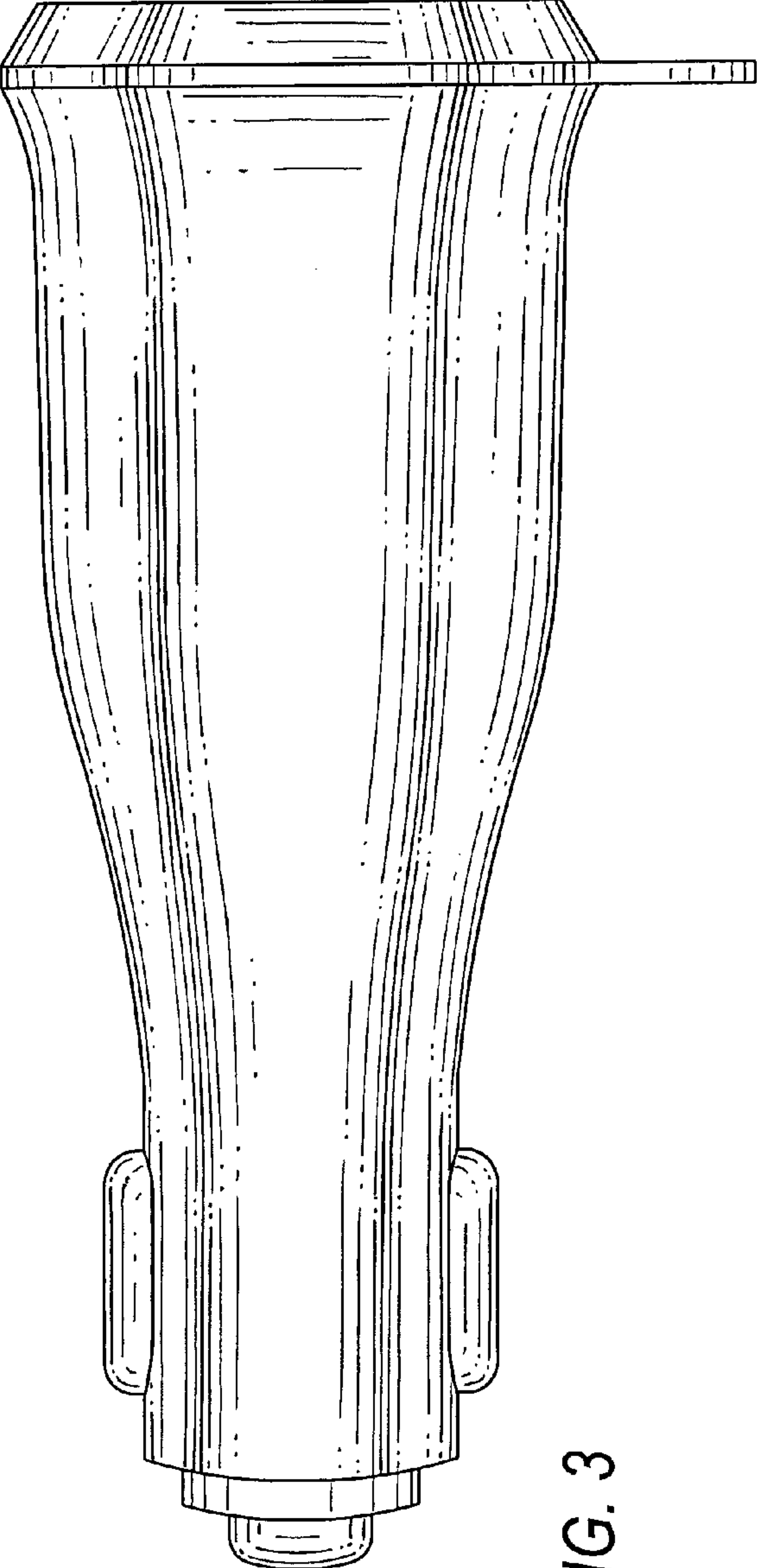

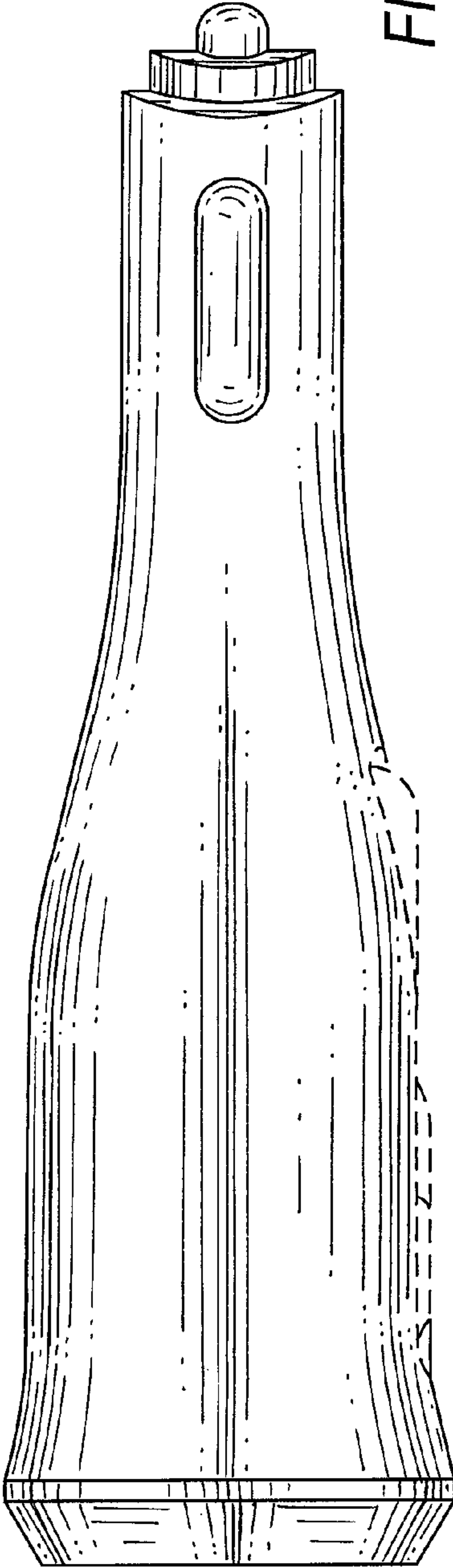

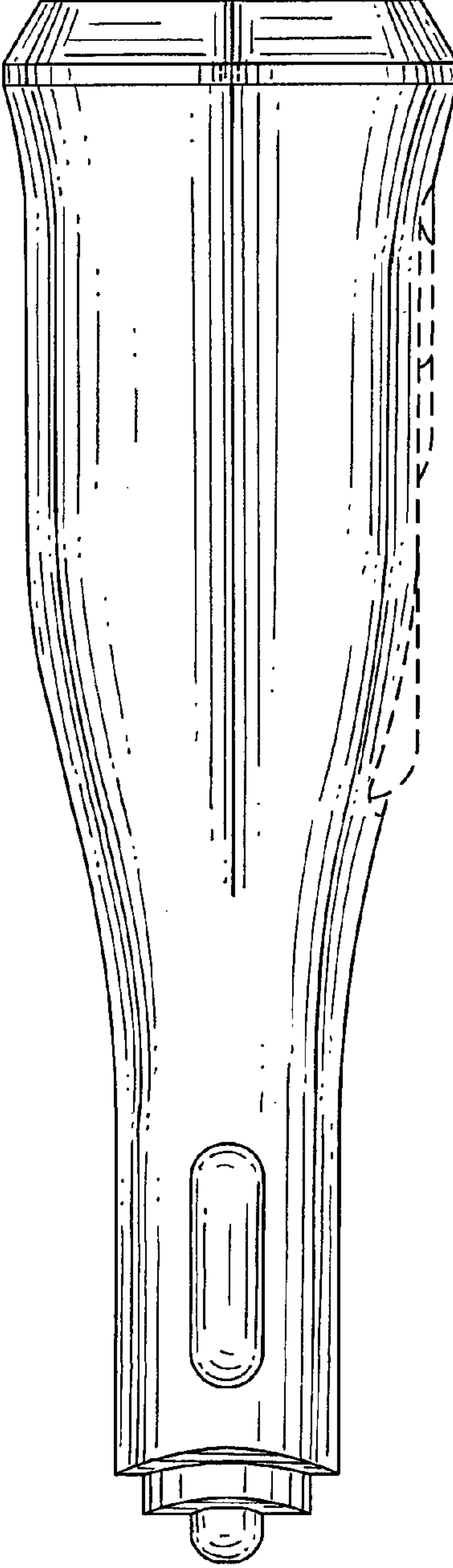

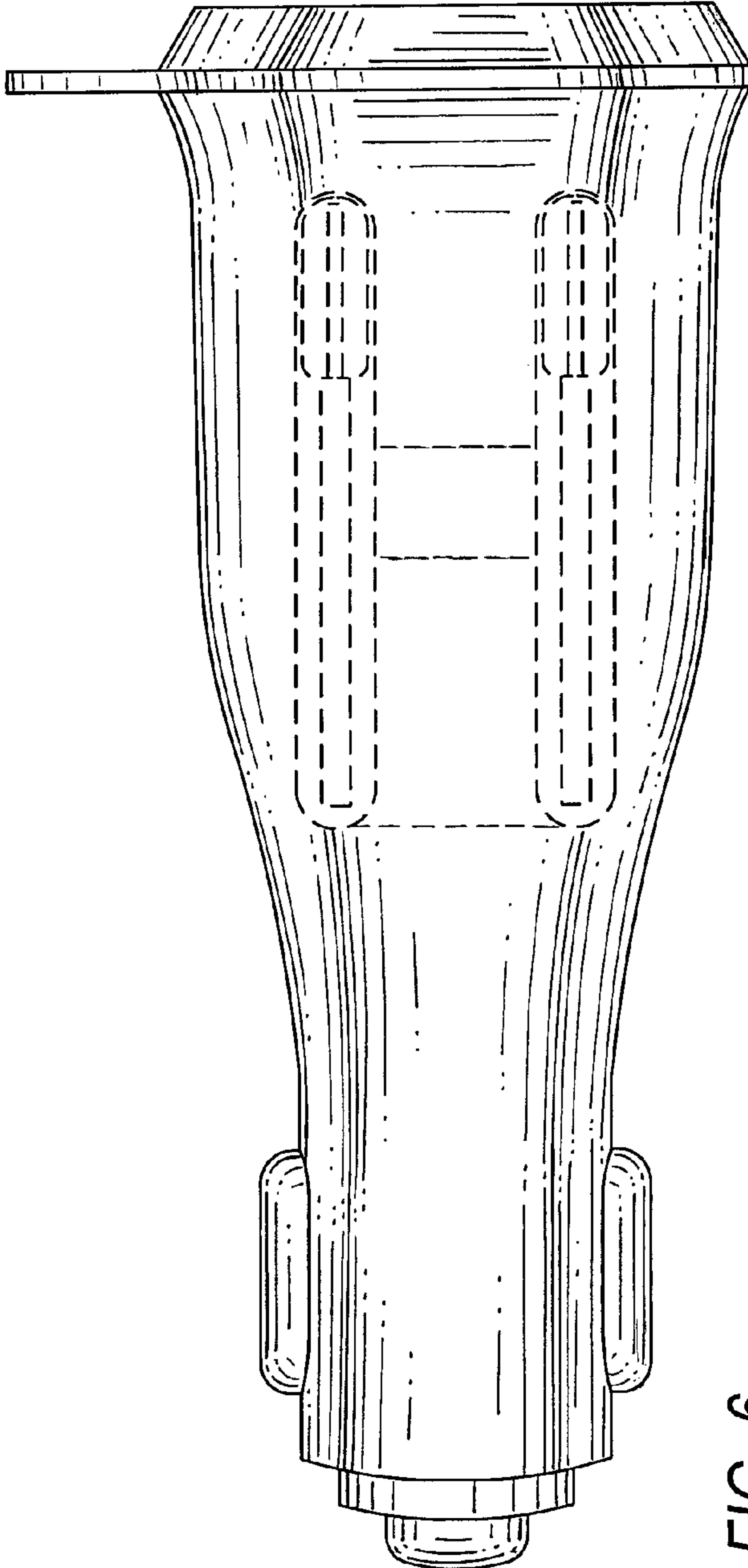

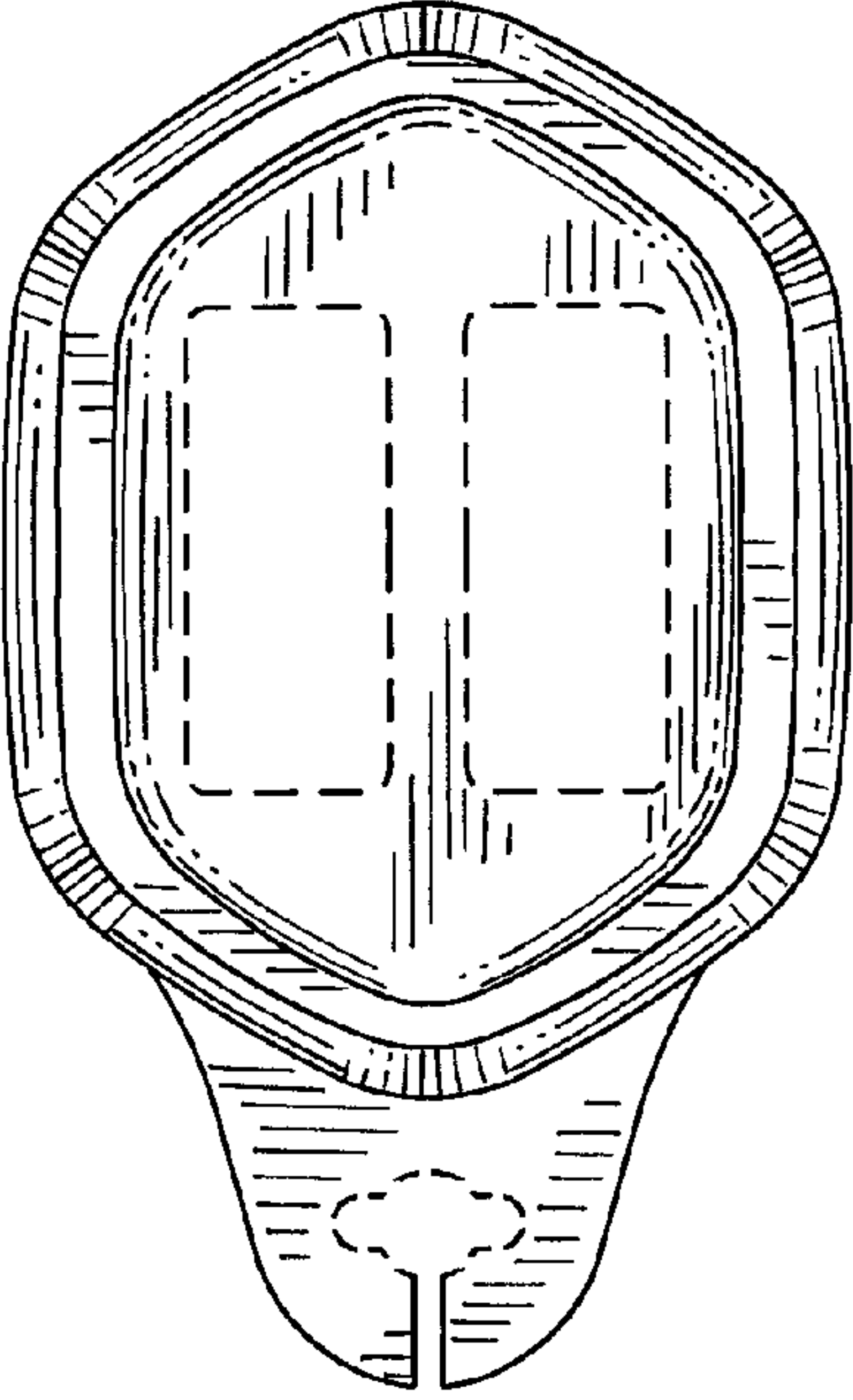
