(57) **CLAIM**

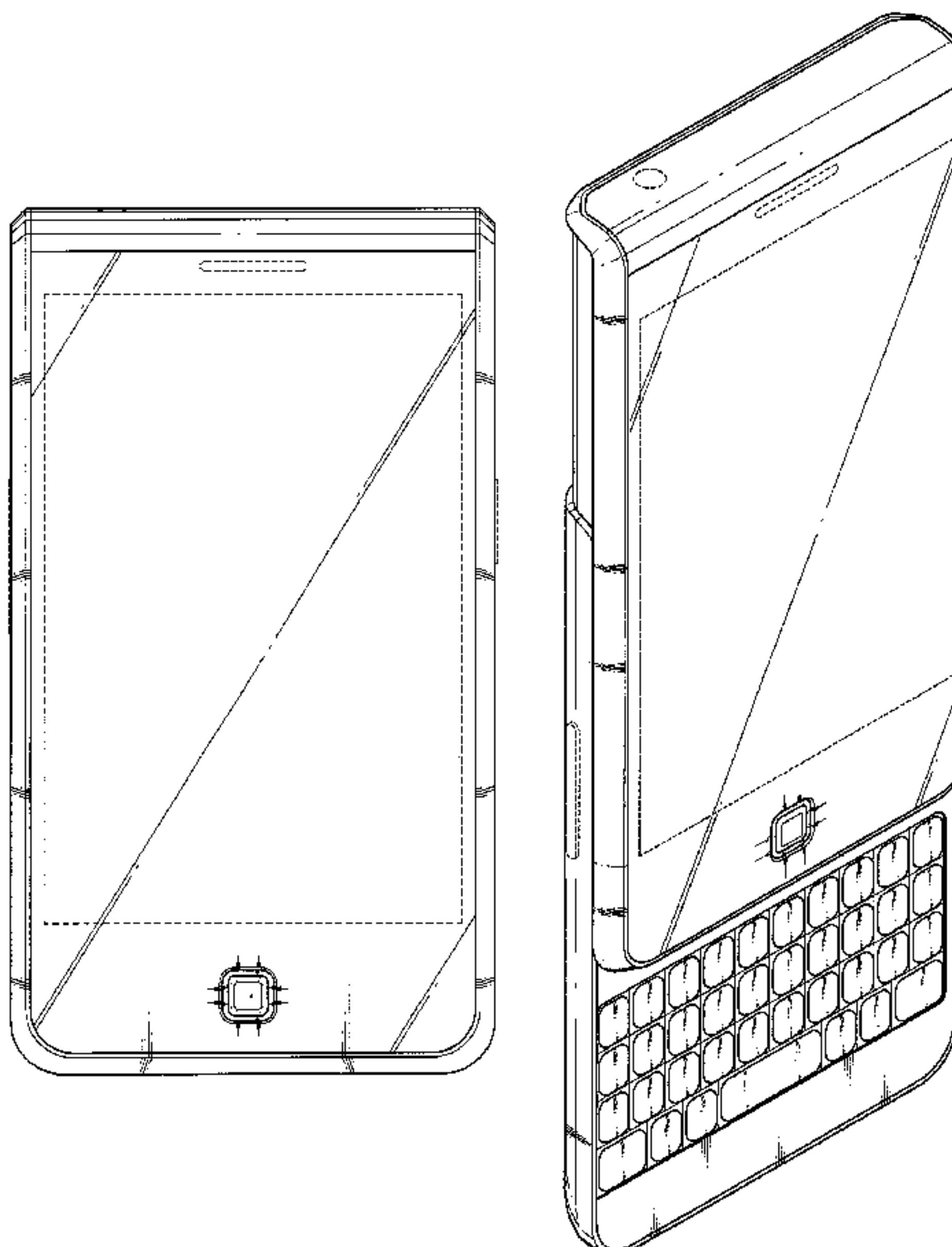
The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone;

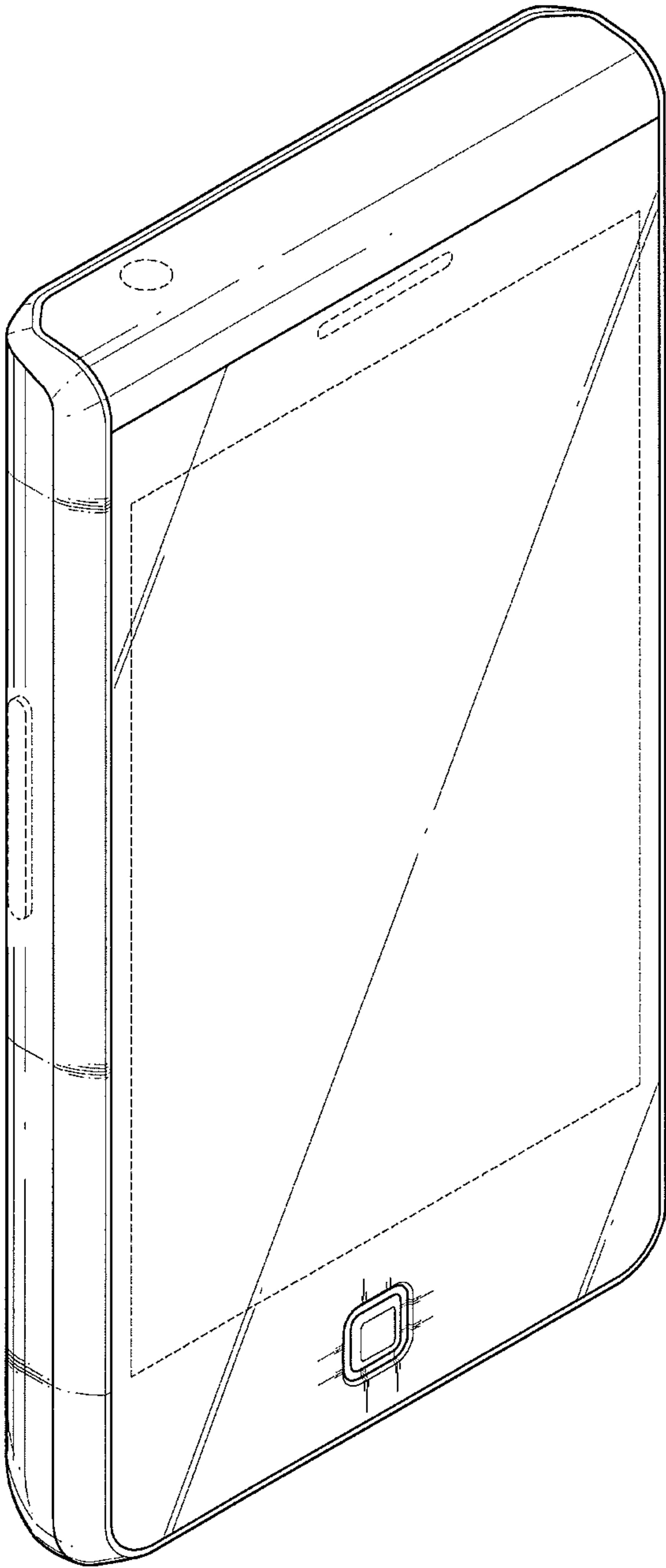

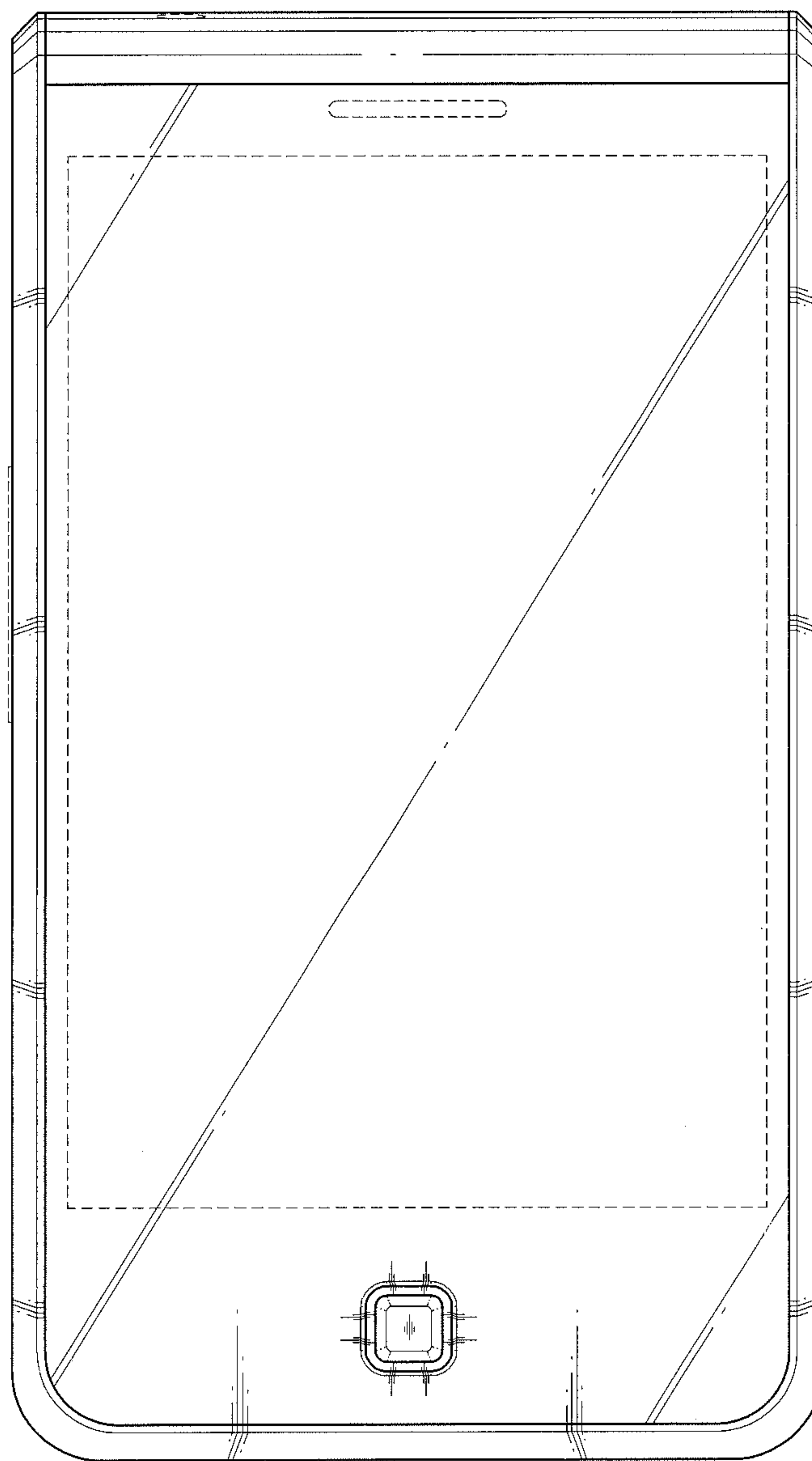

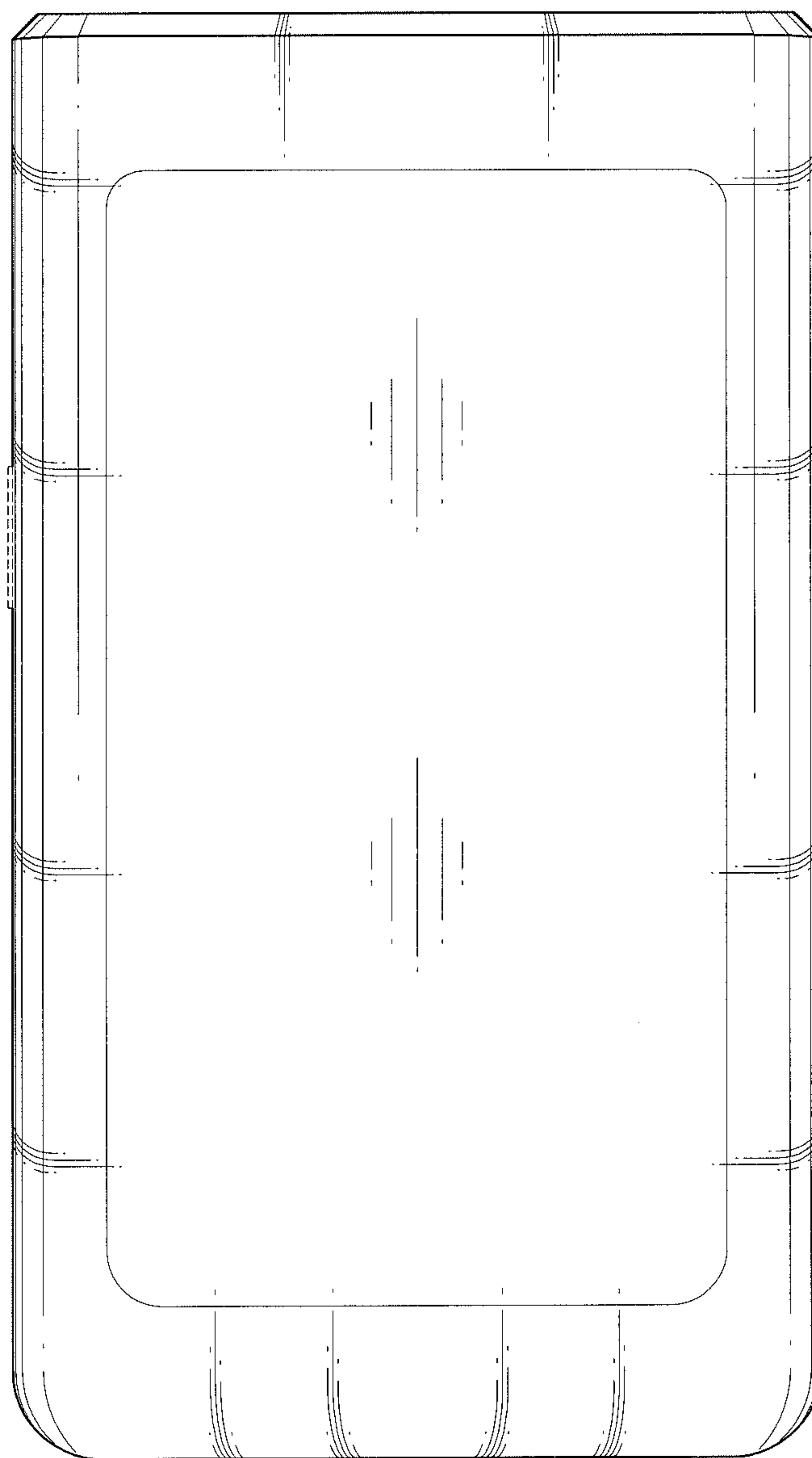

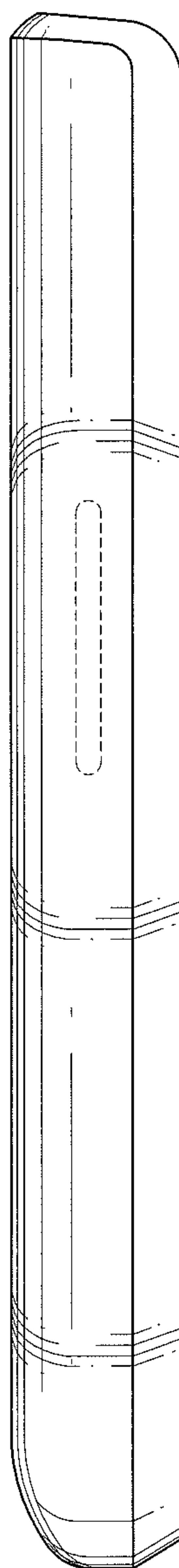

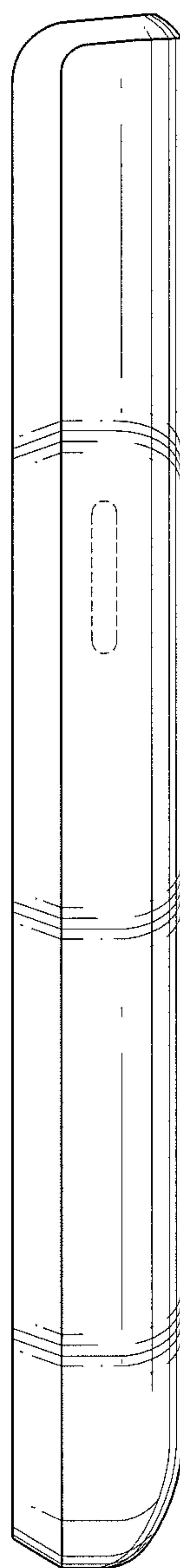

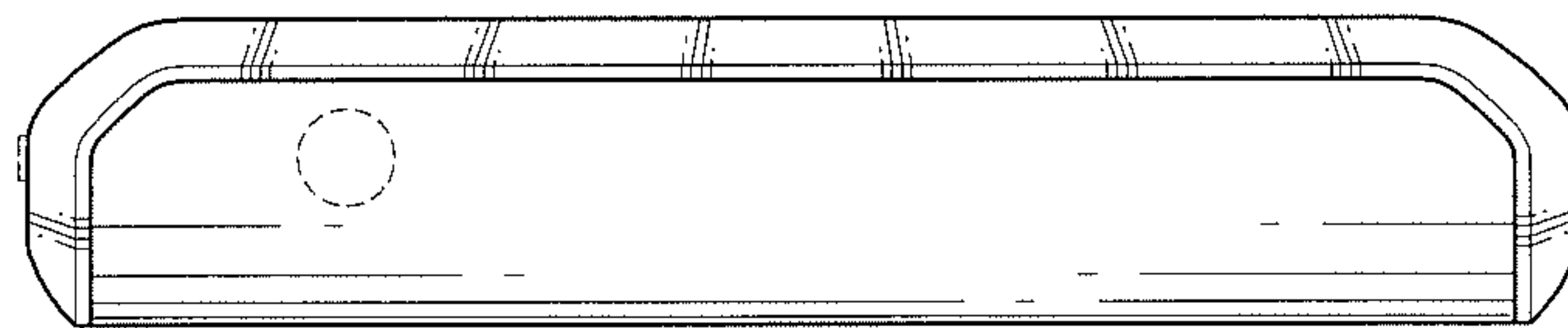

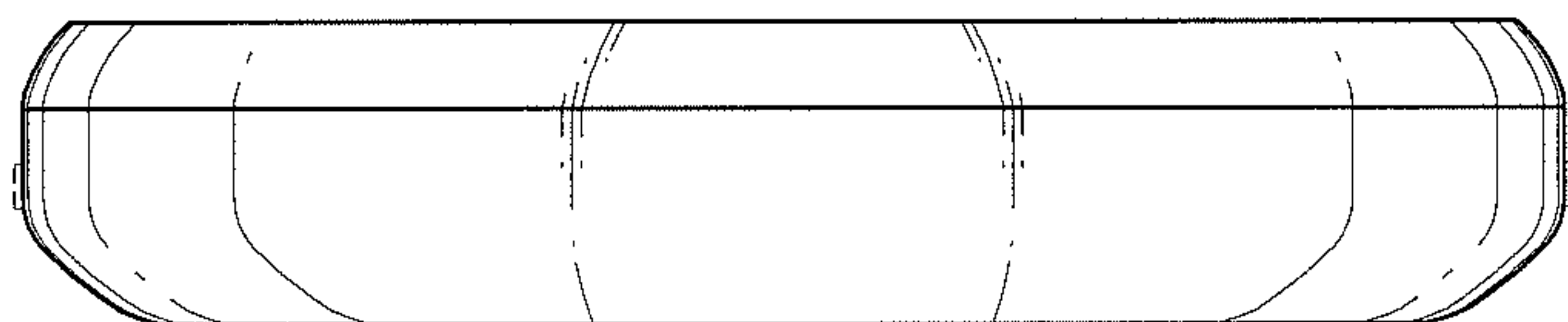
