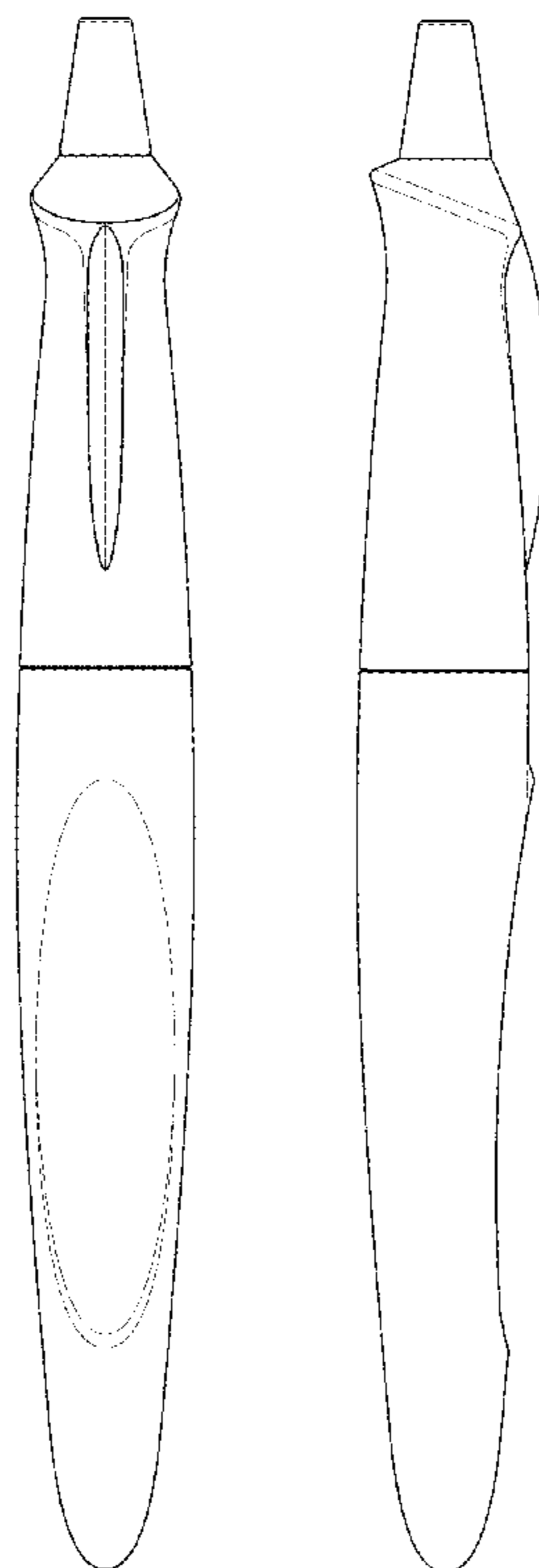
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is bottom view of an ornamental design for a writing instrument design according to the present invention;  
FIG. 2 is a first front view thereof in the extended configuration;  
FIG. 3 is a second front view thereof in the extended configuration;  
FIG. 4 is a third front view thereof in the retracted configuration;  
FIG. 5 is a left side view thereof in the retracted configuration;

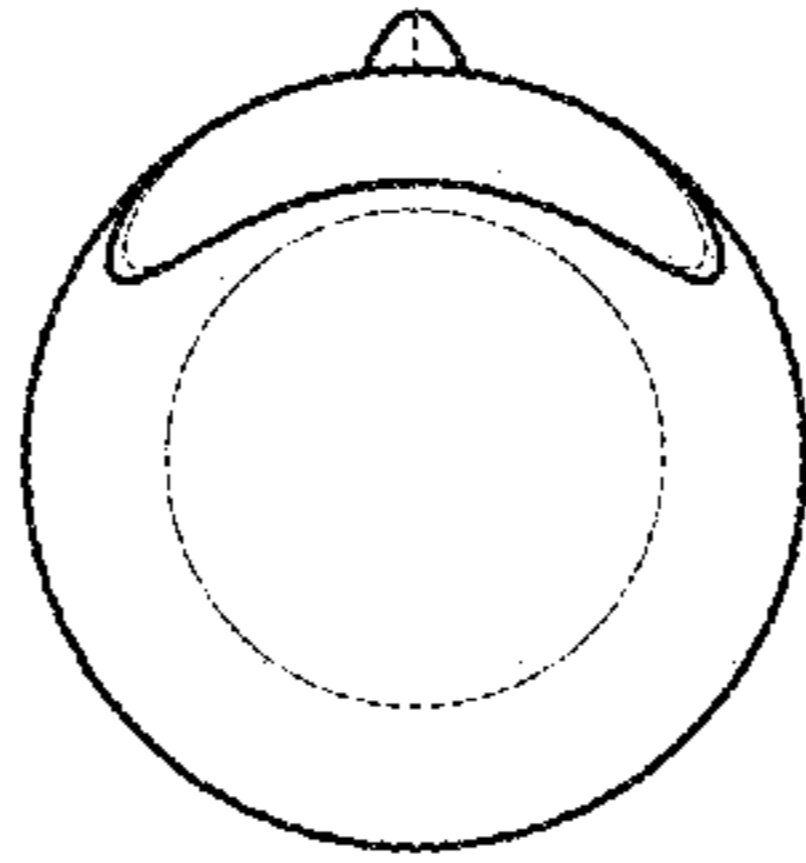

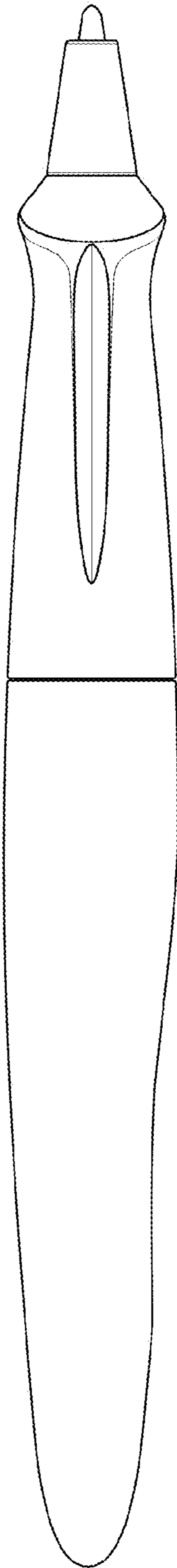

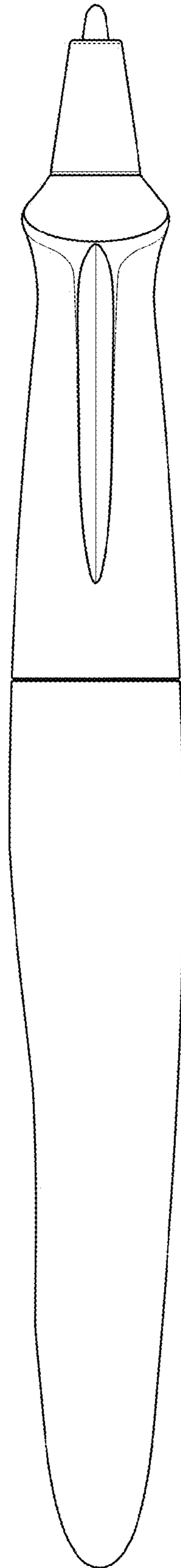

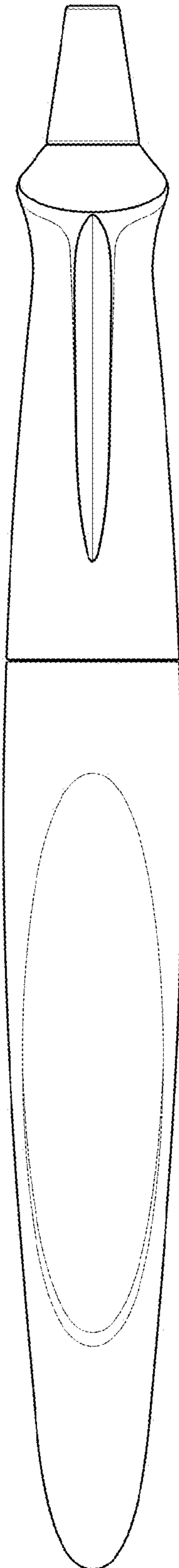

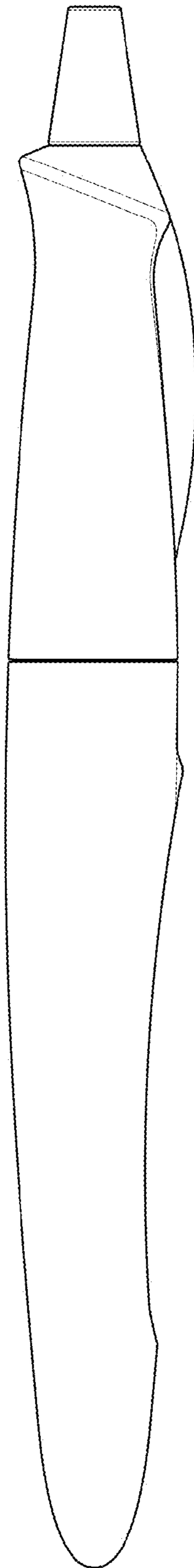

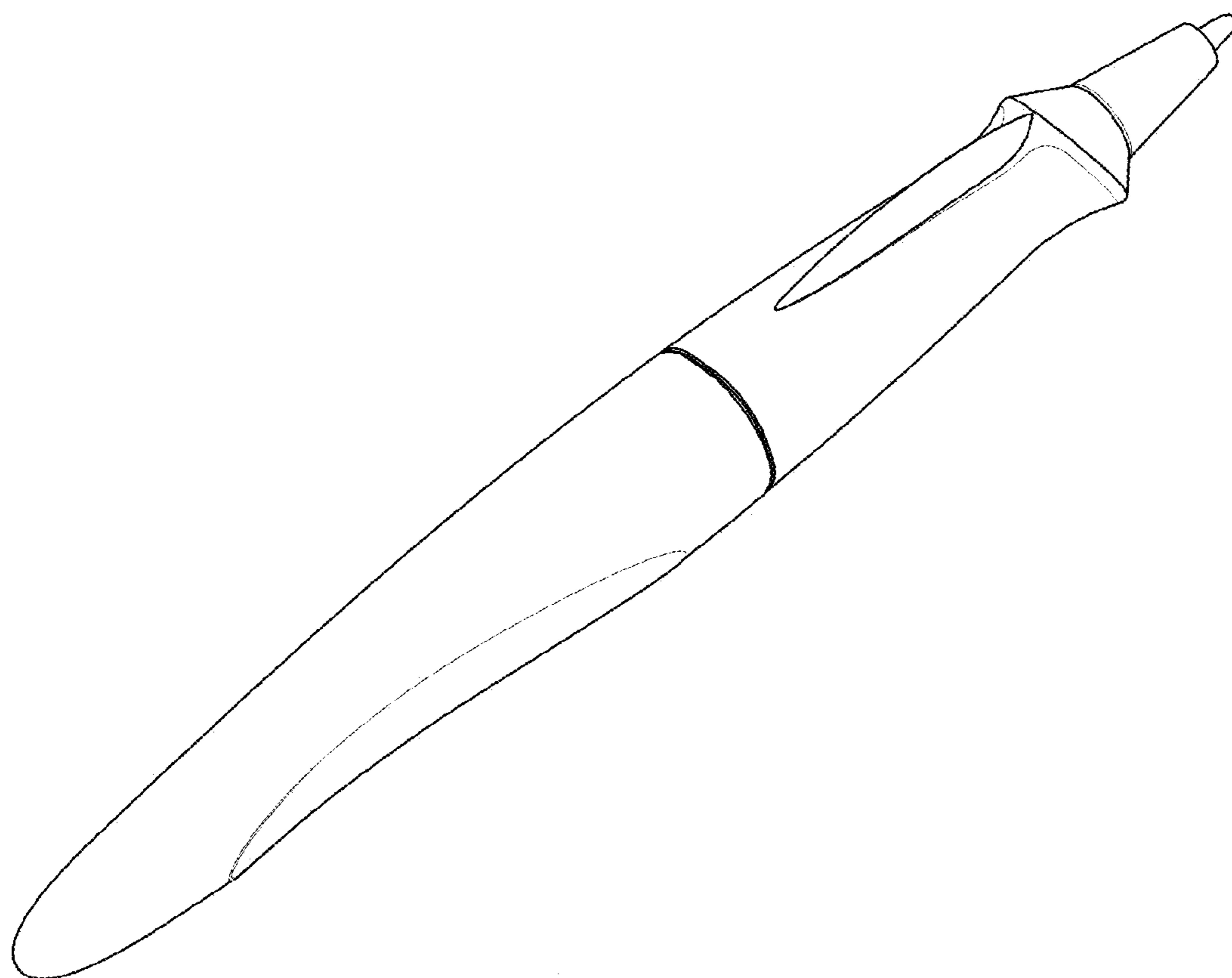

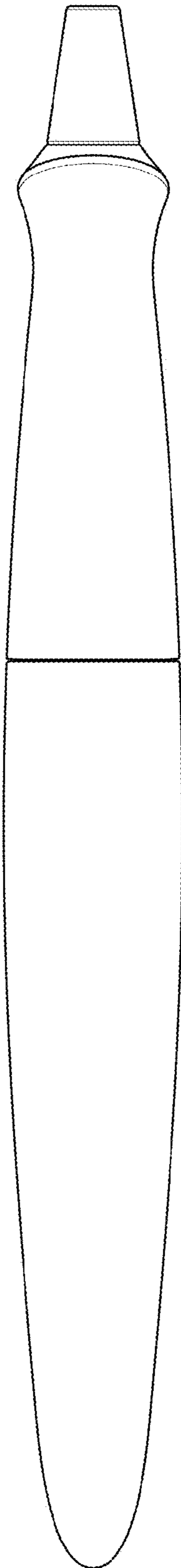
