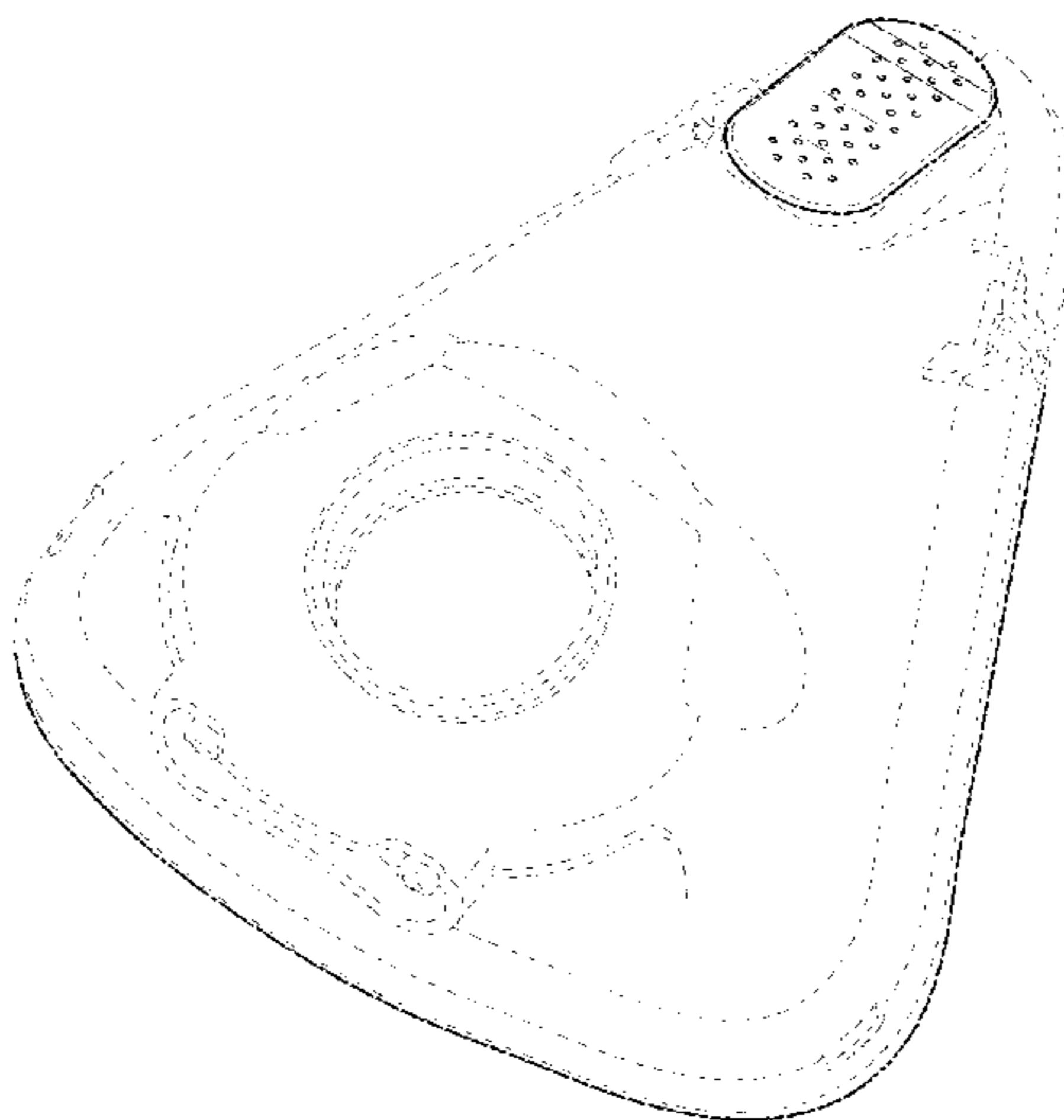
(57) **CLAIM**

The ornamental design for a frame for respiratory mask, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a frame for a respiratory mask according to our new design;

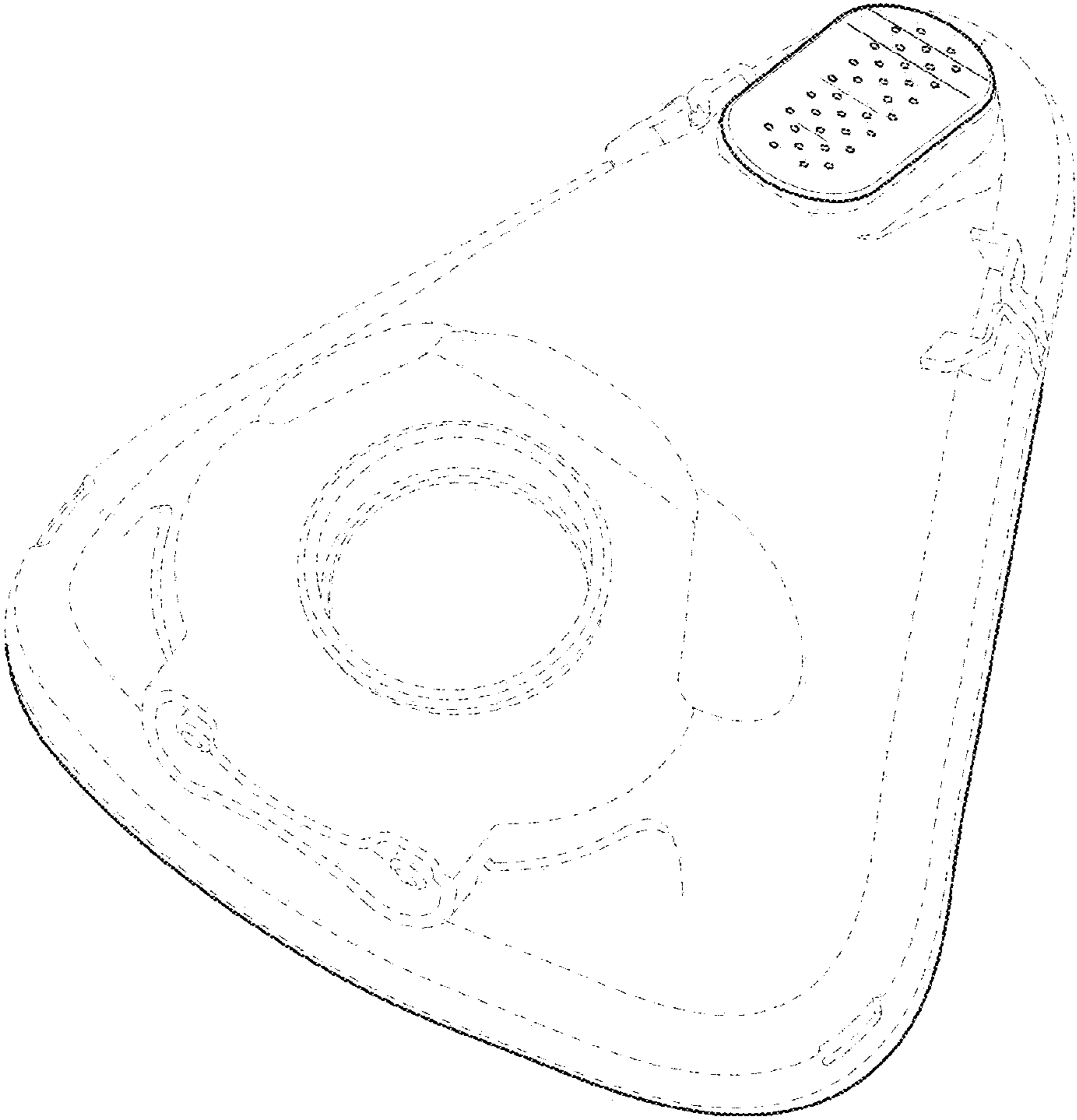

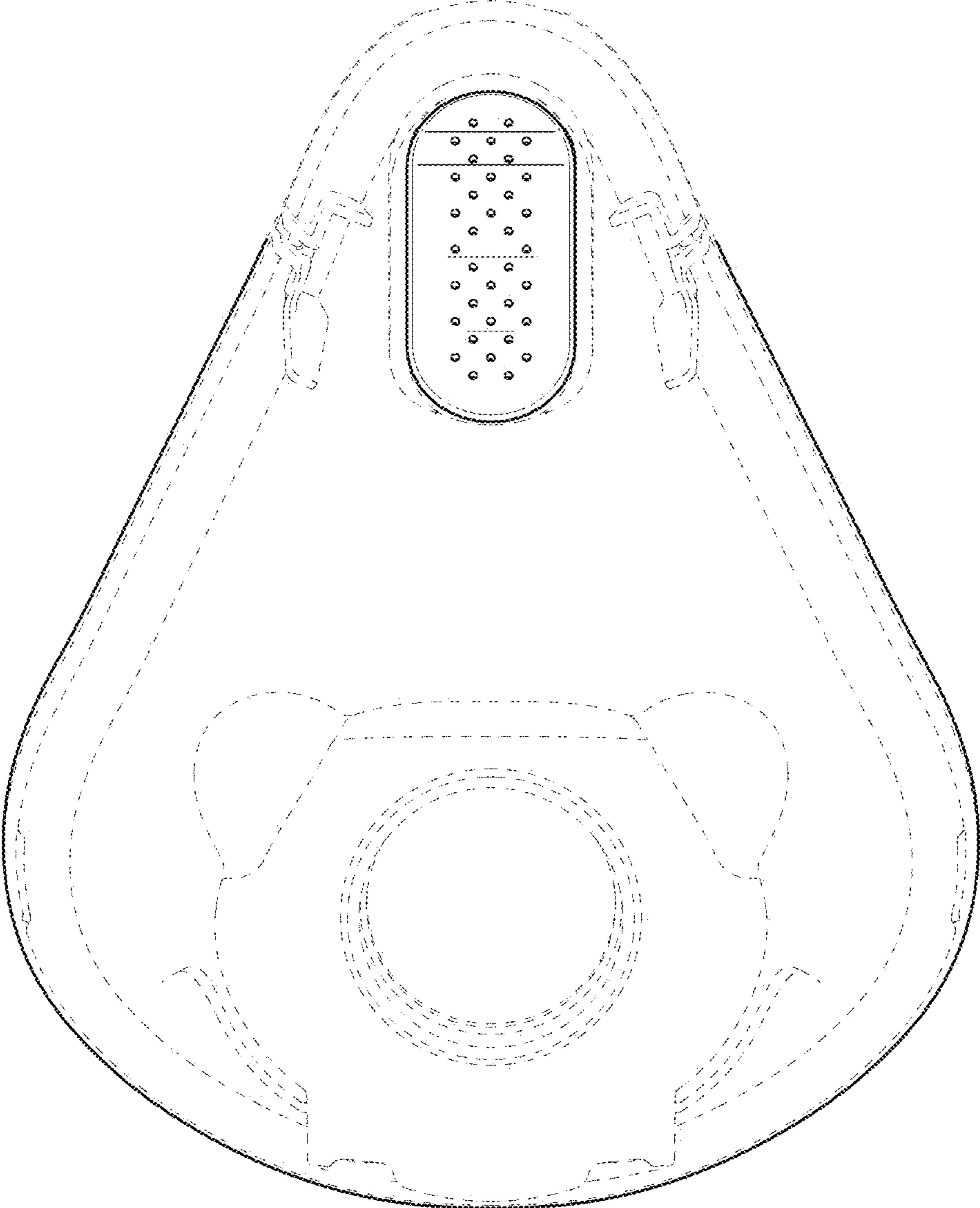

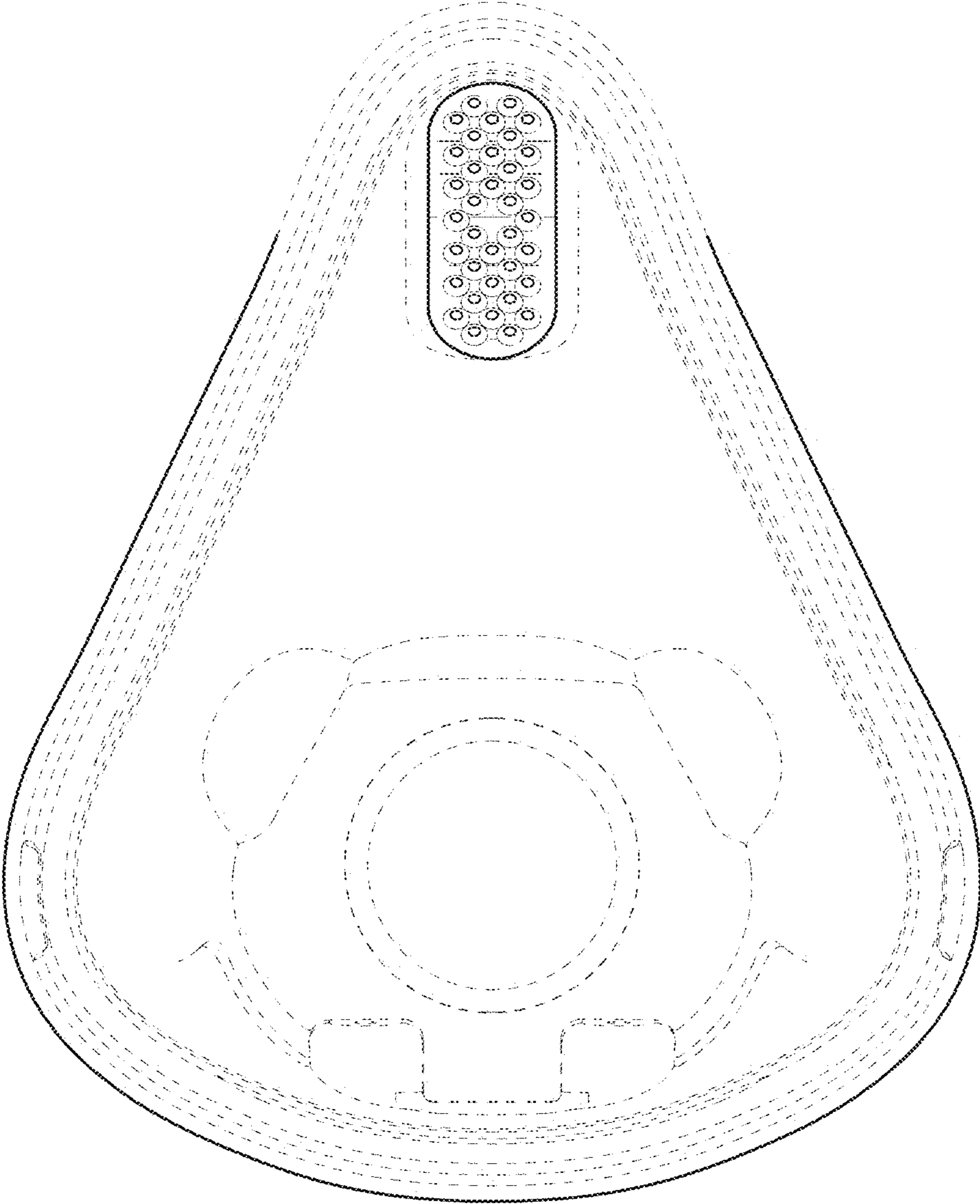

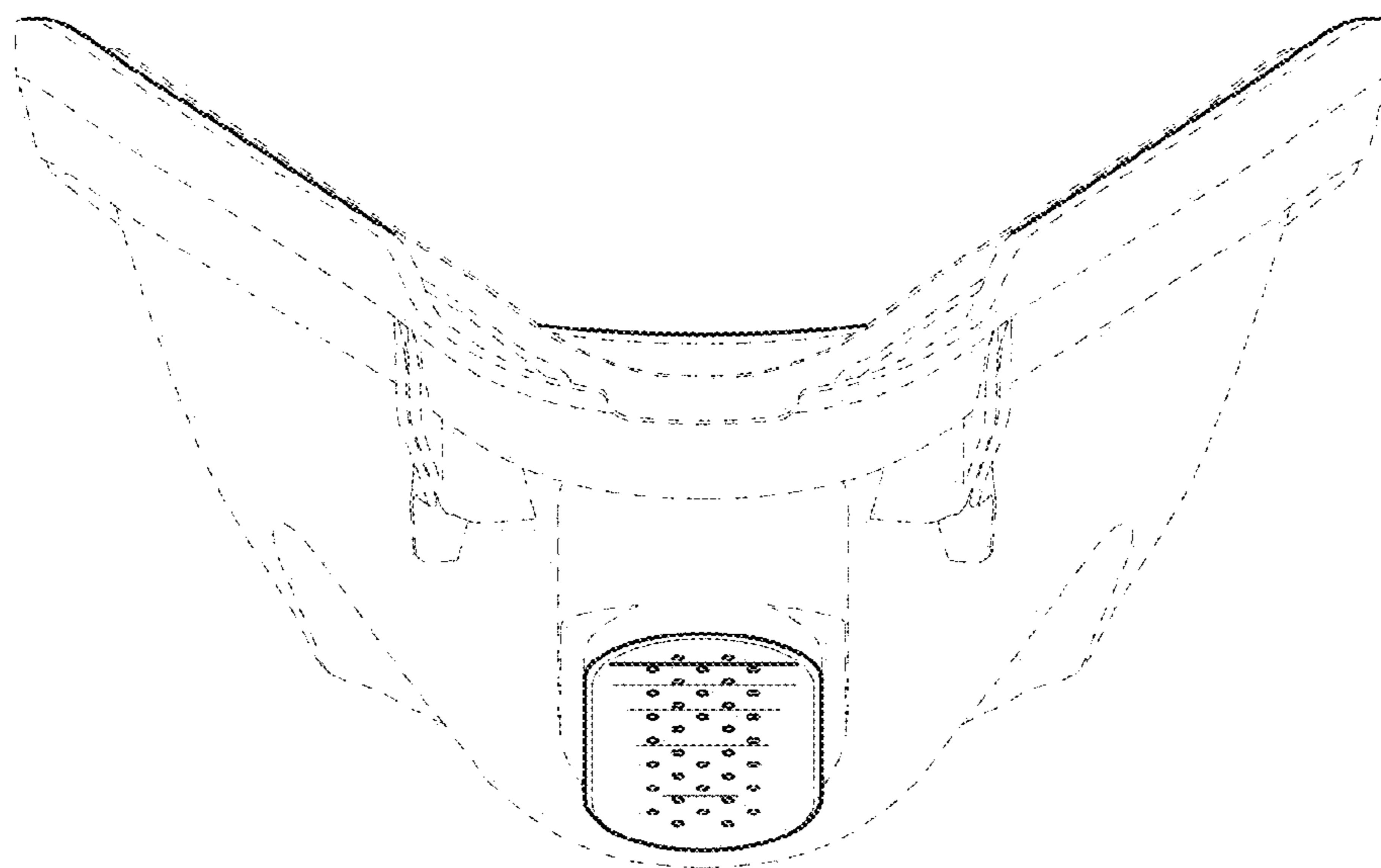

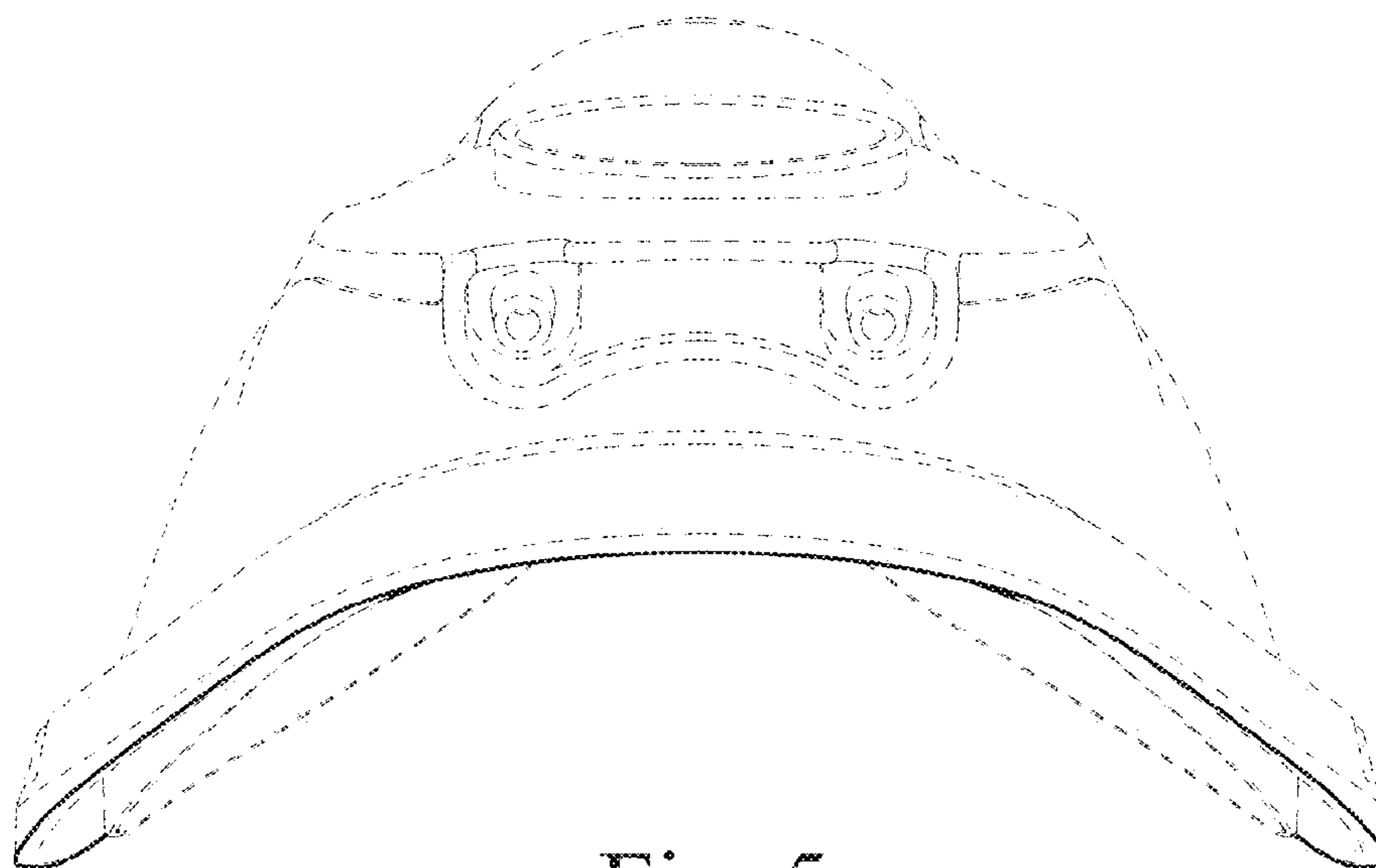

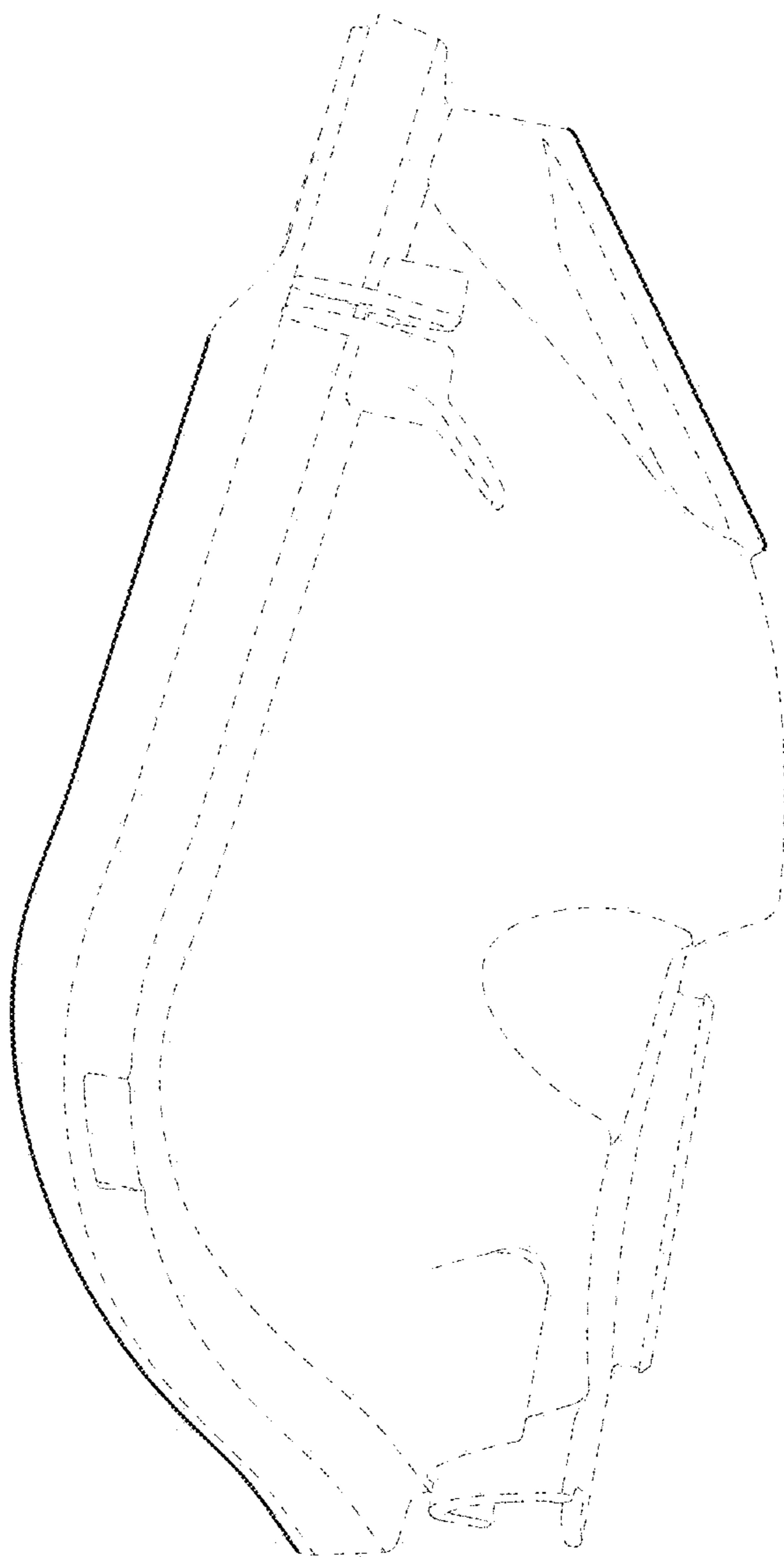

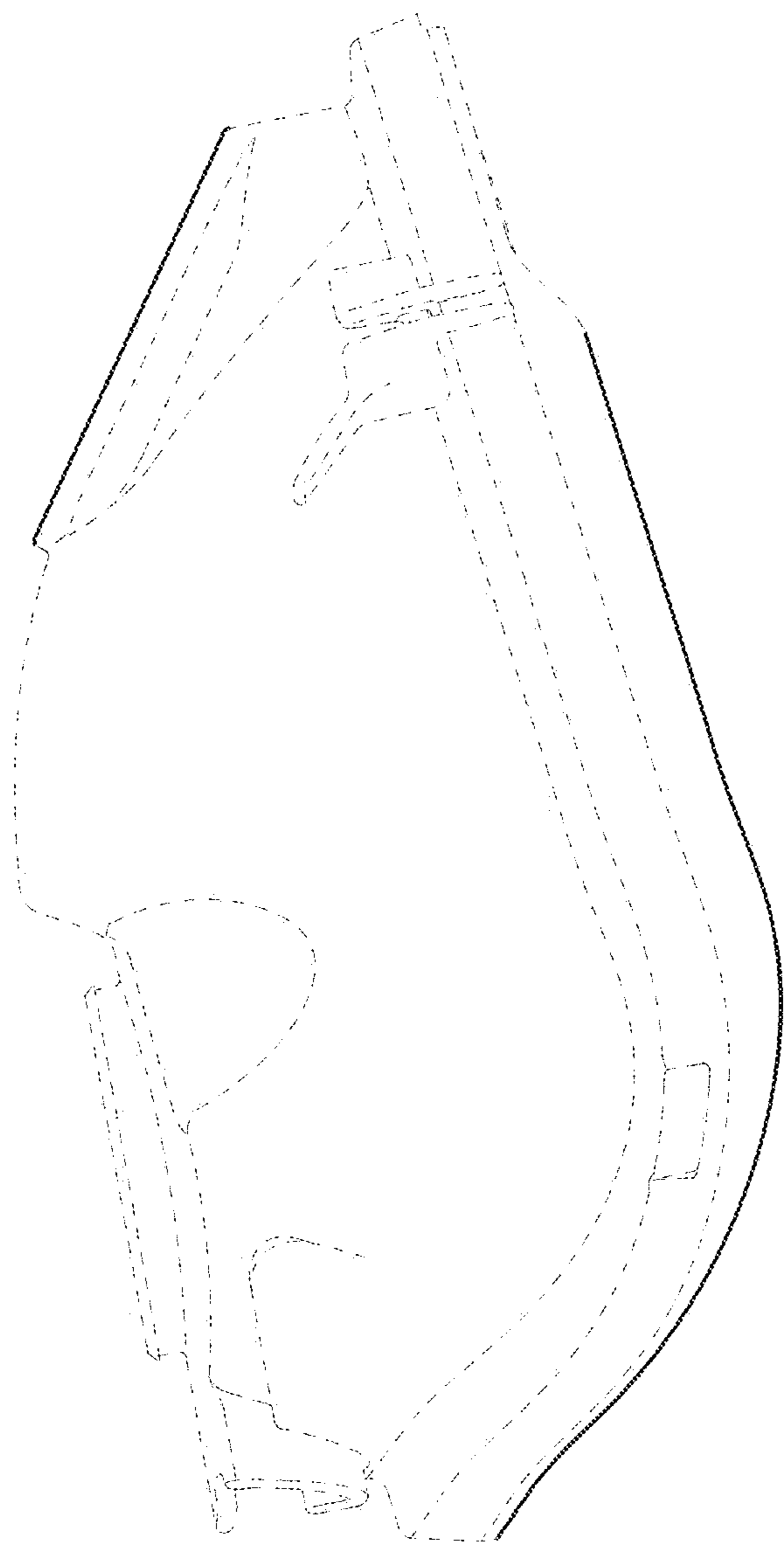

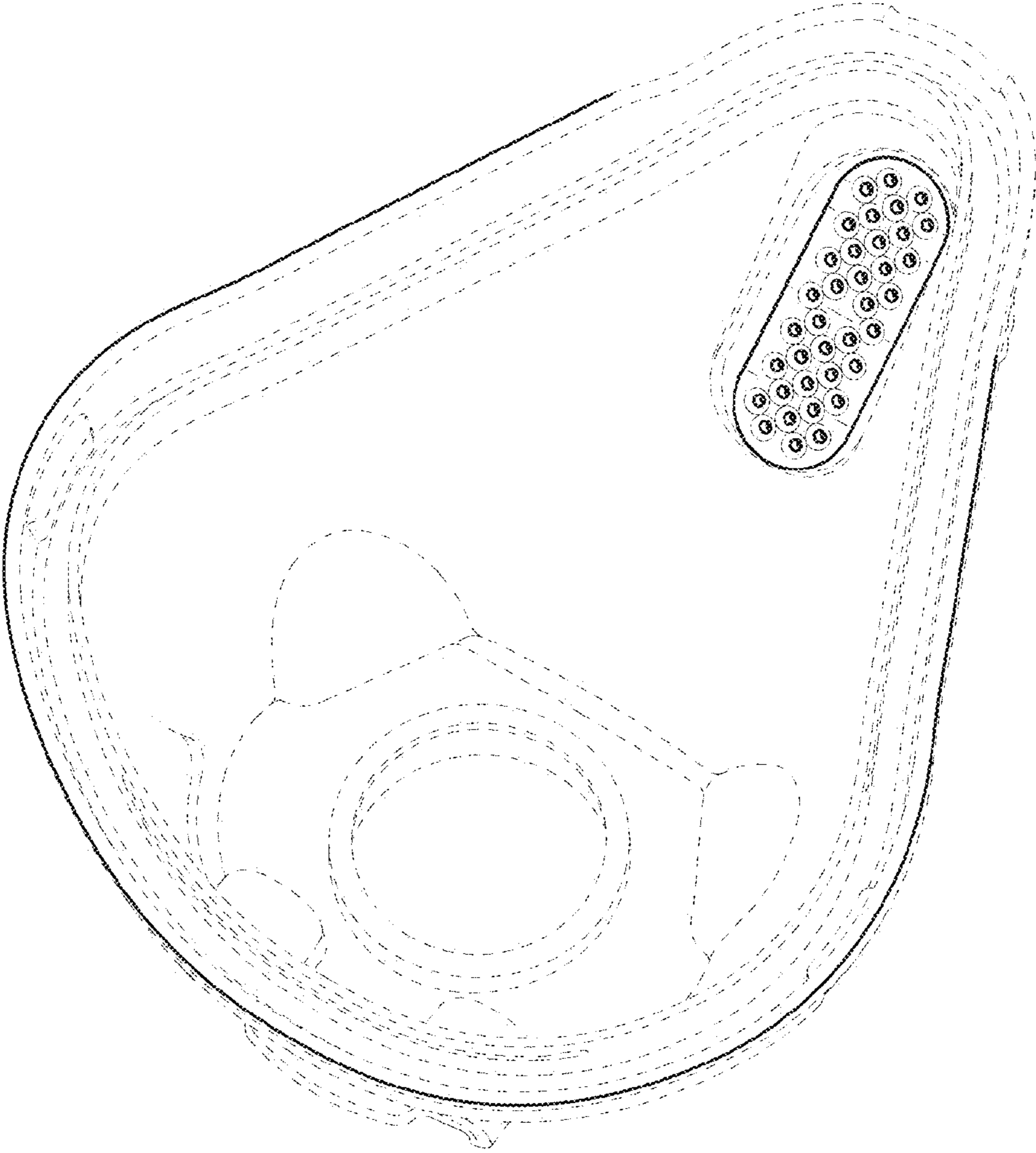
