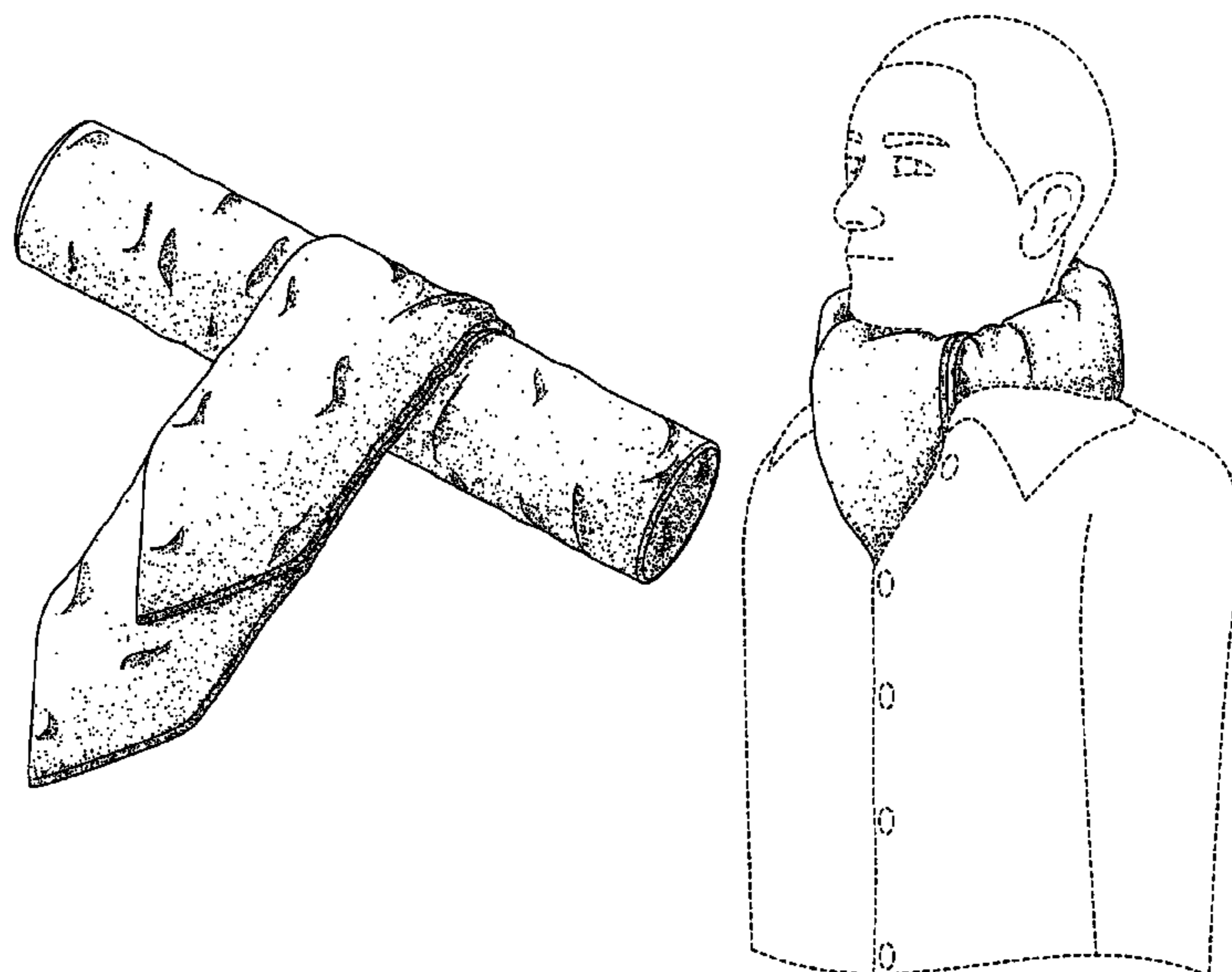
(57) **CLAIM**

The ornamental design for a cervical collar cover with ascot, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side, perspective view showing a new design for a cervical collar cover with ascot  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a top view thereof; and  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a front perspective view of the cervical collar cover with ascot as it would appear with a cervical collar inserted therein and being worn.  
The broken lines showing a person in FIG. 8 illustrate environmental structure and form no part of the claimed design.

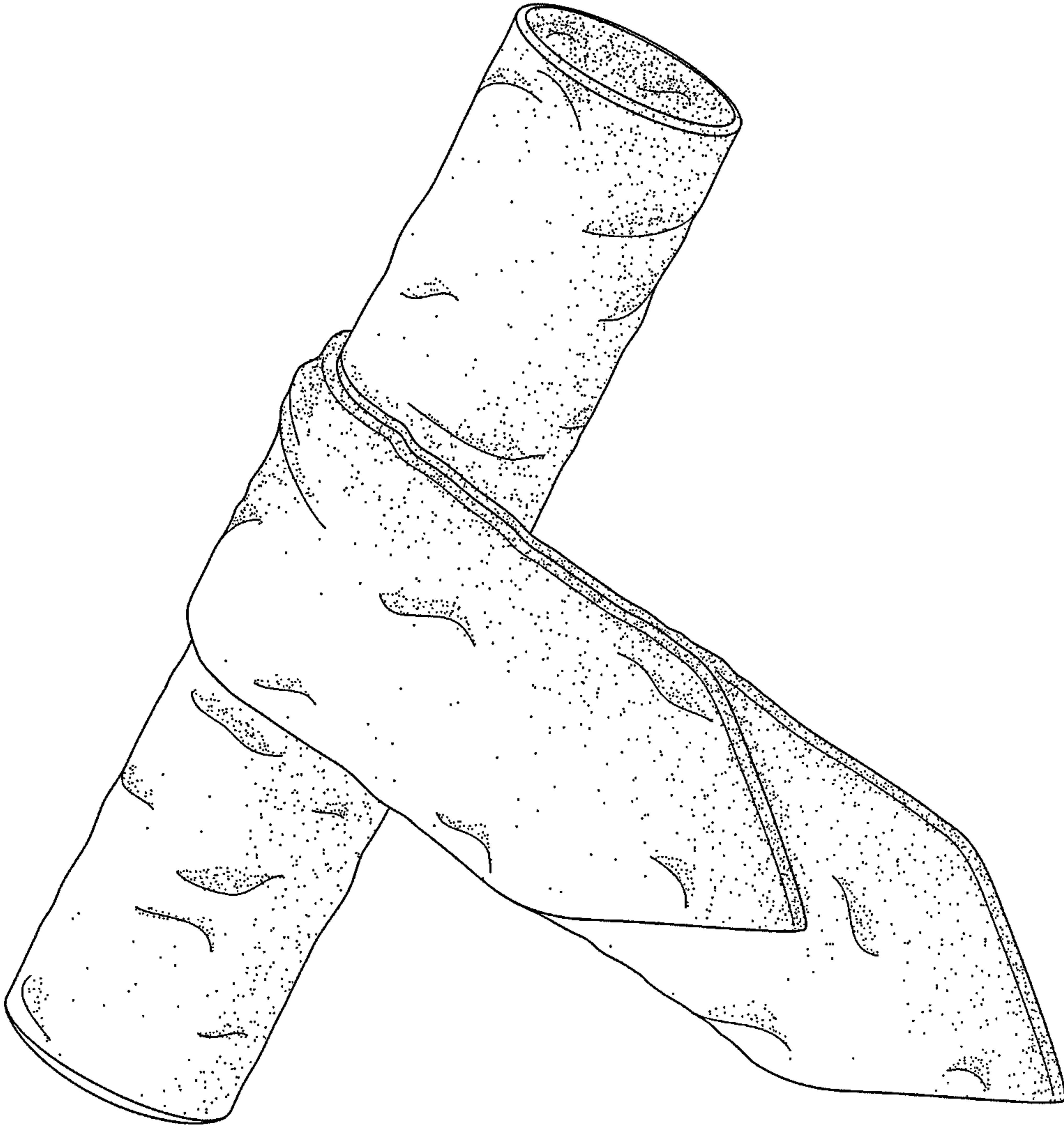

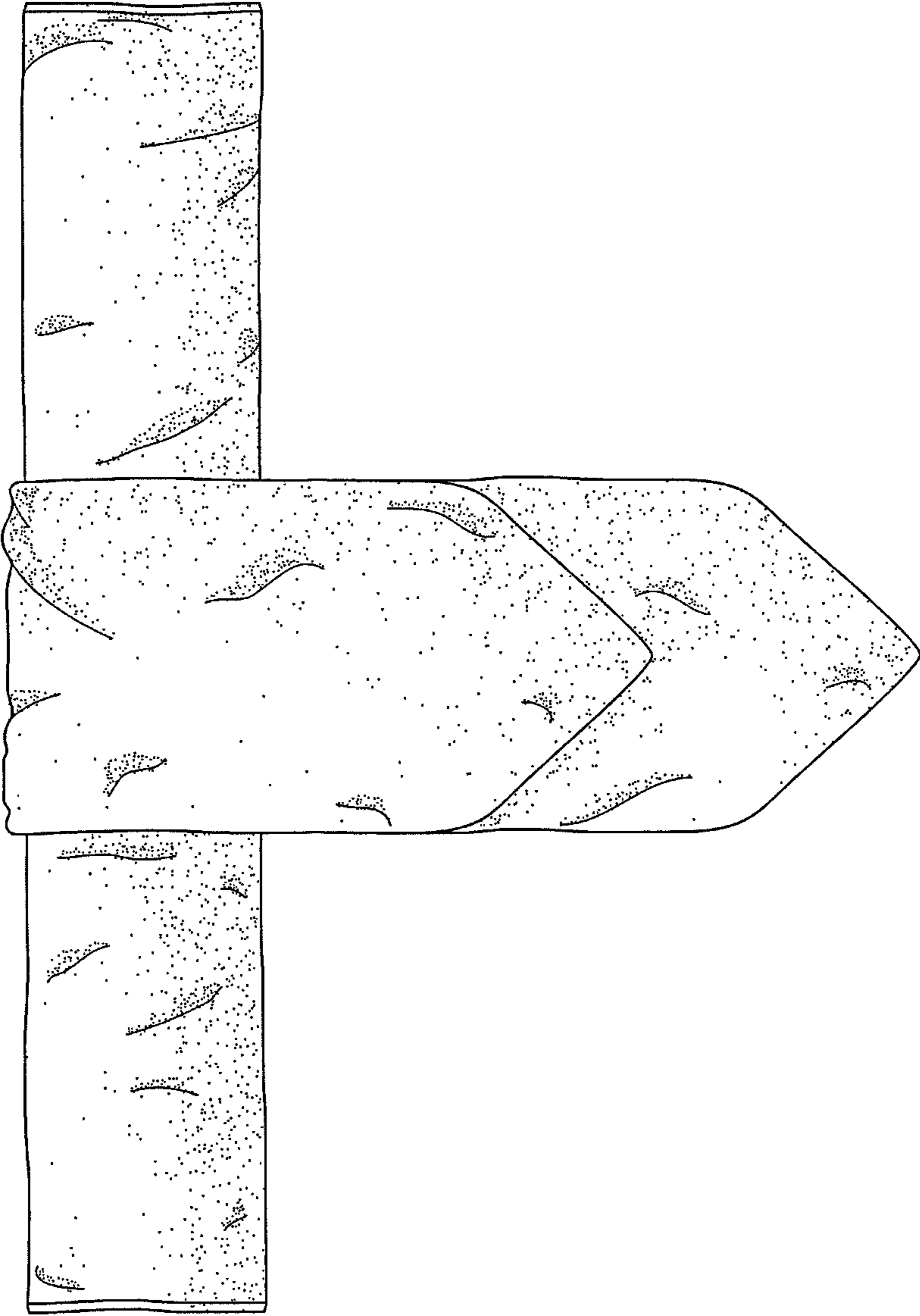

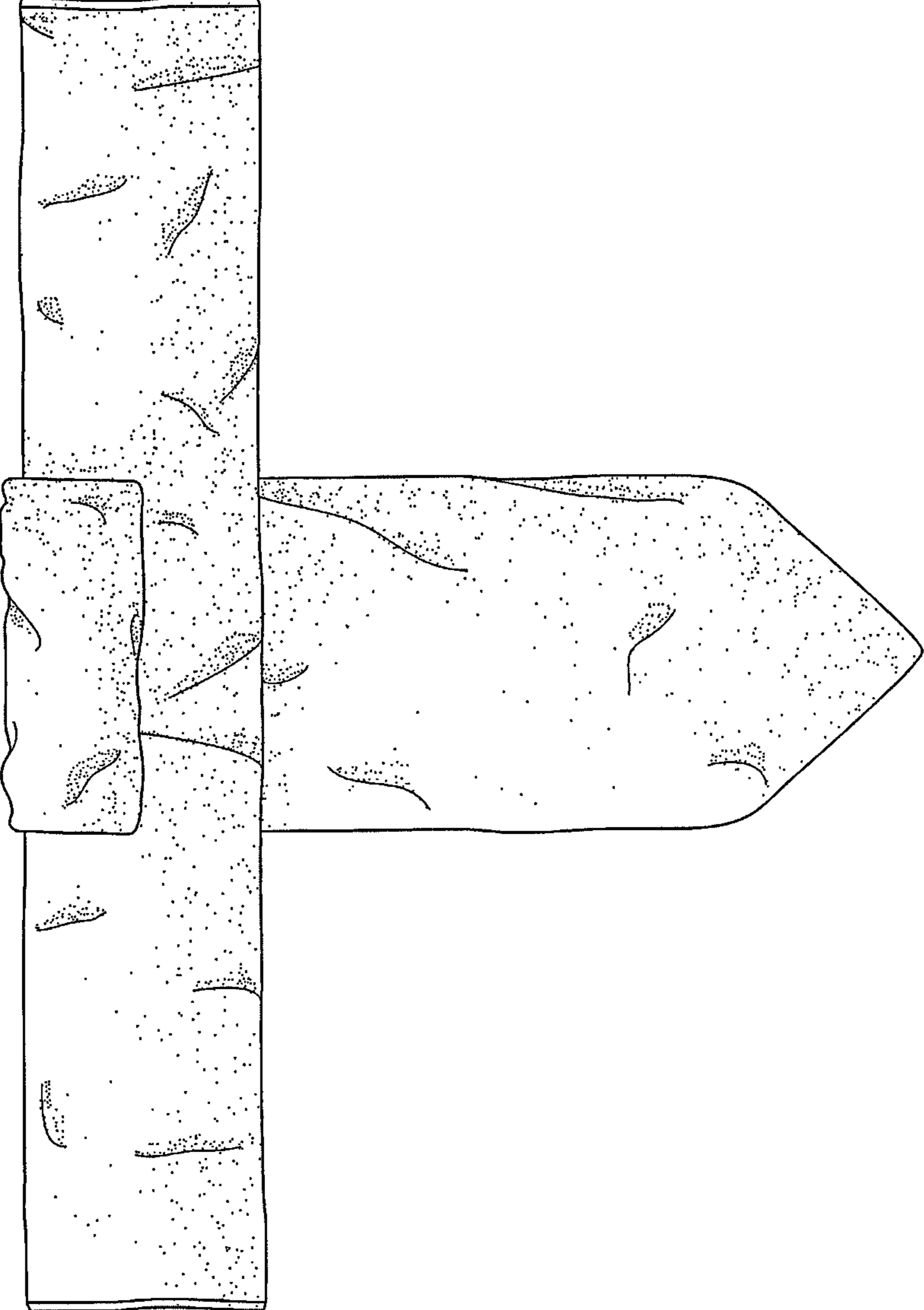

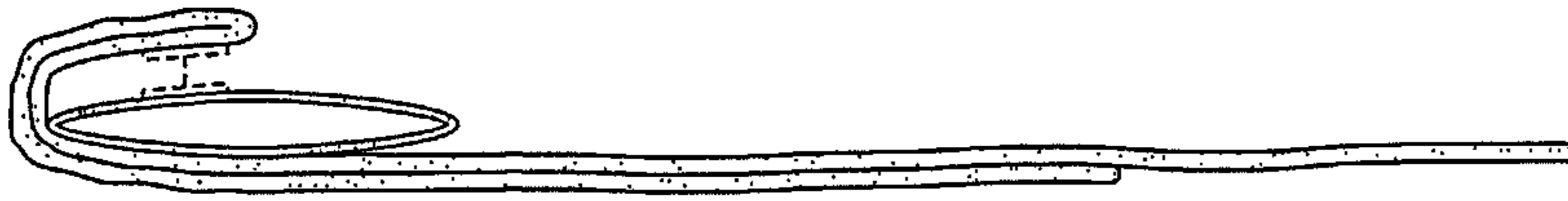

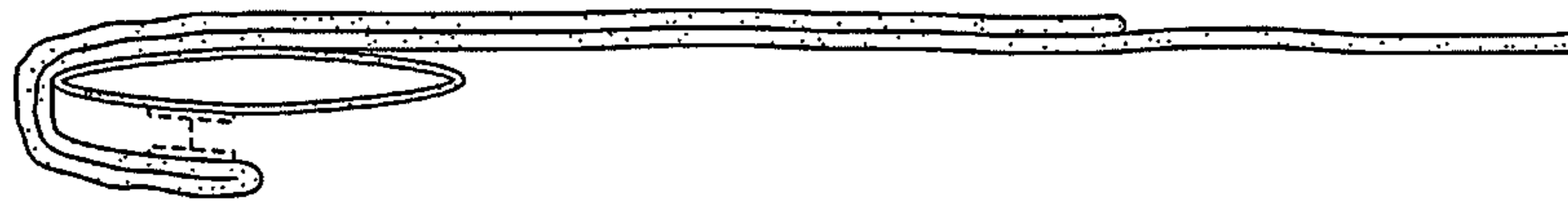

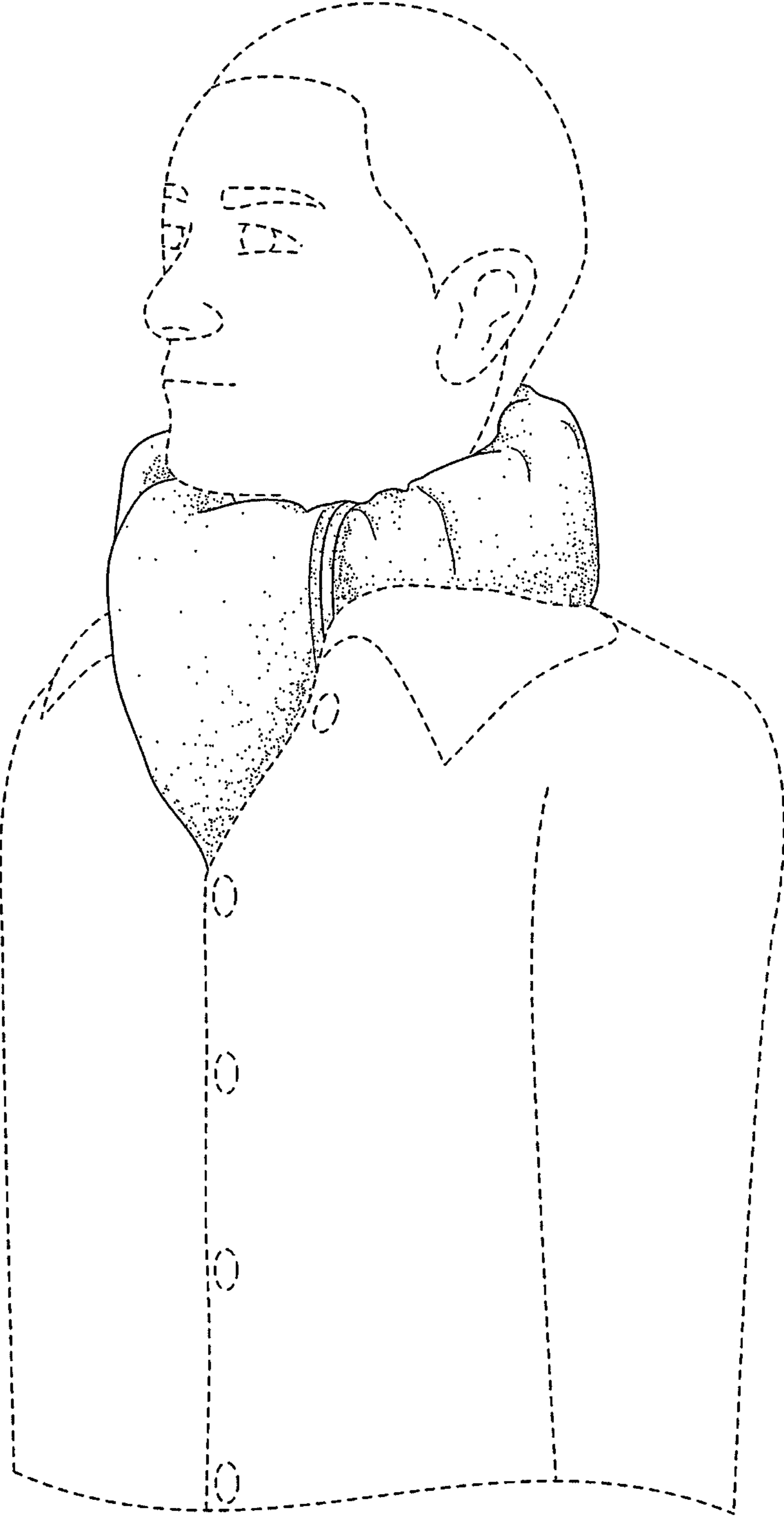
