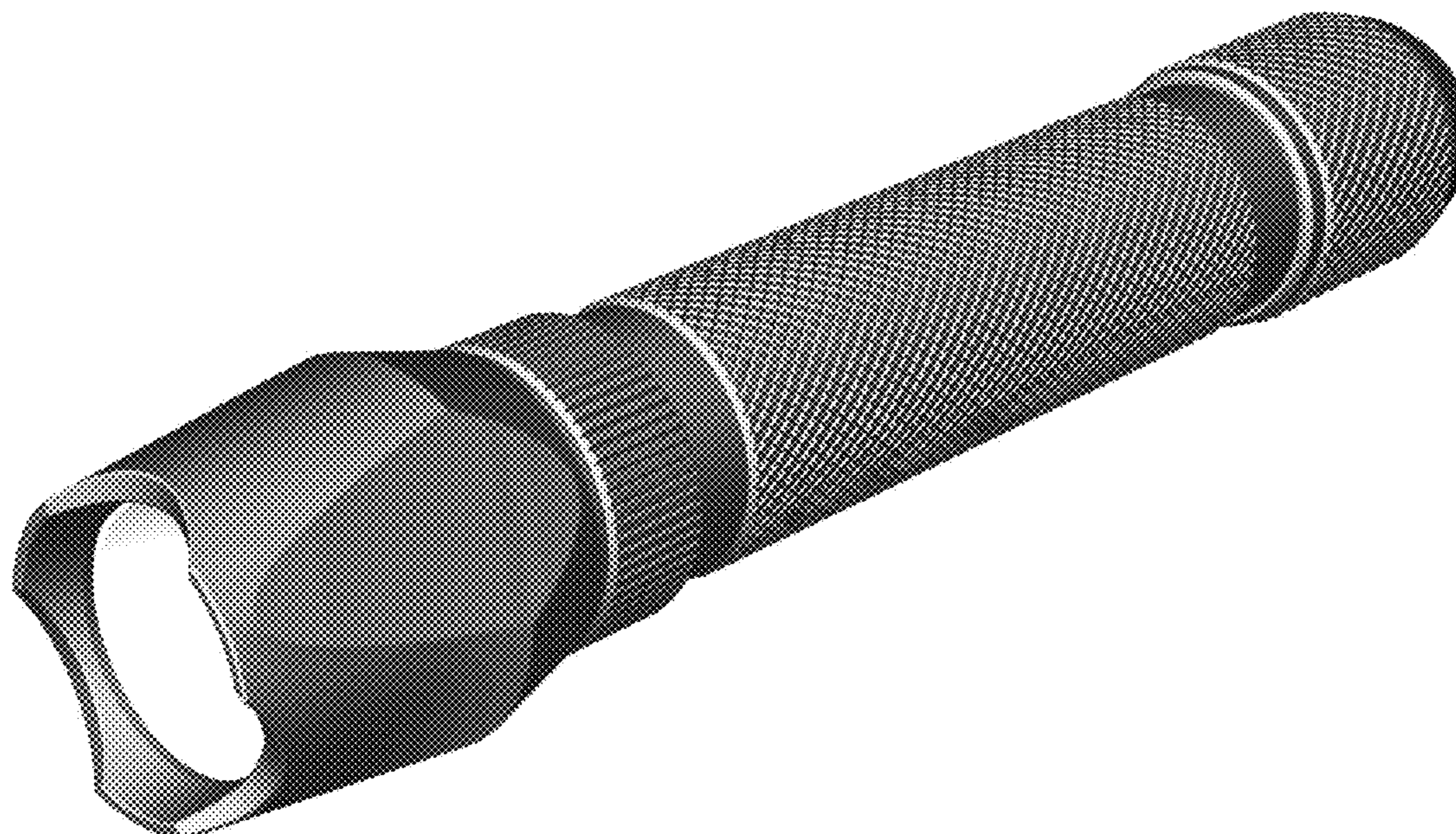
(57) **CLAIM**

The ornamental design for a “flashlight,” as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged front view of a flashlight showing my new design;  
FIG. 2 is an enlarged rear view thereof;  
FIG. 3 is a side view thereof;  
FIG. 4 is a further side view thereof with a partial right axial rotation as compared to FIG. 3;  
FIG. 5 is a side view thereof axially rotated 180° from the view illustrated in FIG. 3;  
FIG. 6 is a front perspective thereof; and,  
FIG. 7 is a rear perspective view thereof.  
The broken line showing is for environmental purposes only and forms no part of the claimed design.

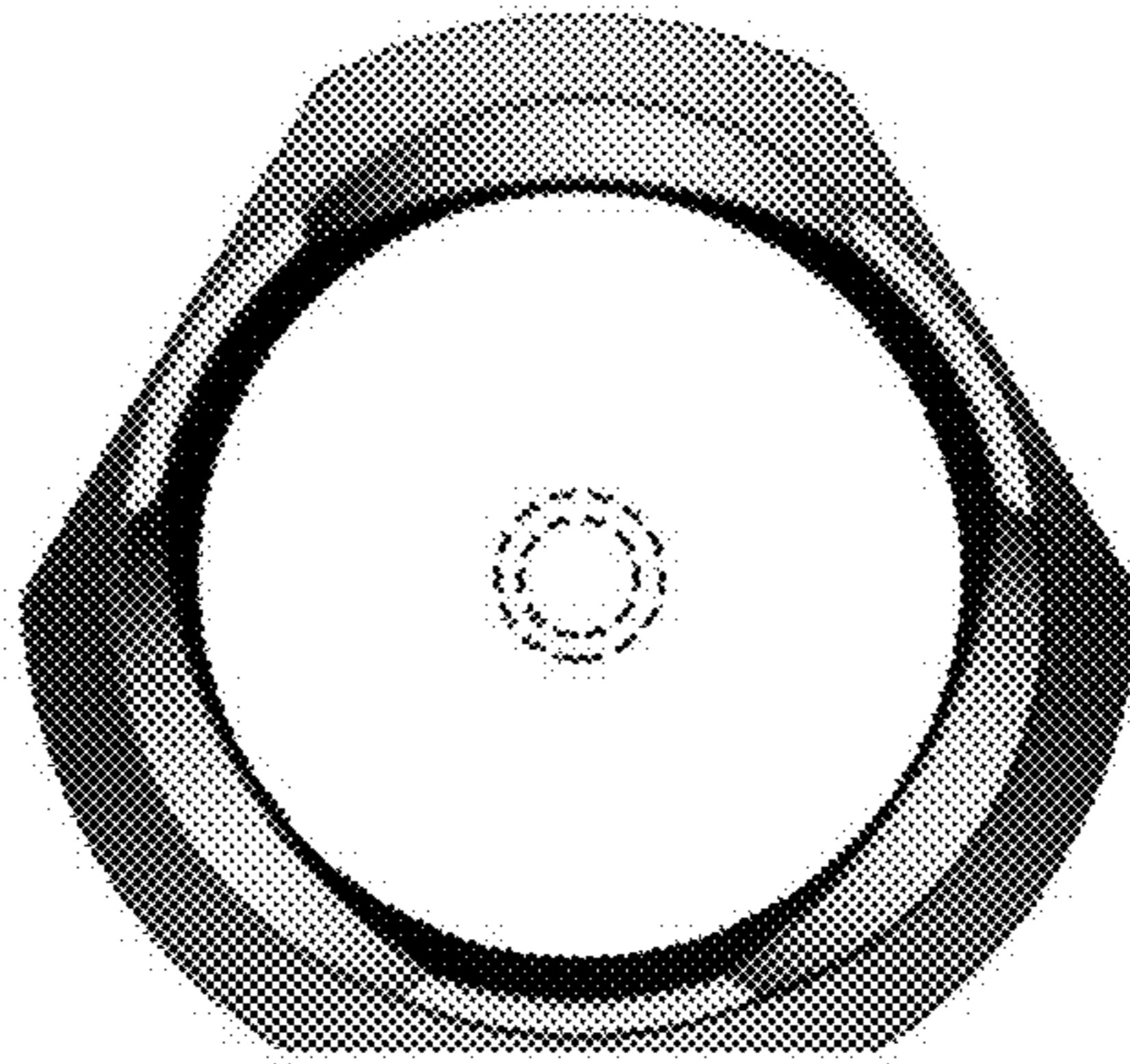

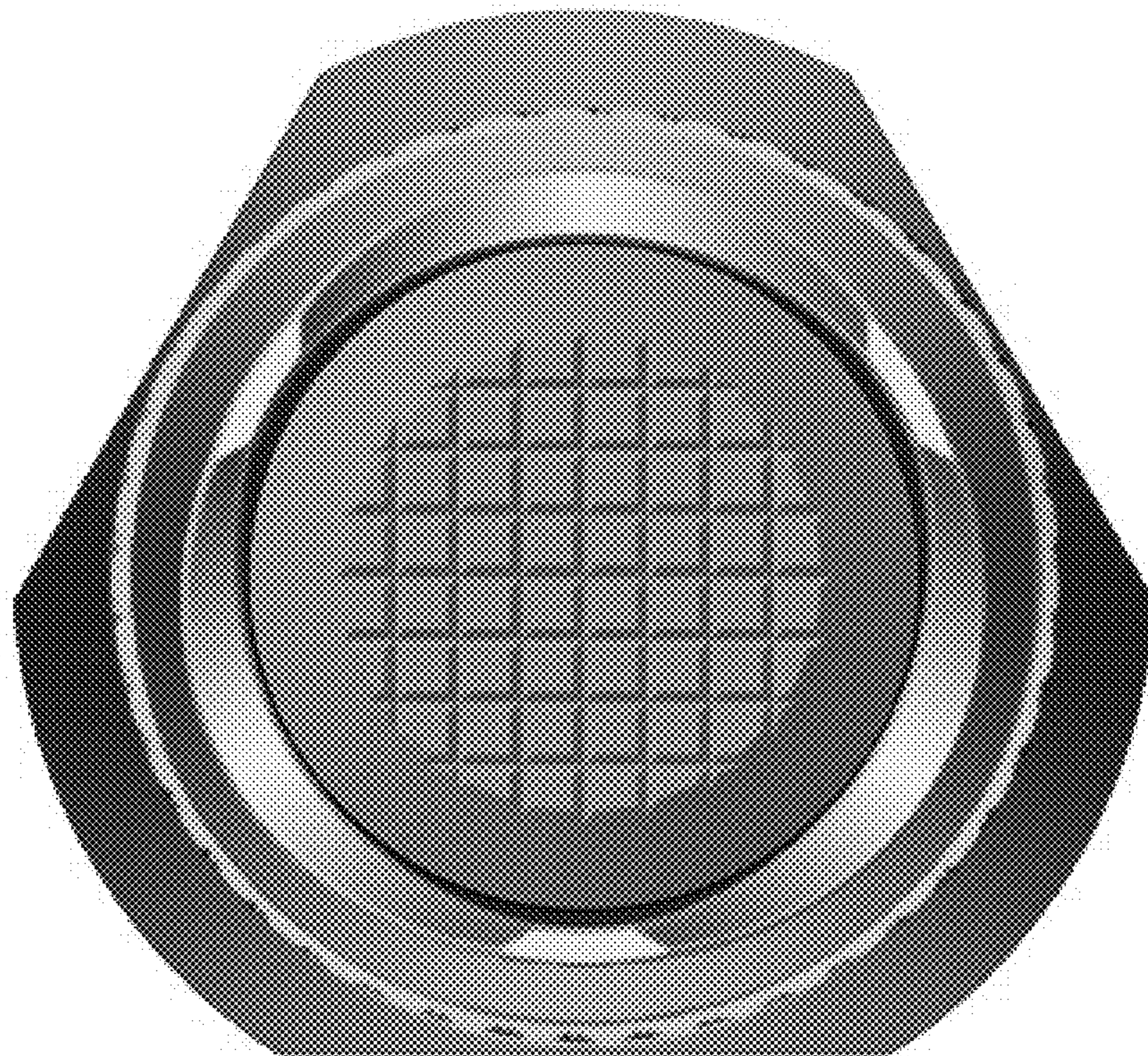

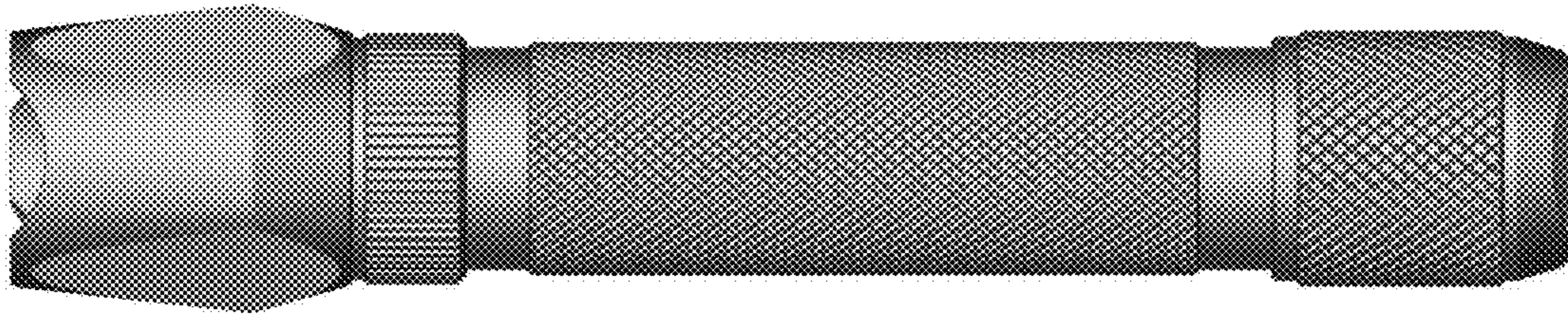

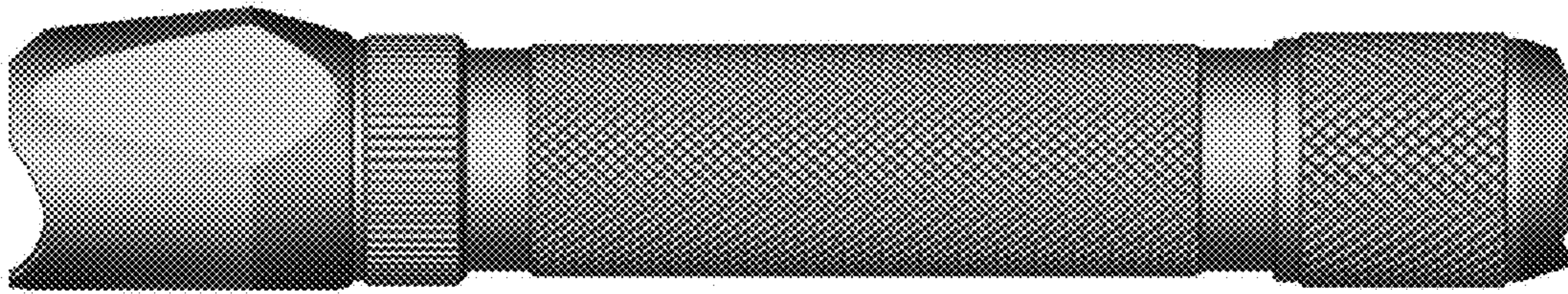

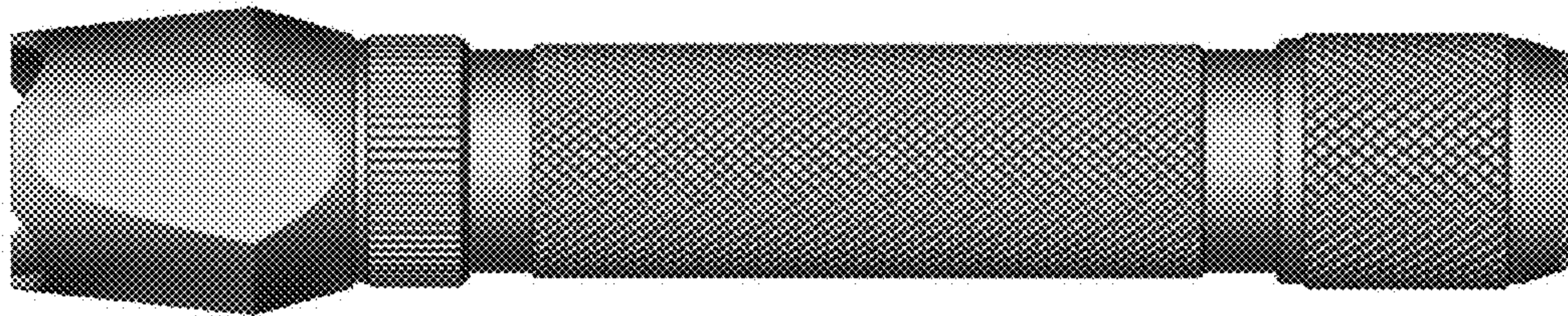

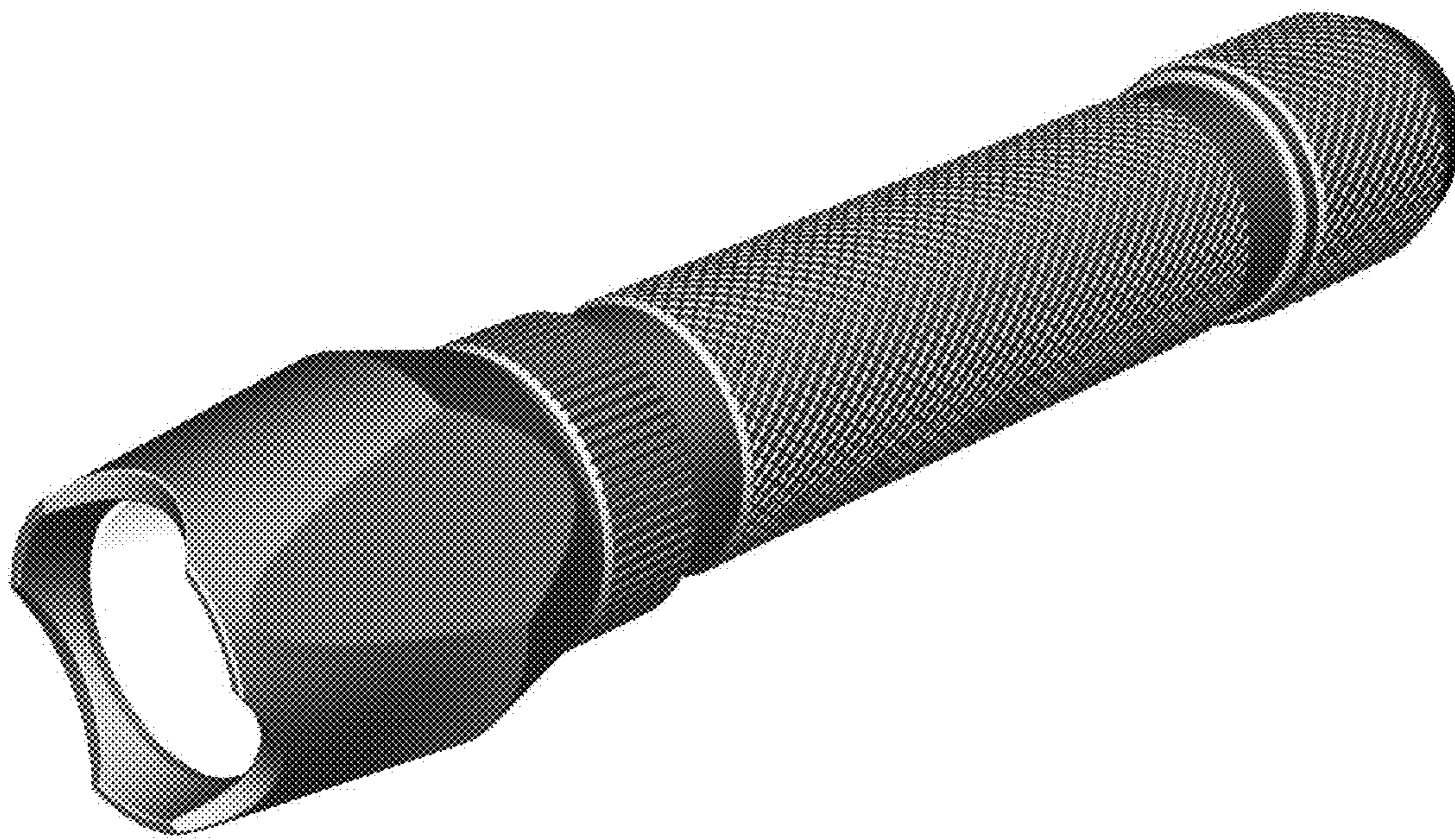

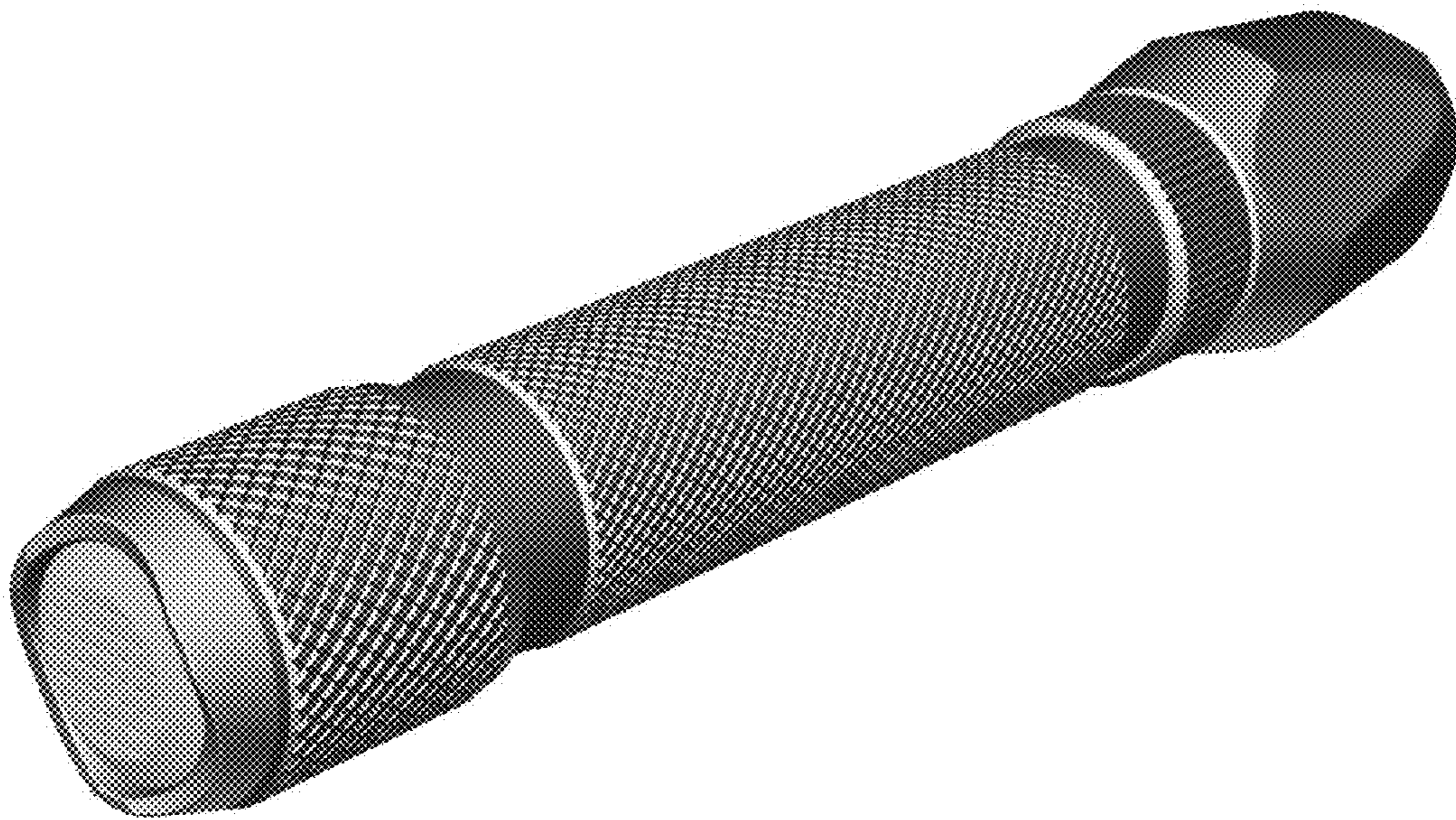
