The ornamental design for an illuminating bottle light, as shown and described.

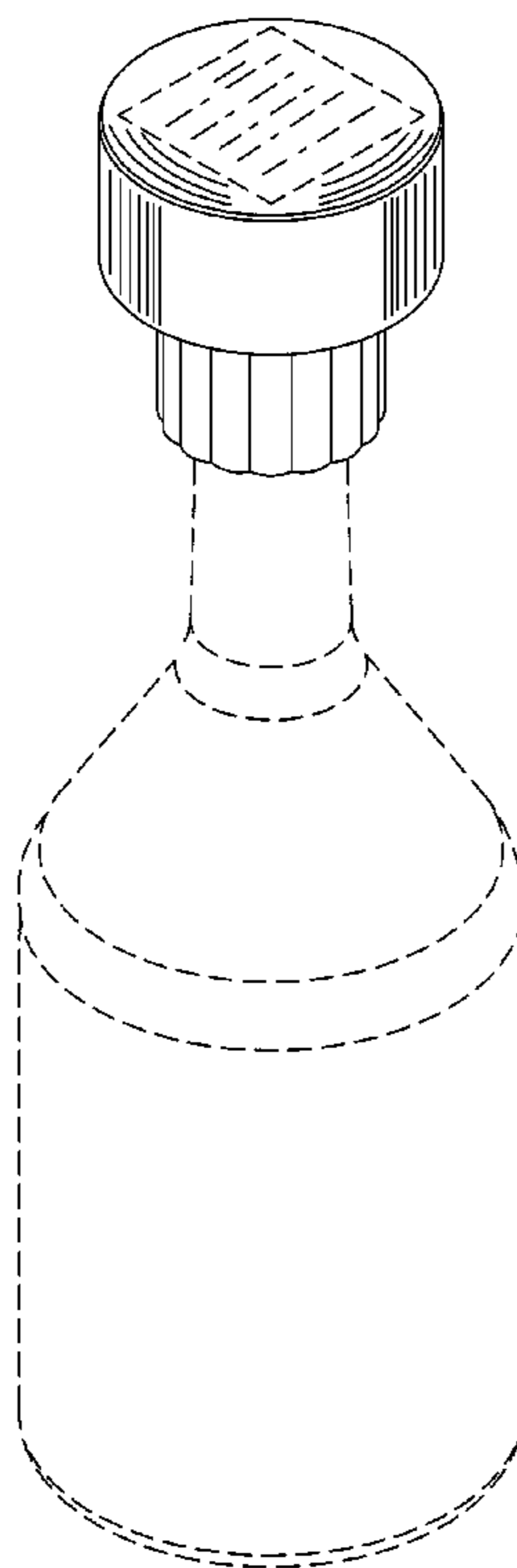
DESCRIPTION

FIG. 1 is a perspective view showing my new design;

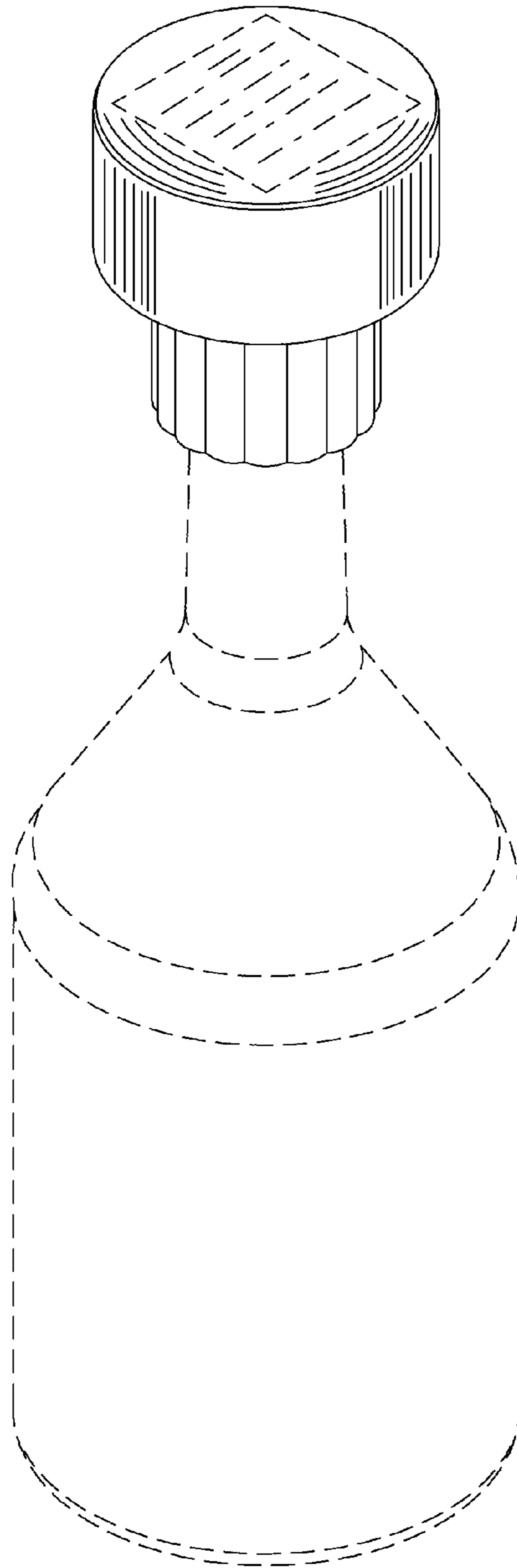

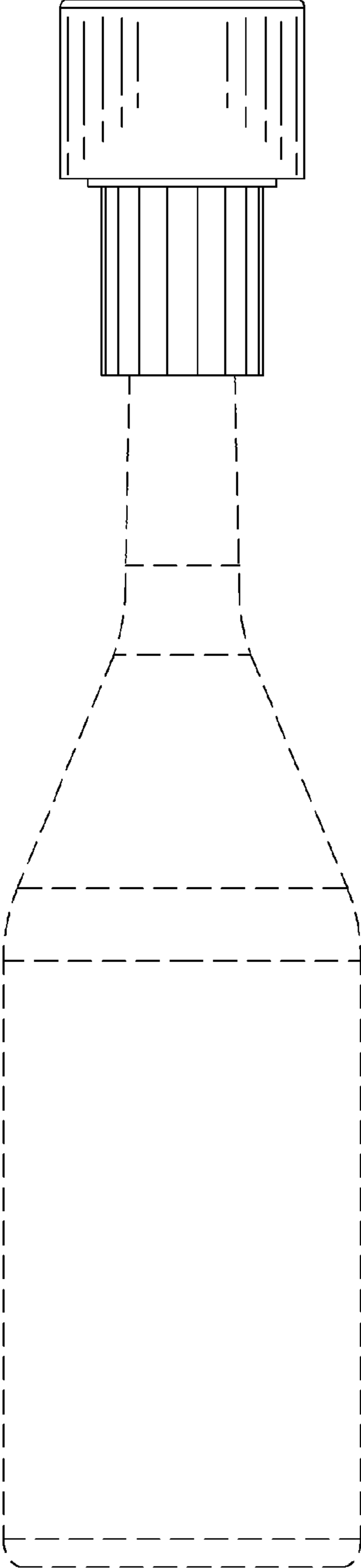

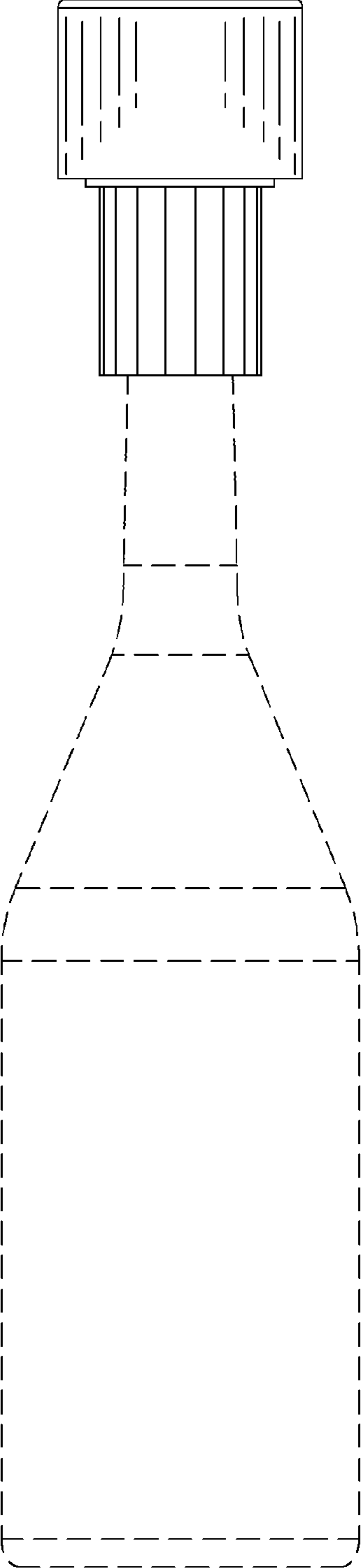

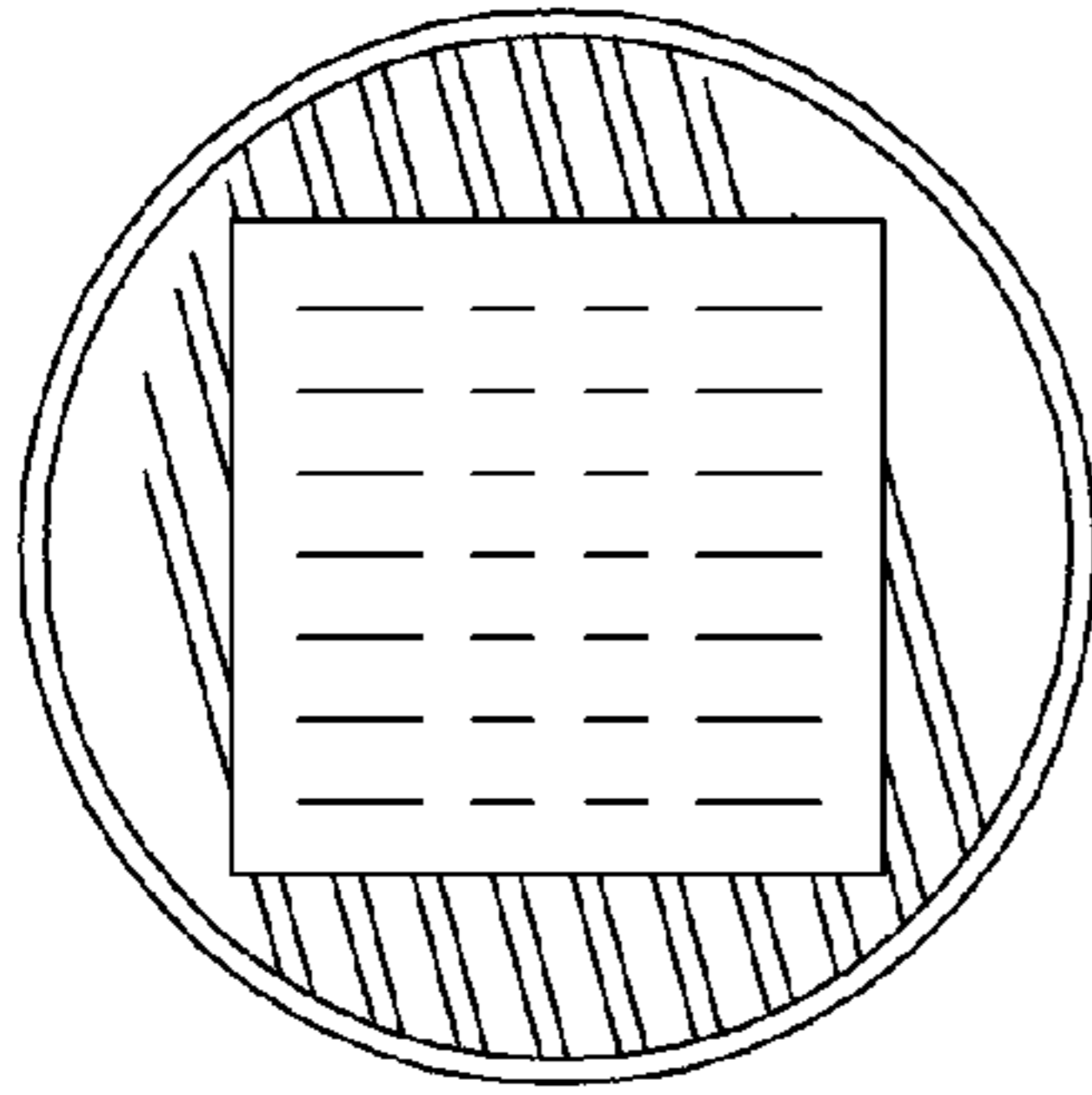

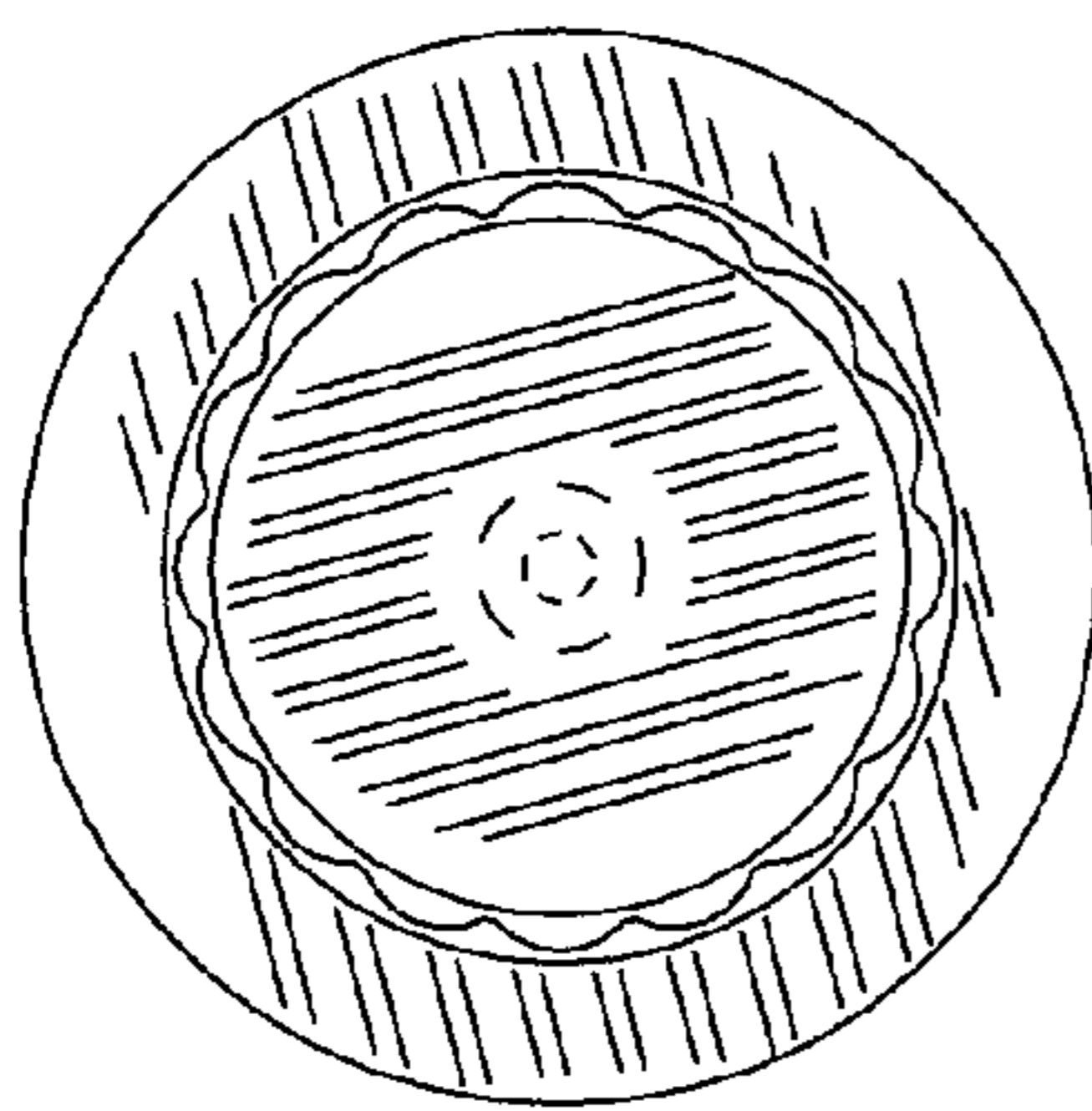

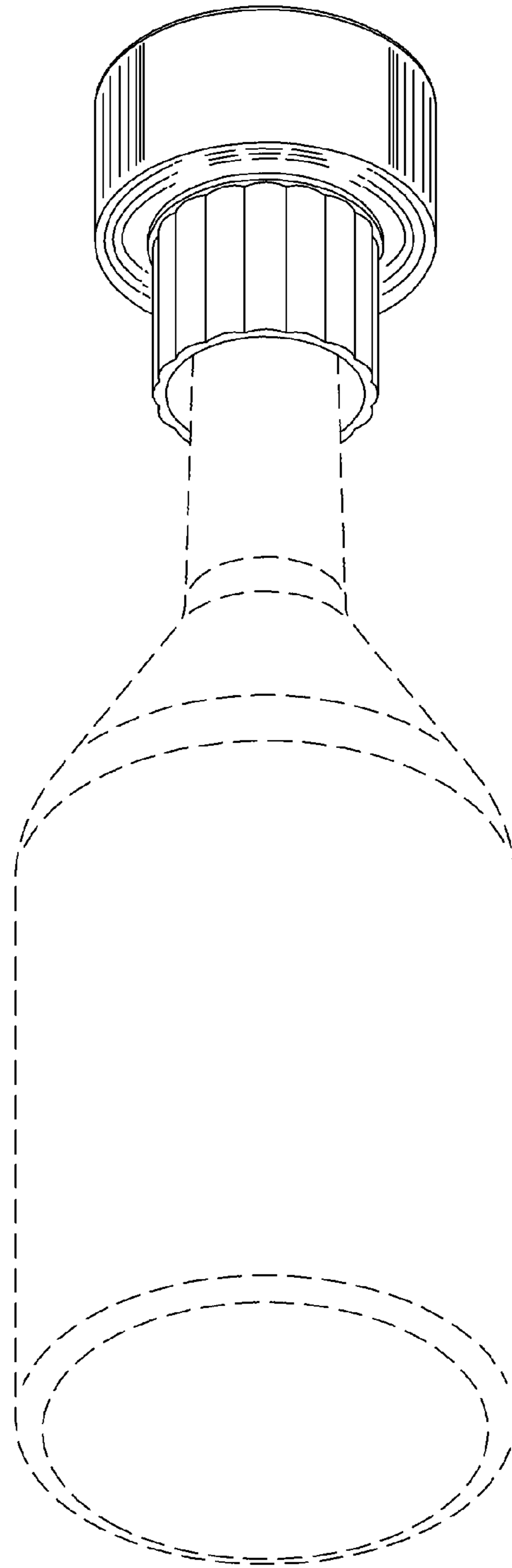
