(57) **CLAIM**

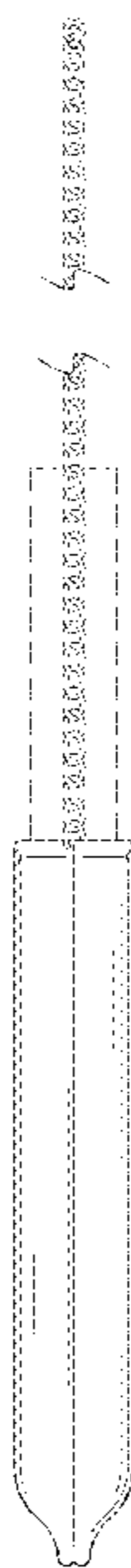
The ornamental design for an electronic vapor cigarette holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an electronic vapor cigarette holder showing the claimed design in use; FIG. 2 is a side elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a top plan view thereof.

The ornamental design which is claimed is shown in solid lines in the drawings. The break lines indicate any portion of the article beyond what is shown forms no part of the claimed design, and the broken lines of the drawings depict environmental subject matter and form no part of the claimed design.

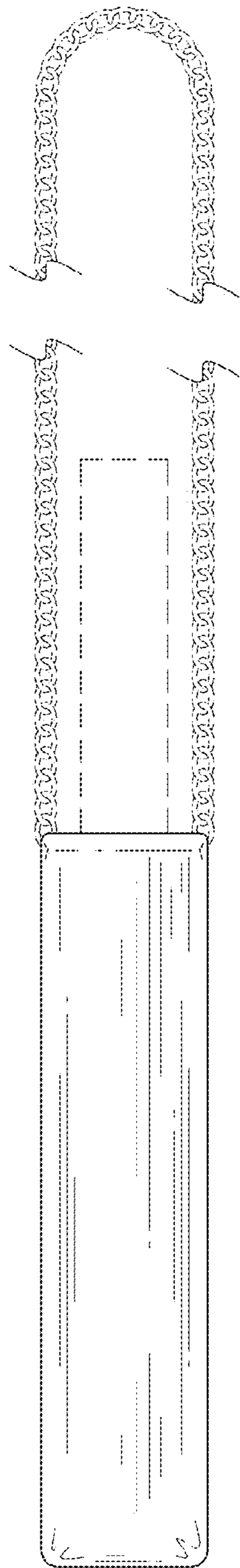

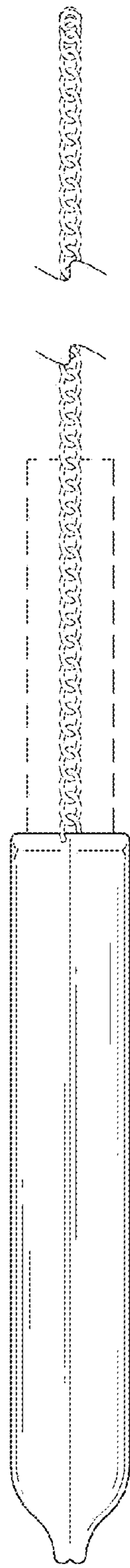

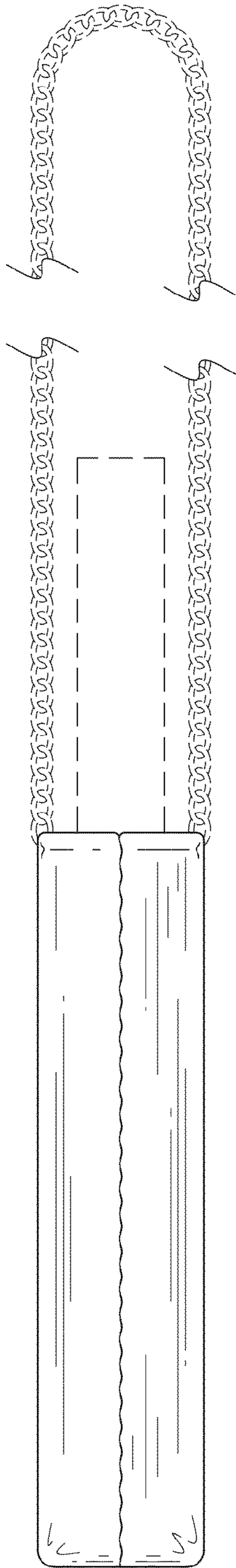

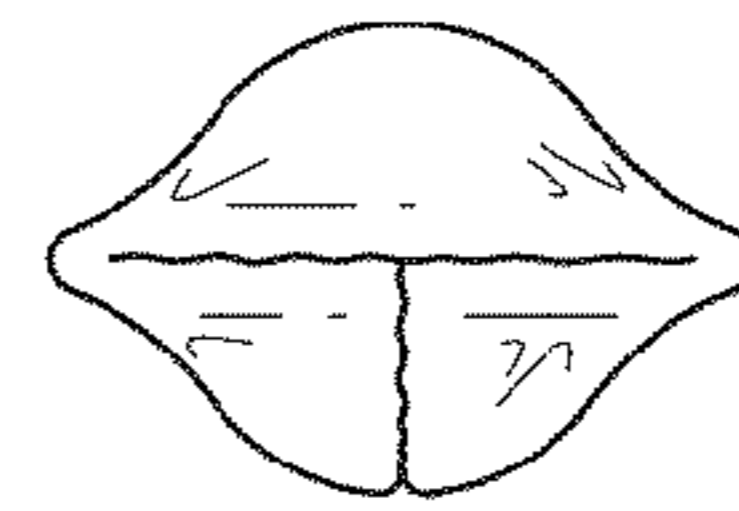

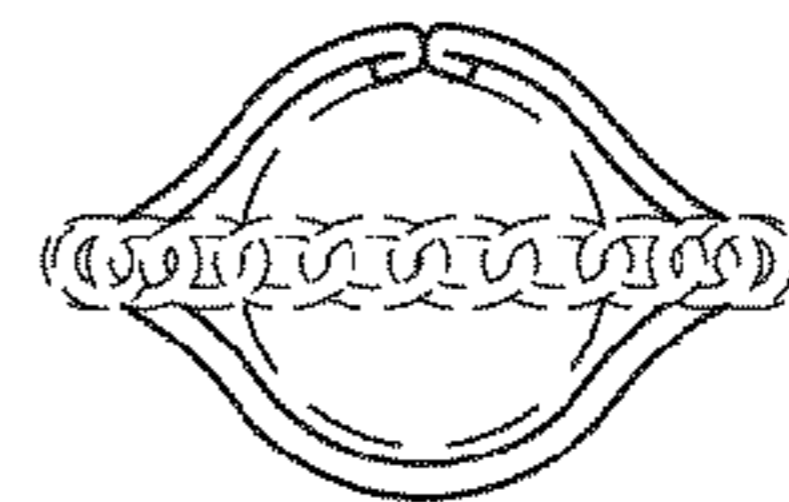
