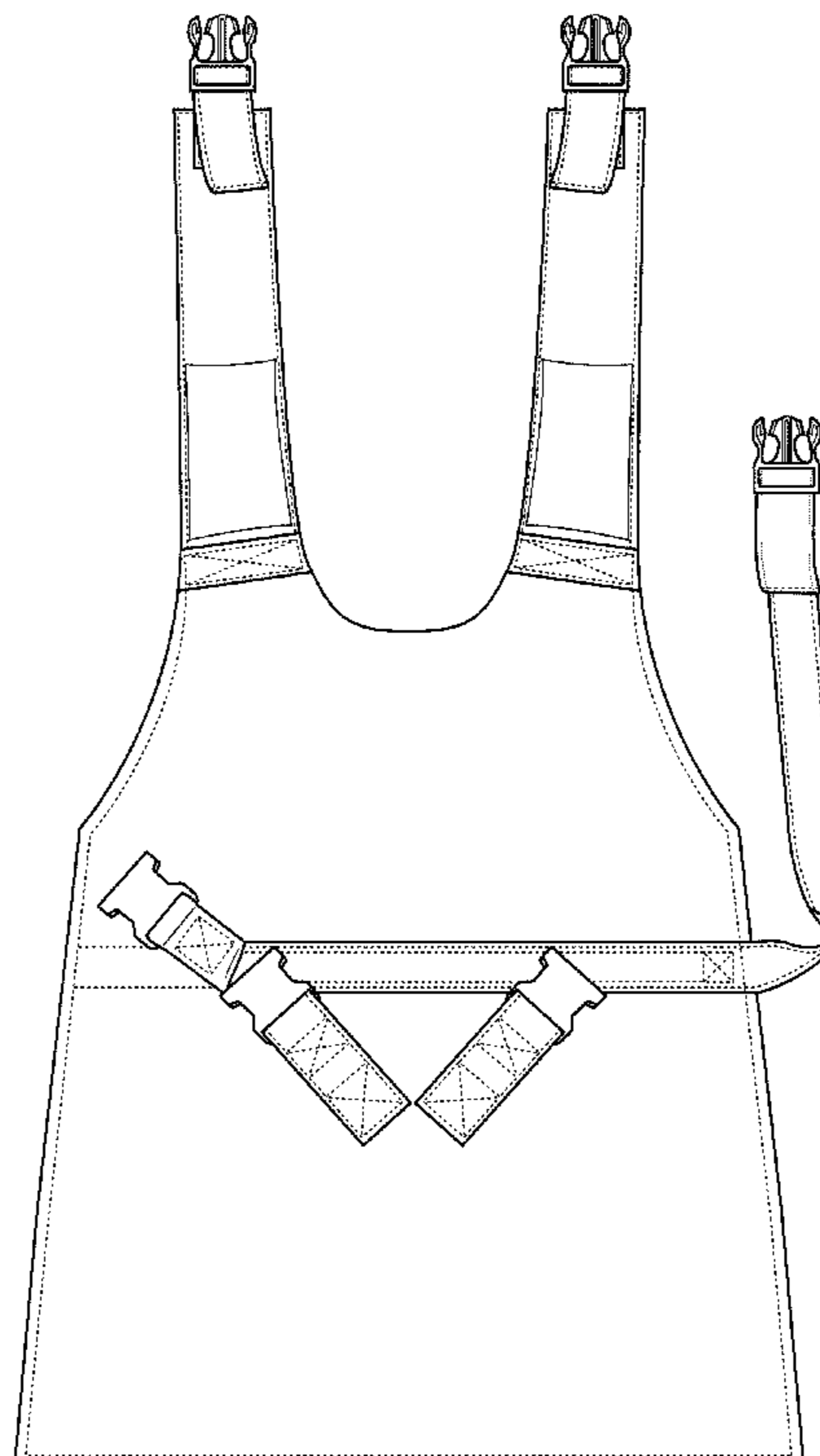
(57) **CLAIM**

The ornamental design for a protective vest, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a protective vest showing the new design;

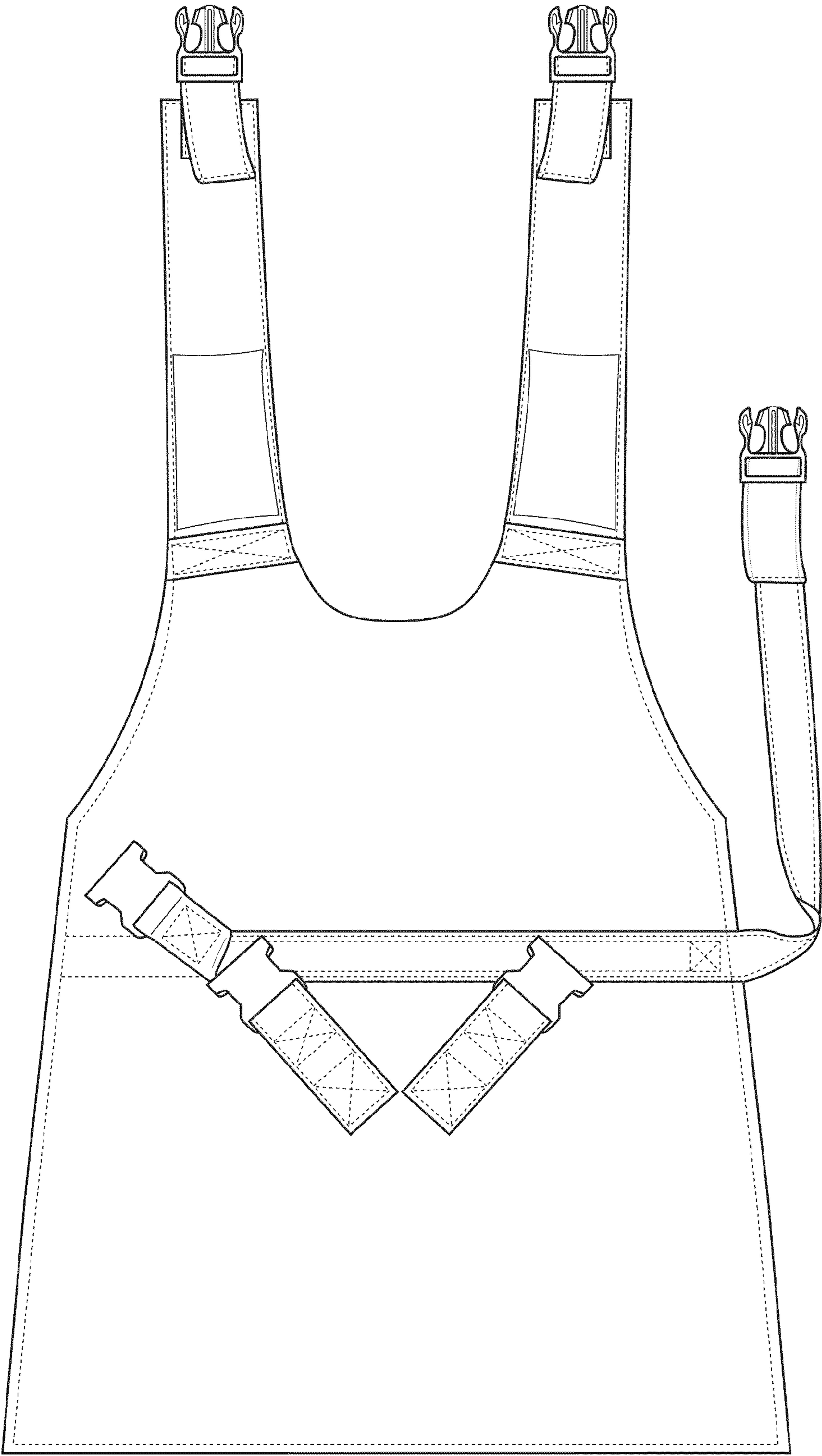

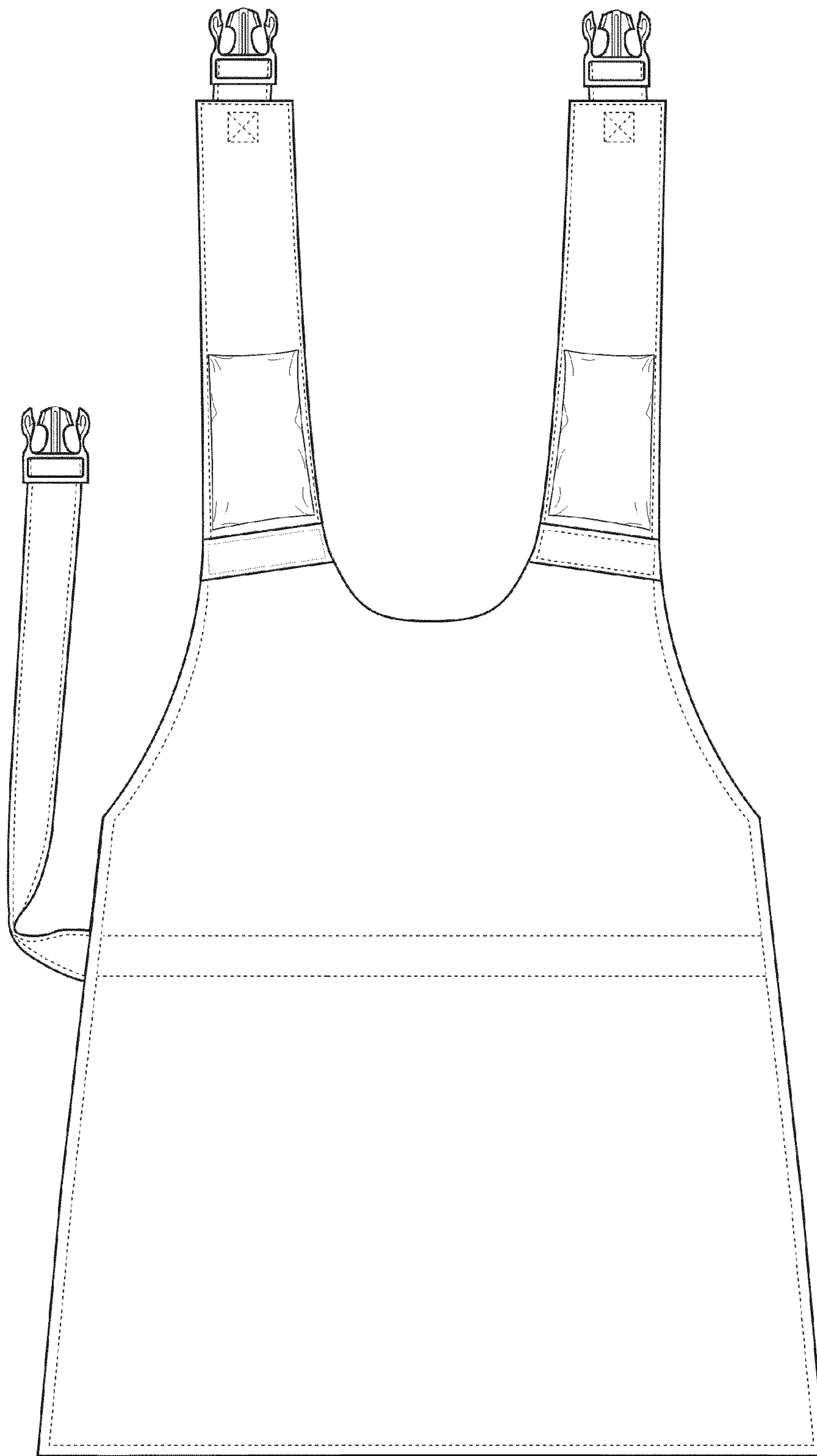

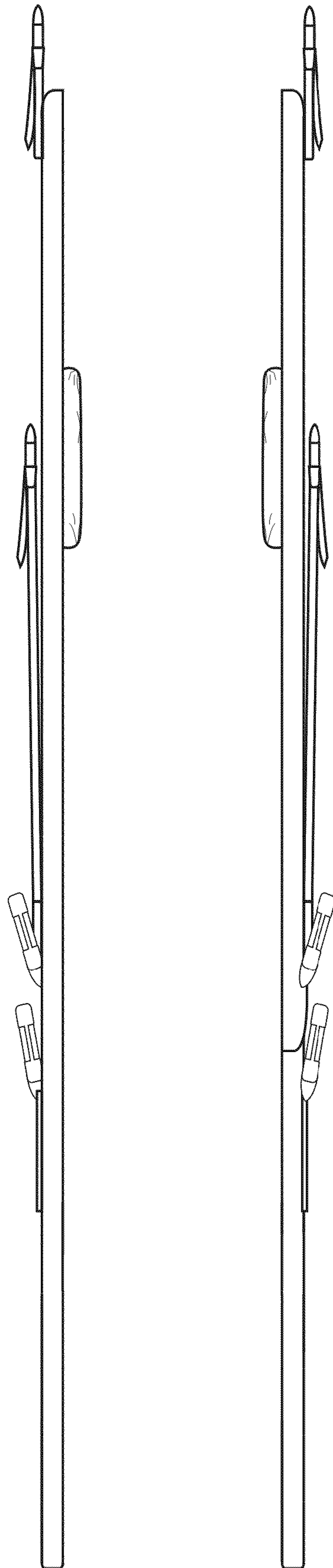

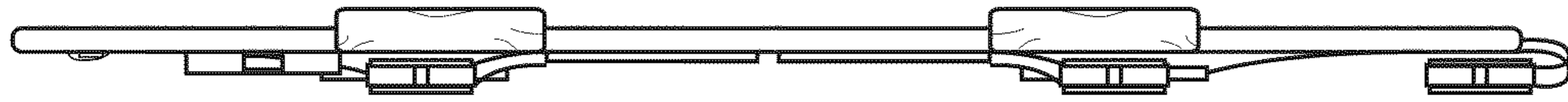

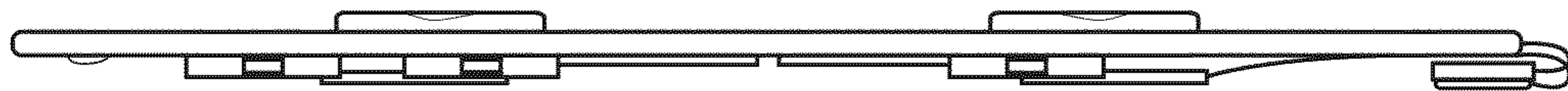

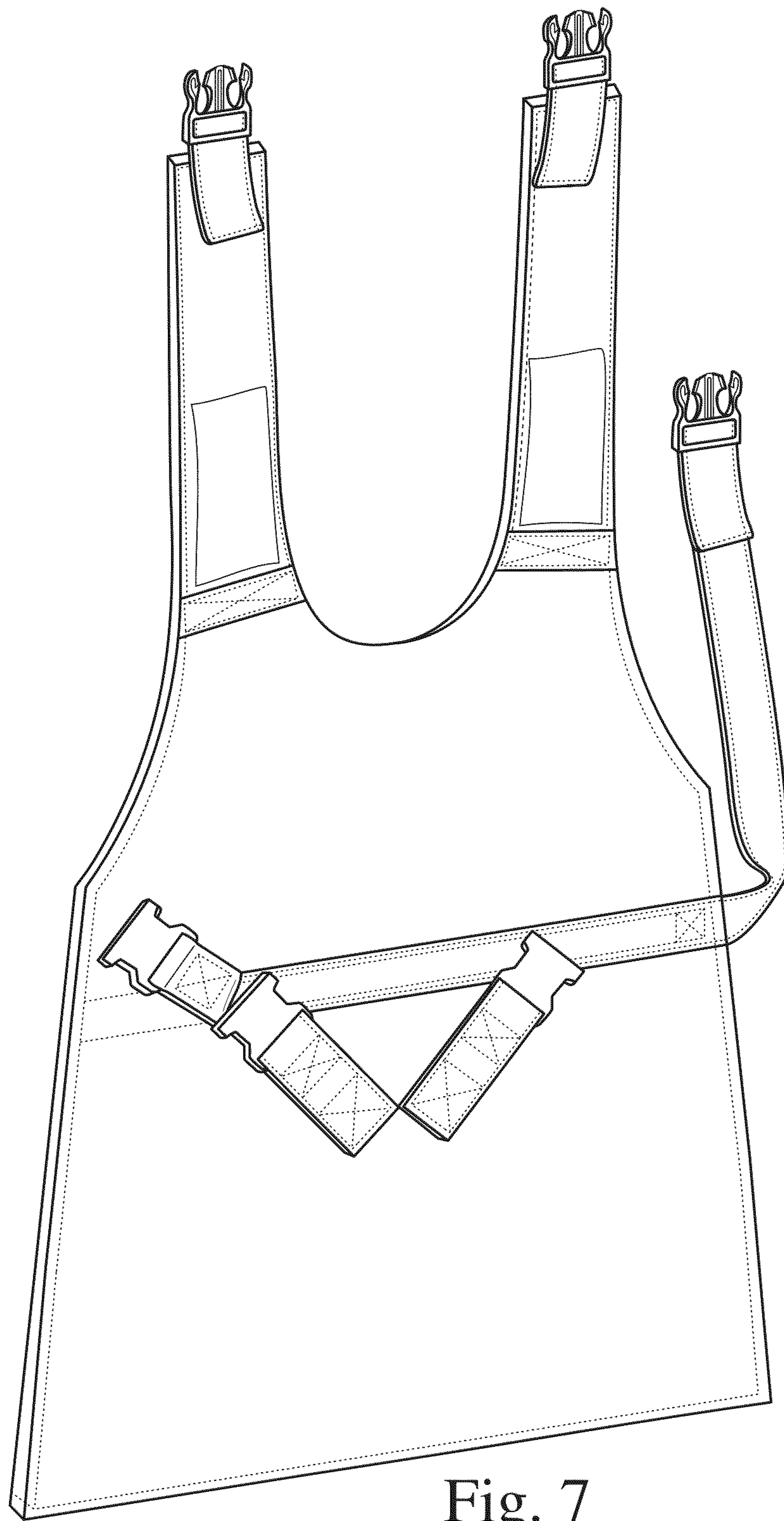

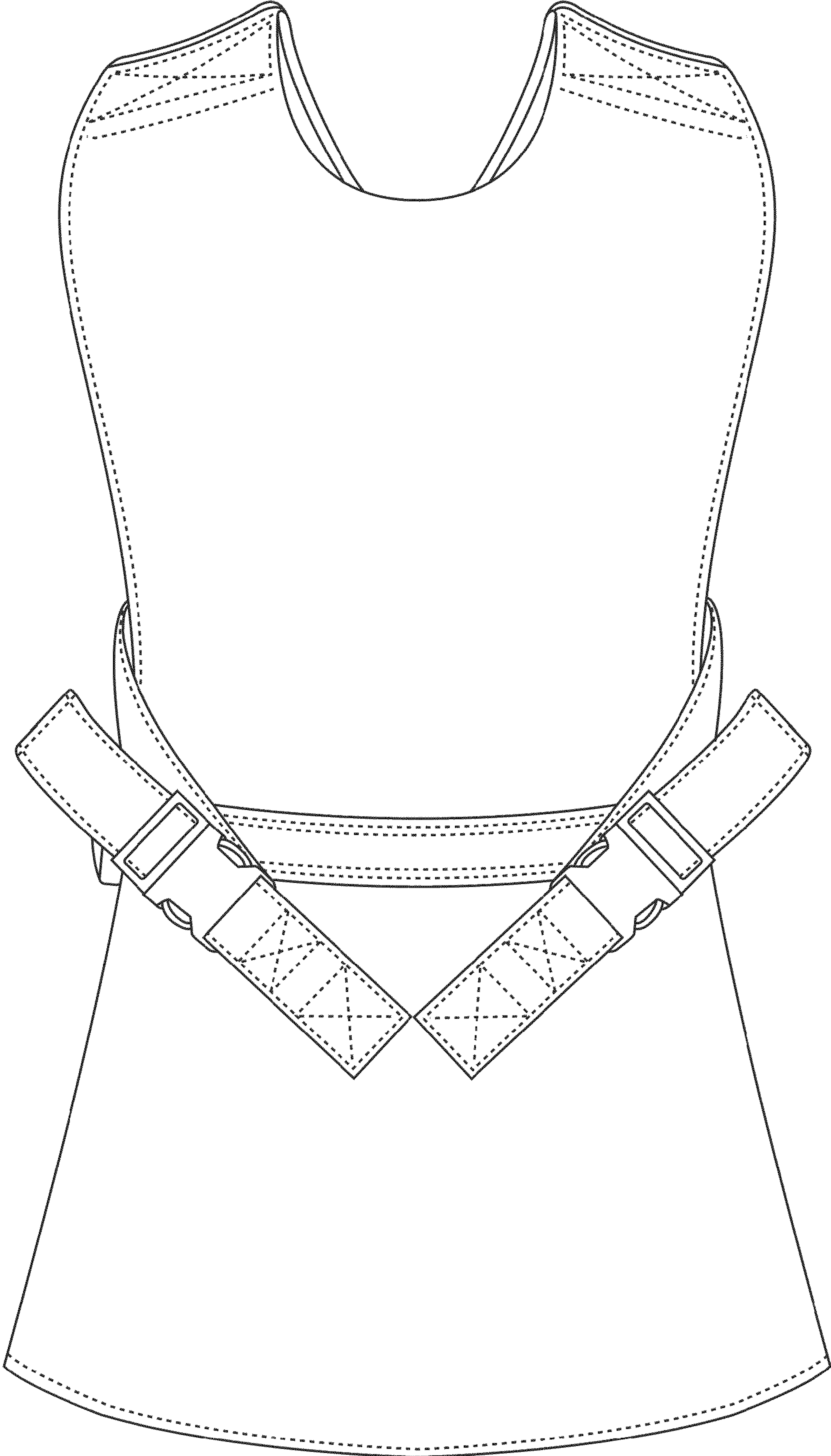

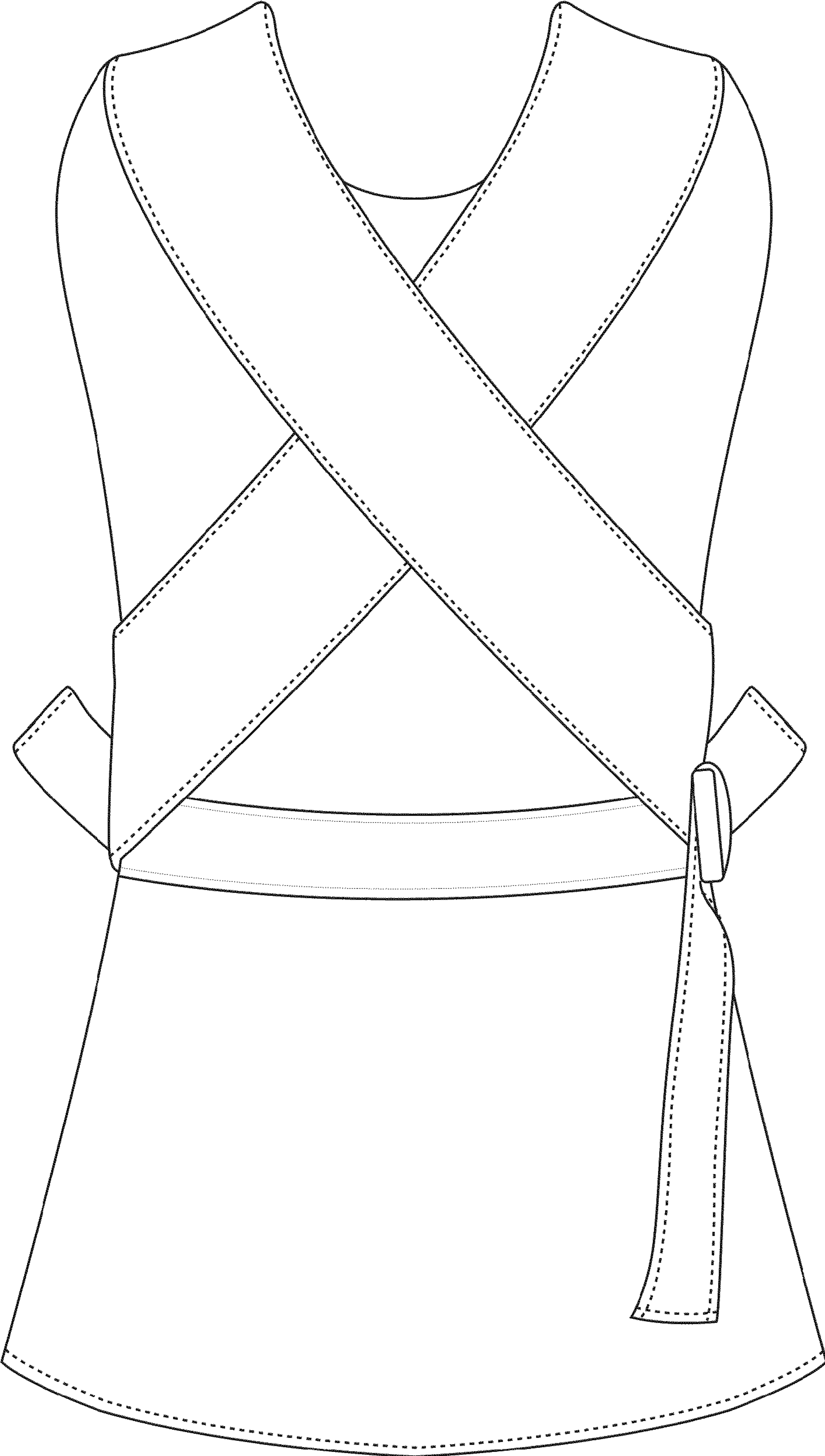

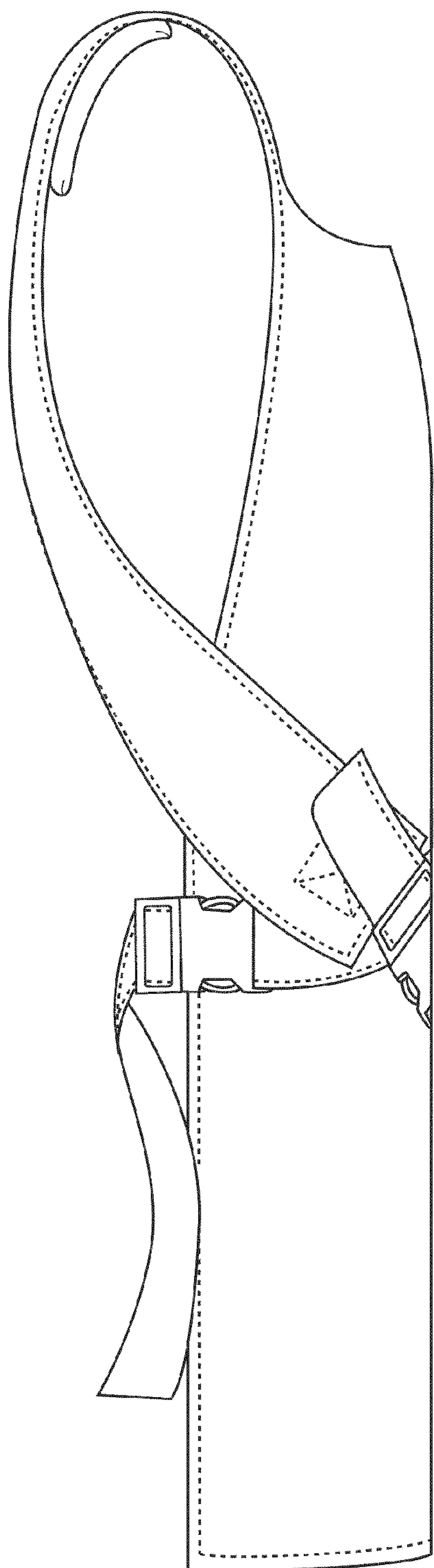

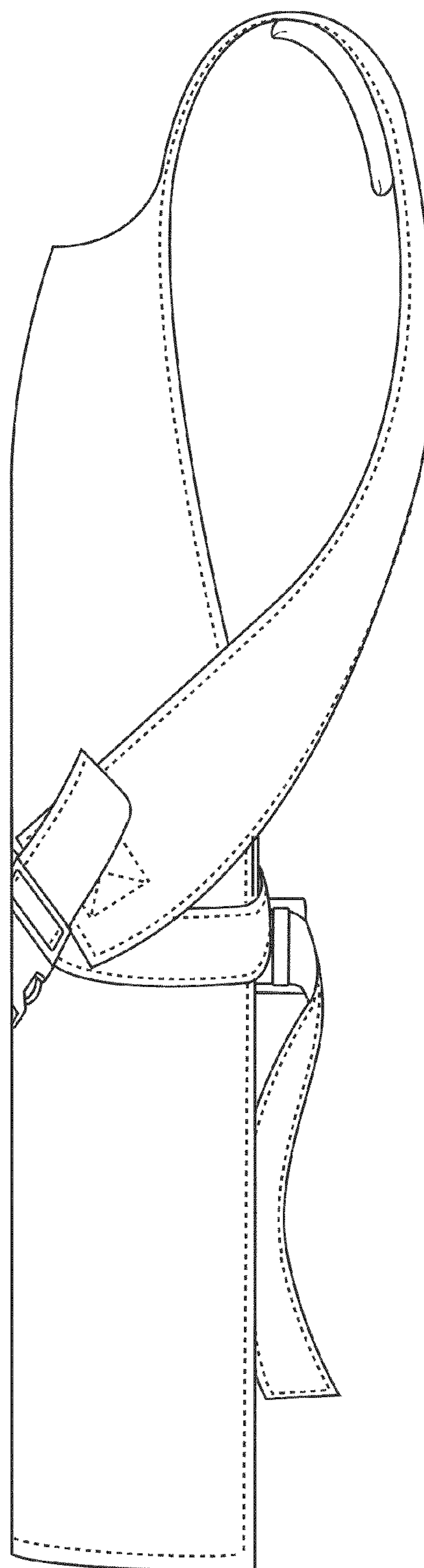

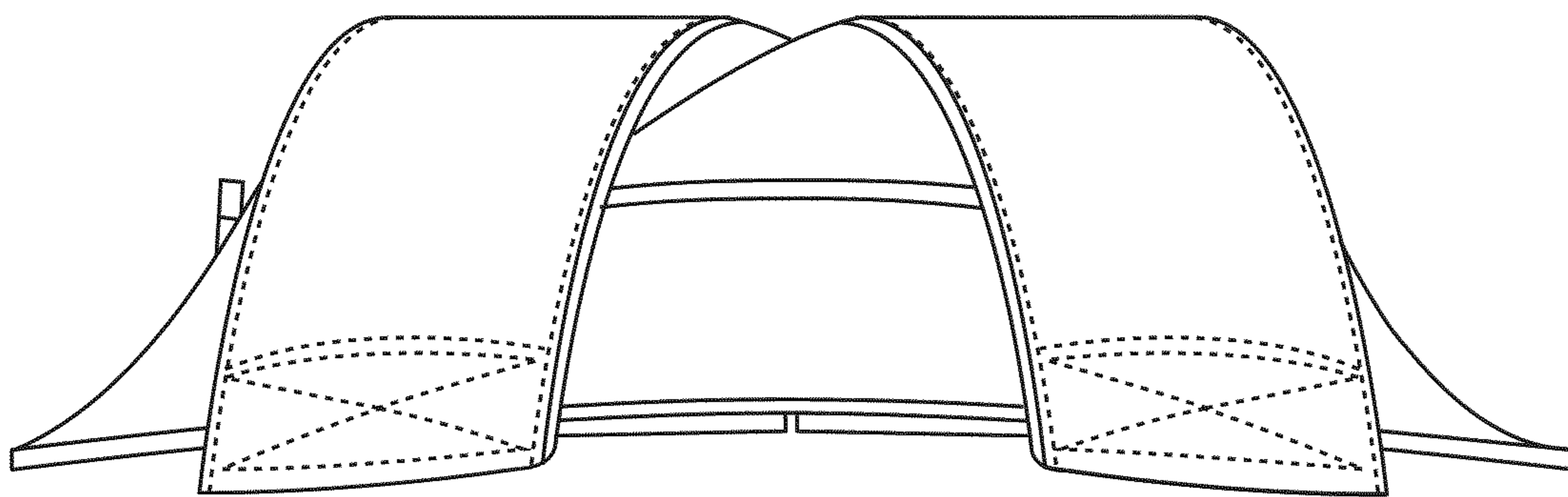

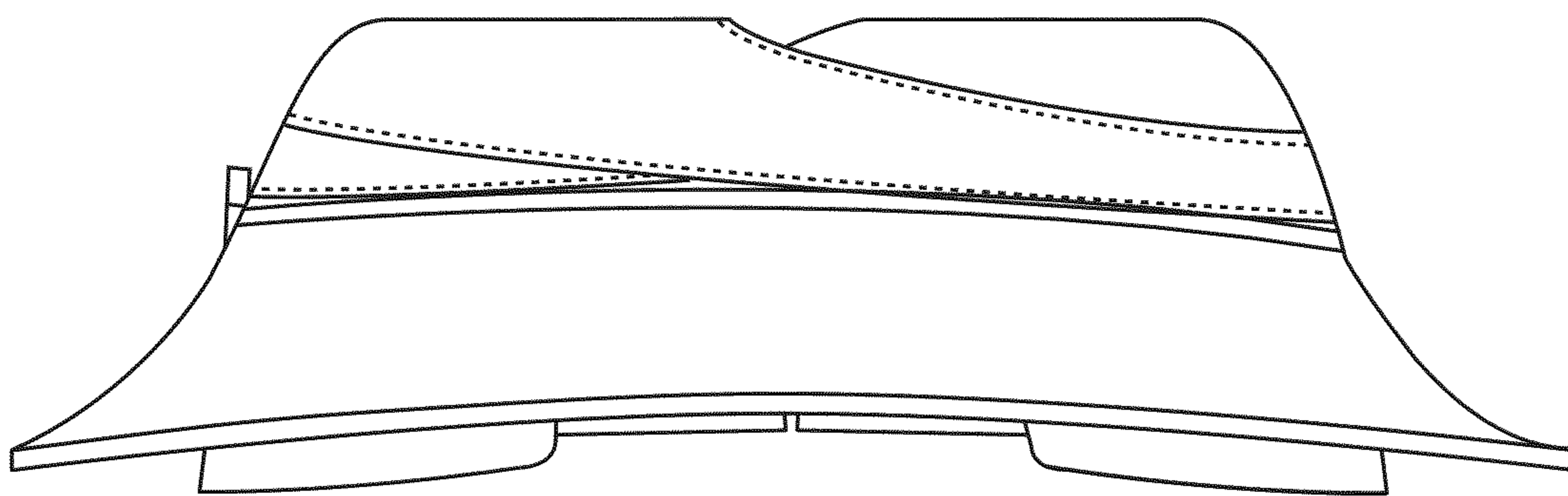

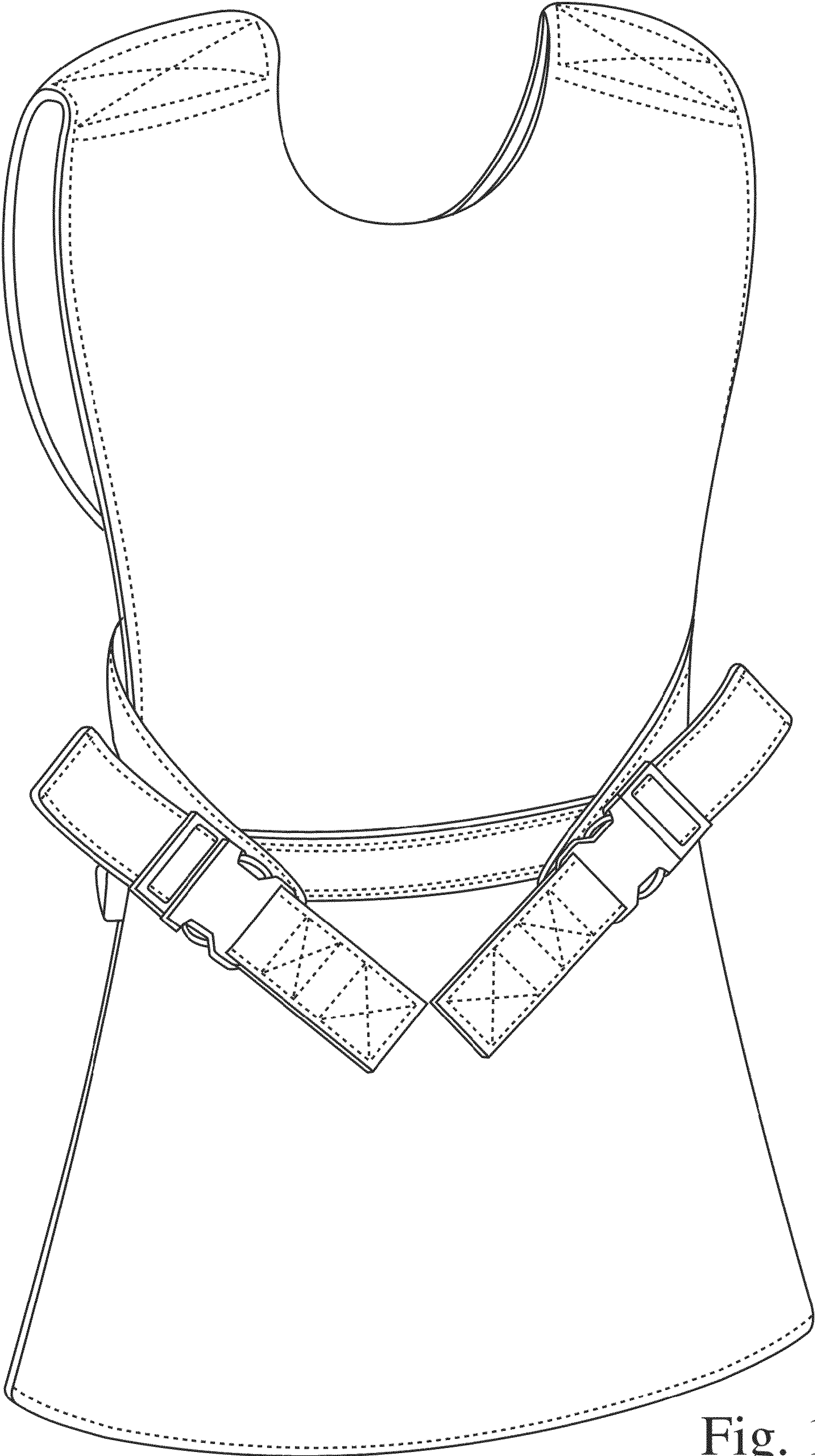
