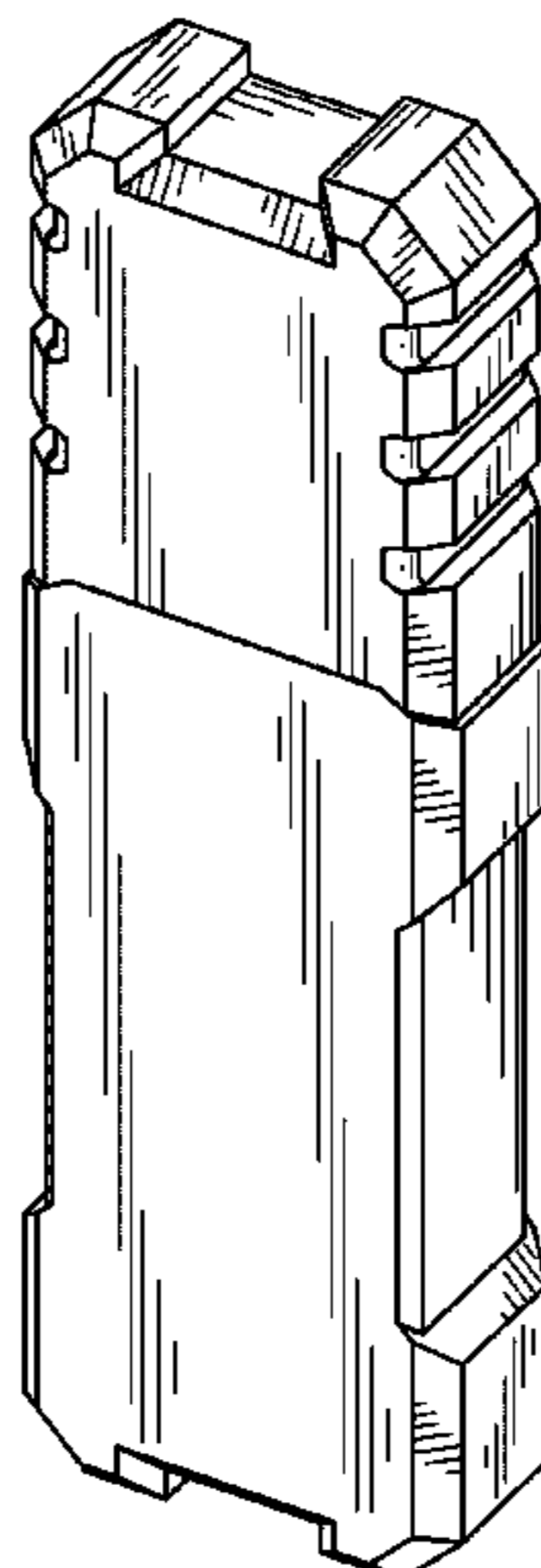

(57) **CLAIM**

We claim the ornamental design for a utility knife blade case, as shown and described.

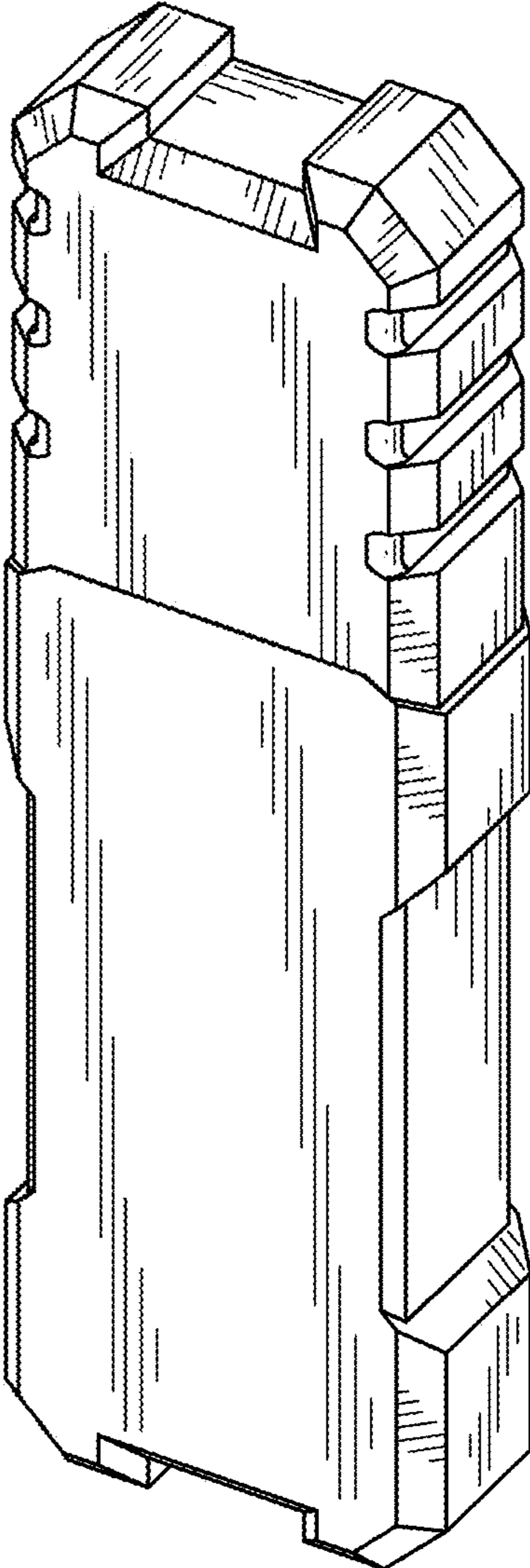

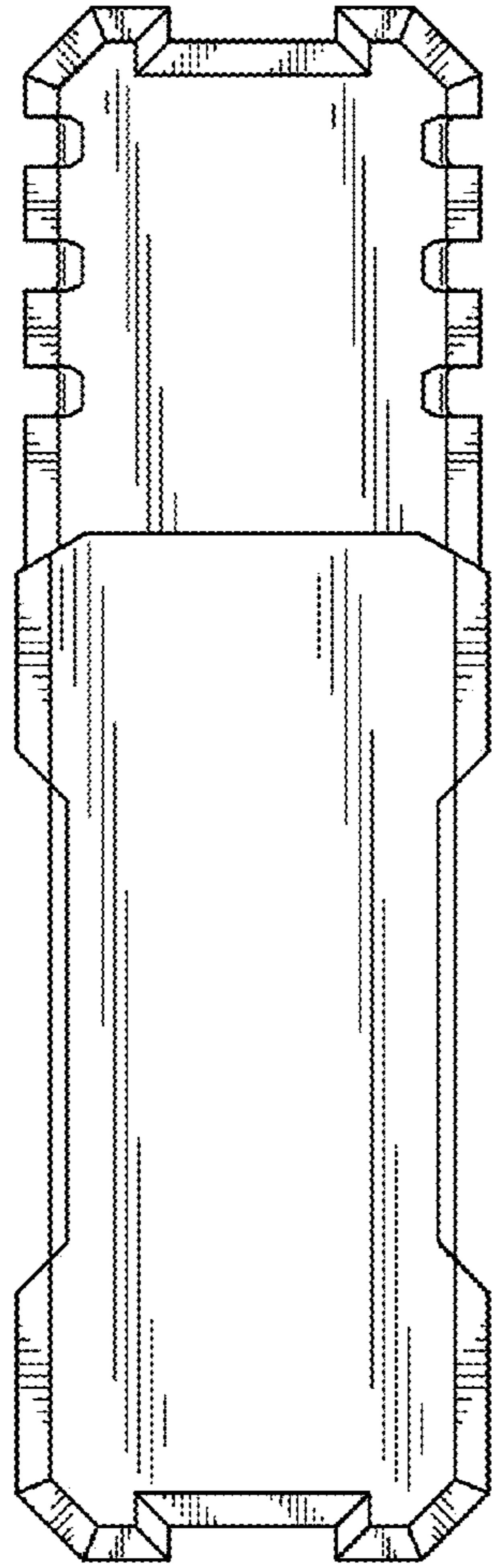

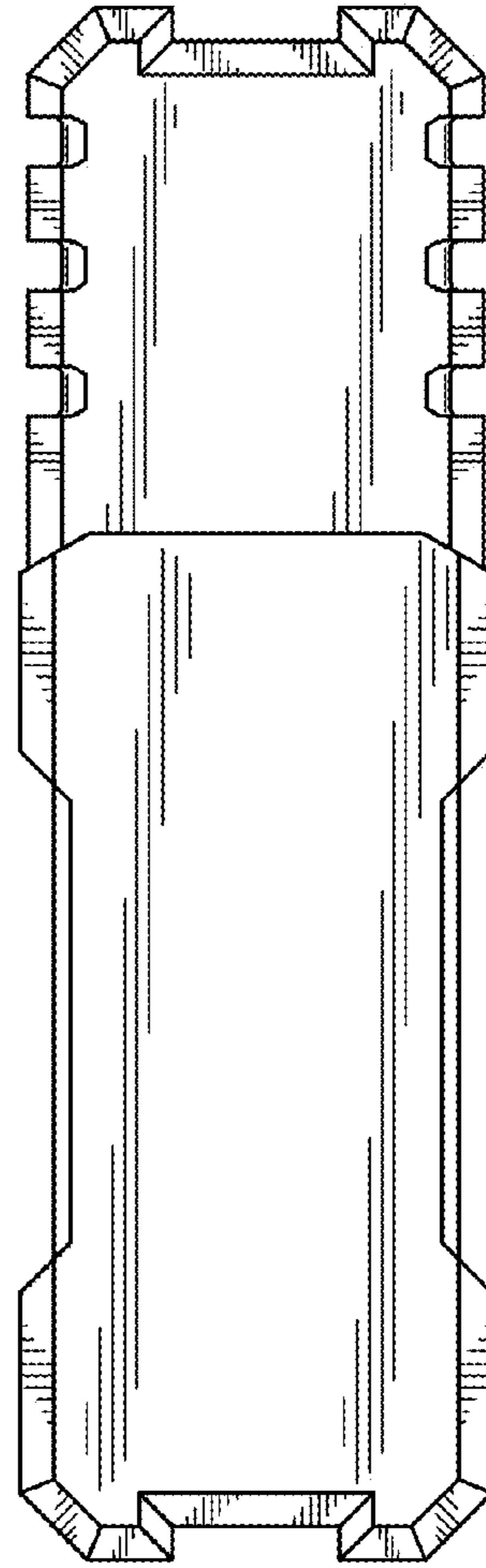

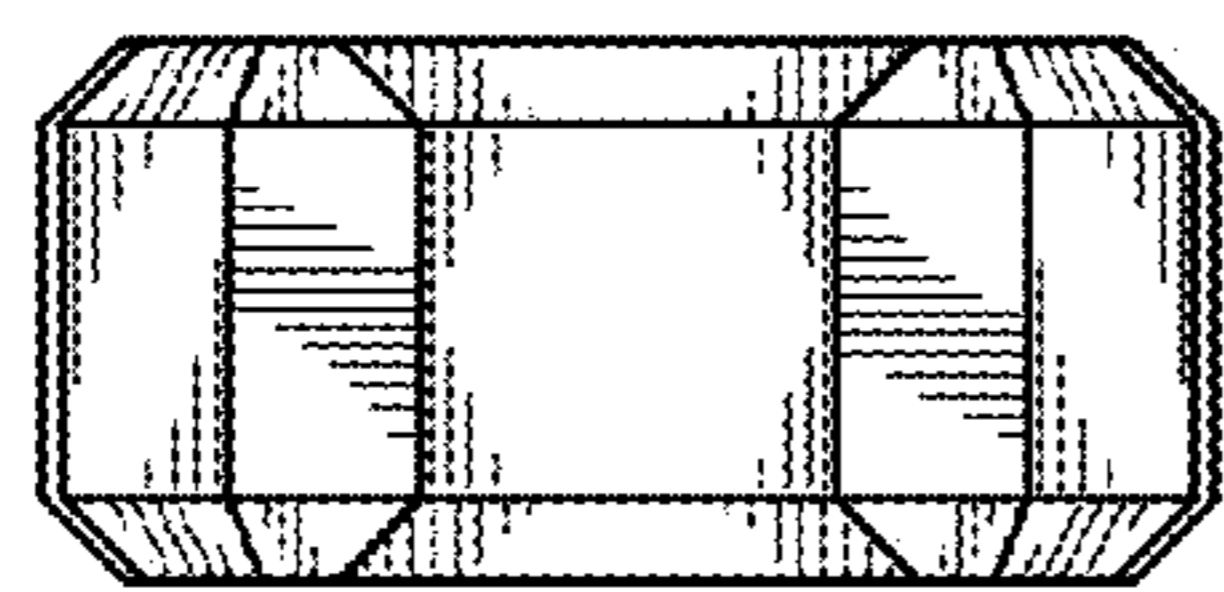

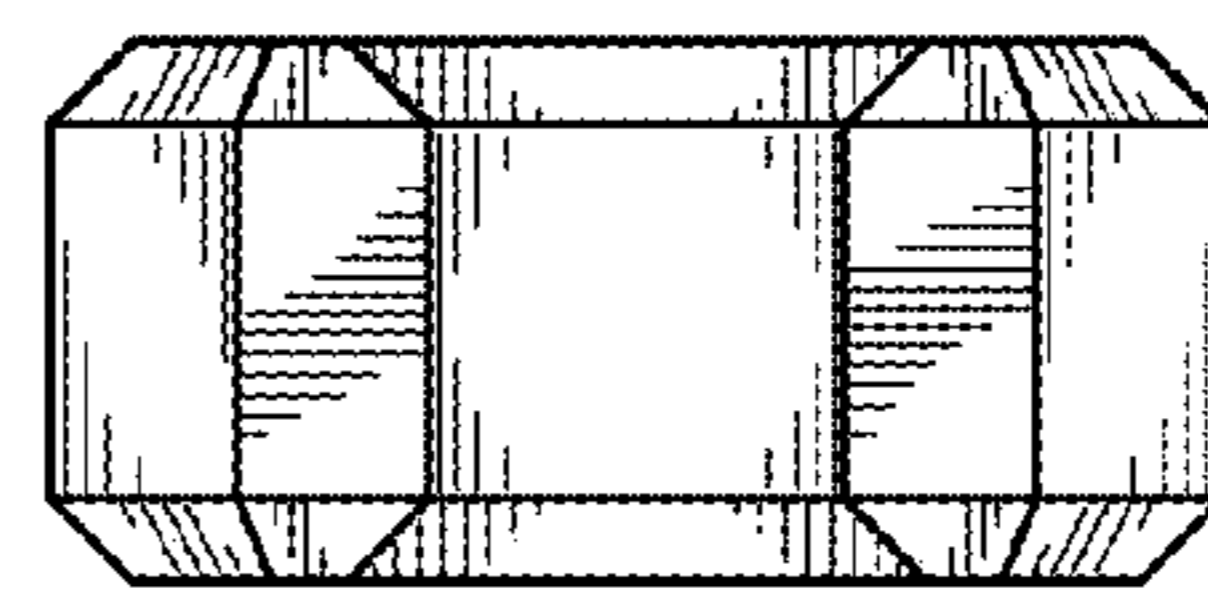

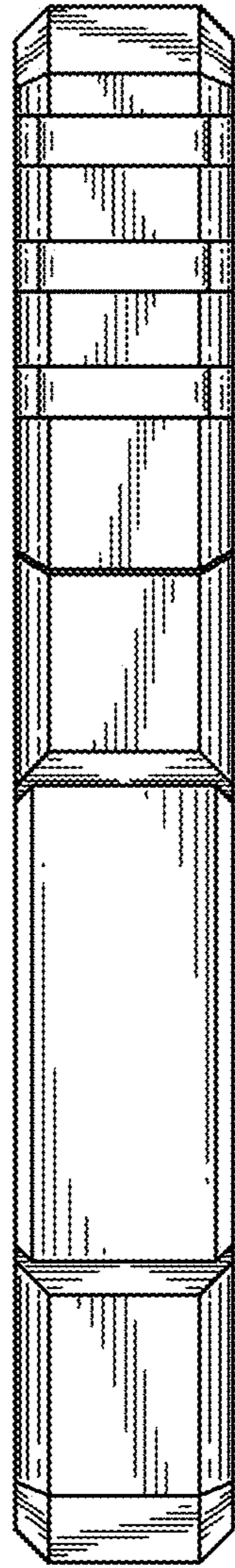

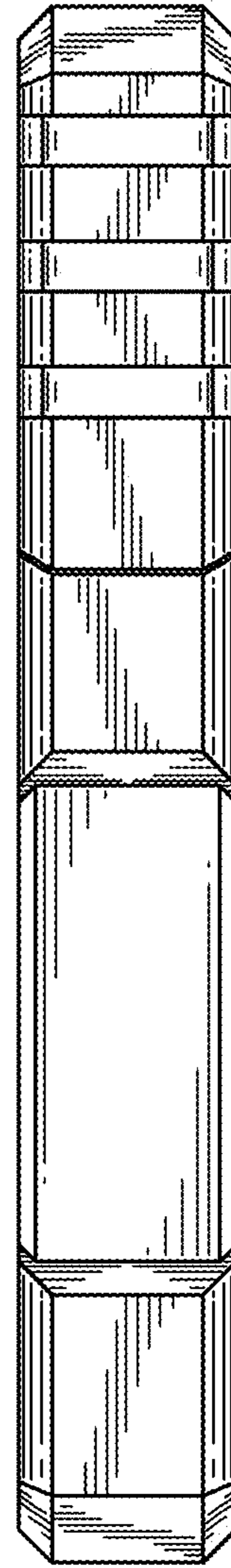

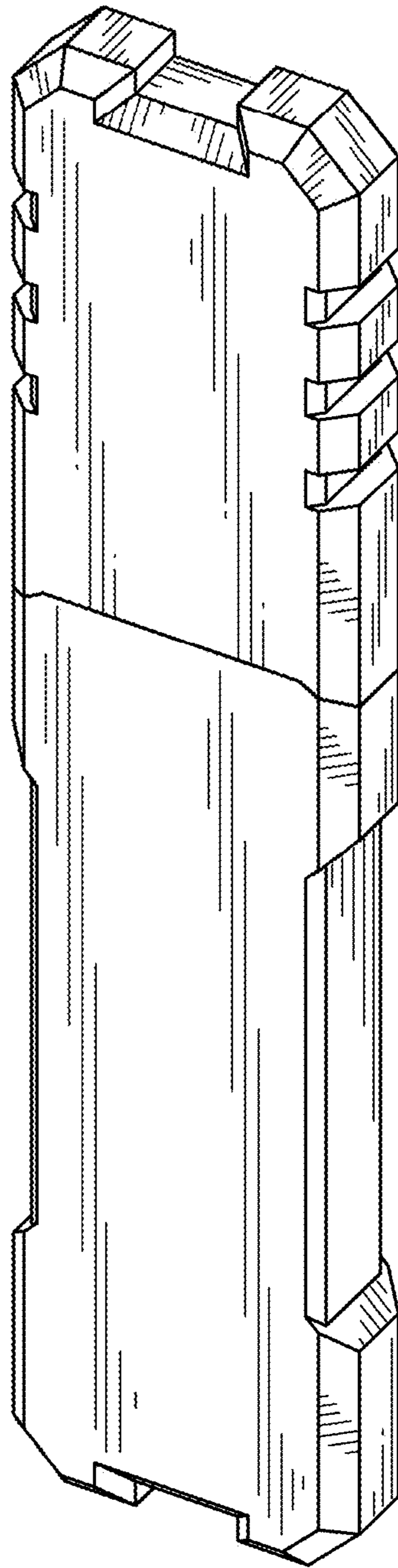

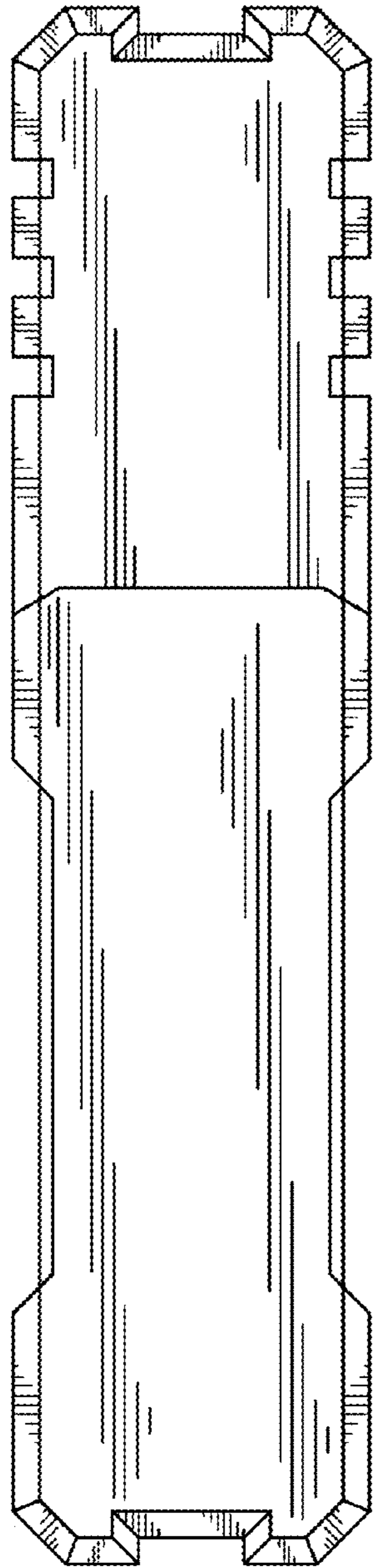

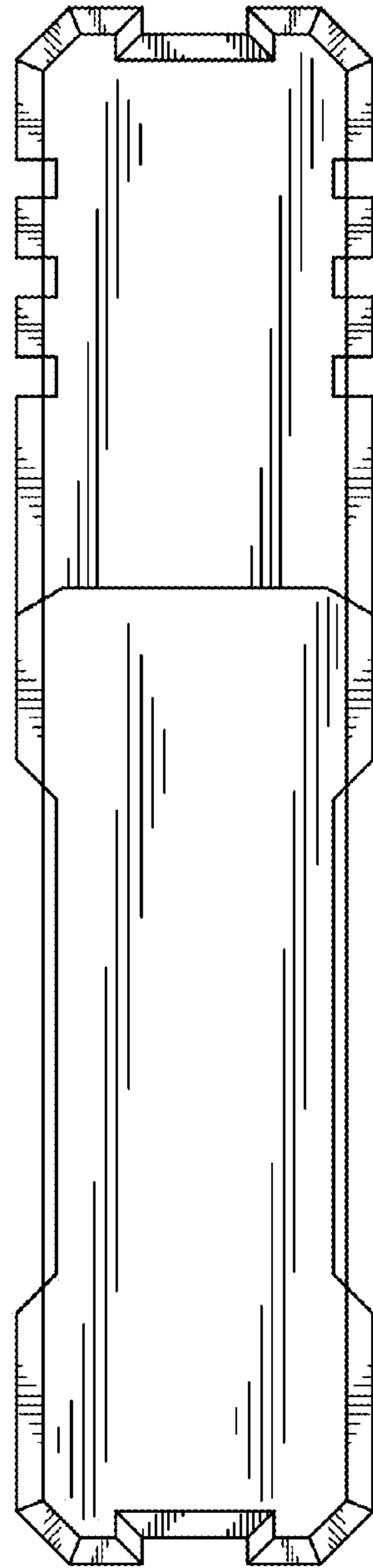

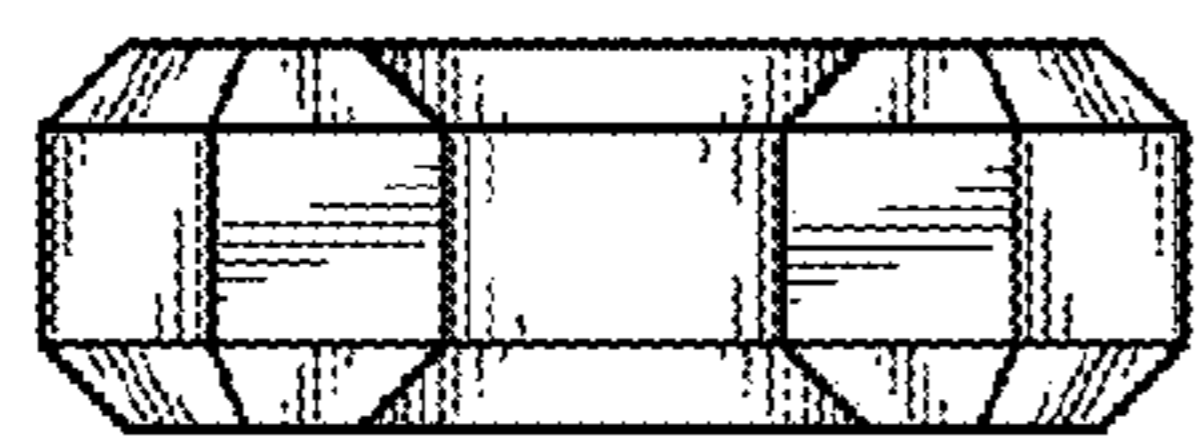

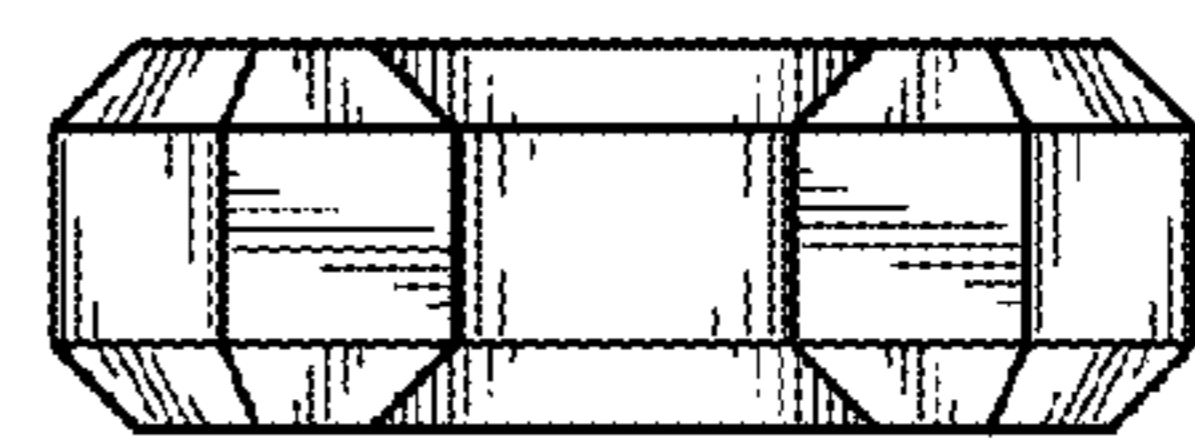

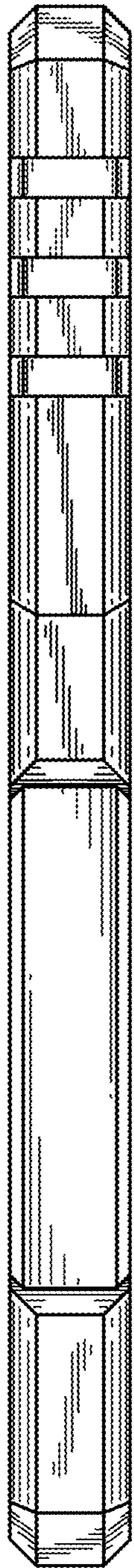

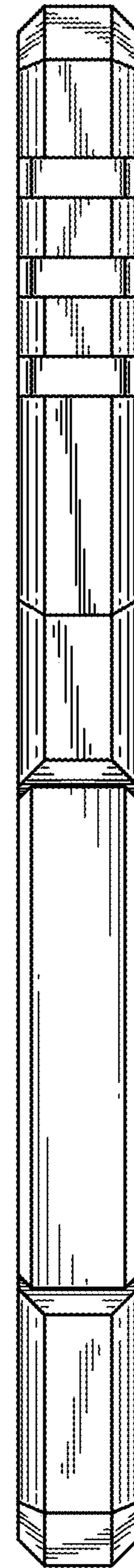

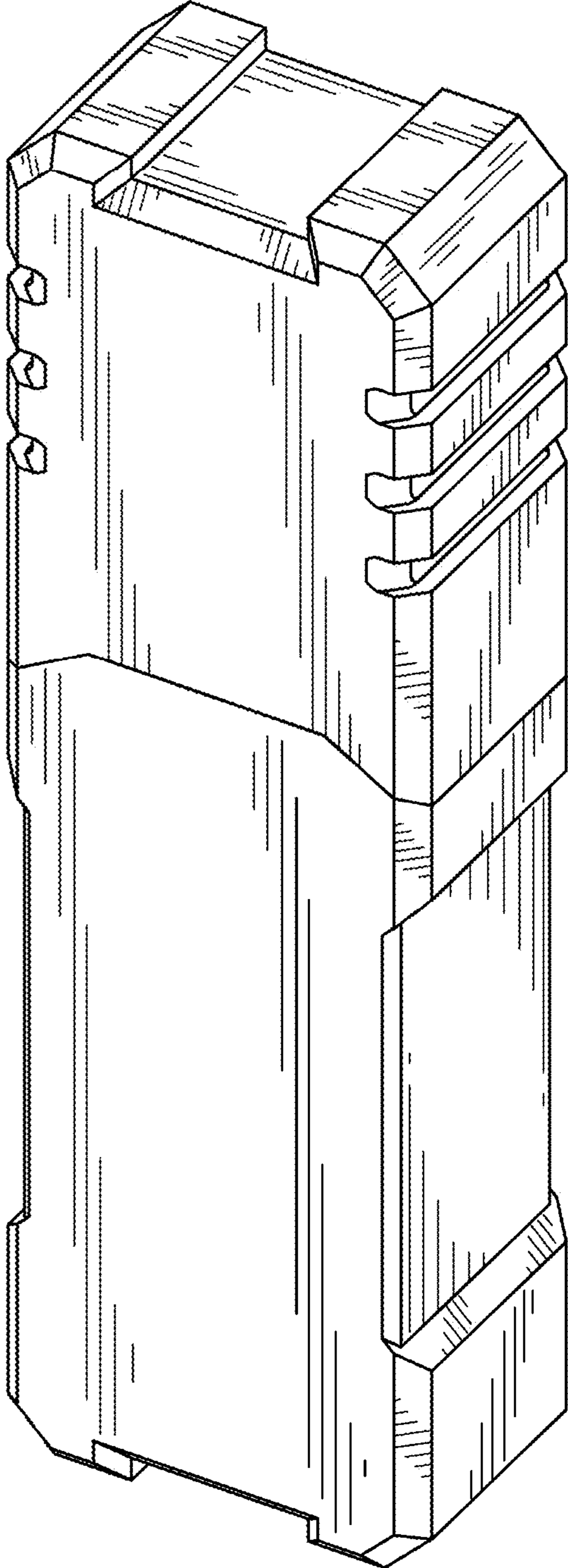

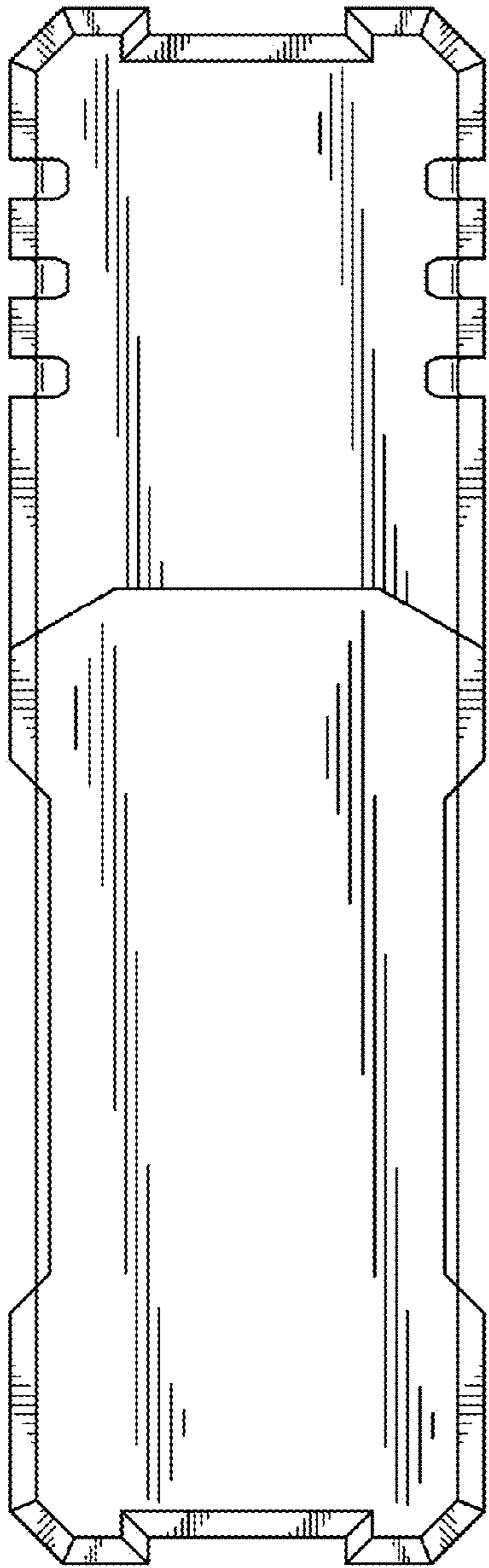

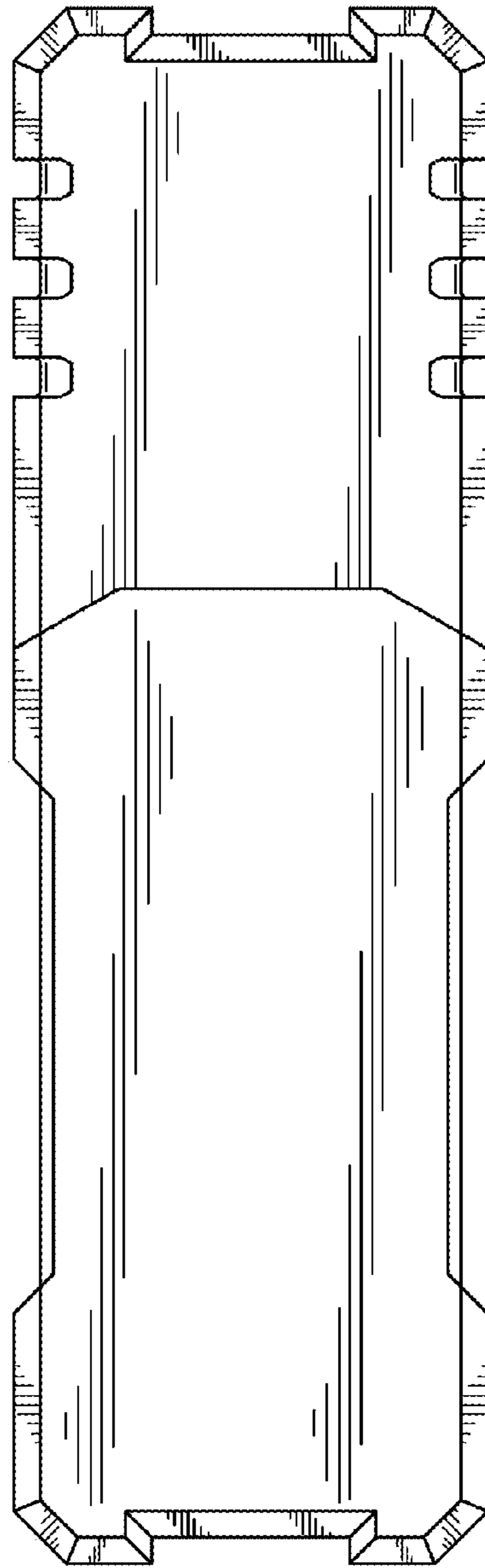

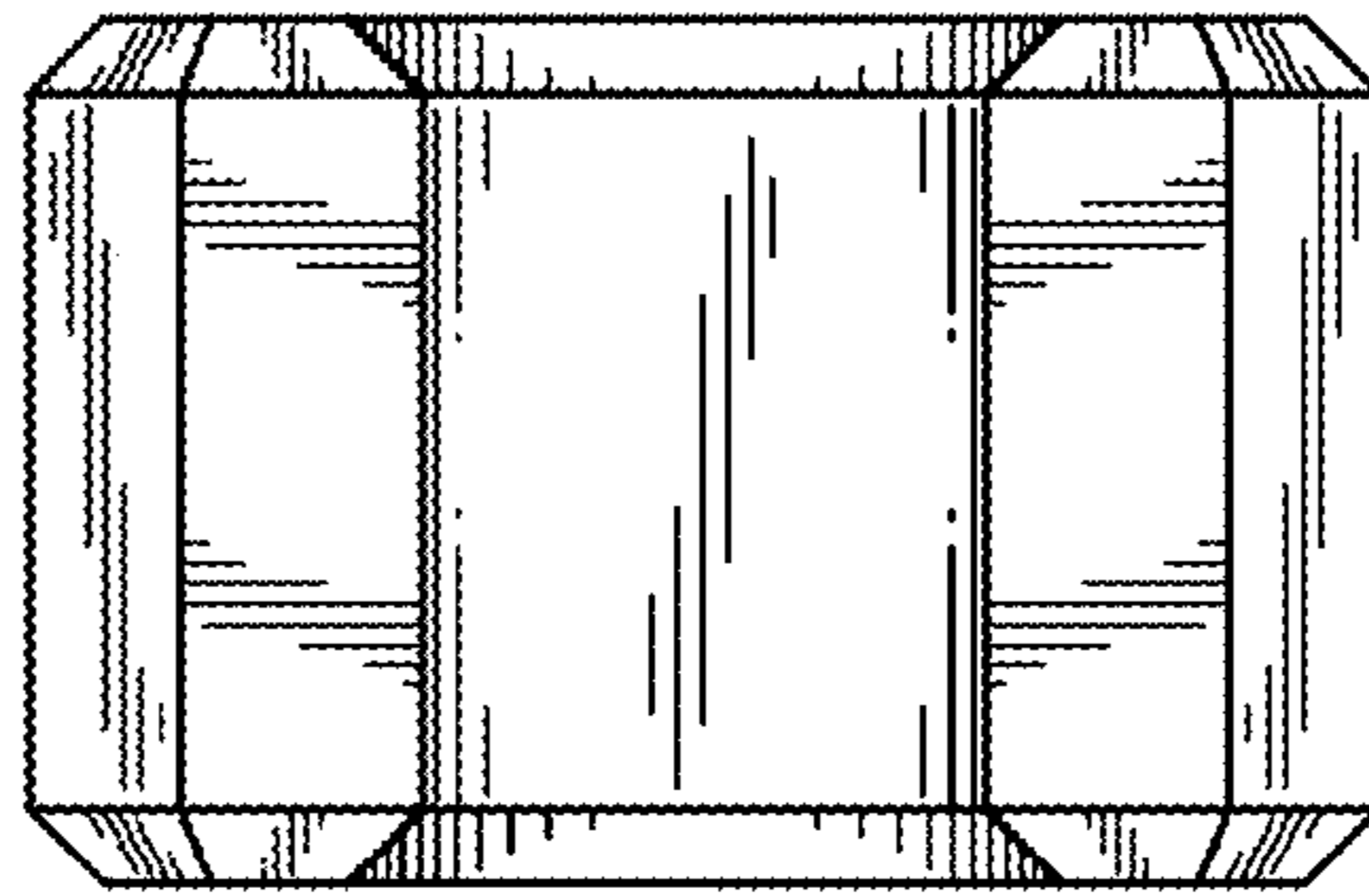

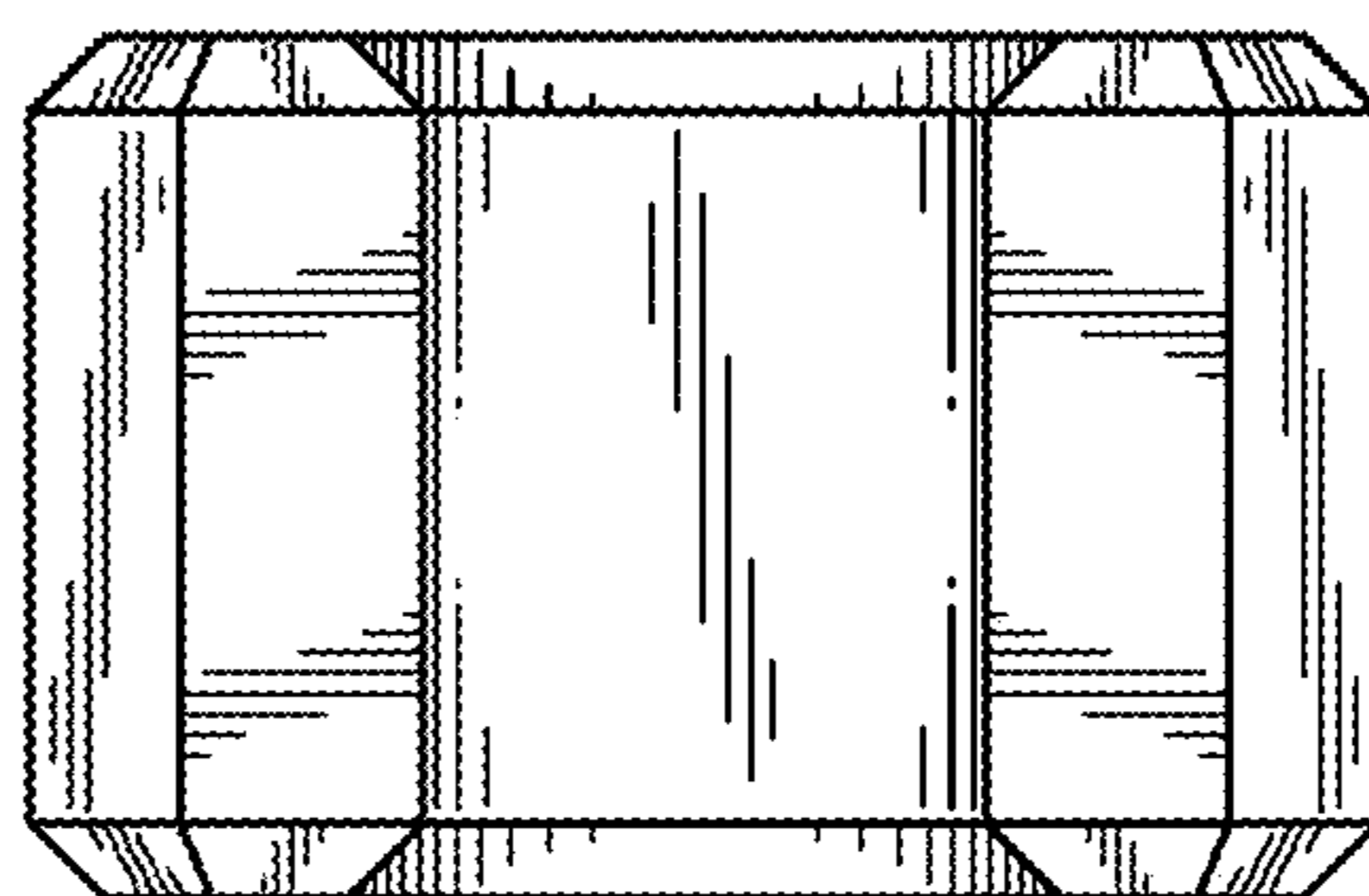

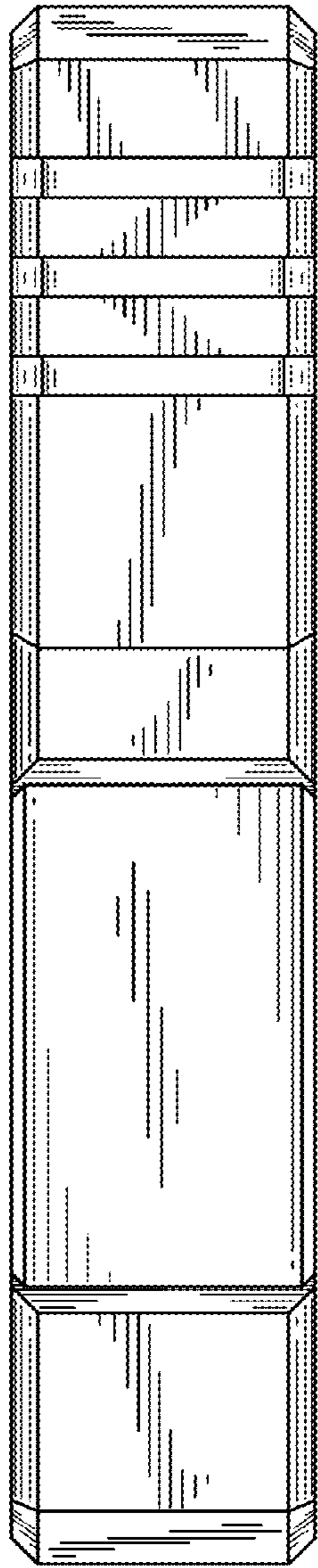

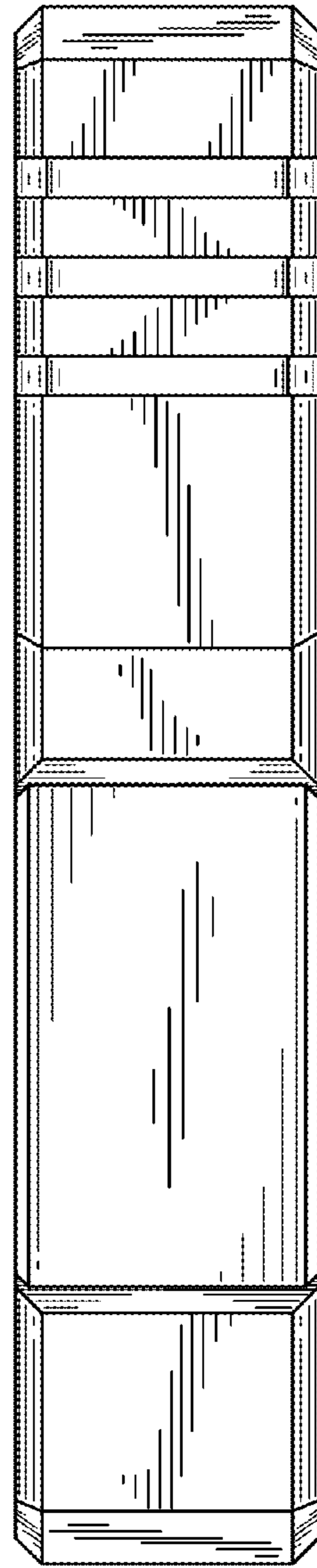

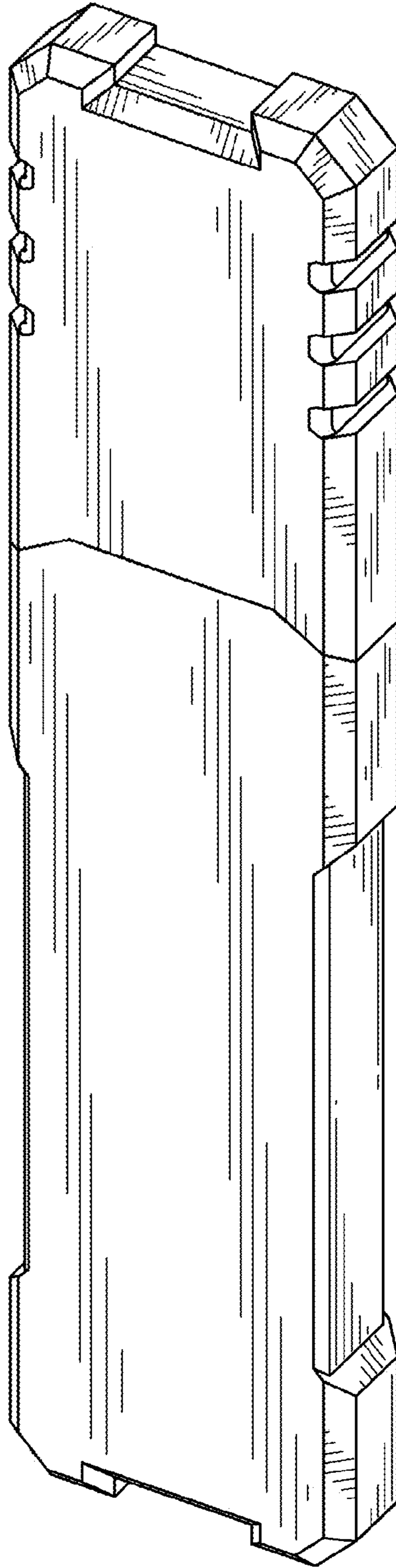

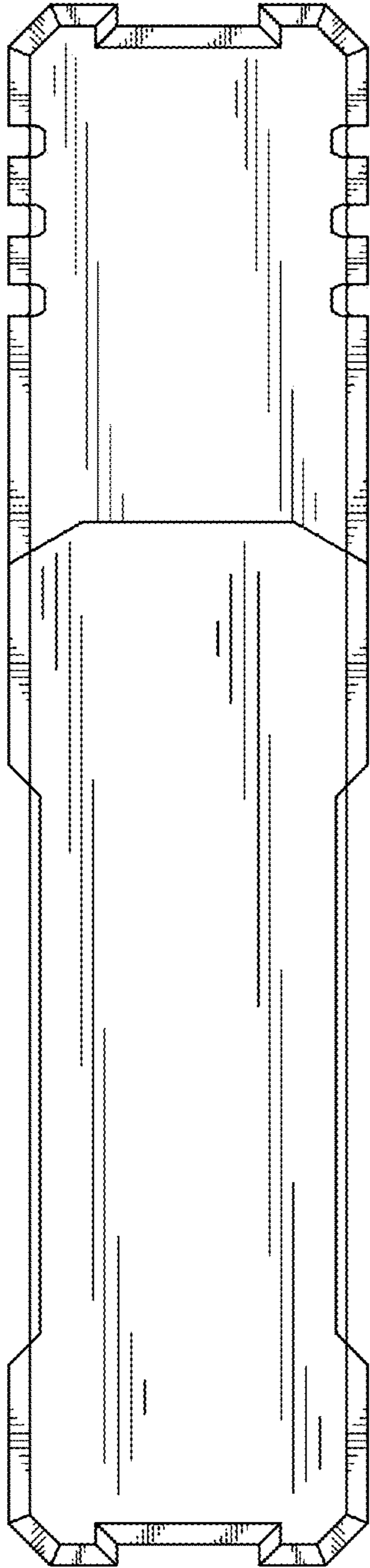

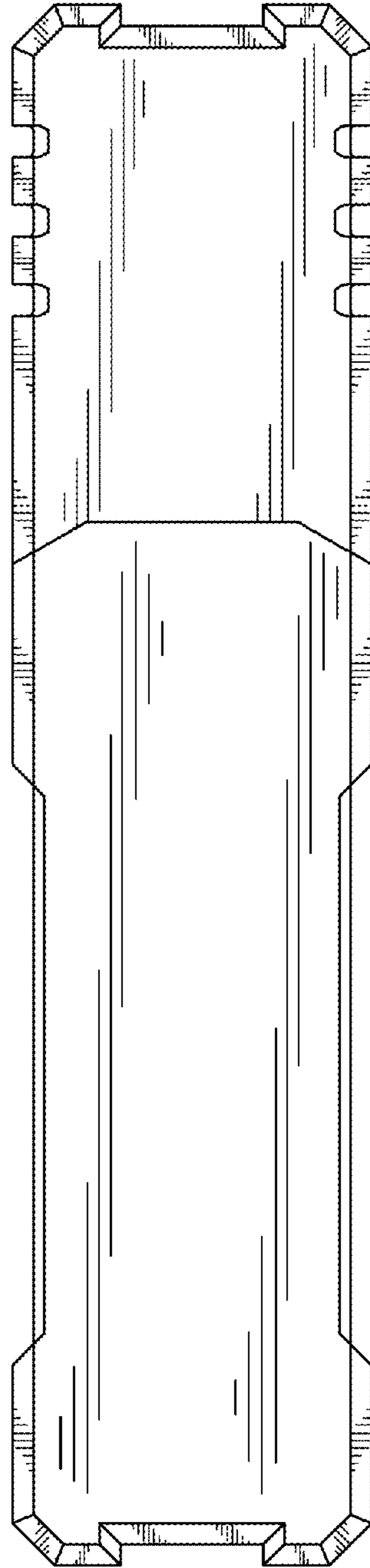

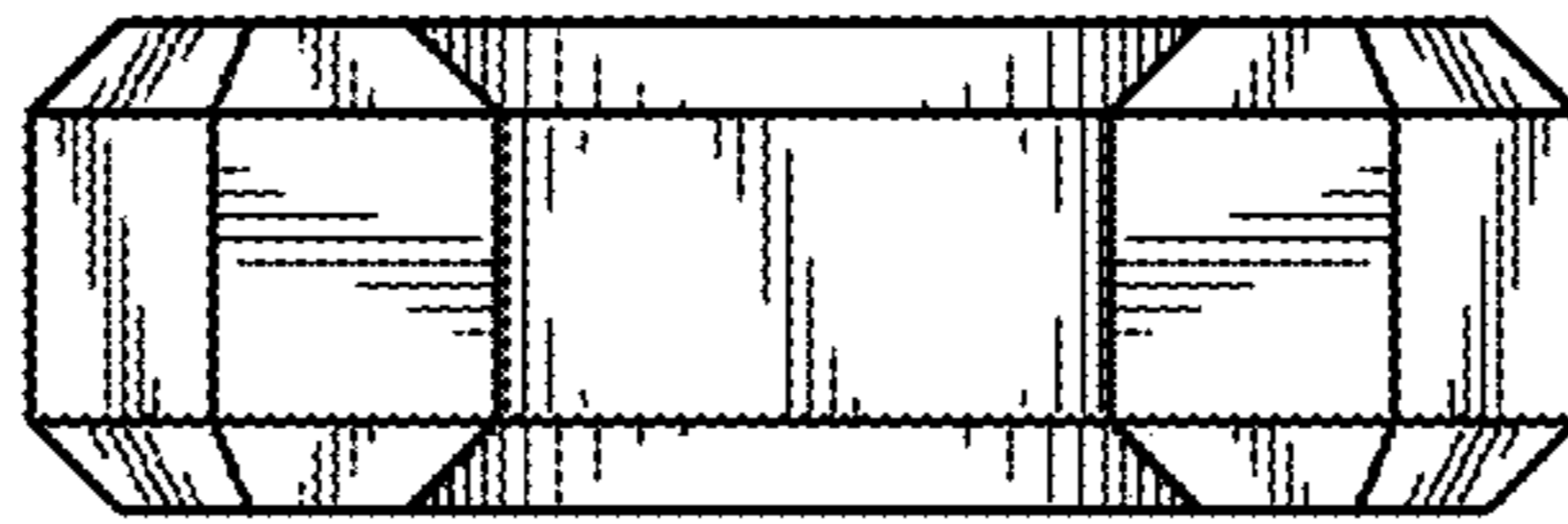

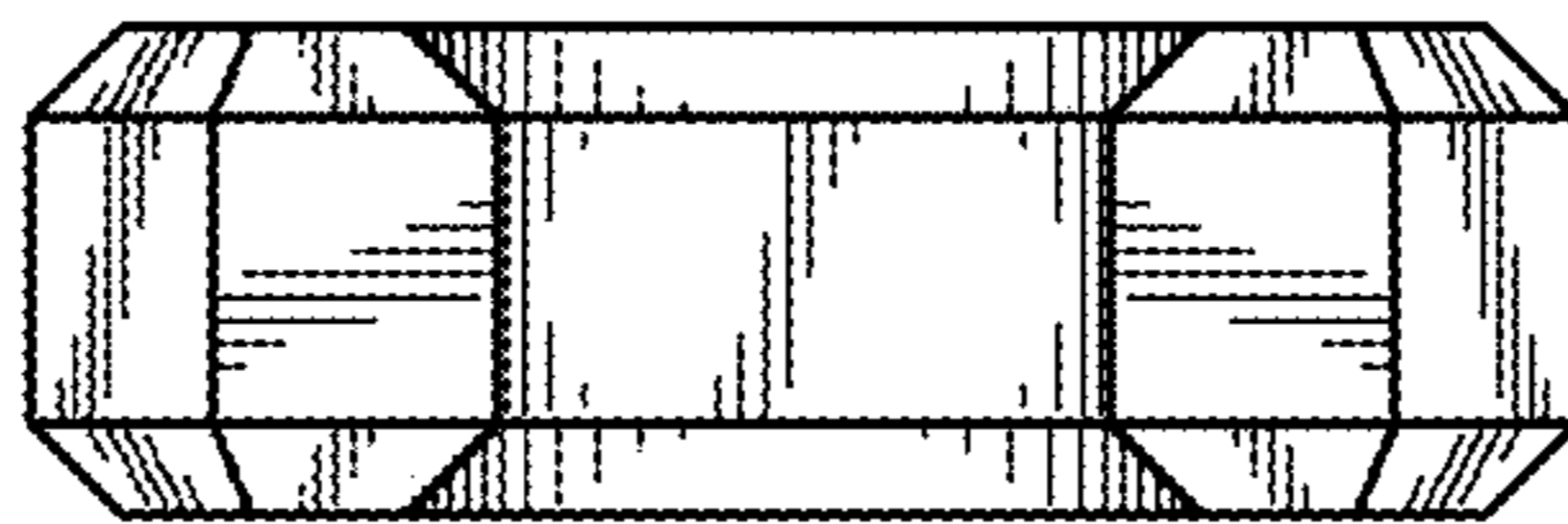

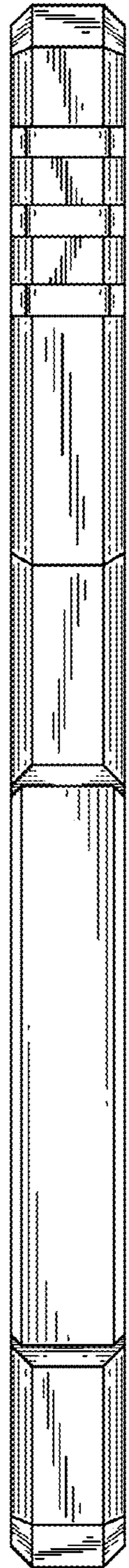

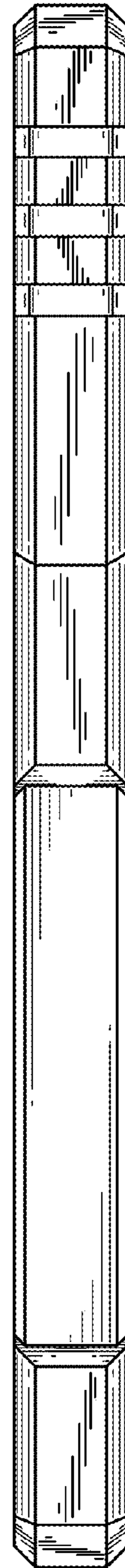

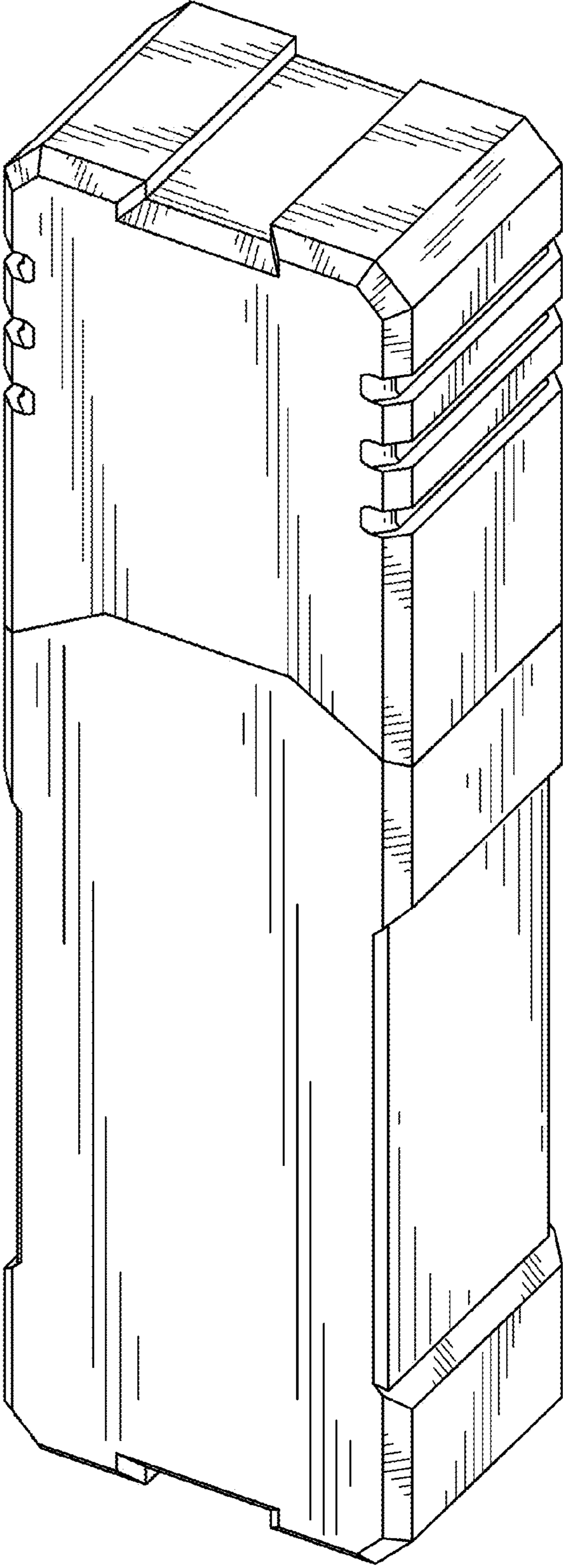

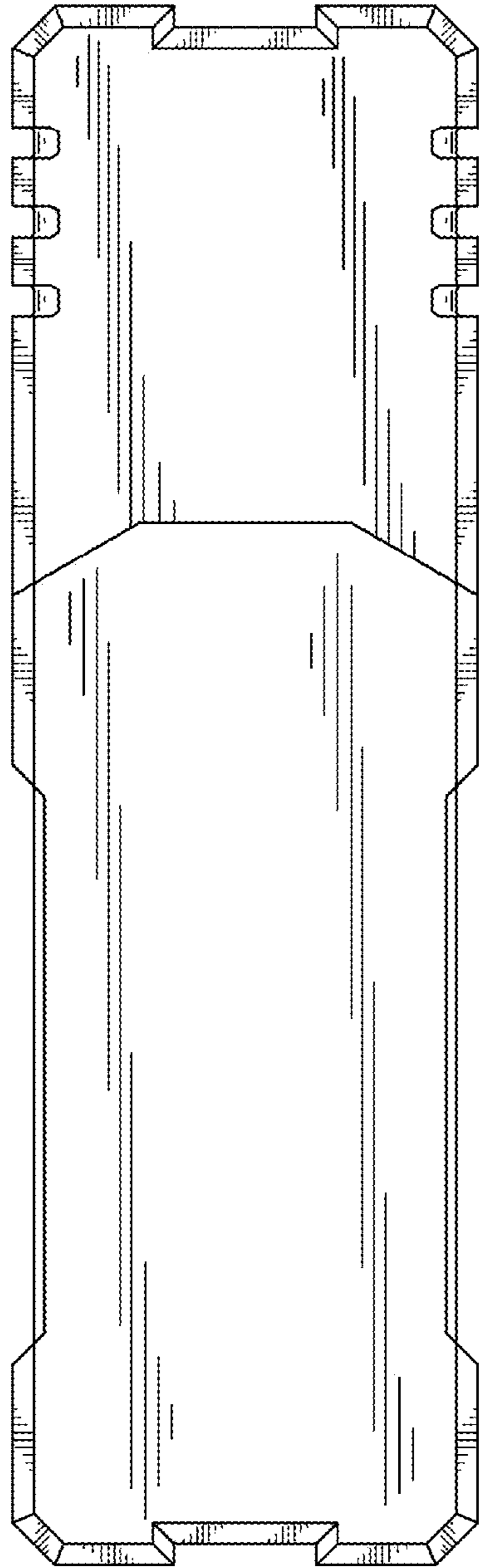

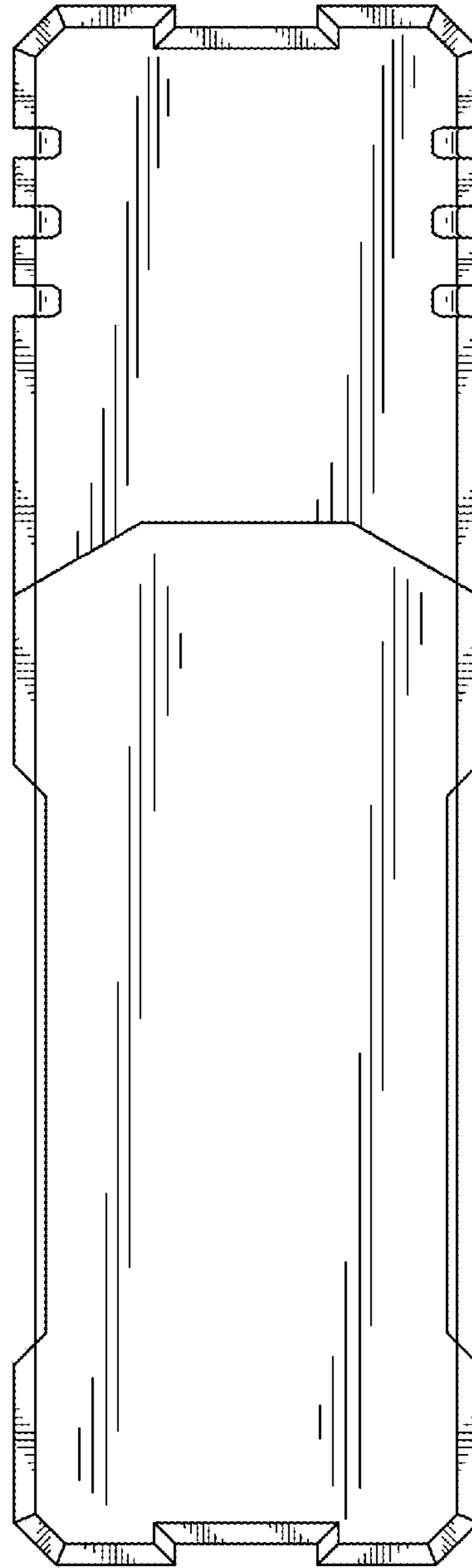

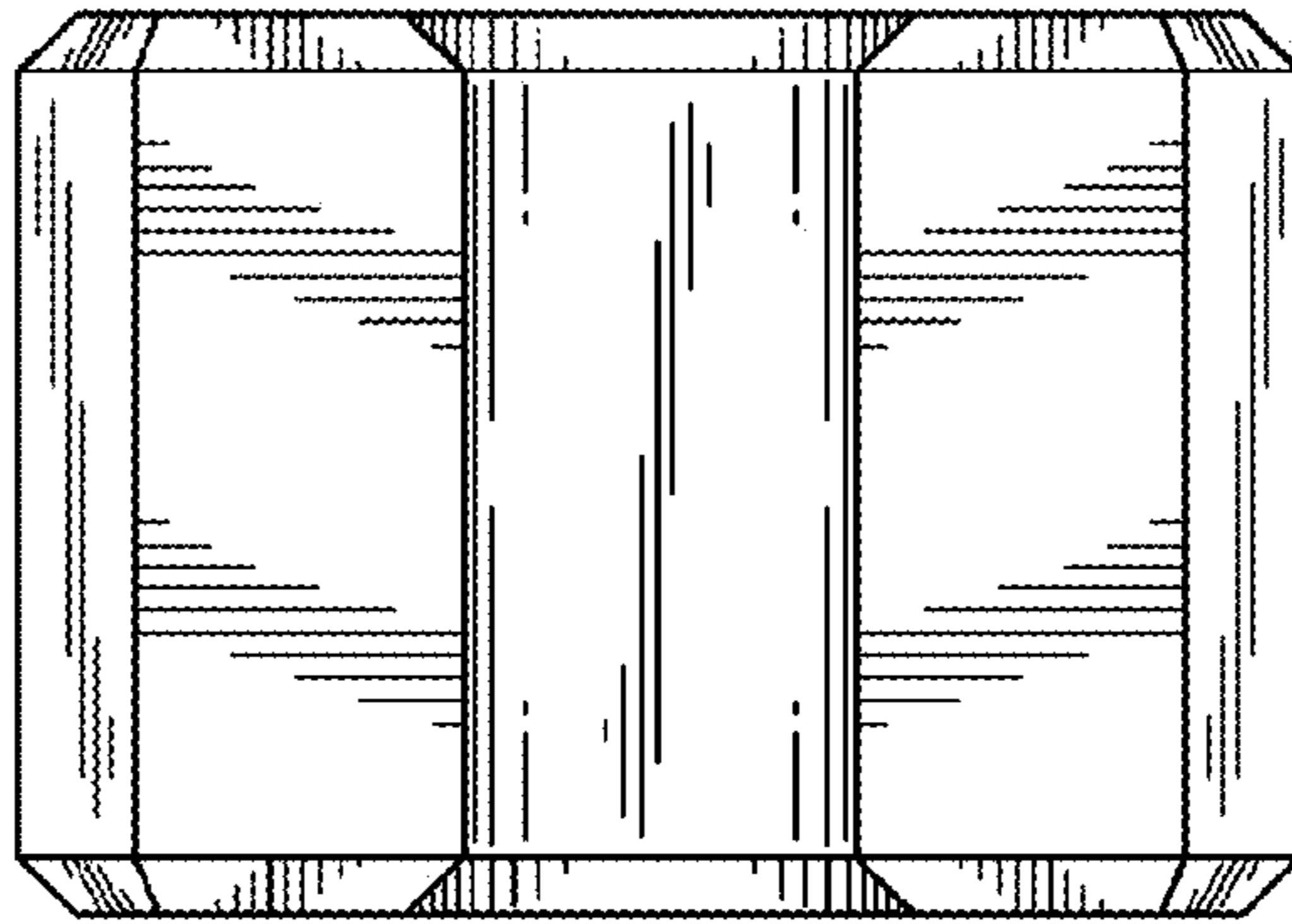

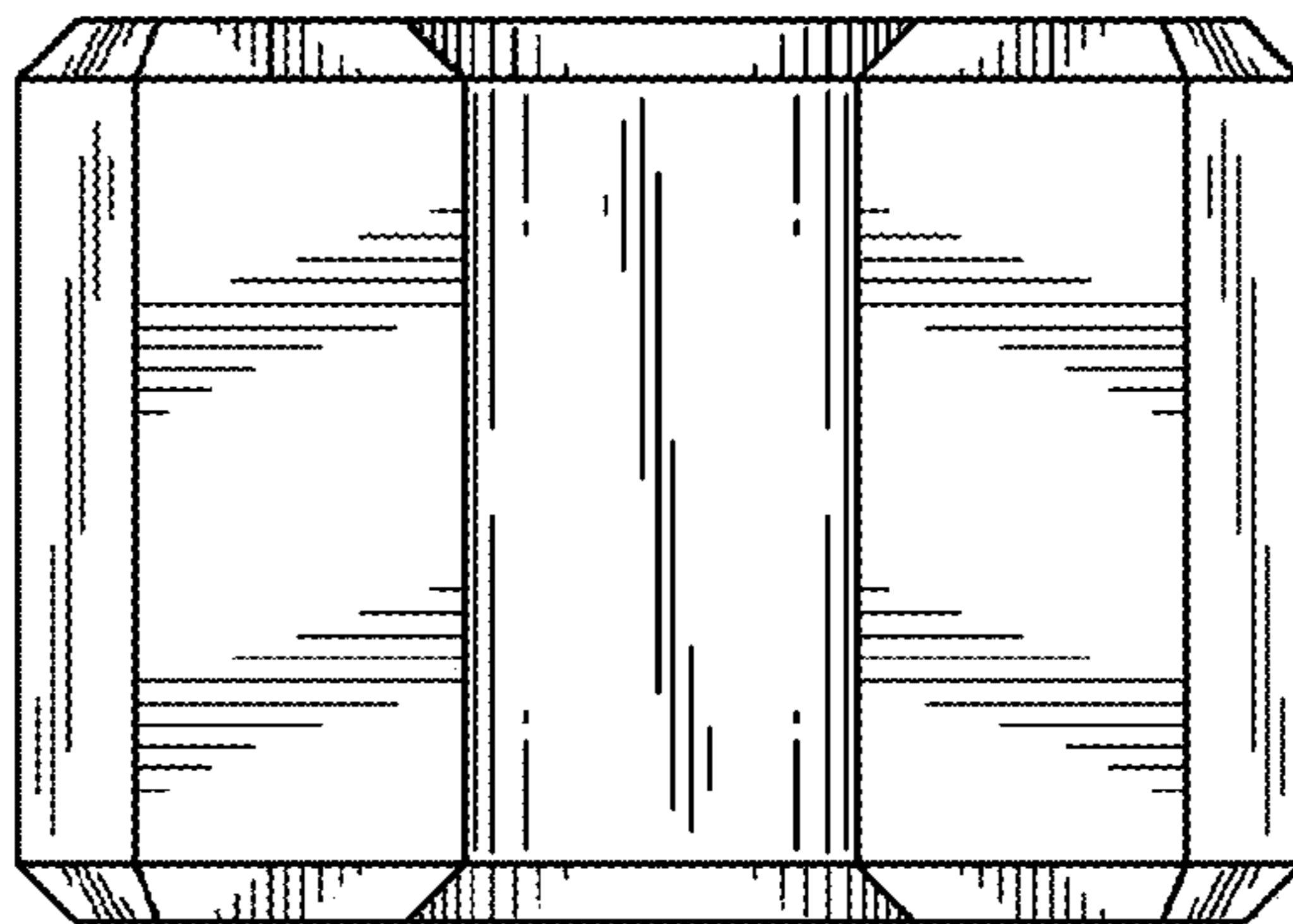

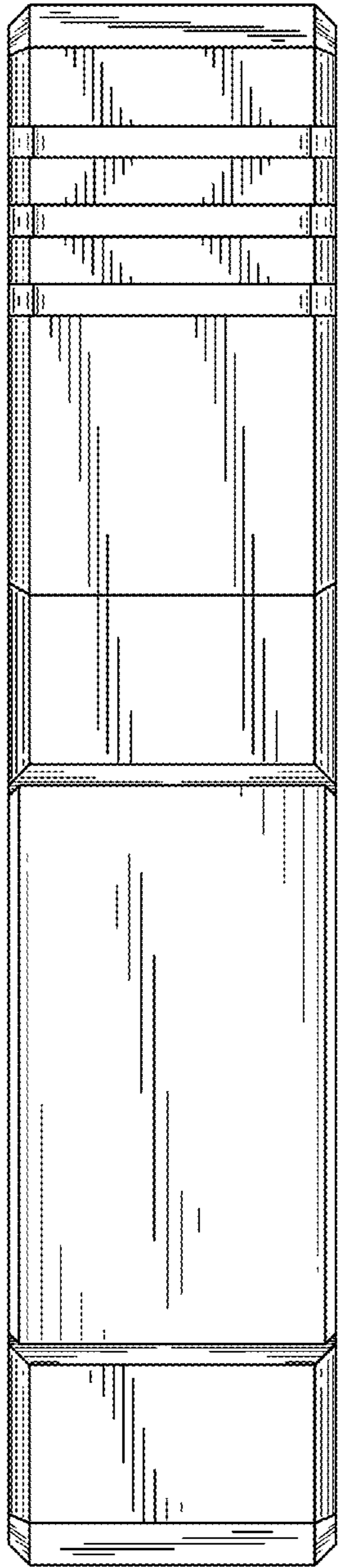

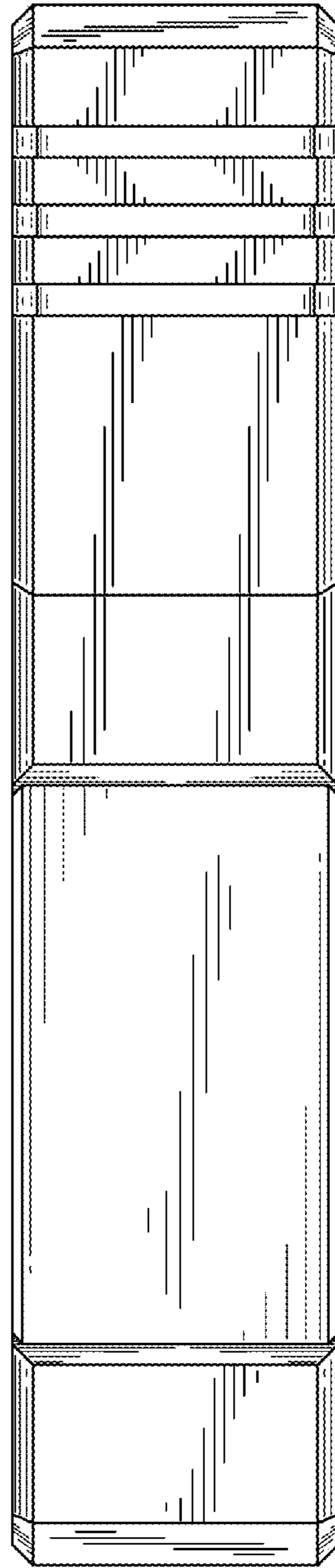
