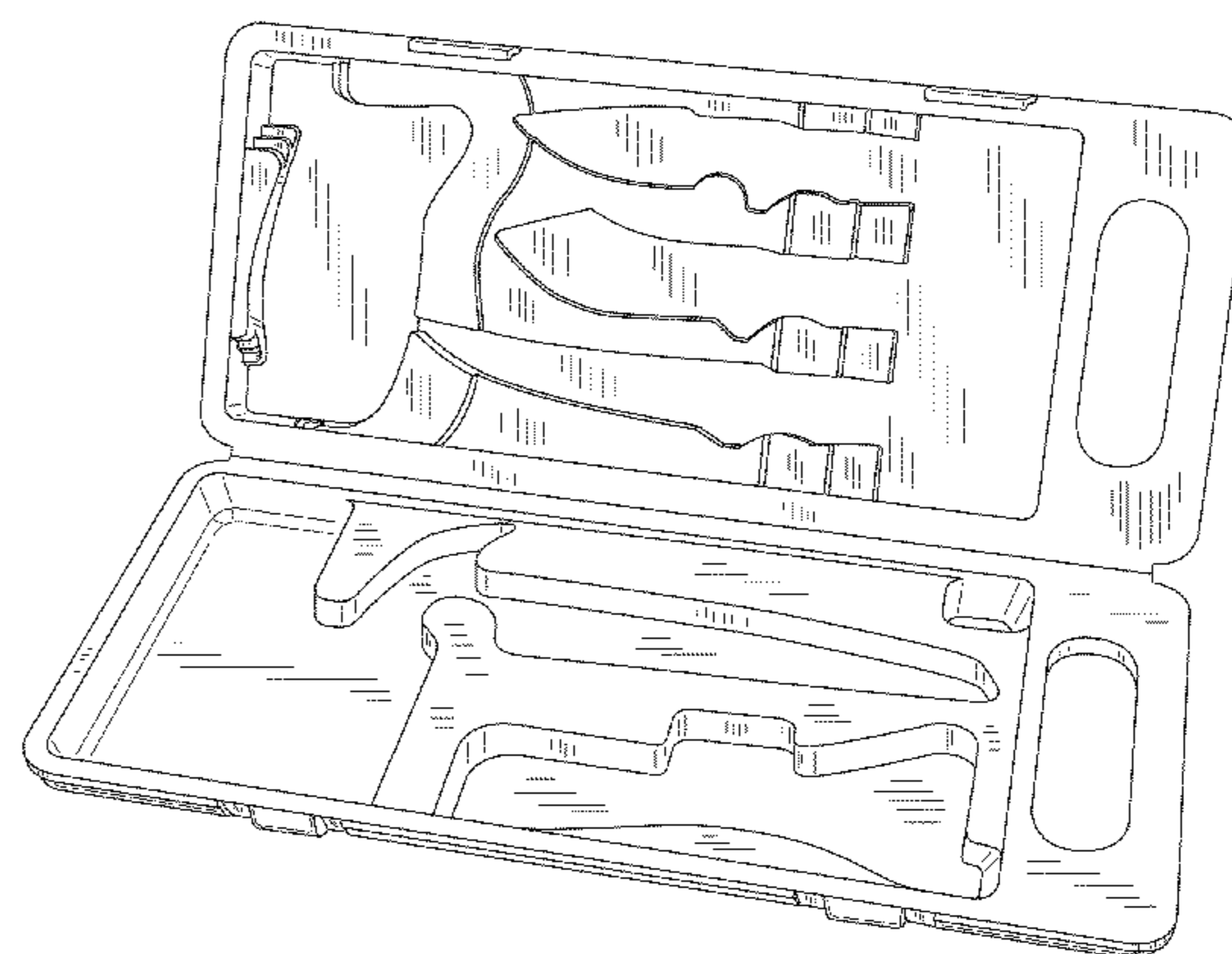
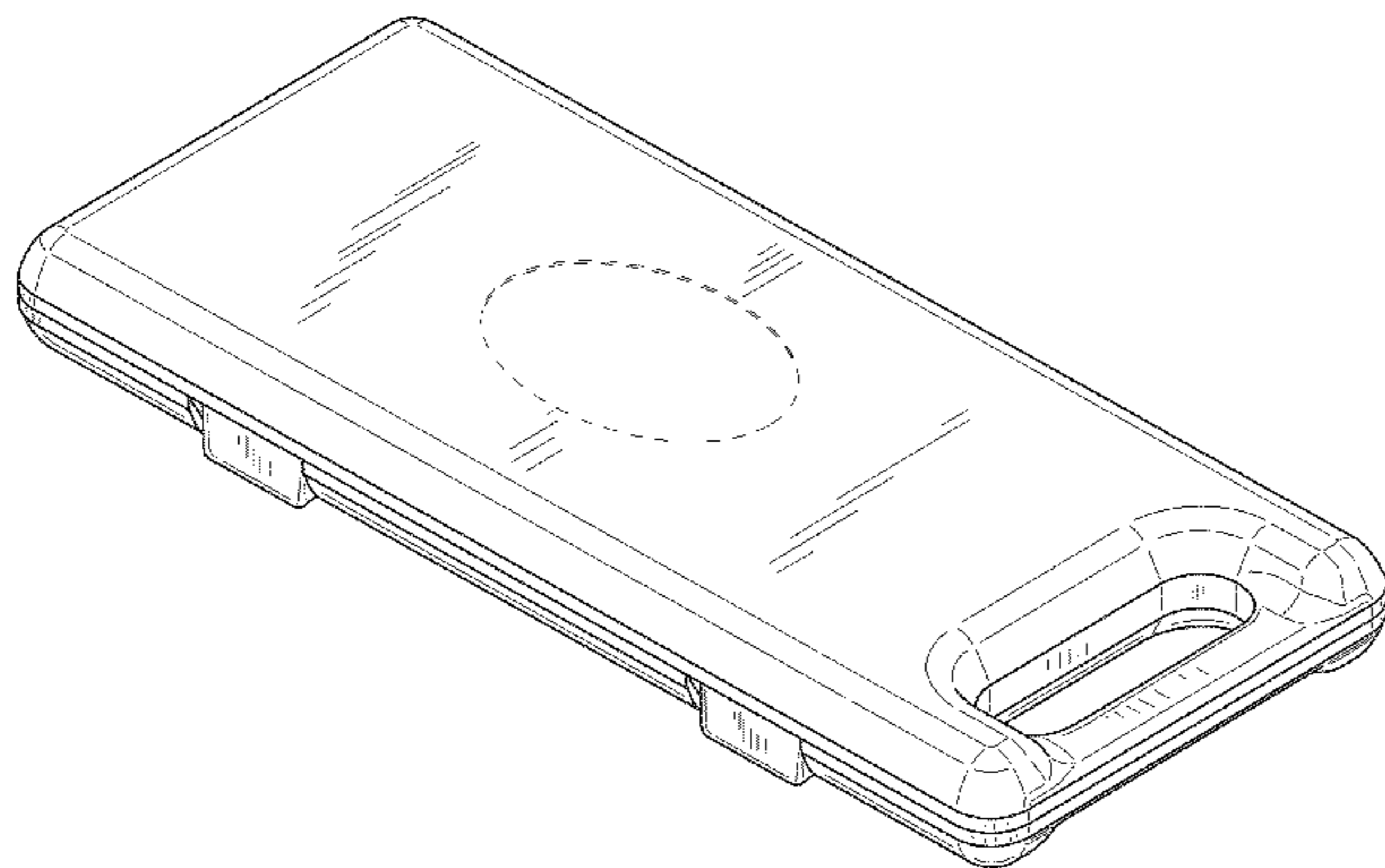
(57) **CLAIM**

The ornamental design for a cutlery case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cutlery case;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a right elevation view thereof;
FIG. 5 is a left elevation view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view of the cutlery case shown in an open position of use.

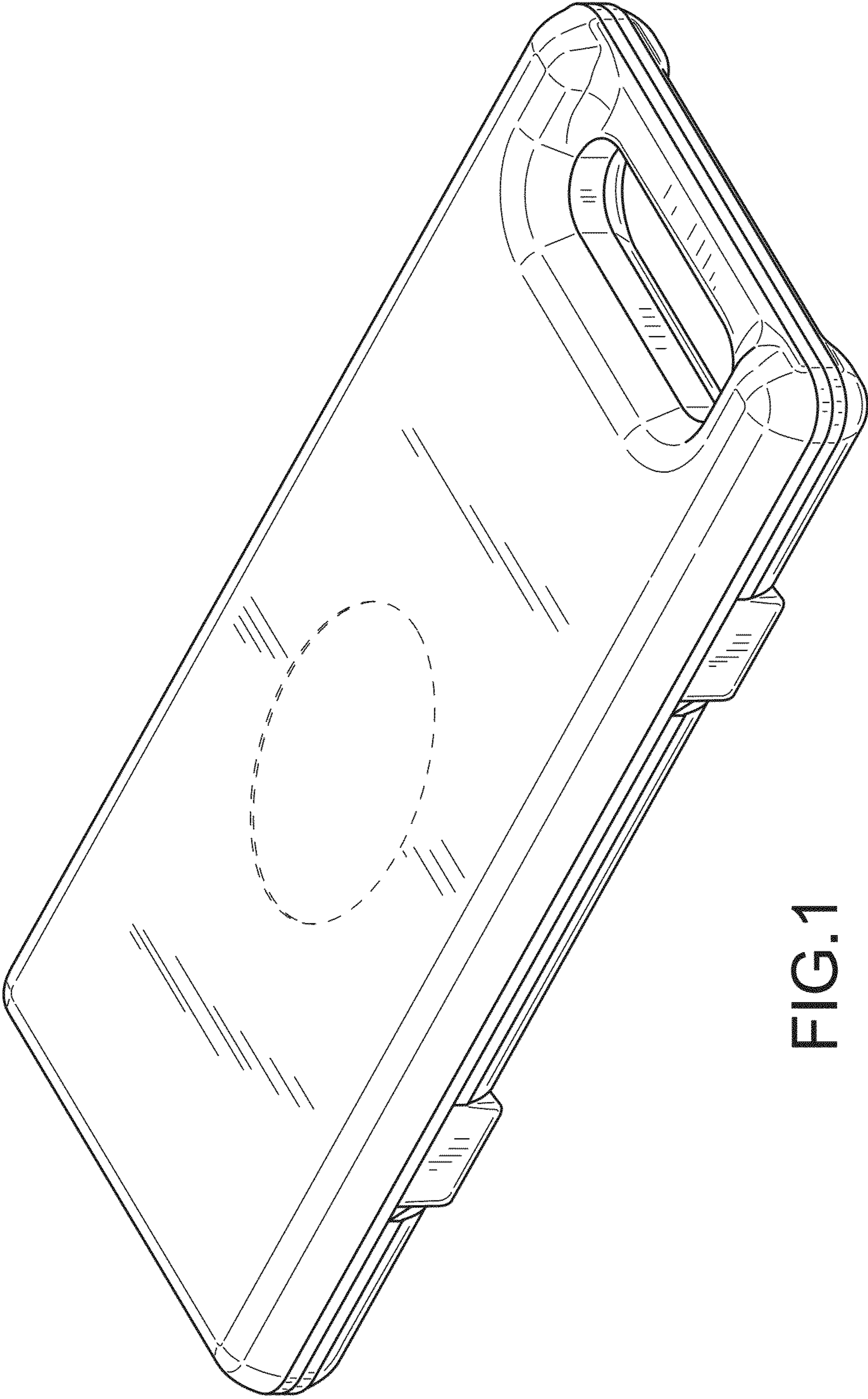

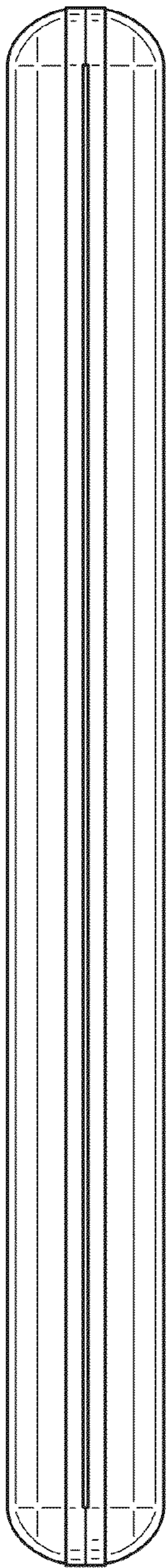

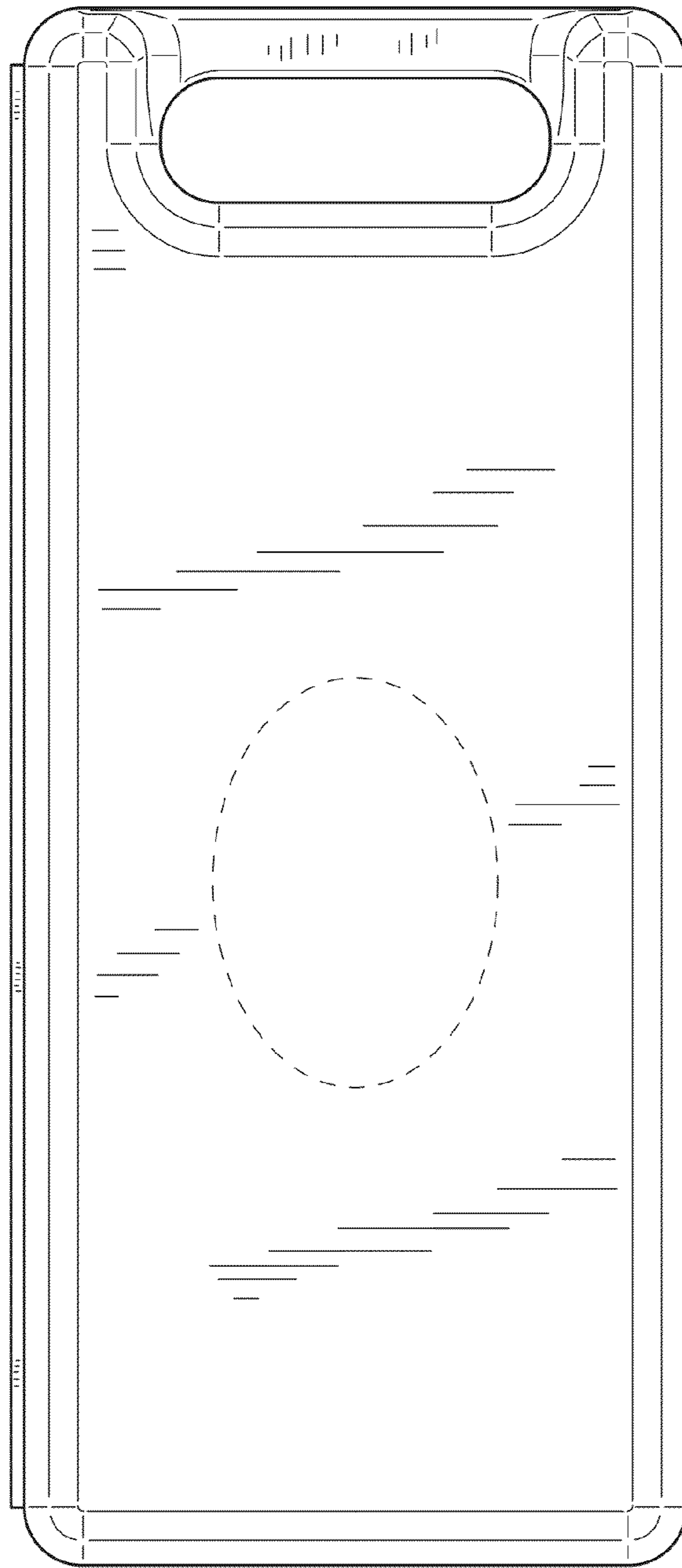

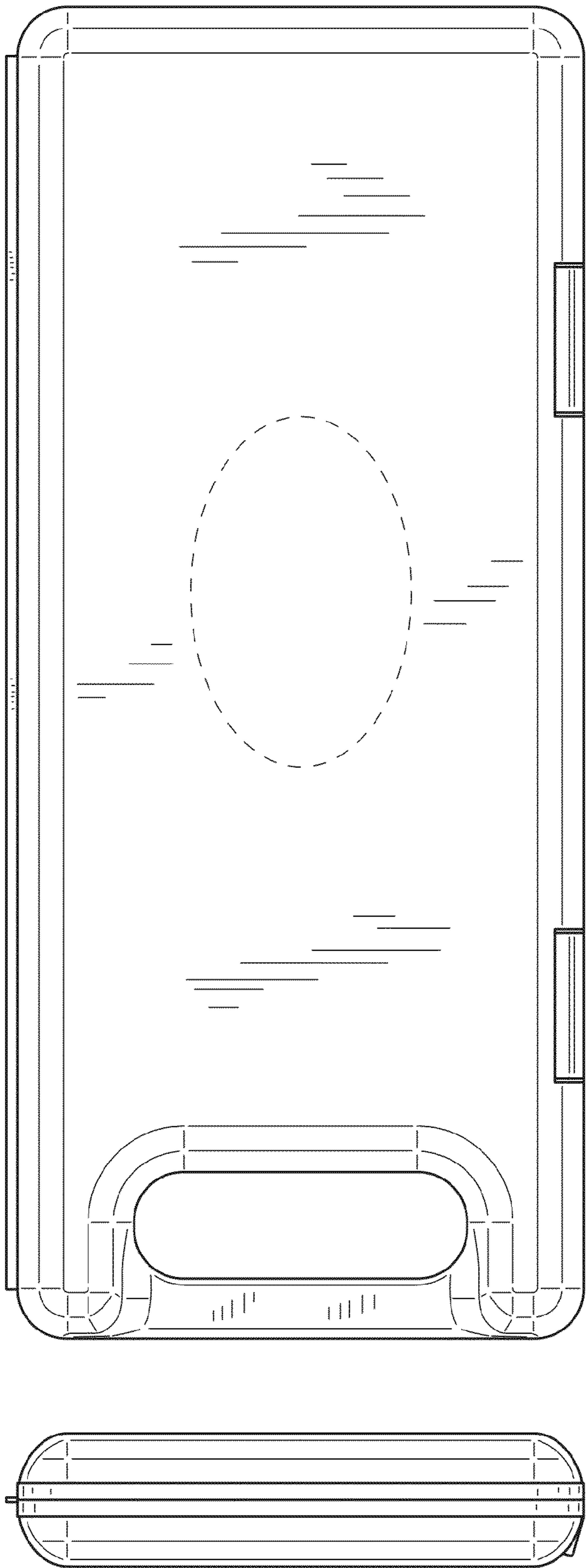

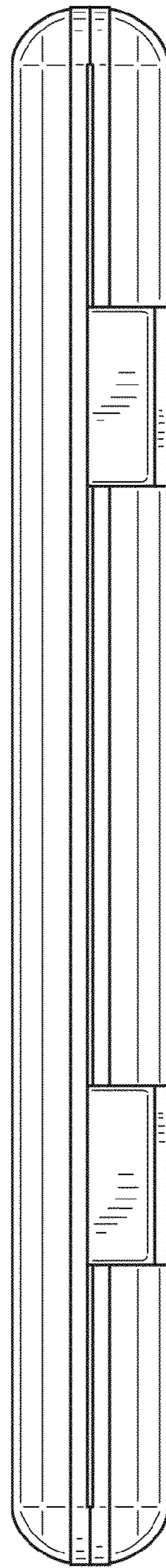

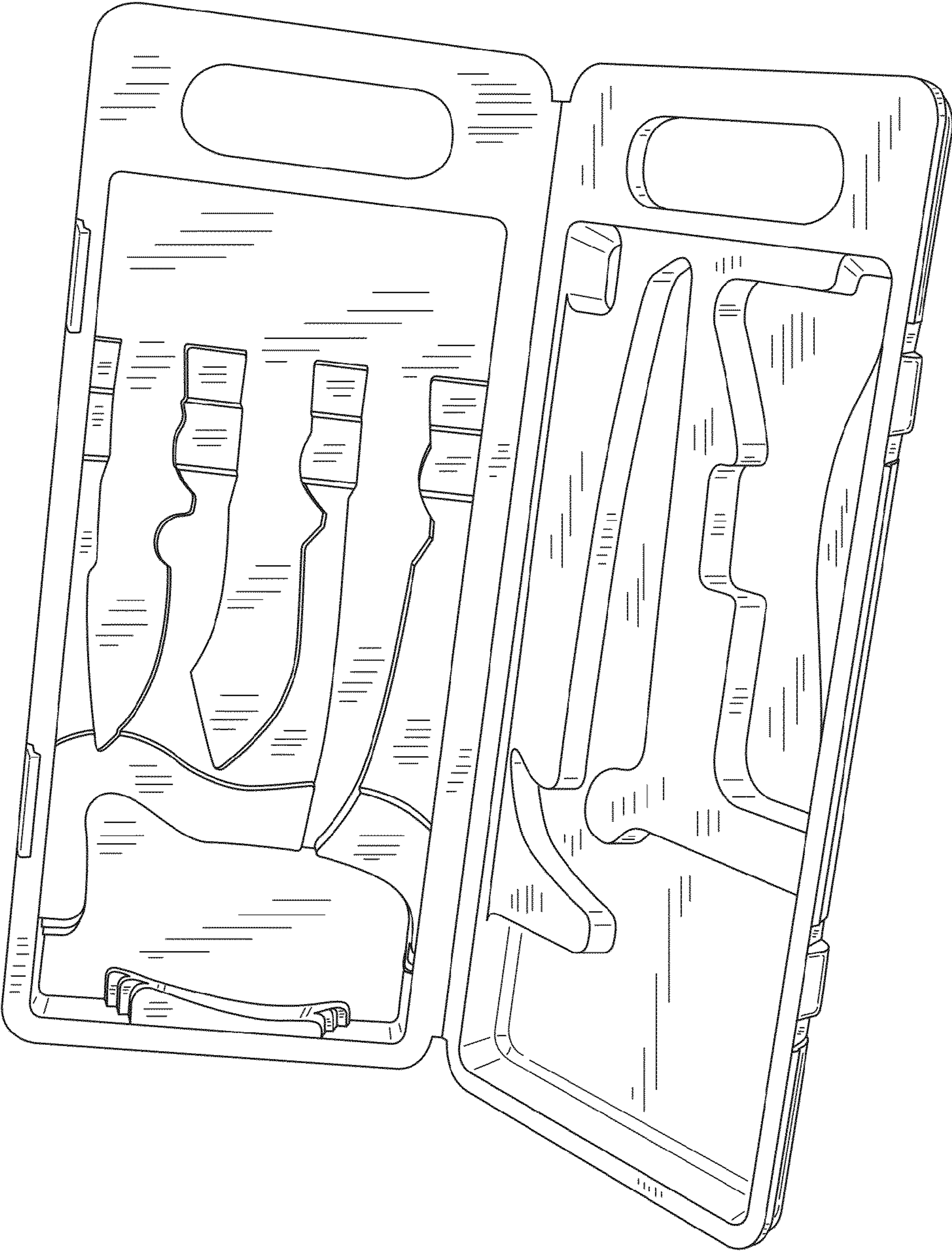
