The ornamental design for a mobile phone case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a mobile phone case.  
 FIG. 2 is a rear elevation view thereof.  
 FIG. 3 is a top plan view thereof.  
 FIG. 4 is a bottom plan view thereof.  
 FIG. 5 is a left side elevation view thereof.  
 FIG. 6 is a right side elevation view thereof.  
 FIG. 7 is a front view wherein the article is closed by the band.  
 FIG. 8 is a rear view wherein the article is closed by the band.  
 FIG. 9 is a top plan view wherein the article is closed by the band.  
 FIG. 10 is a bottom plan view wherein the article is closed by the band.  
 FIG. 11 is a left side view wherein the article is closed by the band.  
 FIG. 12 is a right side view wherein the article is closed by the band.  
 FIG. 13 is an enlarged cross-sectional view taken along the line 13-13 in FIG. 1.  
 FIG. 14 is an enlarged cross-sectional view taken along the line 14-14 in FIG. 1.  
 FIG. 15 is an enlarged cross-sectional view taken along the line 15-15 in FIG. 1; and,  
 FIG. 16 is a reference view showing one usage example.  
 The portion of the article shown in broken lines is for the purpose of showing environmental structure only and forms no part of the claimed design.

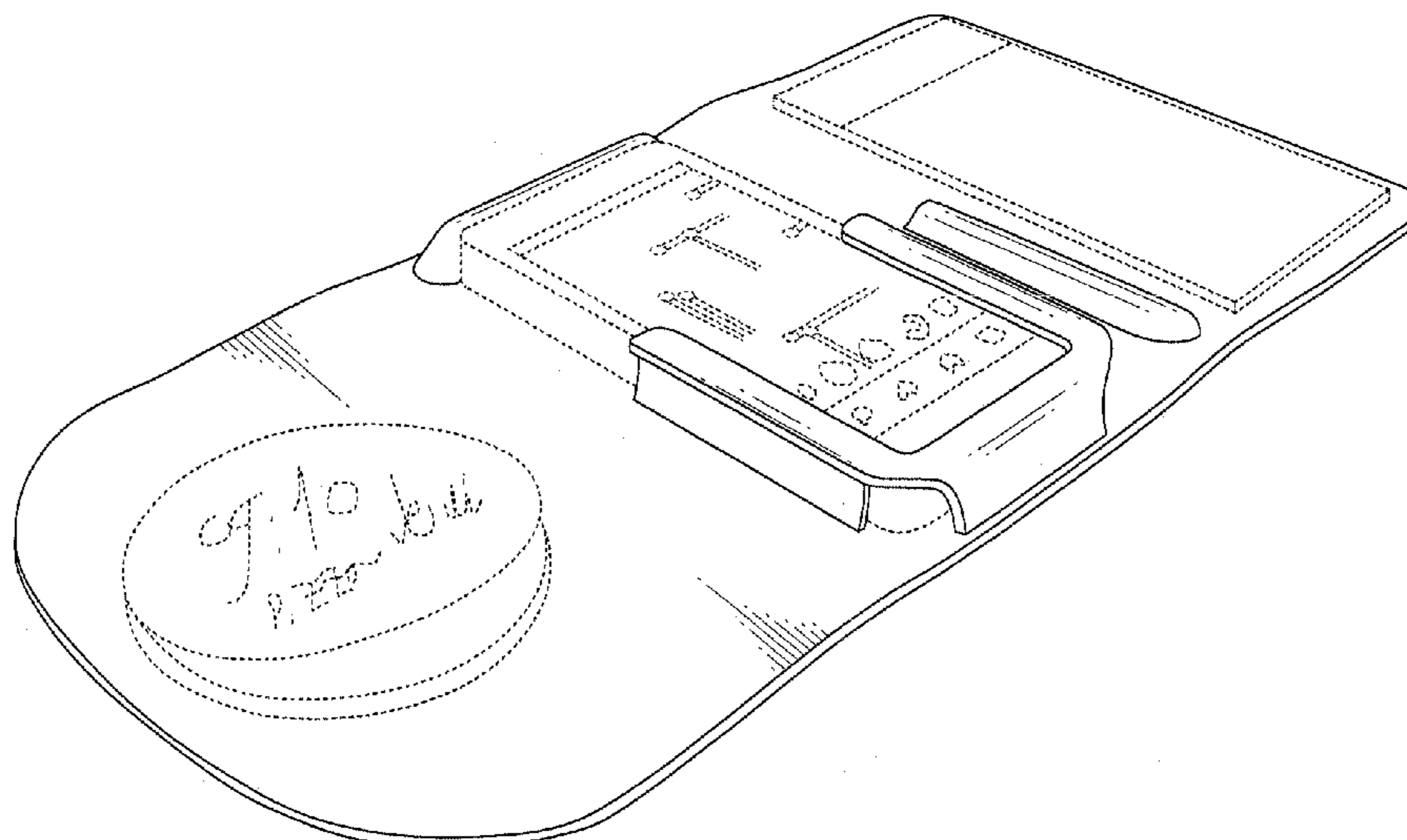

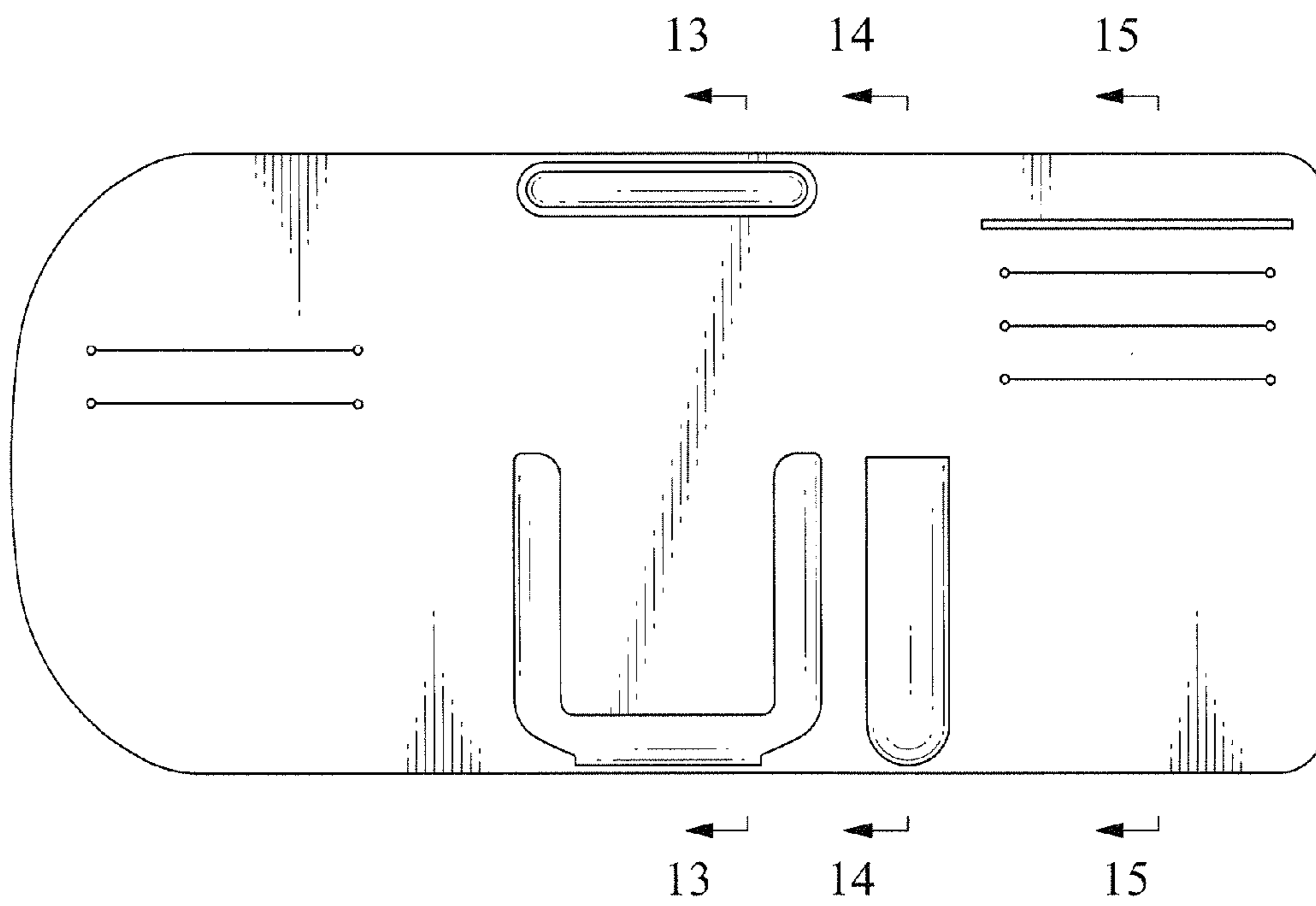

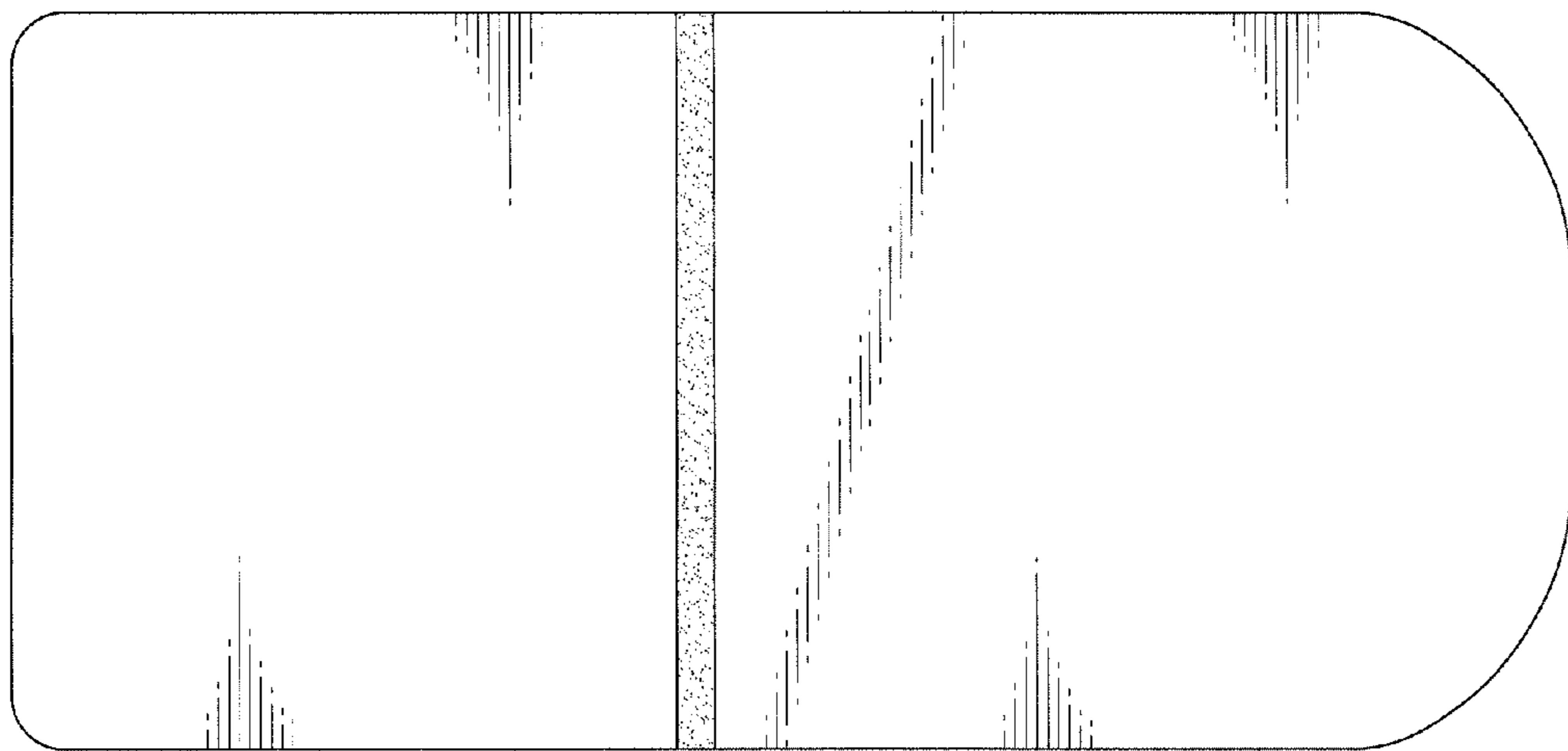

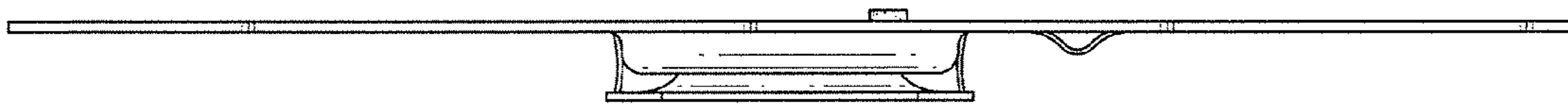

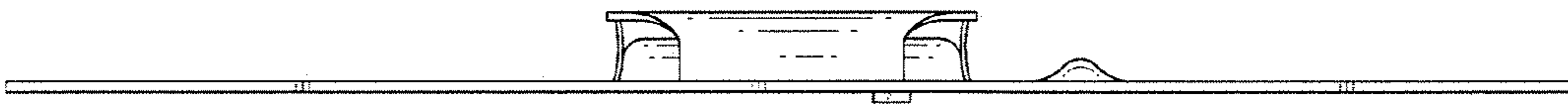

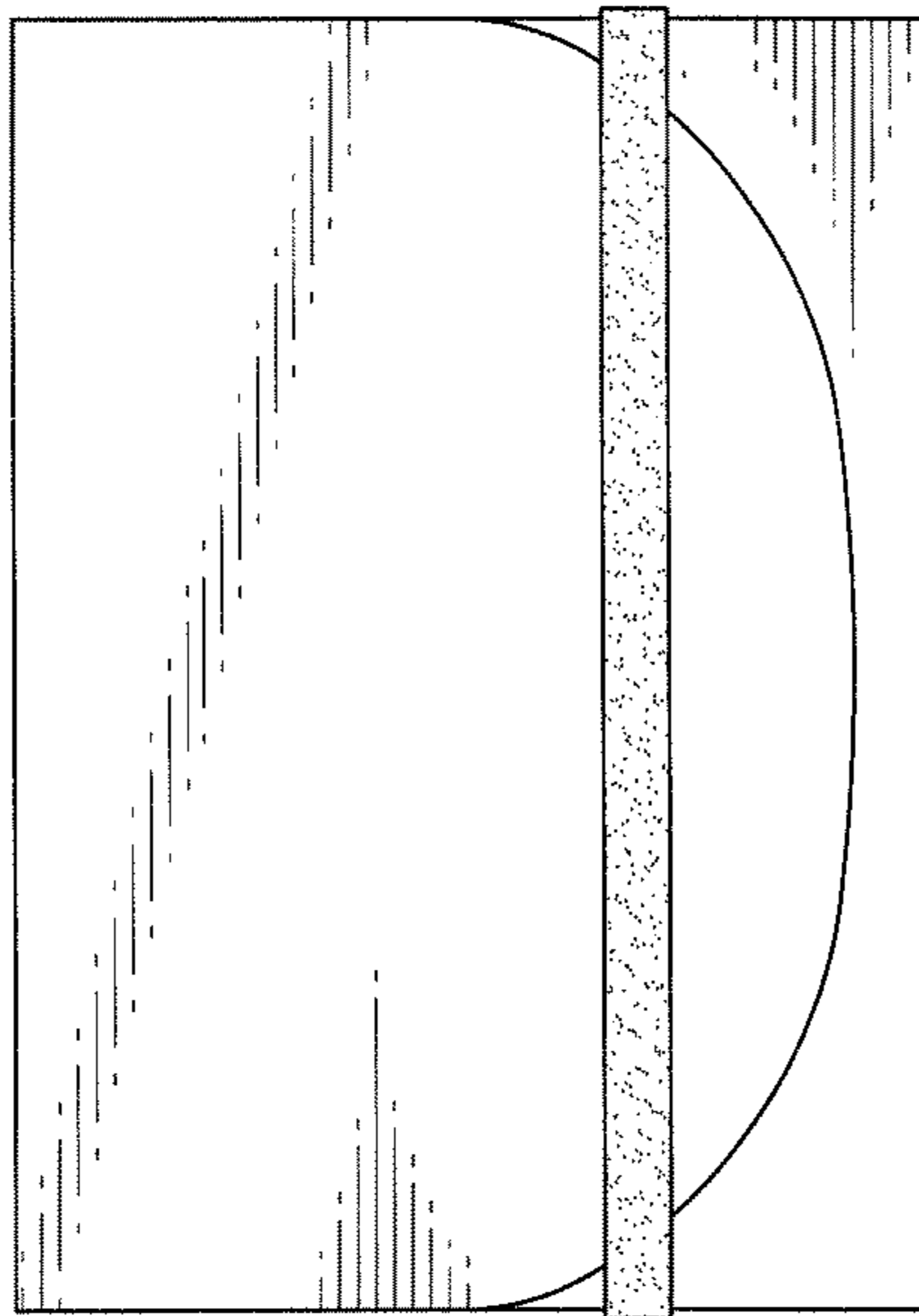

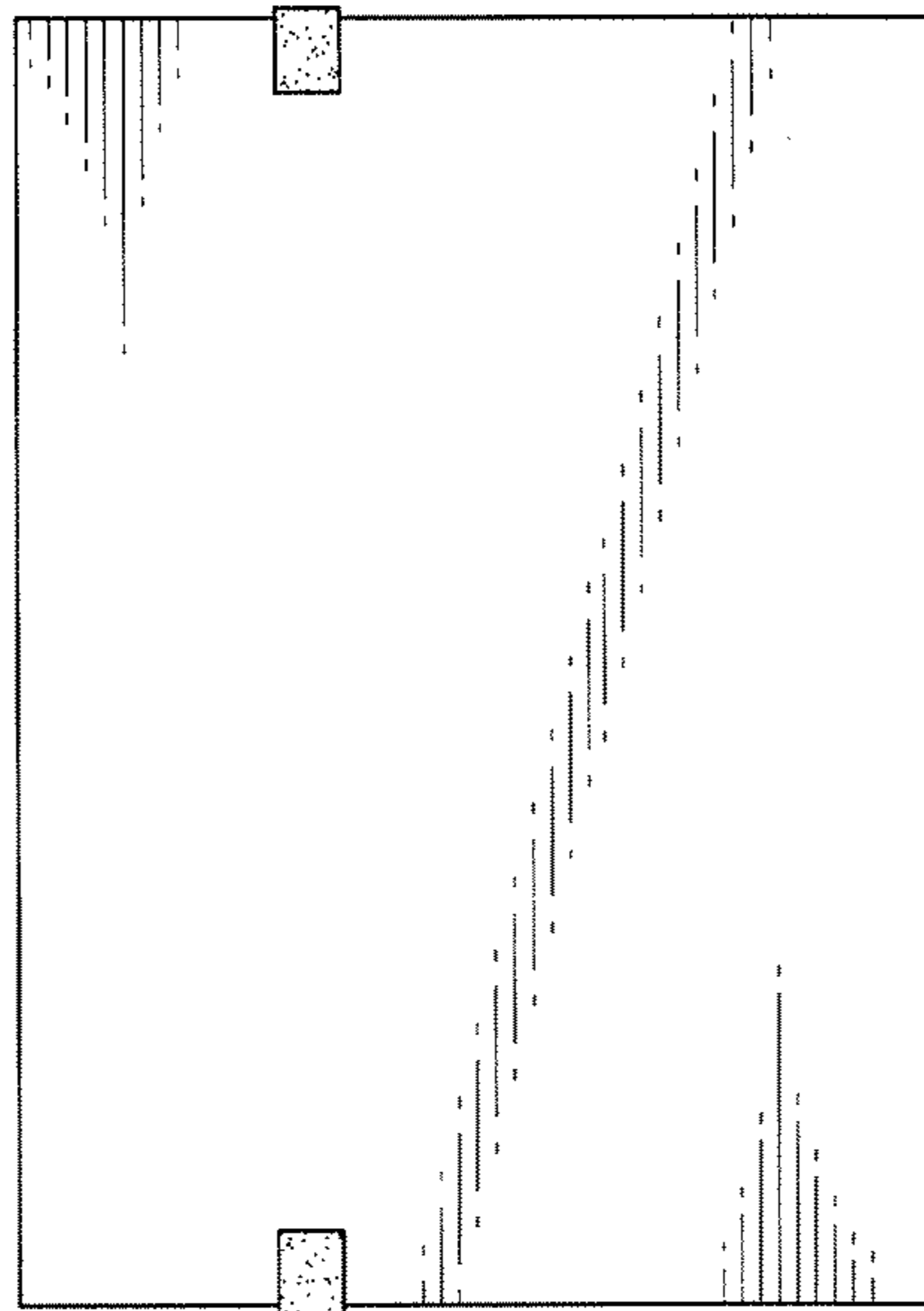

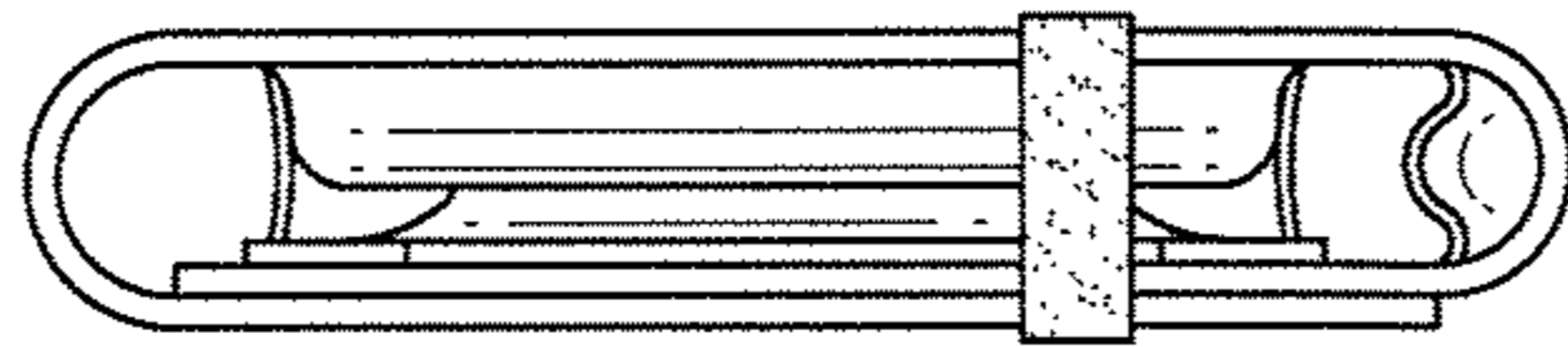

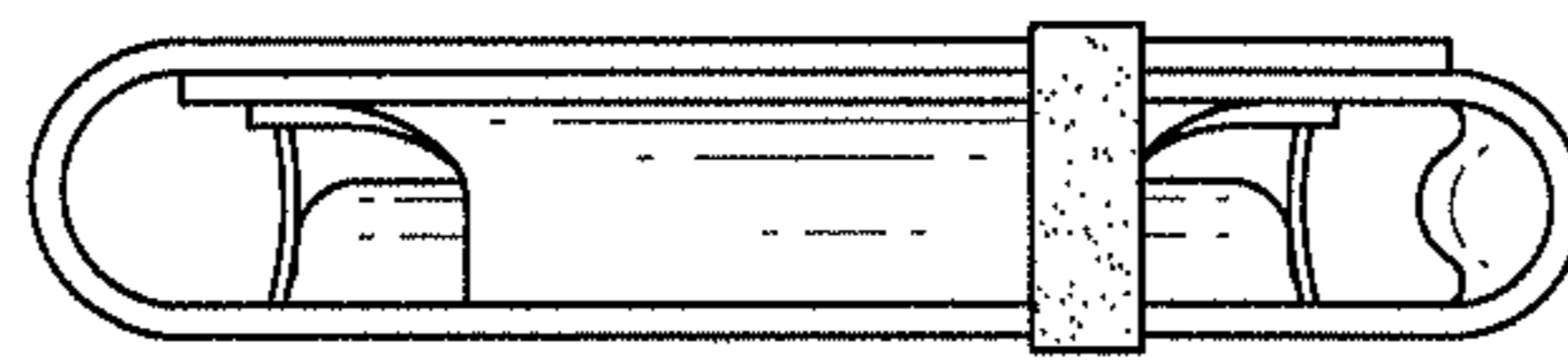

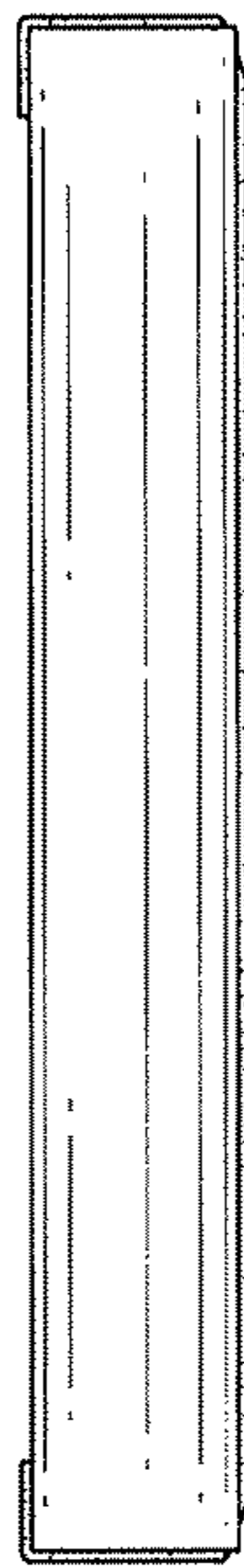

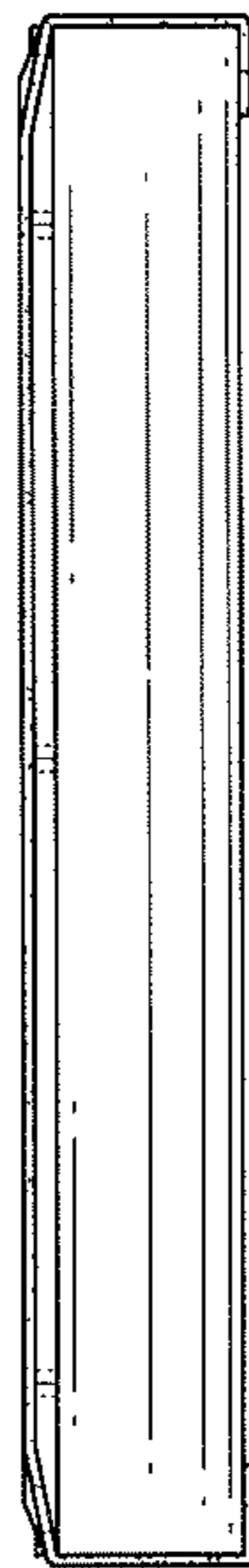

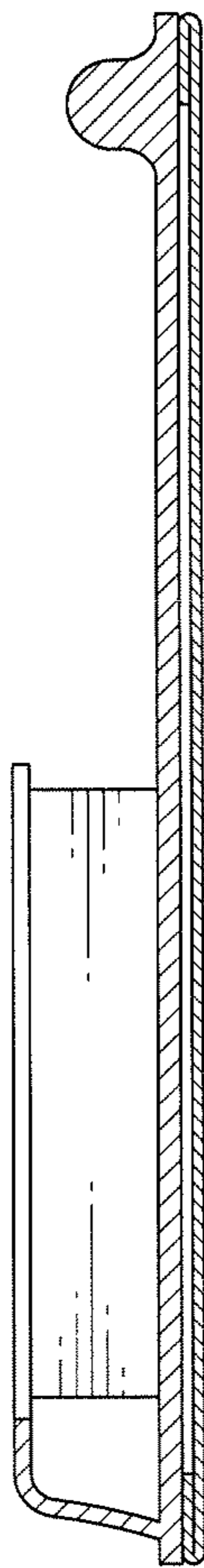

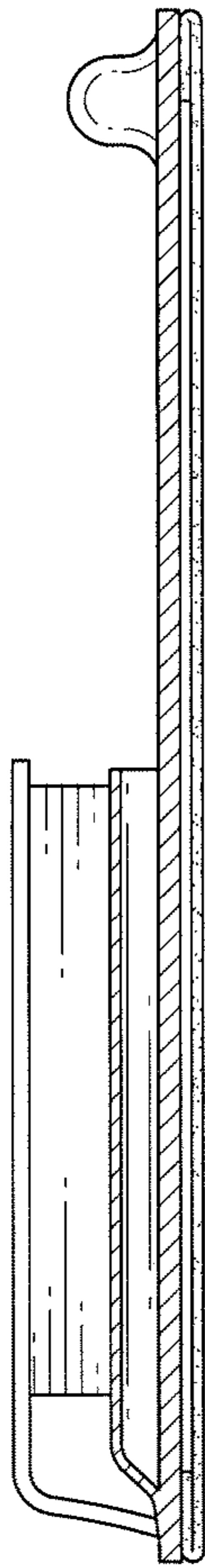

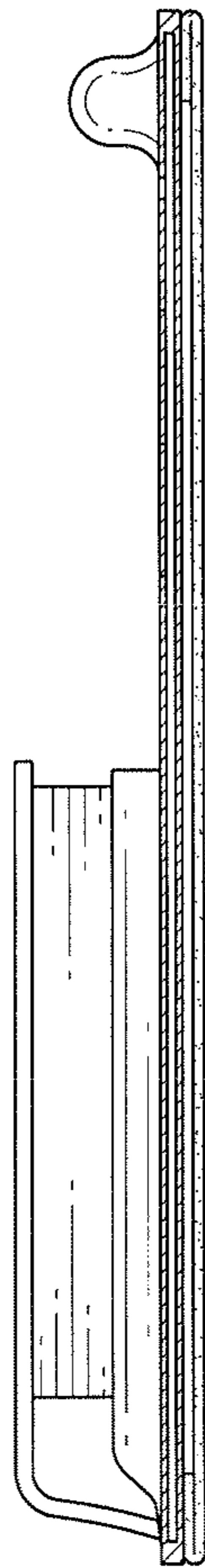
