The ornamental design for an open base for a partition panel, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of an open base for a partition panel, of our new design;
FIG. 2 is a front elevational view;
FIG. 3 is a rear elevational view;
FIG. 4 is a left-hand side elevational view;
FIG. 5 is a right-hand side elevational view;
FIG. 6 is a top plan view;
FIG. 7 is a bottom plan view; and,
FIG. 8 is a bottom isometric view.
The dashed lines in the figures show the environment of the present design and are not part of the present design.

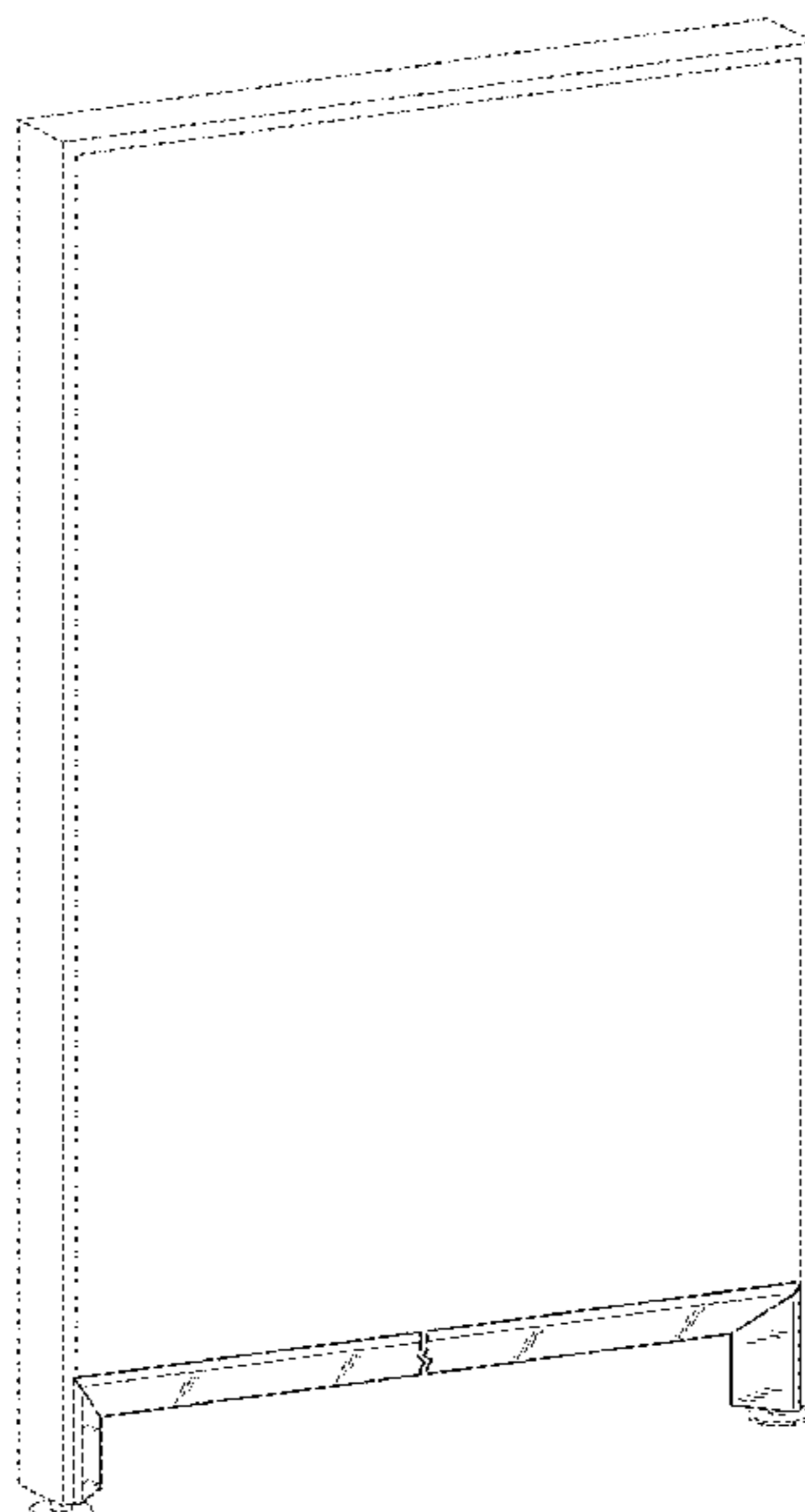

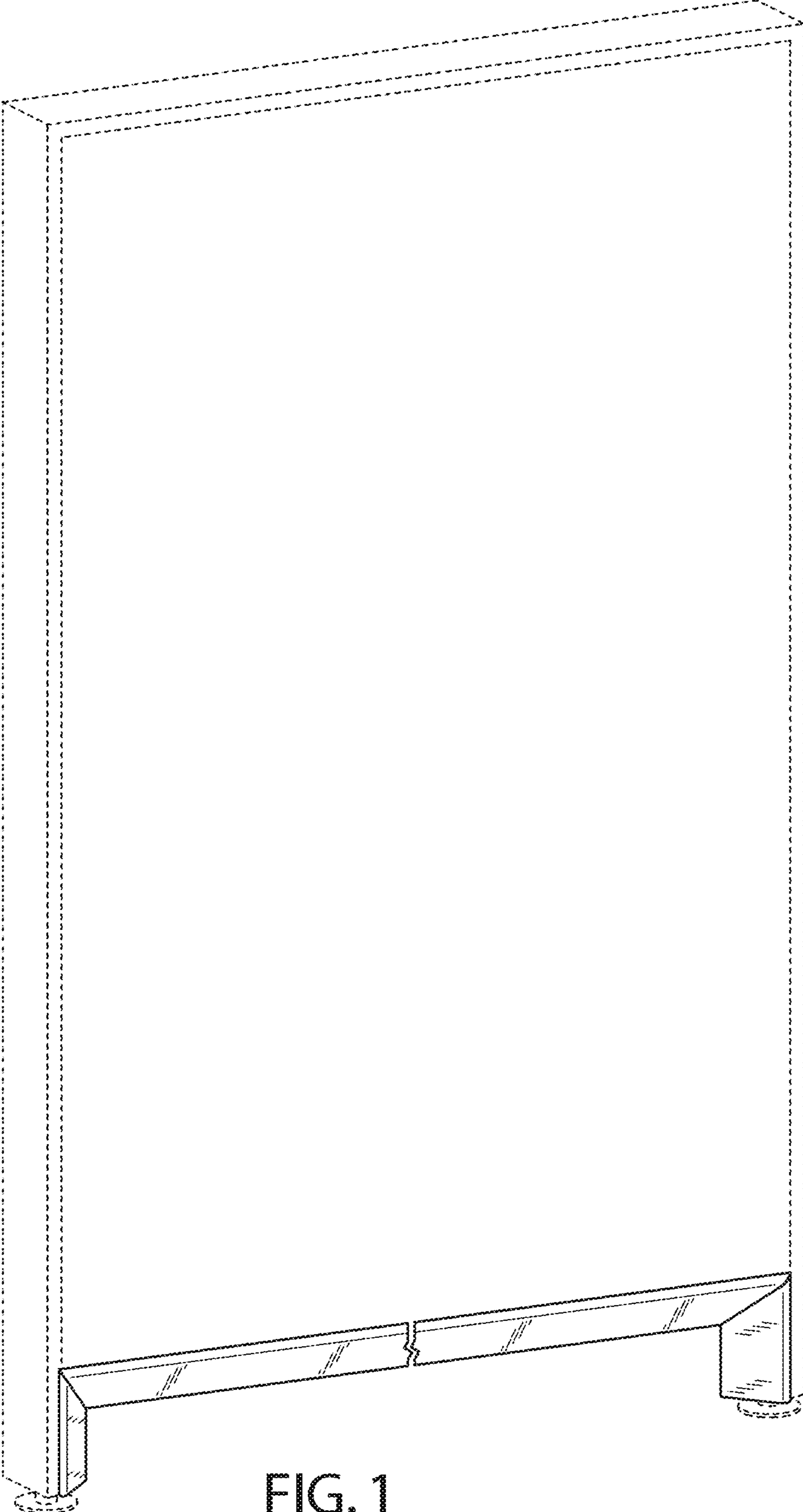

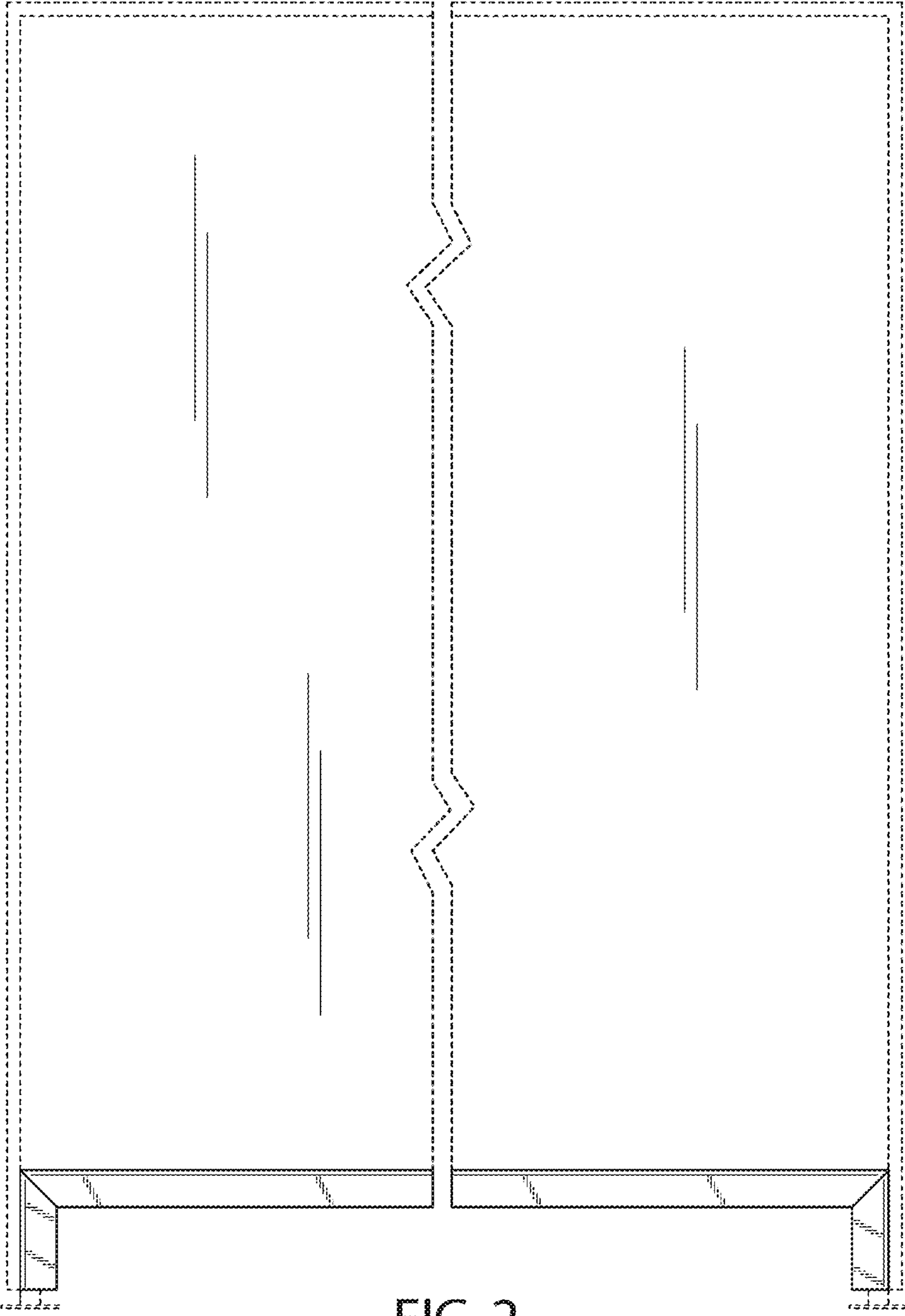

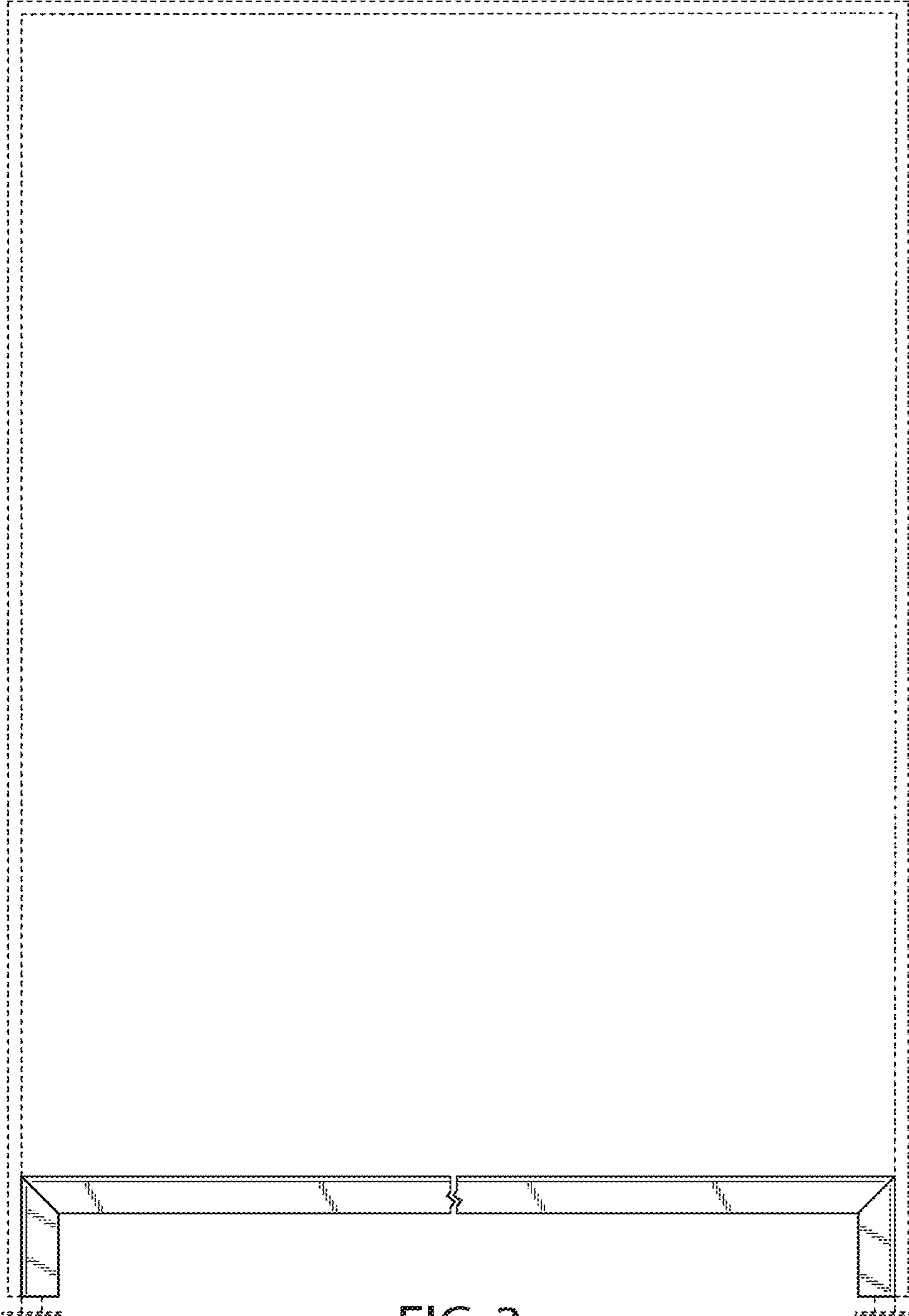

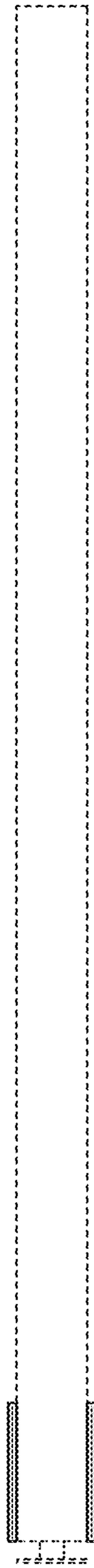

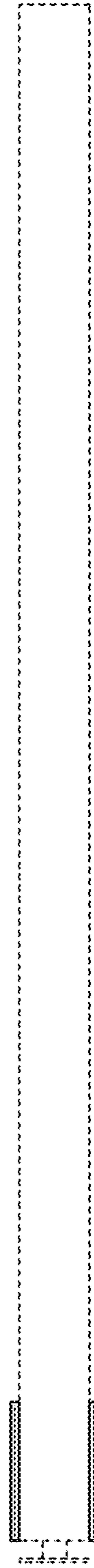

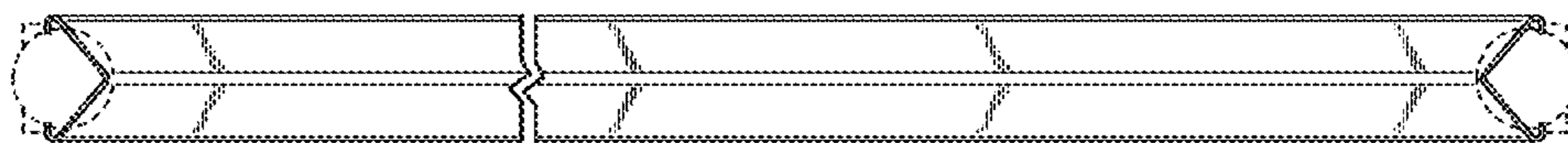

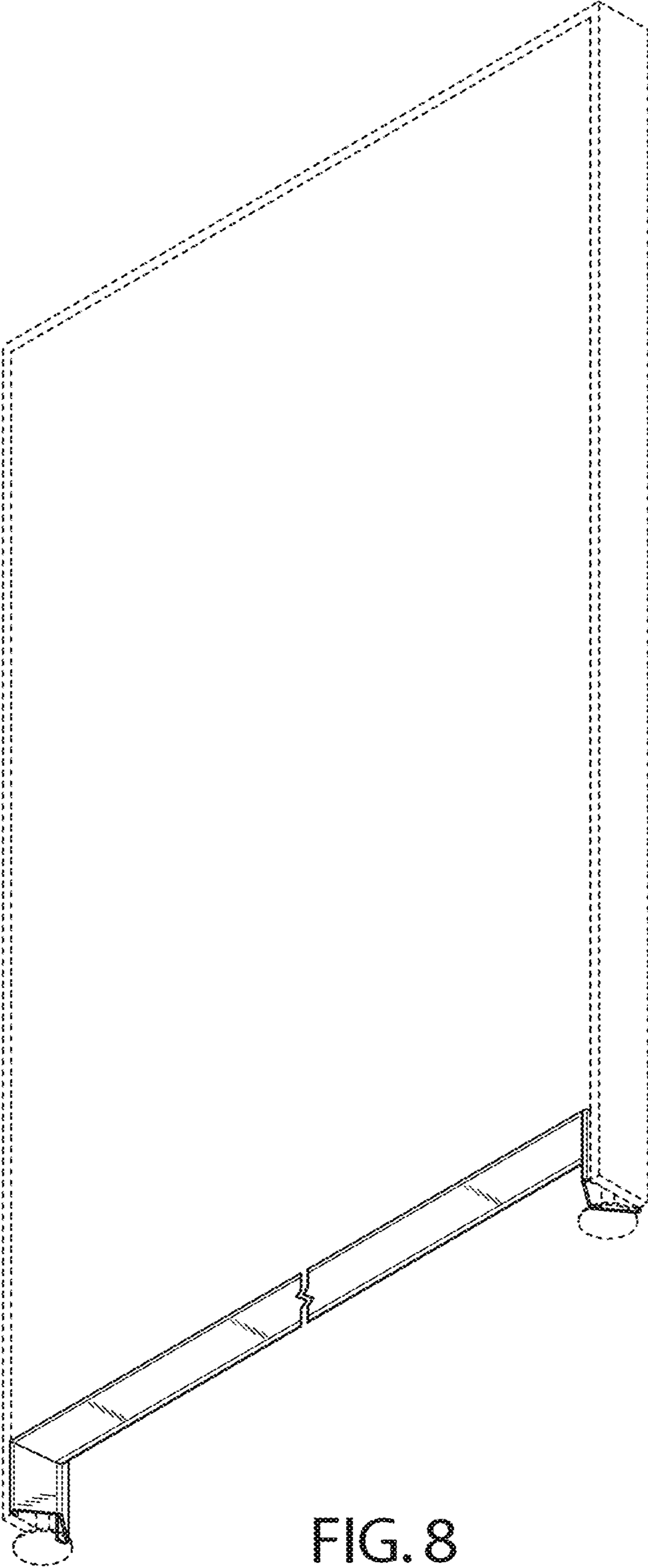
