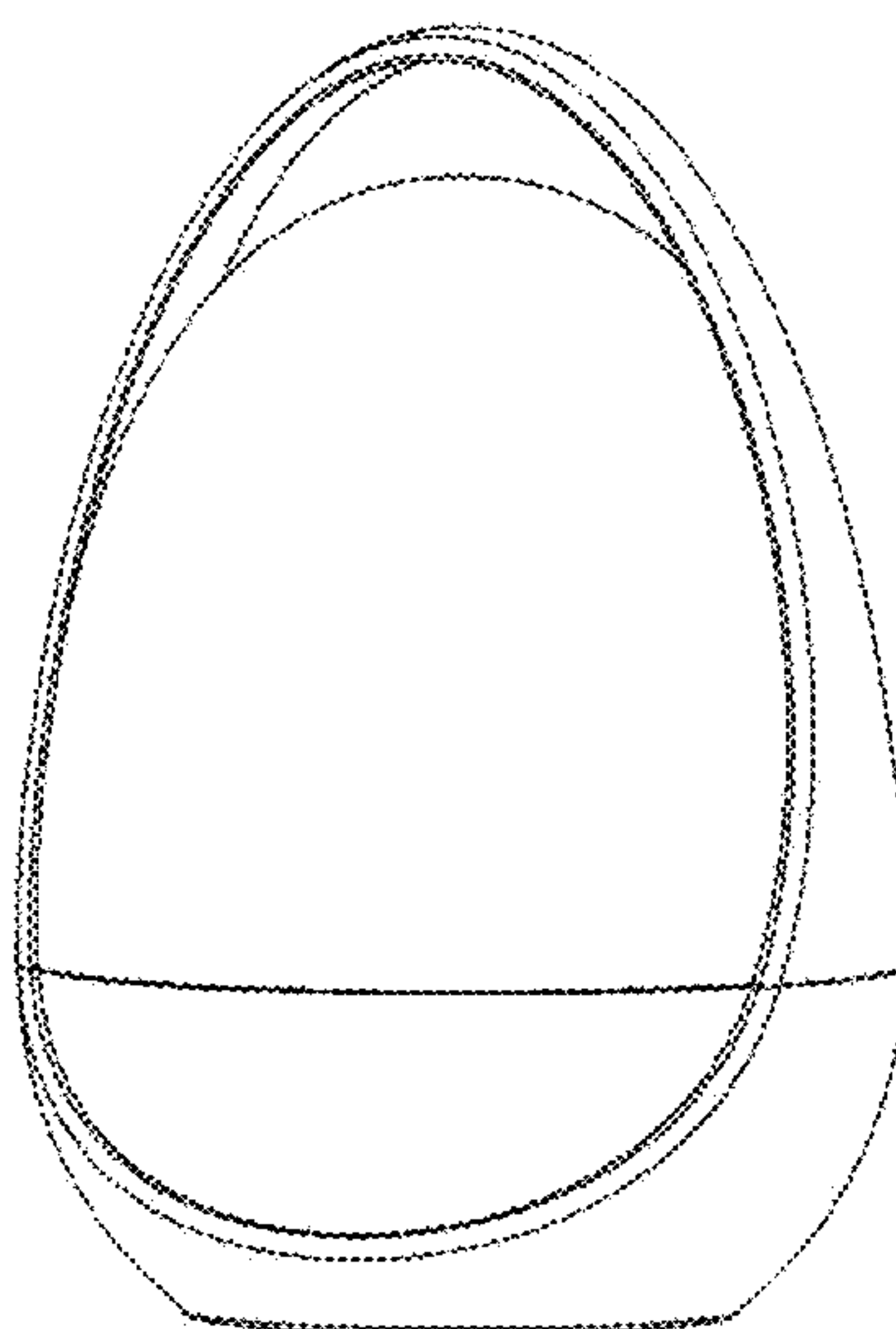
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front side perspective view of an egg cooker showing my new design;

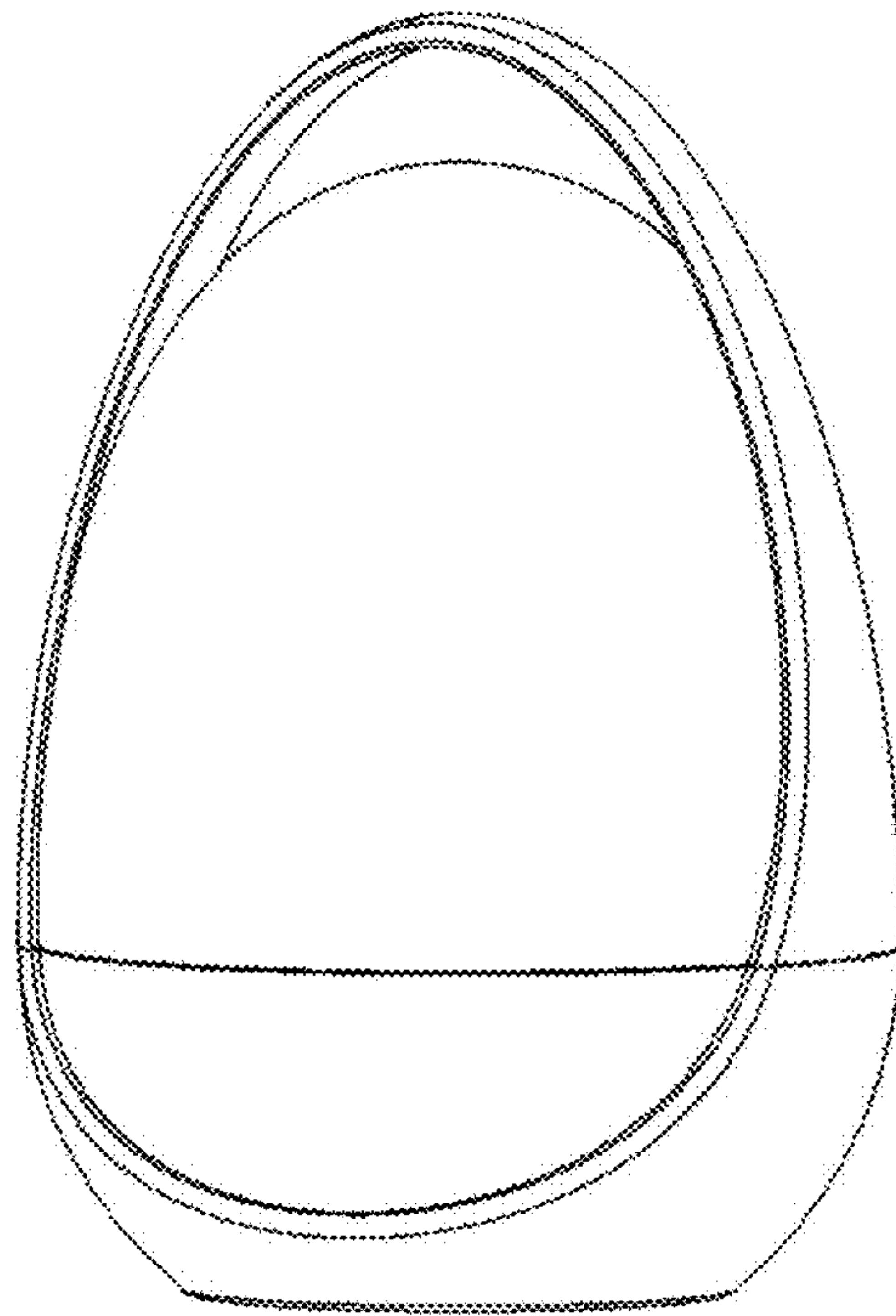

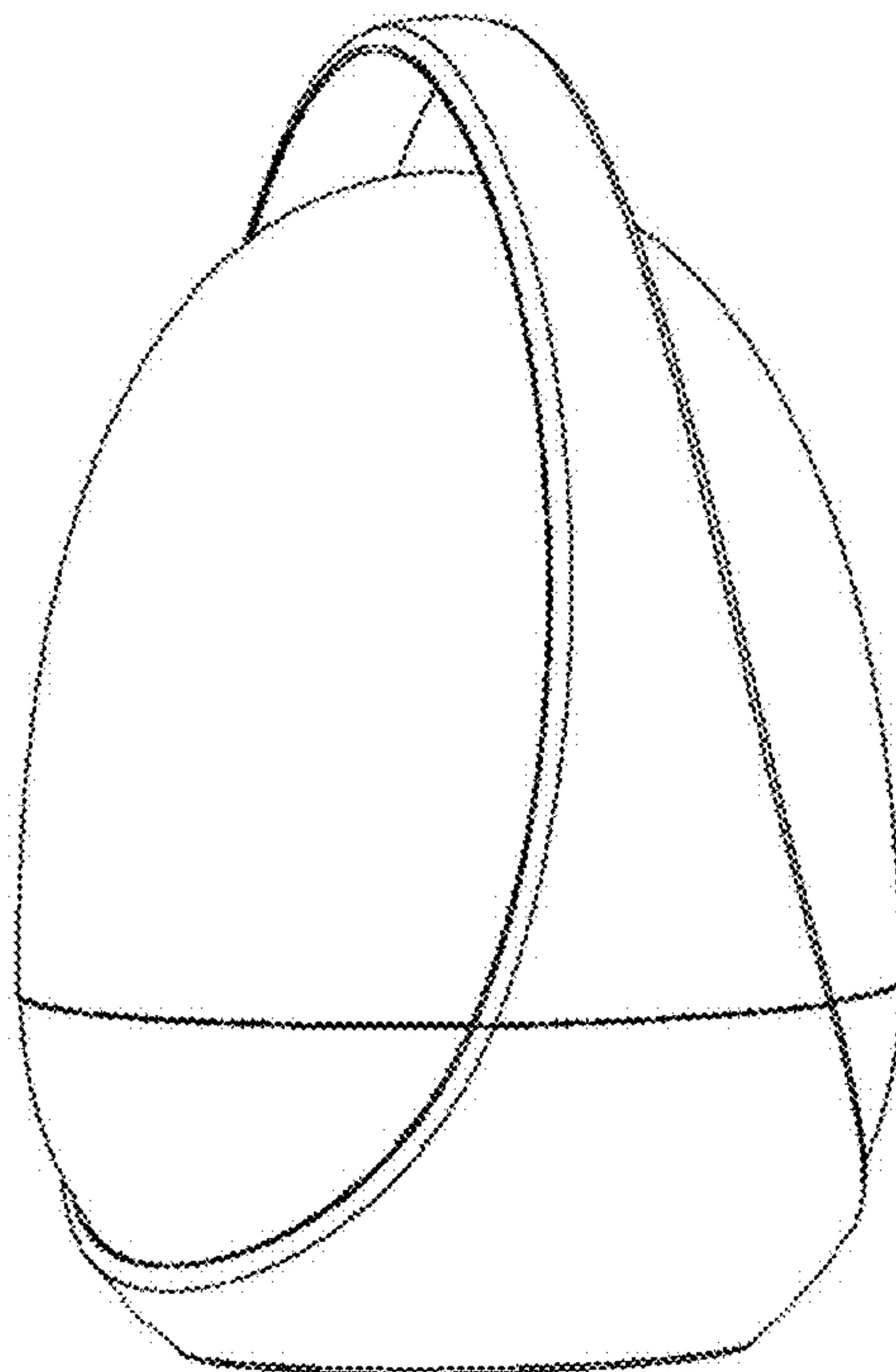

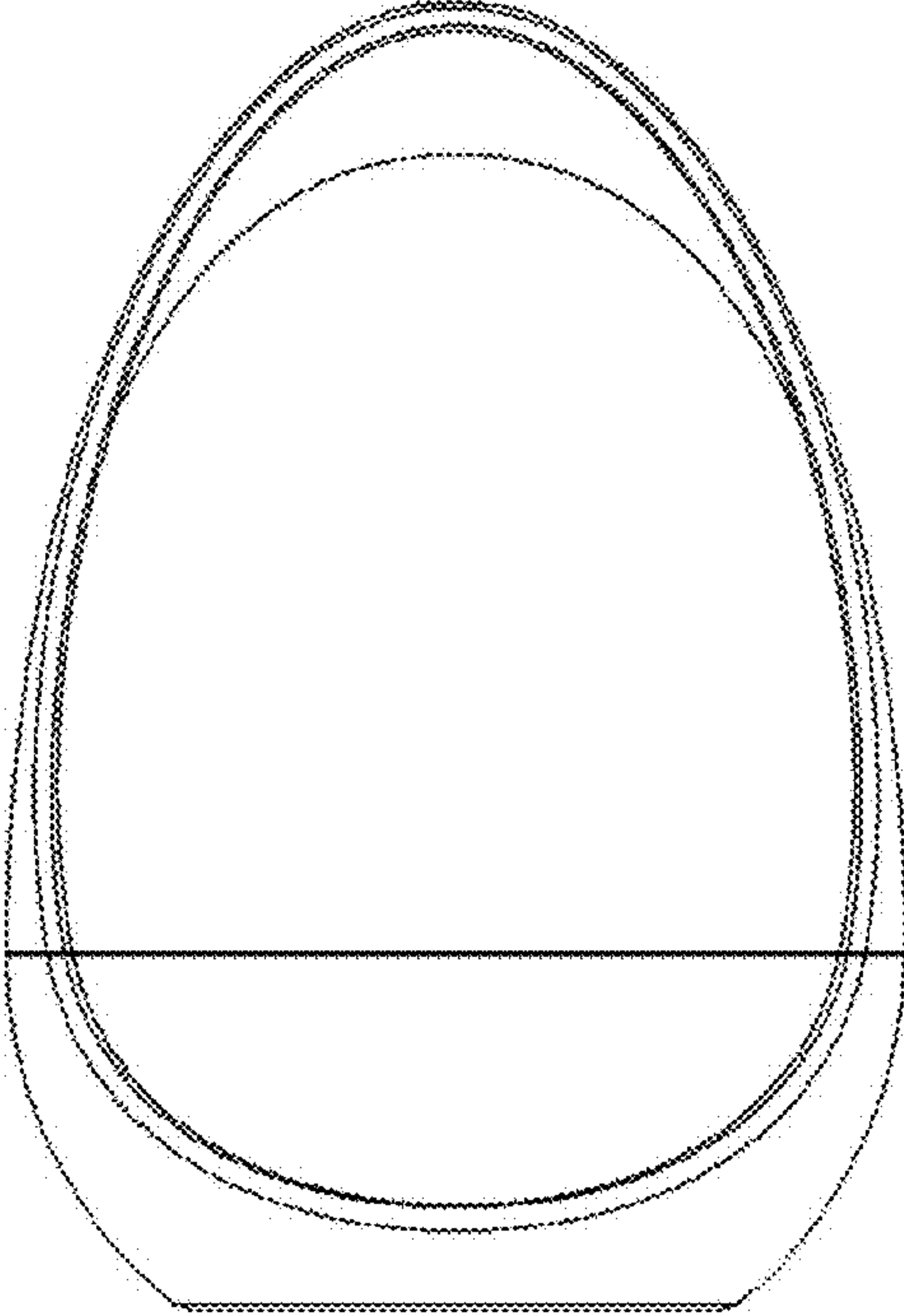

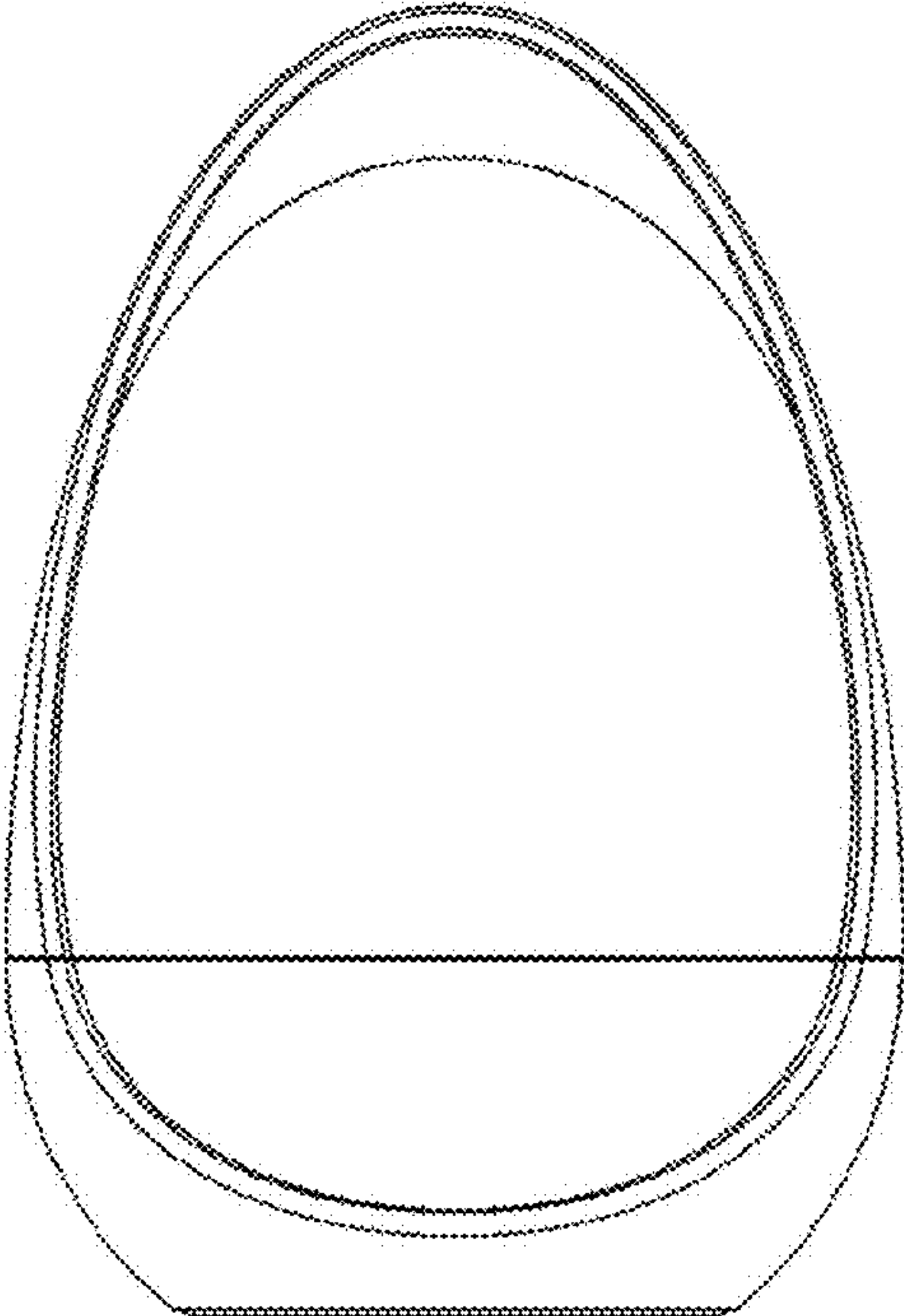

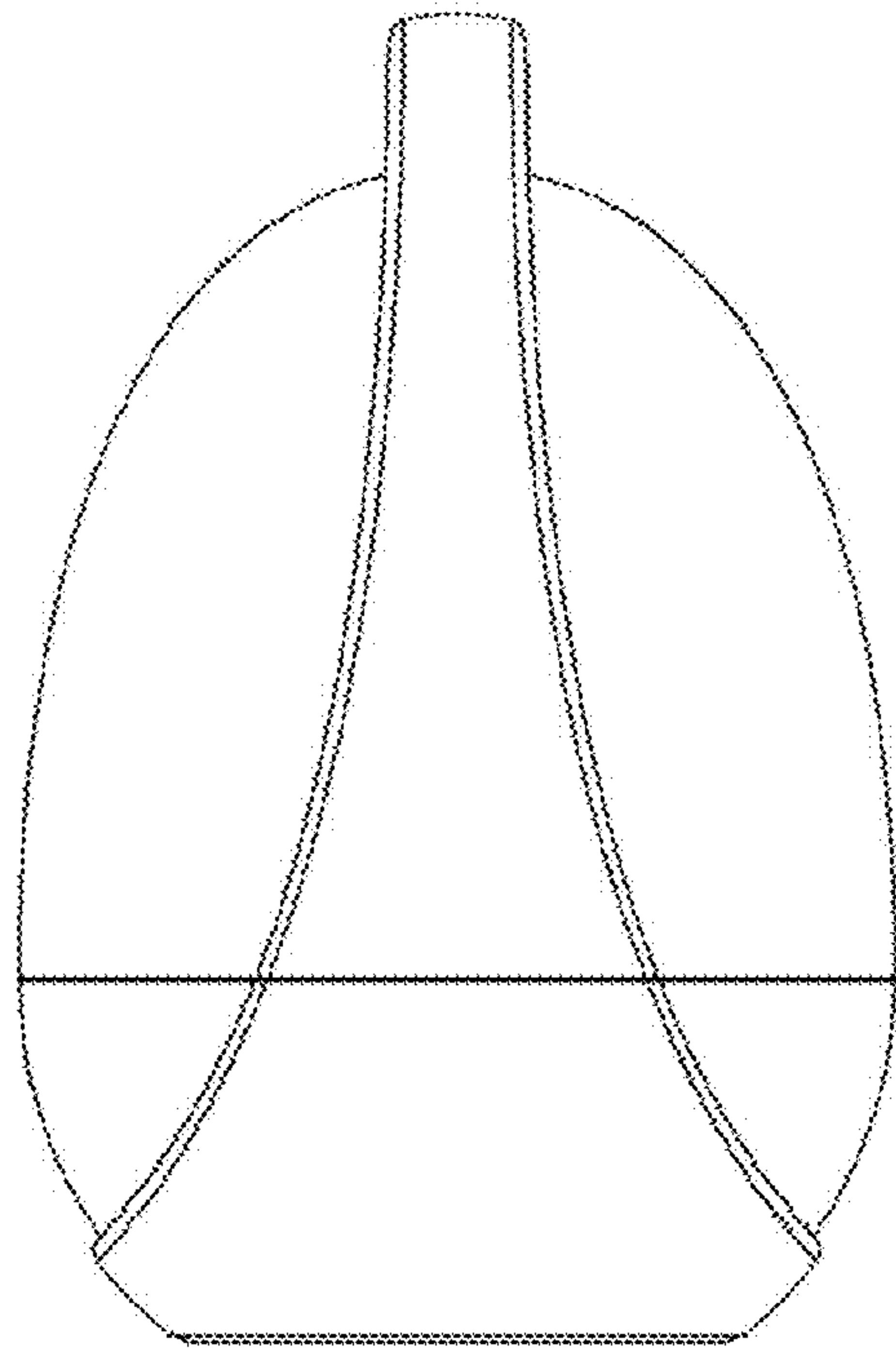

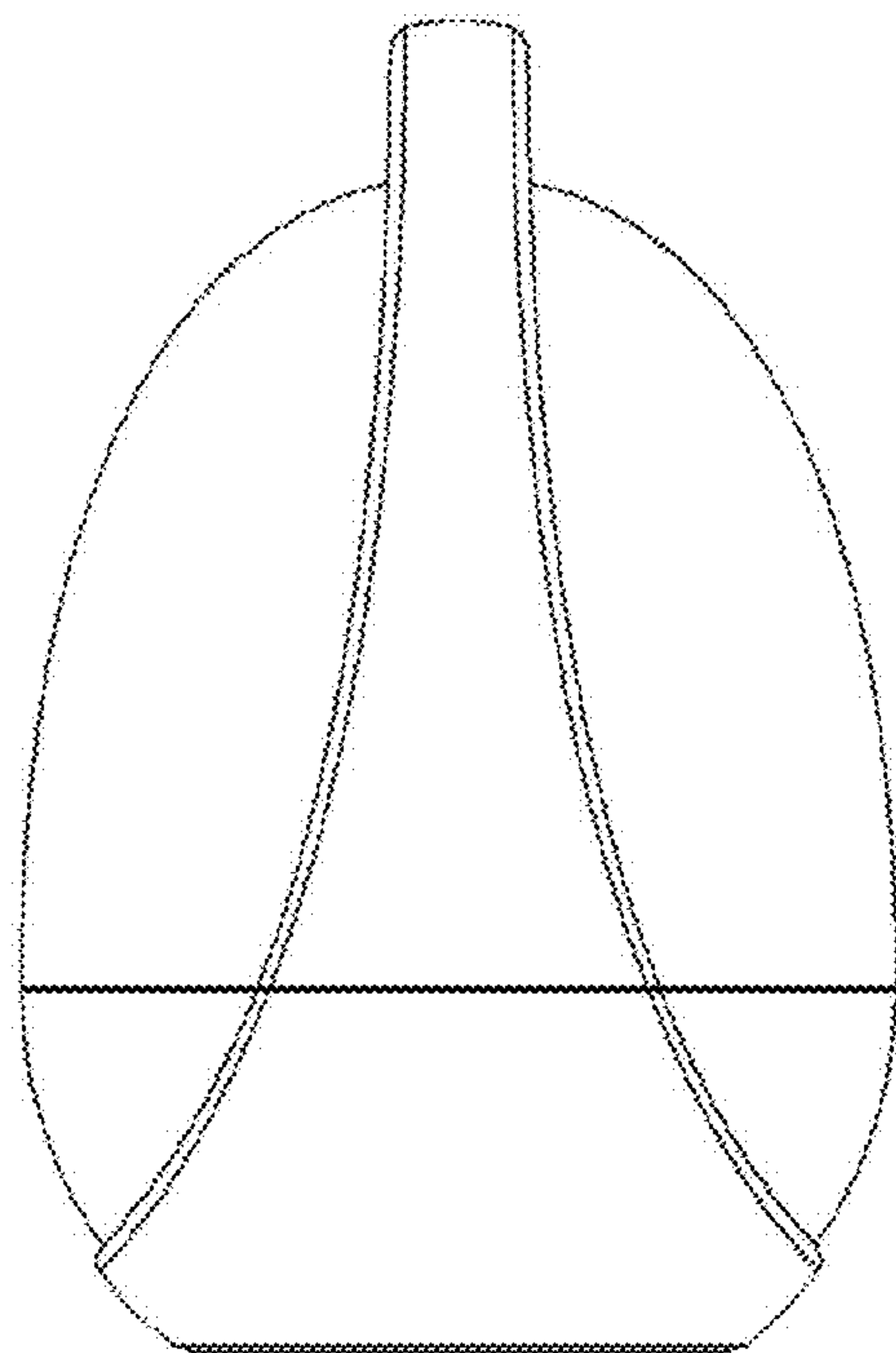

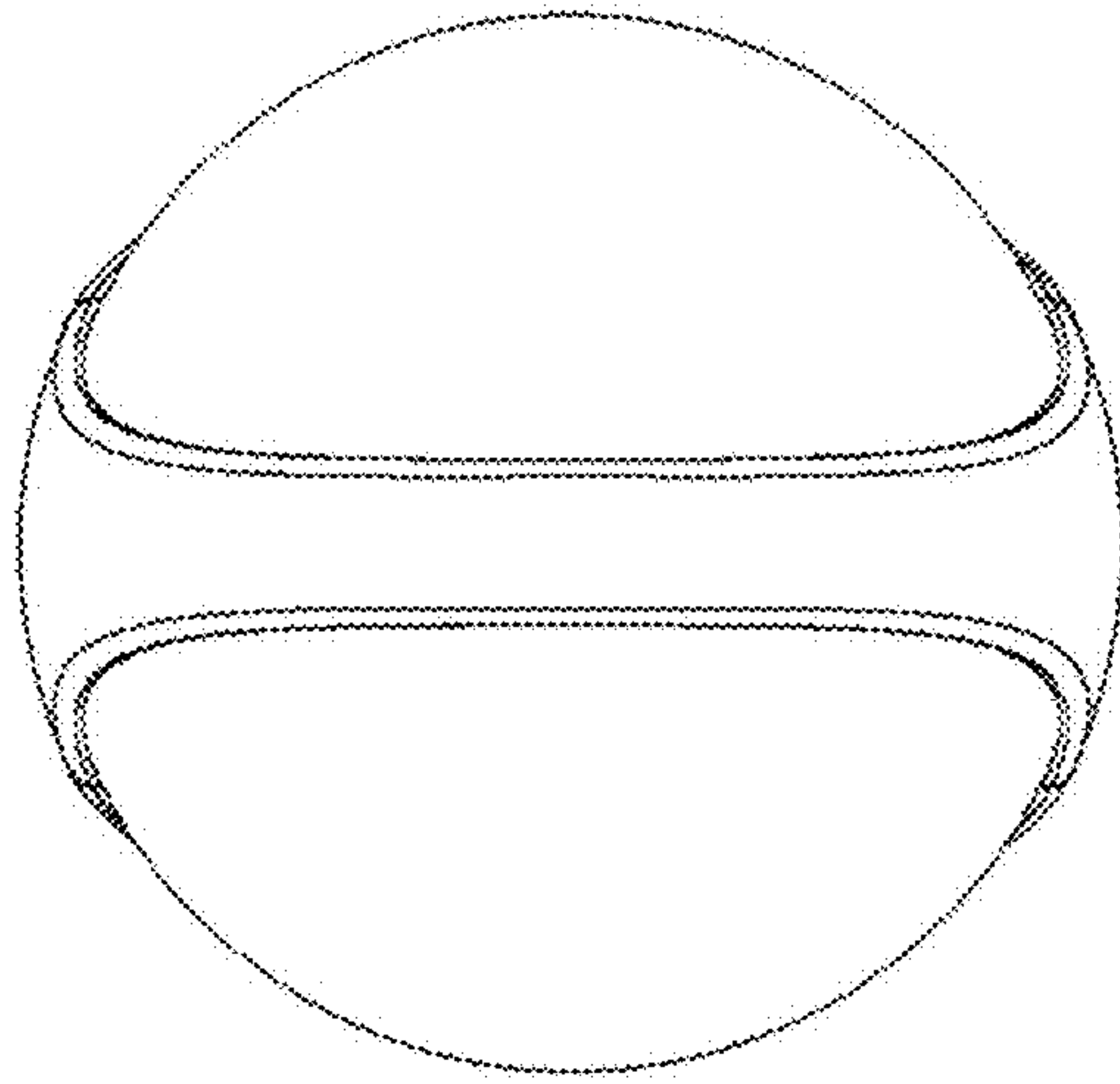

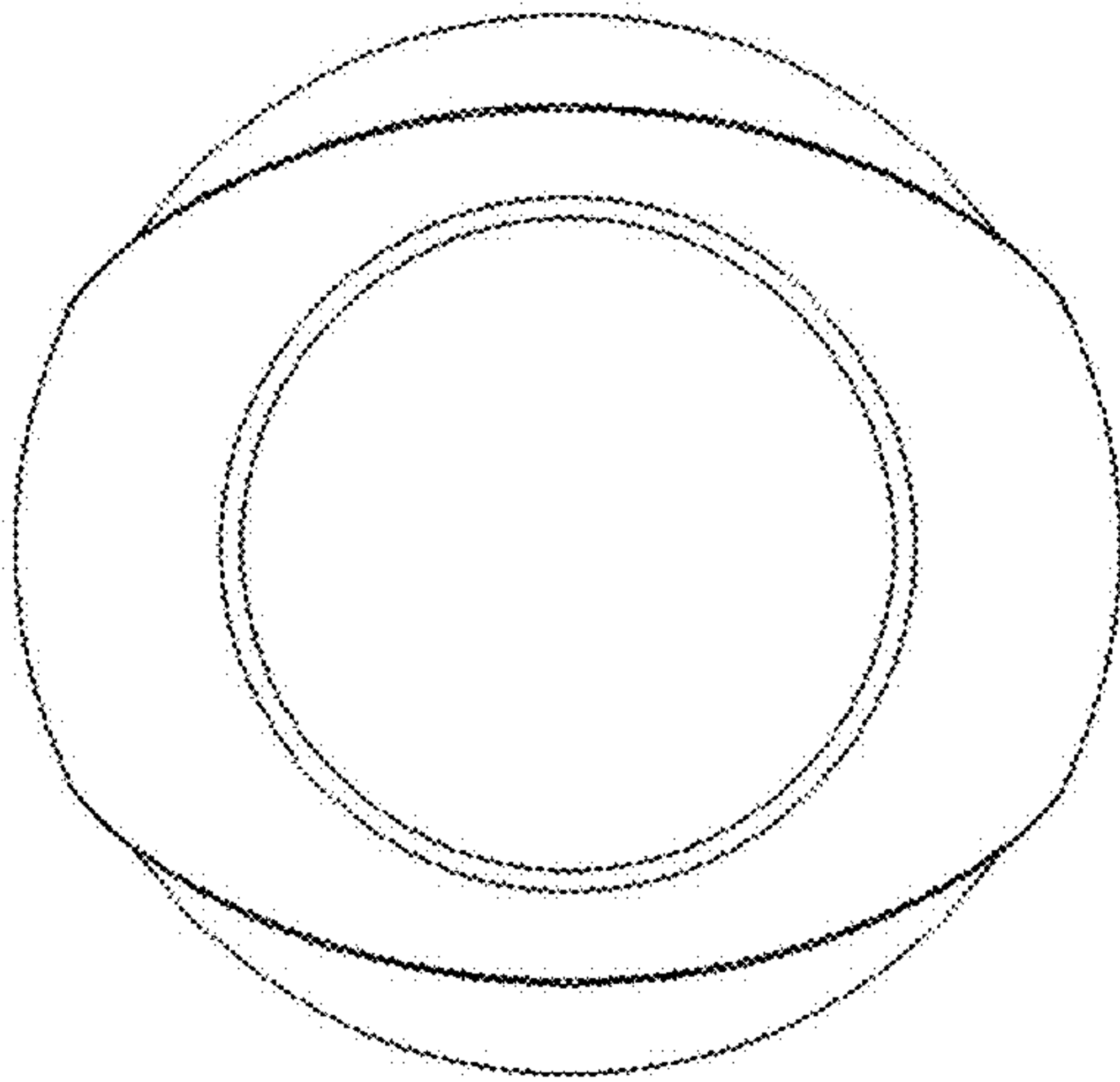
