The ornamental design for a package, as shown and described.

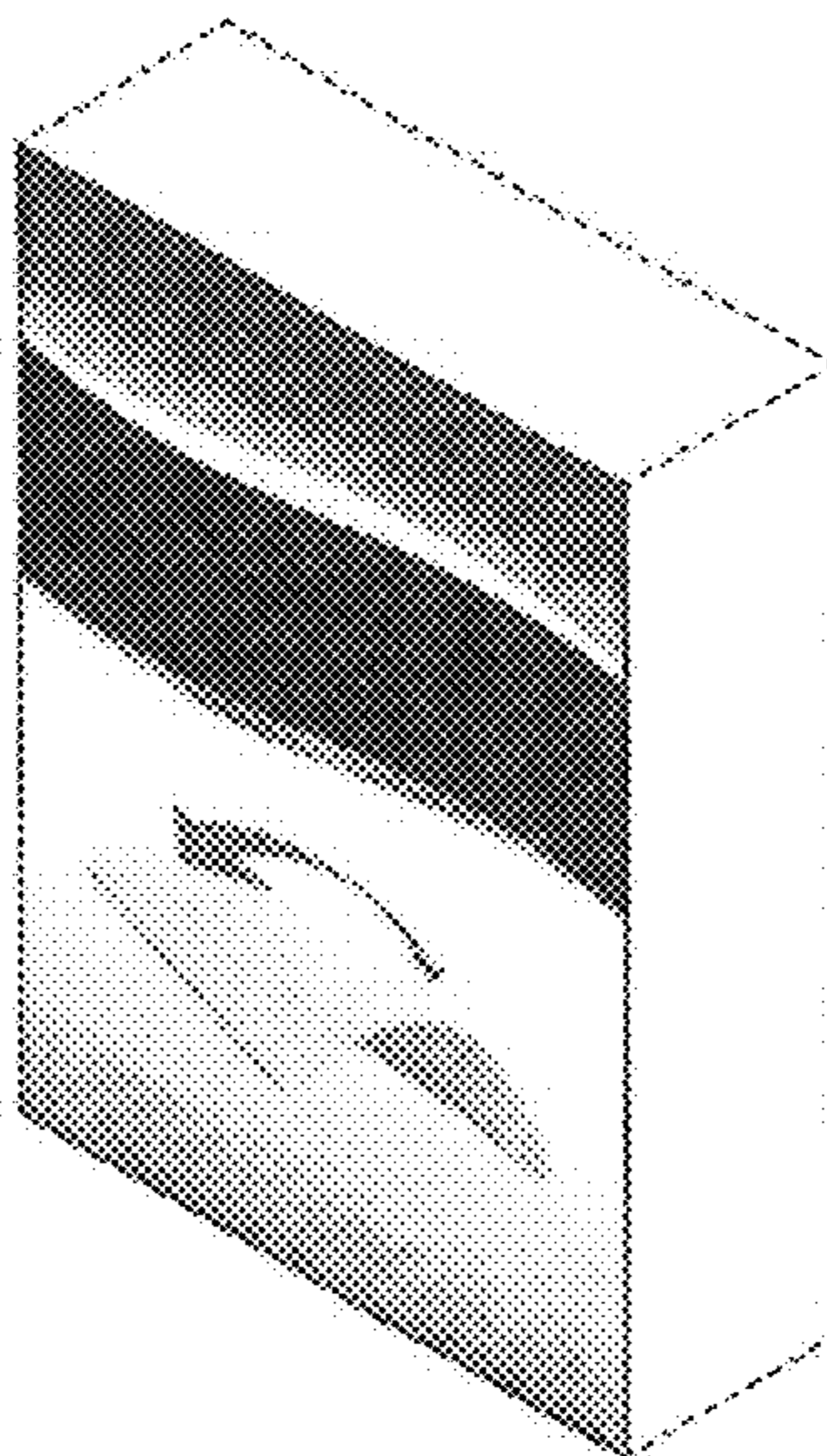
DESCRIPTION

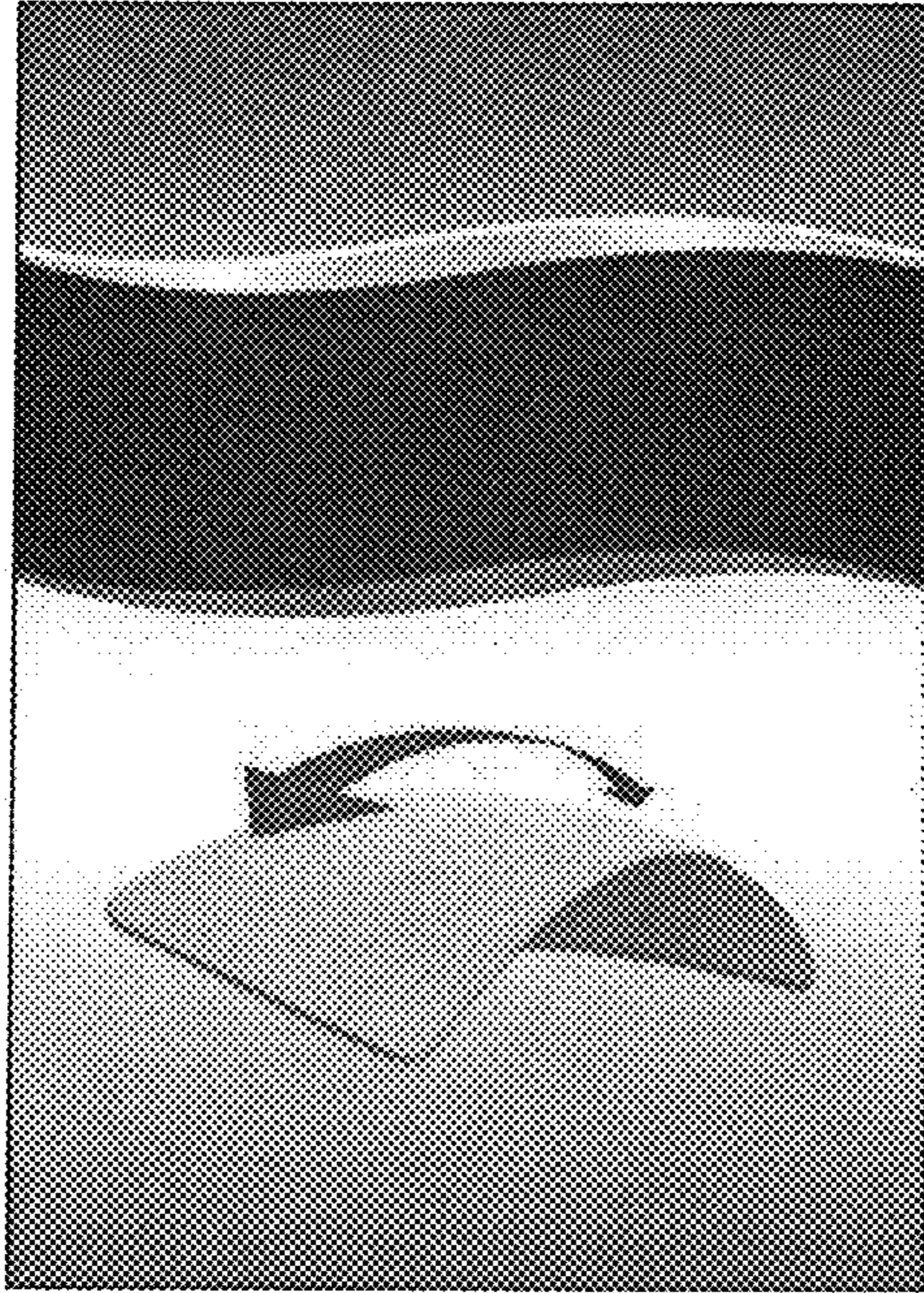

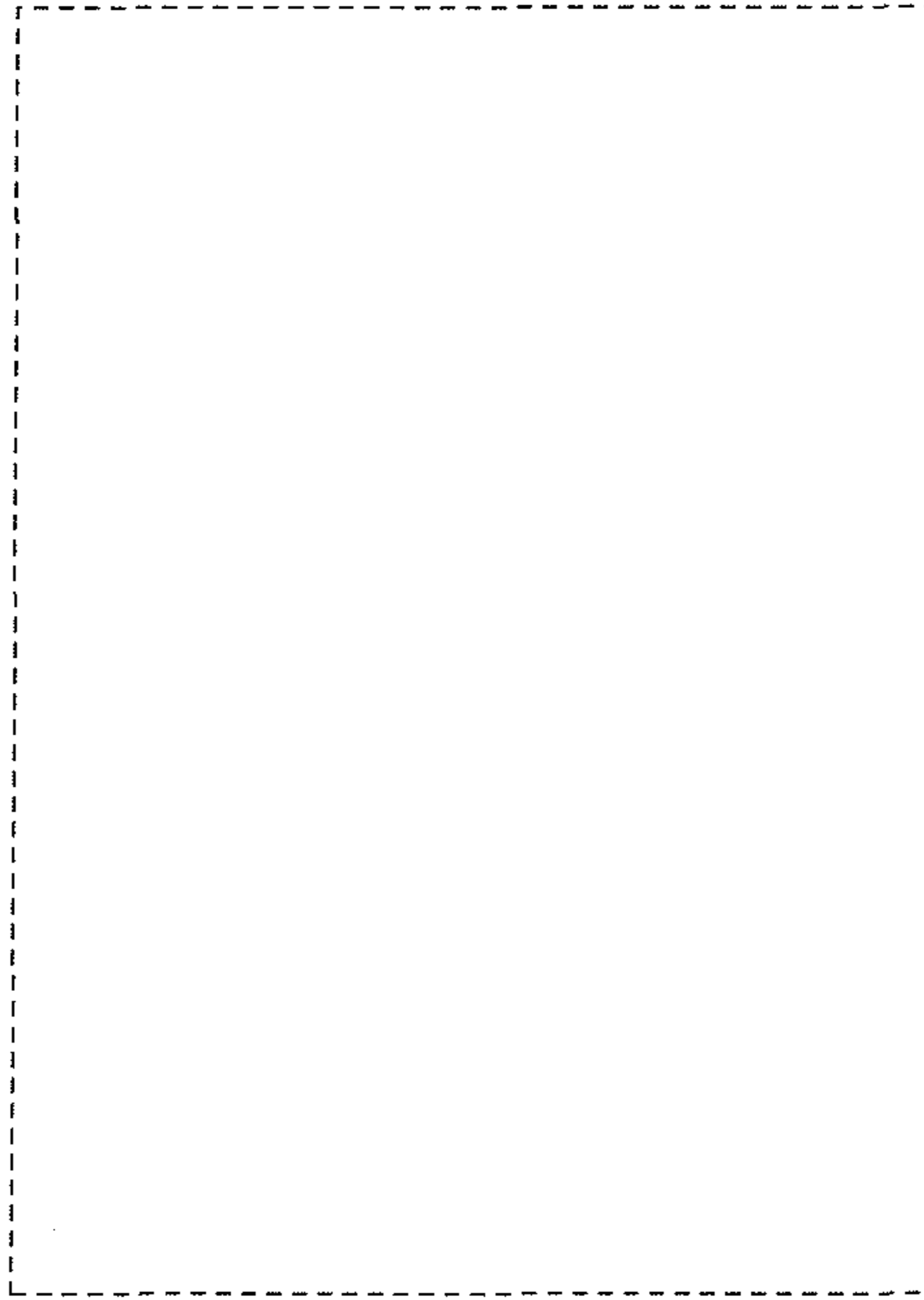

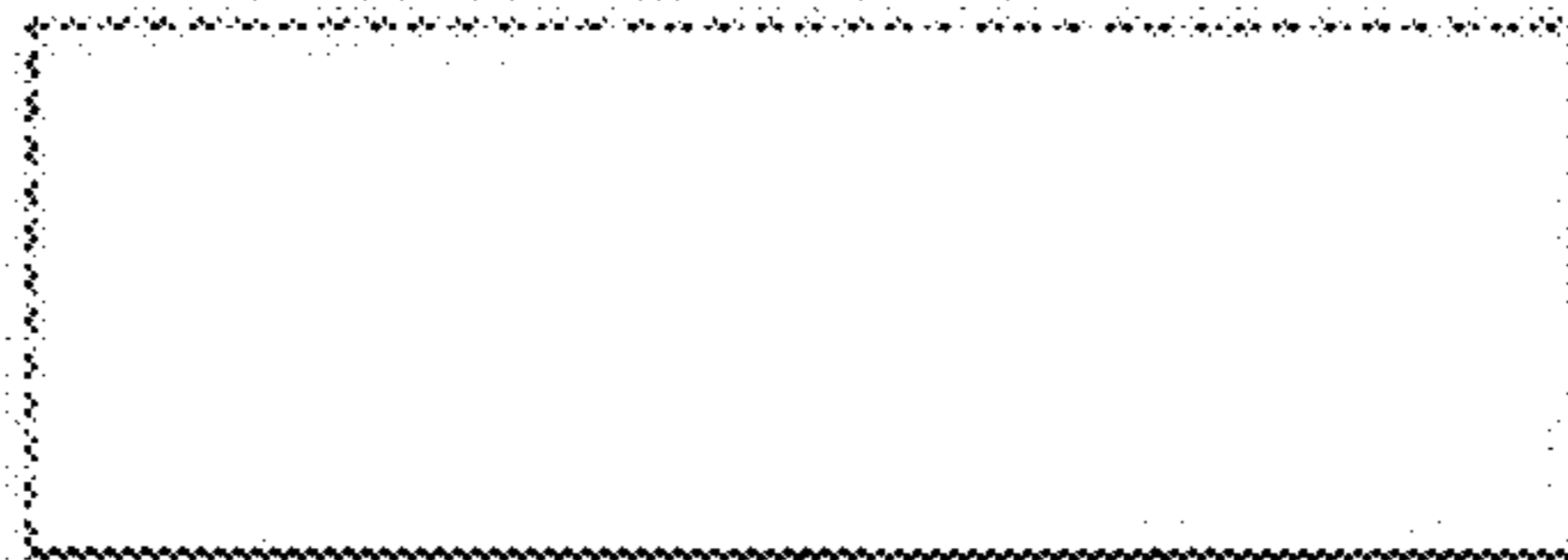

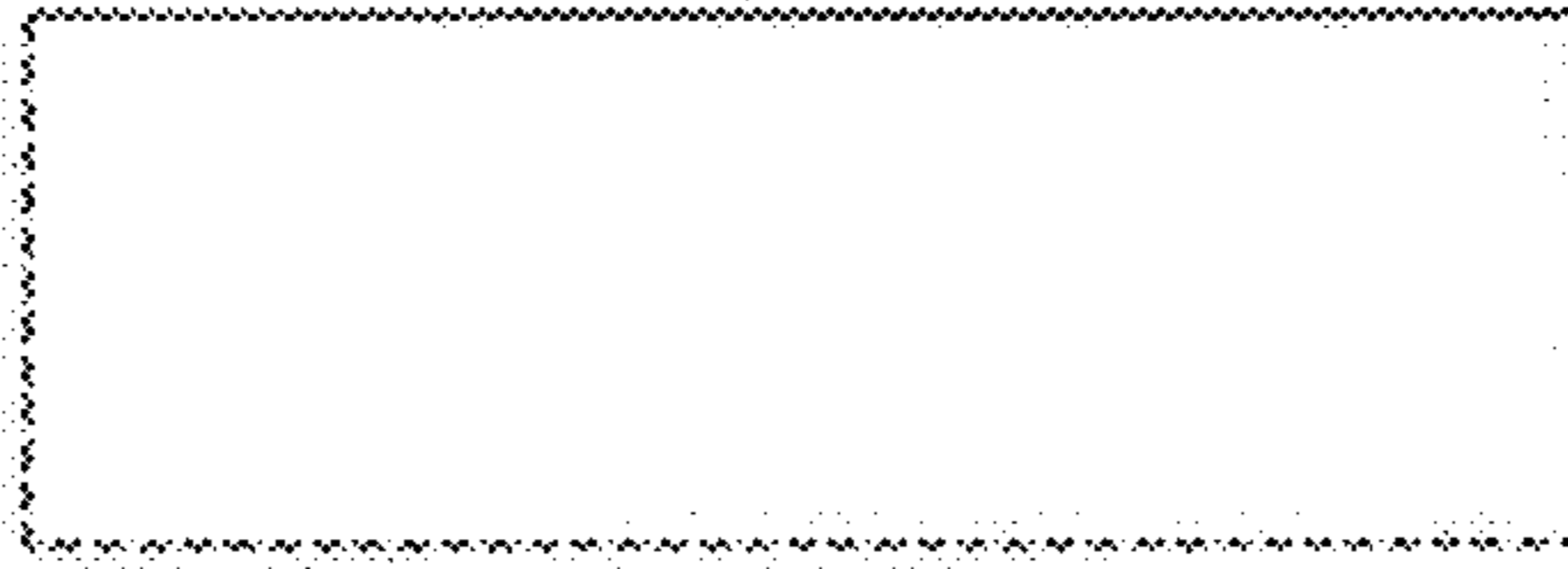

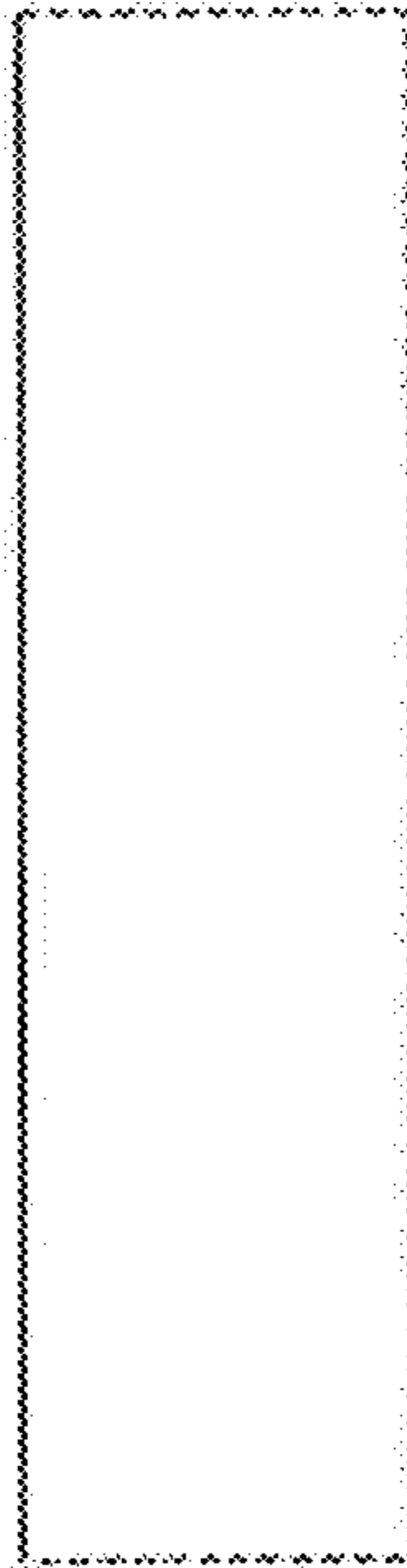

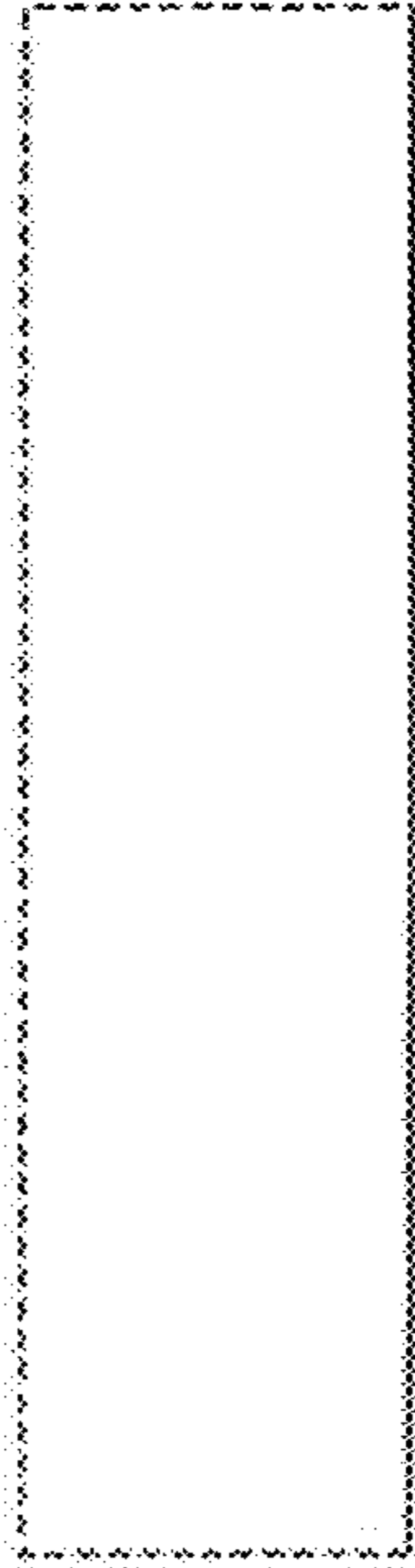

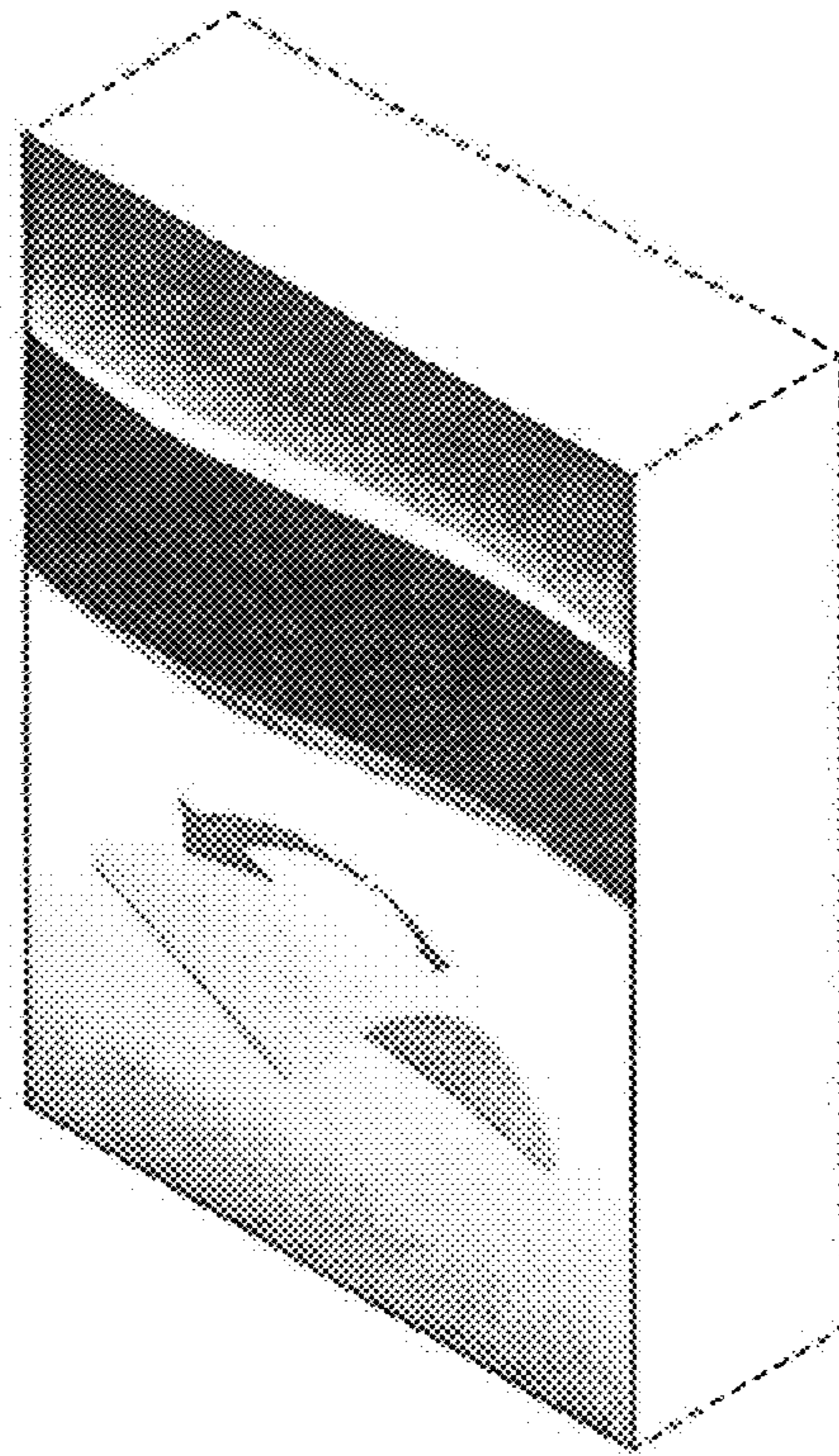
