(57) **CLAIM**

The ornamental design for a wine bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wine bag showing my new design;

FIG. 2 is a front side elevation view thereof, the back elevation view being the mirror image thereof;

FIG. 3 is a right side elevation view thereof; the left side elevation view being the mirror image thereof;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

The circular broken line in FIGS. 1 and 2 are for illustrative purposes only, depicting the environment of the new design, forming no part of the claimed design.

The cross-hatched region depicted on the front side of the wine bag illustrate a quilted external appearance, and not a particular color, as color is not a claimed aspect of the design.

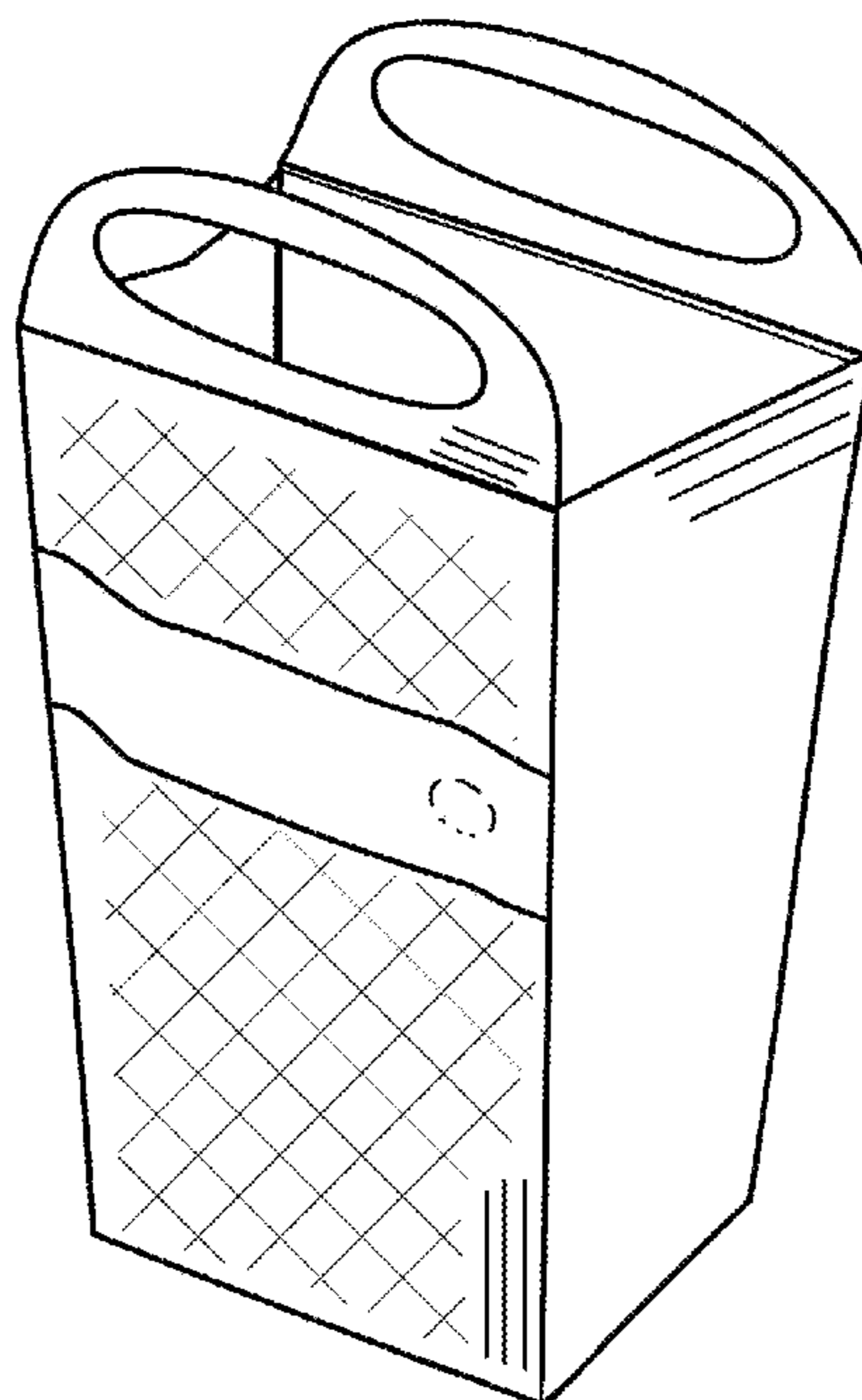
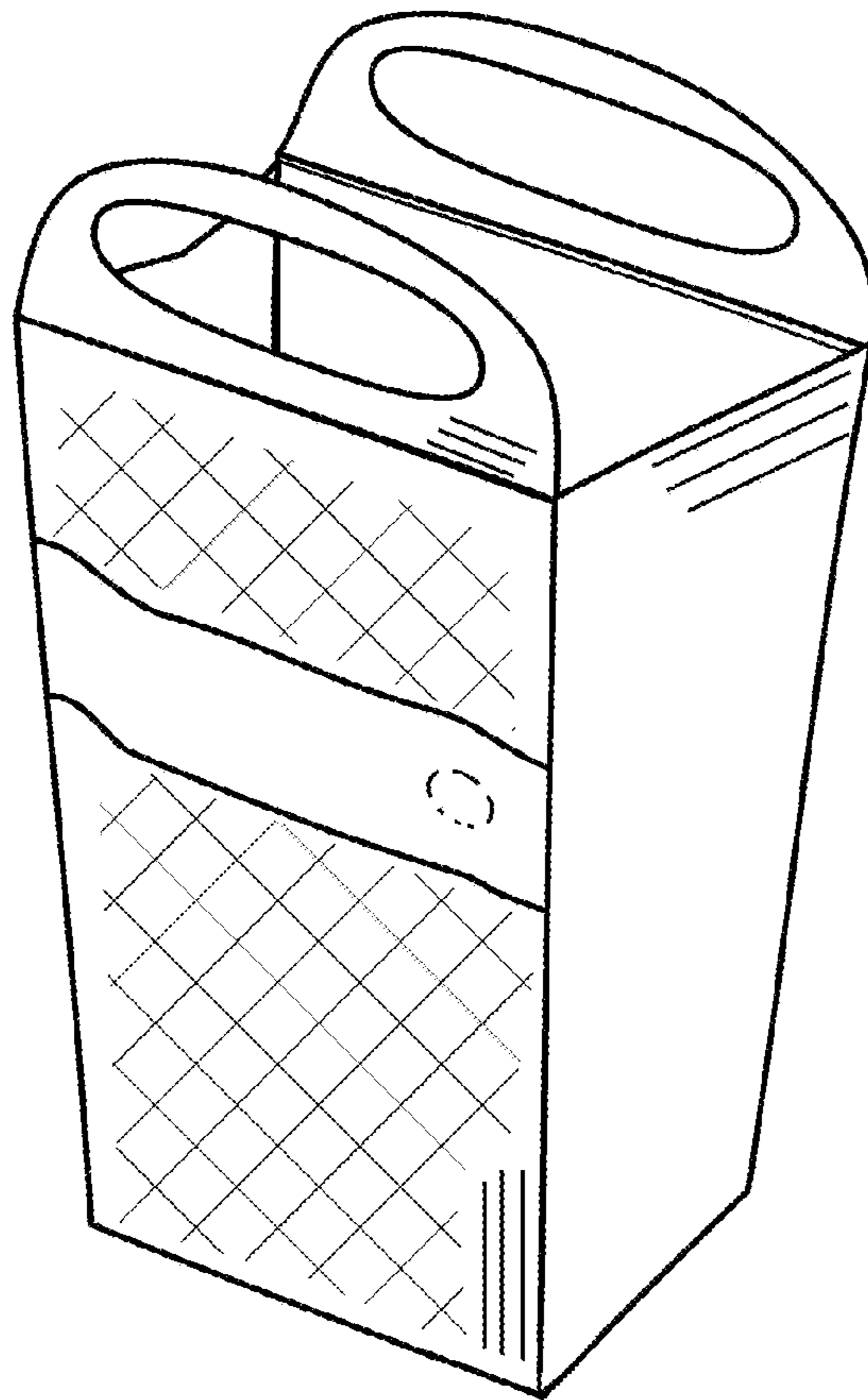

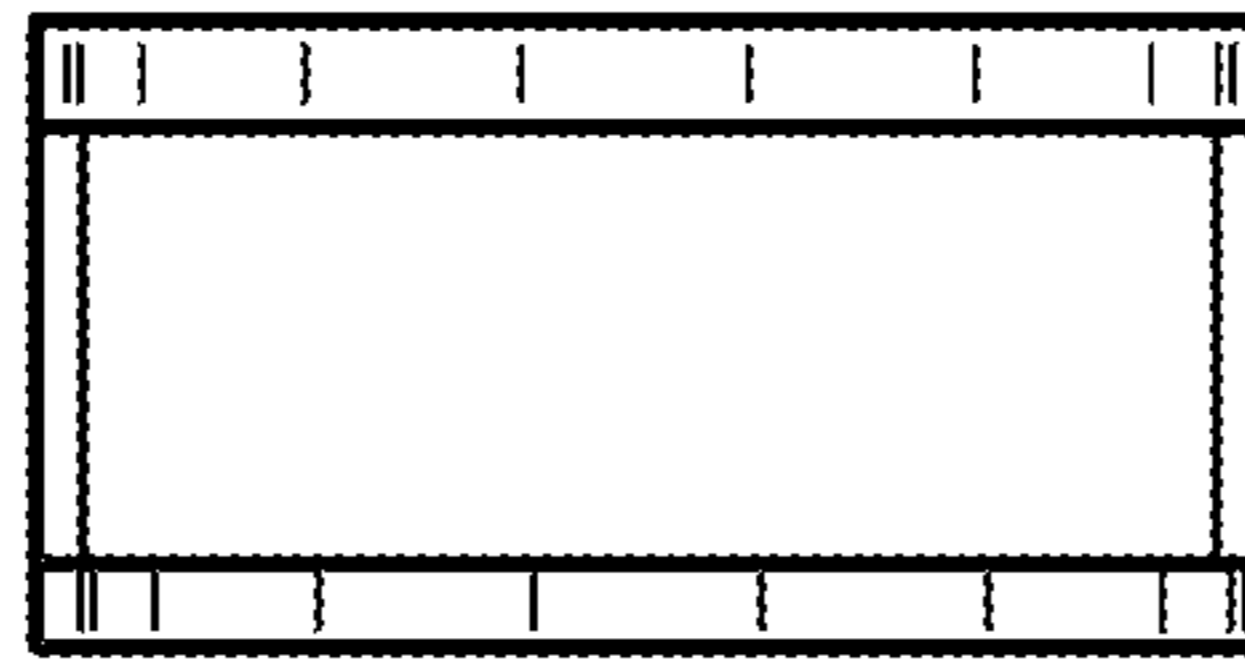

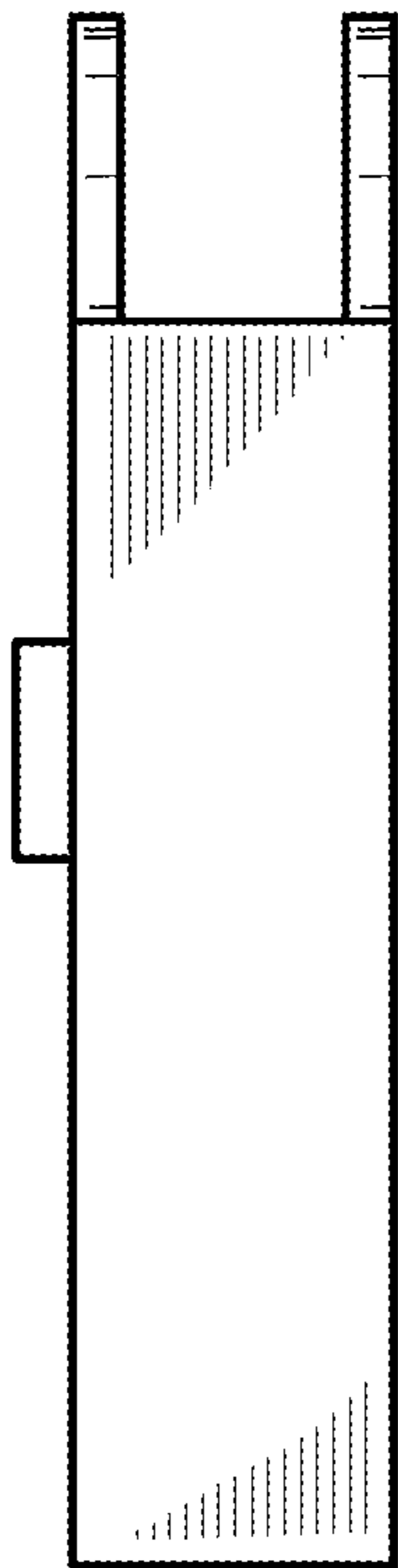

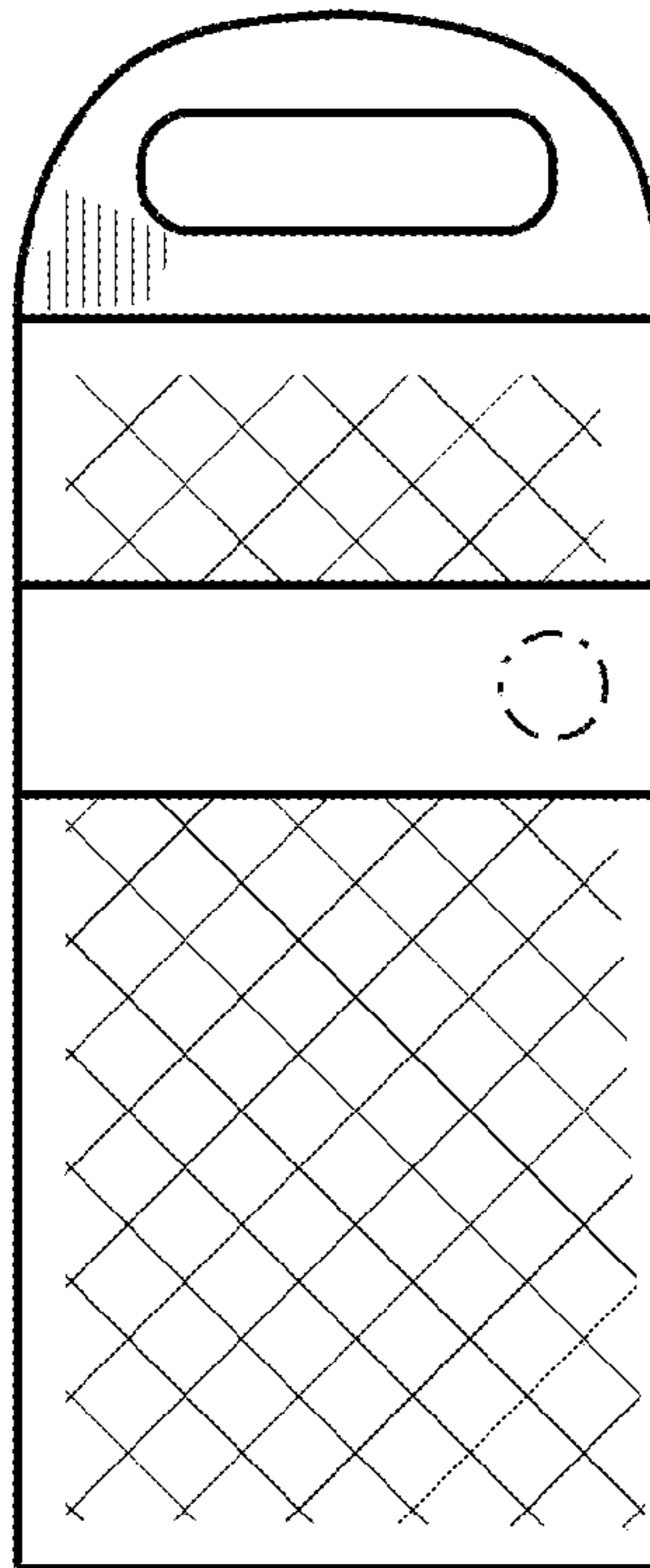

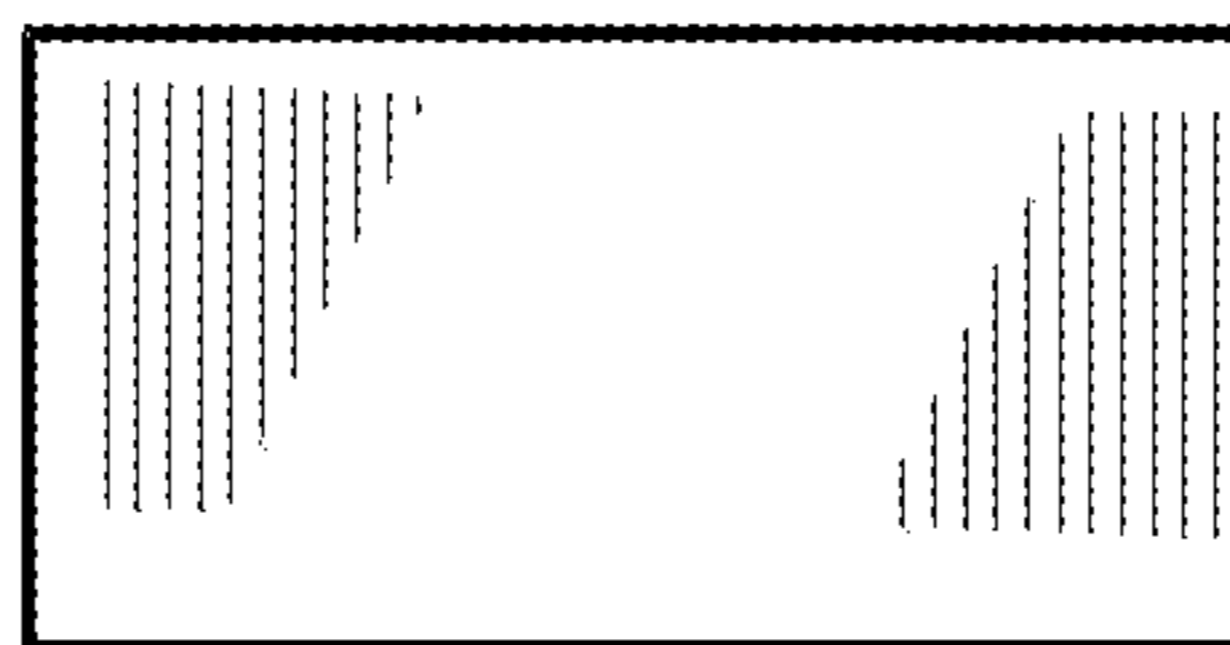
