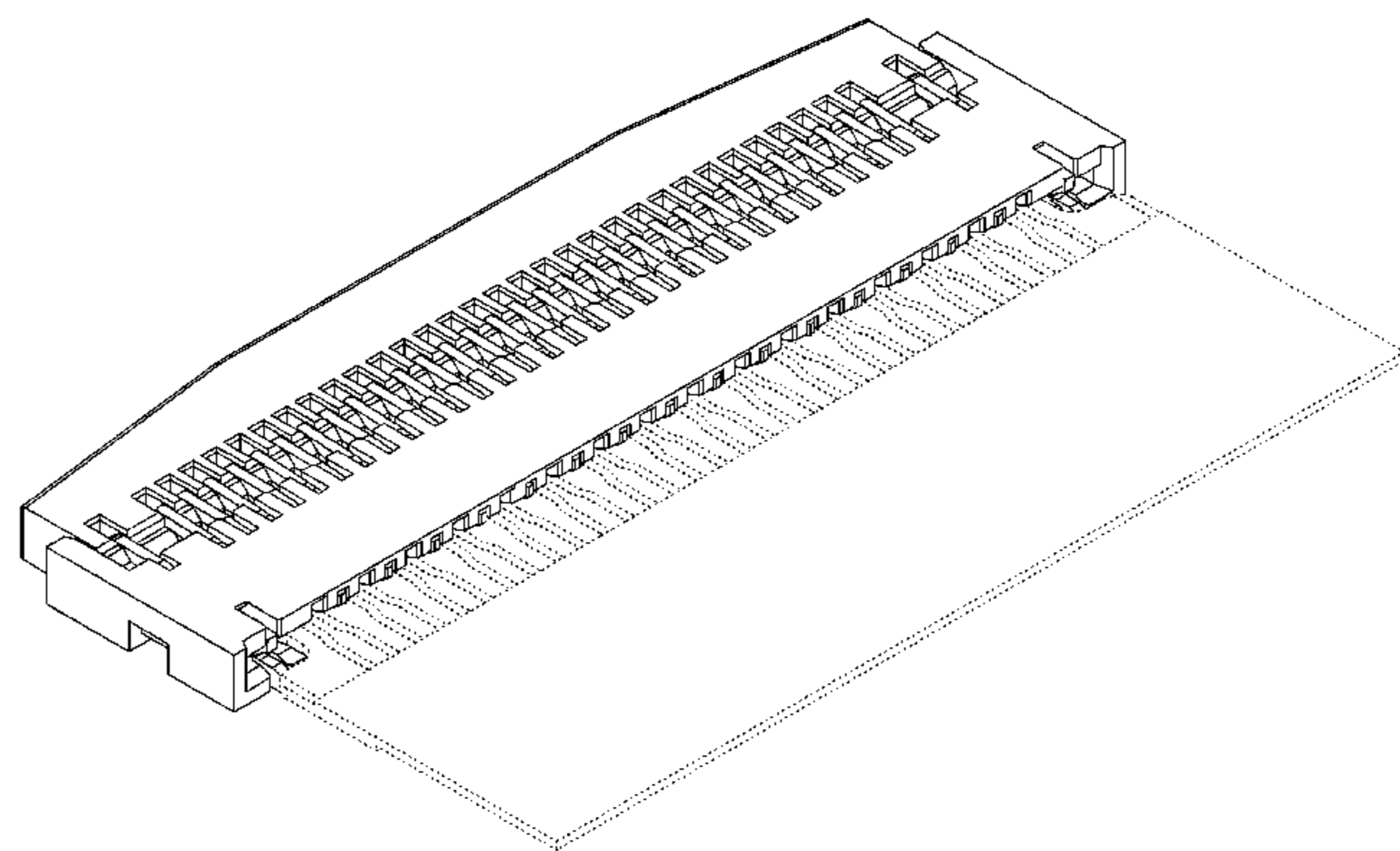
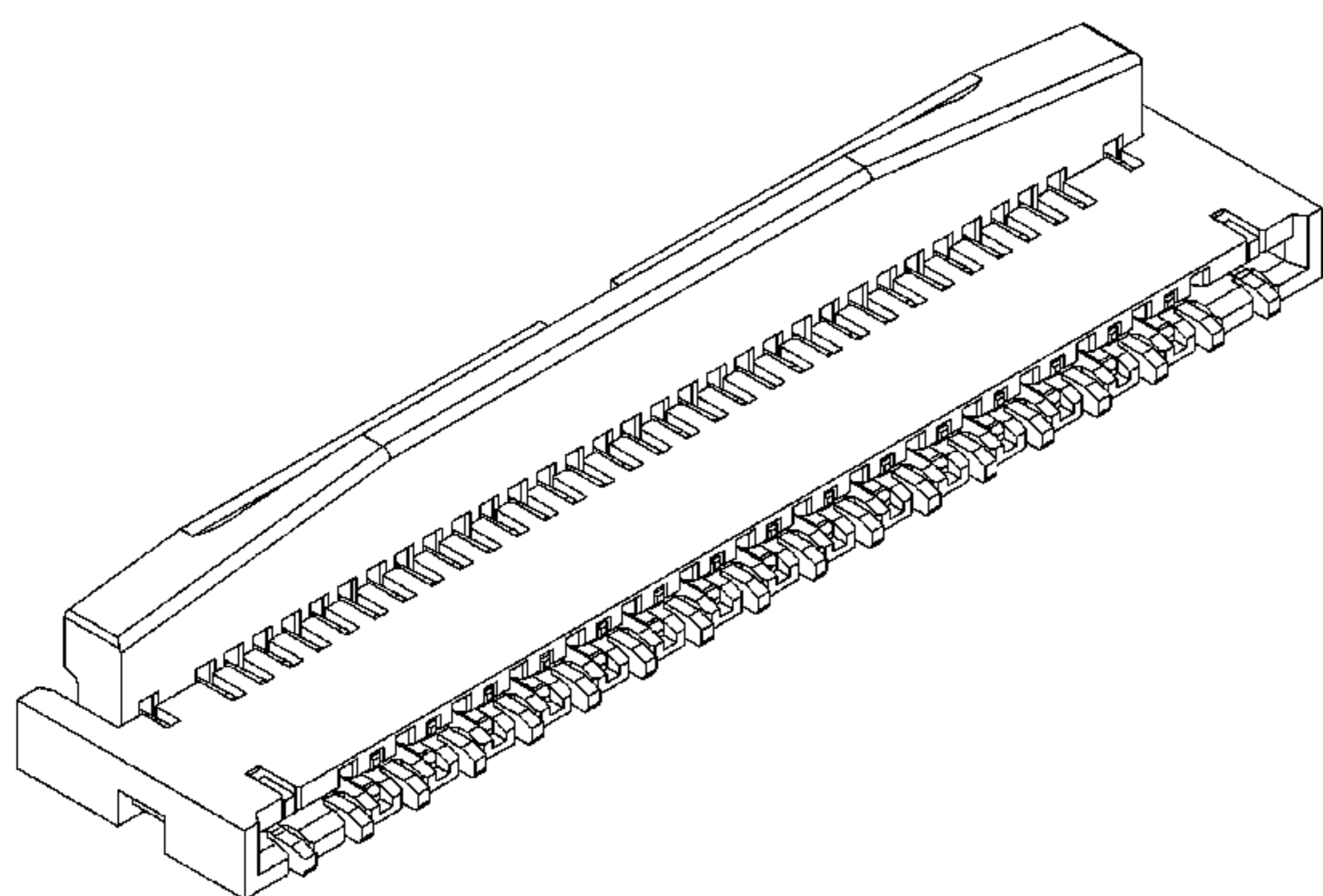
The ornamental design for an electric connector, as shown and described.

DESCRIPTION

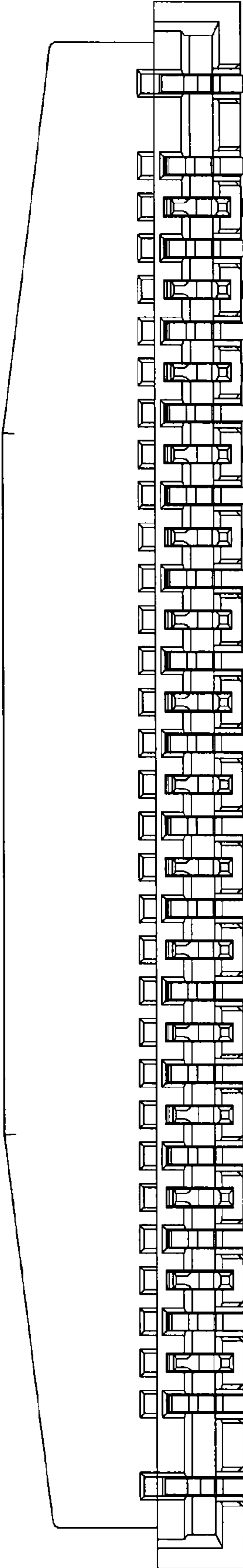

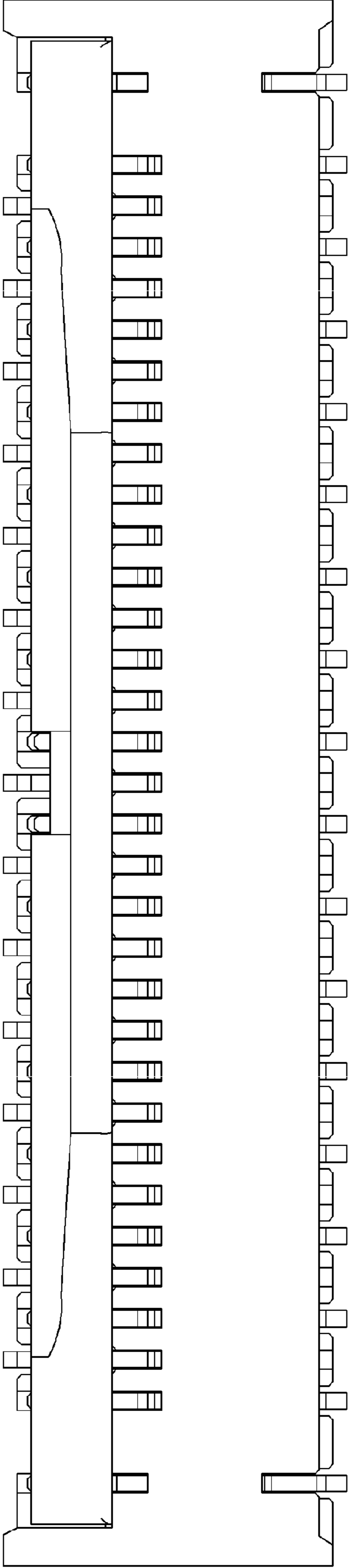

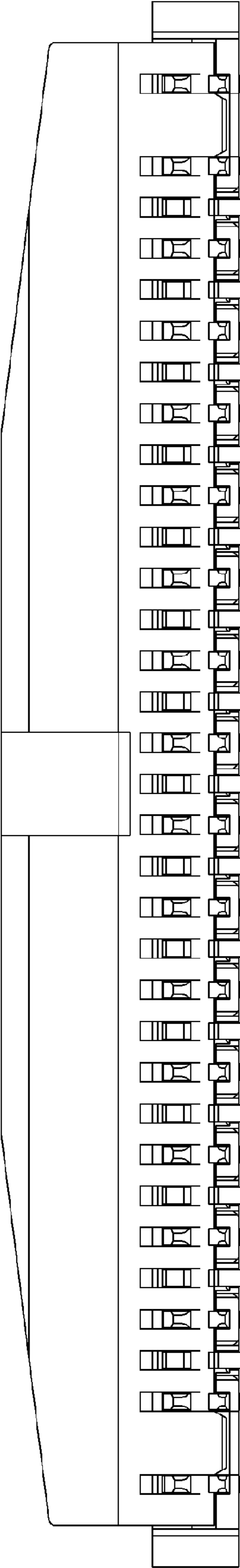

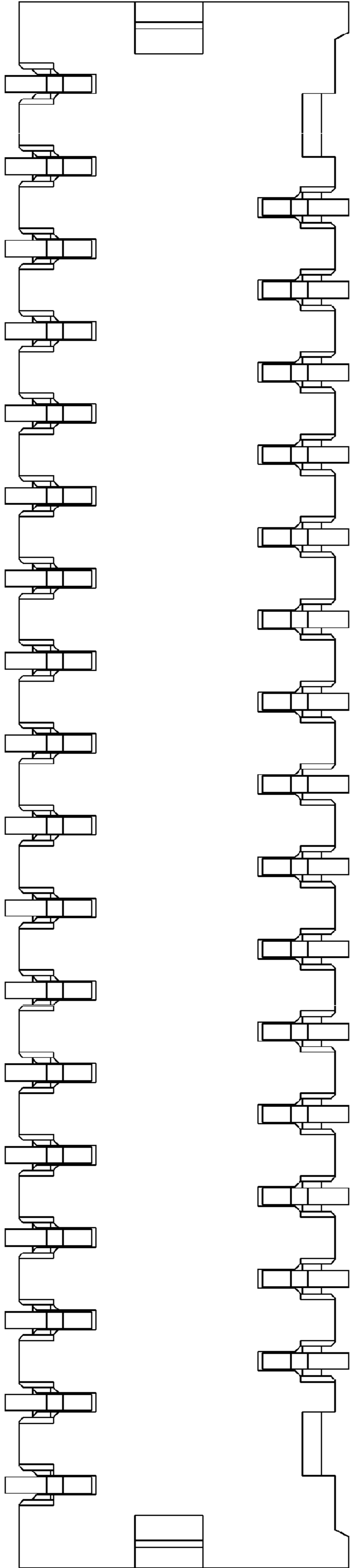

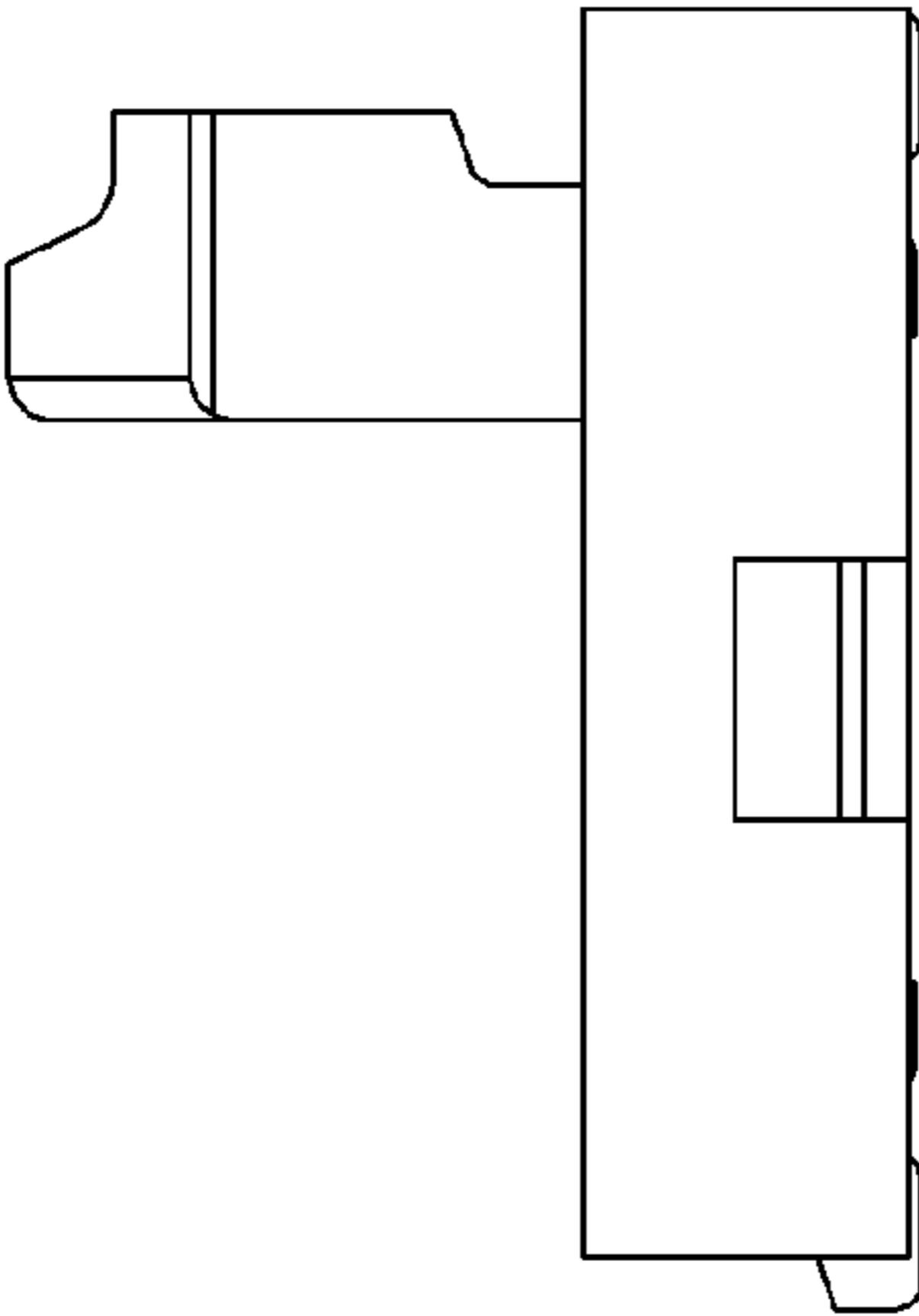

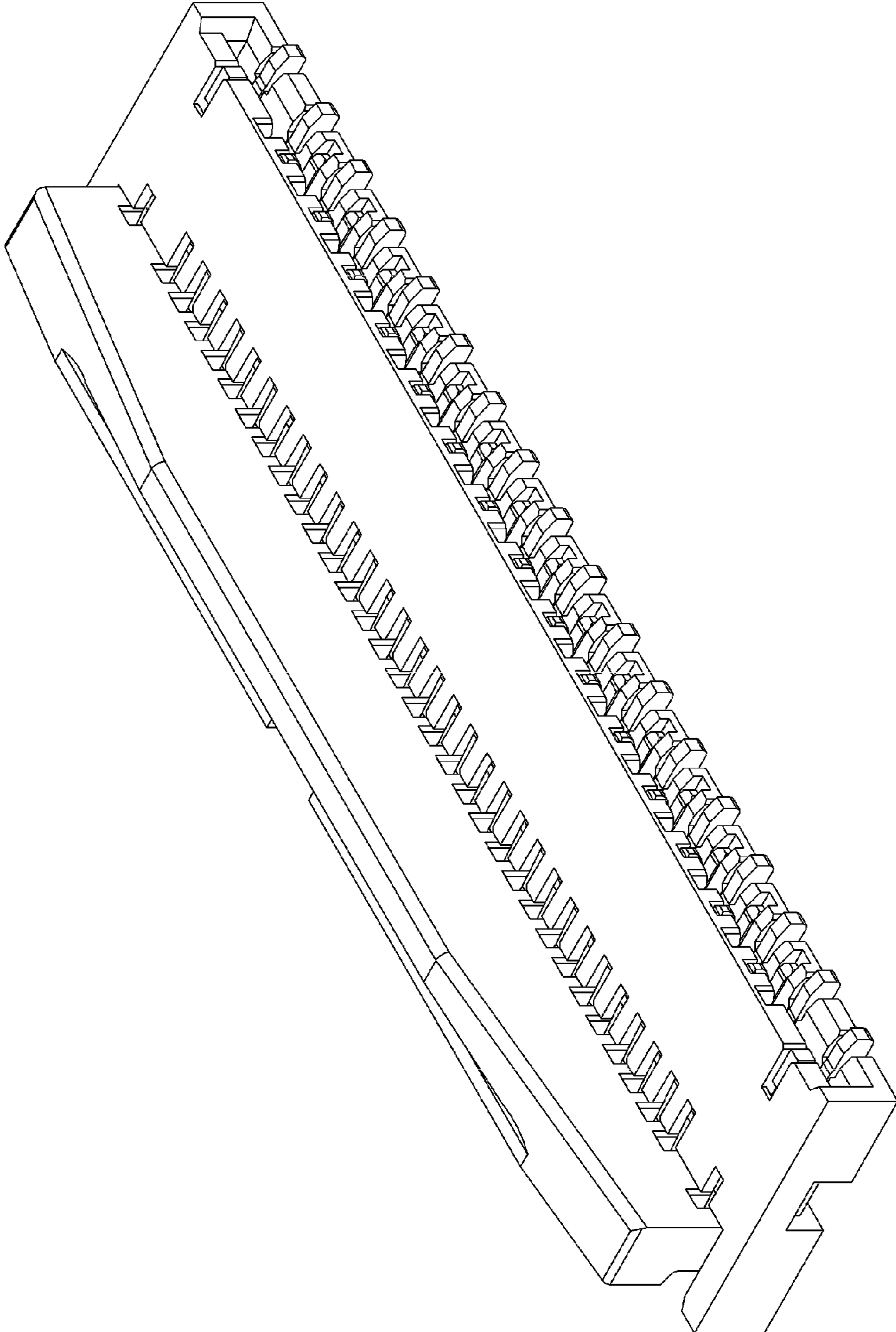

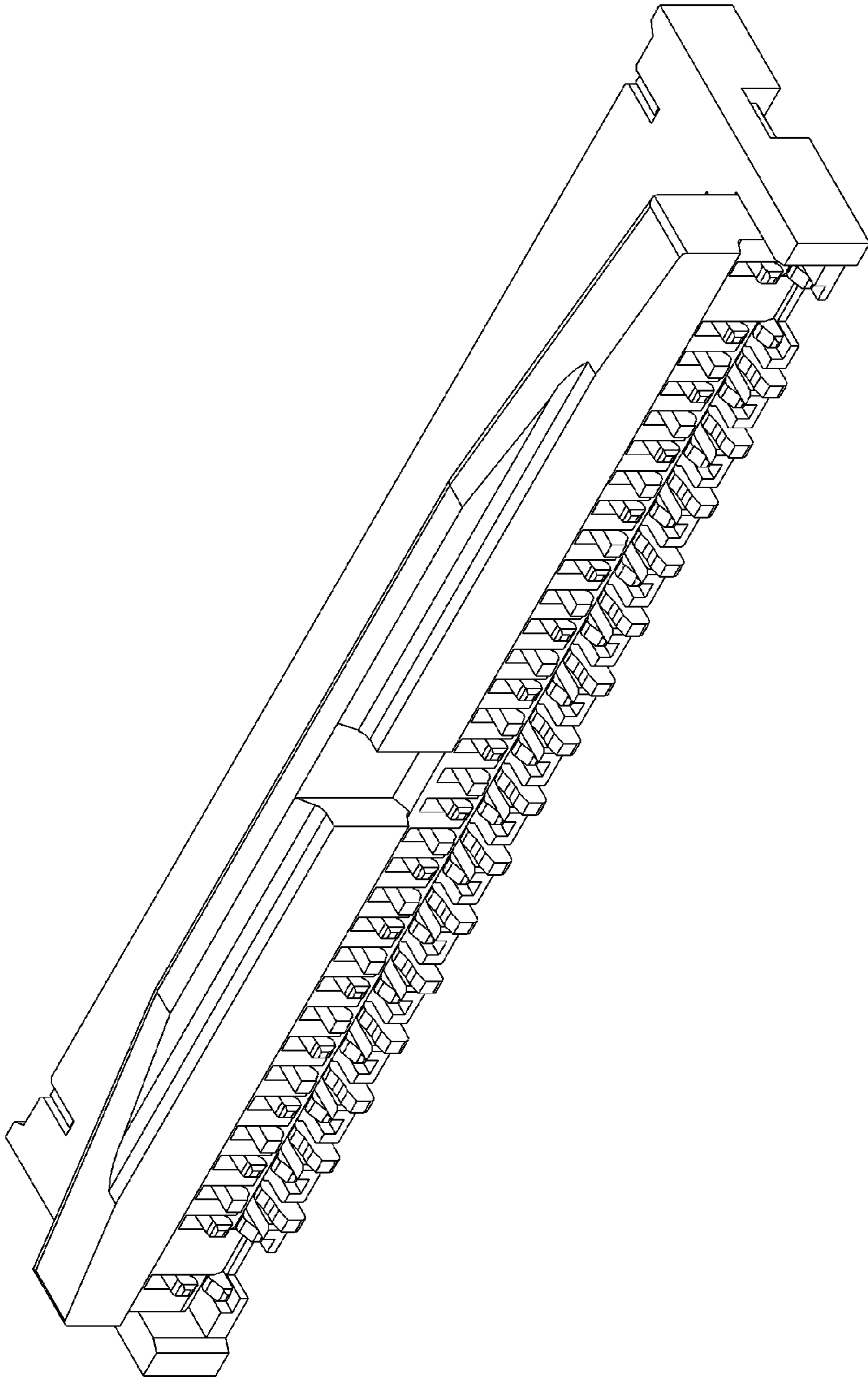

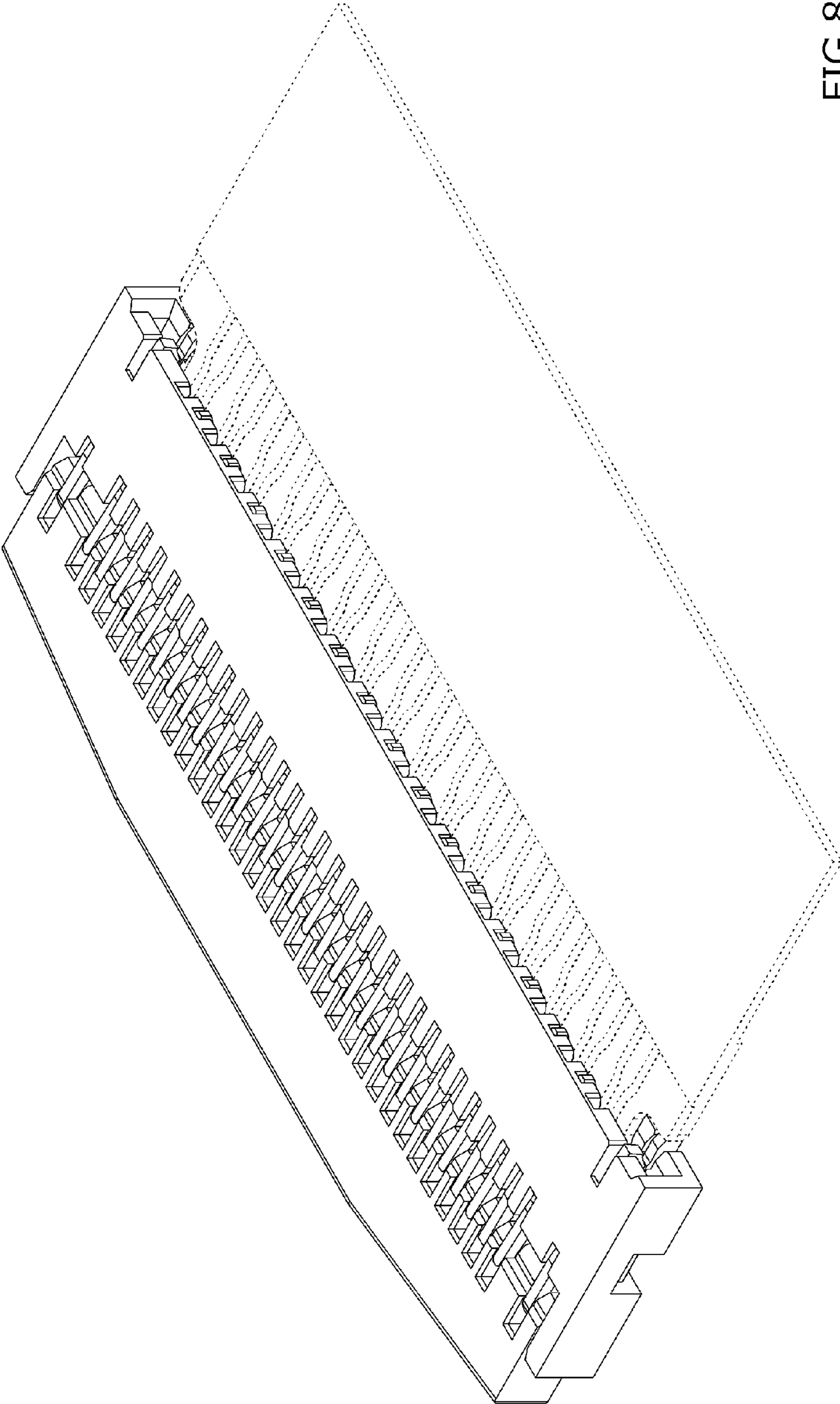
