DESCRIPTION

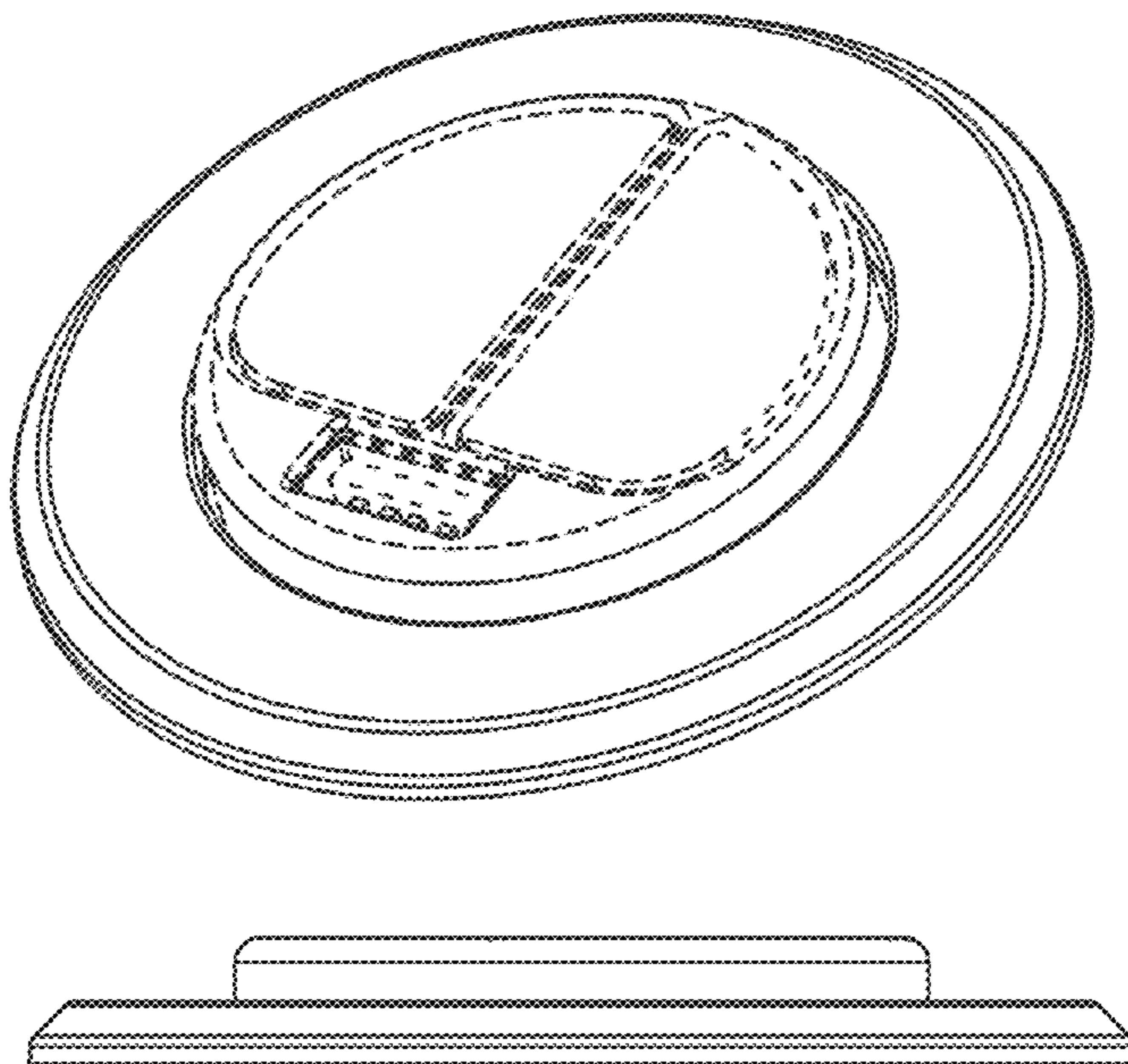
FIG. 1 is a top perspective view showing our new design;

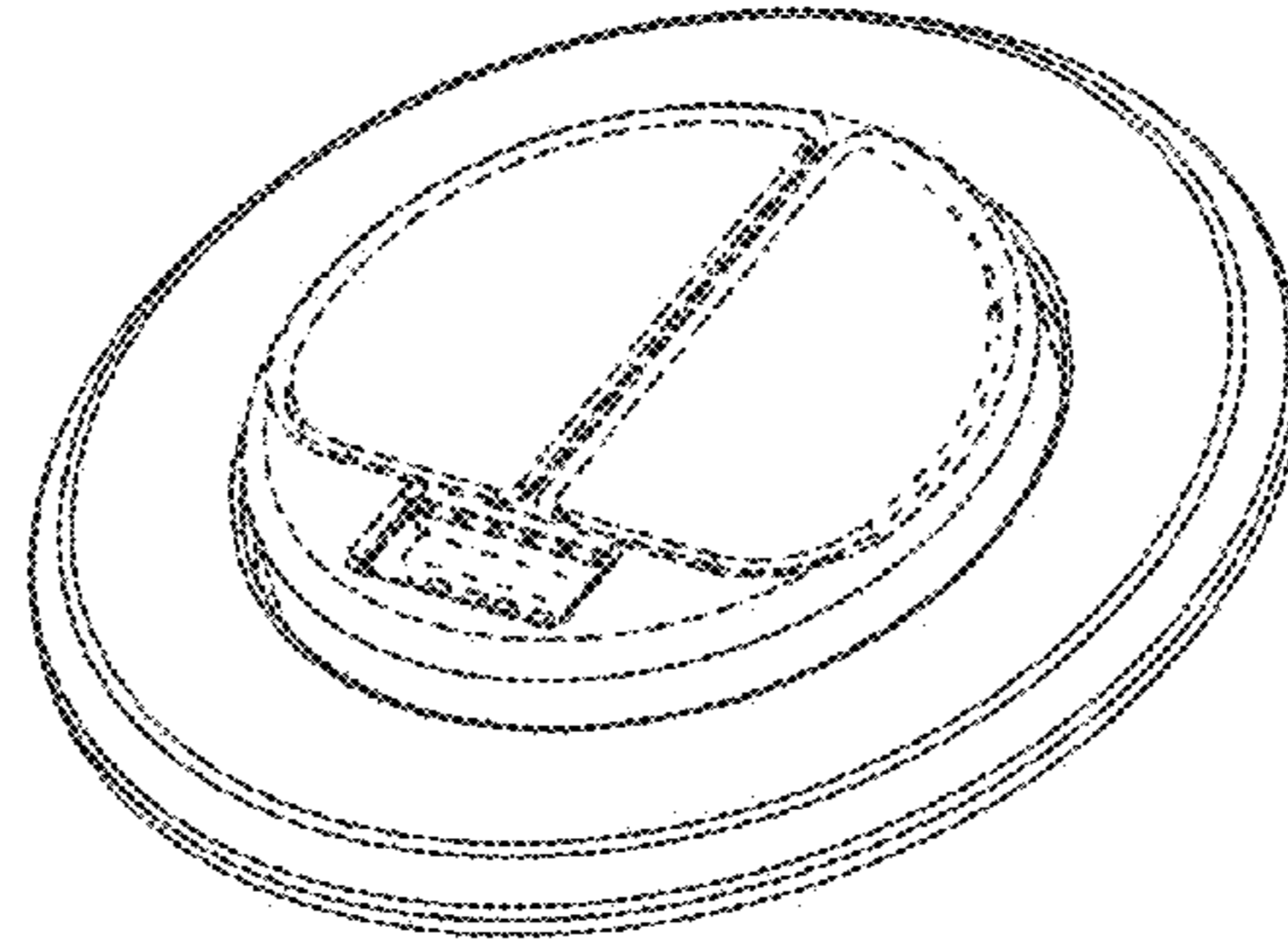

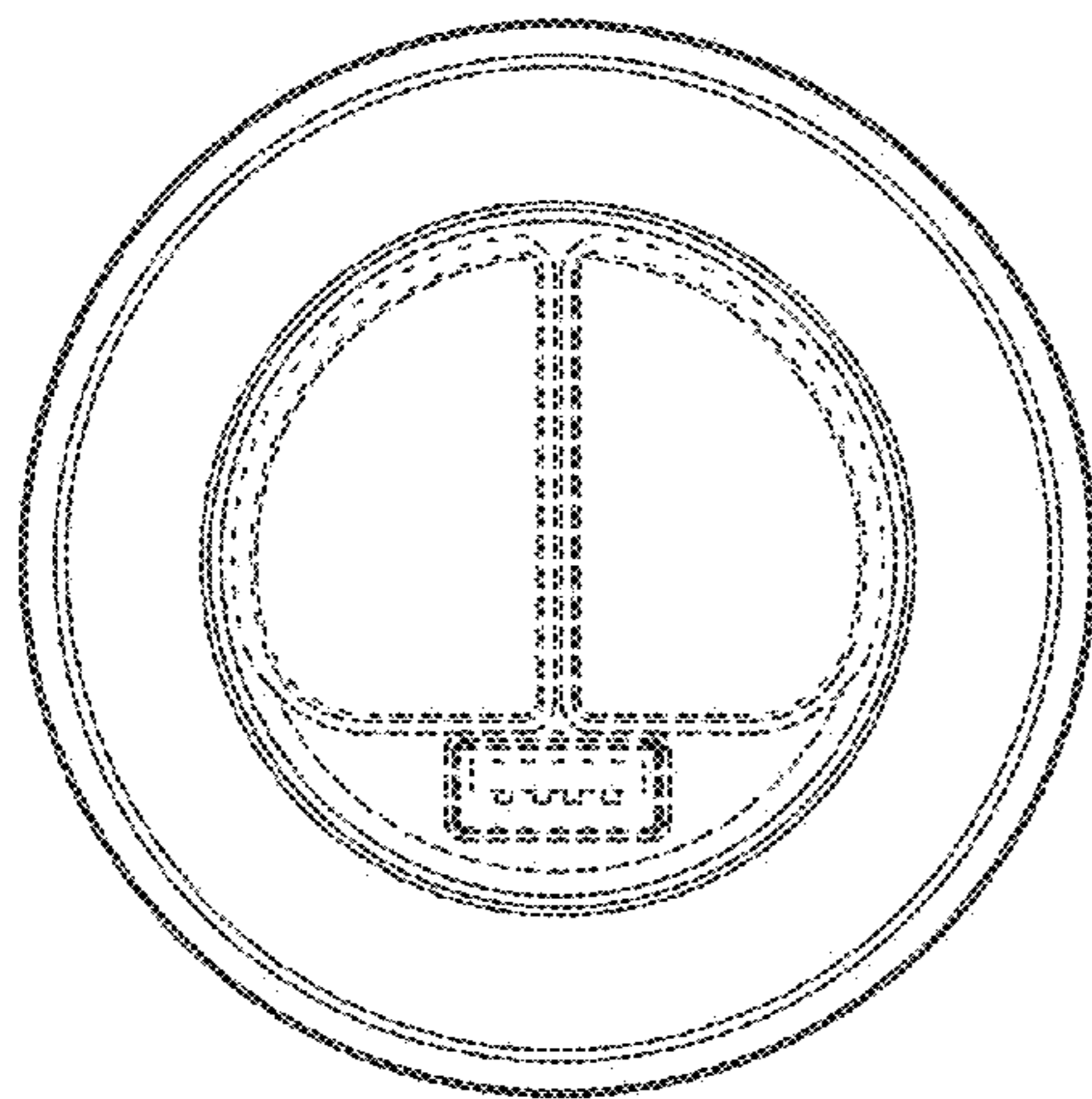

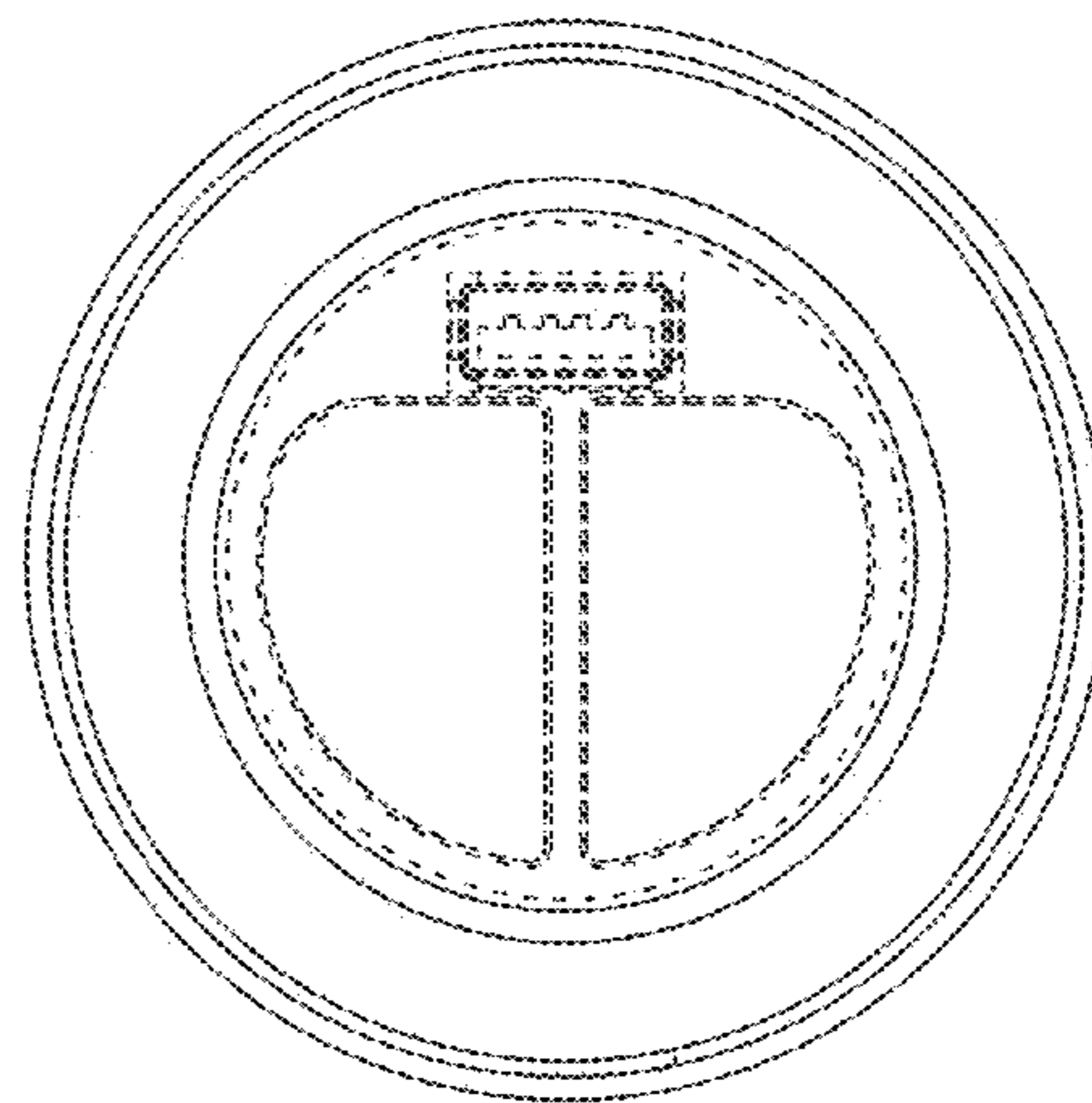

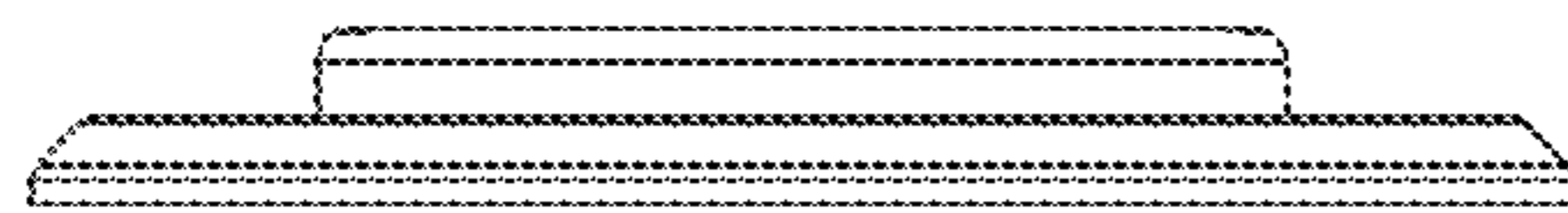

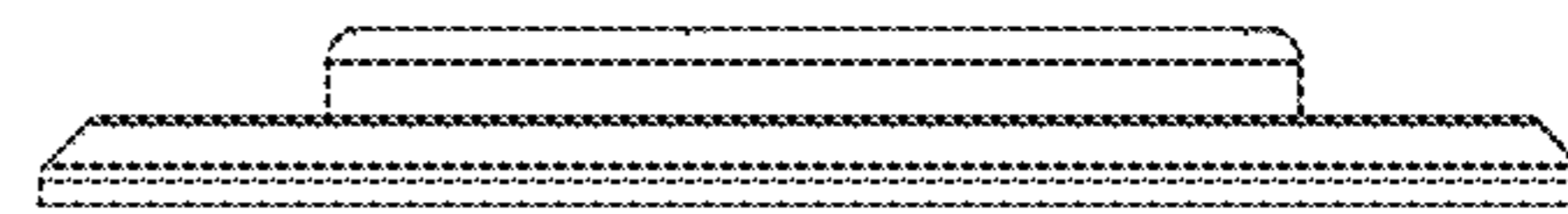
