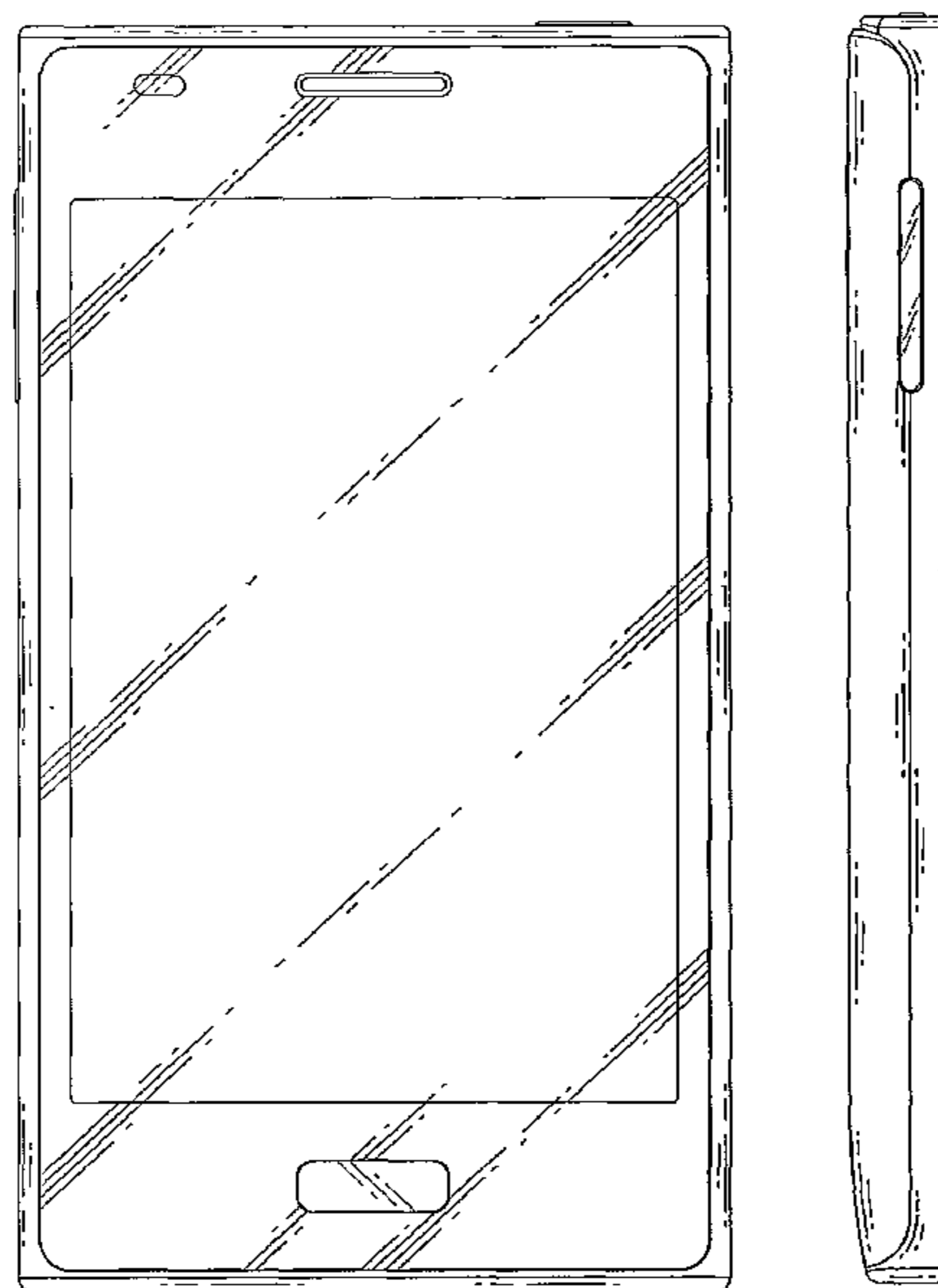

DESCRIPTION

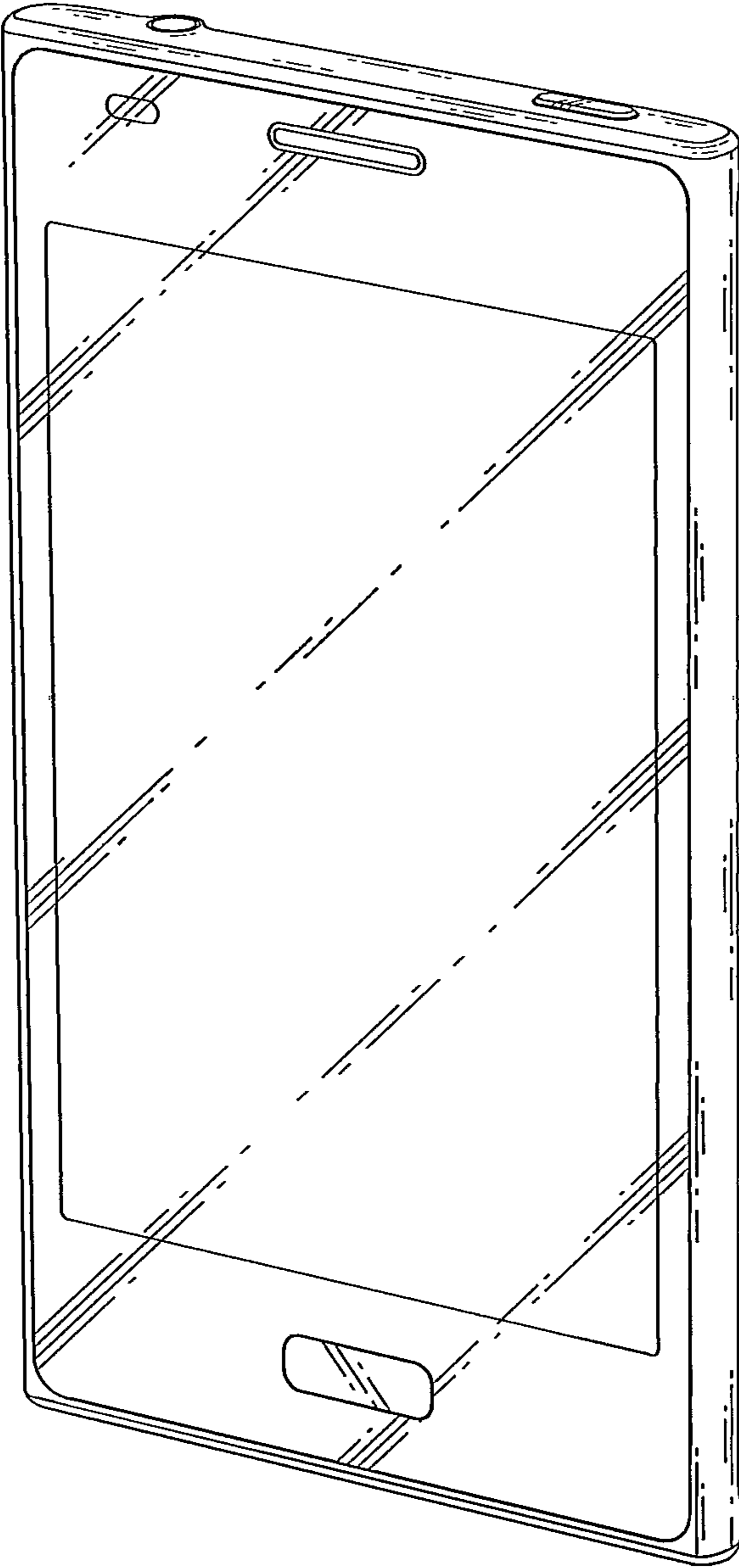

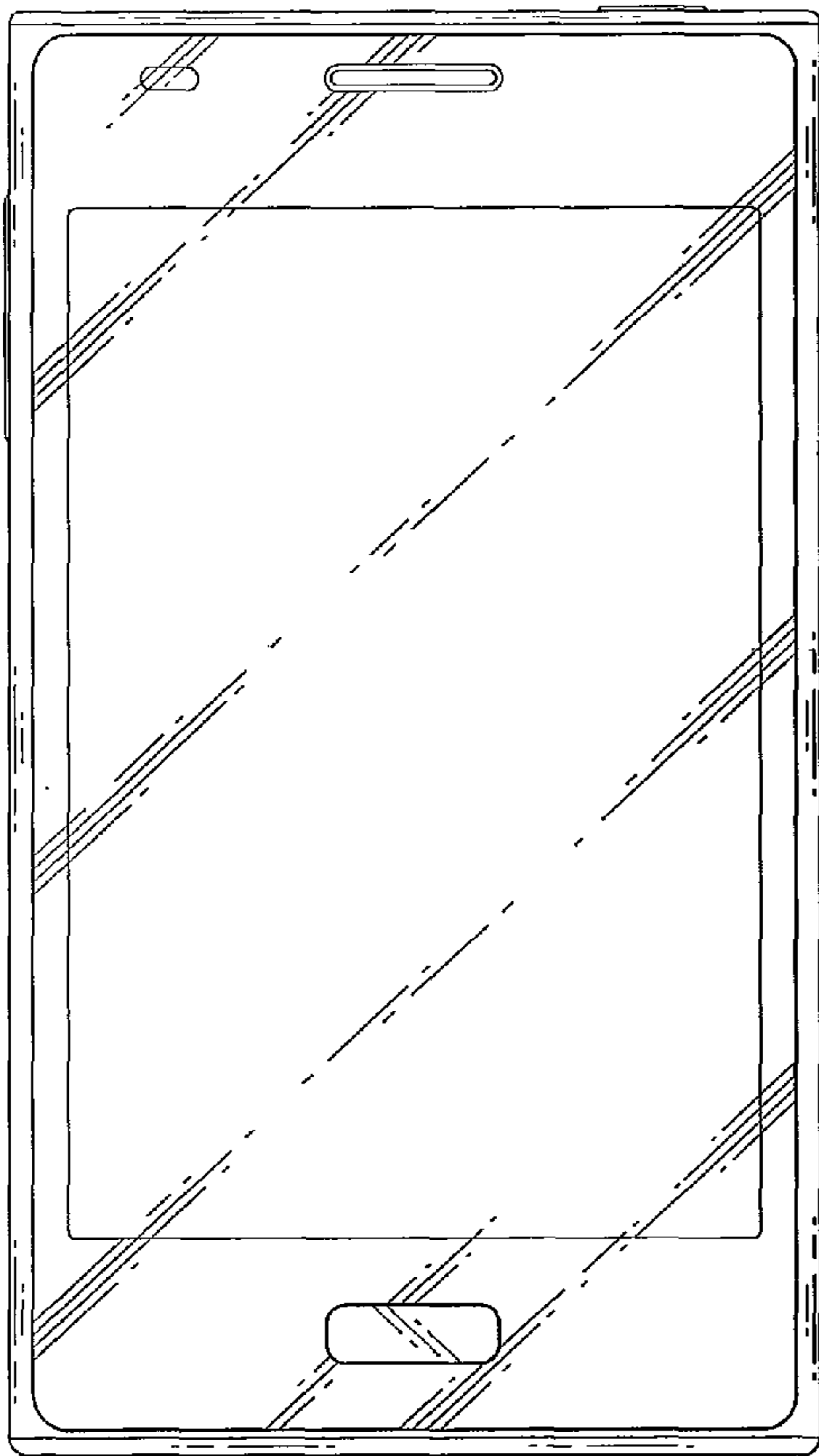

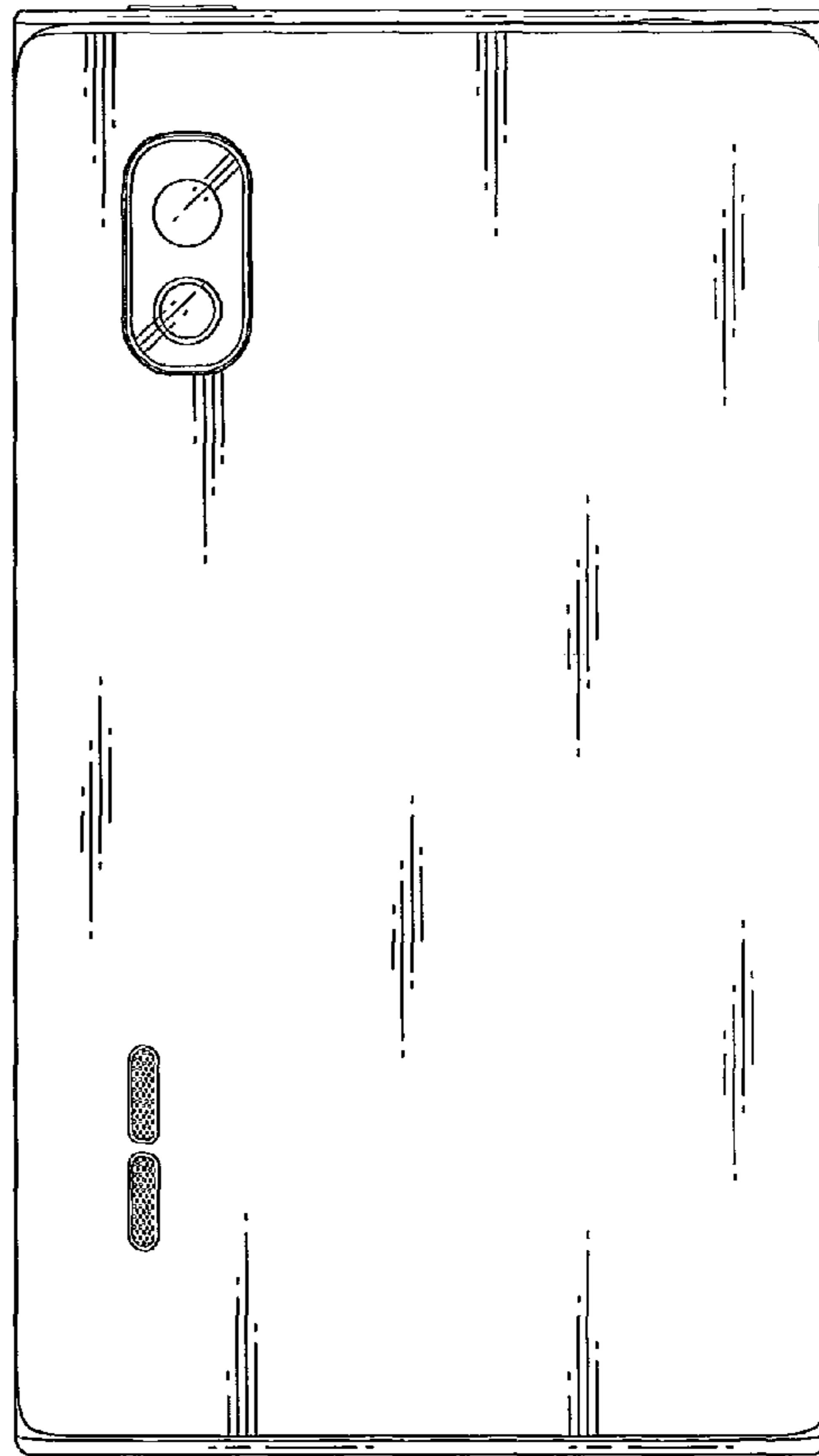

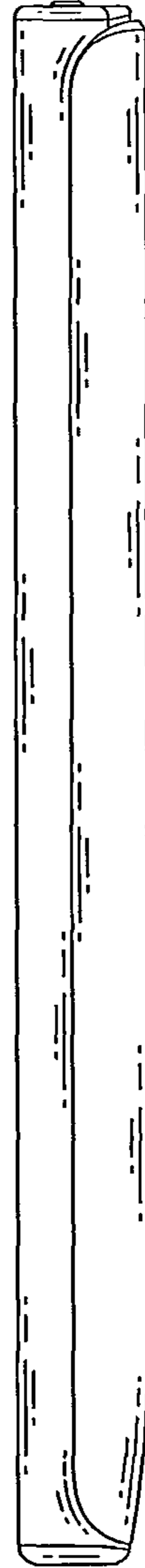

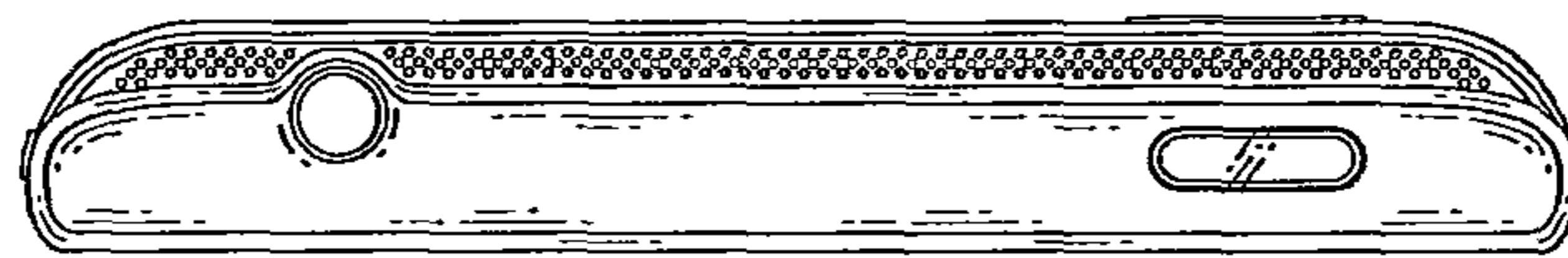
