(57) **CLAIM**

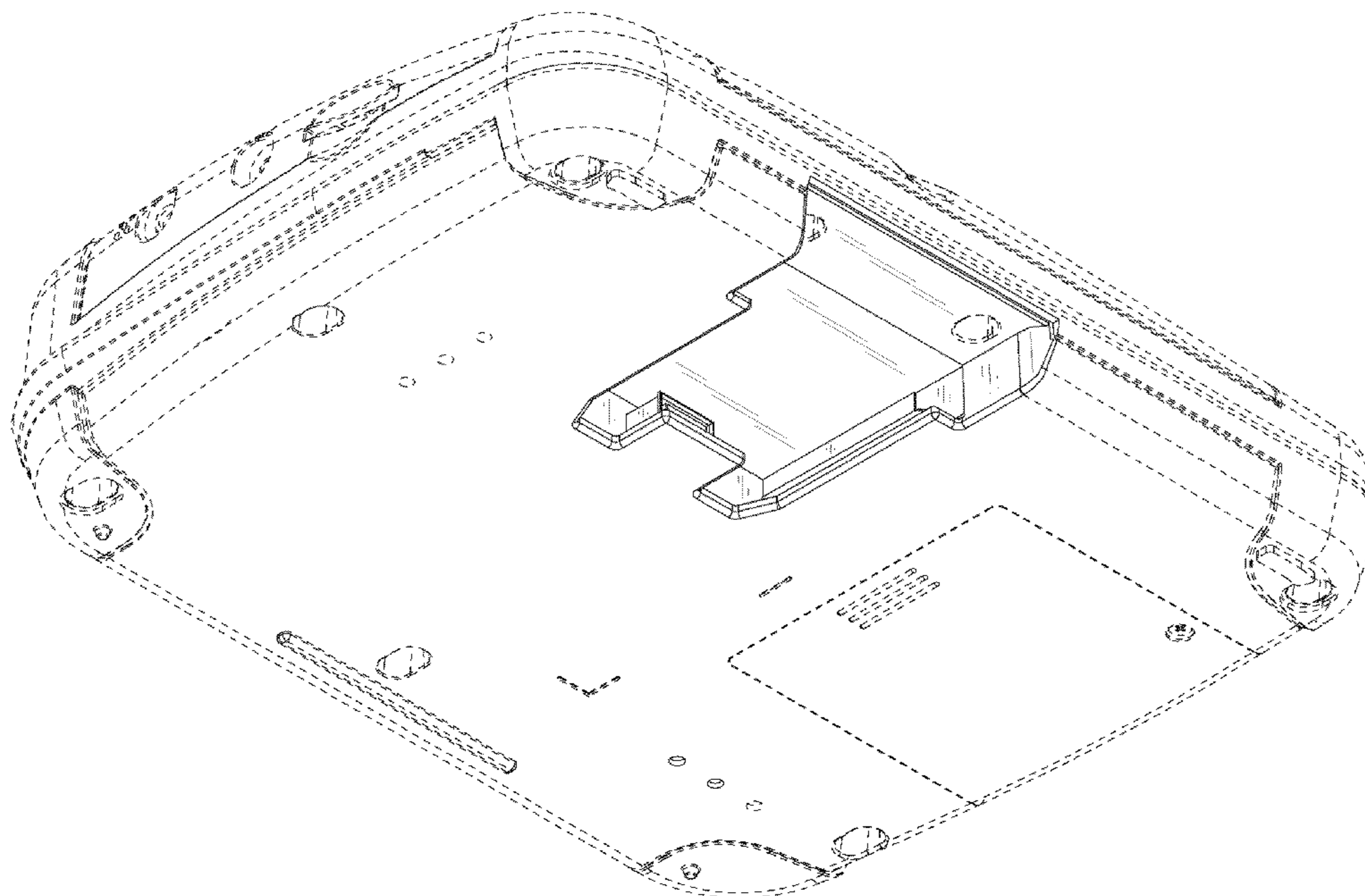
The ornamental design for a cartridge receptacle for audio player, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an cartridge receptacle for audio player showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;

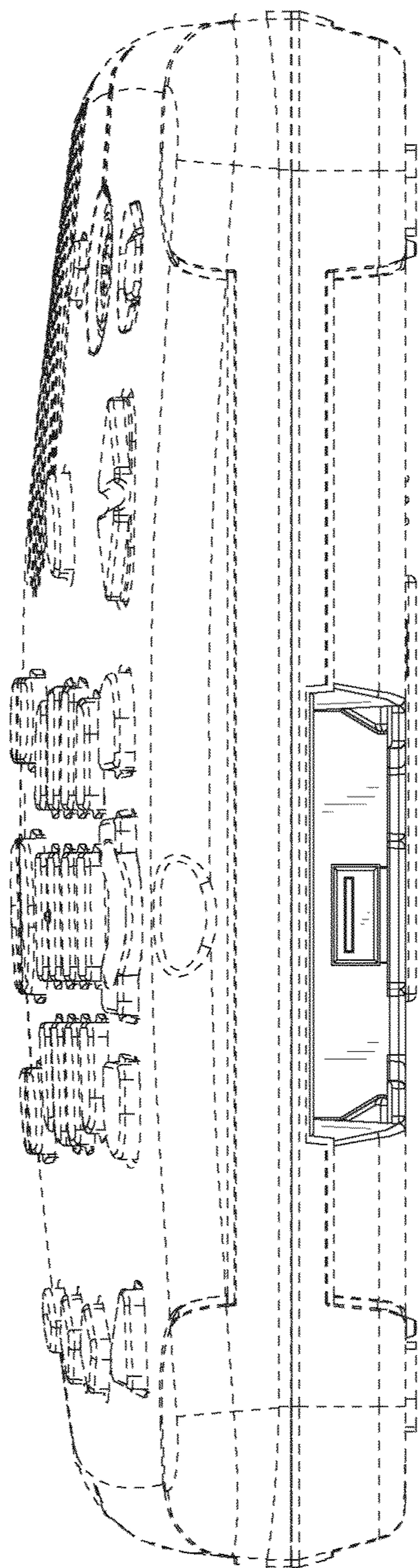

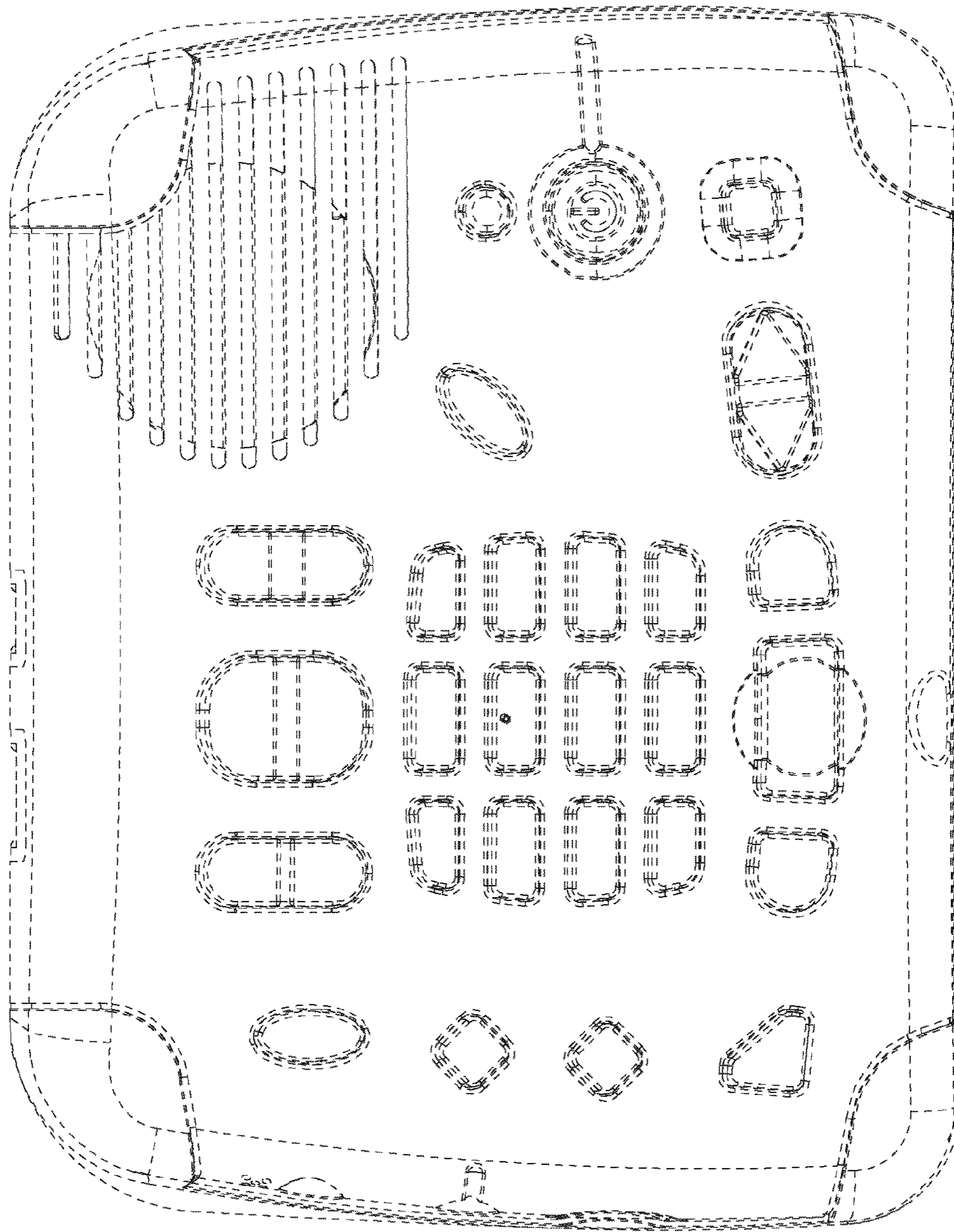

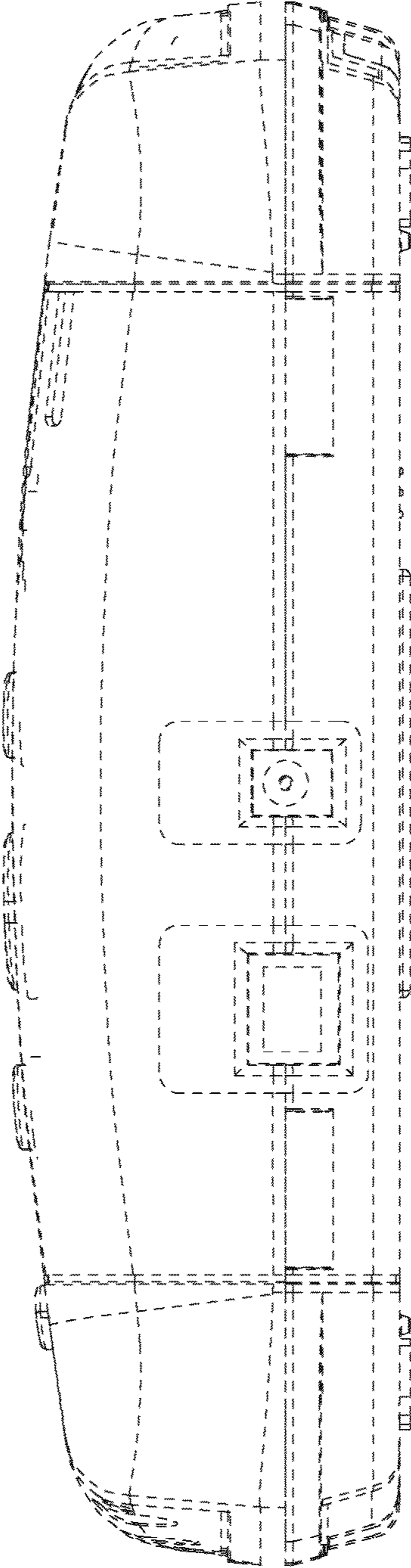

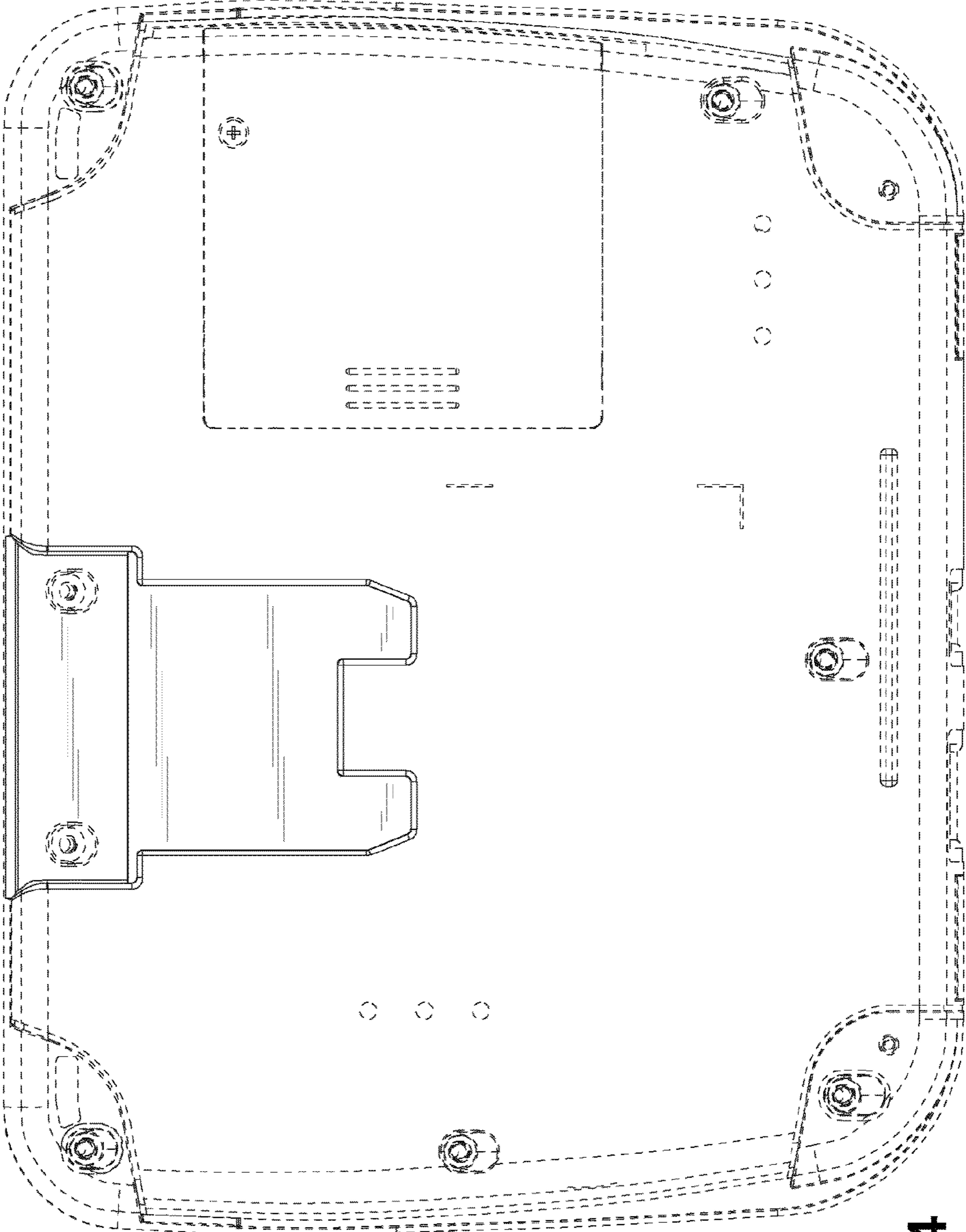

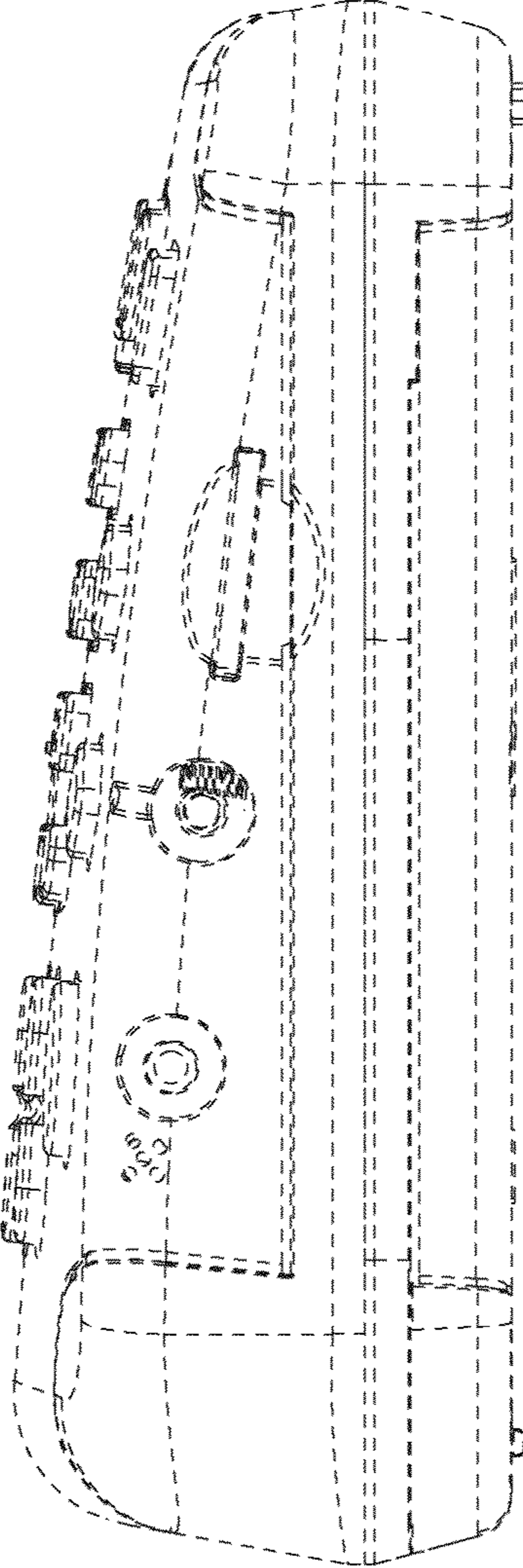

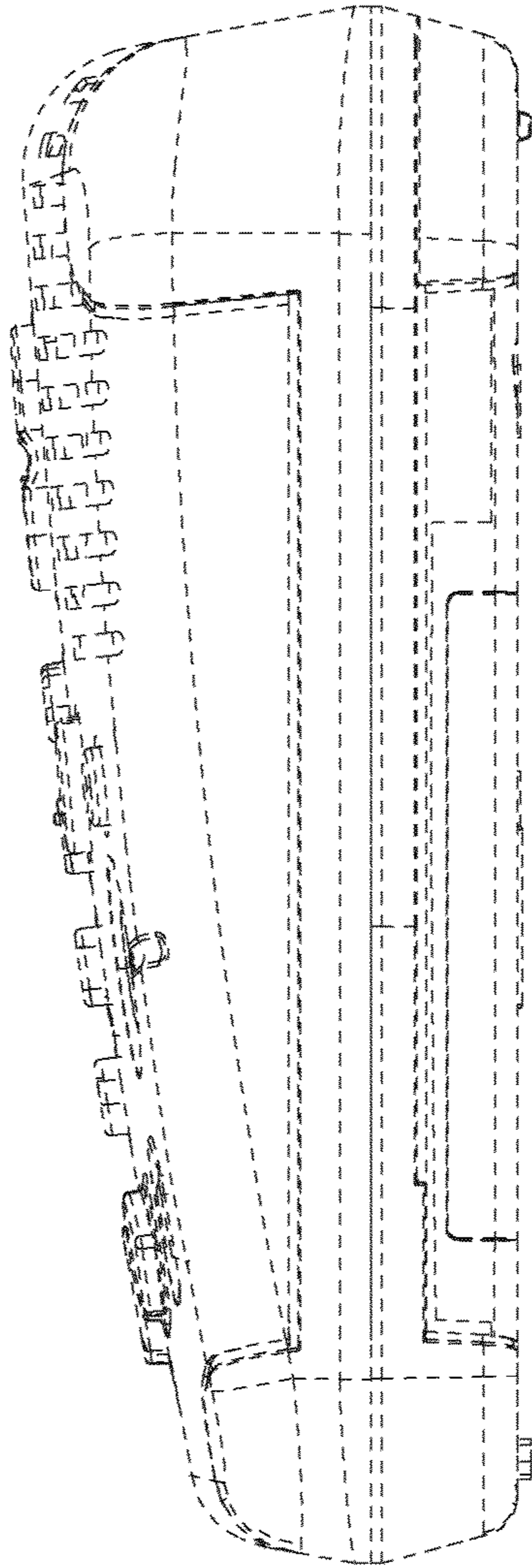

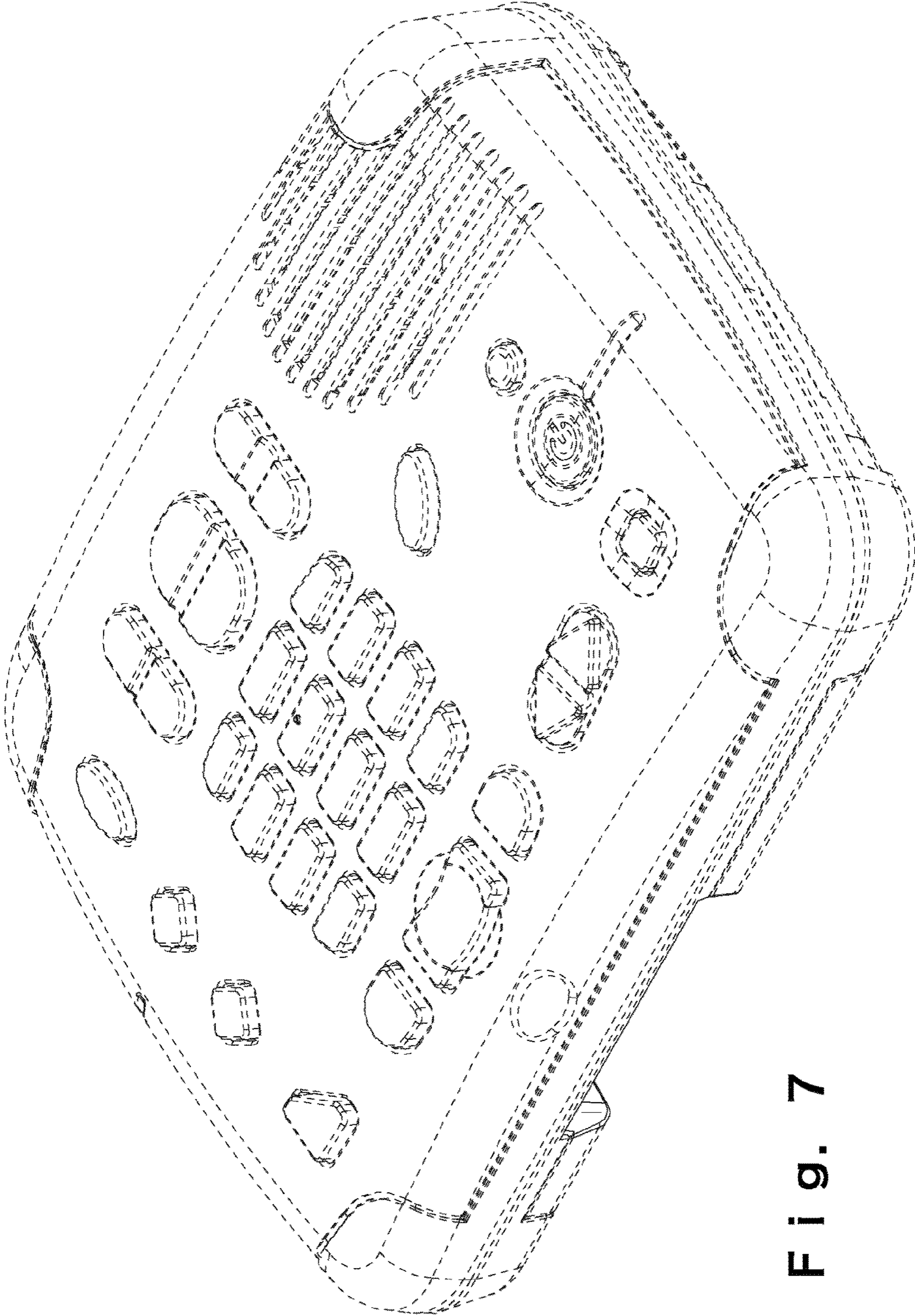

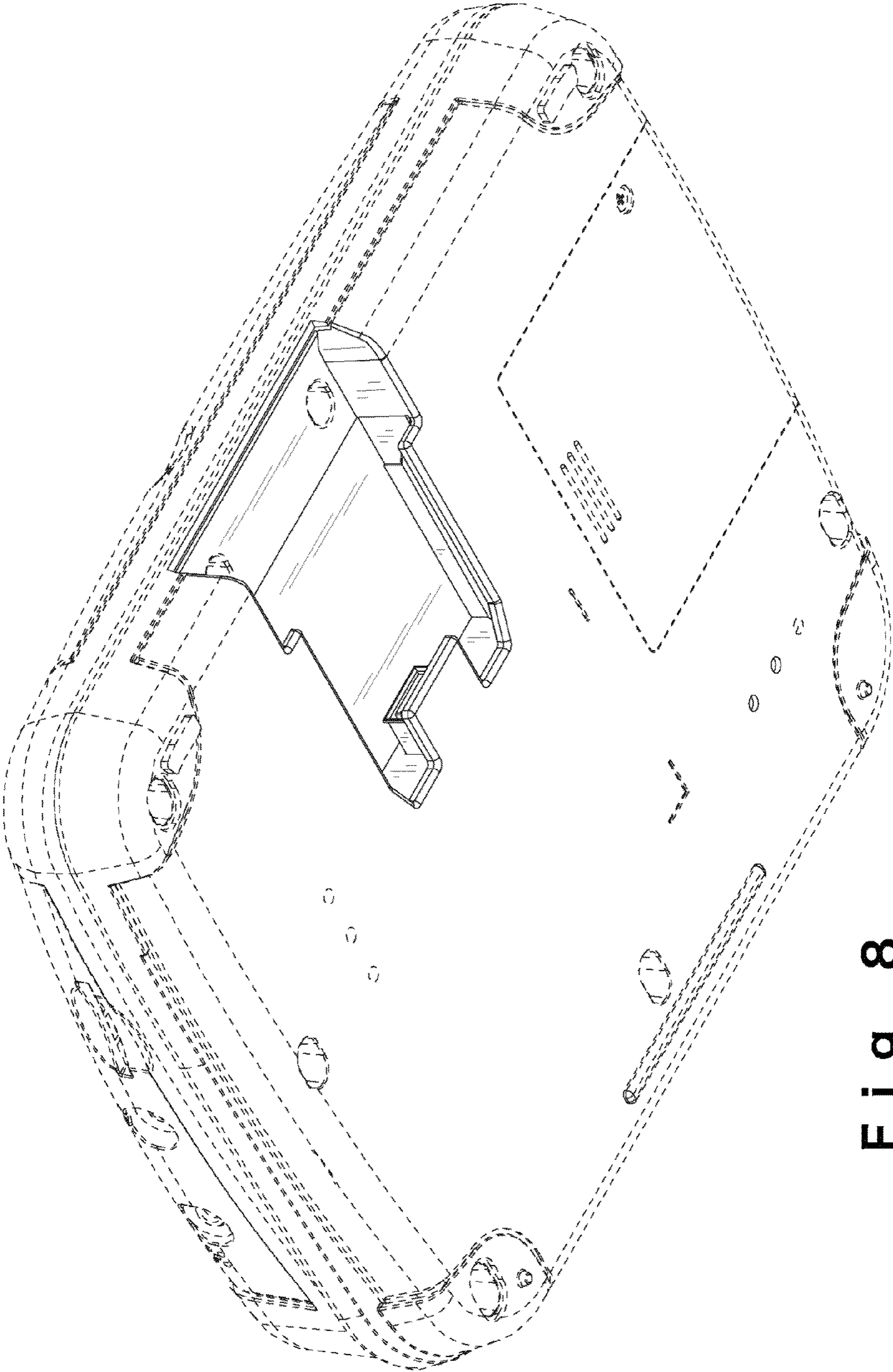

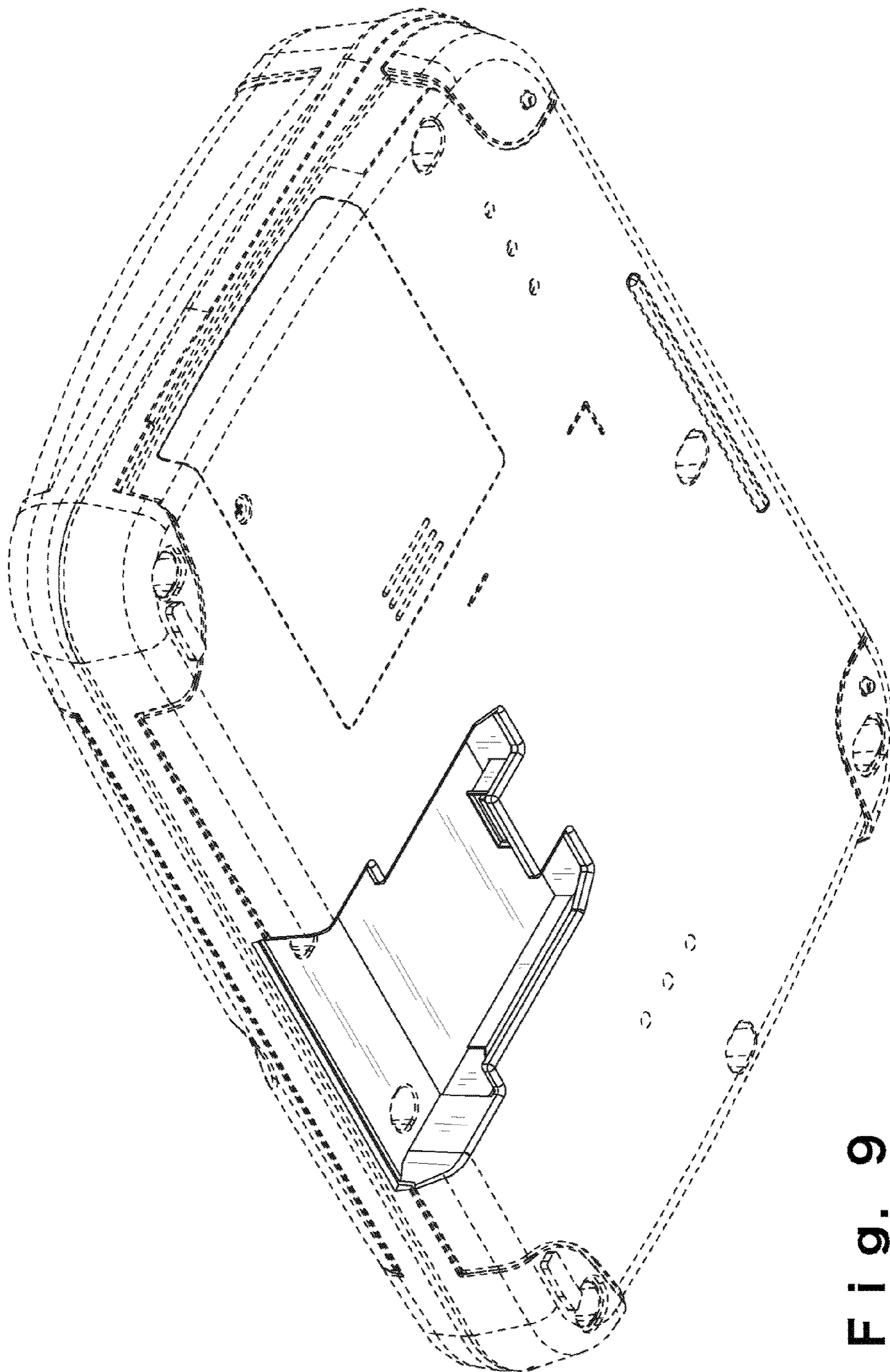
