DESCRIPTION

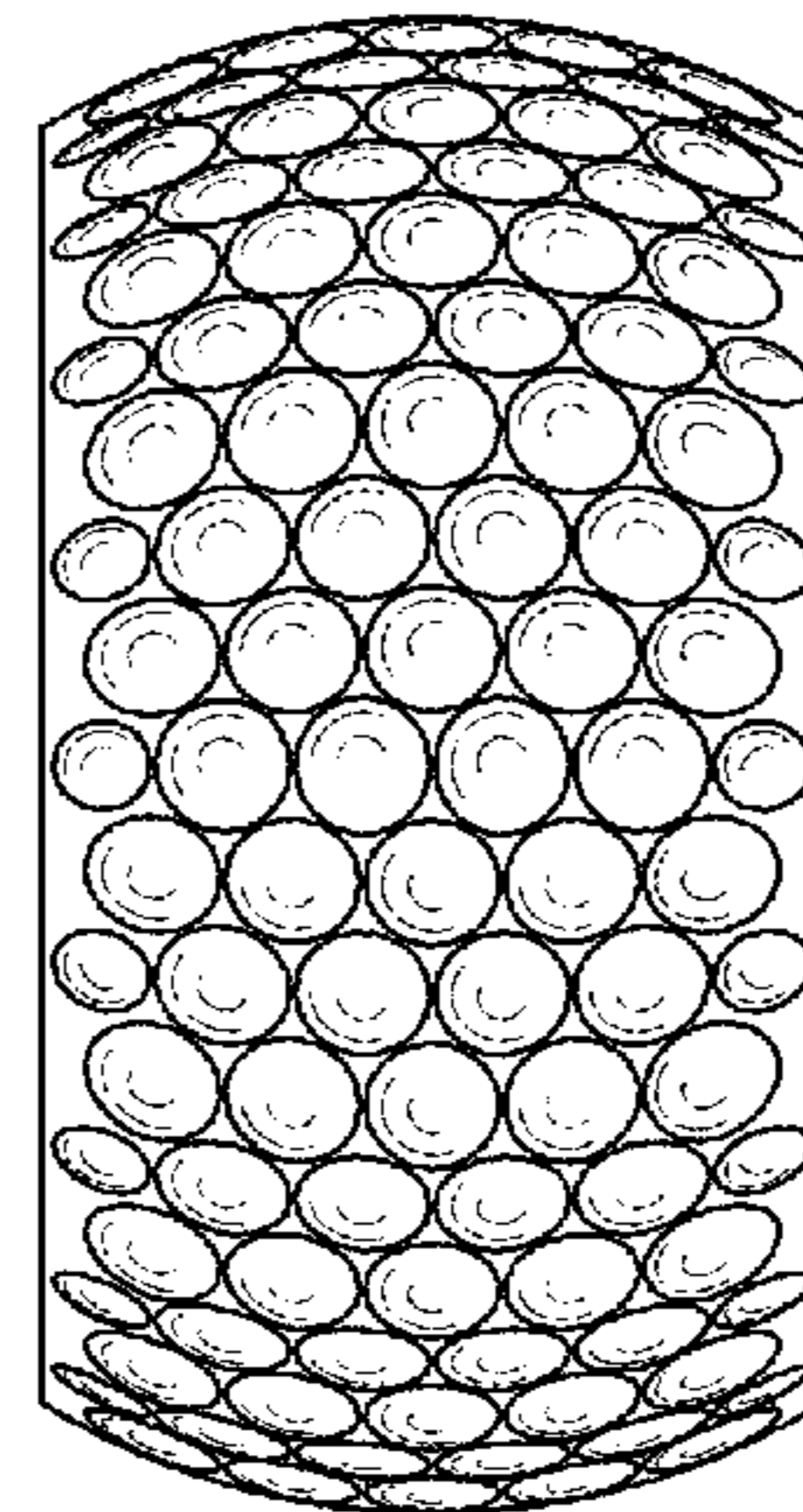
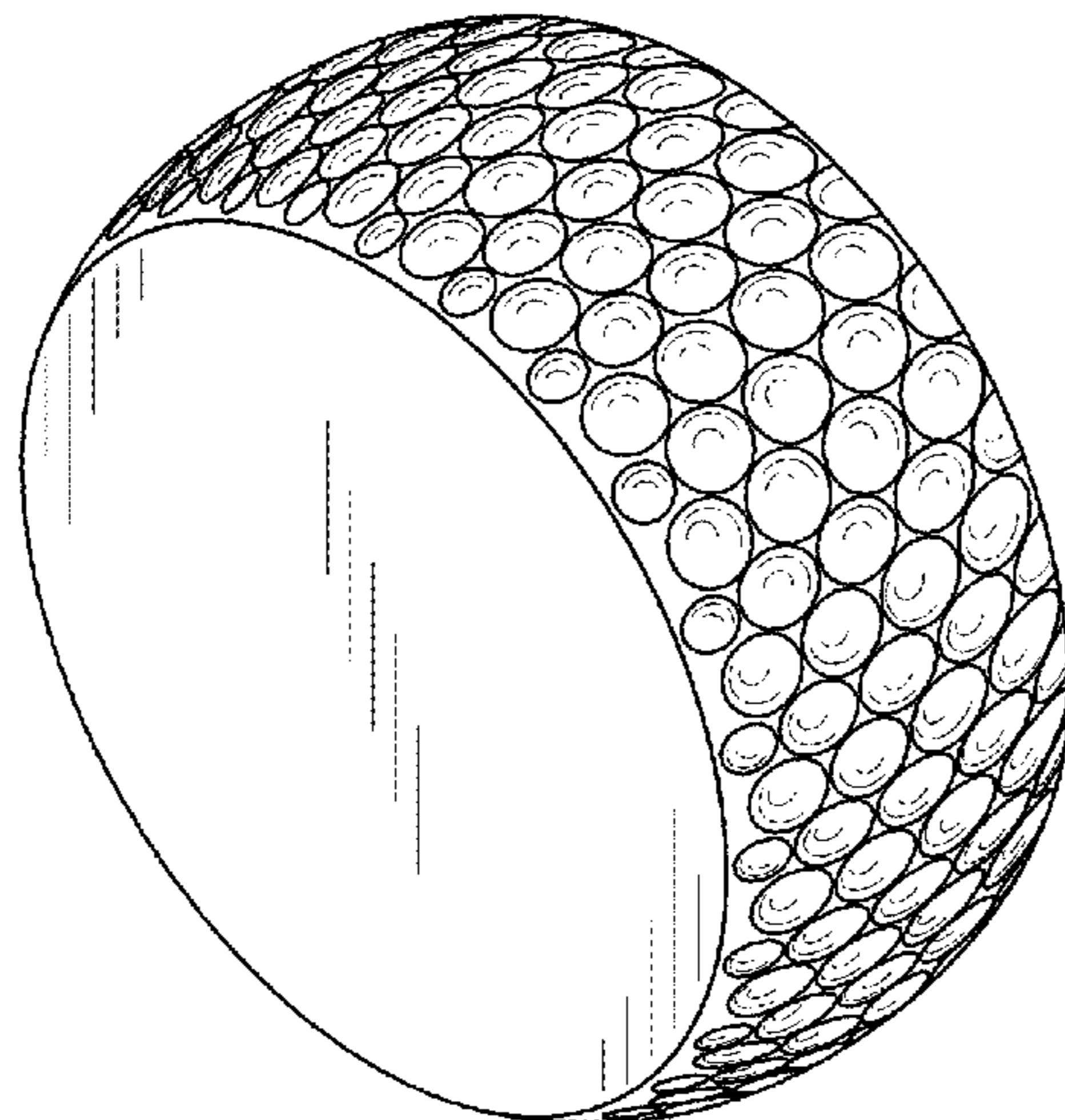
FIG. 1 is a perspective view of a golf training device embodying my new design;

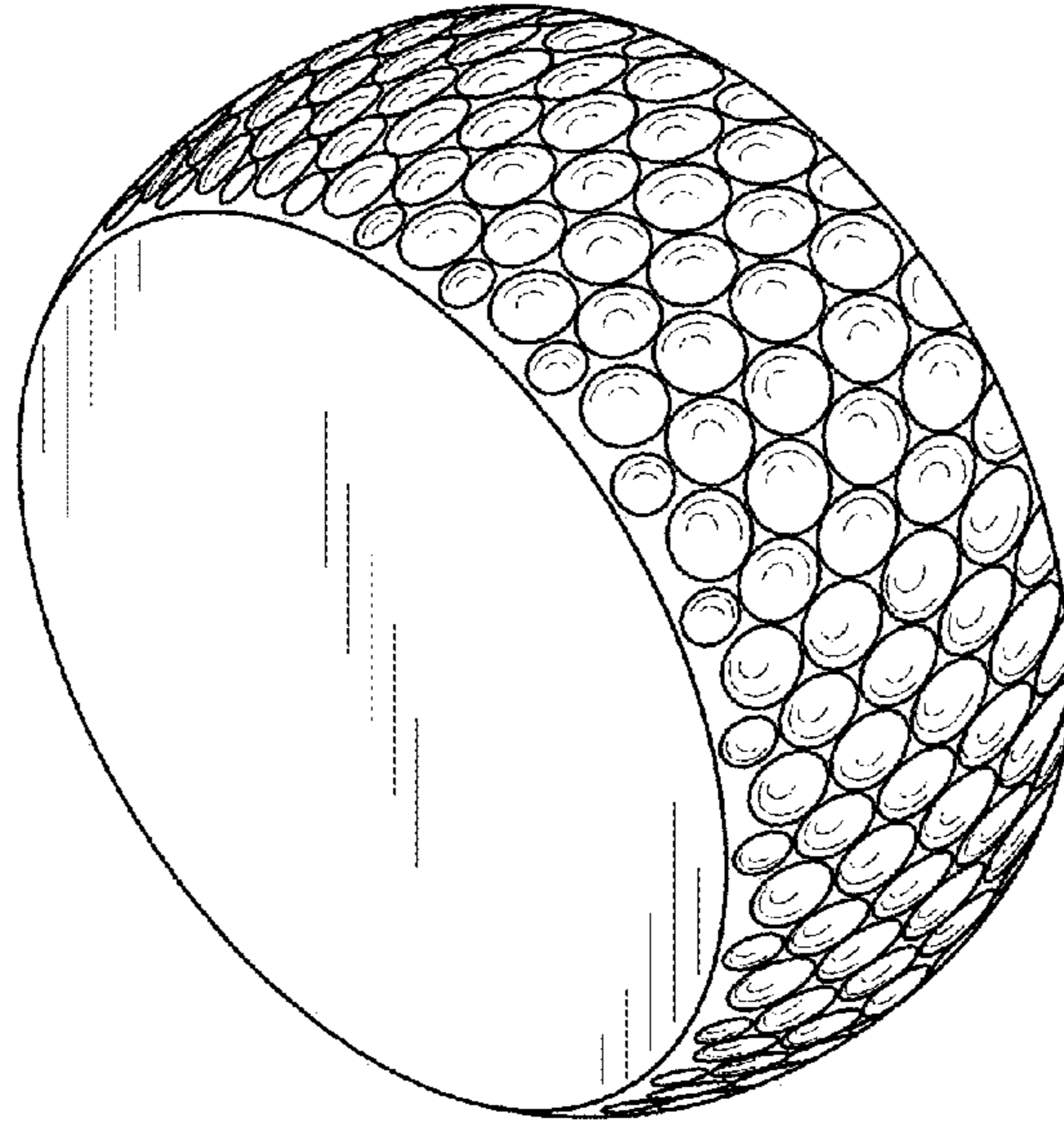

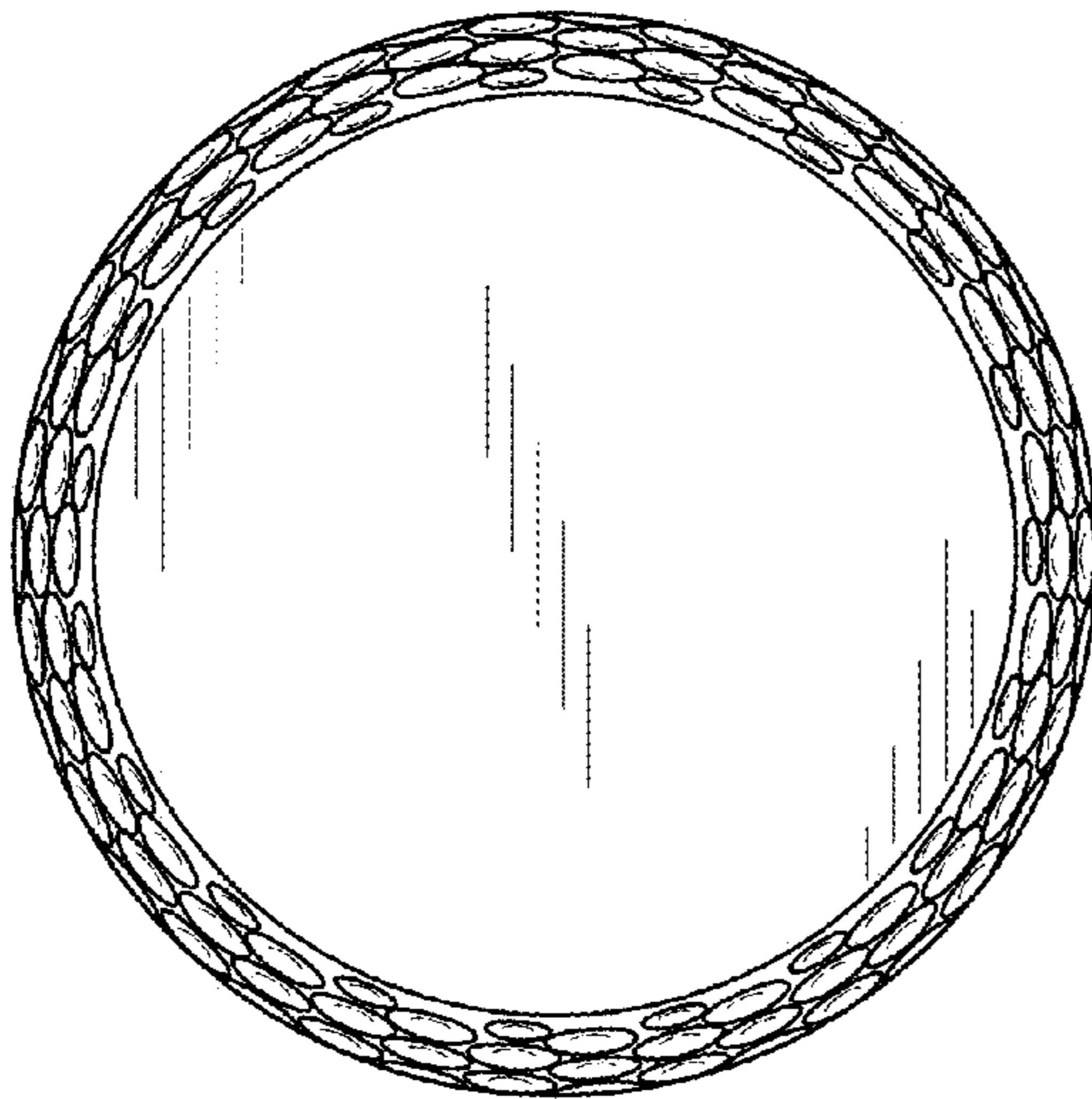

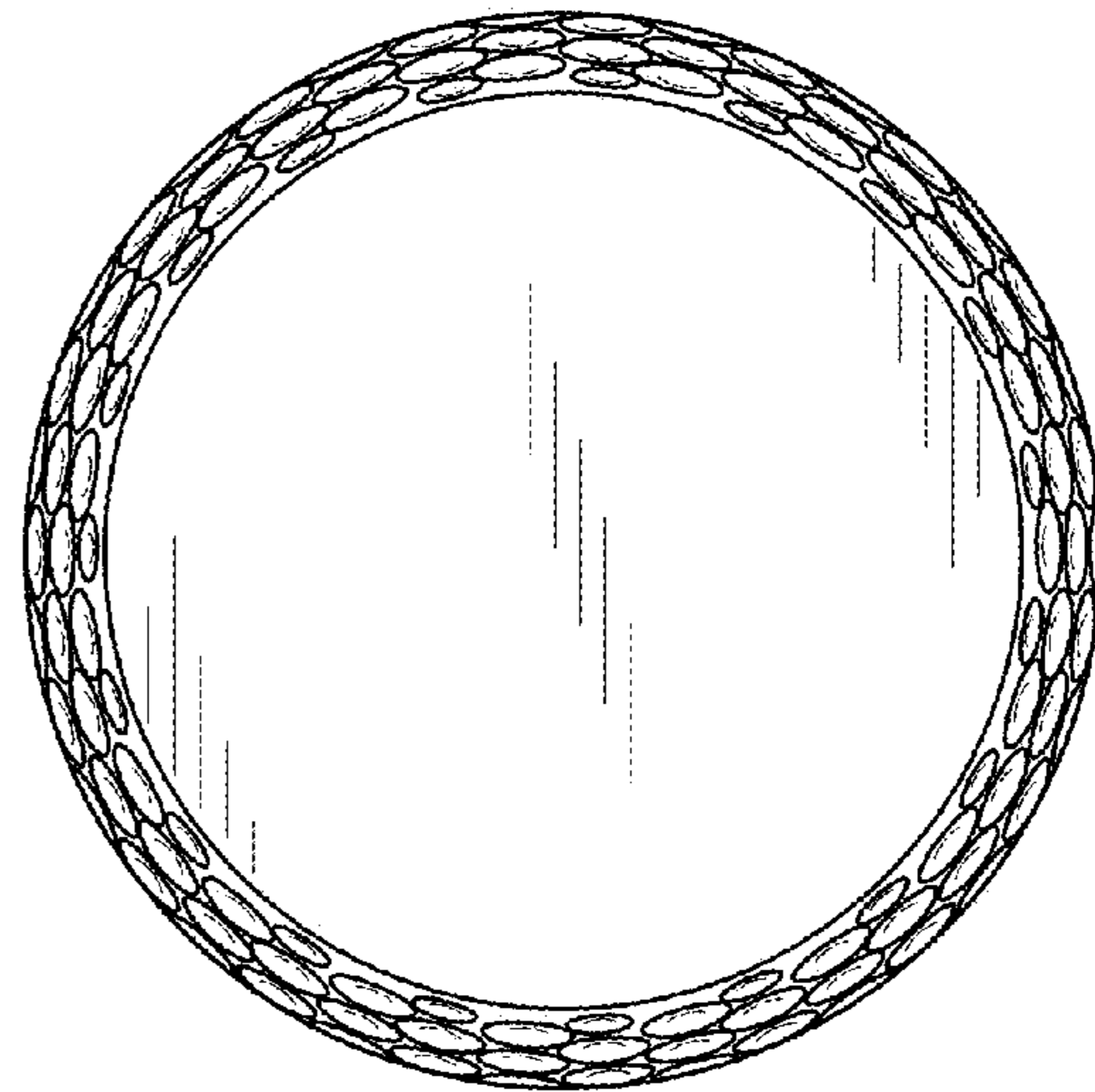

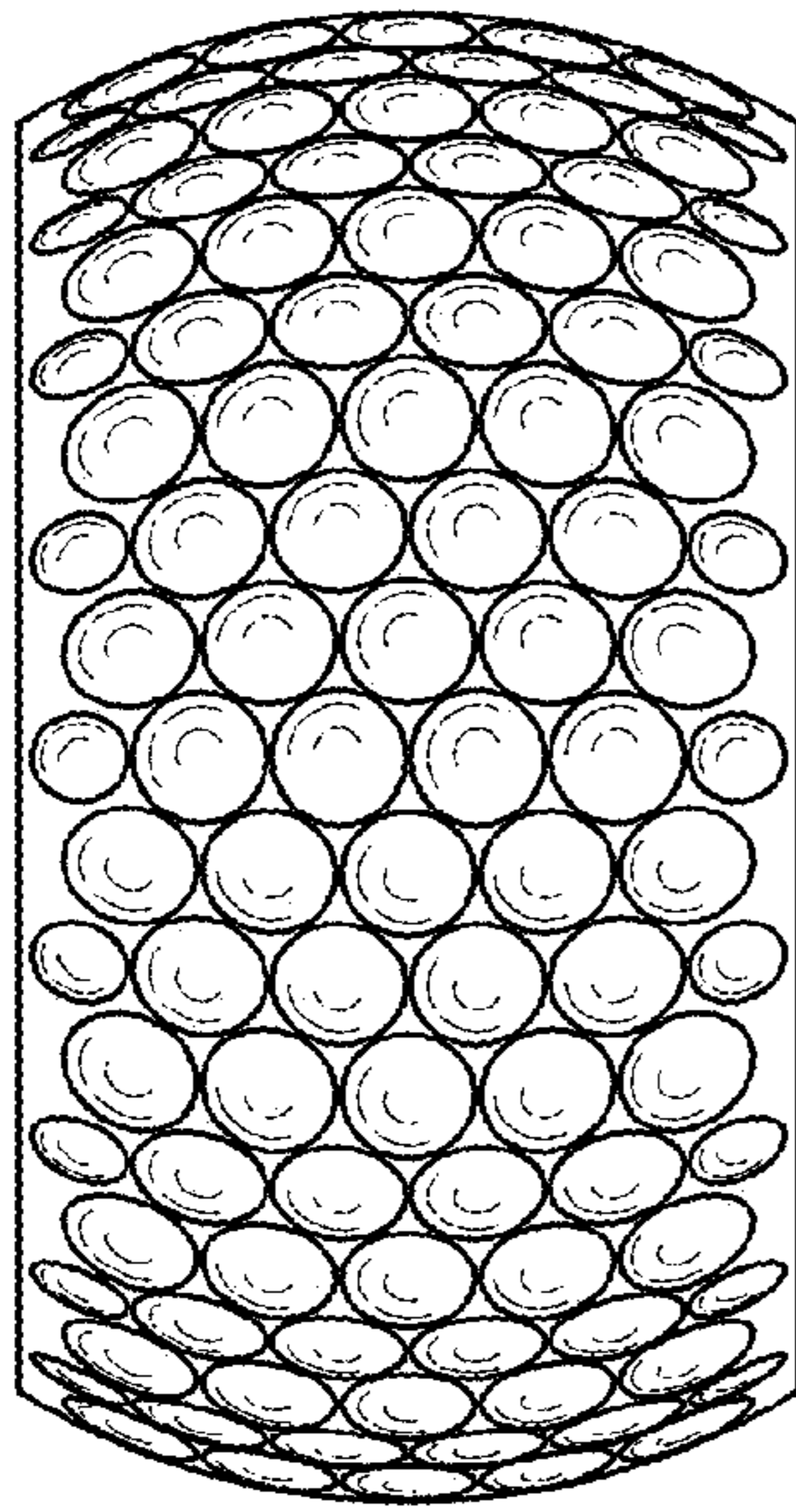

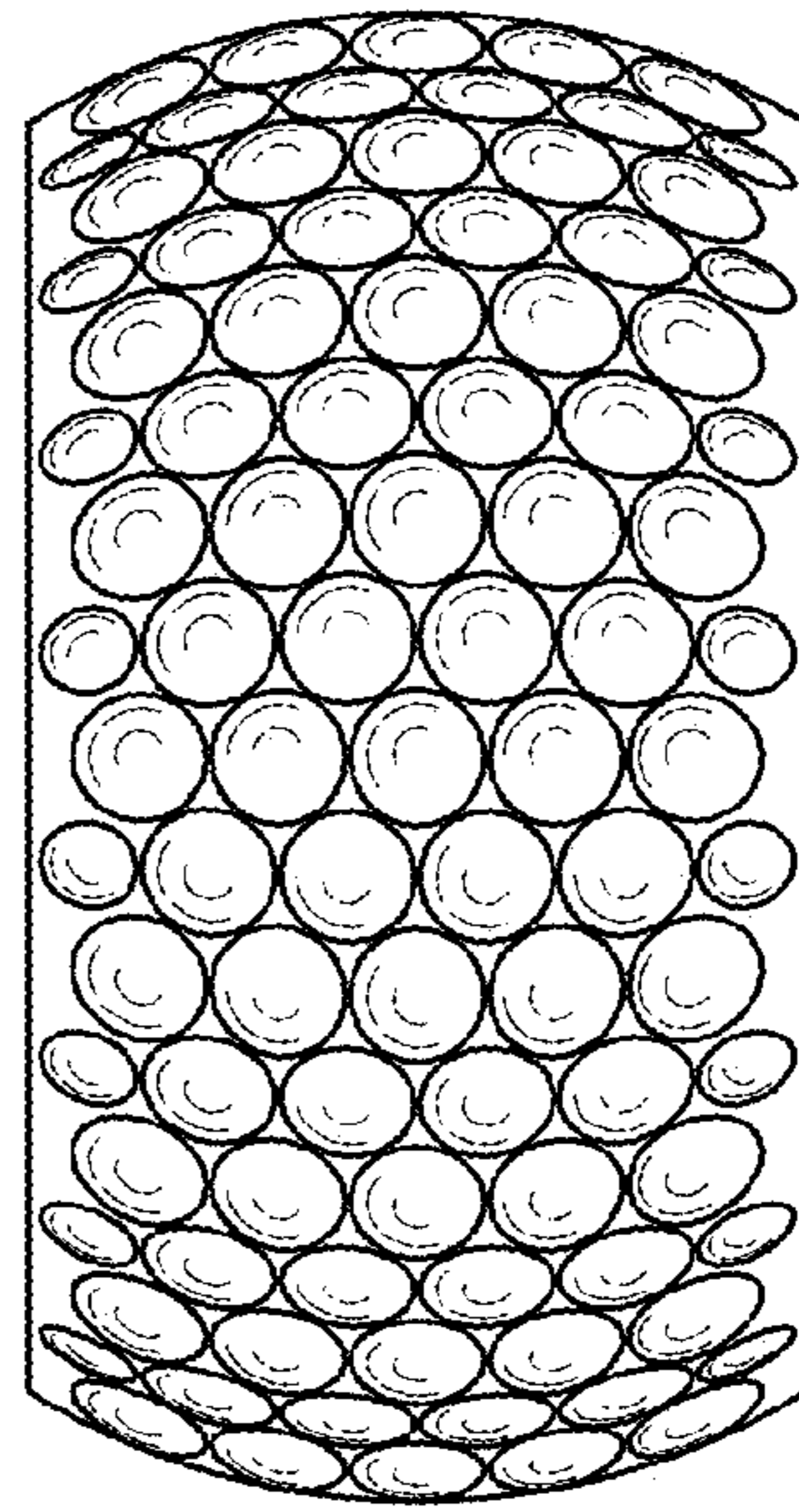

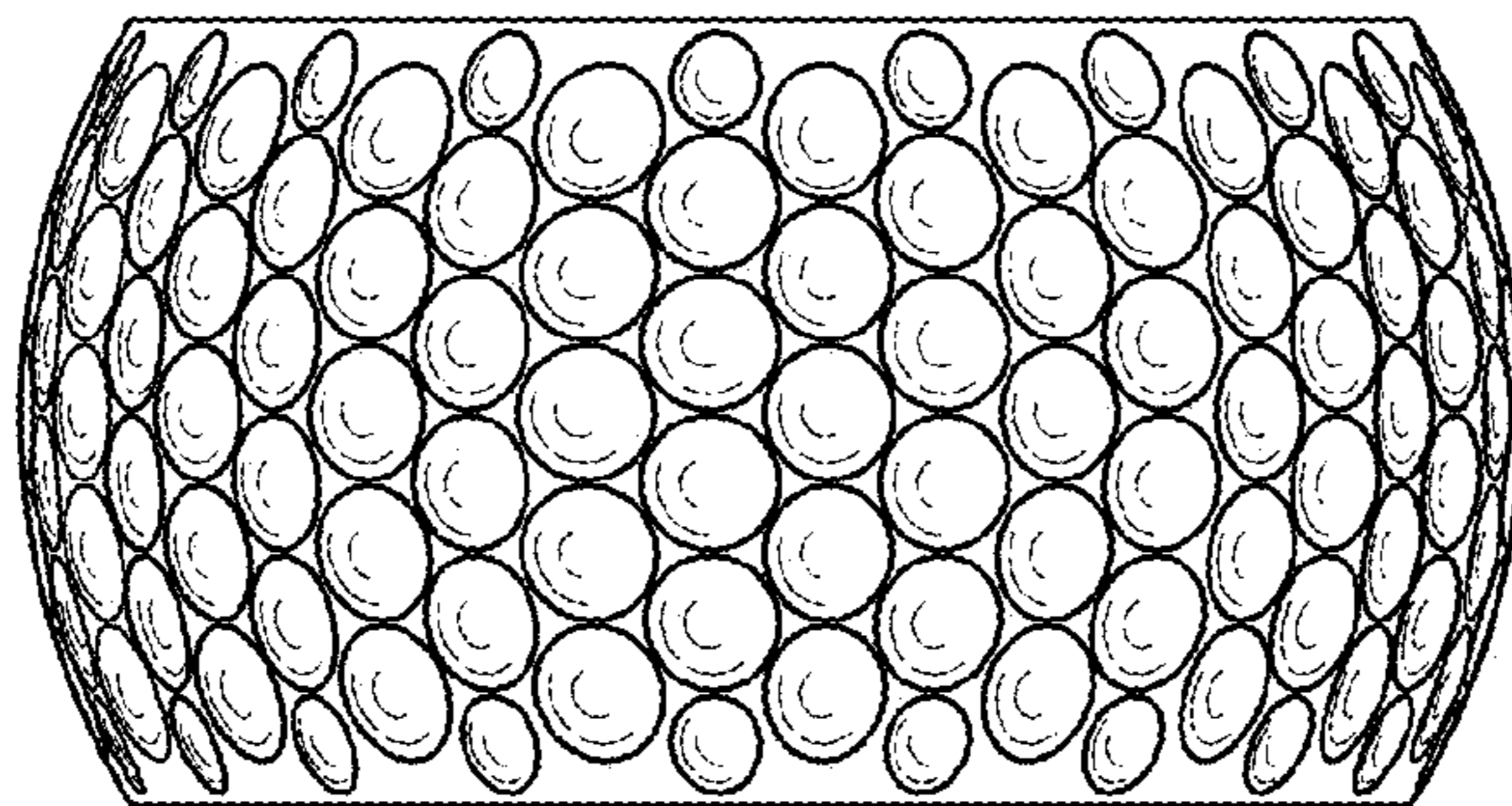

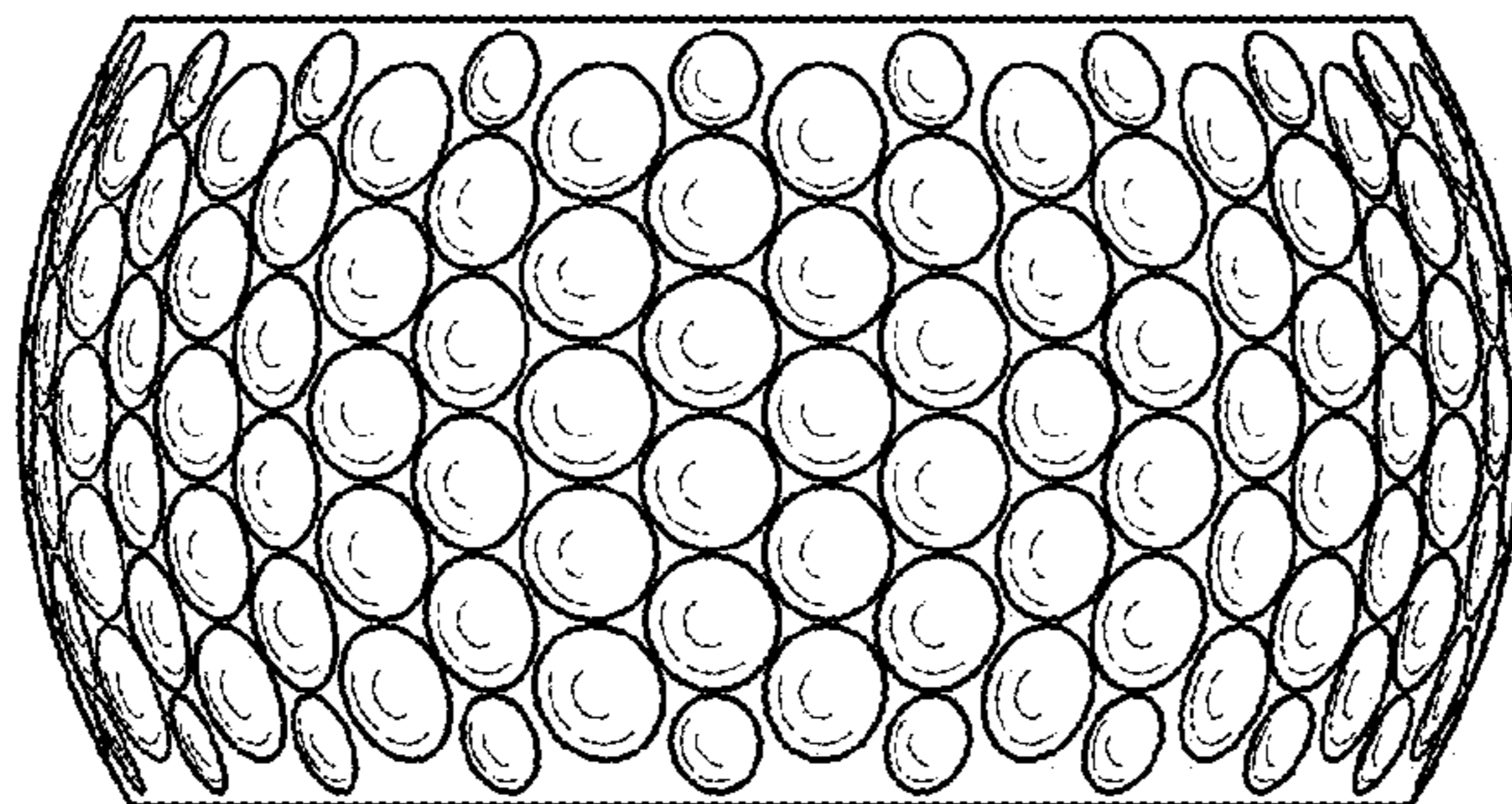
