FIG. 2 is a front perspective view of my folding footrest, fully assembled.

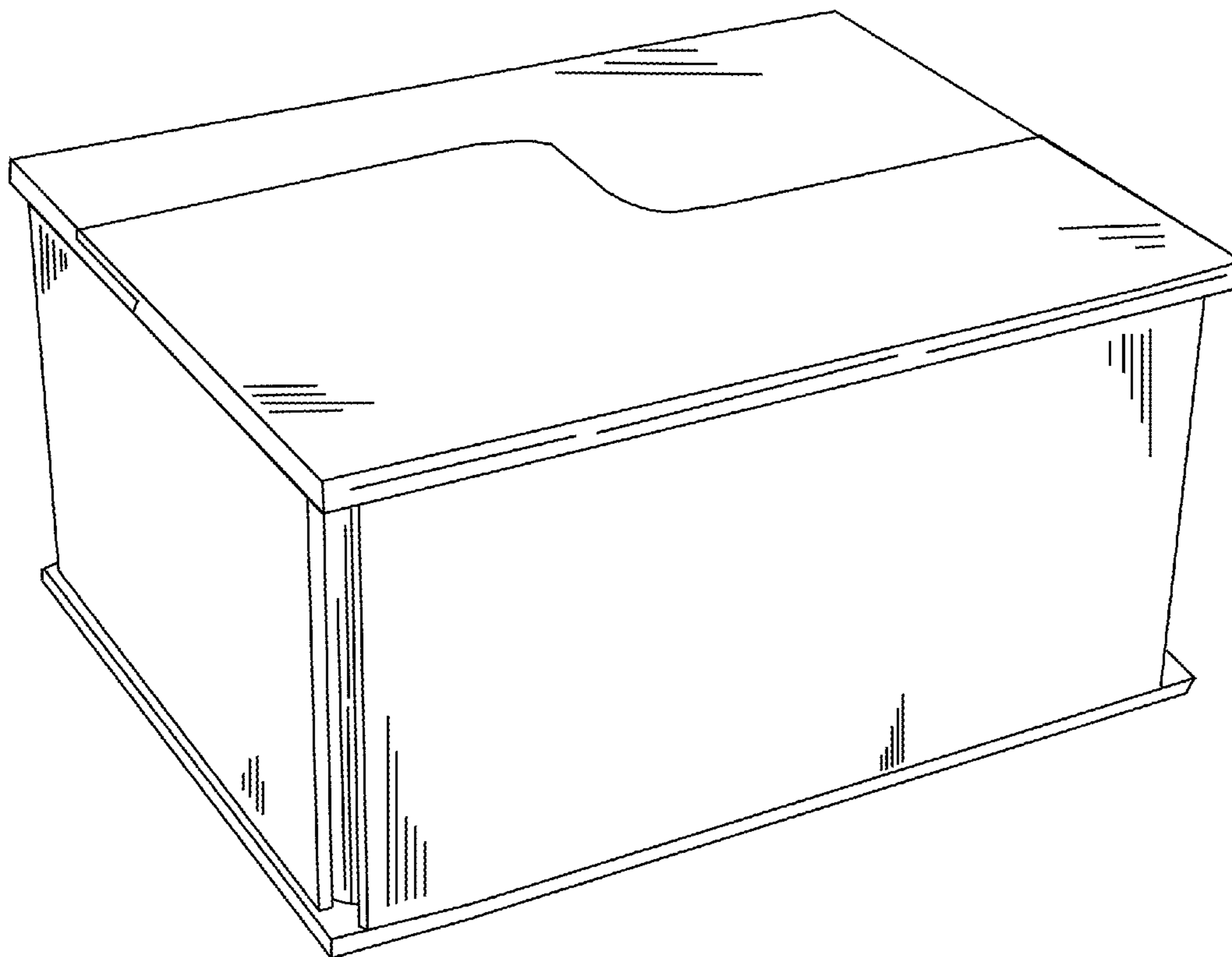
FIG. 3 is a right side elevation view of my folding footrest as fully assembled.

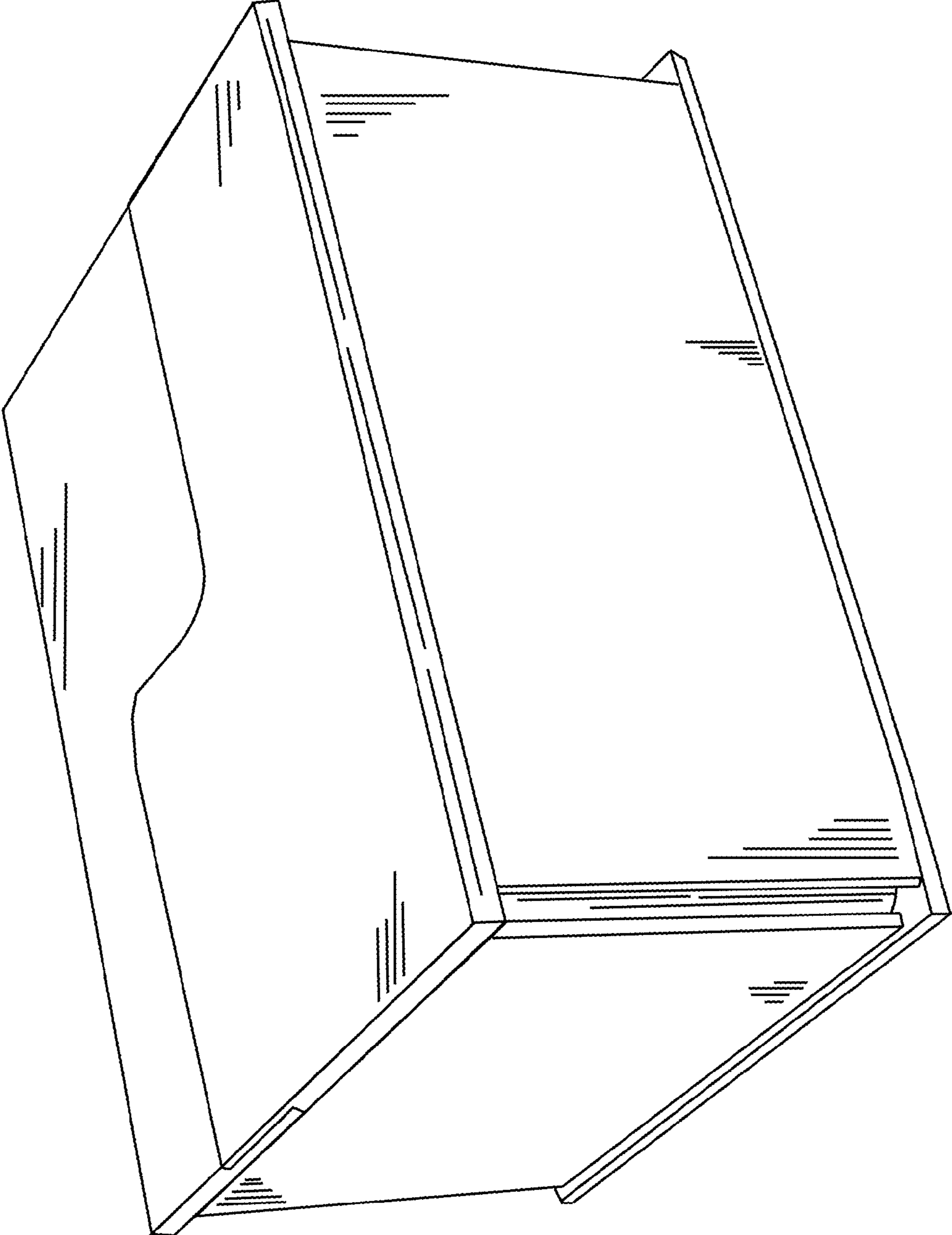

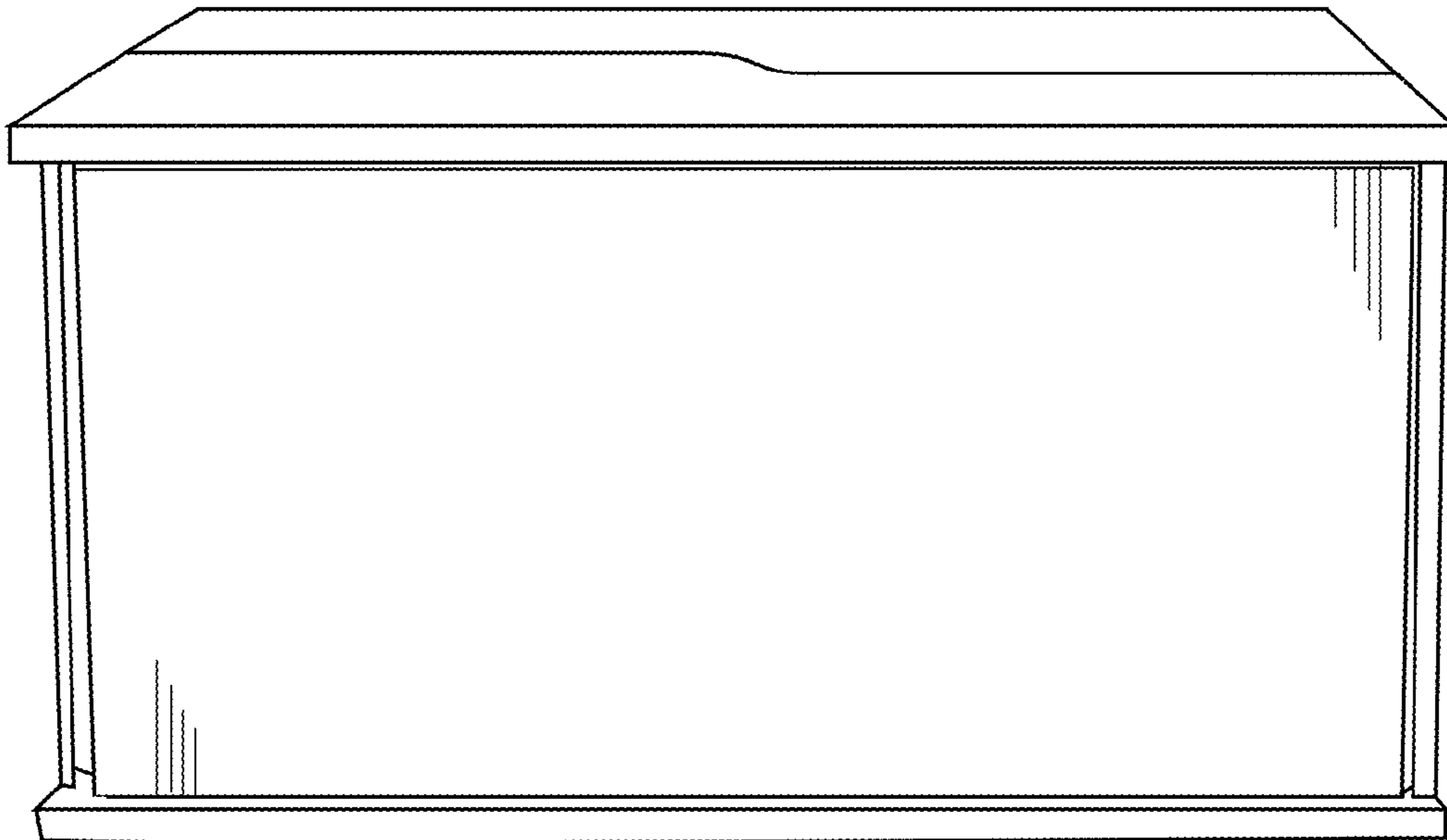

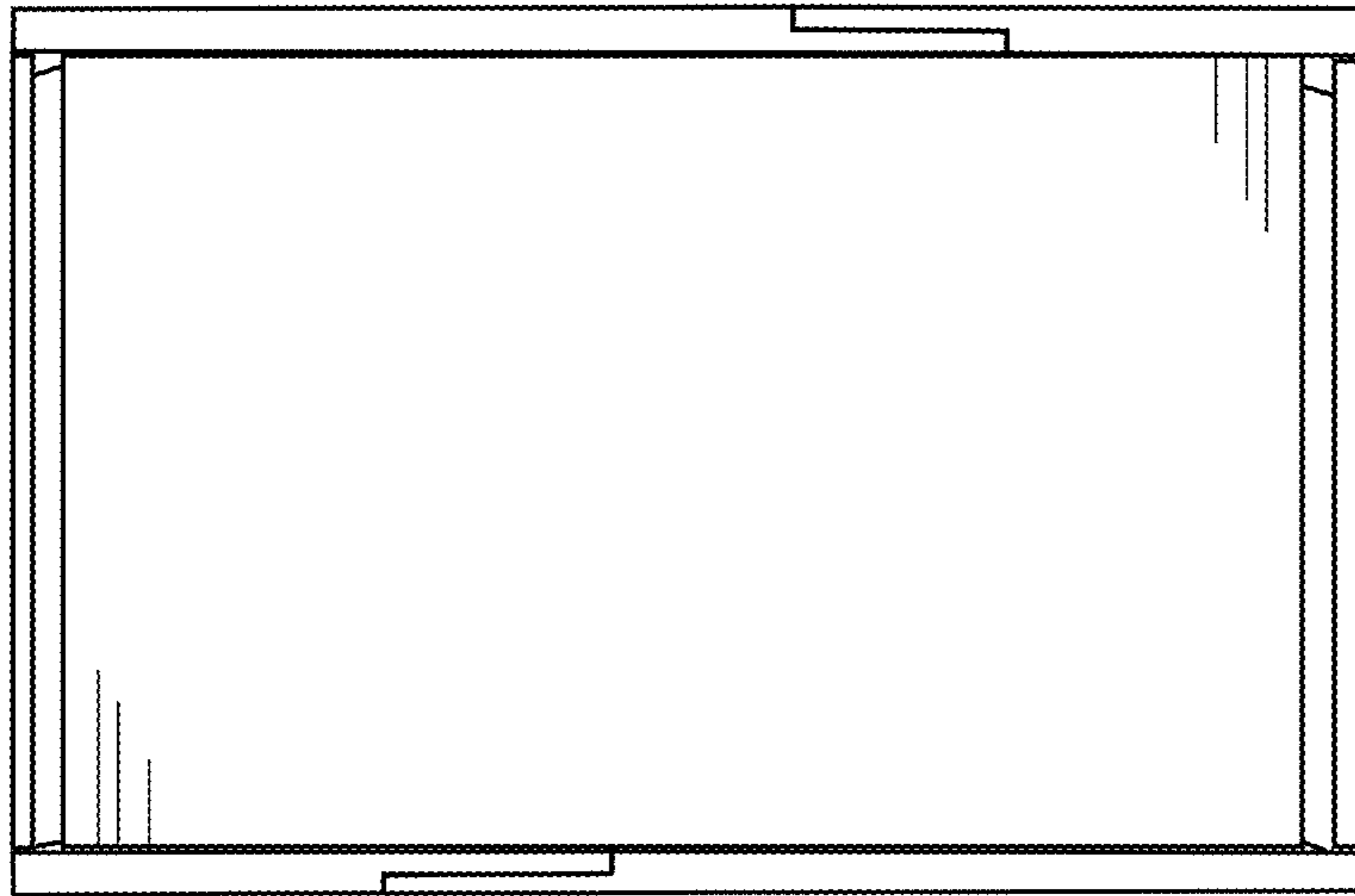

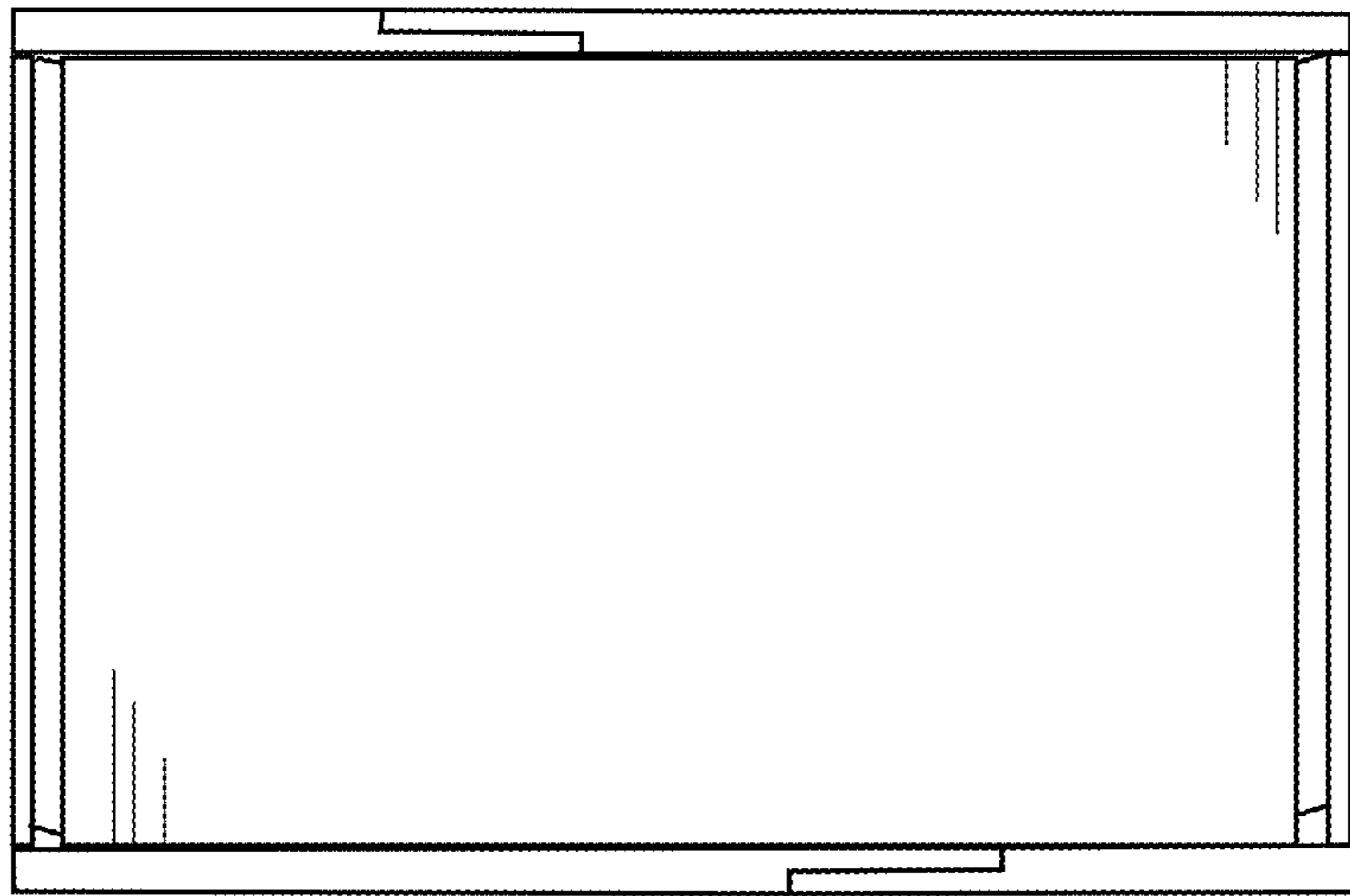

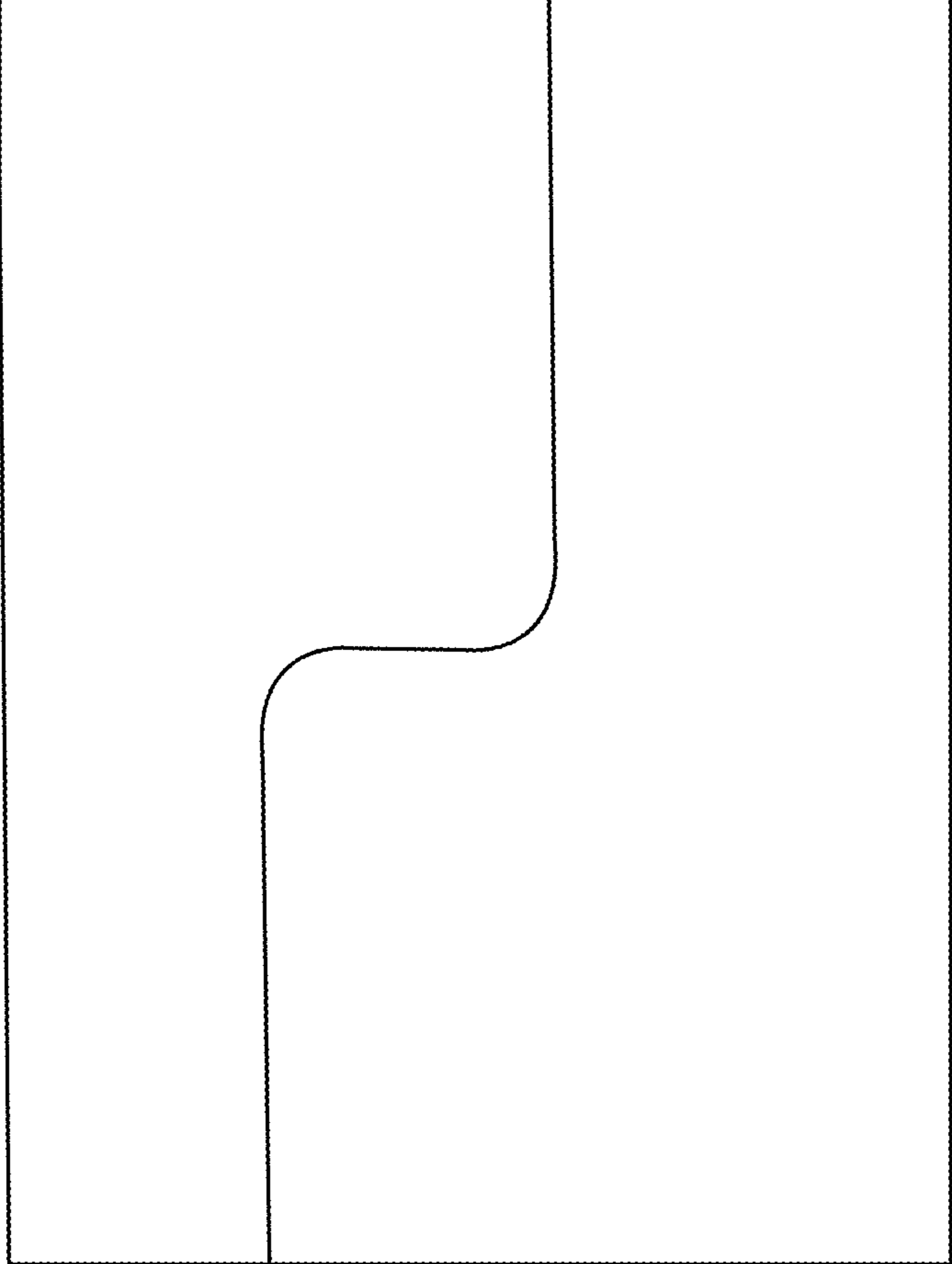

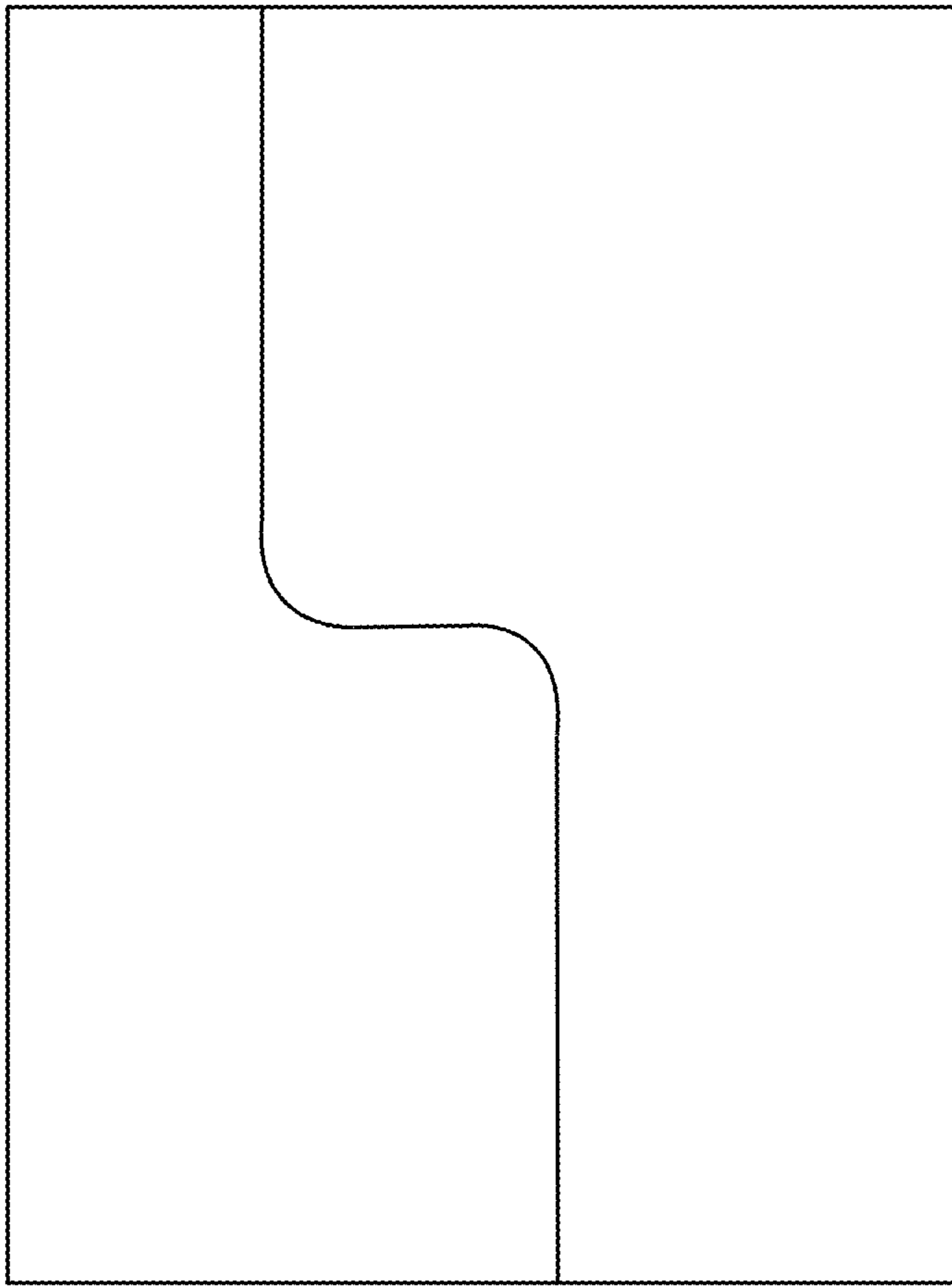
