DESCRIPTION

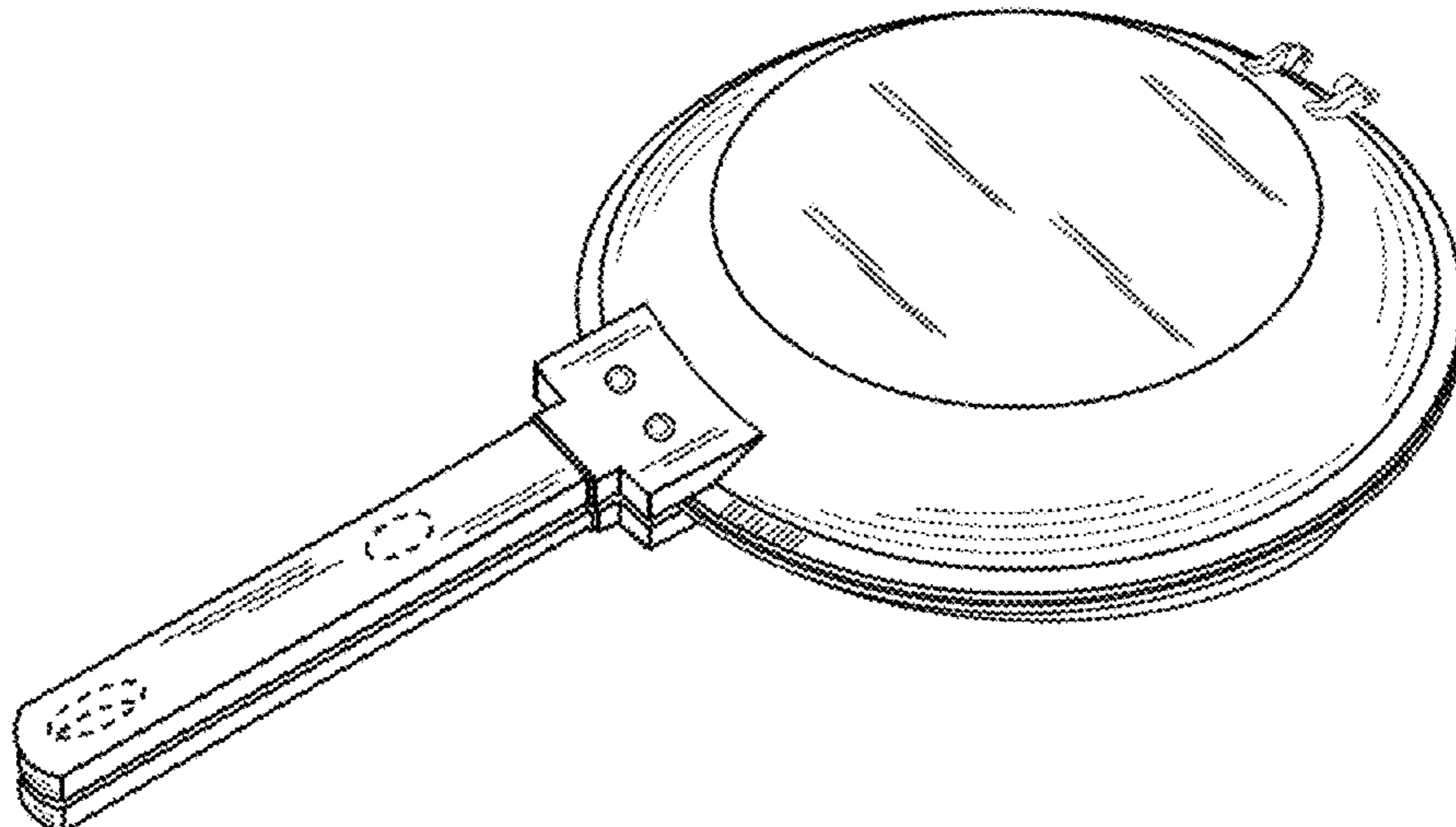
FIG. 1 is a downward-looking perspective view of the top of
a skillet pancake flipper in accordance with the present inven-
tion;

FIG. 2 is a downward-looking perspective view of the bottom
of the skillet pancake flipper of FIG. 1 in accordance with the
present invention;

FIG. 3 is an elevational left view of the skillet pancake flipper
of FIG. 1 in accordance with the present invention; and,
FIG. 4 is an elevational right view of the skillet pancake
flipper of FIG. 1 in accordance with the present invention.

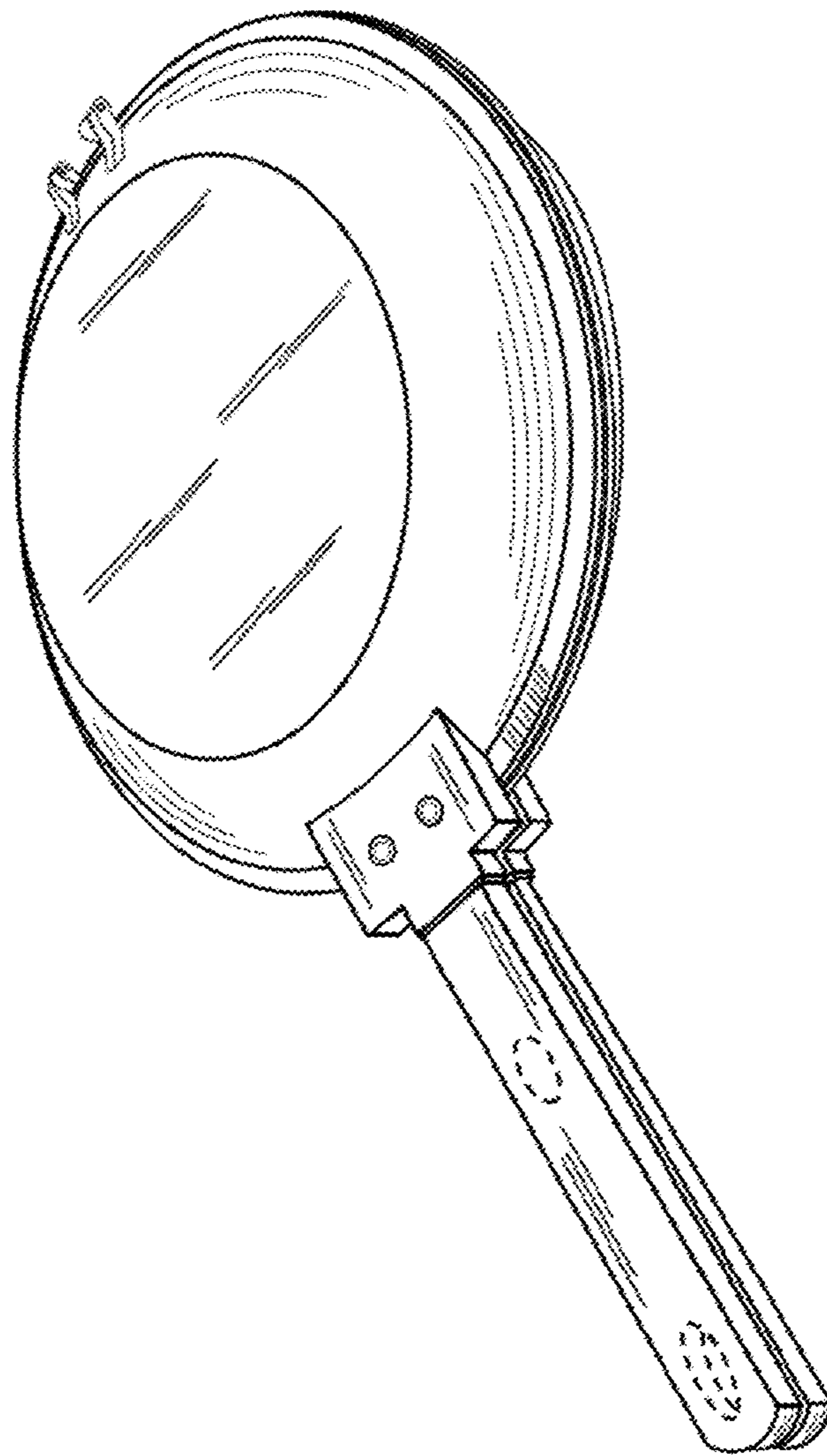

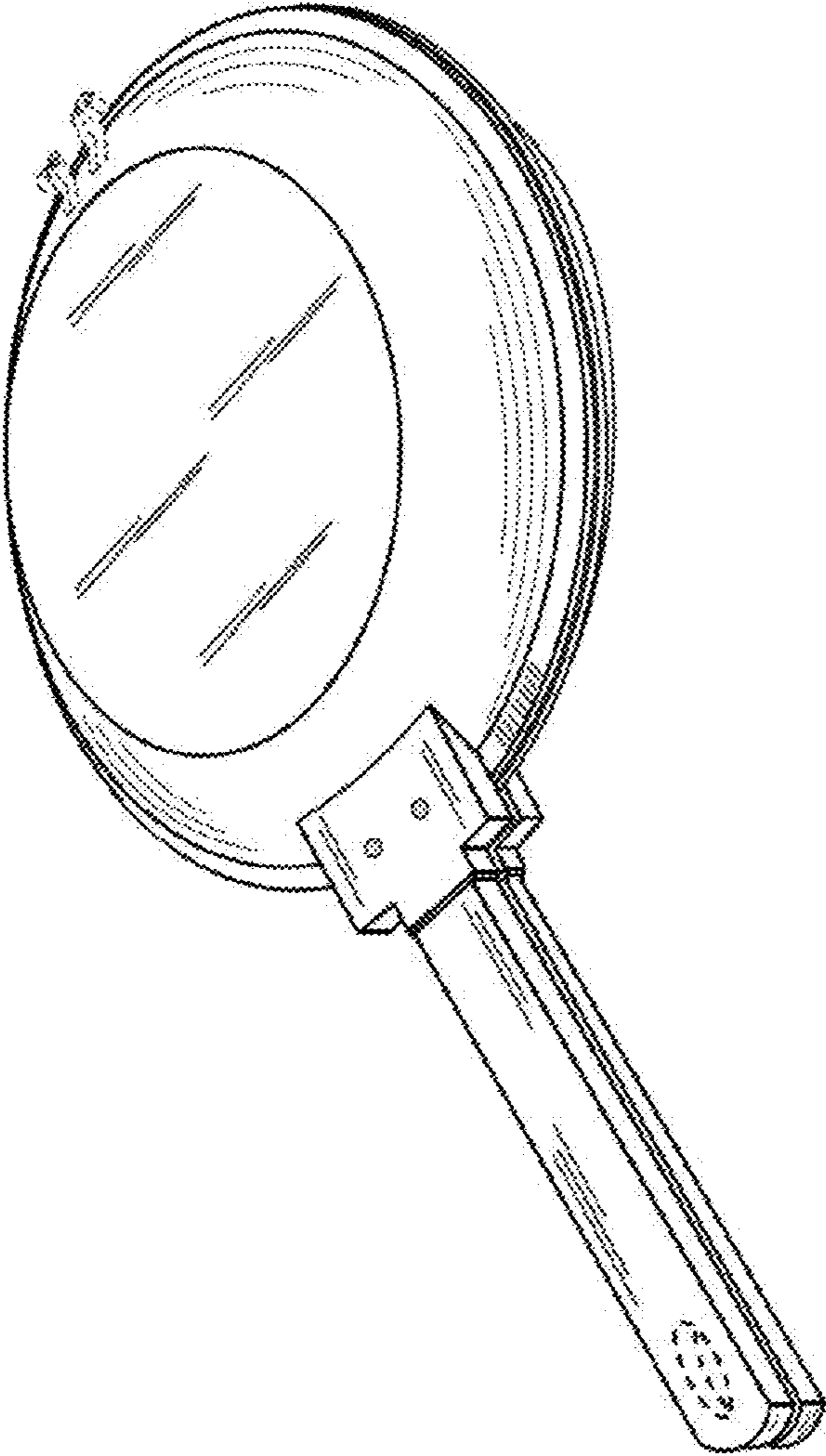

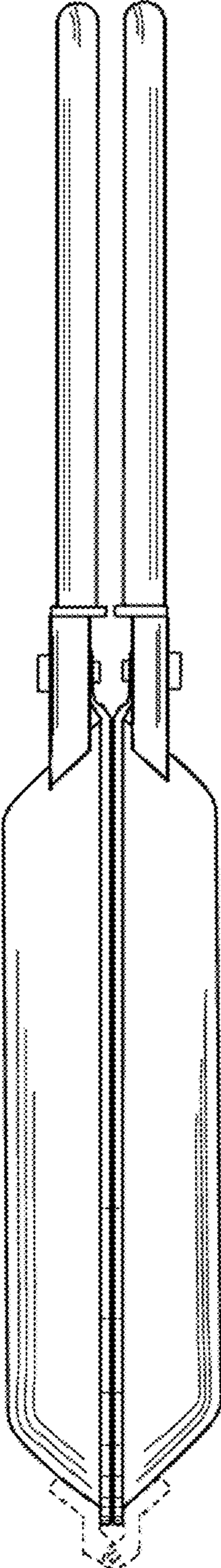

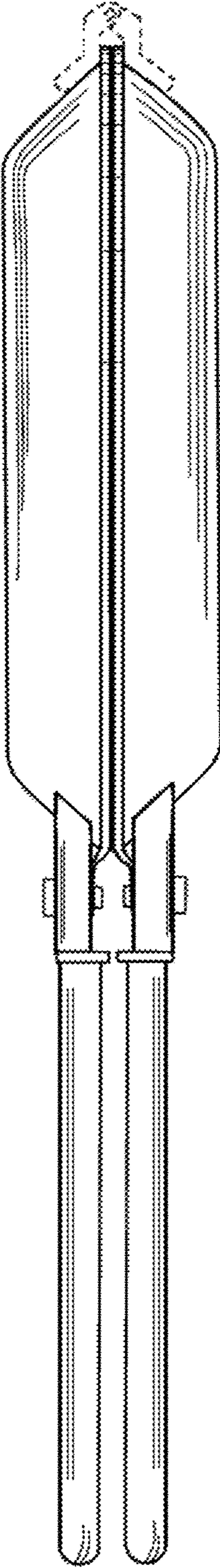
