(57) **CLAIM**

The ornamental design for a bowl, as shown and described.

DESCRIPTION

FIG. 1 is a front, perspective view of a bowl showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof, the left side view being a mirror image of the right side view;

FIG. 5 is a top view thereof; and

FIG. 6 is a bottom view thereof.

FIG. 7 is a front, perspective view of a bowl shown in a configuration of use with the broken lines representing environmental subject matter and forming no part of the claim;

FIG. 8 is a front perspective view showing the bowl in another environment of use;

FIG. 9 is a front view thereof;

FIG. 10 is a rear view thereof;

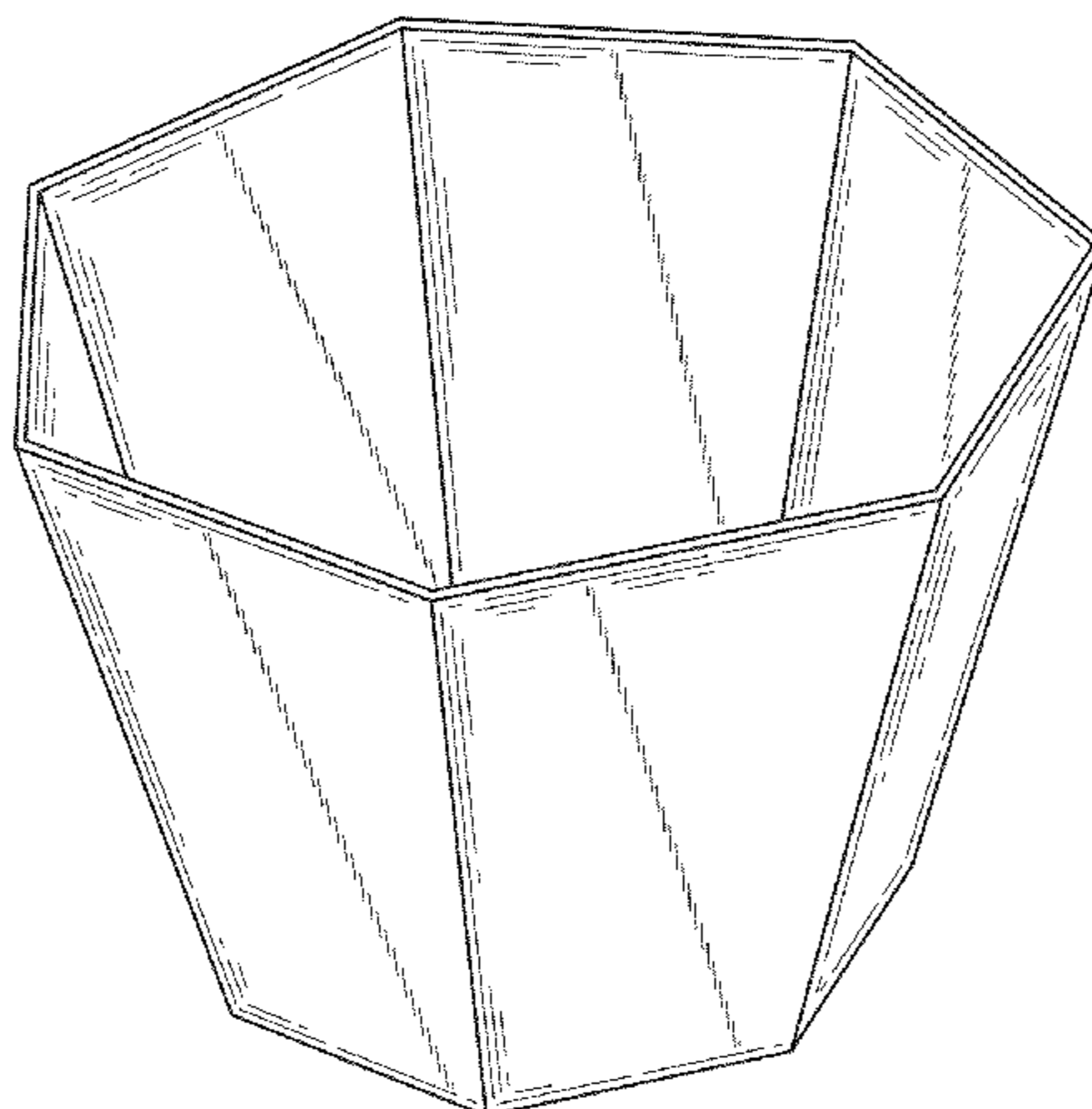
FIG. 11 is a right side view thereof, the left side view being a mirror image of the right side view;

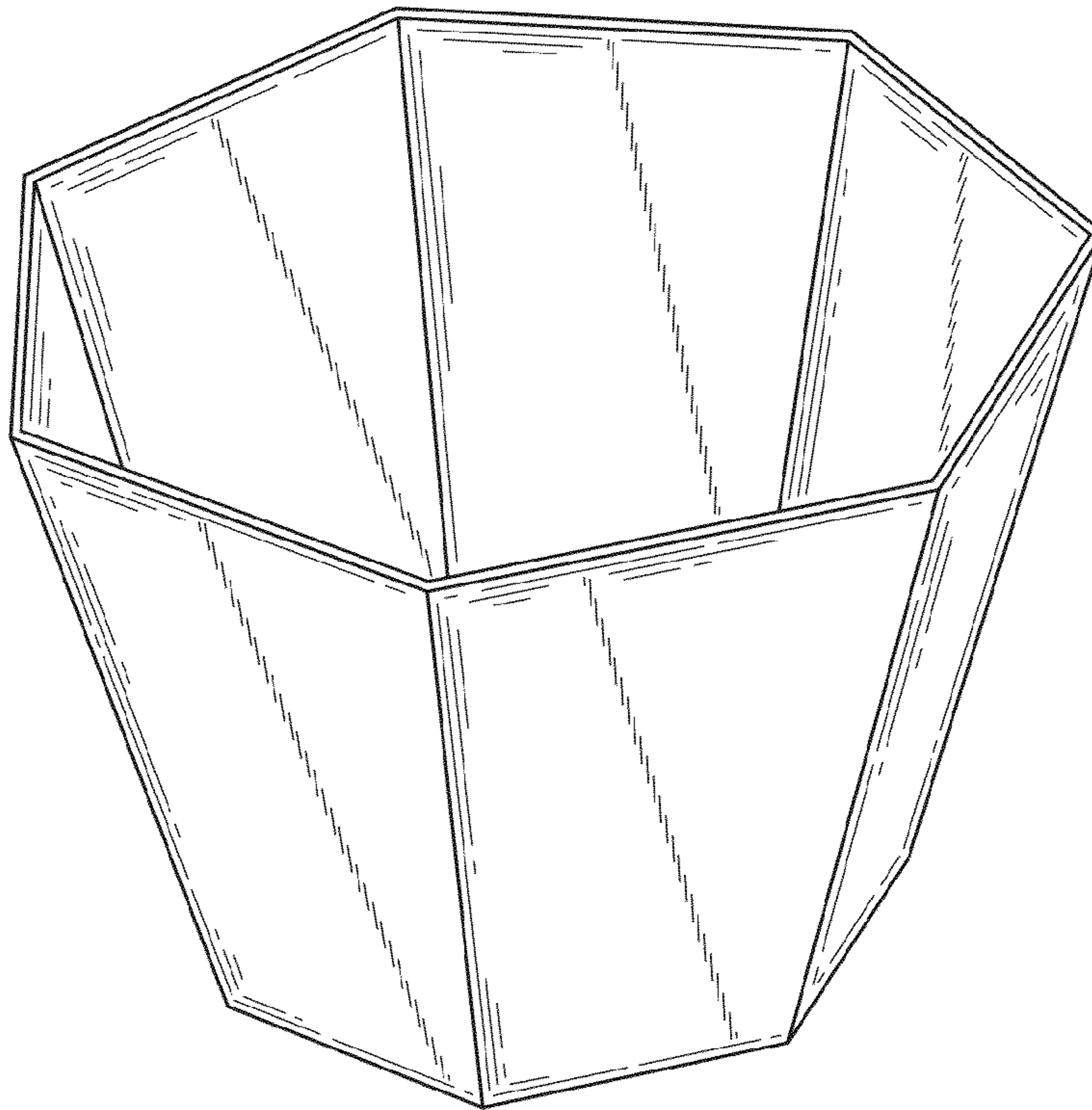

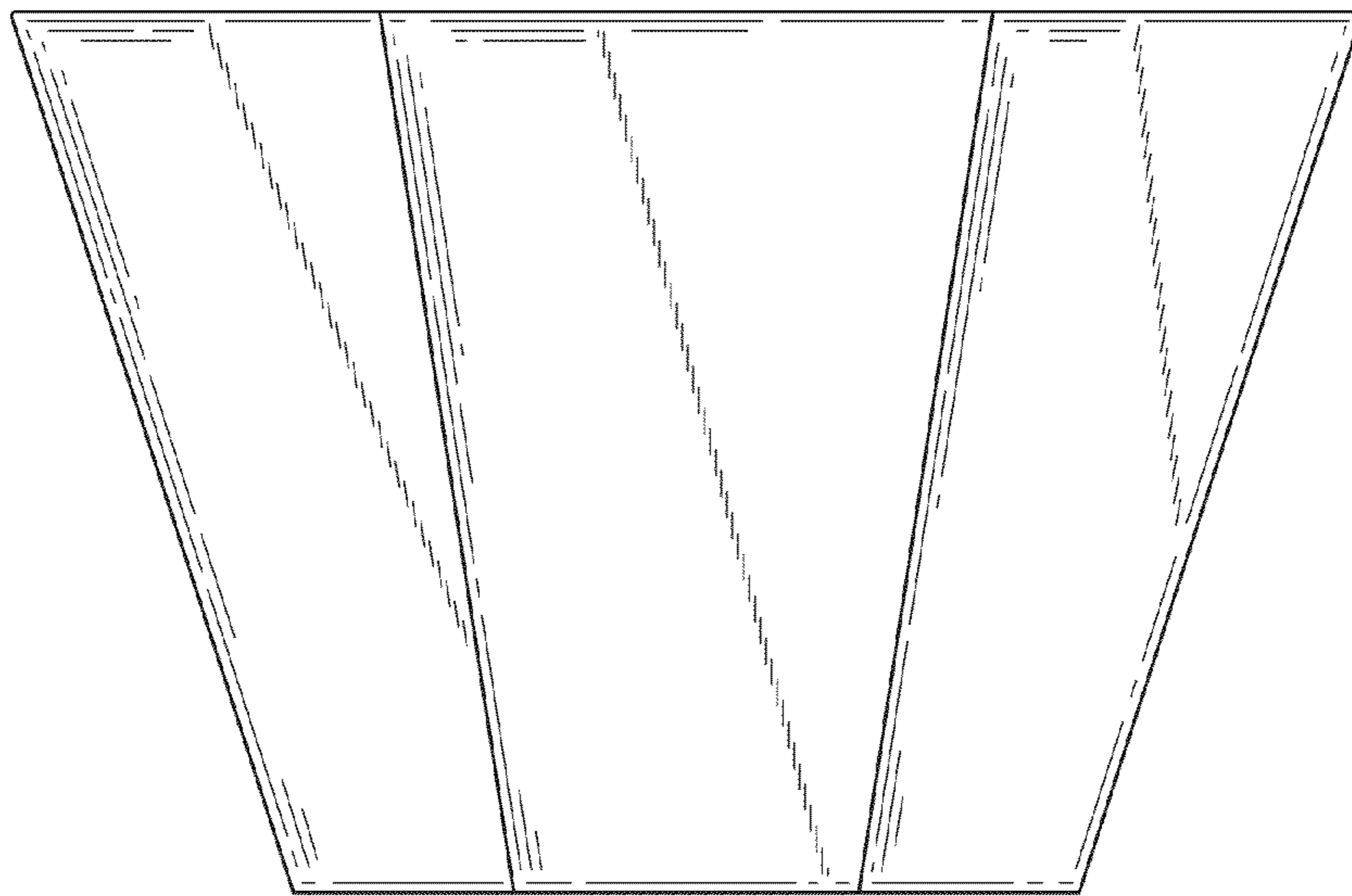

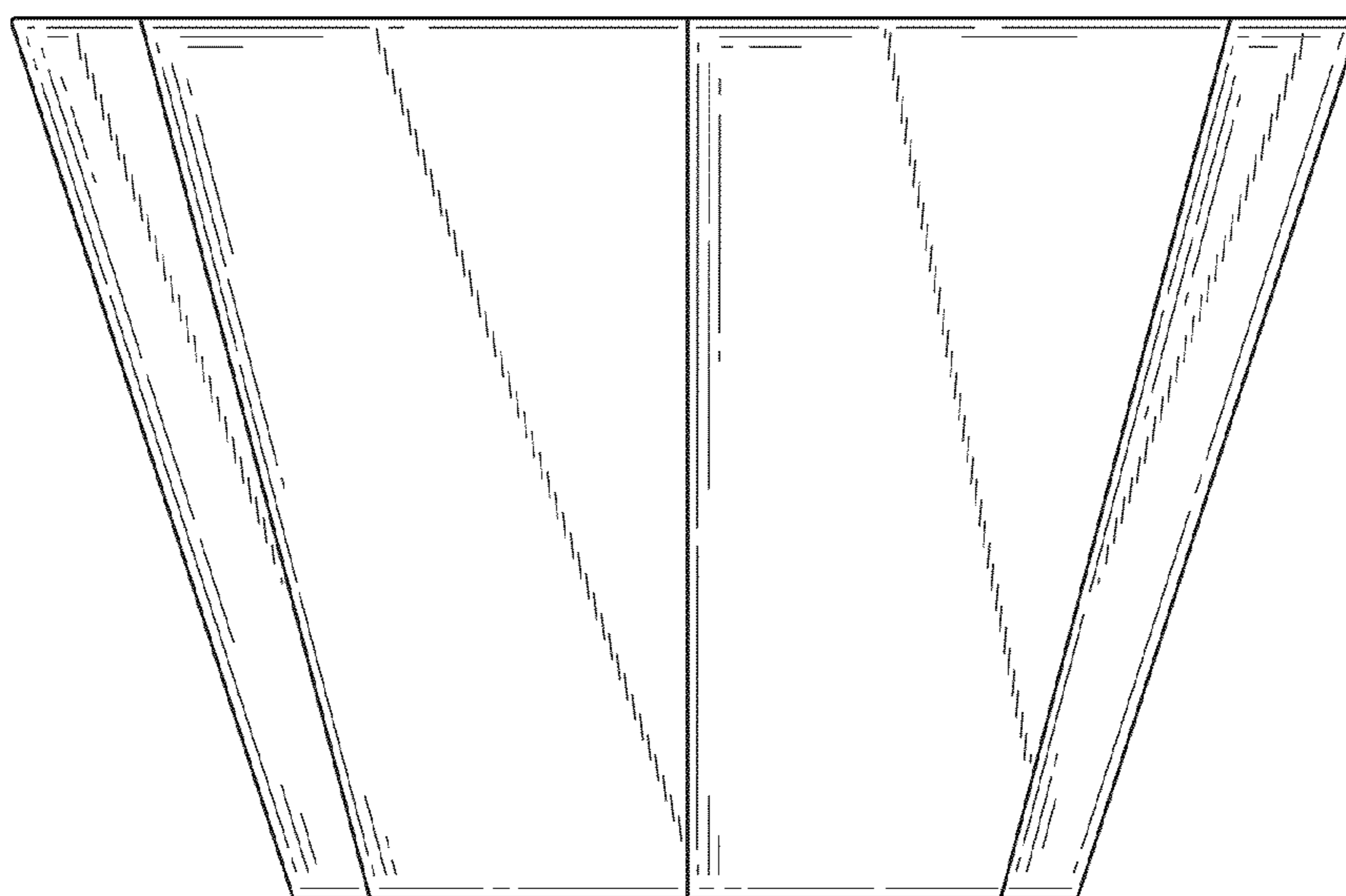

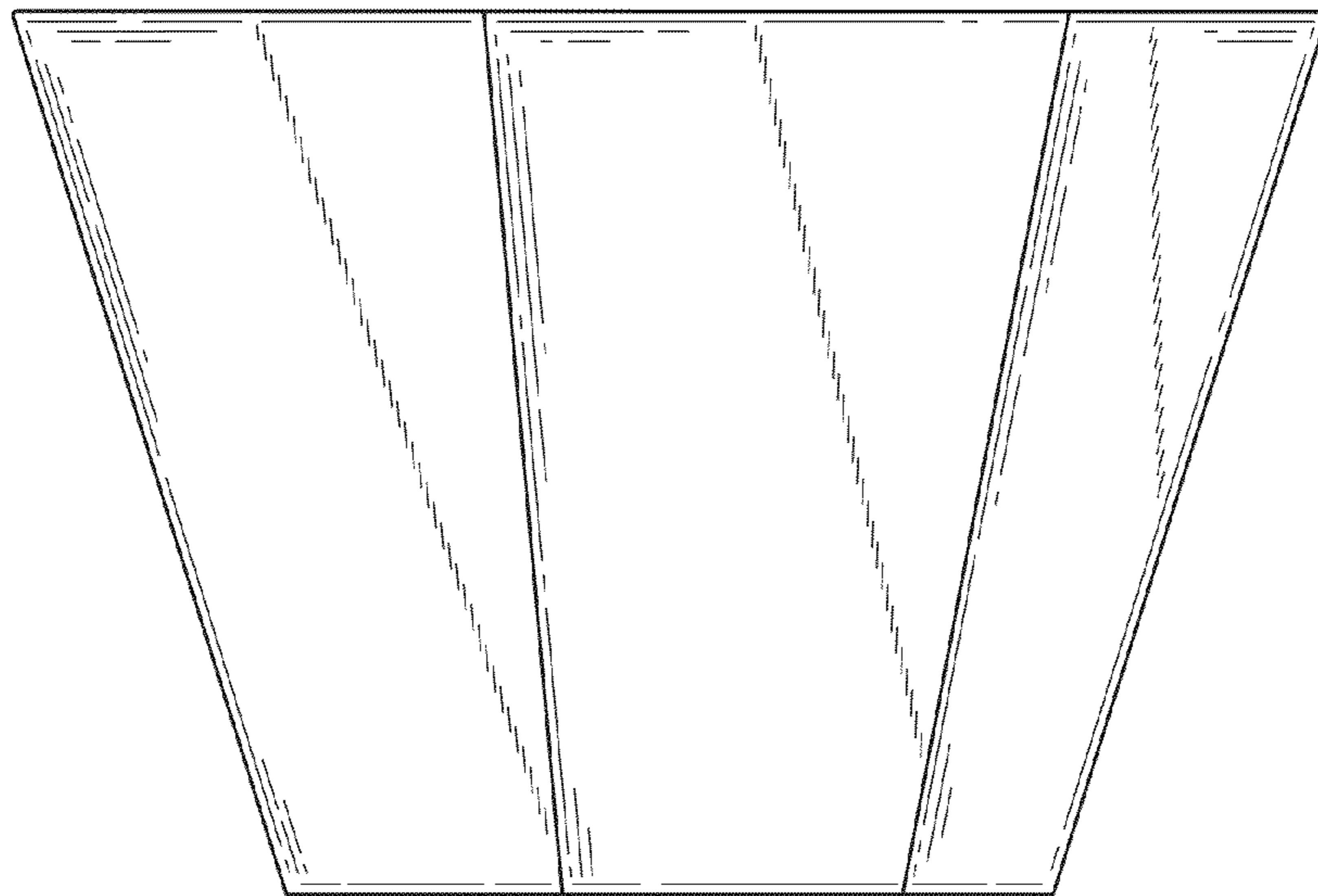

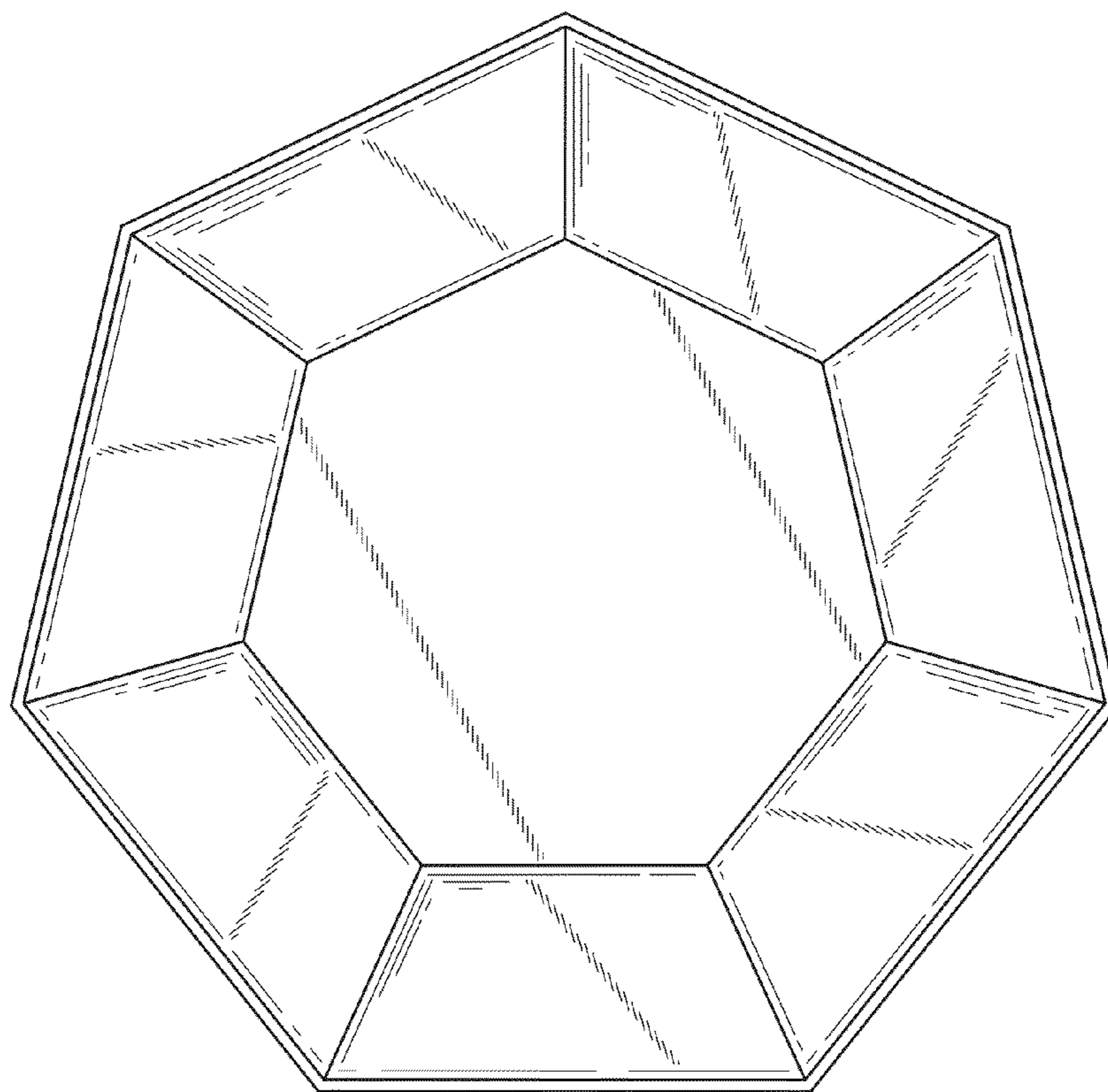

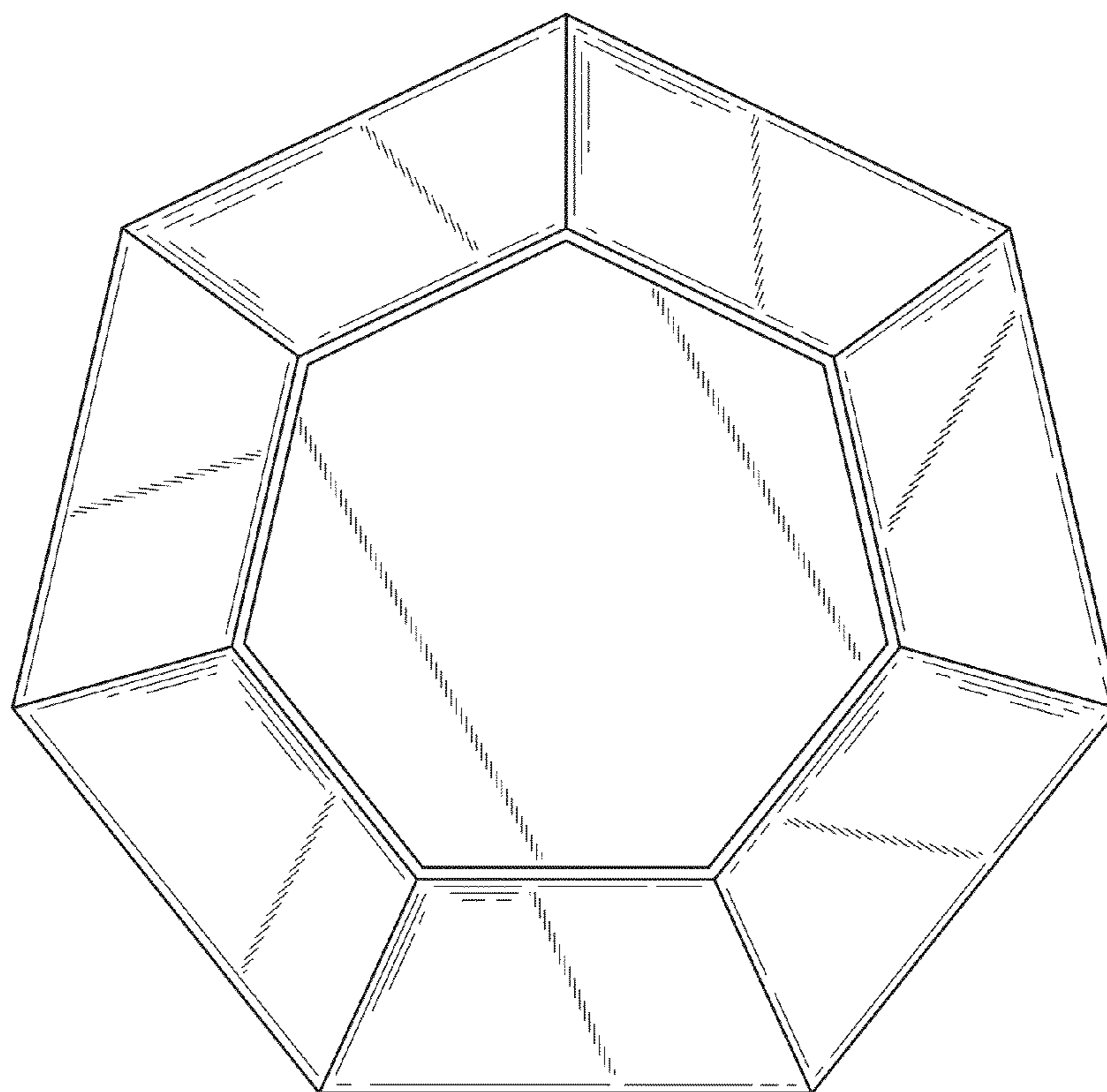

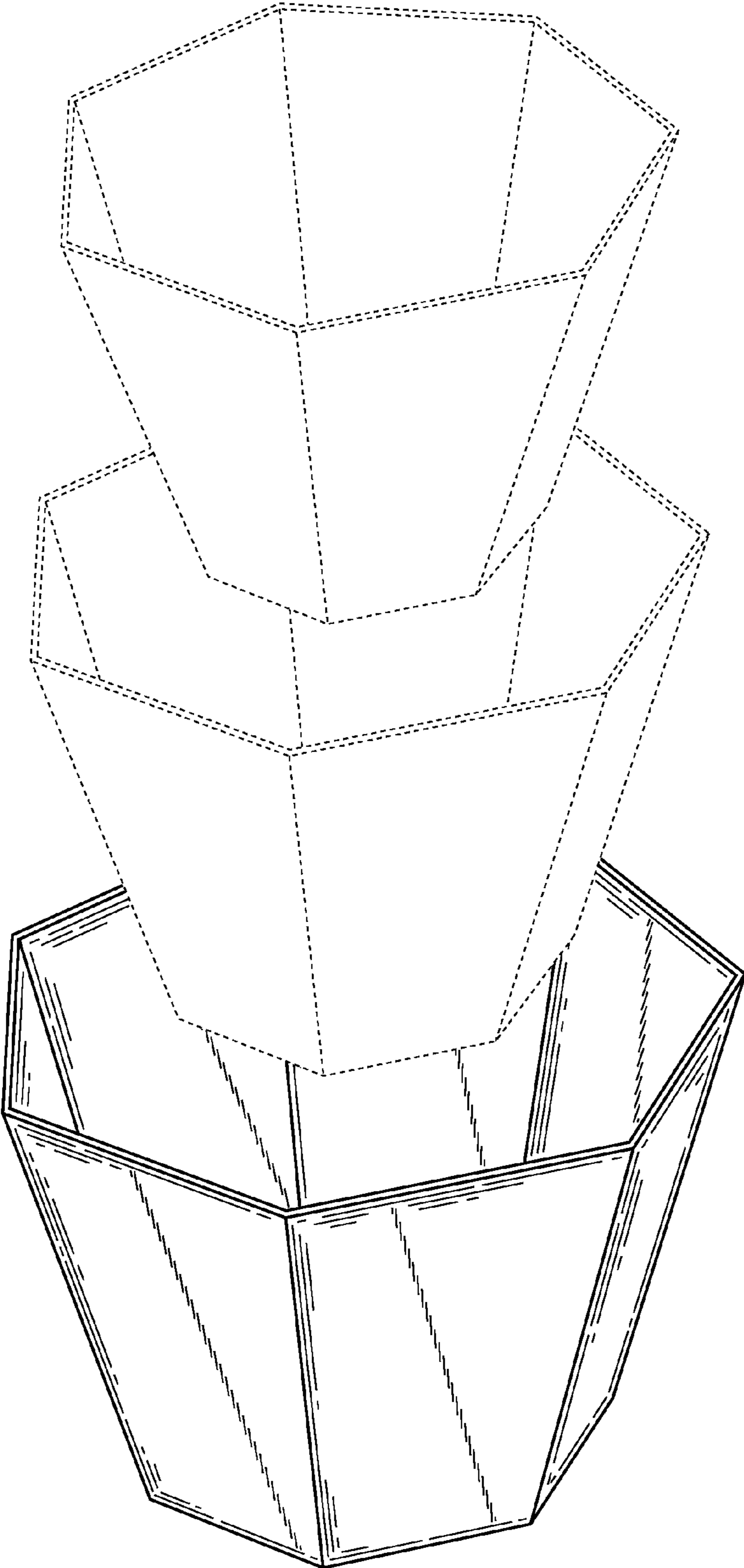

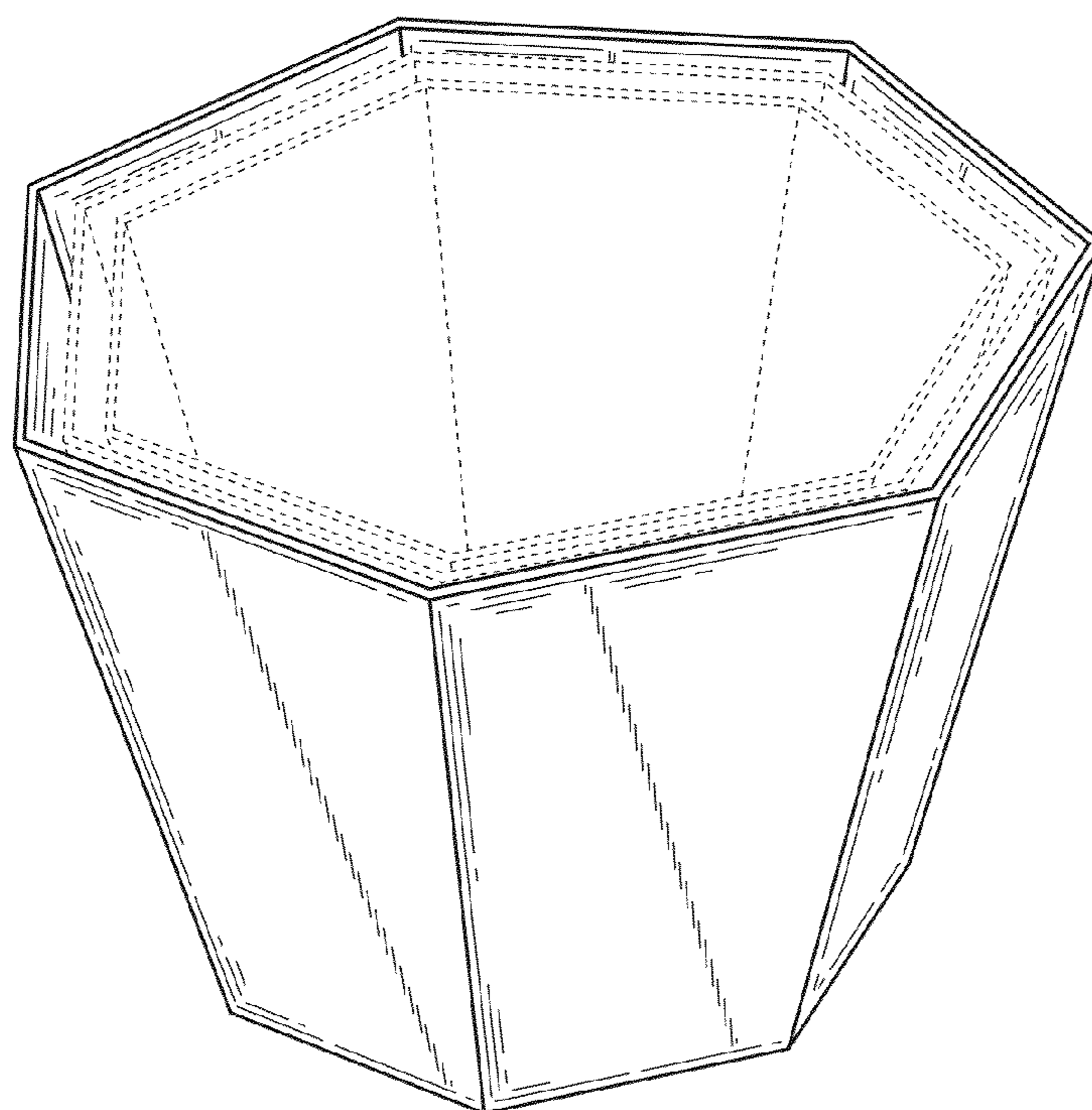

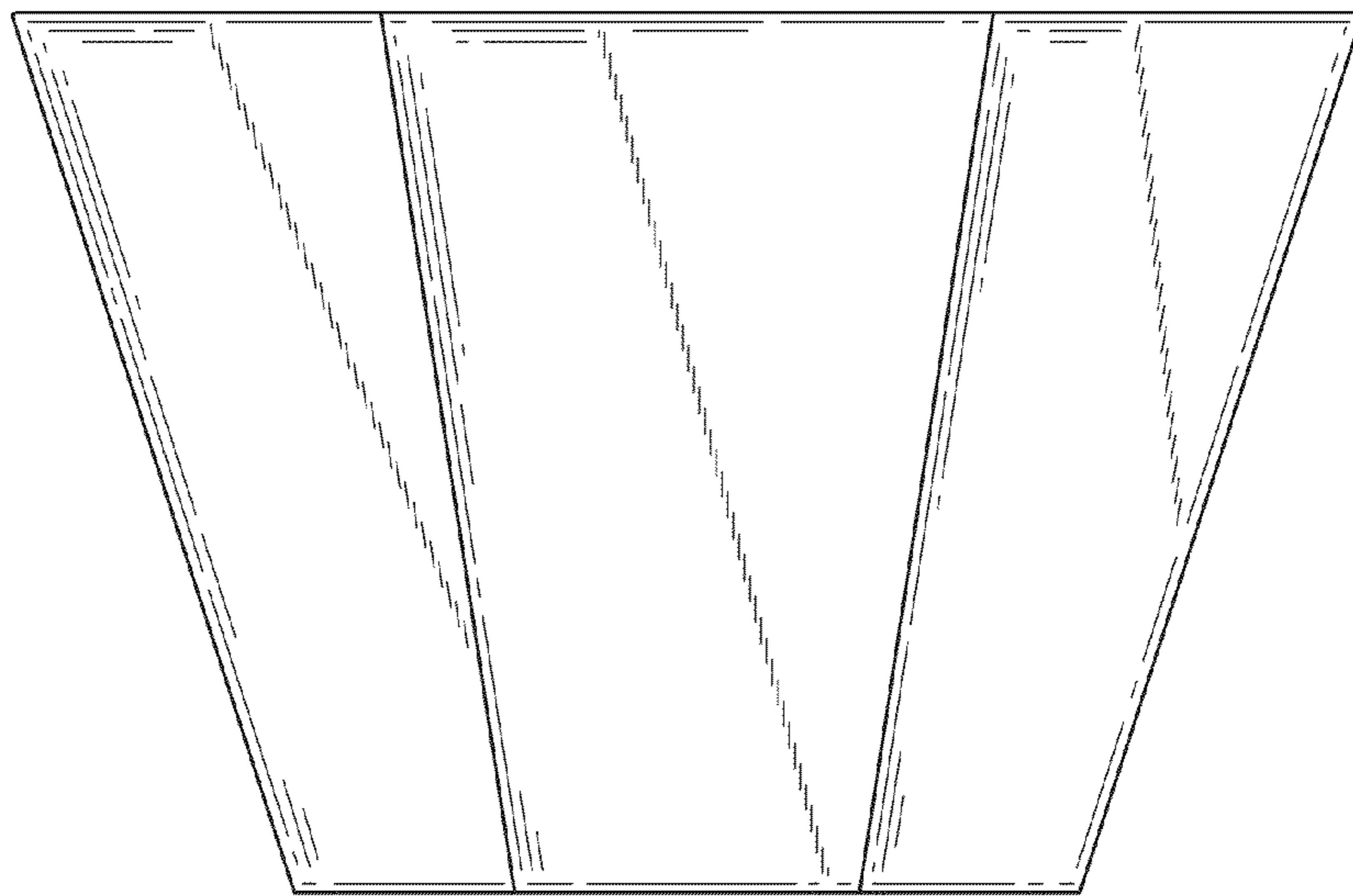

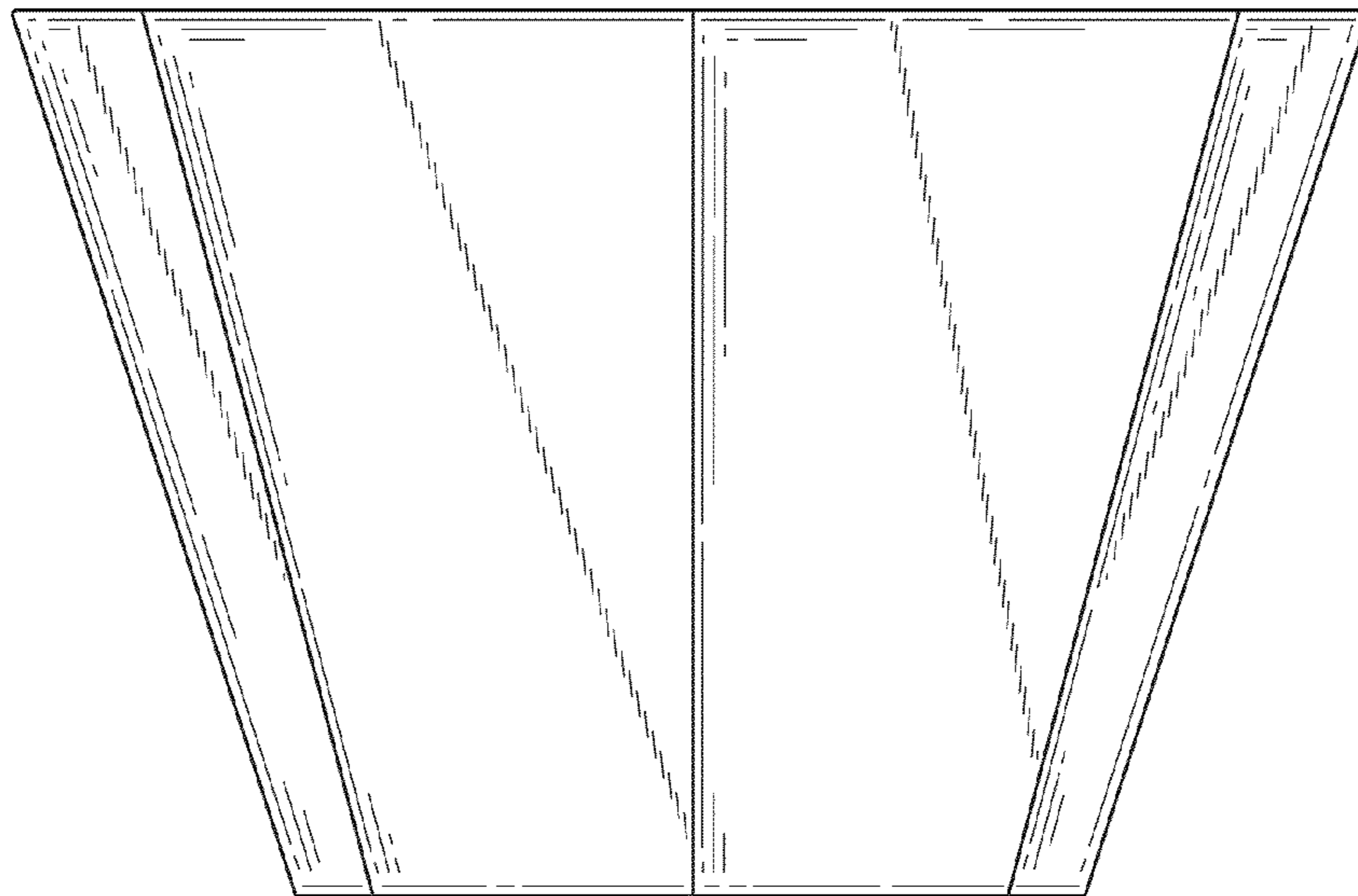

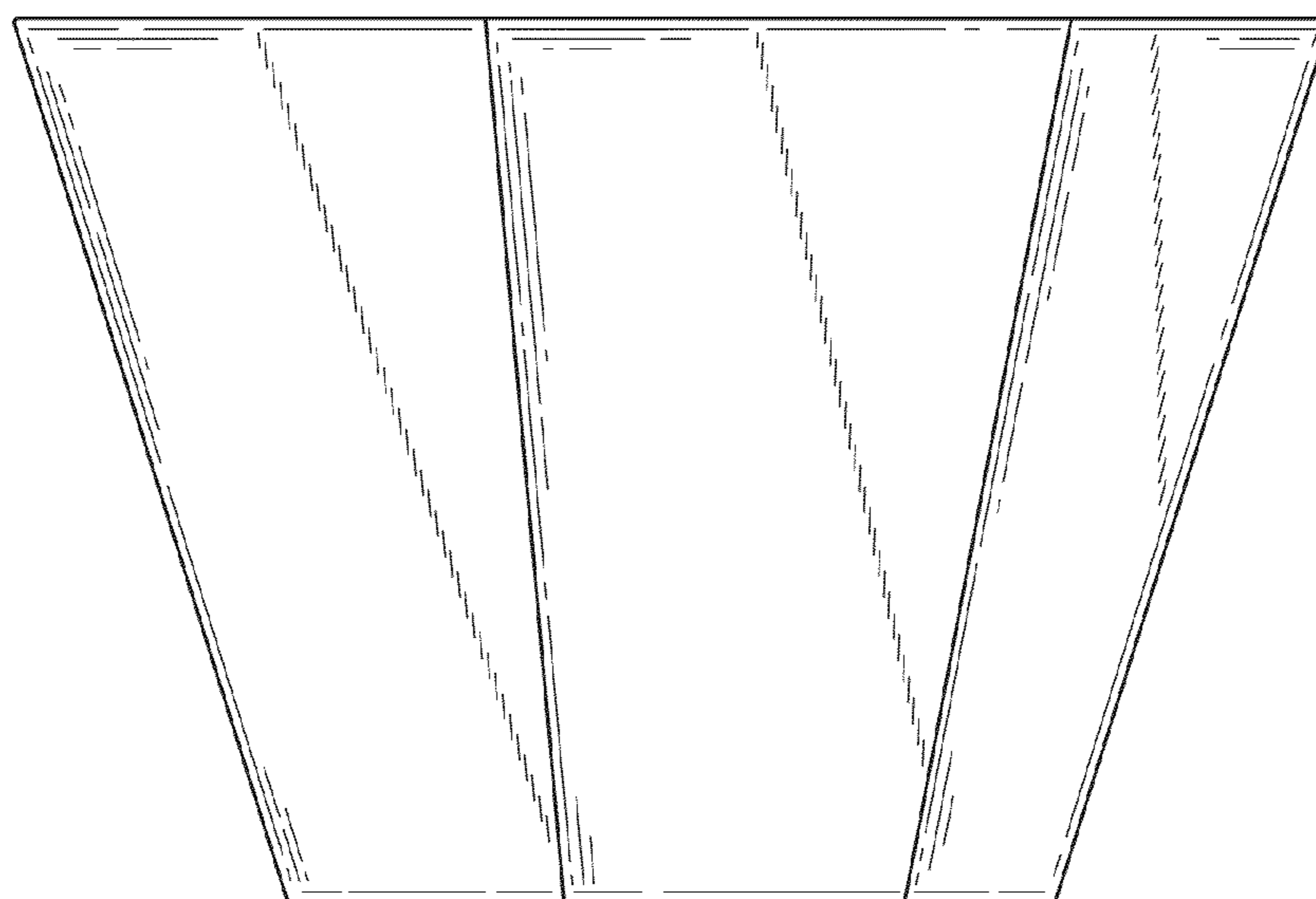

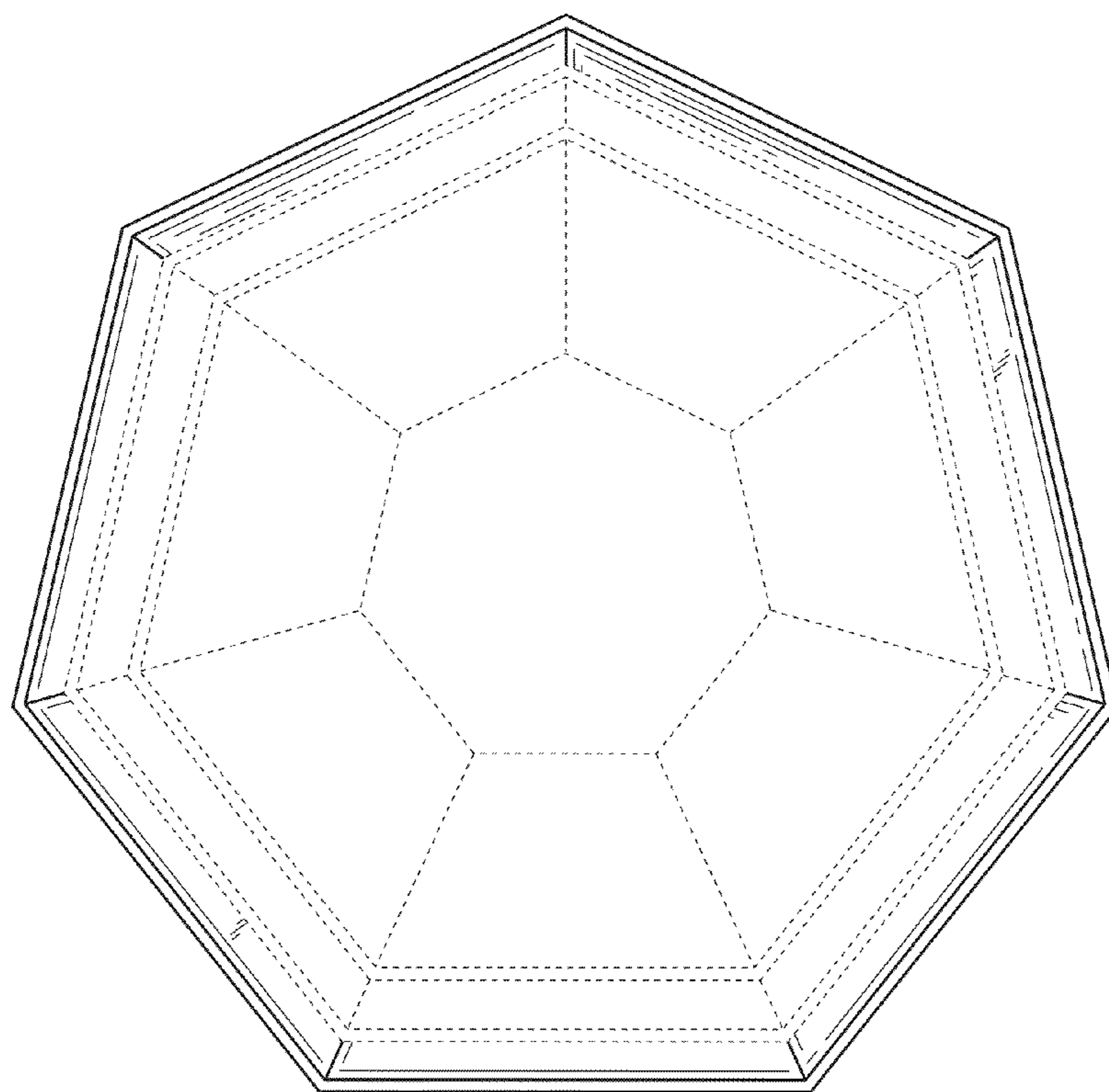

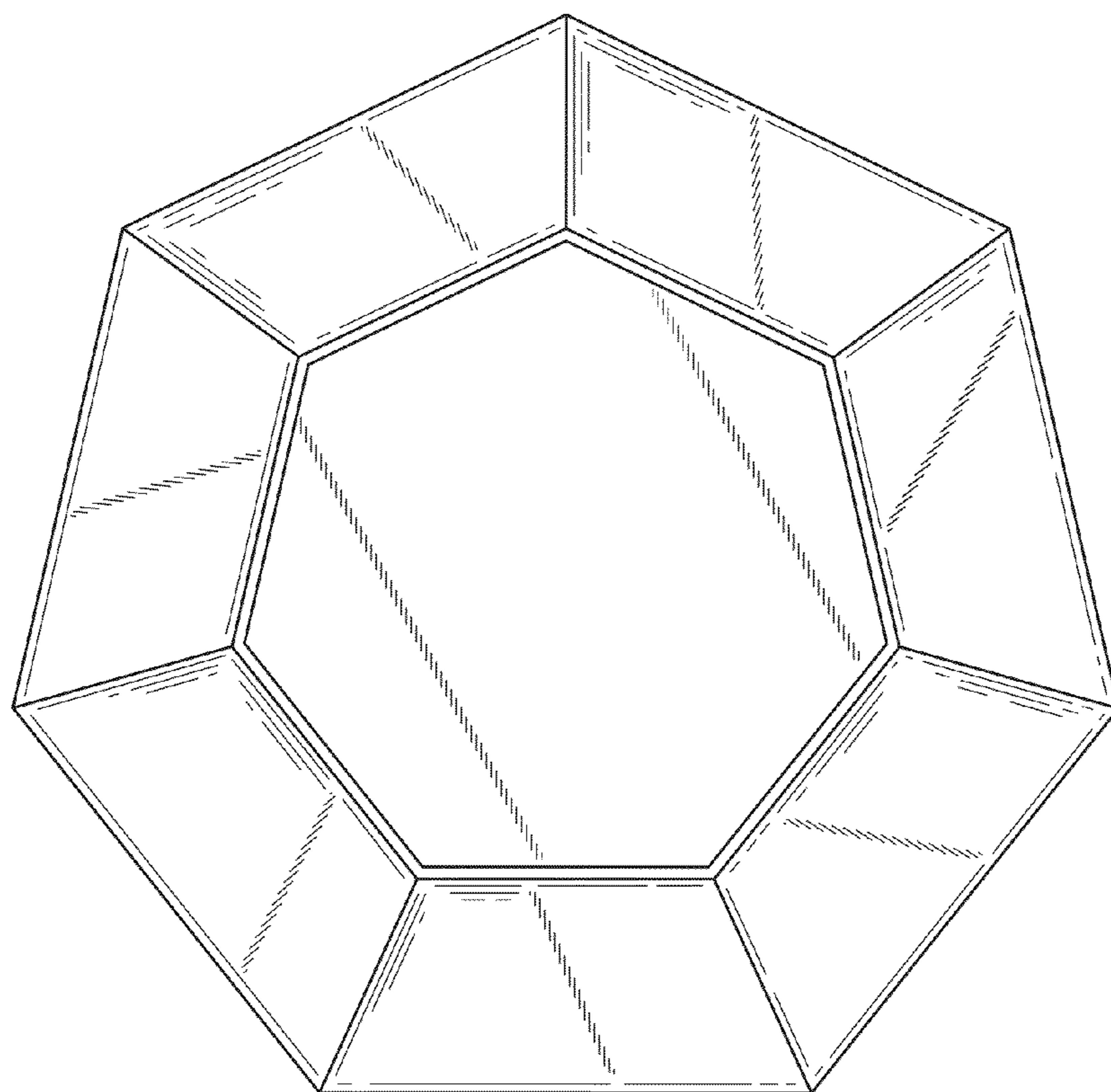
