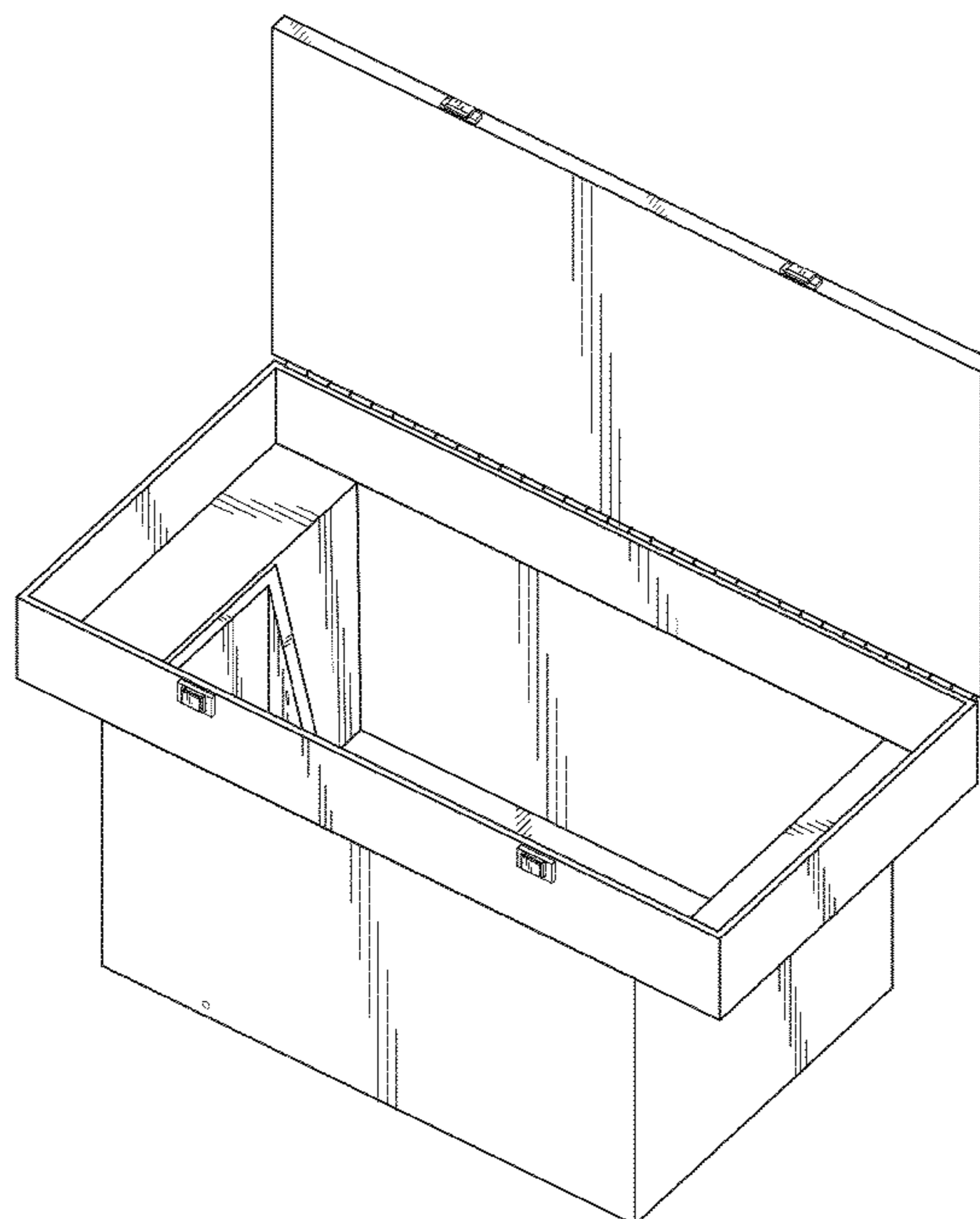
(57) **CLAIM**

The ornamental design for a combined portable chiller and dispensing unit, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a combined portable chiller and dispensing unit;  
FIG. 2 is a front view thereof;

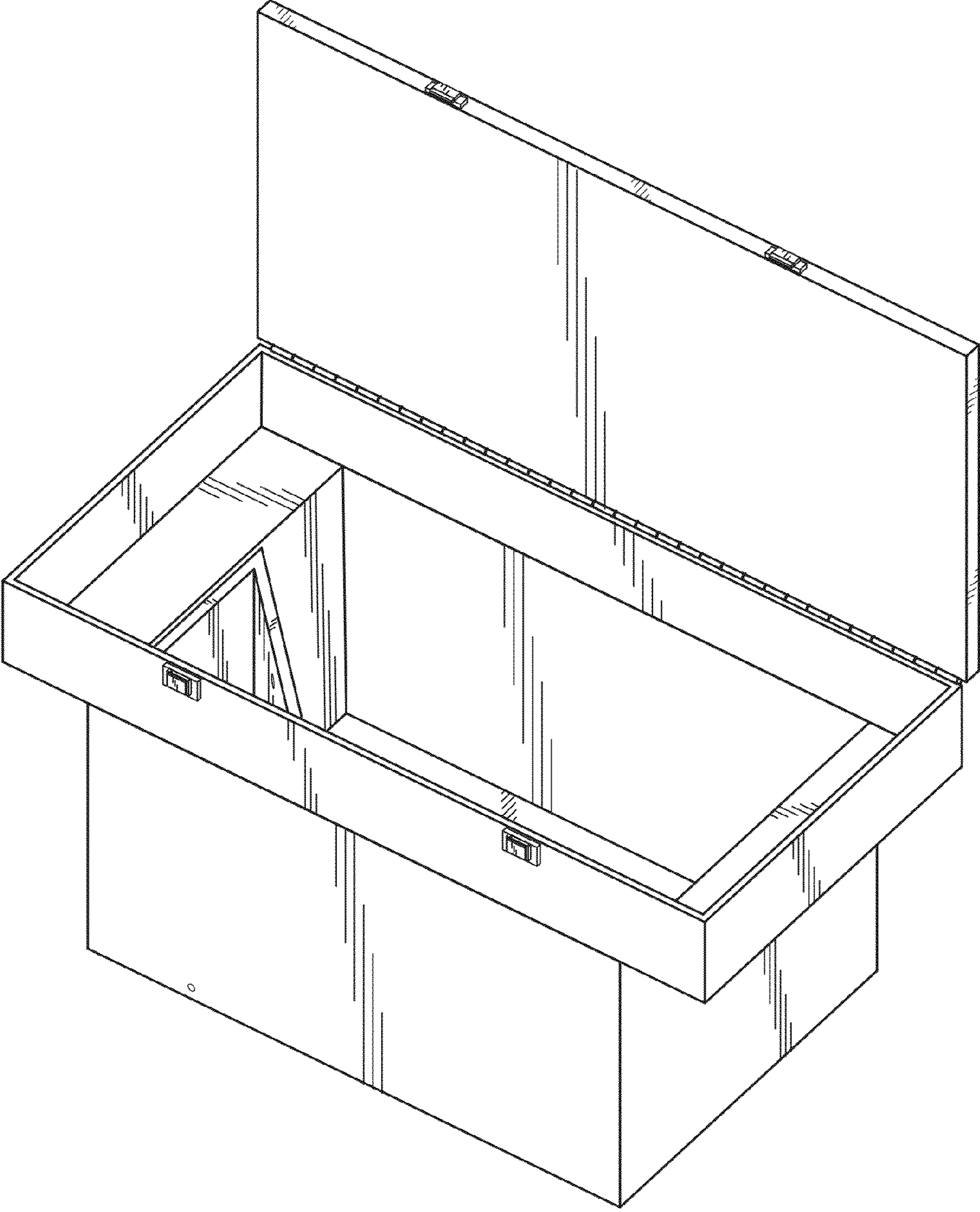

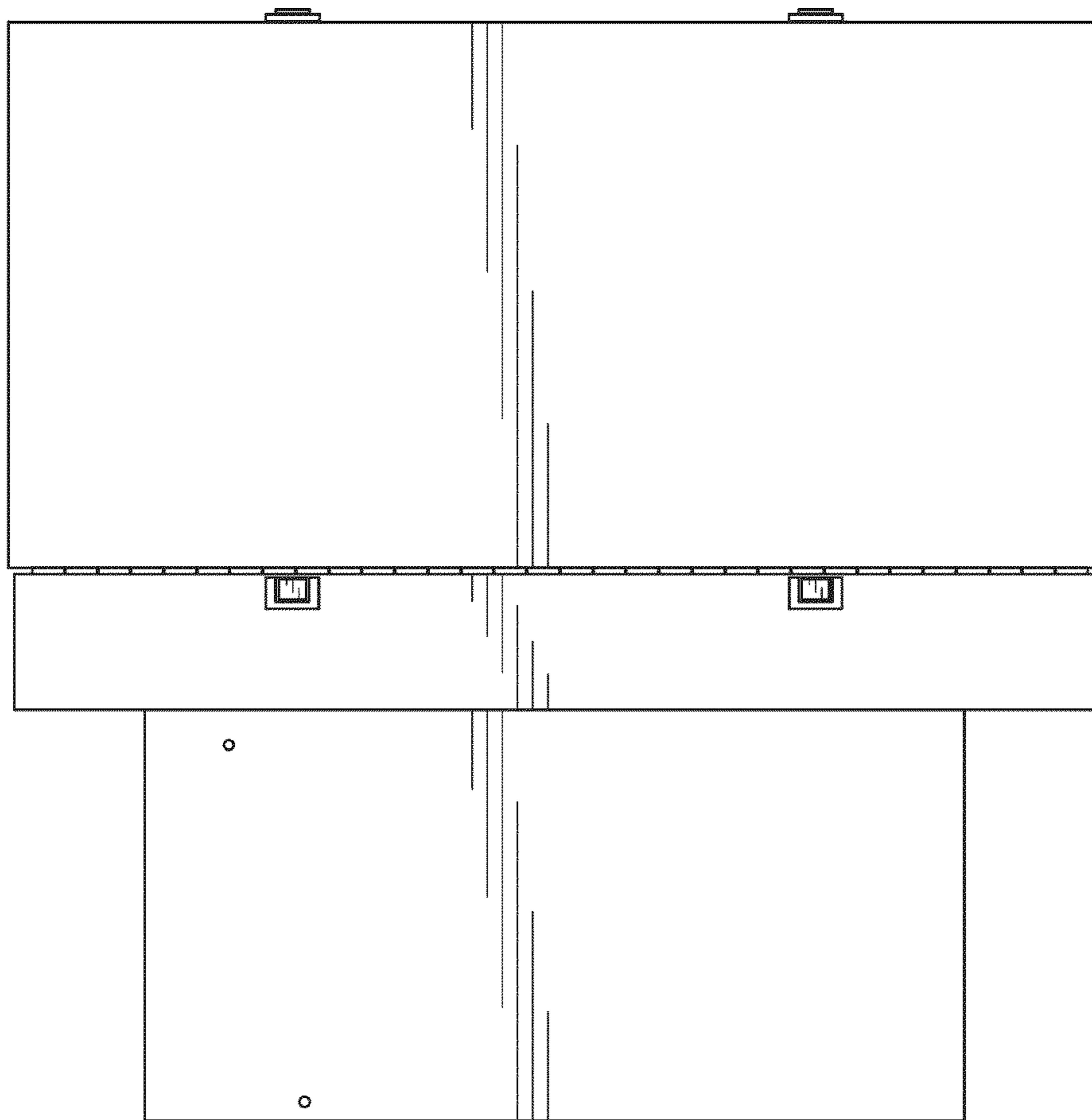

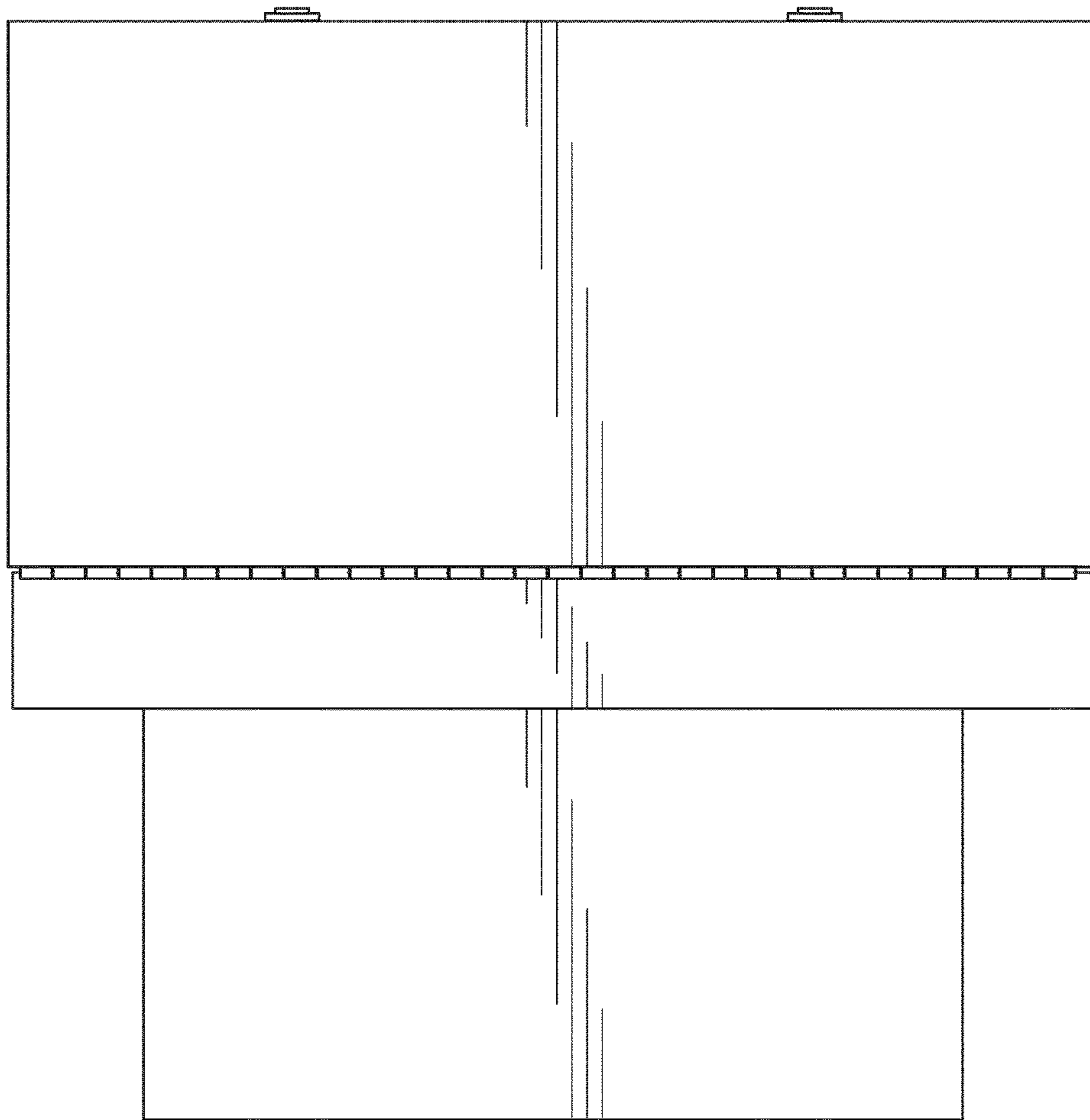

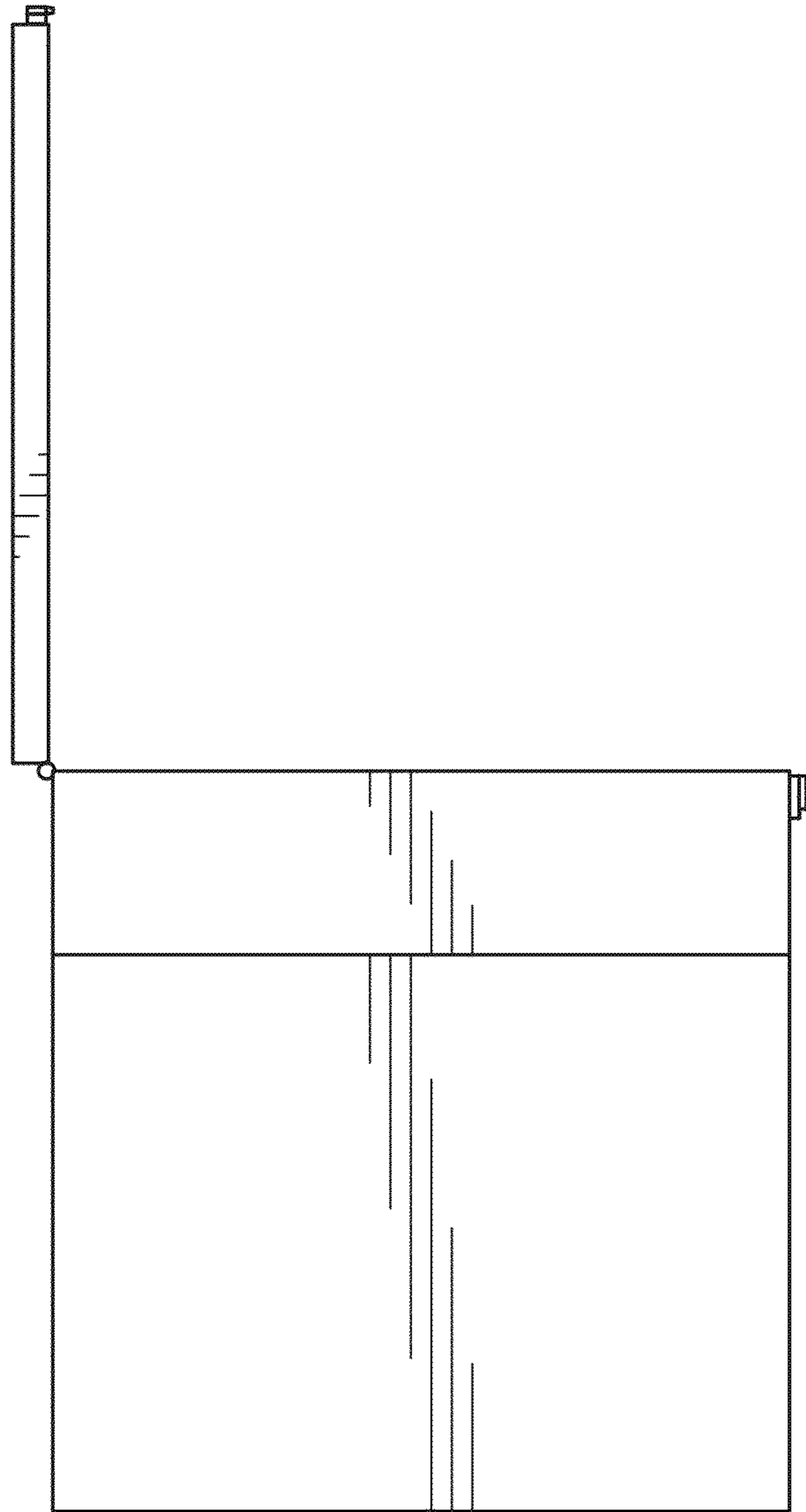

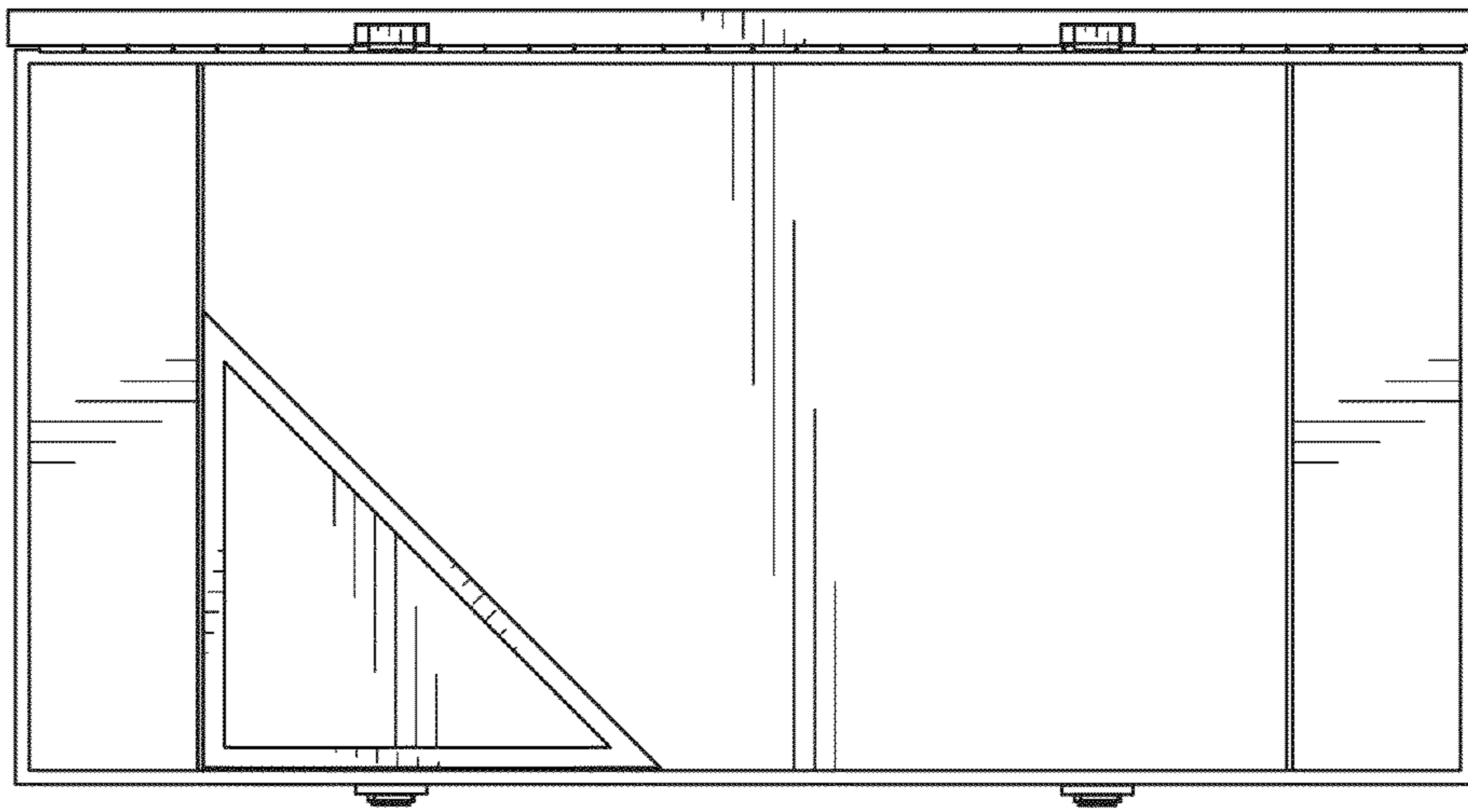

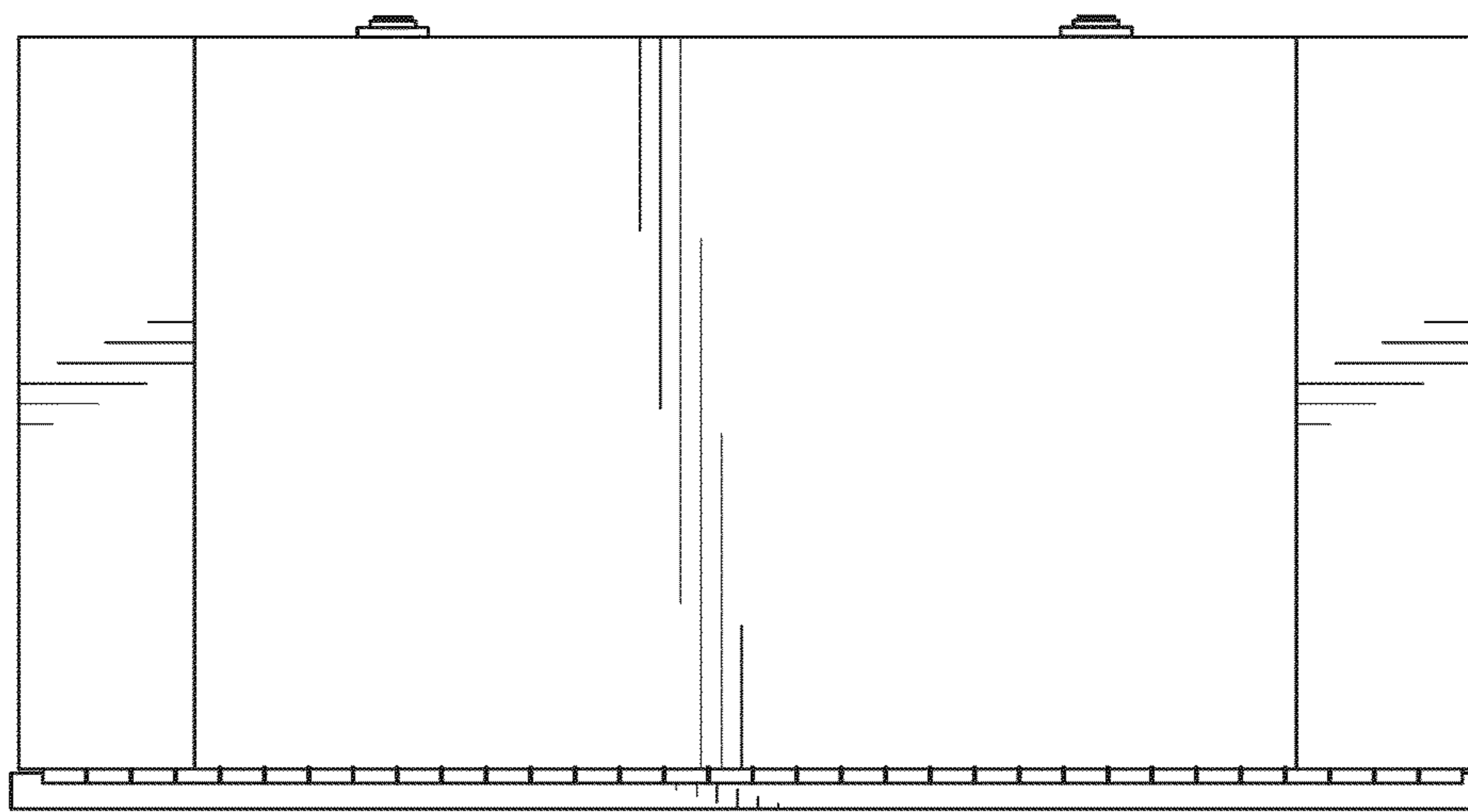
