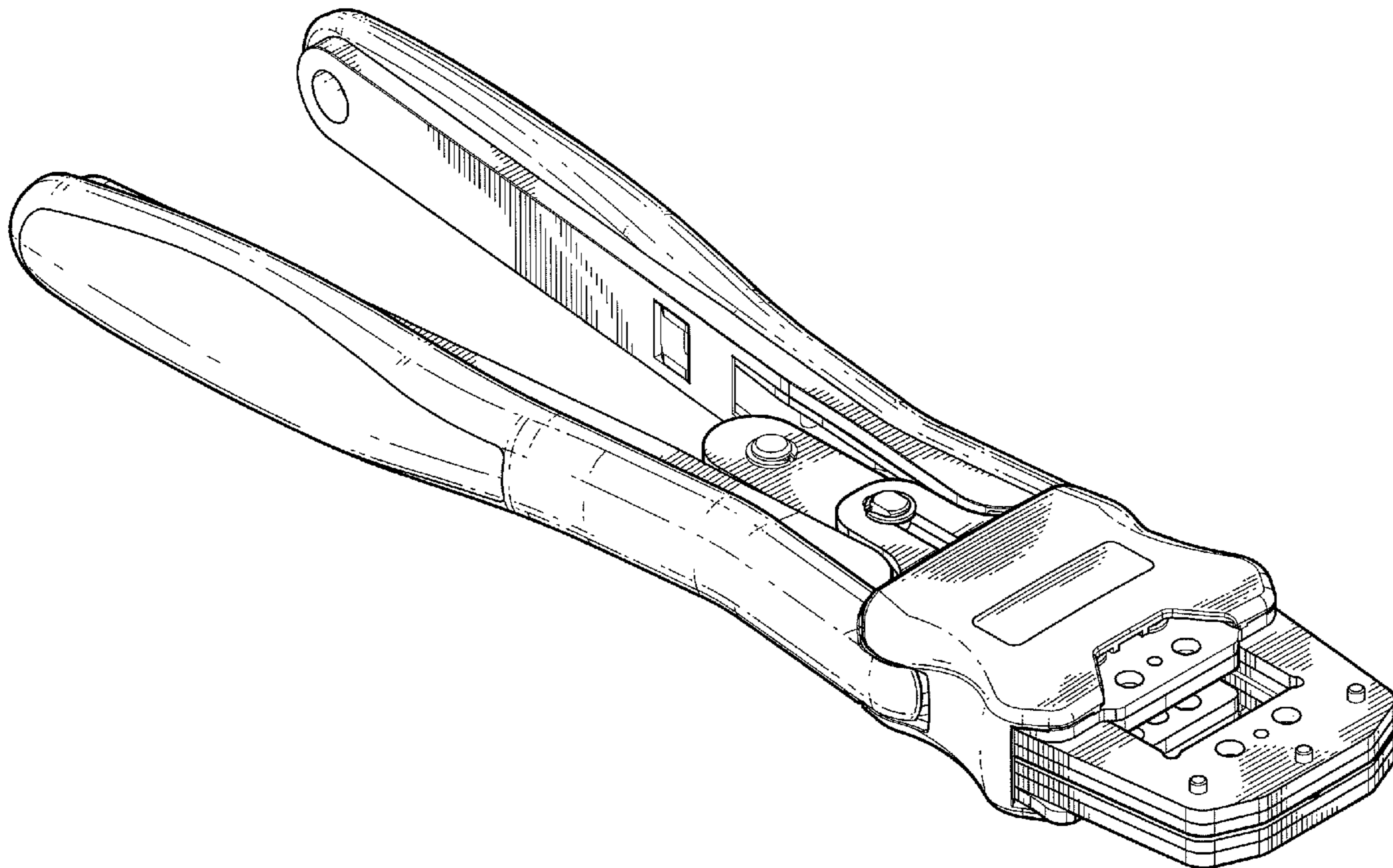
(57) **CLAIM**

The ornamental design for a hand operated crimping tool, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, and top perspective view of a hand operated crimping tool, showing the new design;

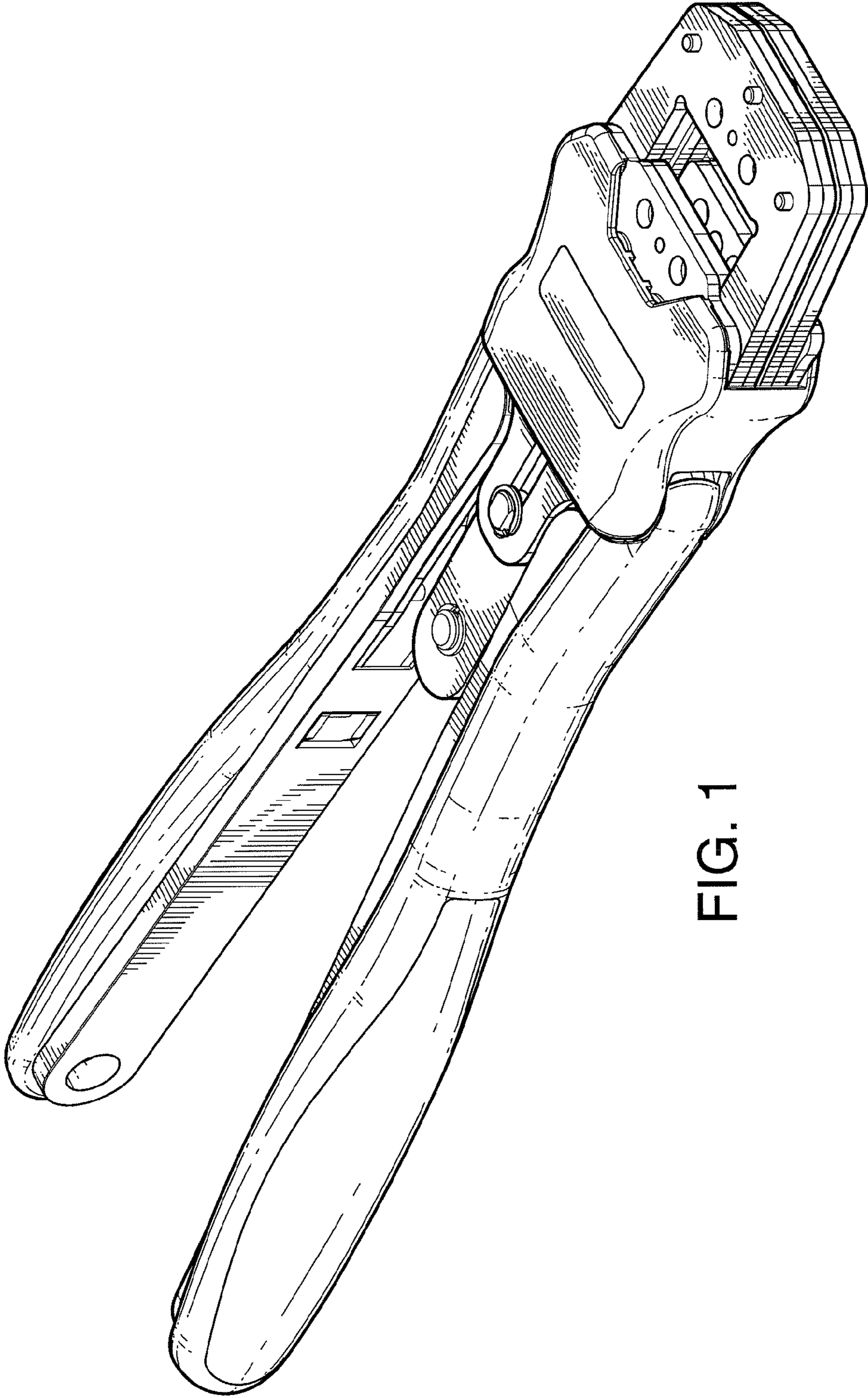

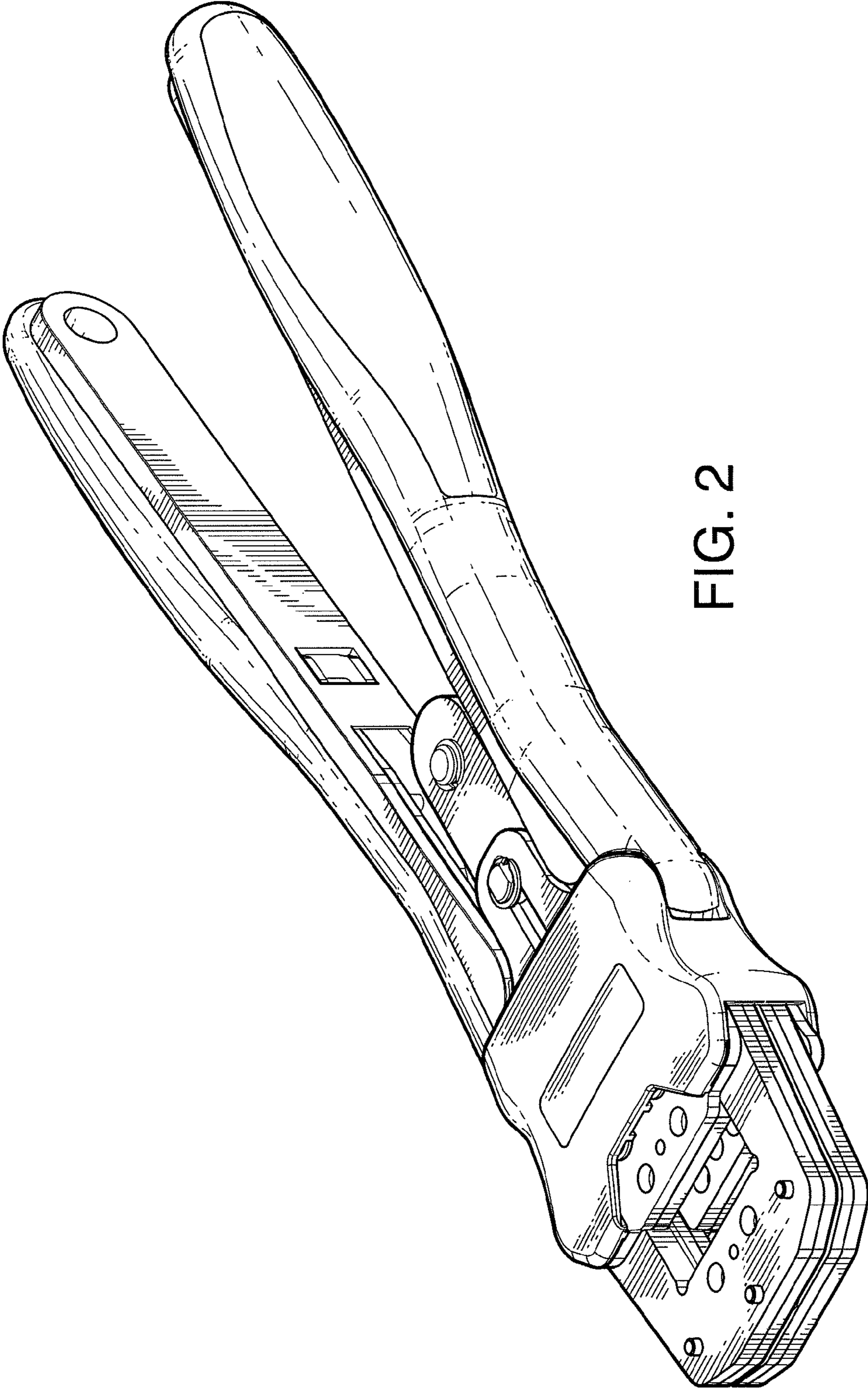

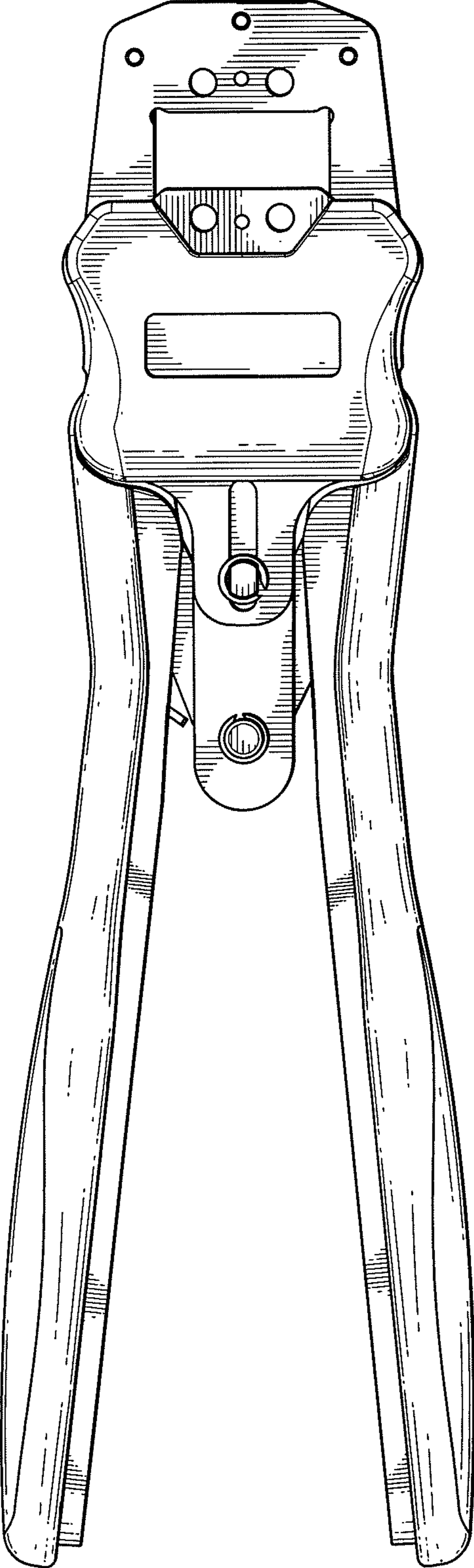

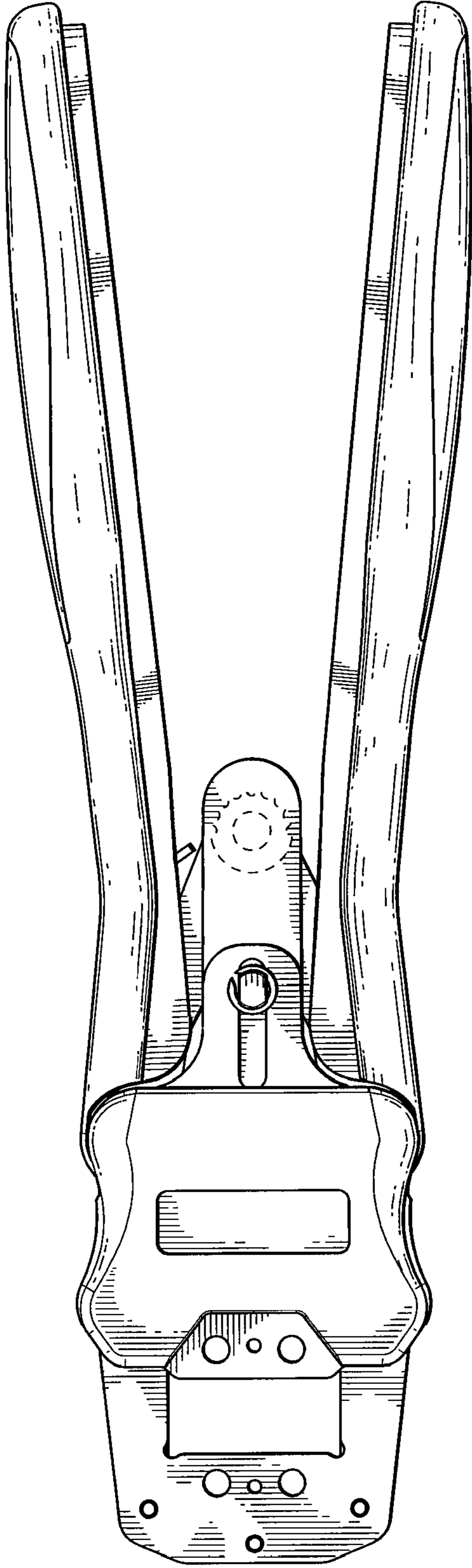

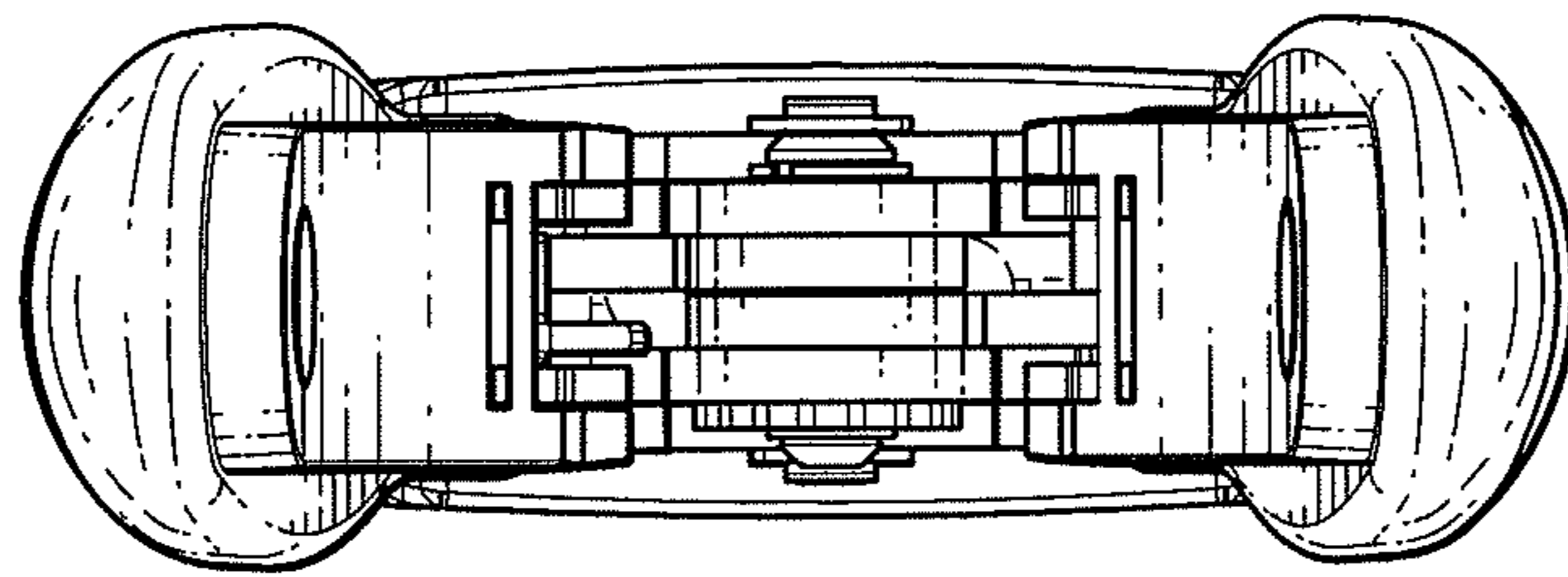

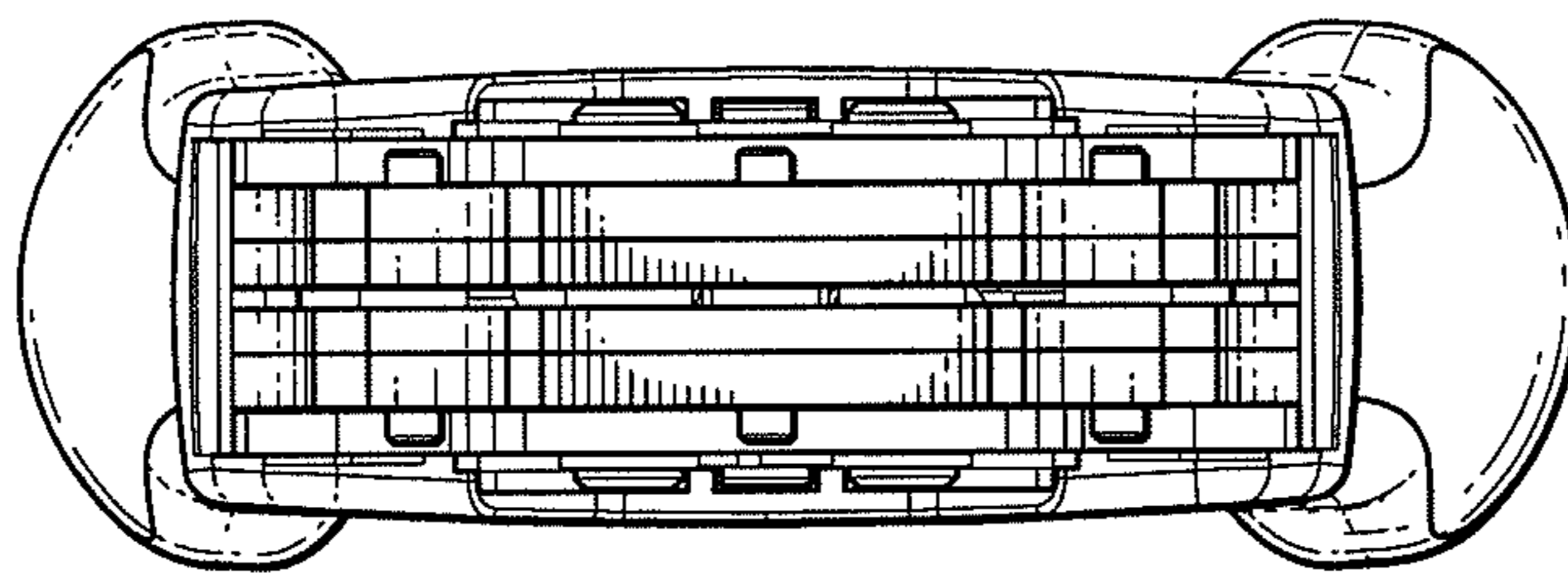

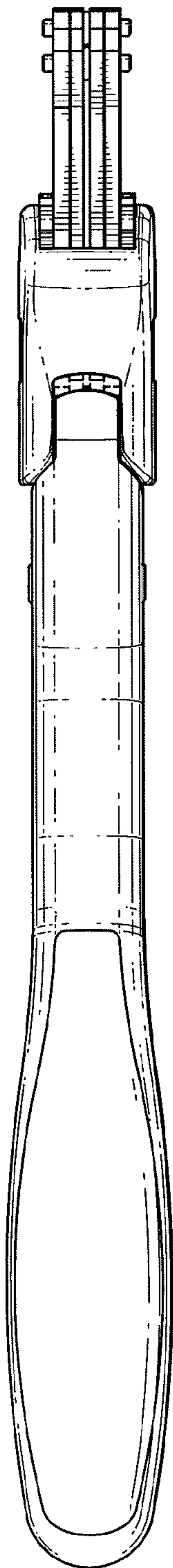

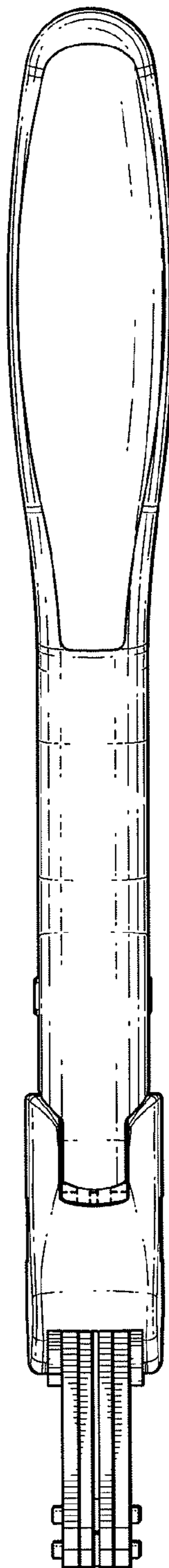

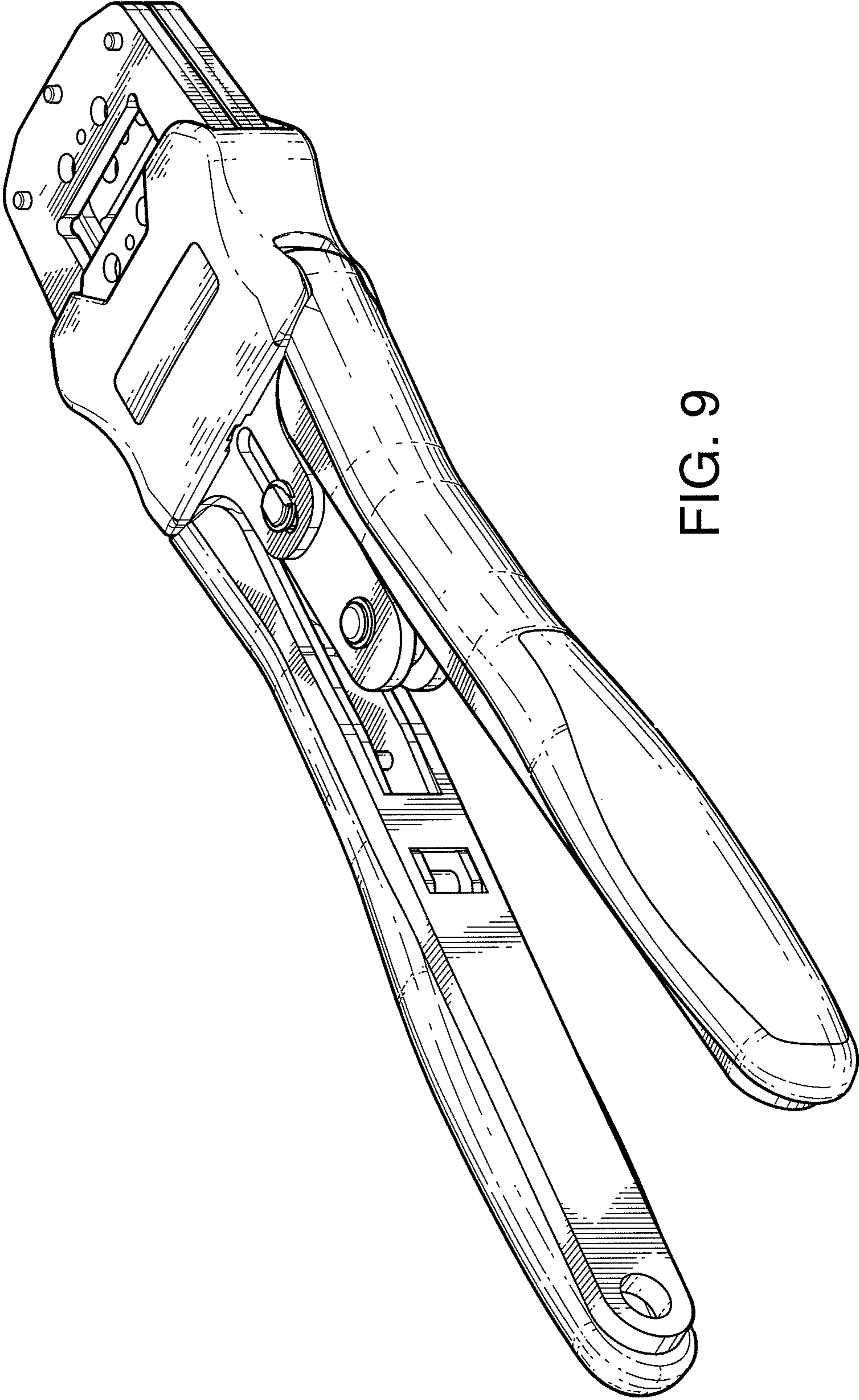

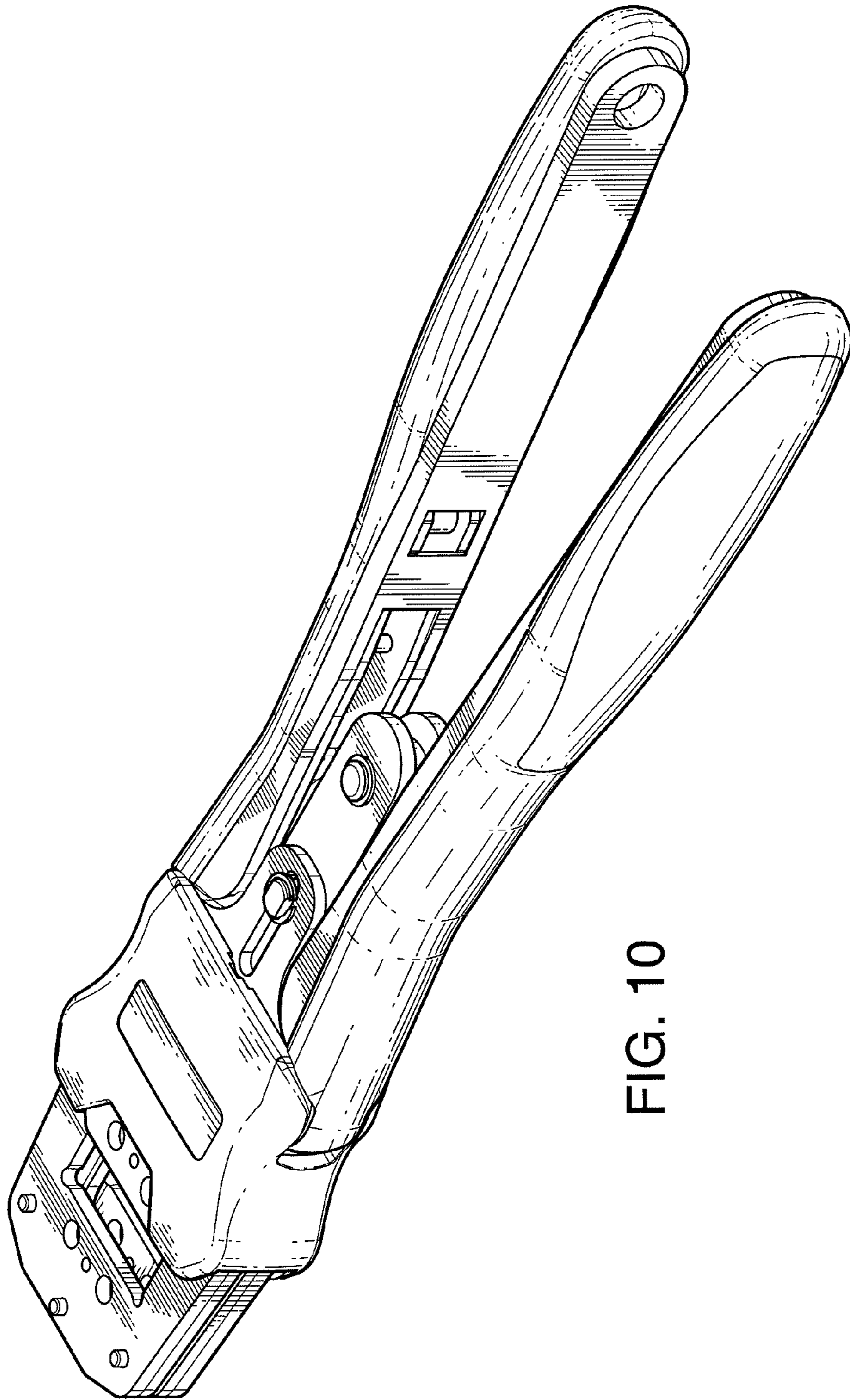

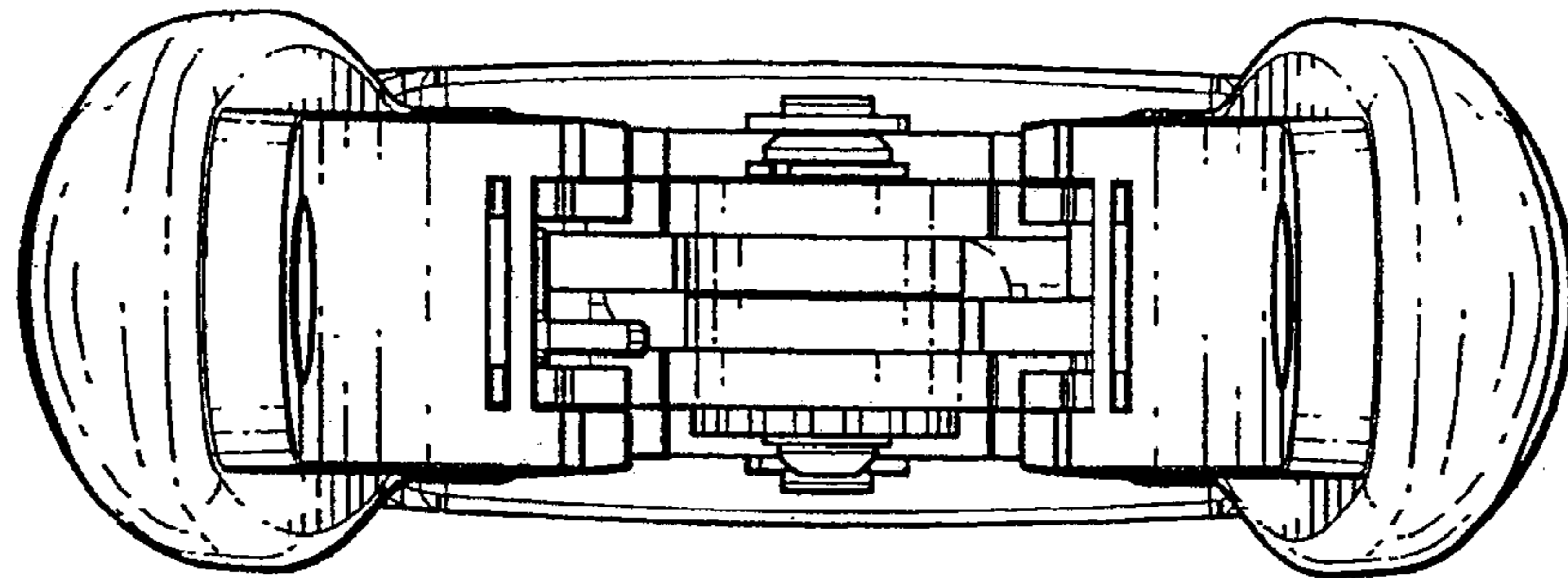

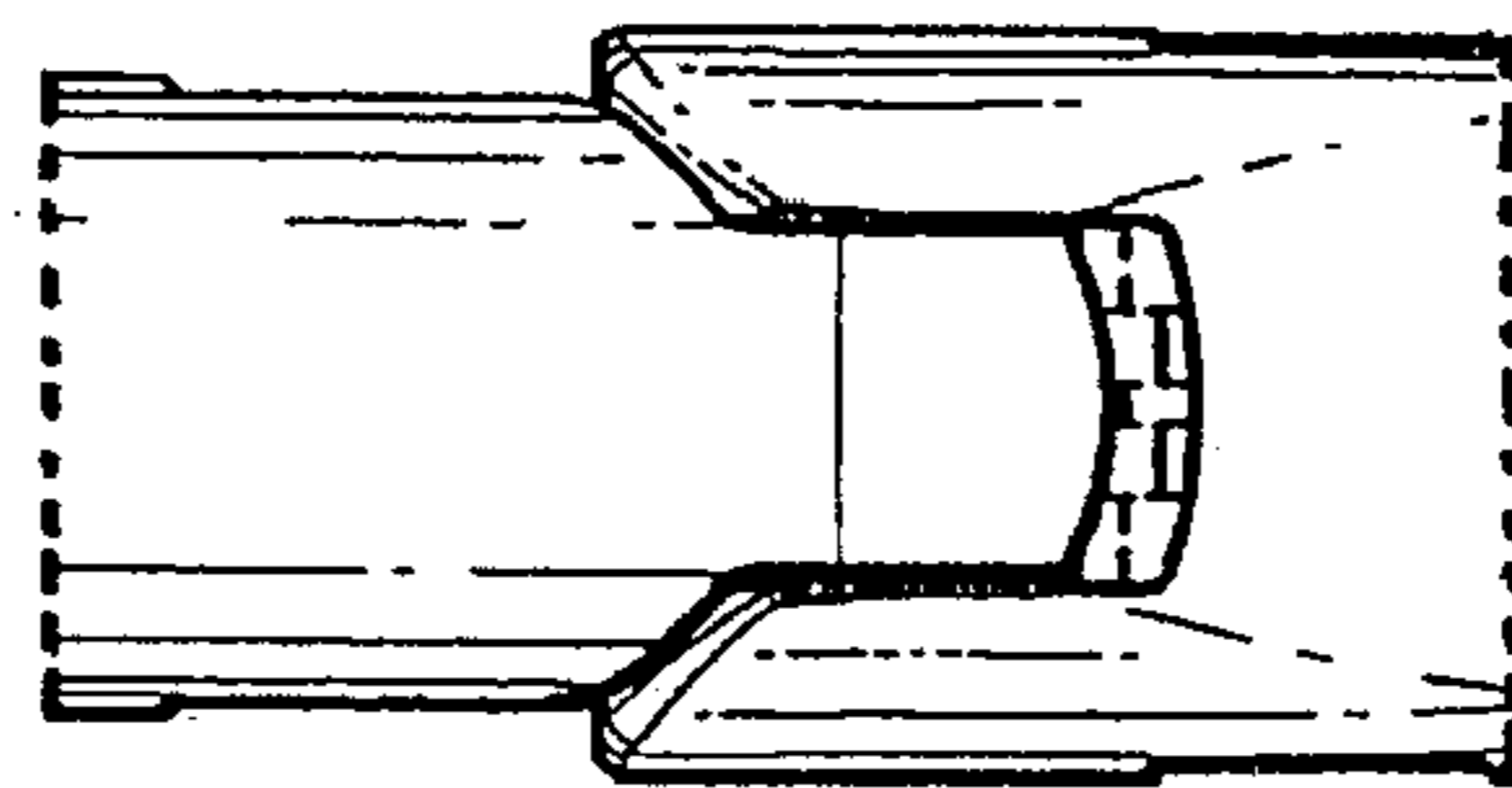

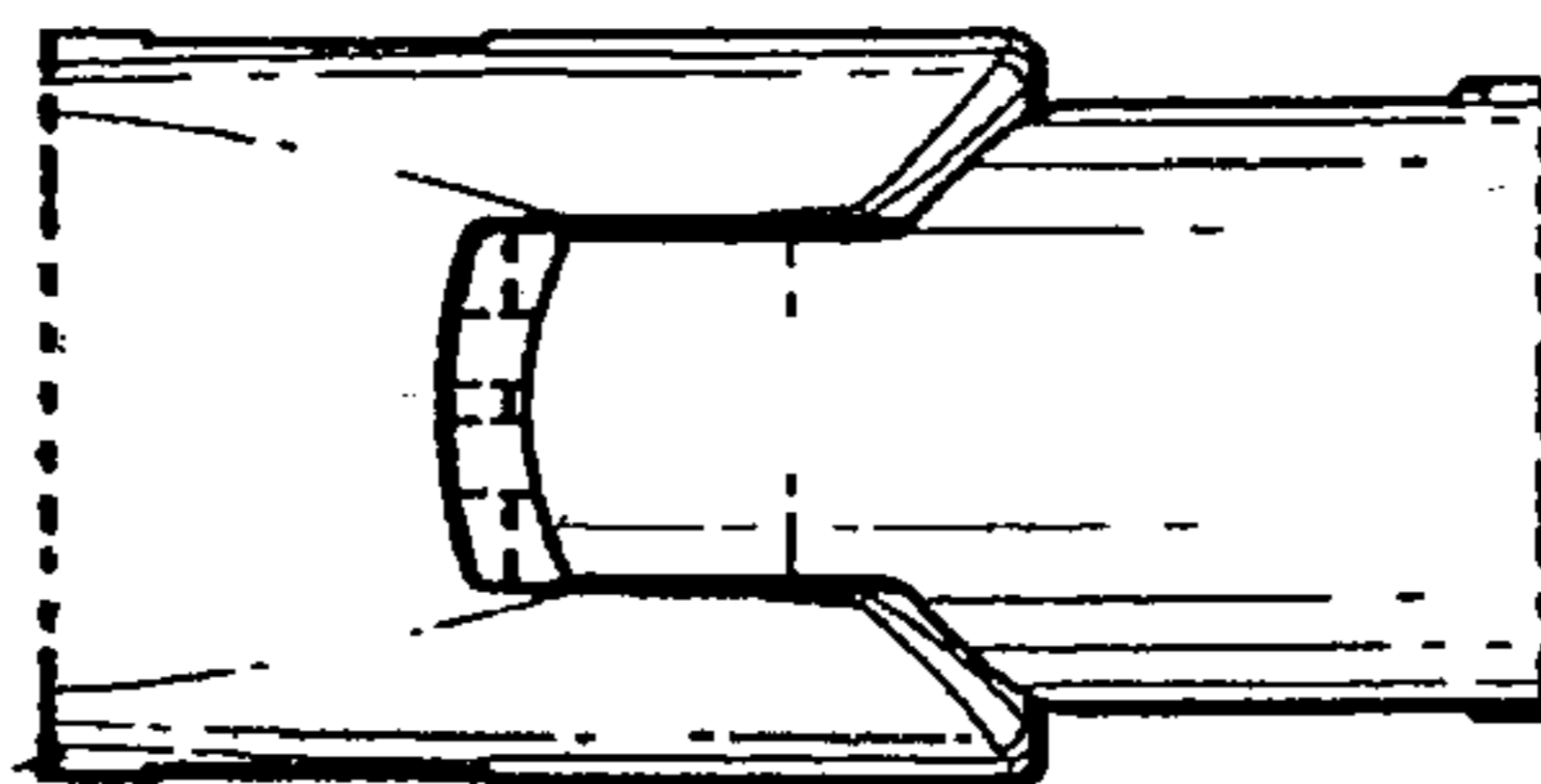
