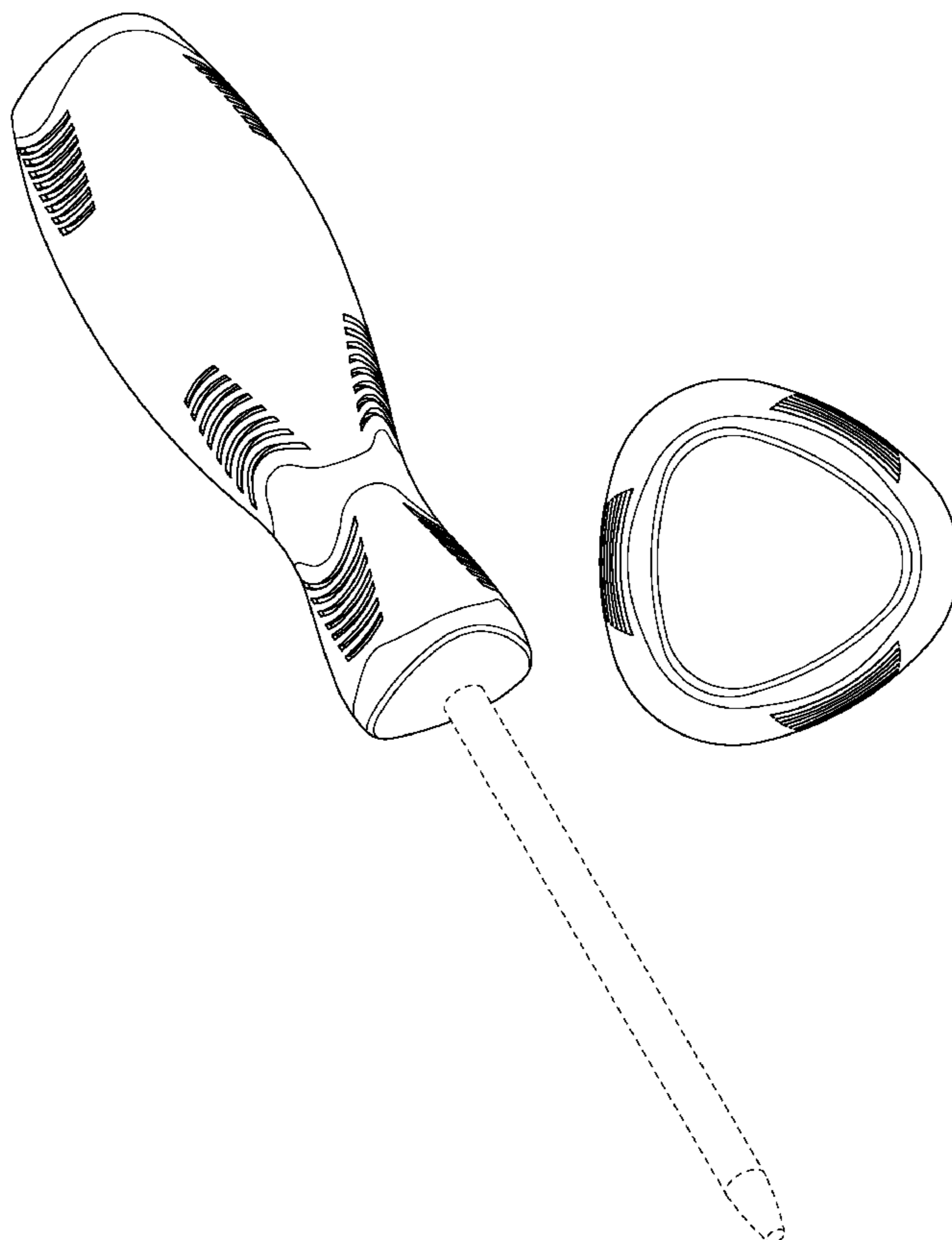
(57) **CLAIM**

The ornamental design for a tool handle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a tool handle embodying our design; FIG. 2 is a rear perspective view of the tool handle of FIG. 1; FIG. 3 is a first side view of the tool handle of FIG. 1; FIG. 4 is a second side view of the tool handle of FIG. 1; FIG. 5 is a third side view of the tool handle of FIG. 1; FIG. 6 is front view of the tool handle of FIG. 1; and, FIG. 7 is a rear view of the tool handle of FIG. 1. The broken lines shown in the drawings are for illustrative purposes only of an environment and form no part of the claimed design.

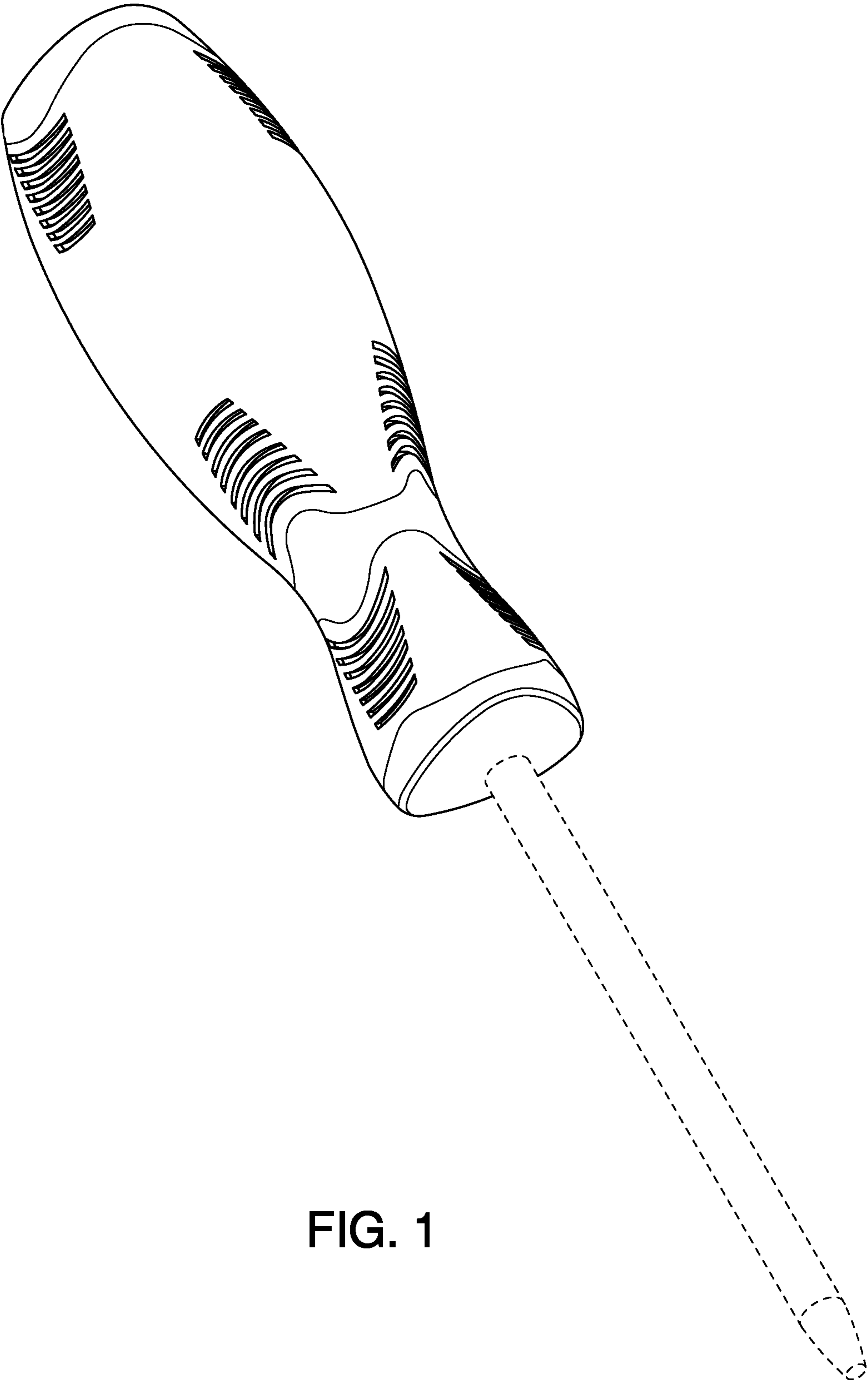

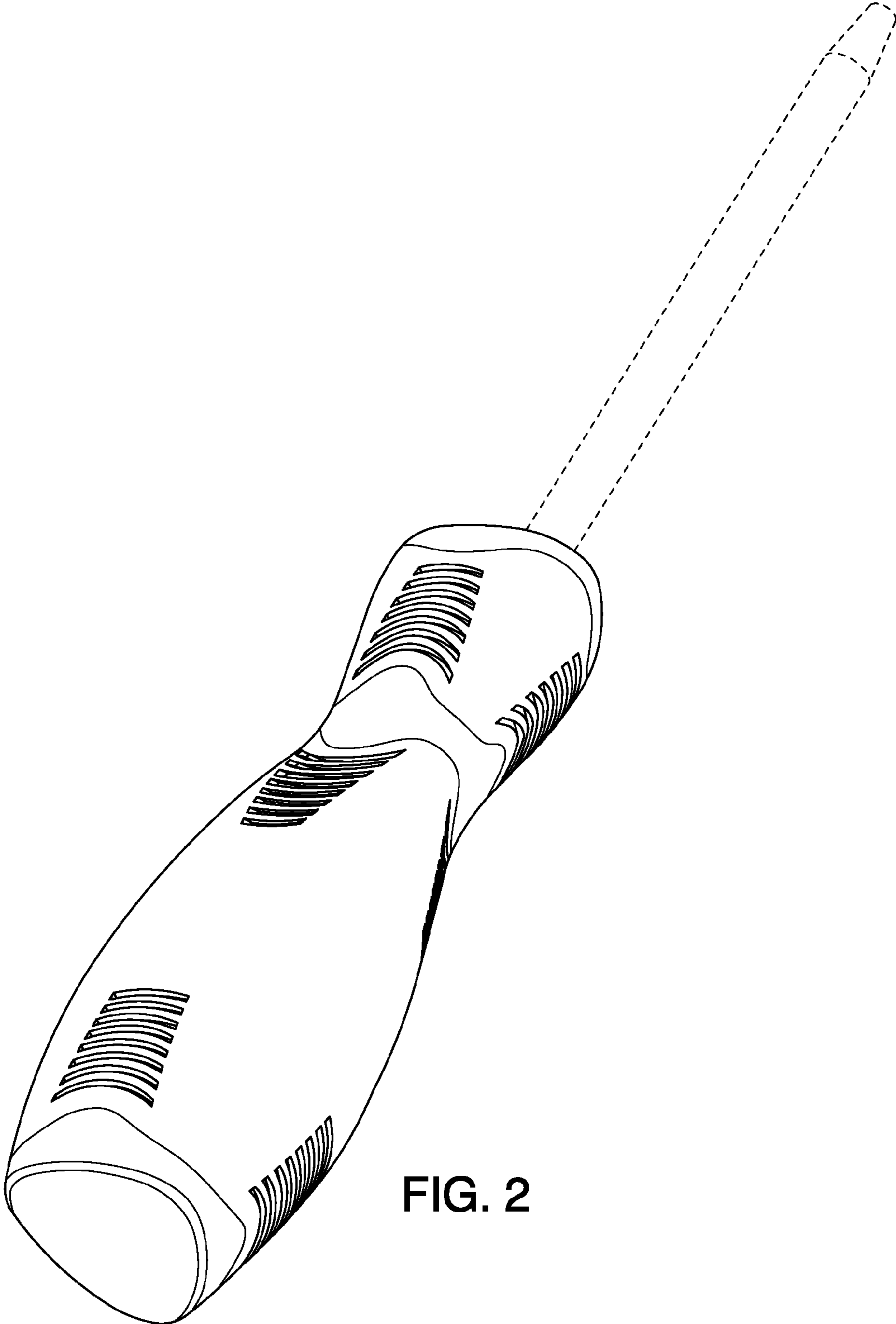

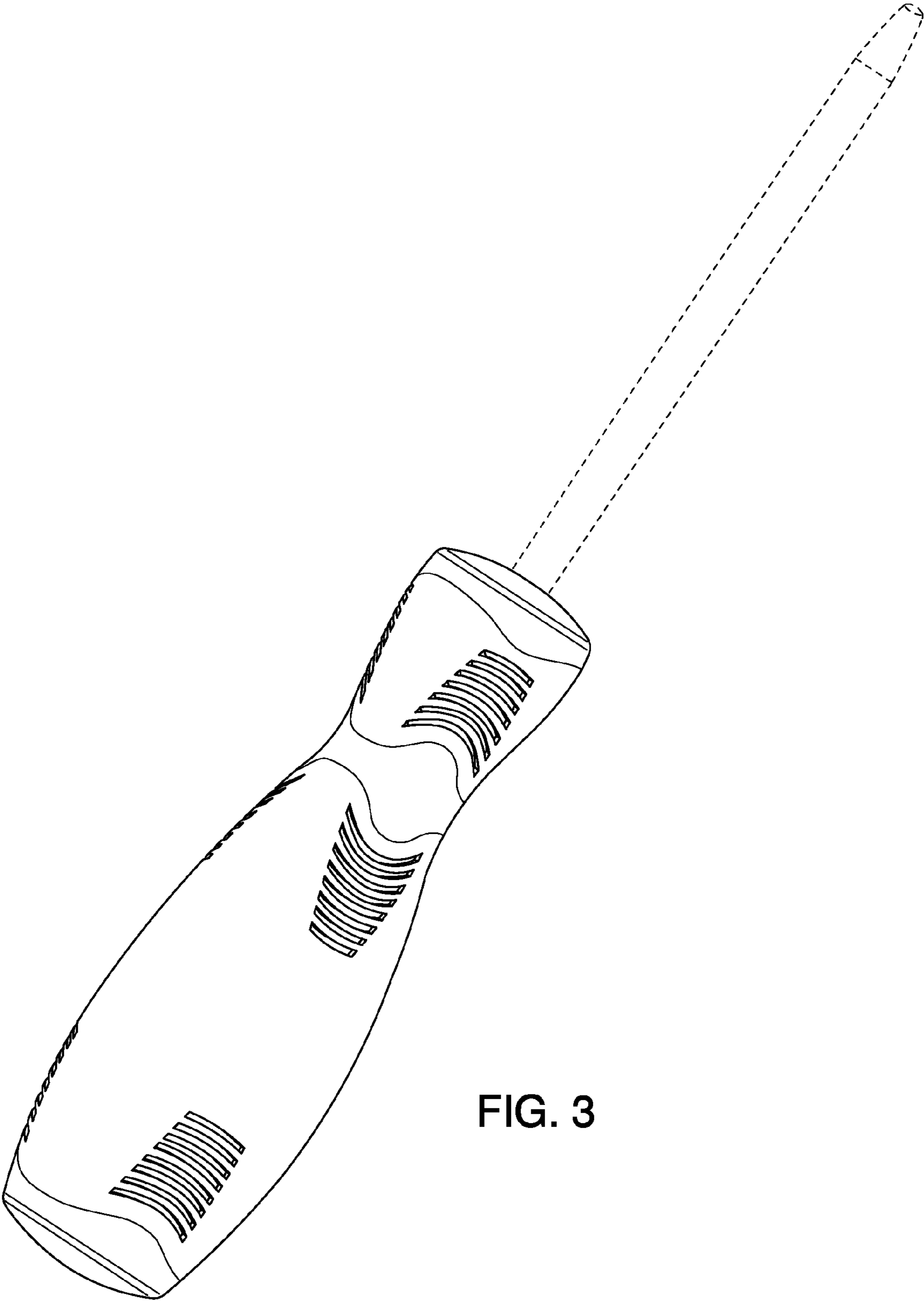

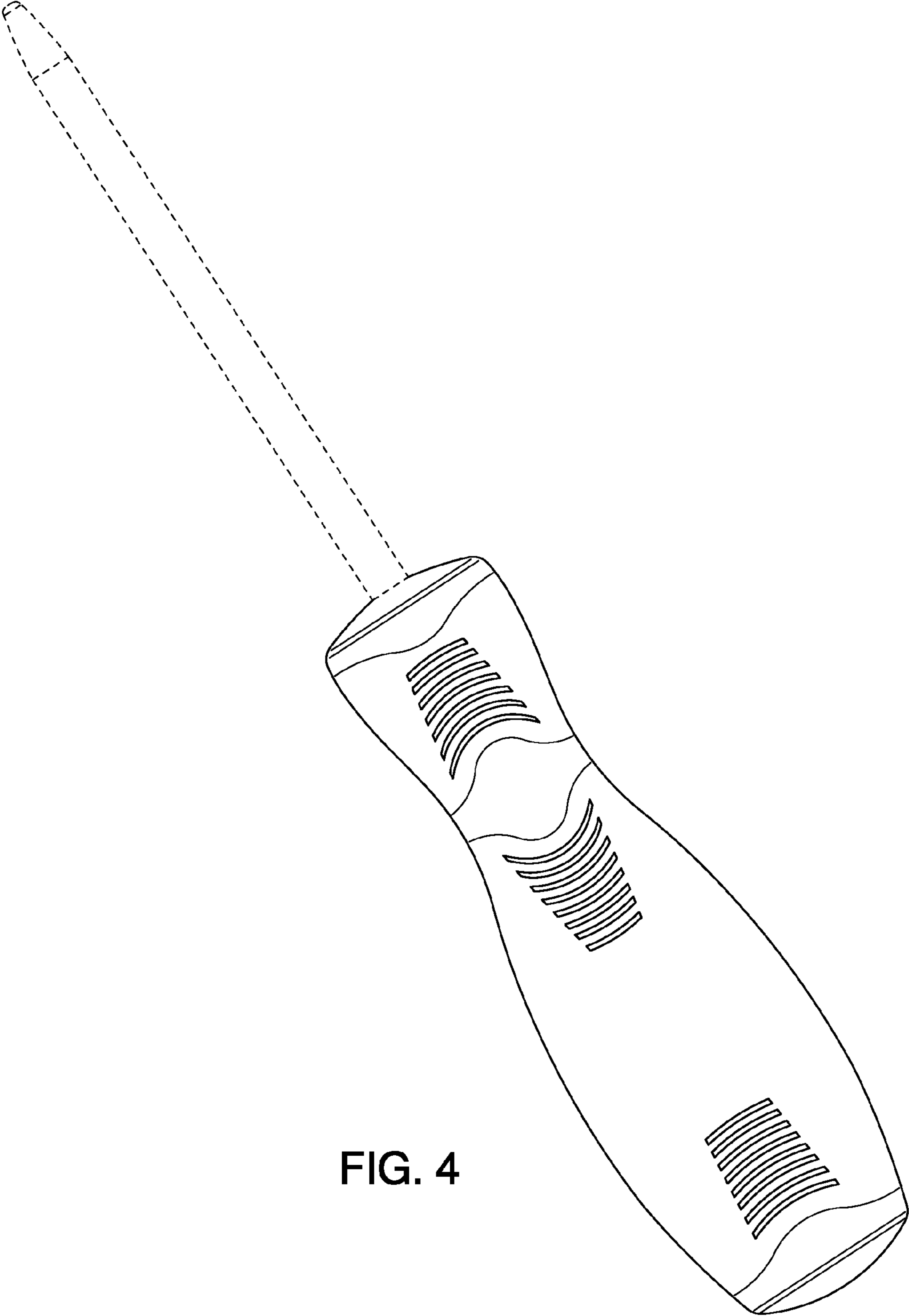

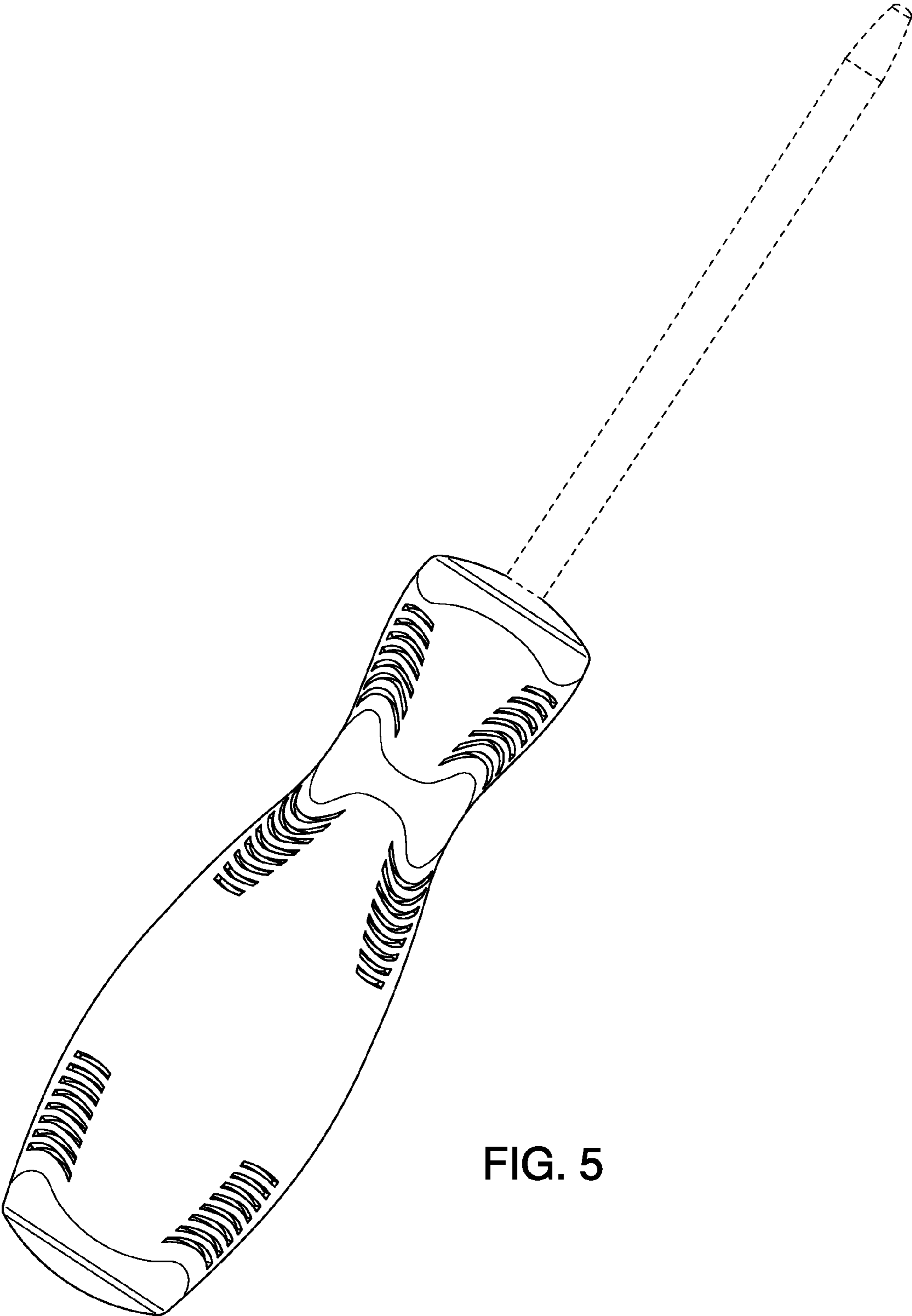

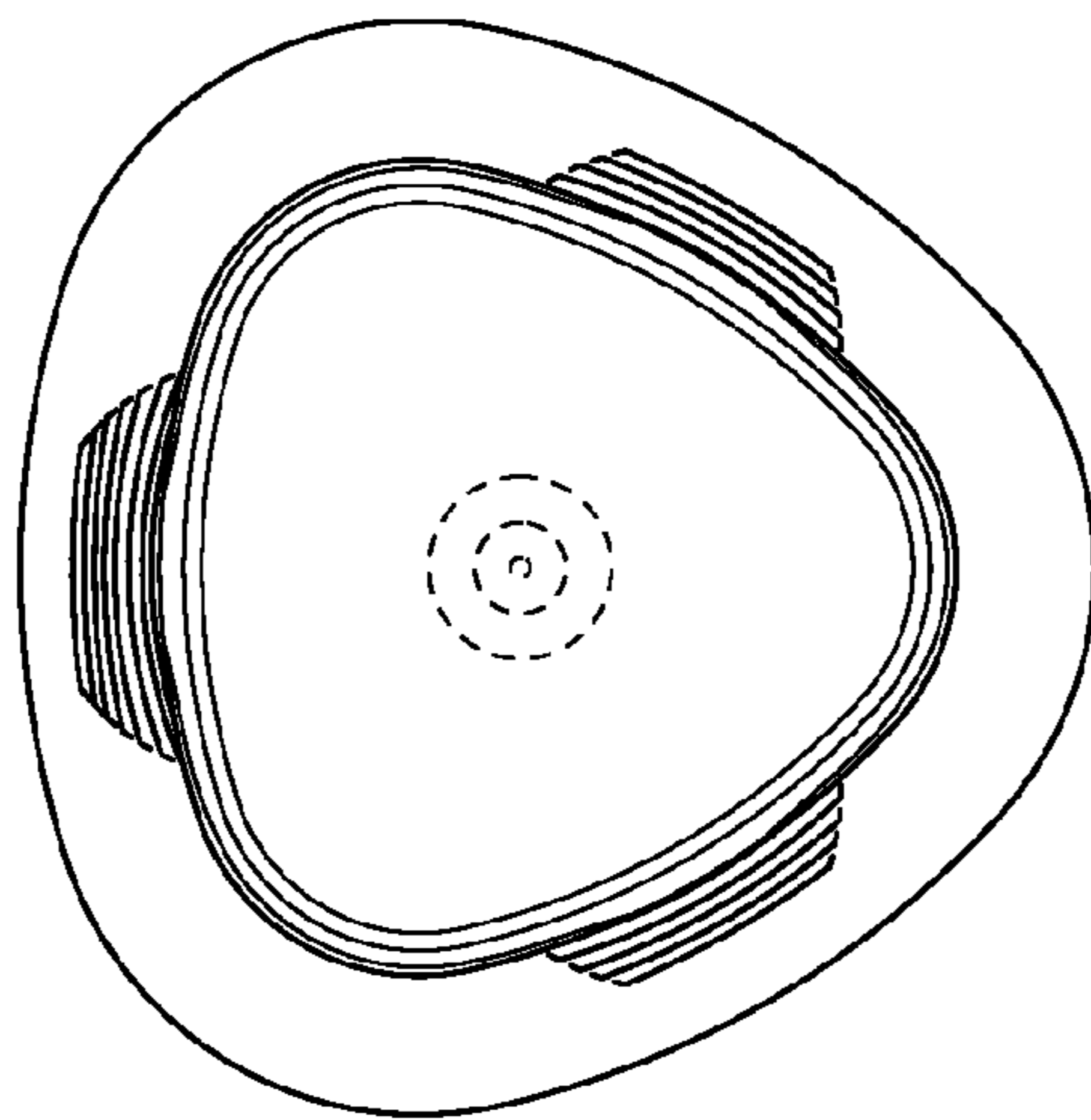

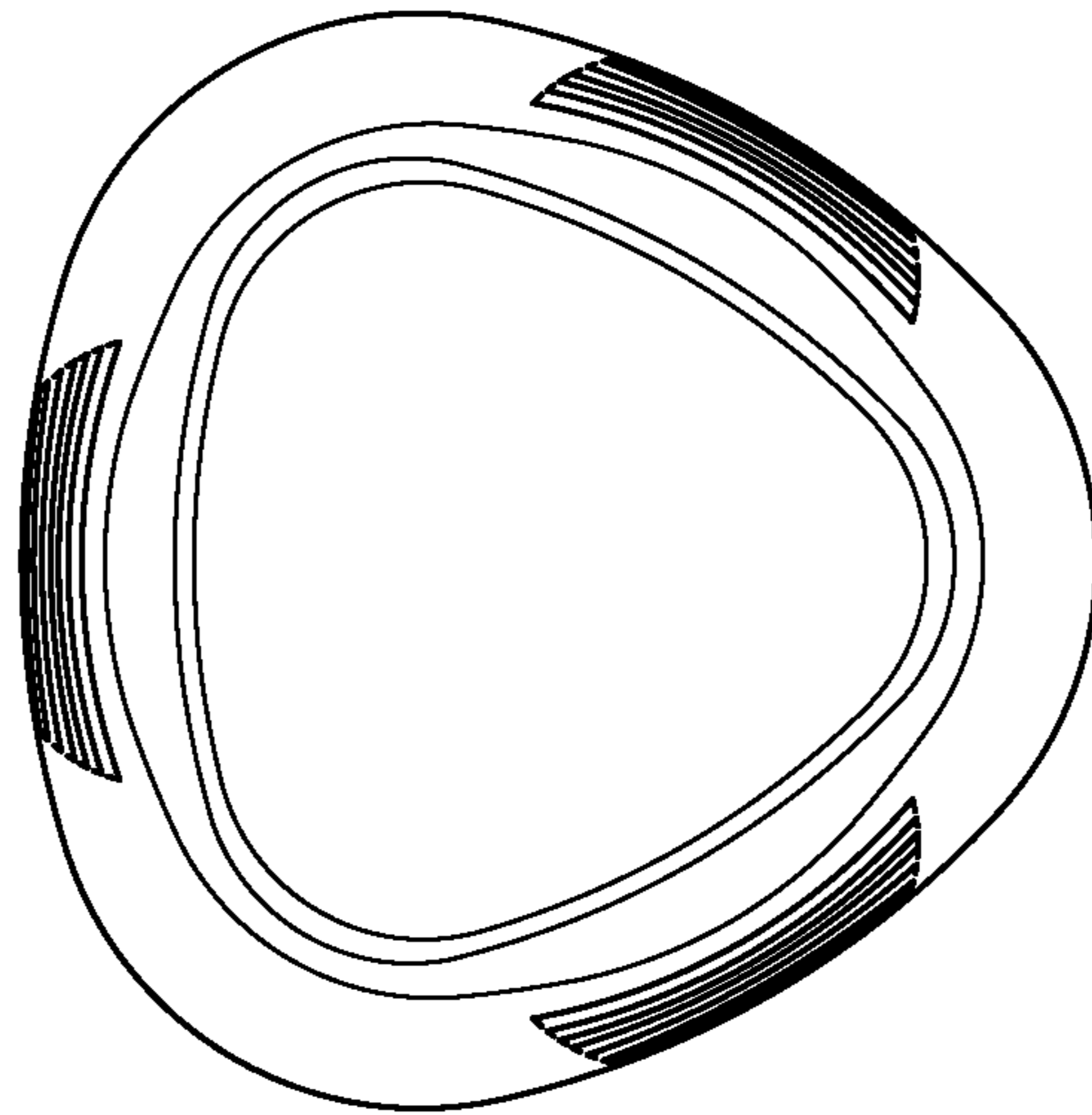
